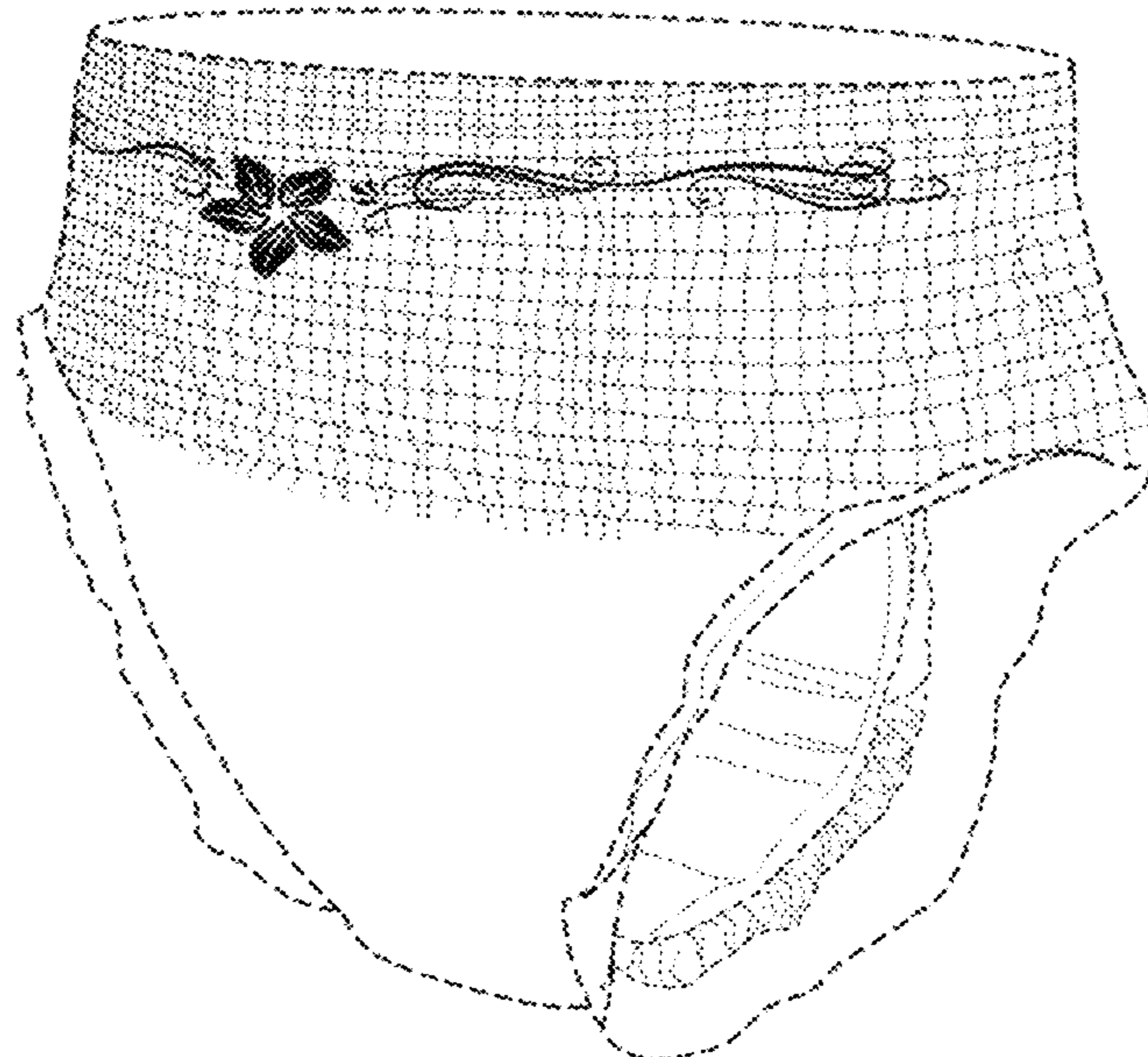
The ornamental design for protective underwear with pattern, as shown and described.

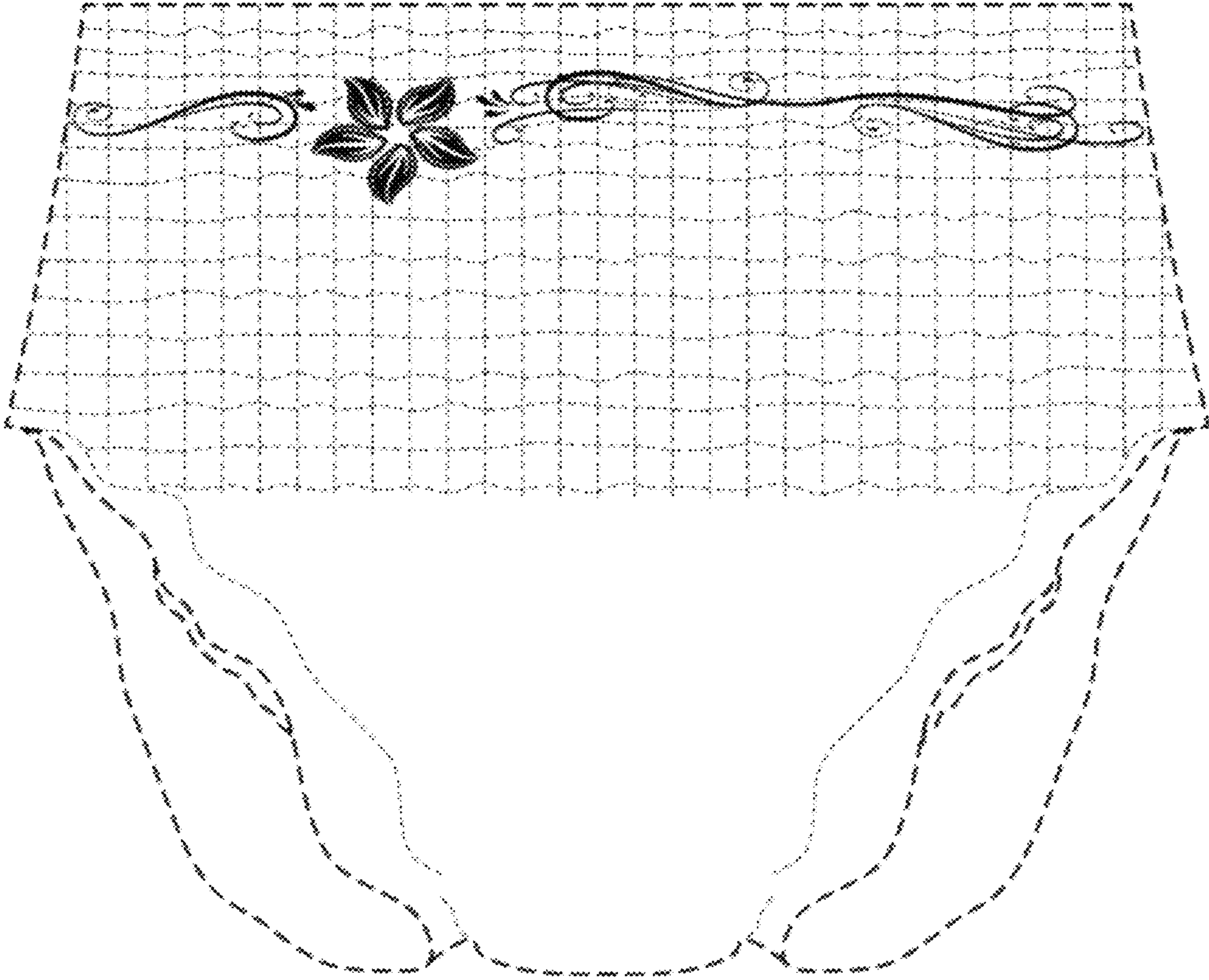

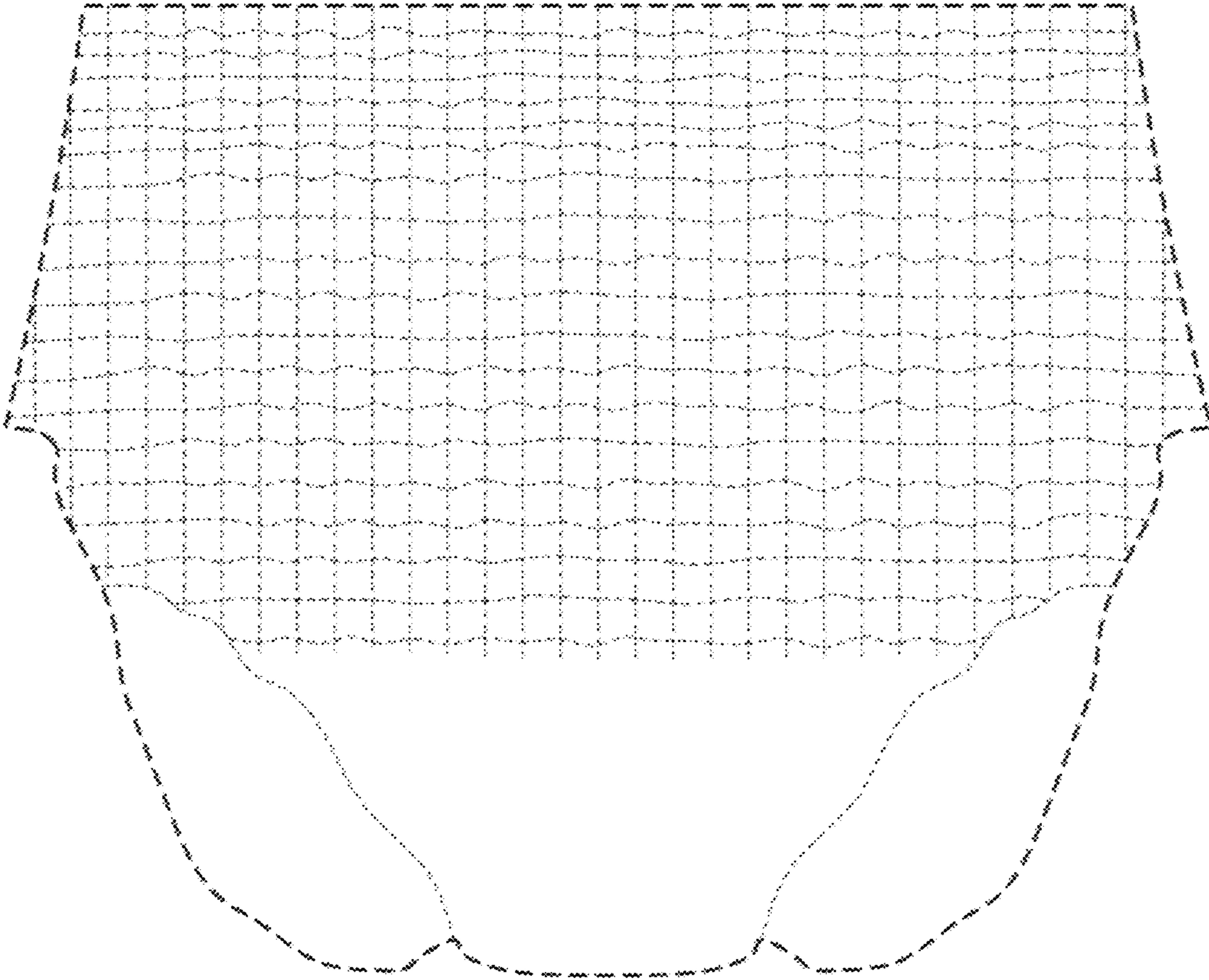

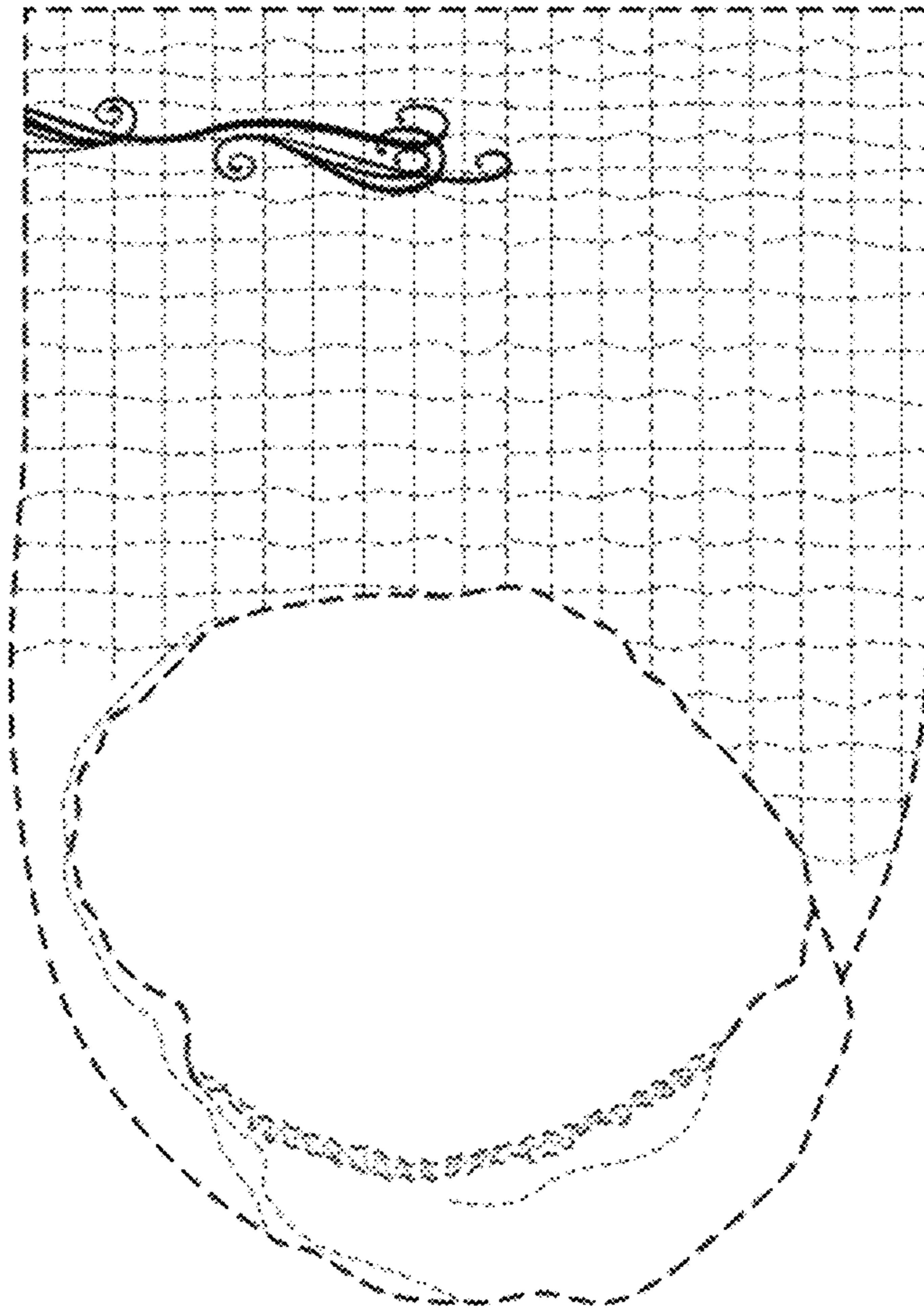

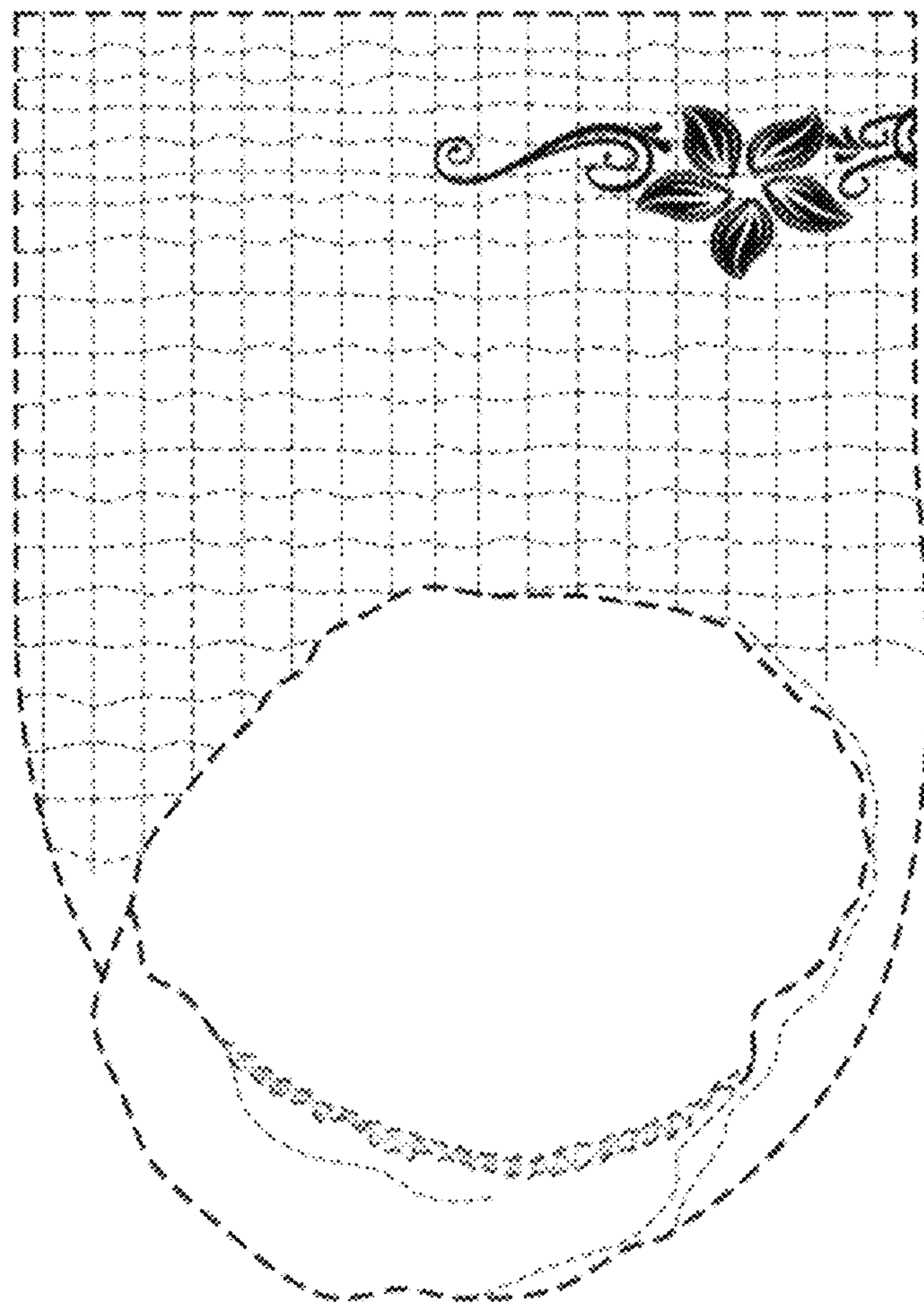

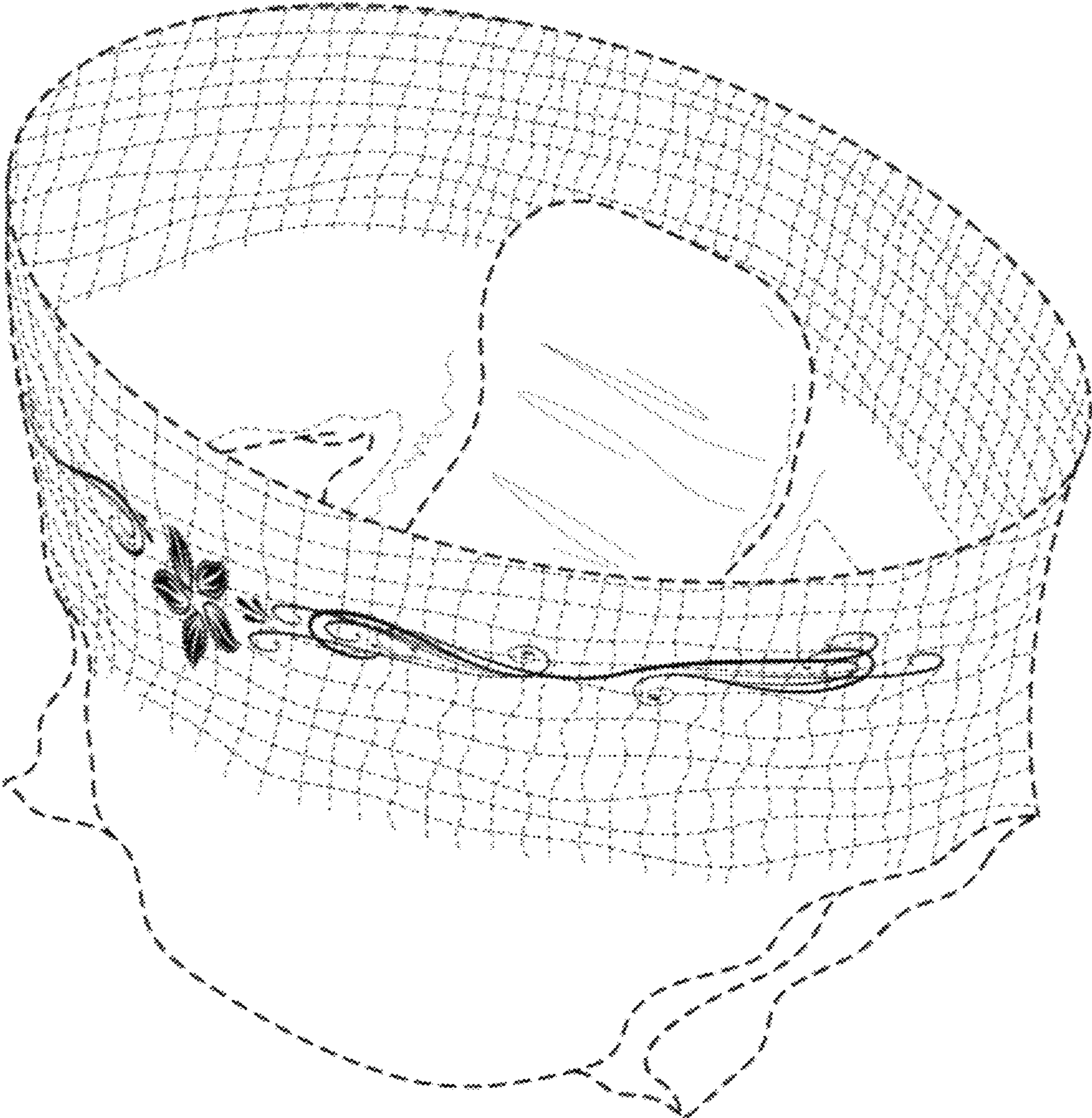
