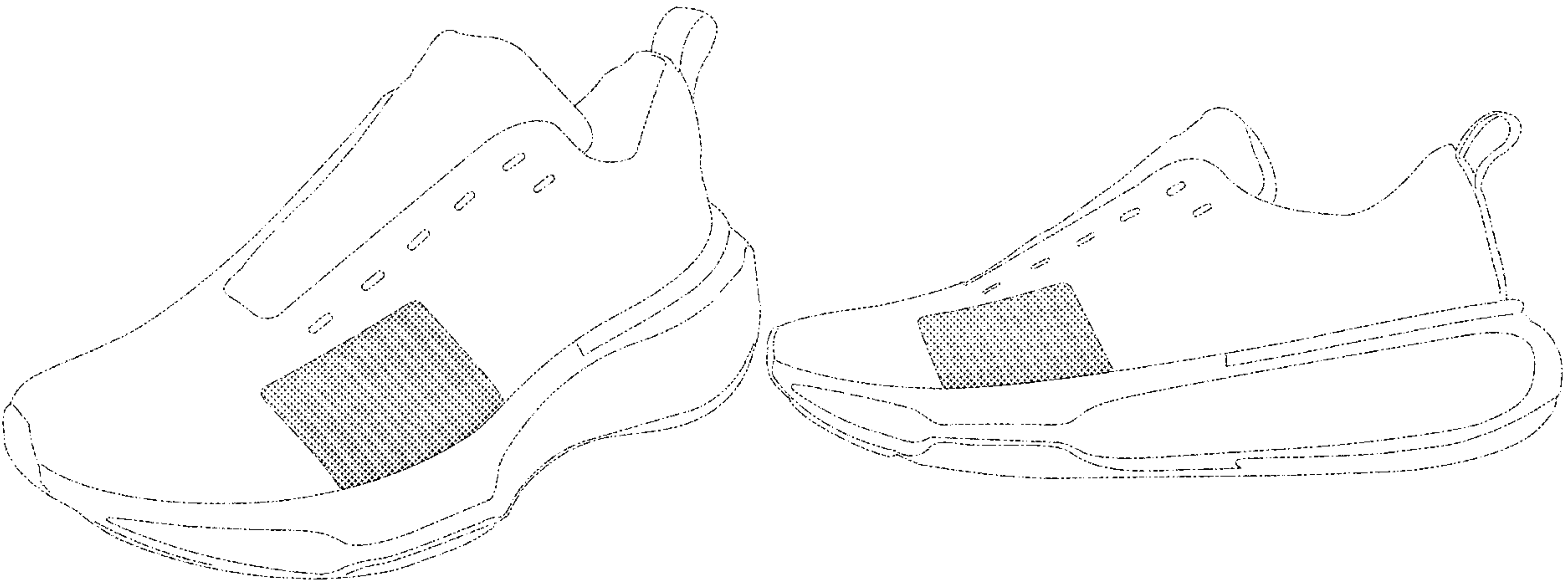

DESCRIPTION

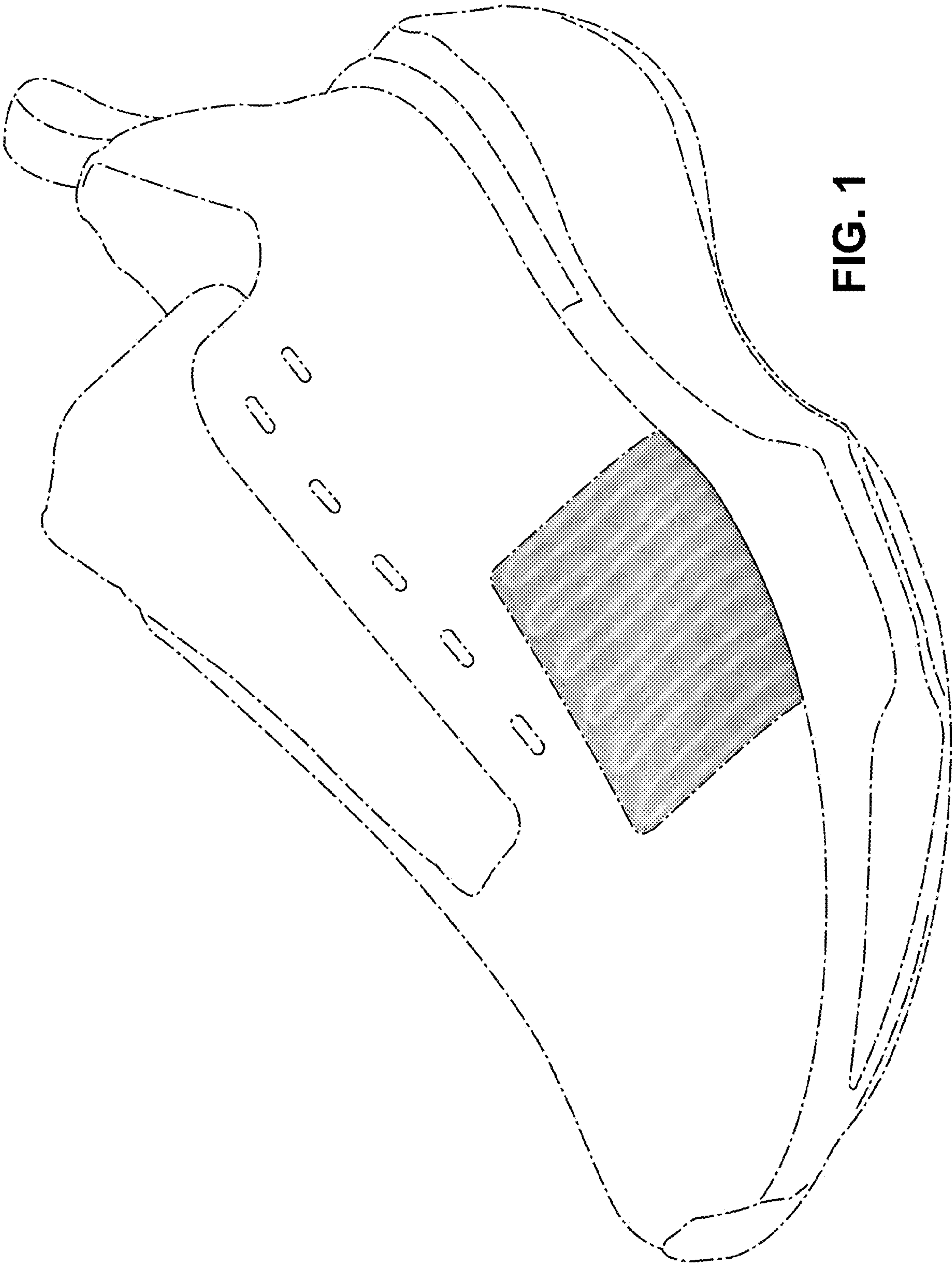

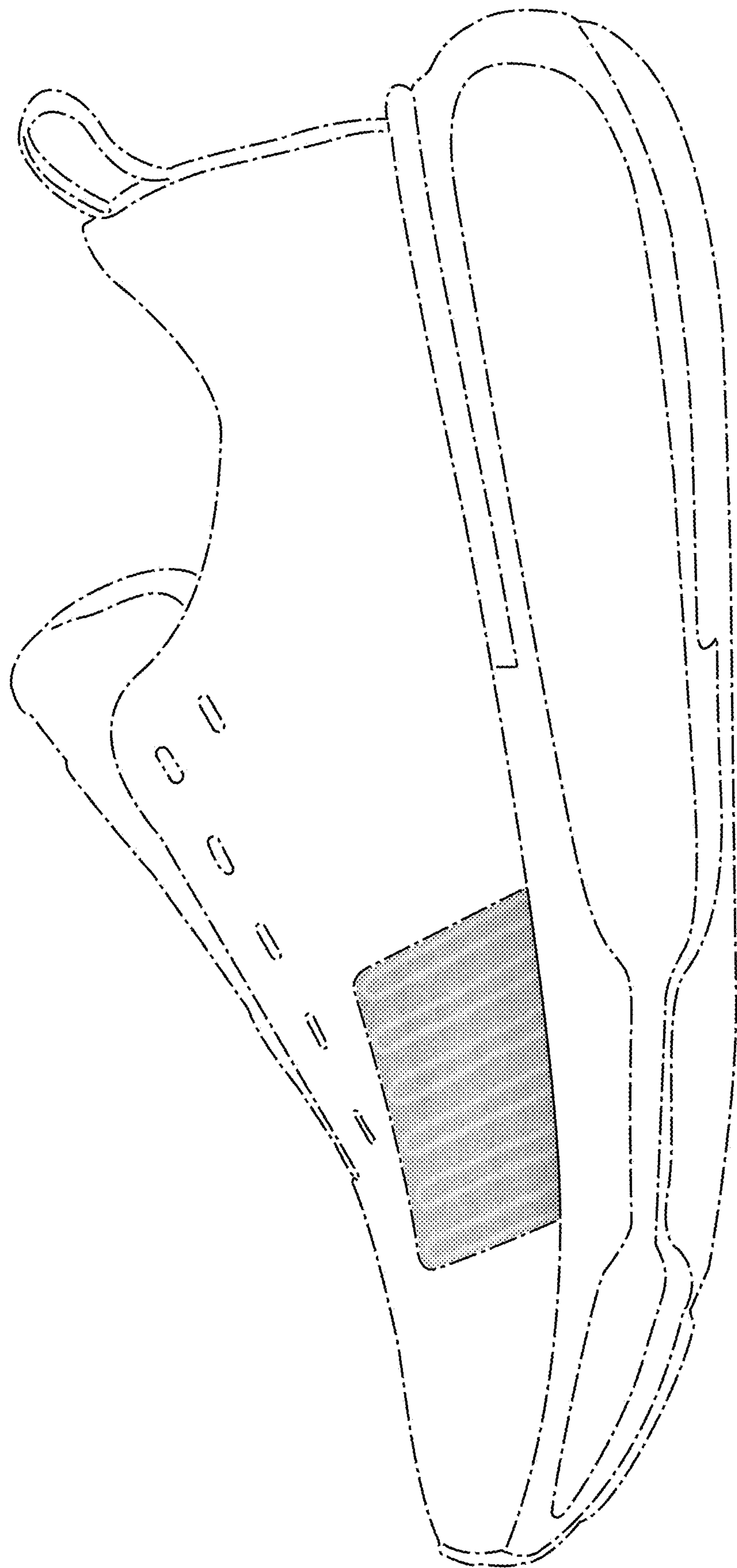

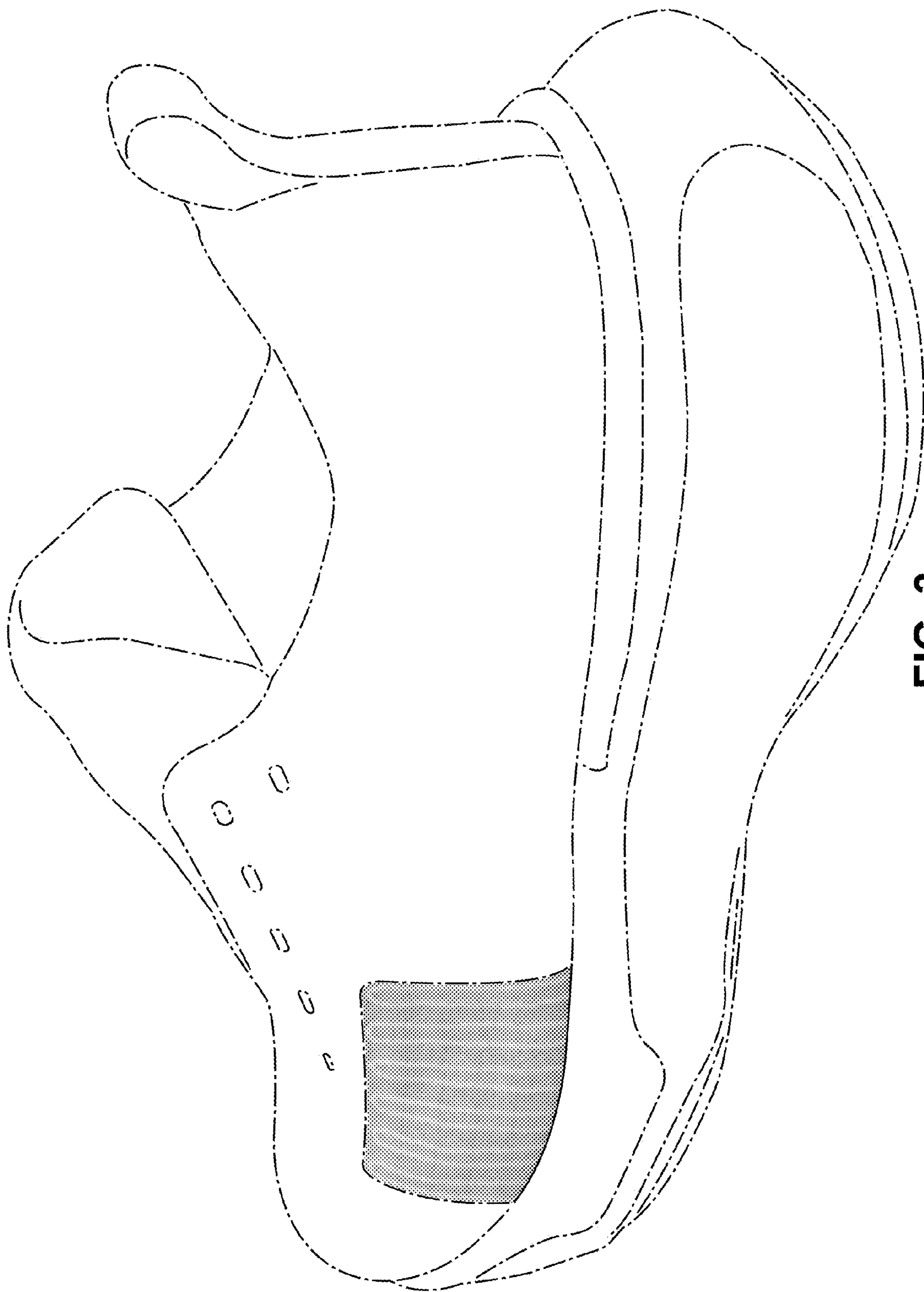
