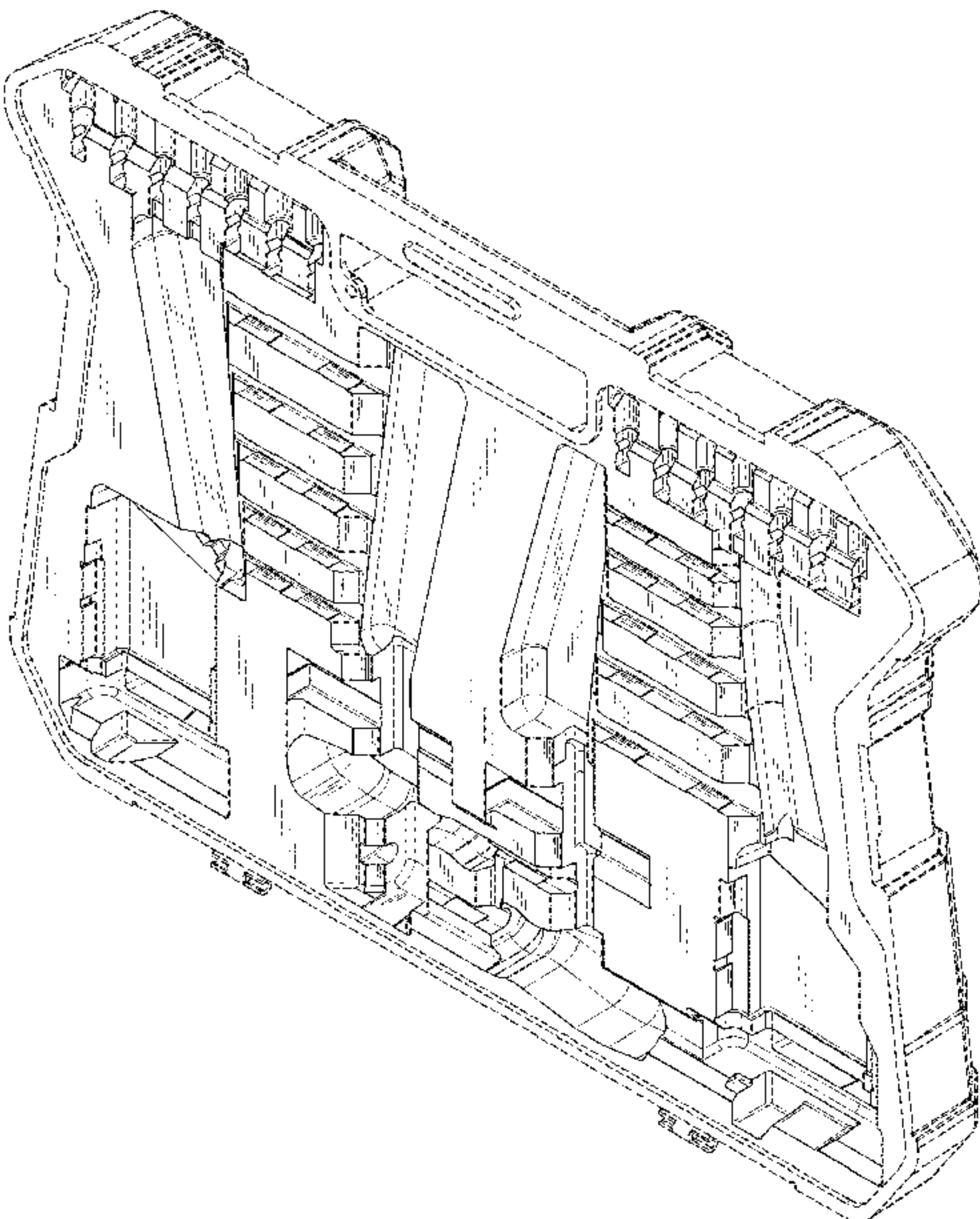
(57) CLAIM

DESCRIPTION

FIG. 1 is a top, front, right perspective view of a tool box showing my new design;
FIG. 2 is a front elevational view thereof;

FIG. 5 is a right side view thereof;
FIG. 6 is a top plan view thereof; and,

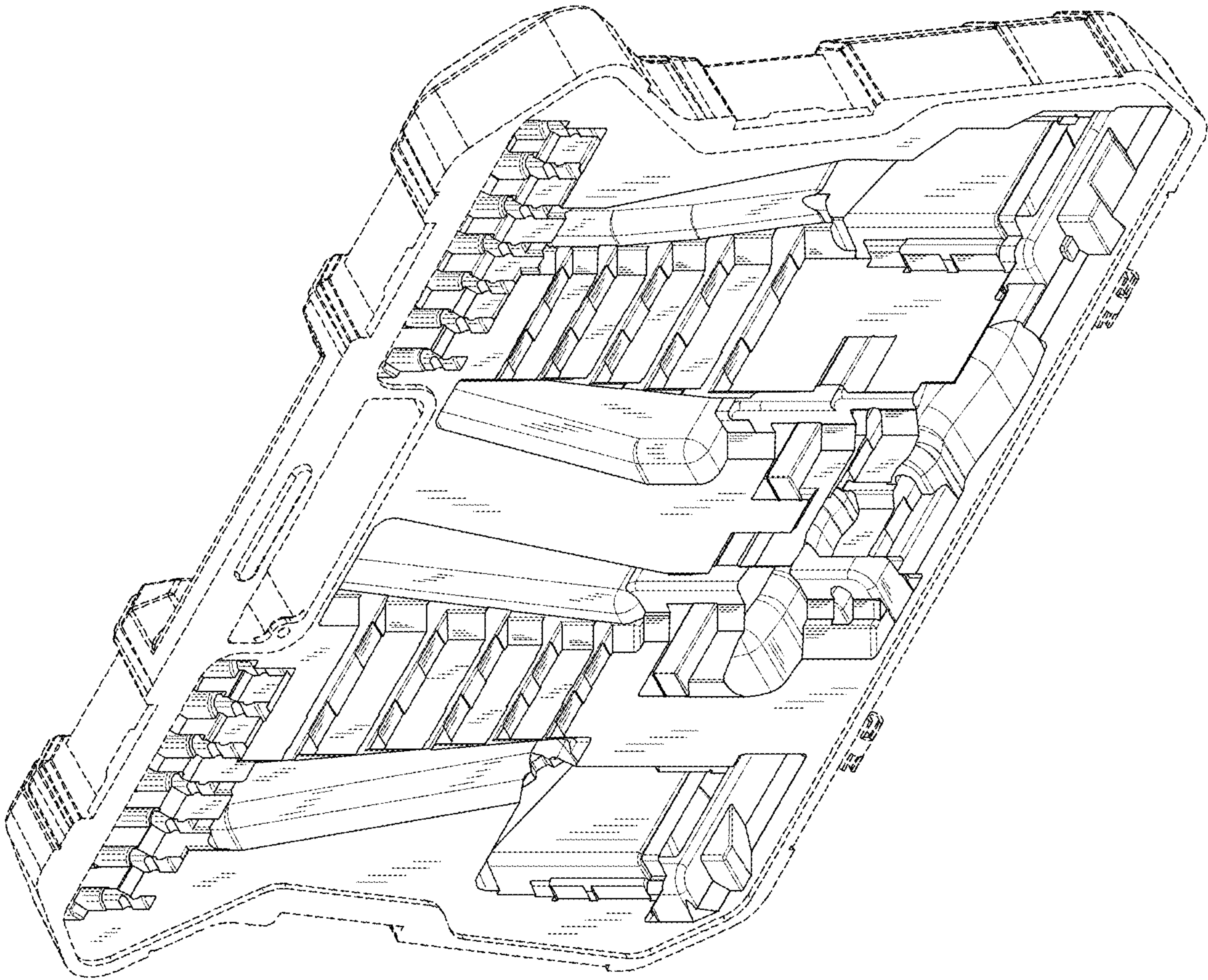

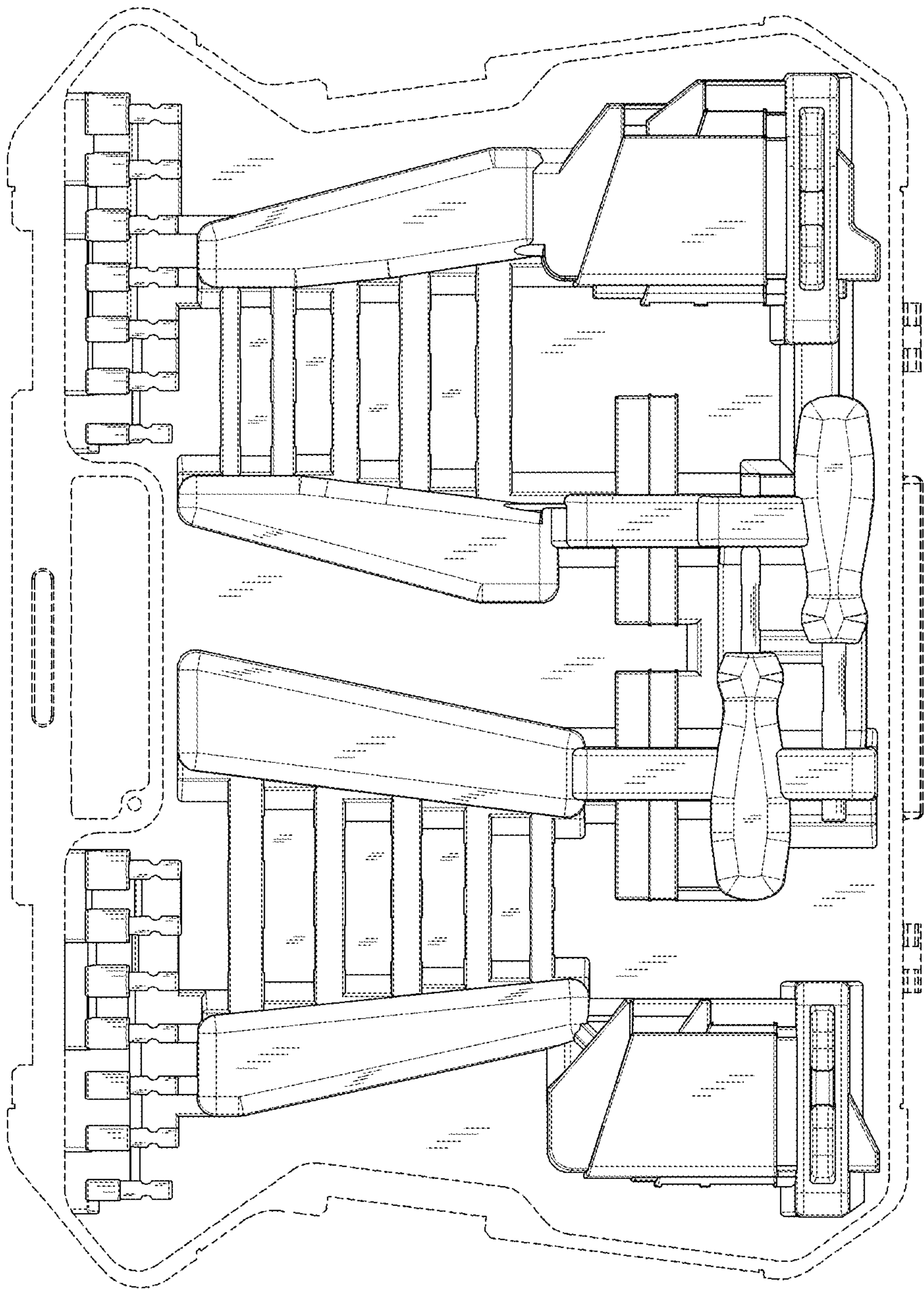

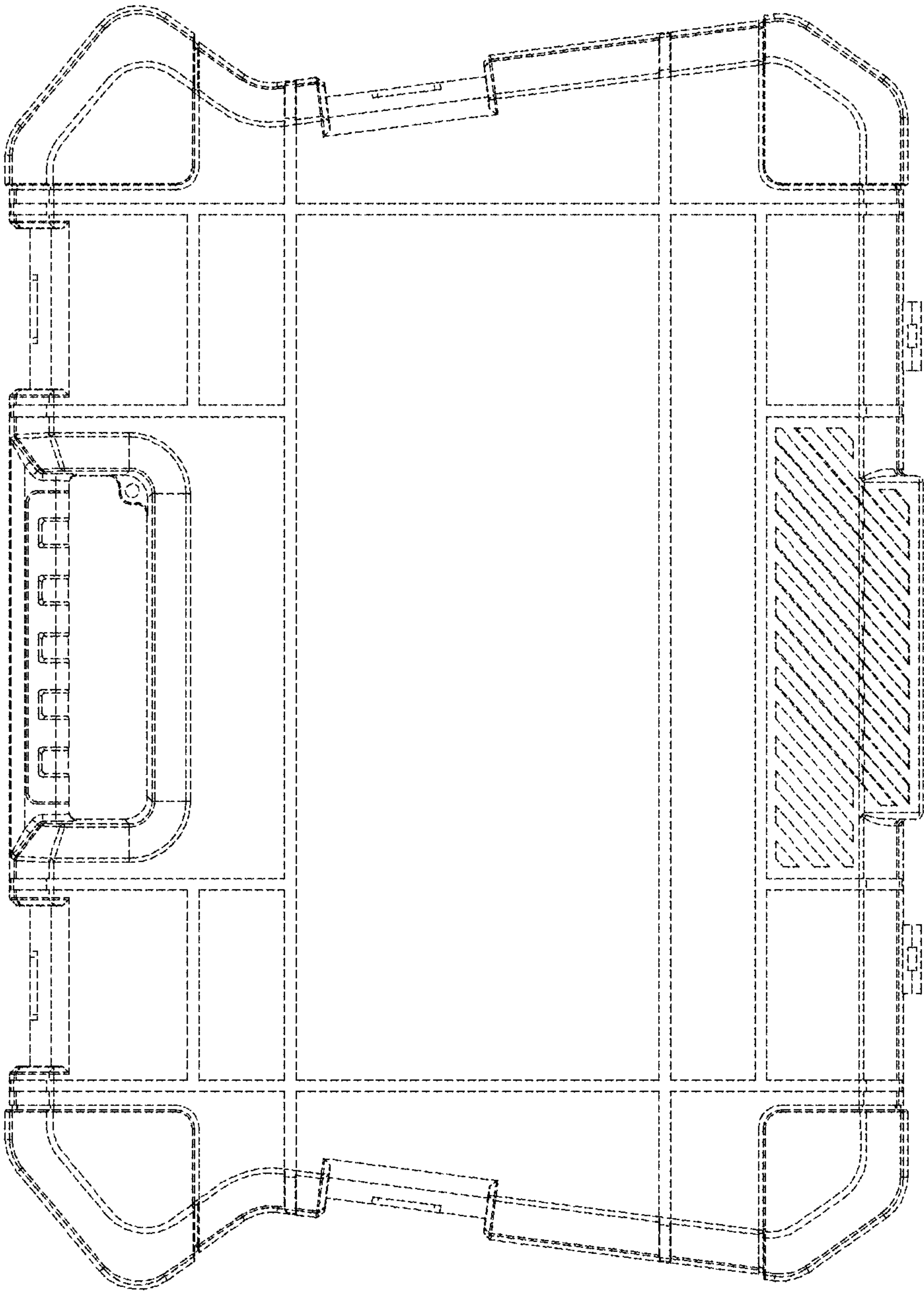

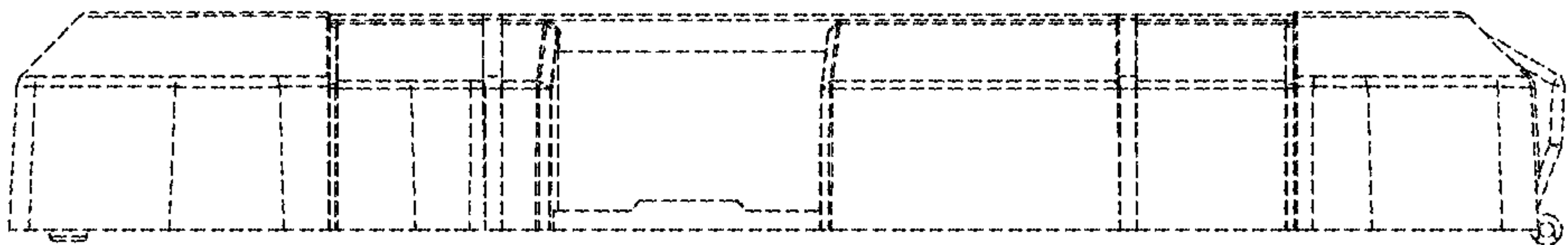

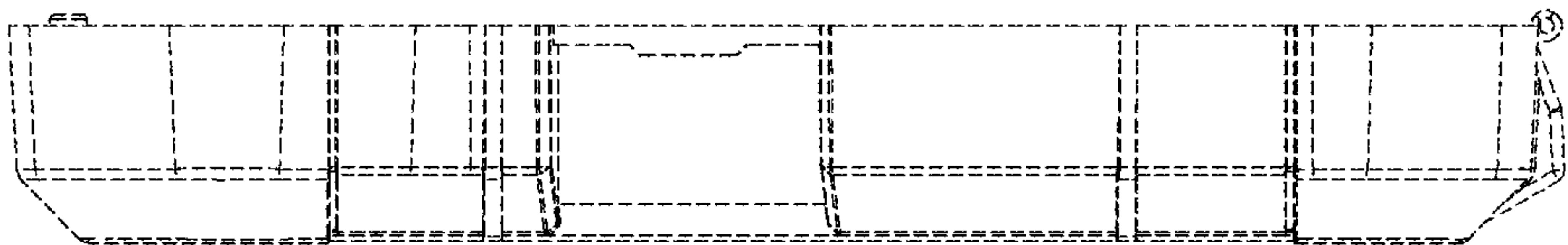

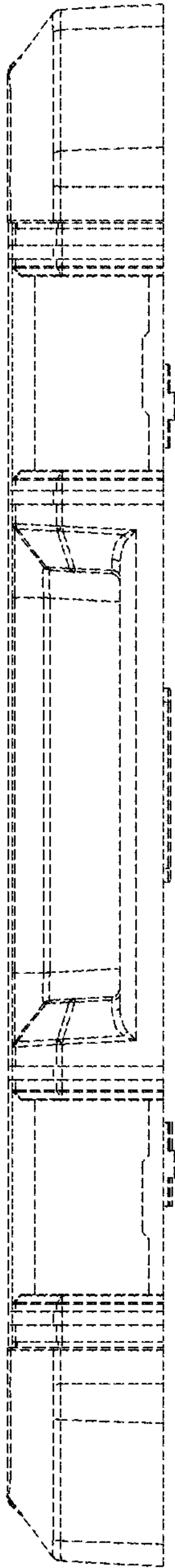

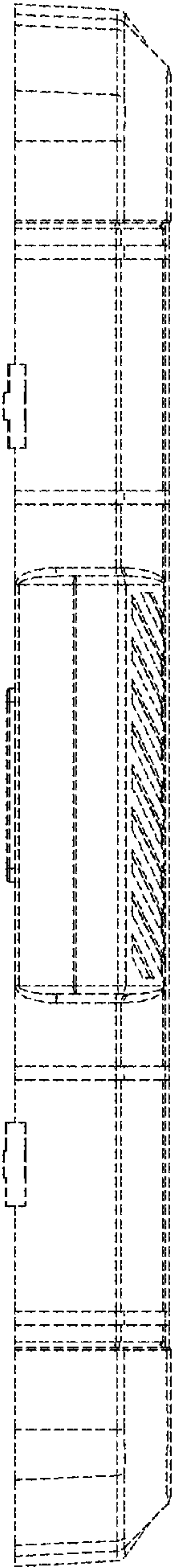
