(57) **CLAIM**

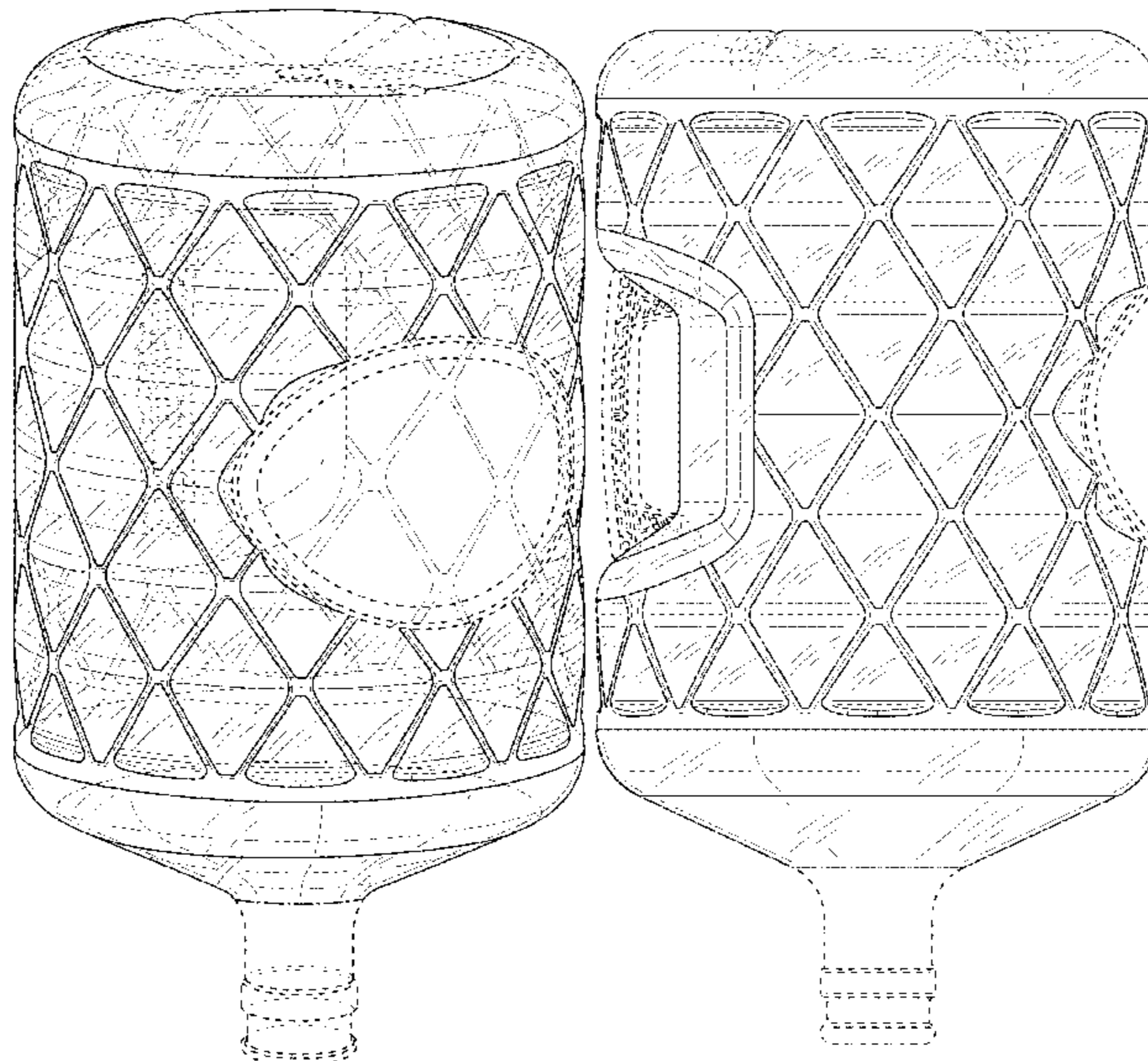
The ornamental design for a container, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, rear, right side perspective view of a container, showing our new design; FIG. 2 is a right elevation view thereof; FIG. 3 is a left elevation view thereof; FIG. 4 is a front side view thereof; FIG. 5 is a rear side view thereof; FIG. 6 is a bottom plan view thereof; and, FIG. 7 is a top plan view thereof.

The dash-dash lines depict portions of the container. The dash-dot lines depict the boundaries of the claim. Broken lines form no part of the claimed design.

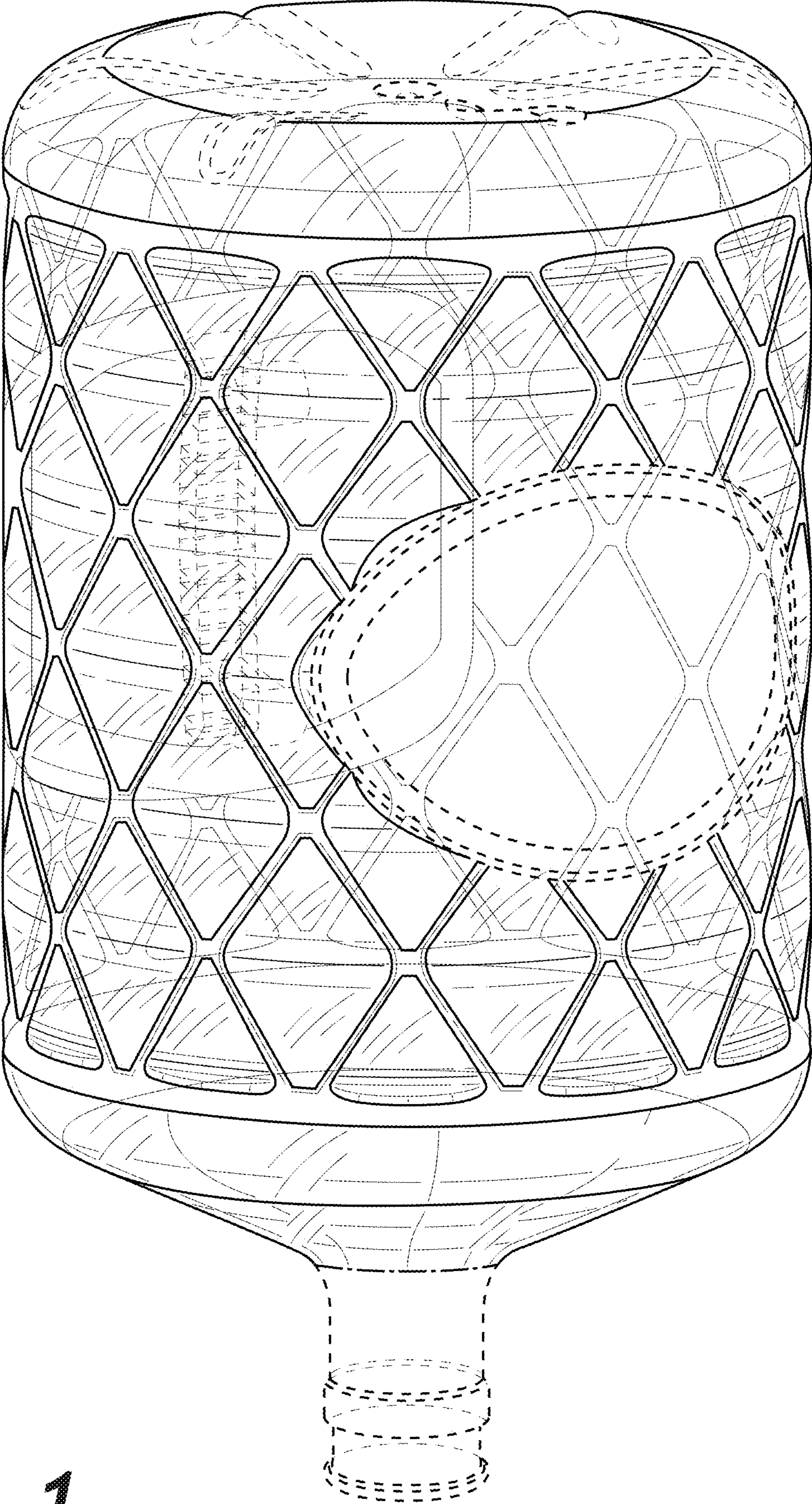

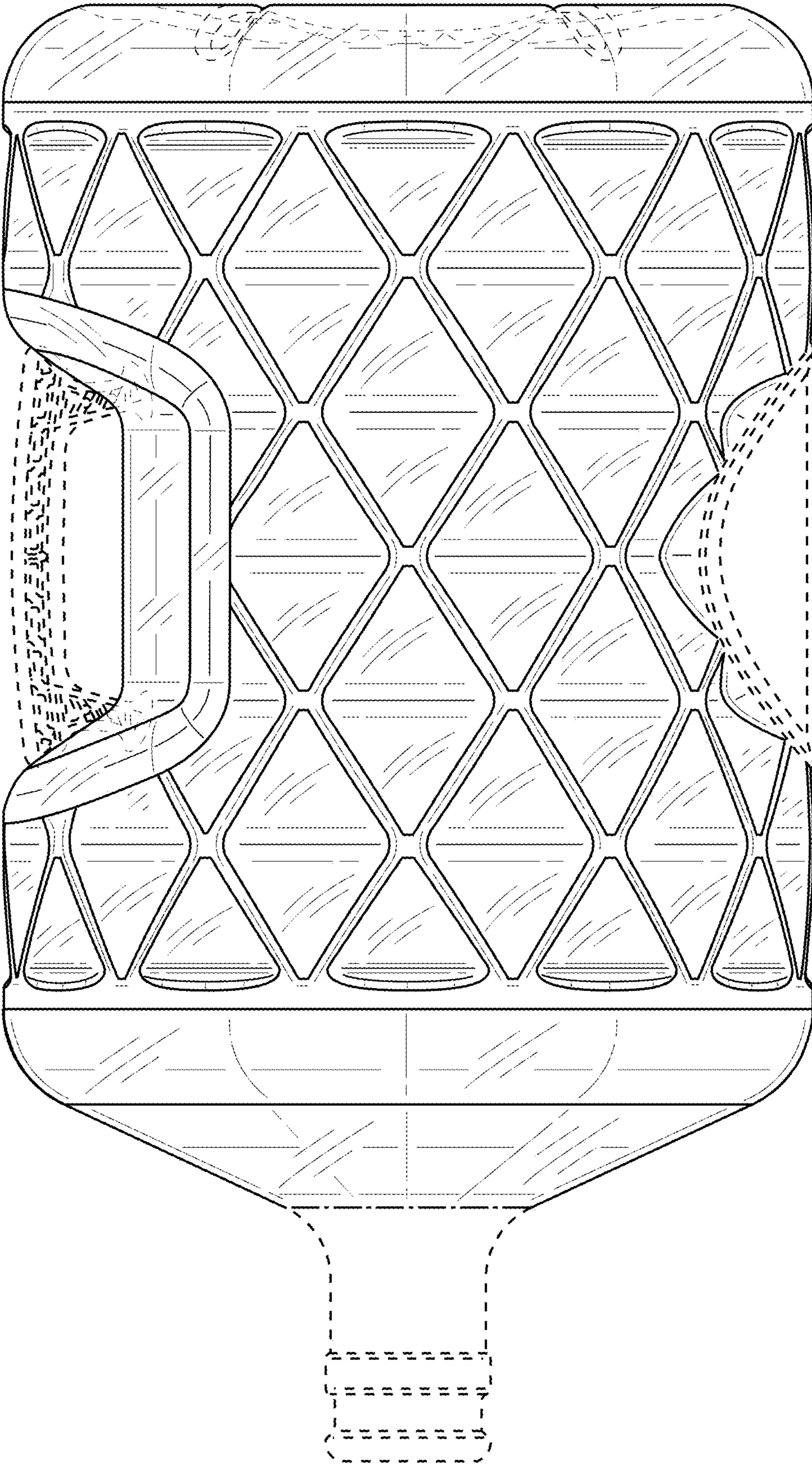

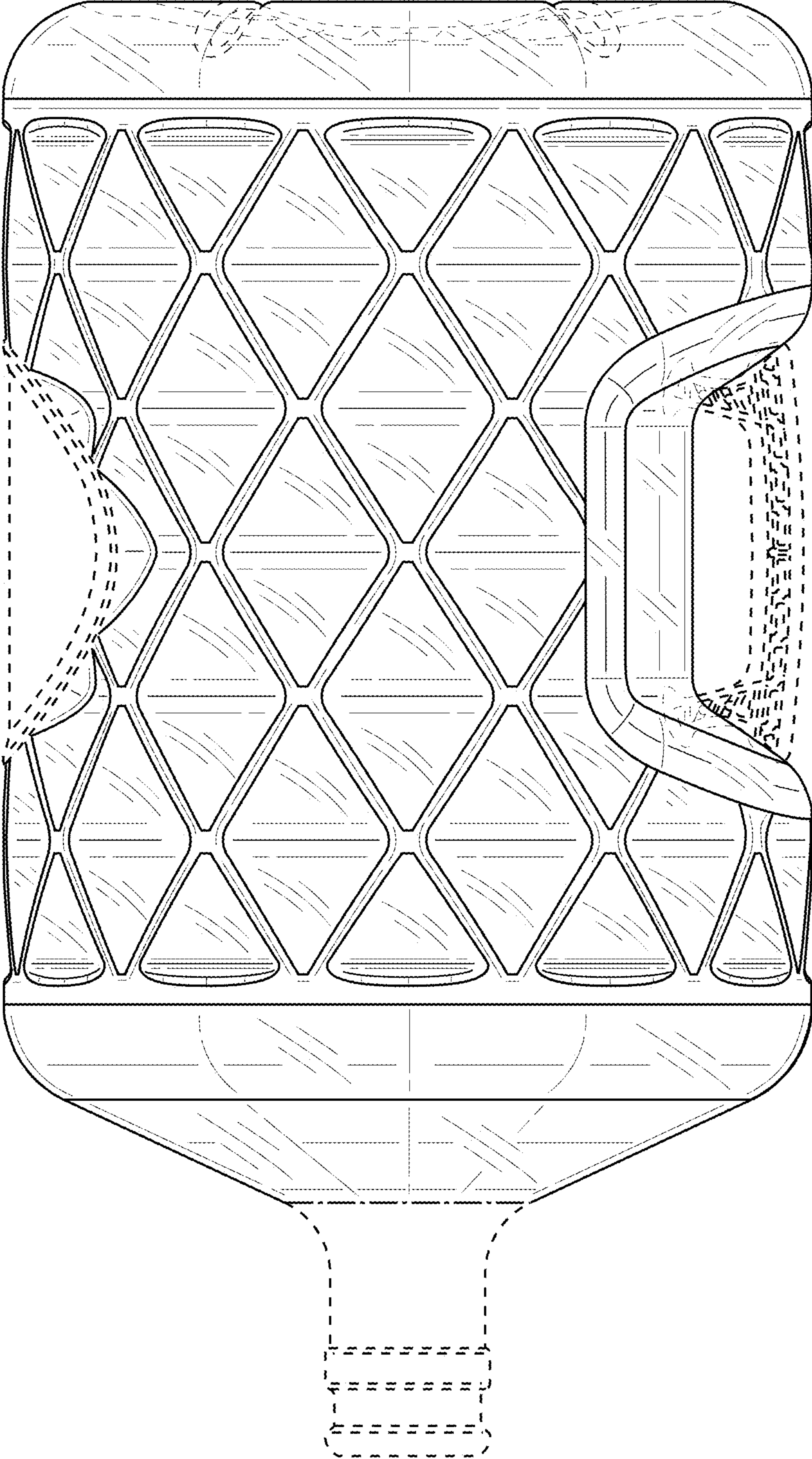

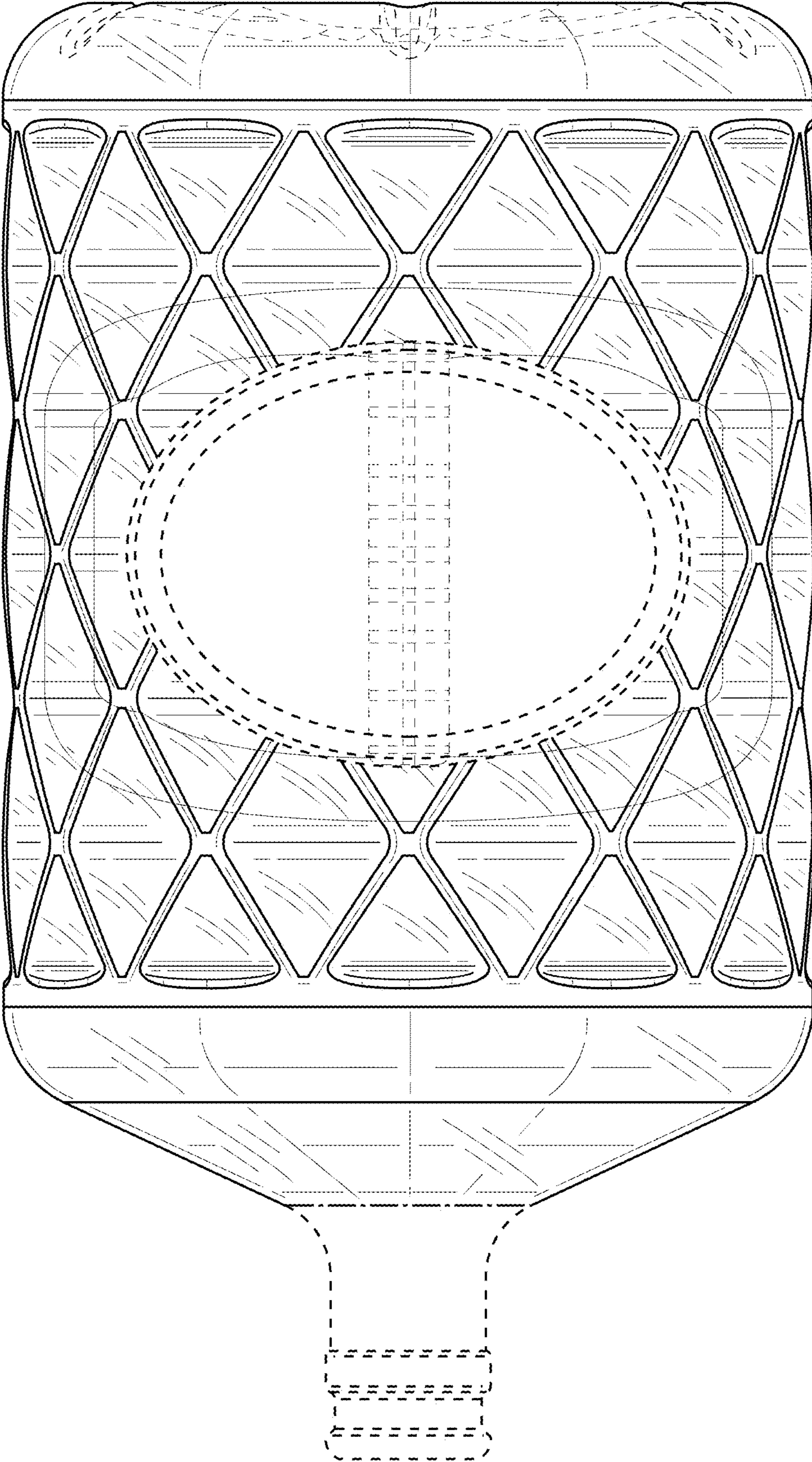

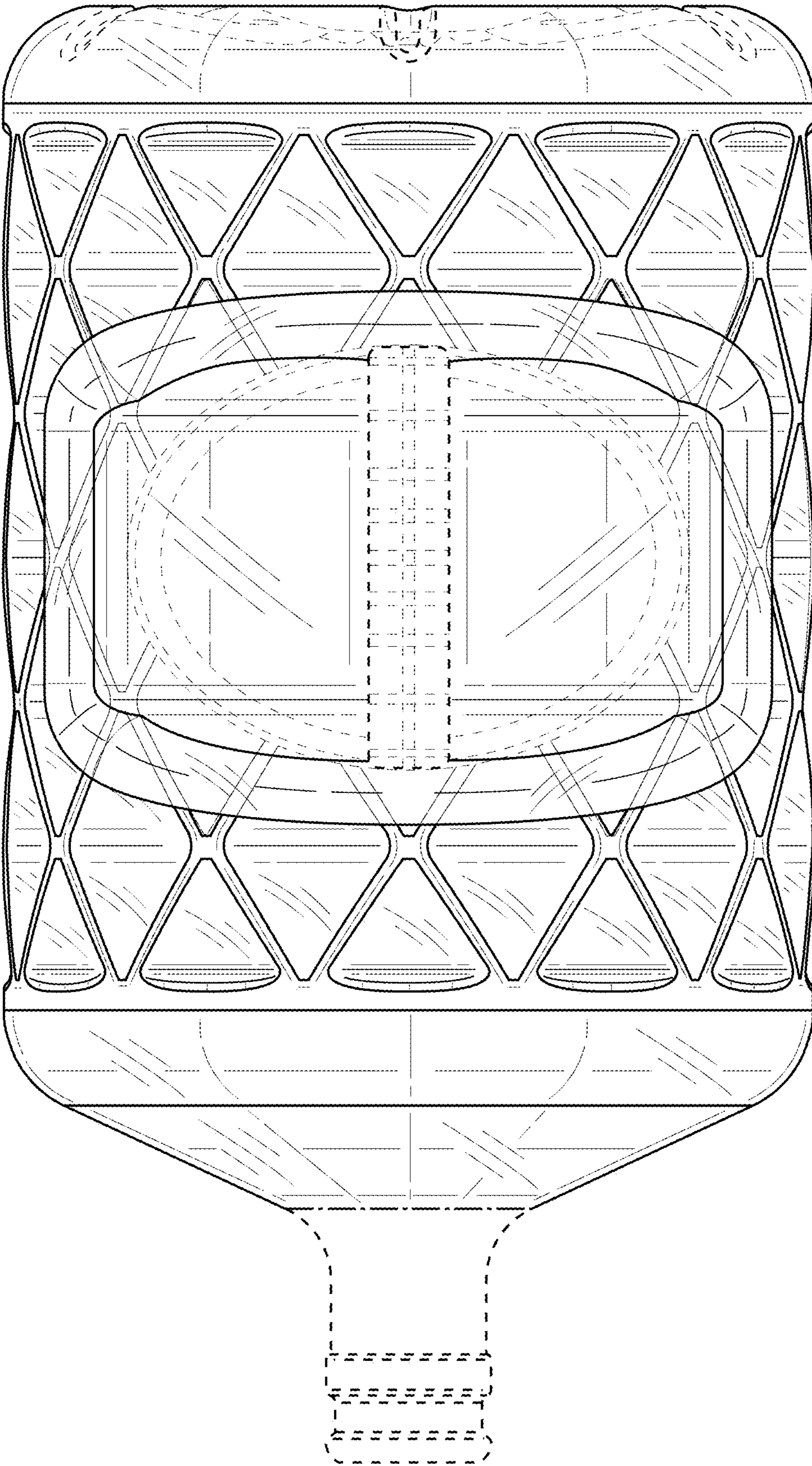

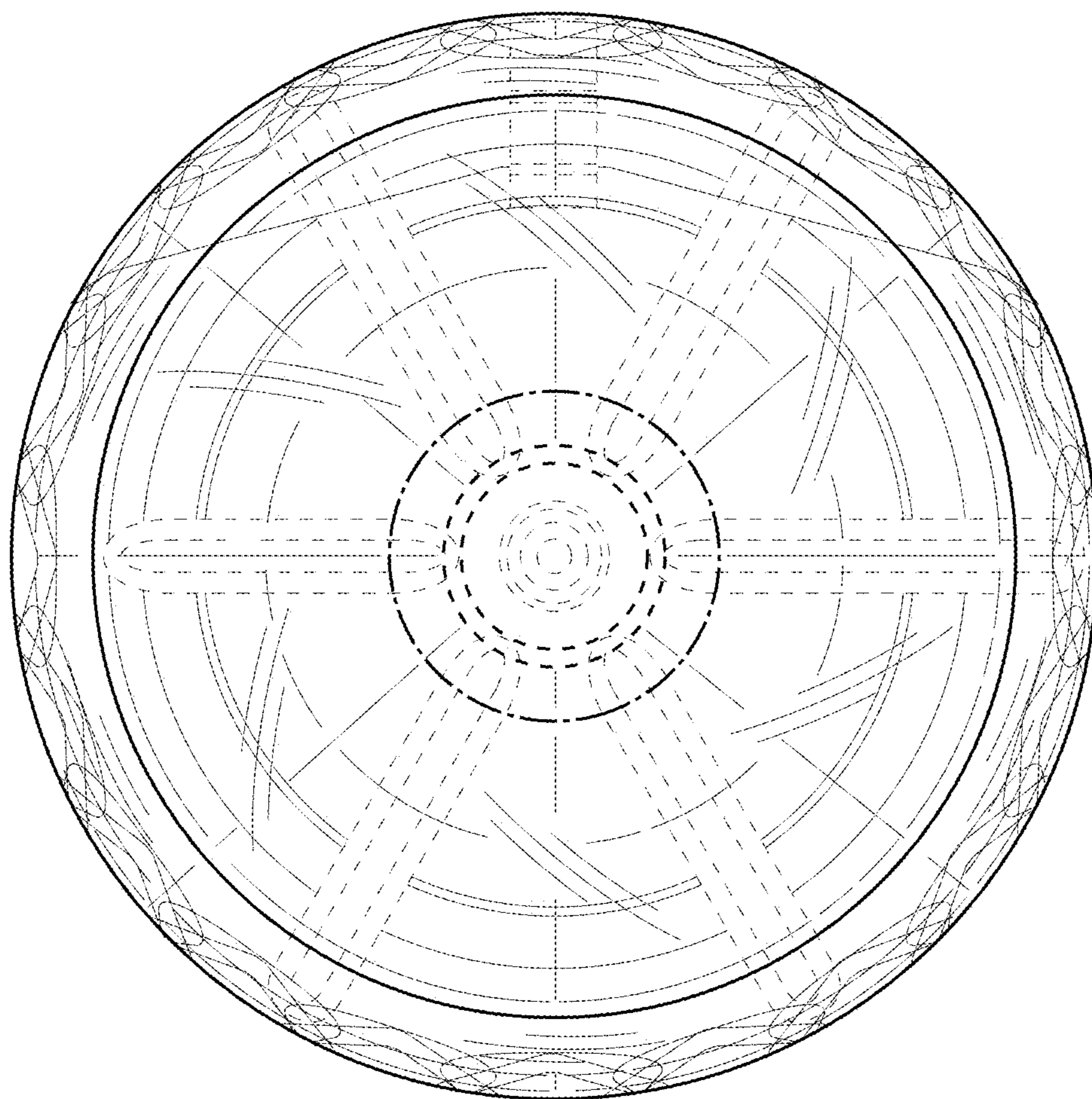

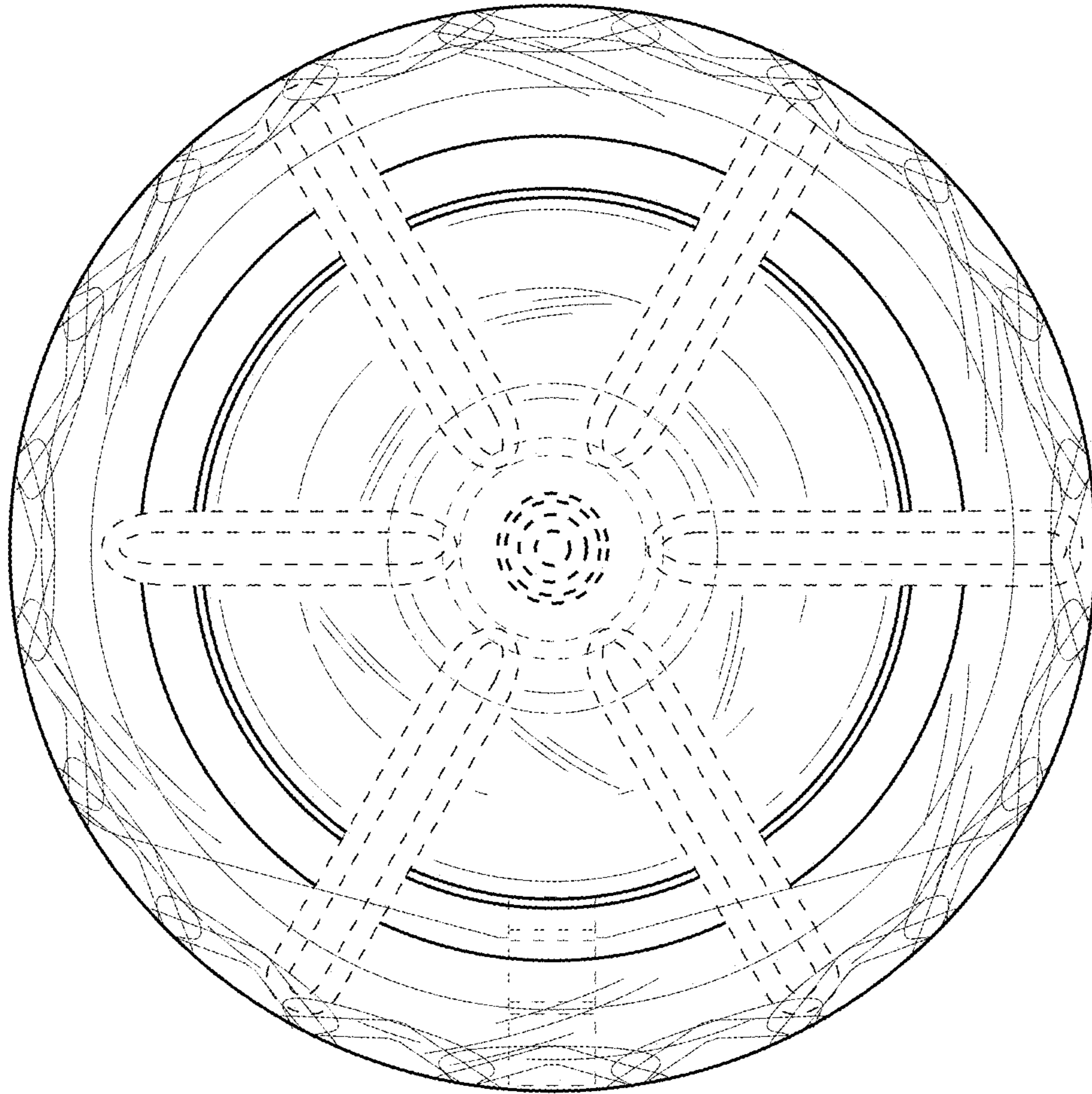
