FIG. 6 is a second image thereof;

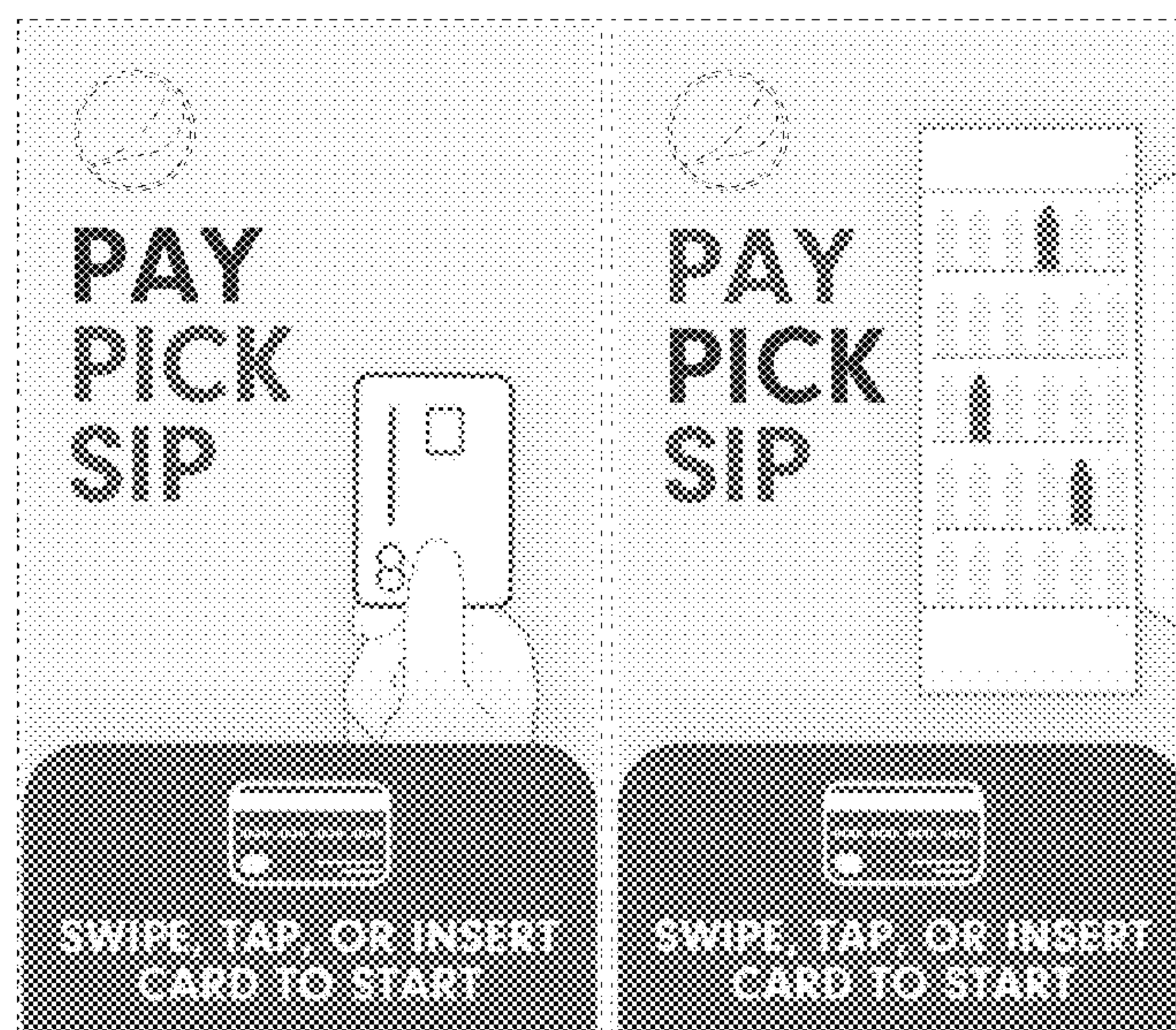
FIG. 7 is a third image thereof; and,

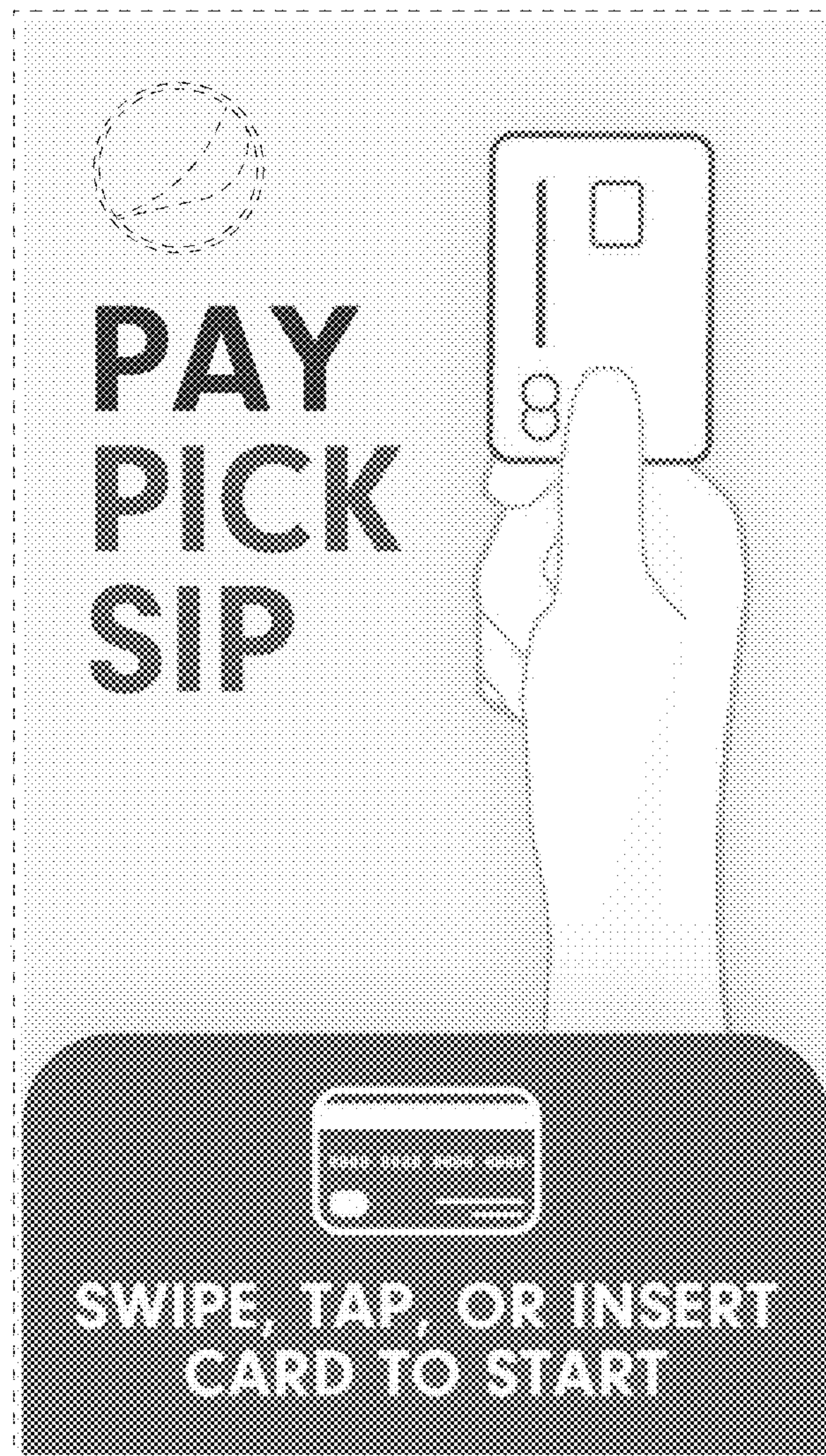

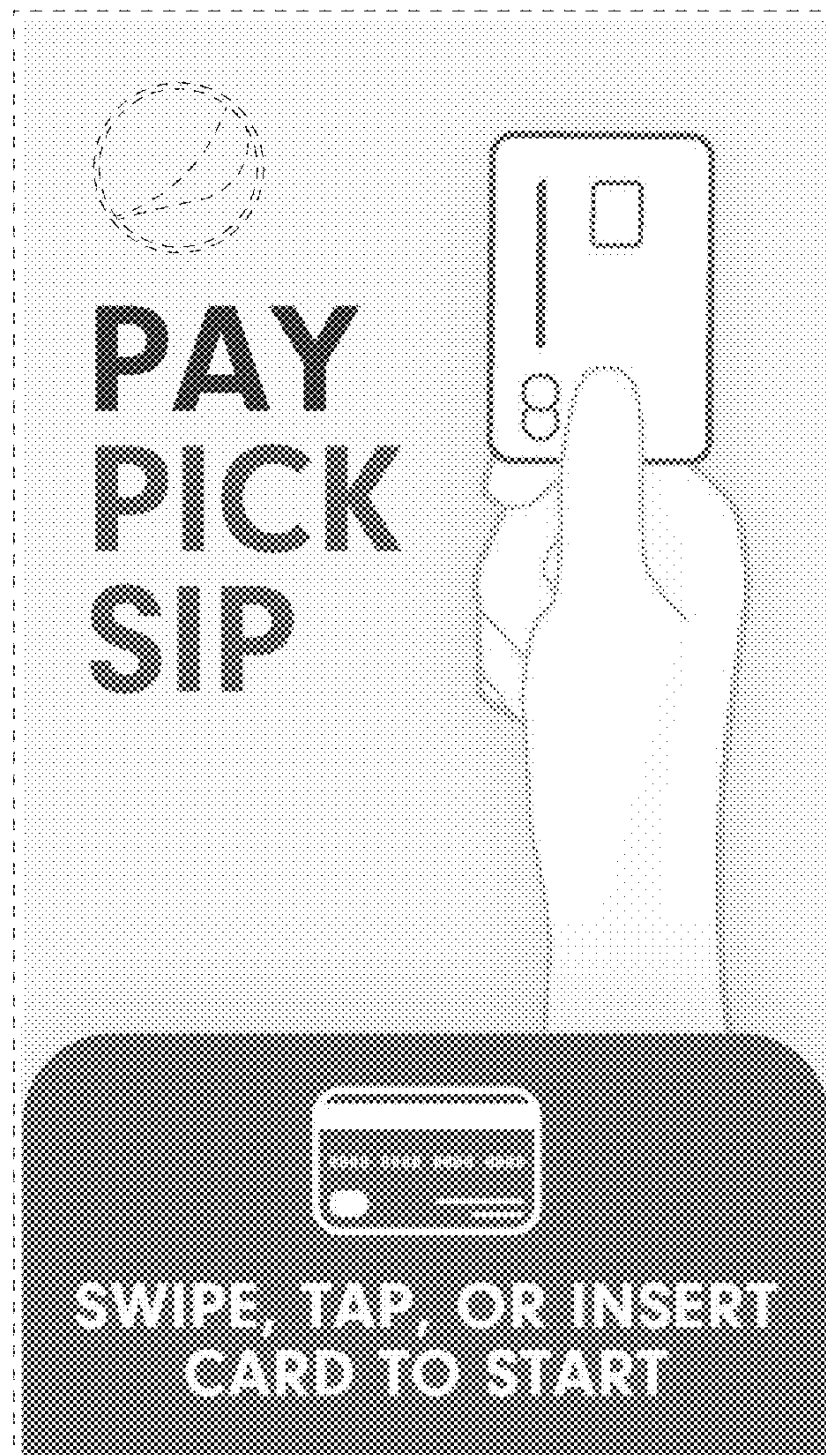
