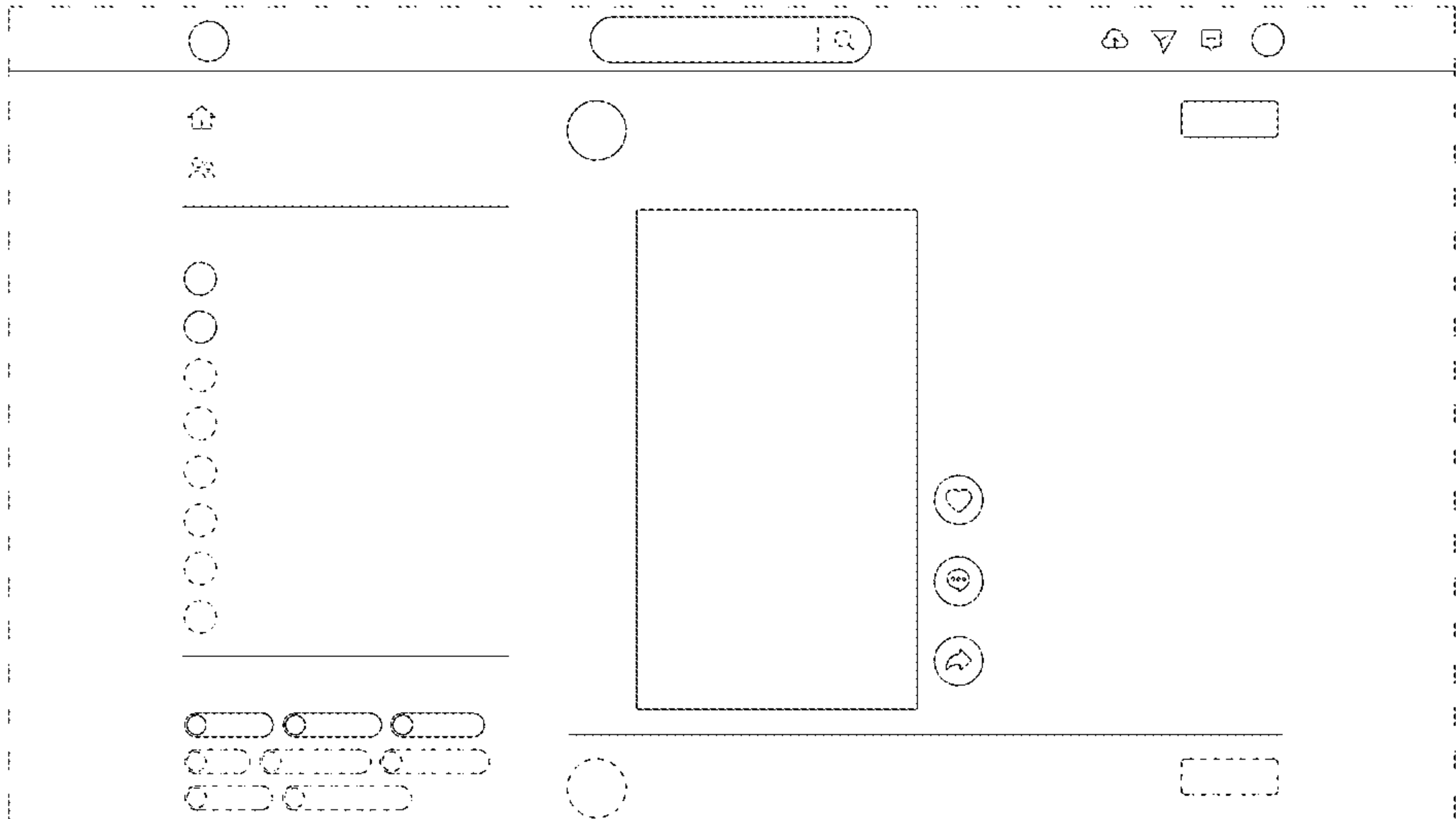
(57) **CLAIM**

I claim the ornamental design for a display screen or portion thereof with a graphical user interface, as shown and described.

DESCRIPTION

FIG.1 is a front view of a first embodiment of a display screen or portion thereof with a graphical user interface showing the new design;
FIG. 2 is a front view of a second embodiment thereof;
FIG. 3 is a front view of a third embodiment thereof;
FIG. 4 is a front view of a fourth embodiment thereof; and,
FIG. 5 is a front view of a fifth embodiment thereof.

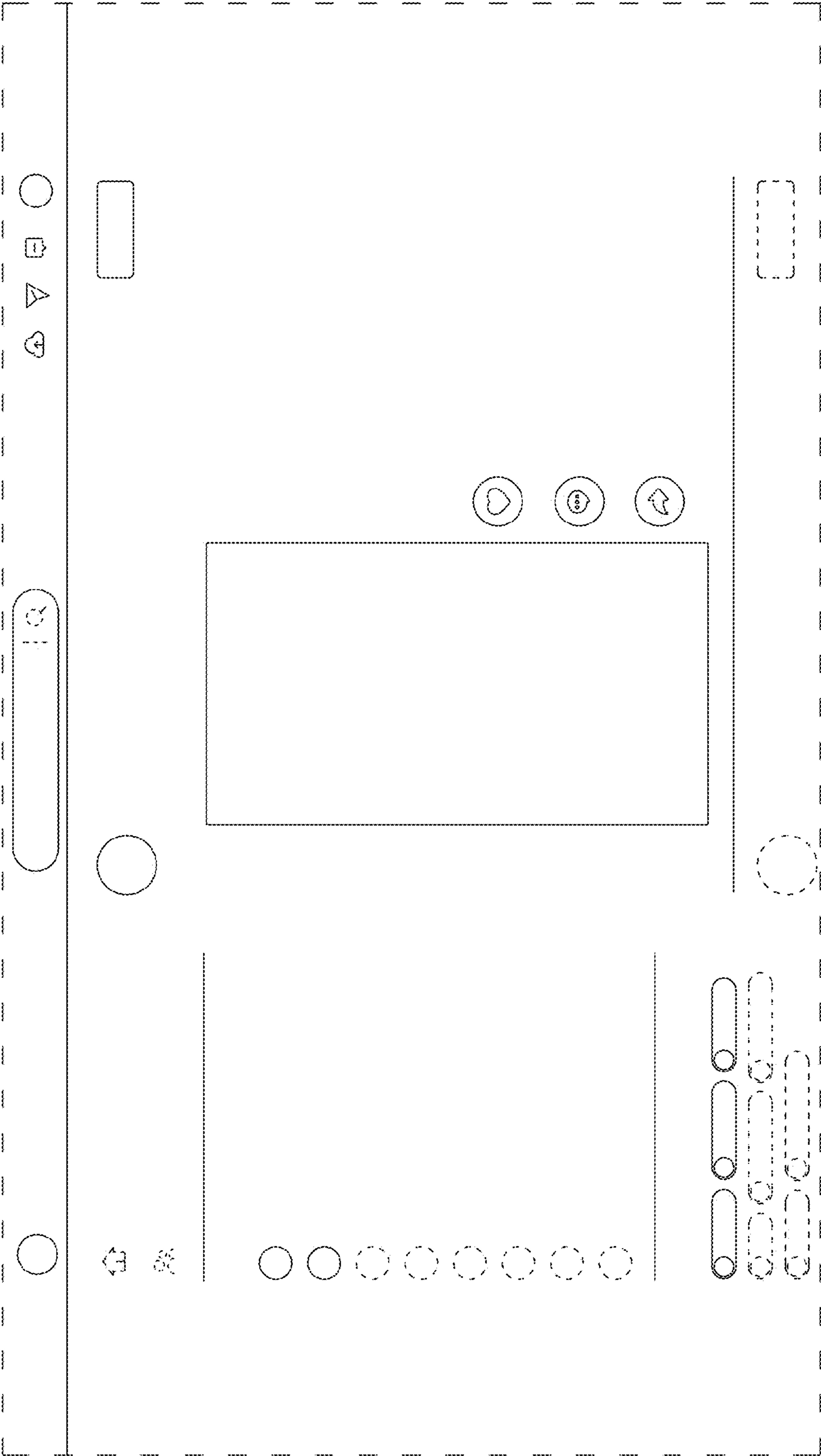

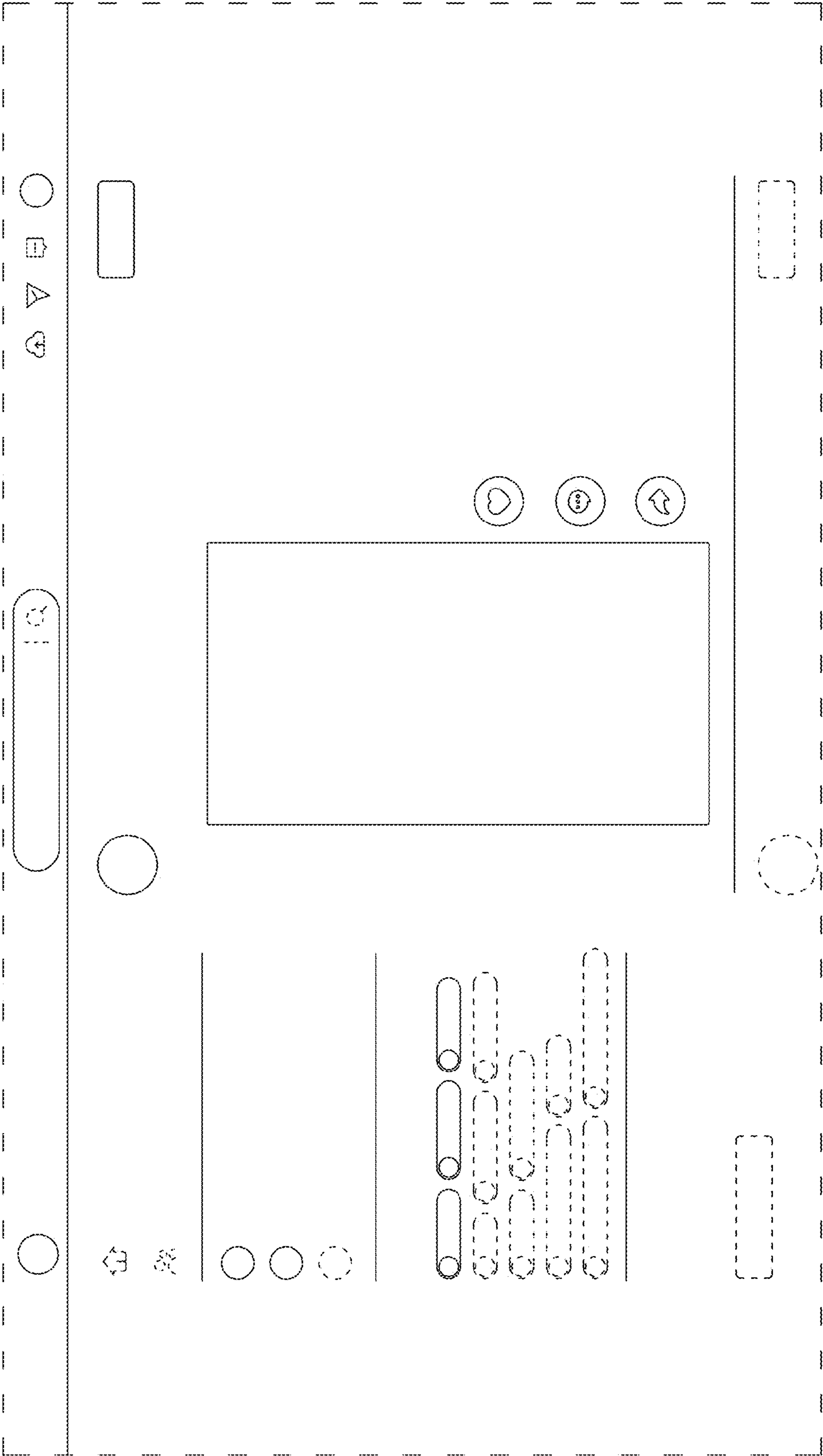

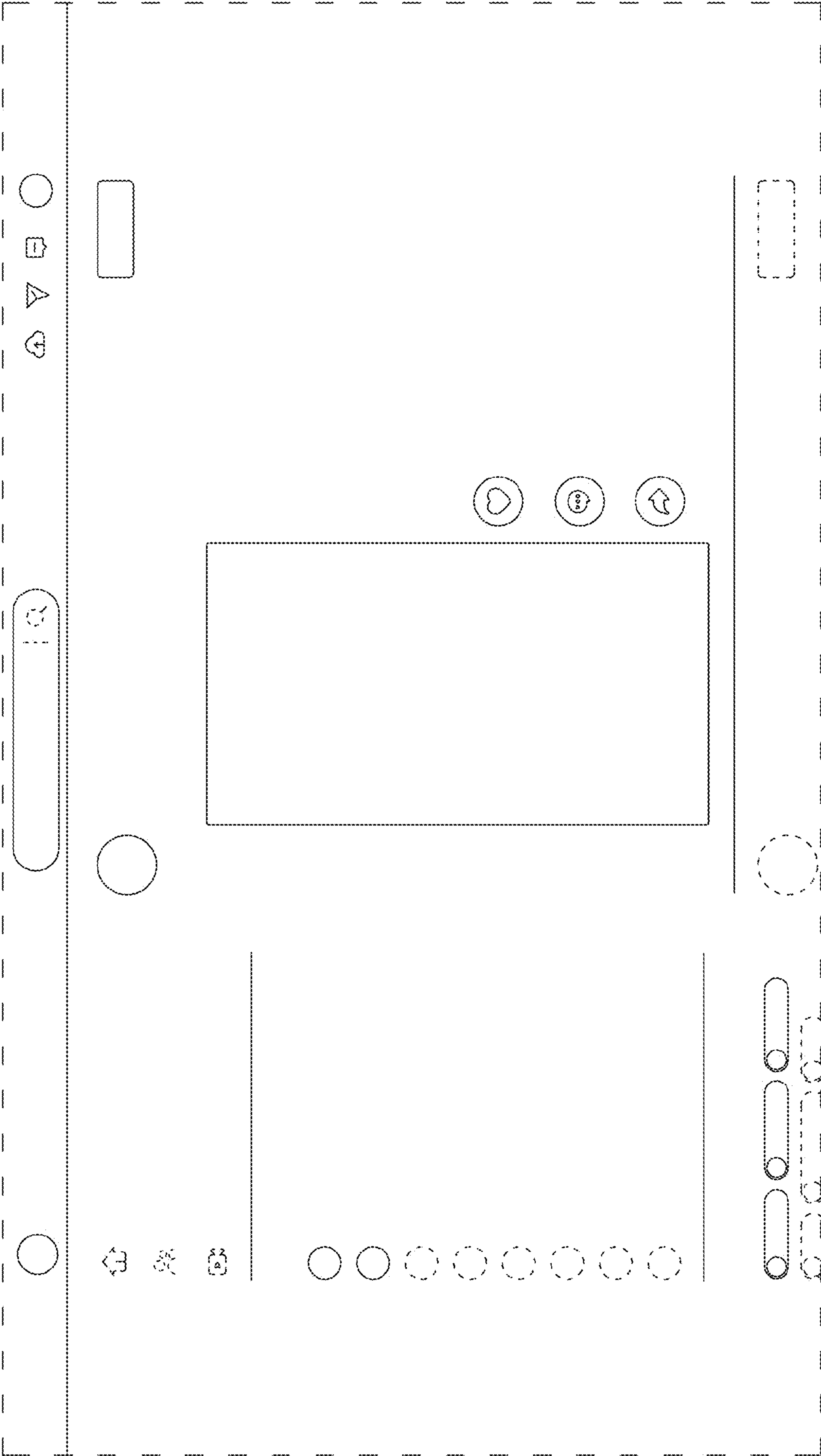

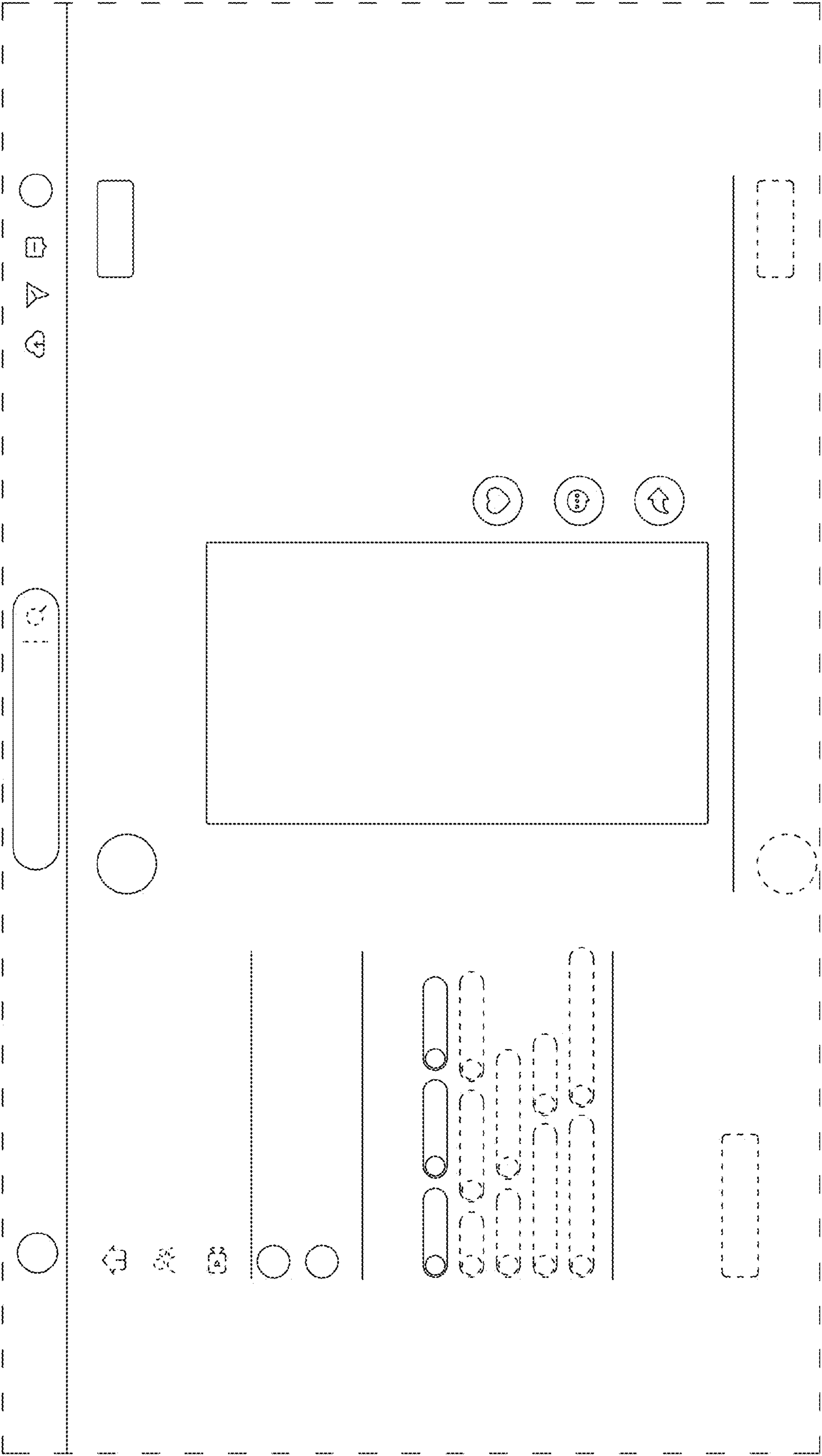

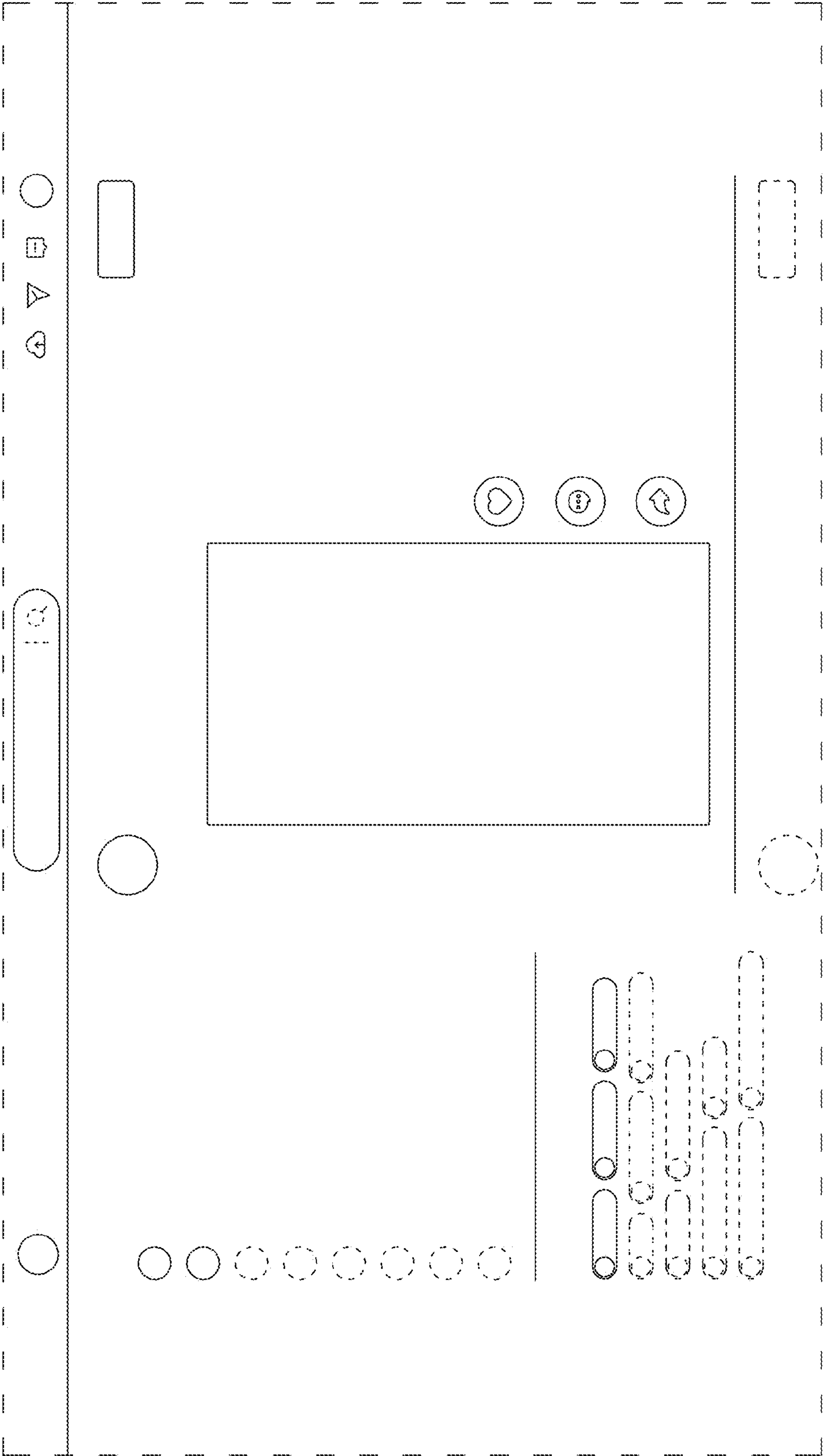
