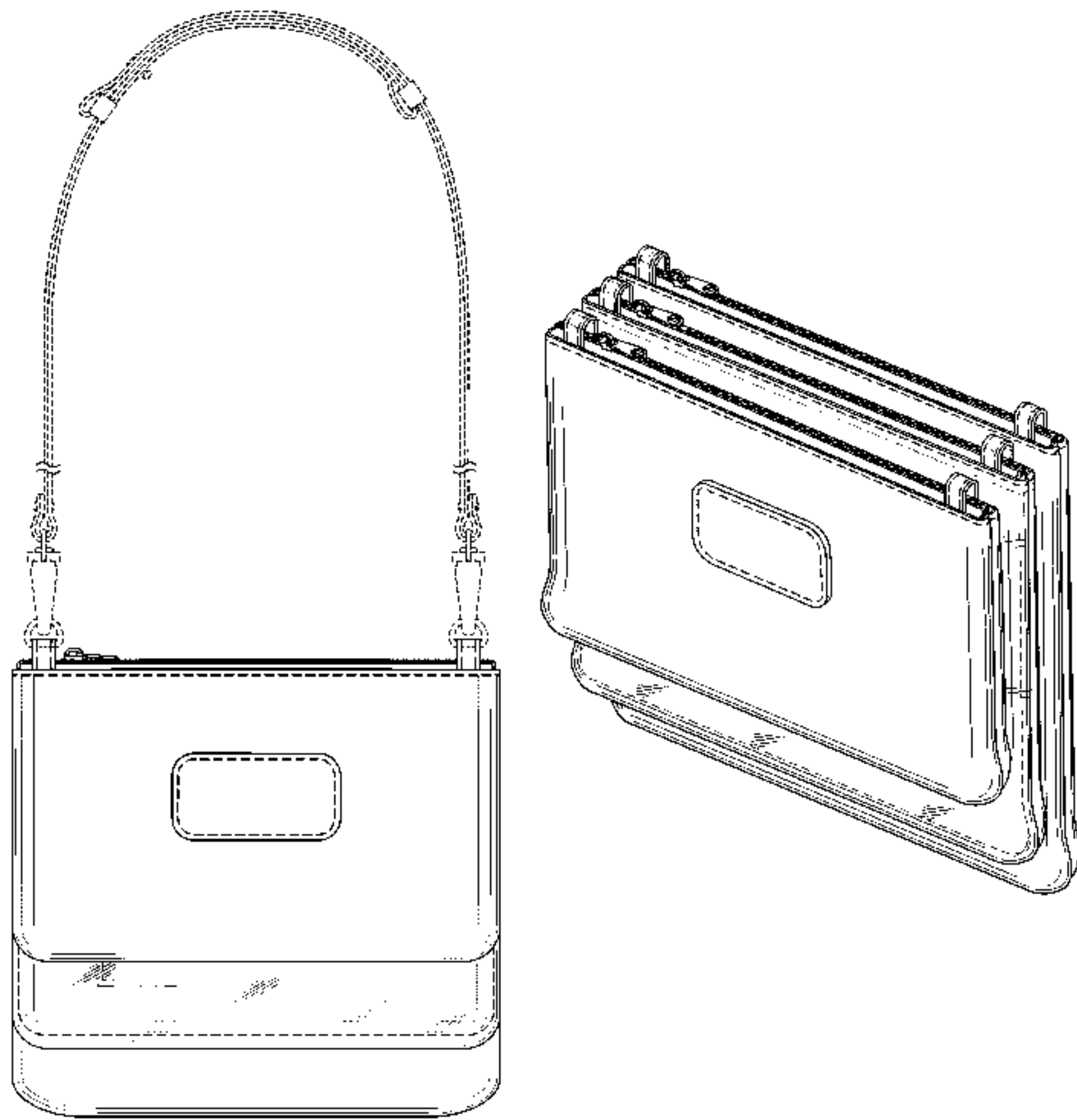

An ornamental design for a hand bag as shown and described.

DESCRIPTION

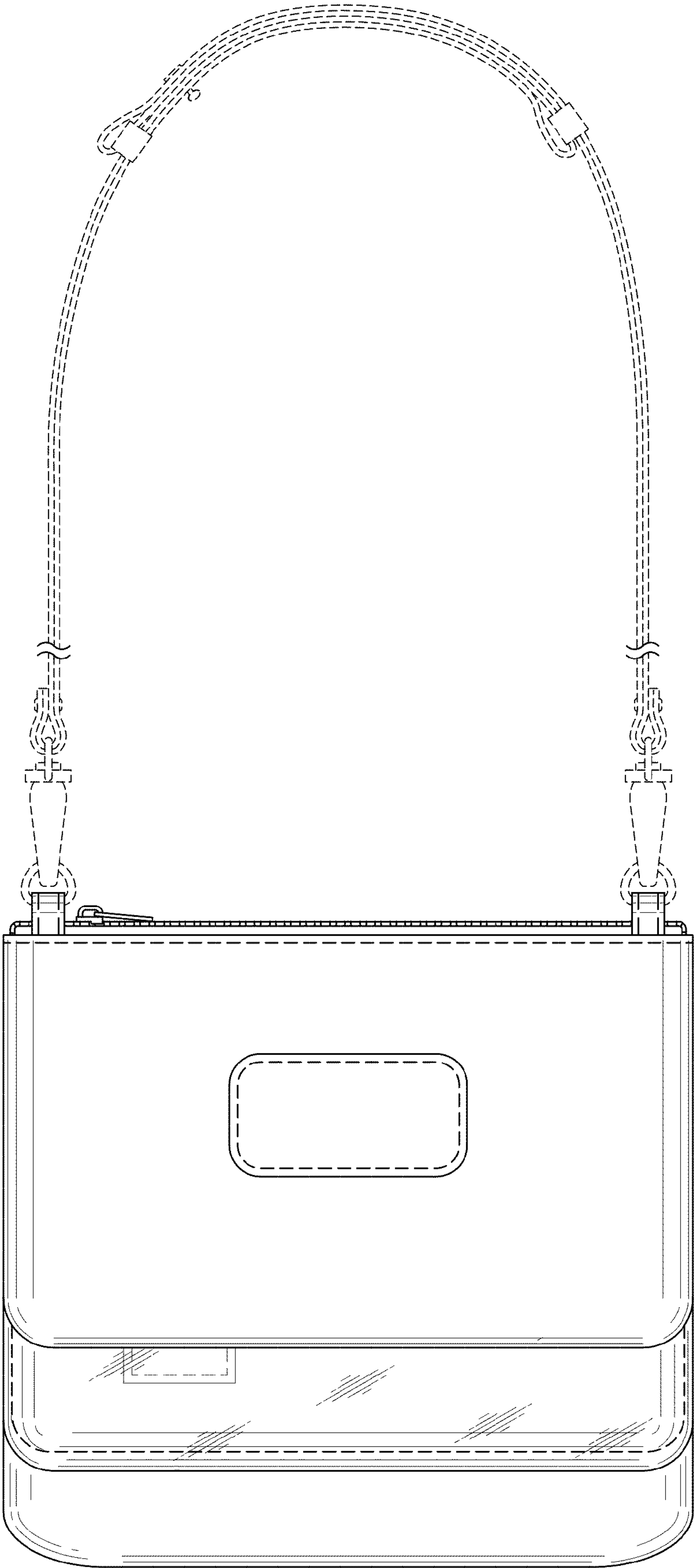

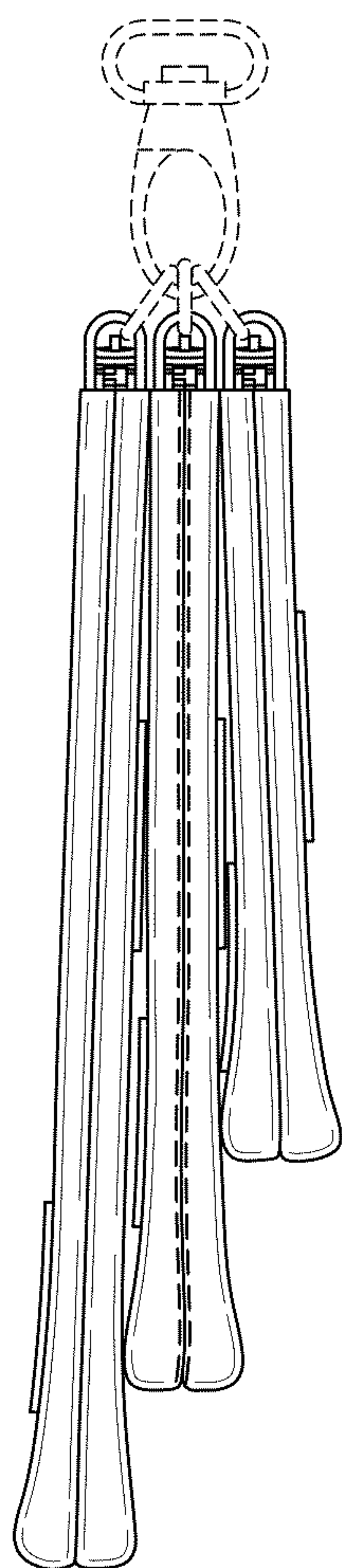

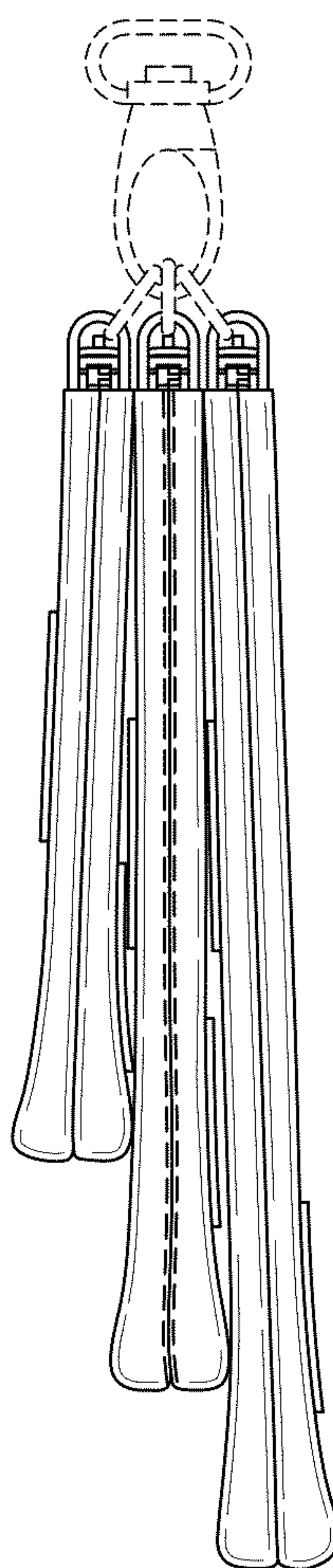

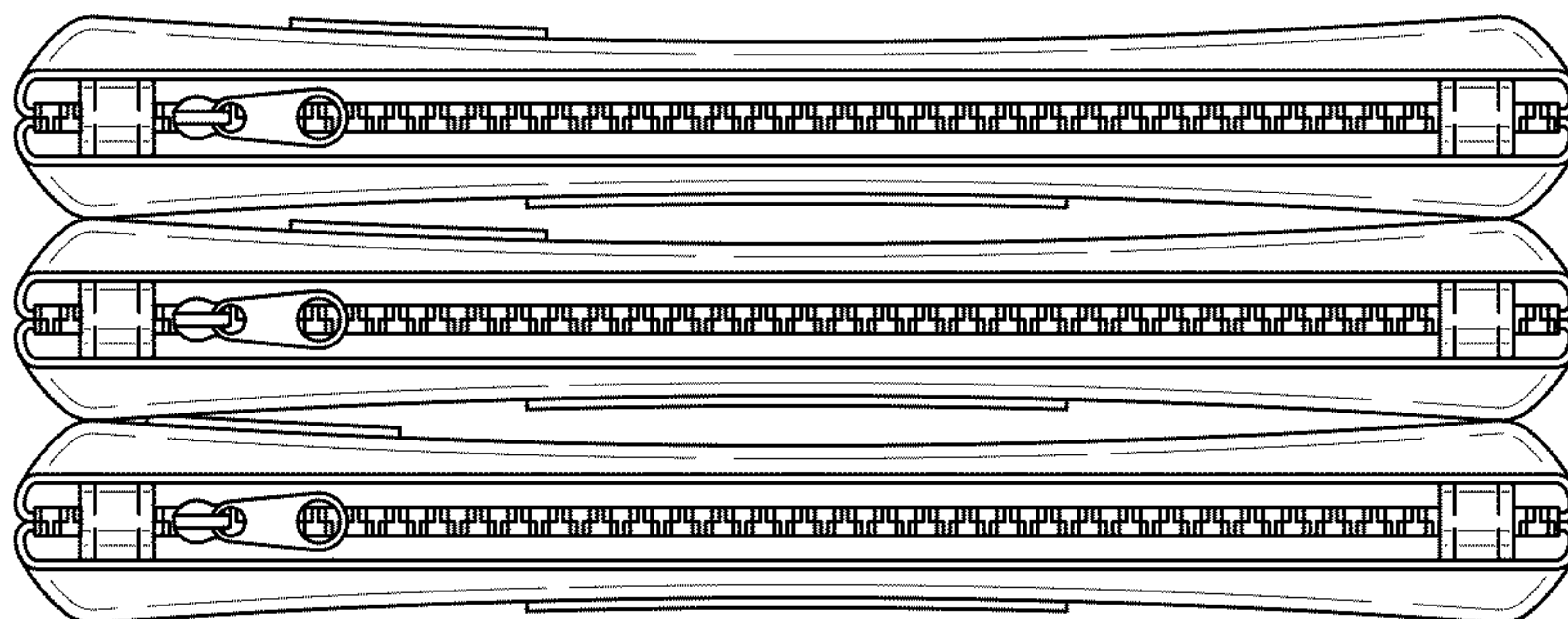

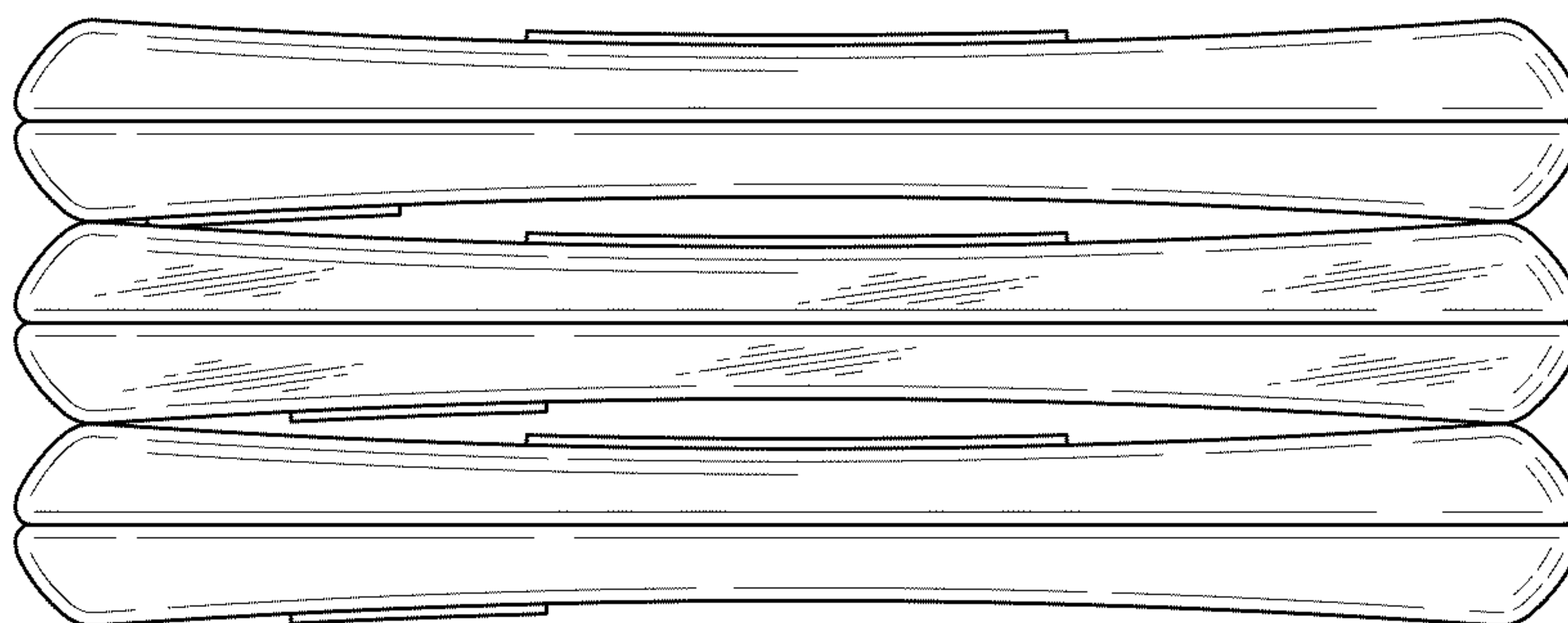

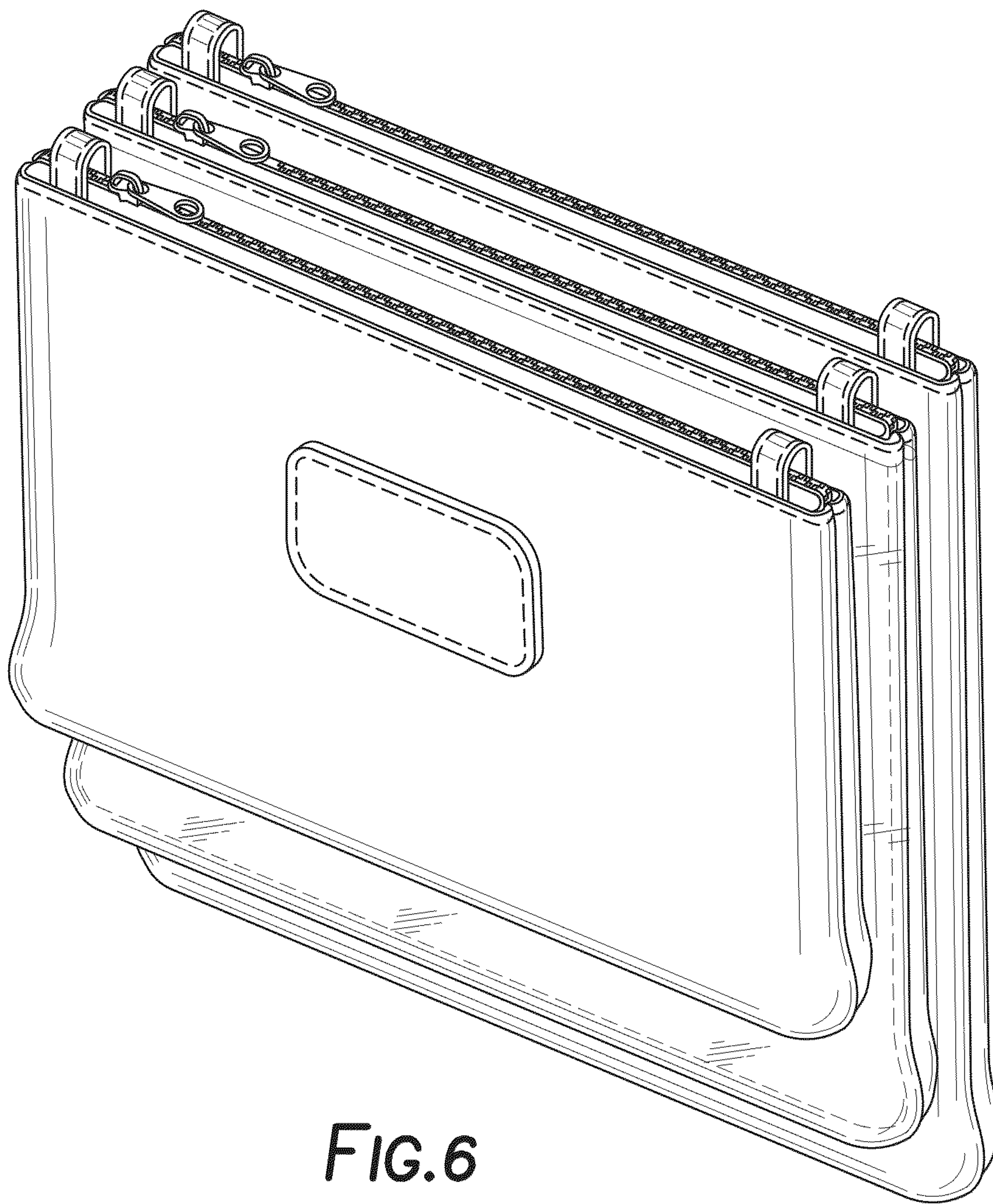

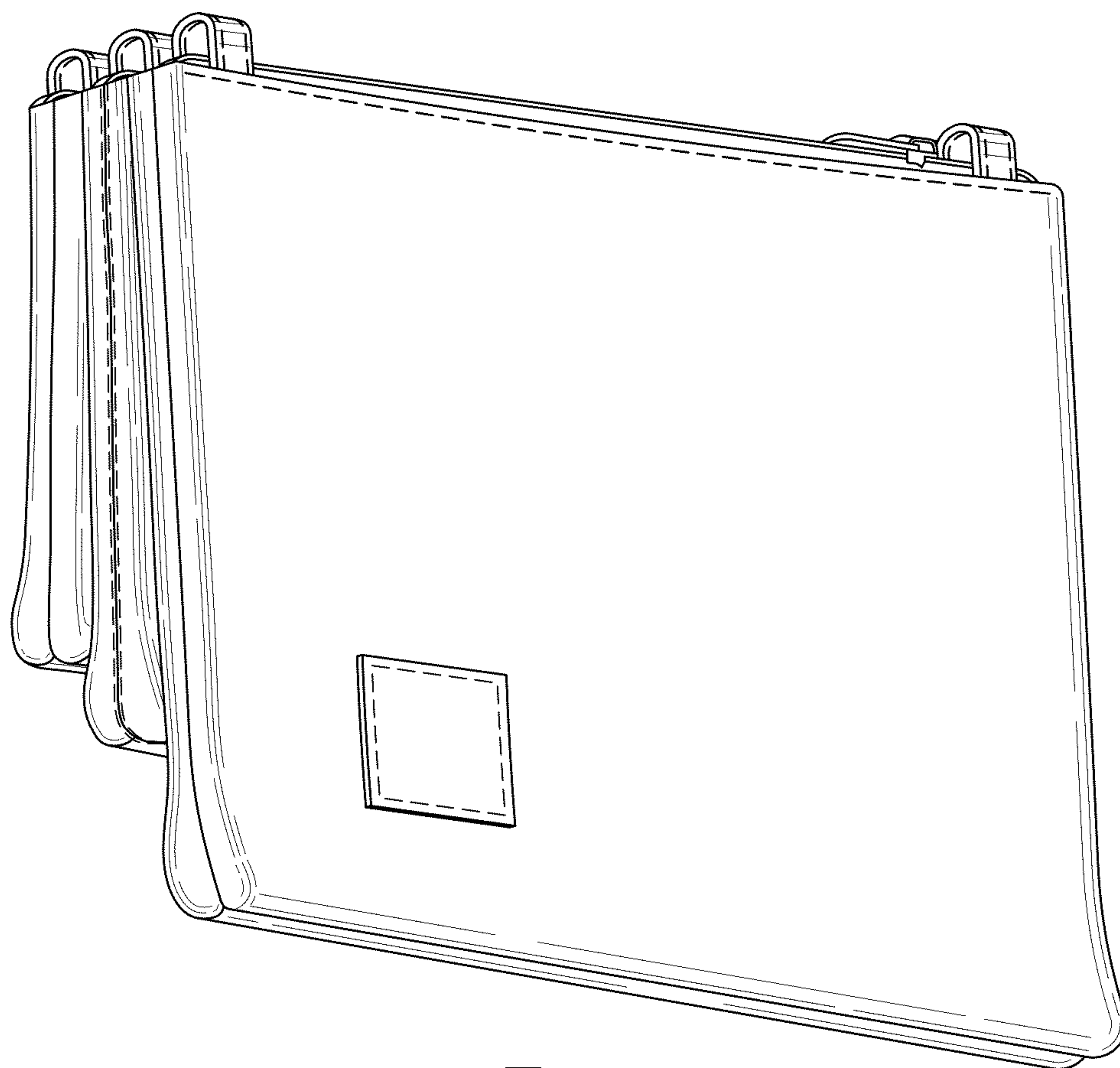

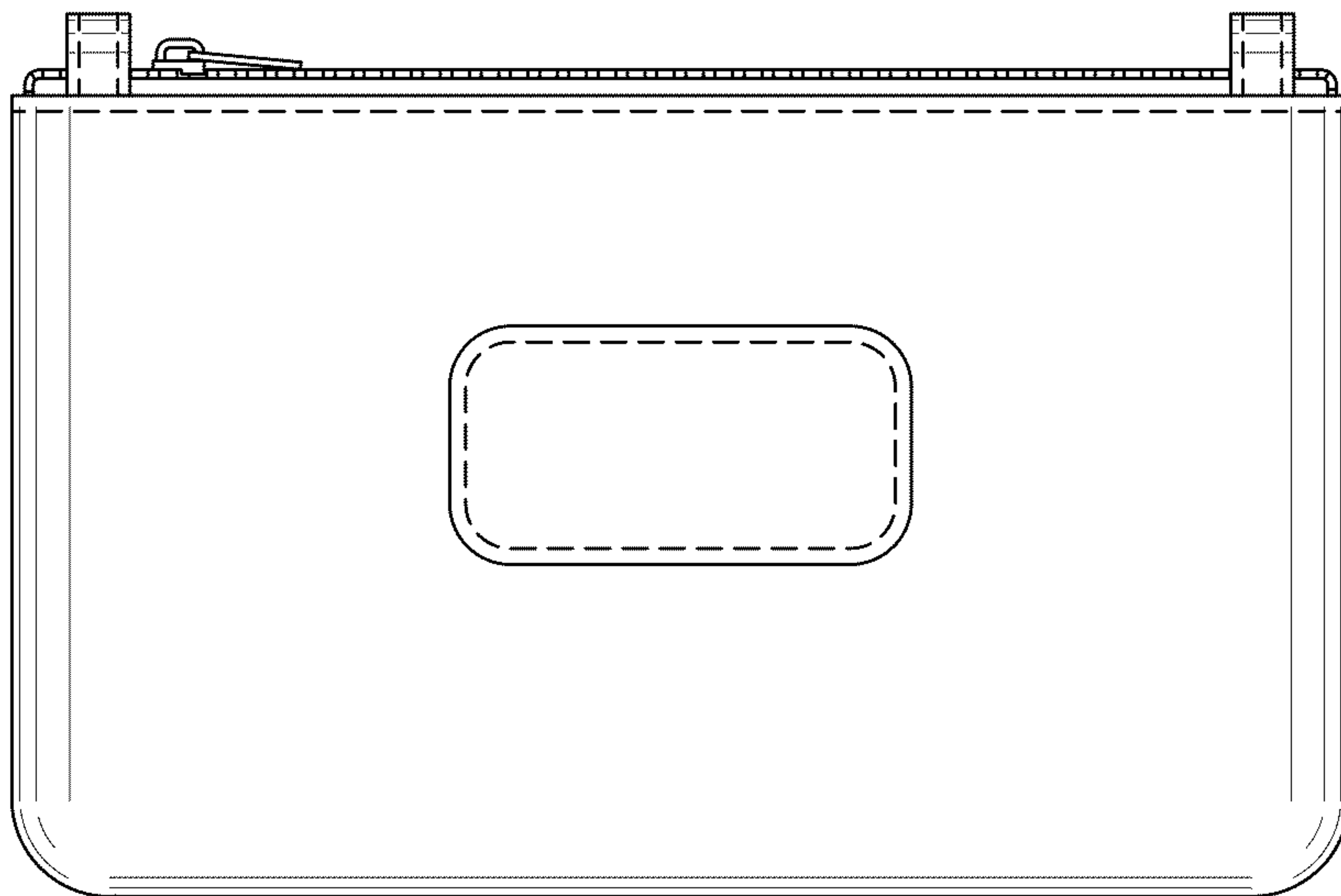

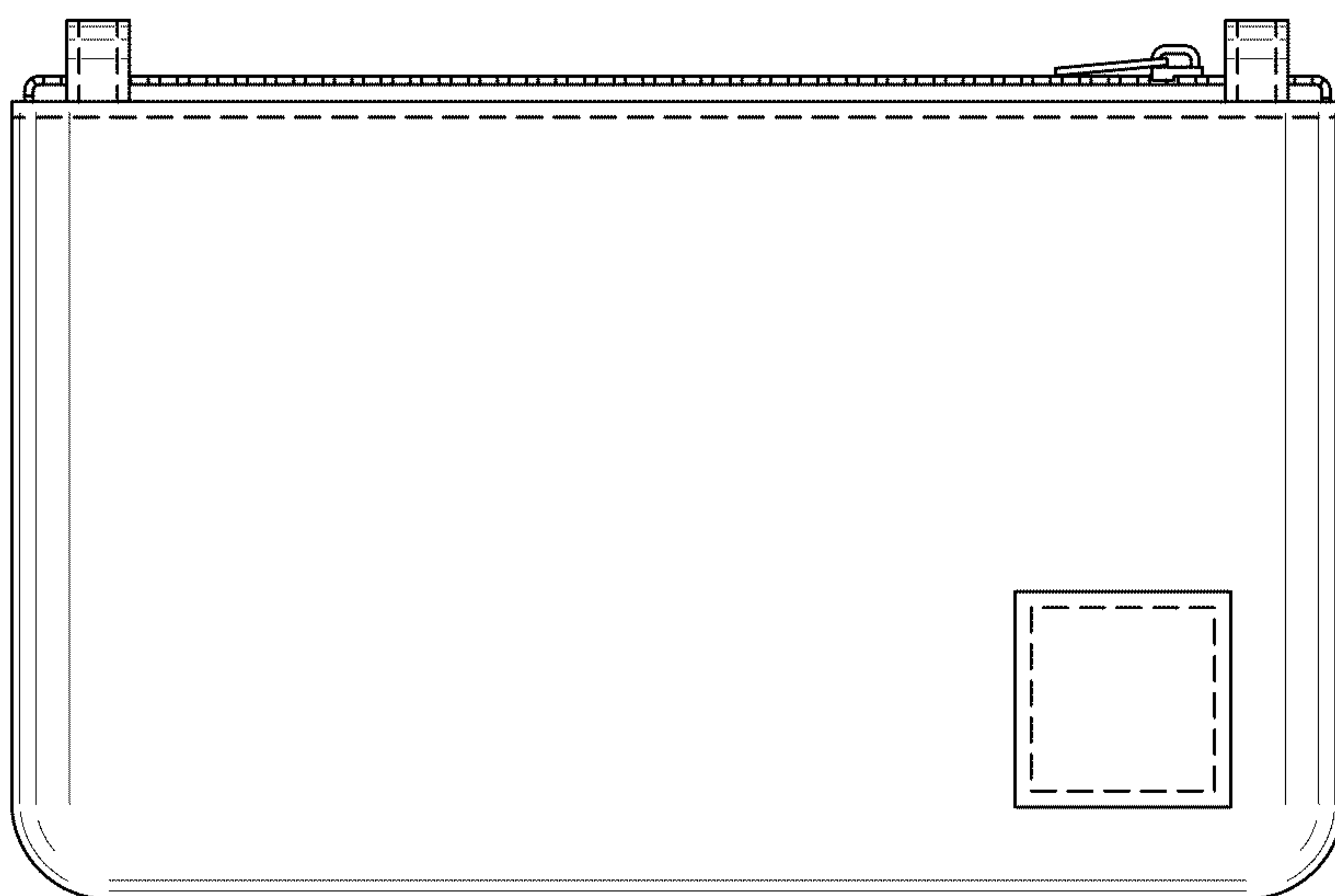

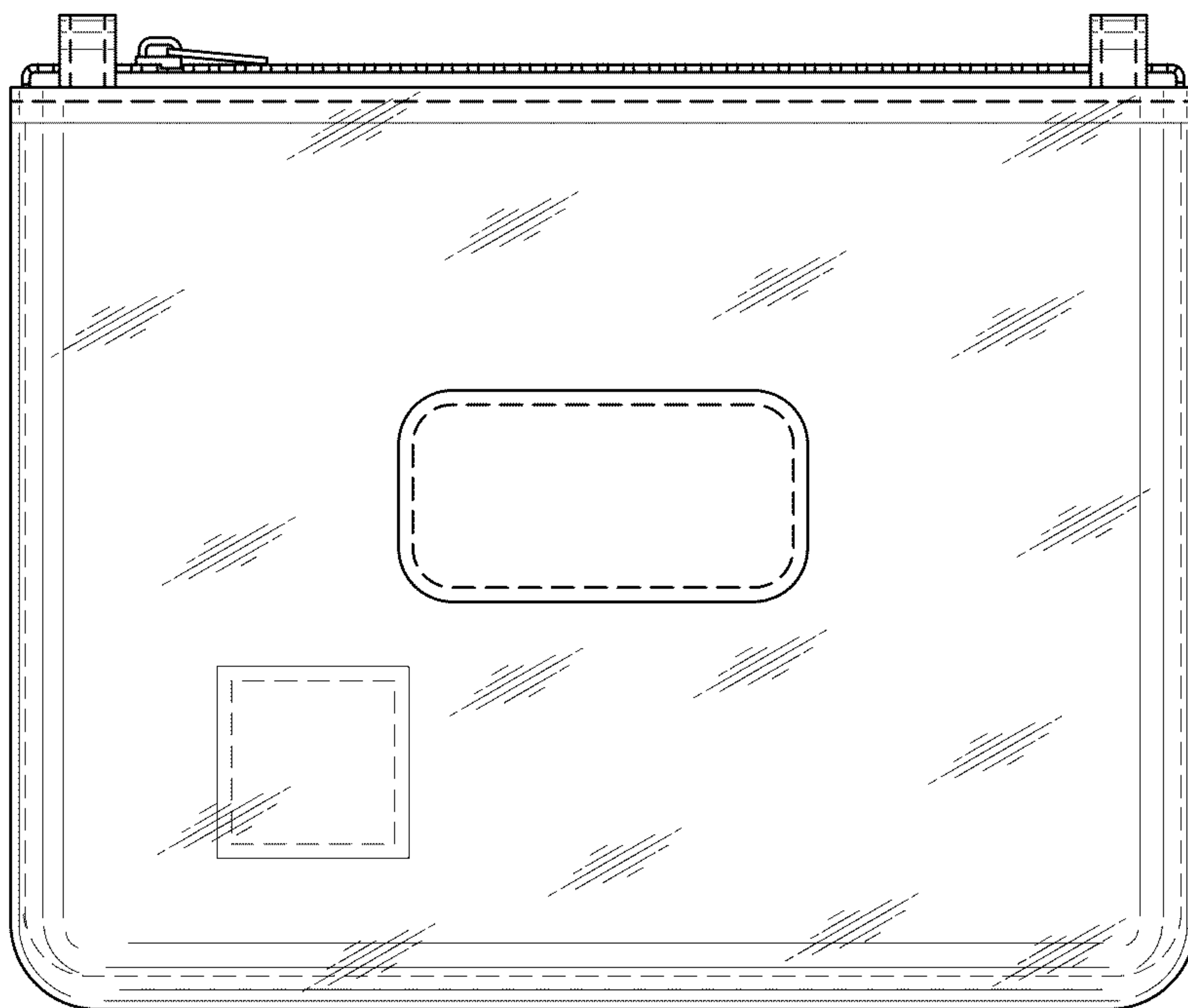

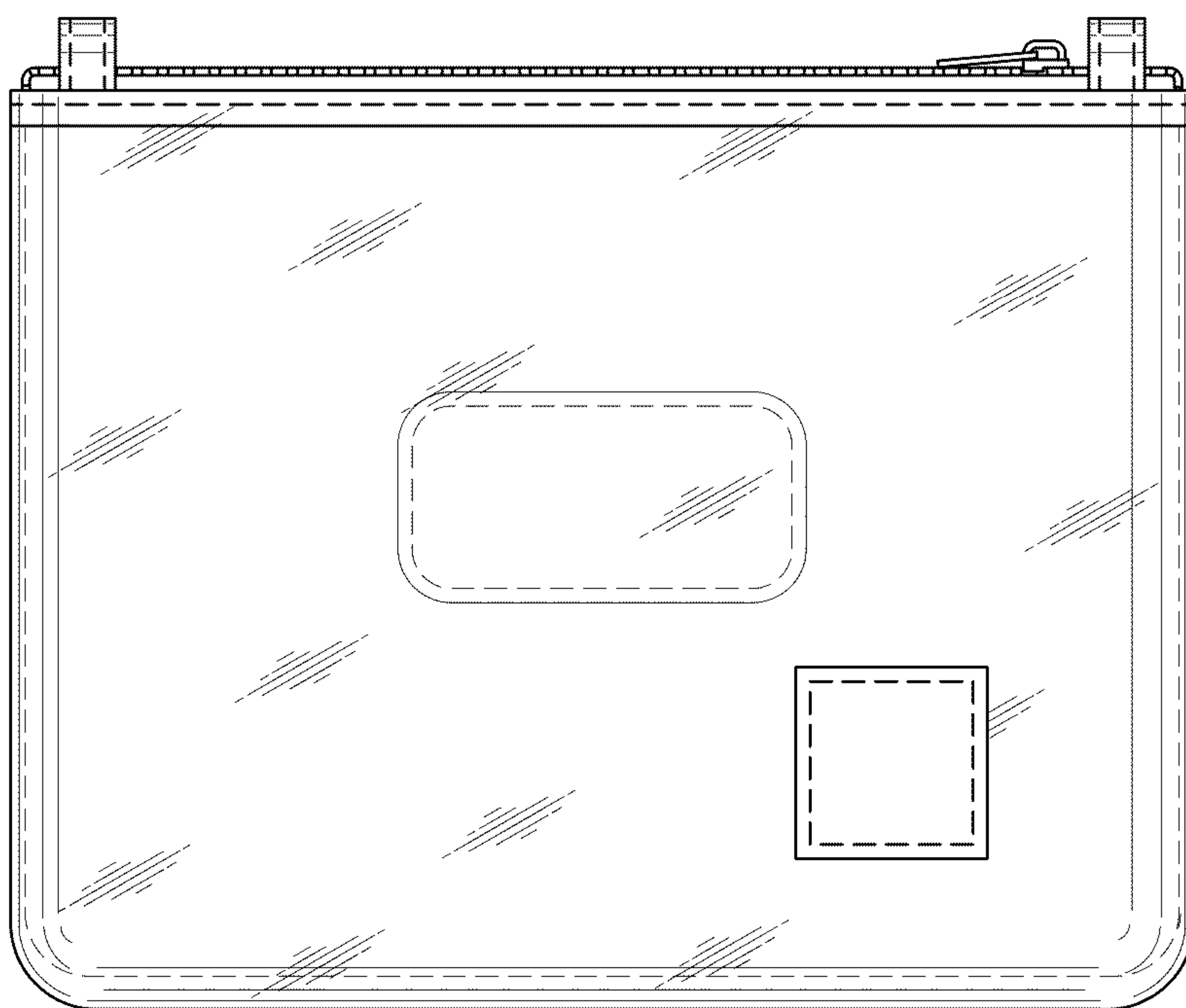

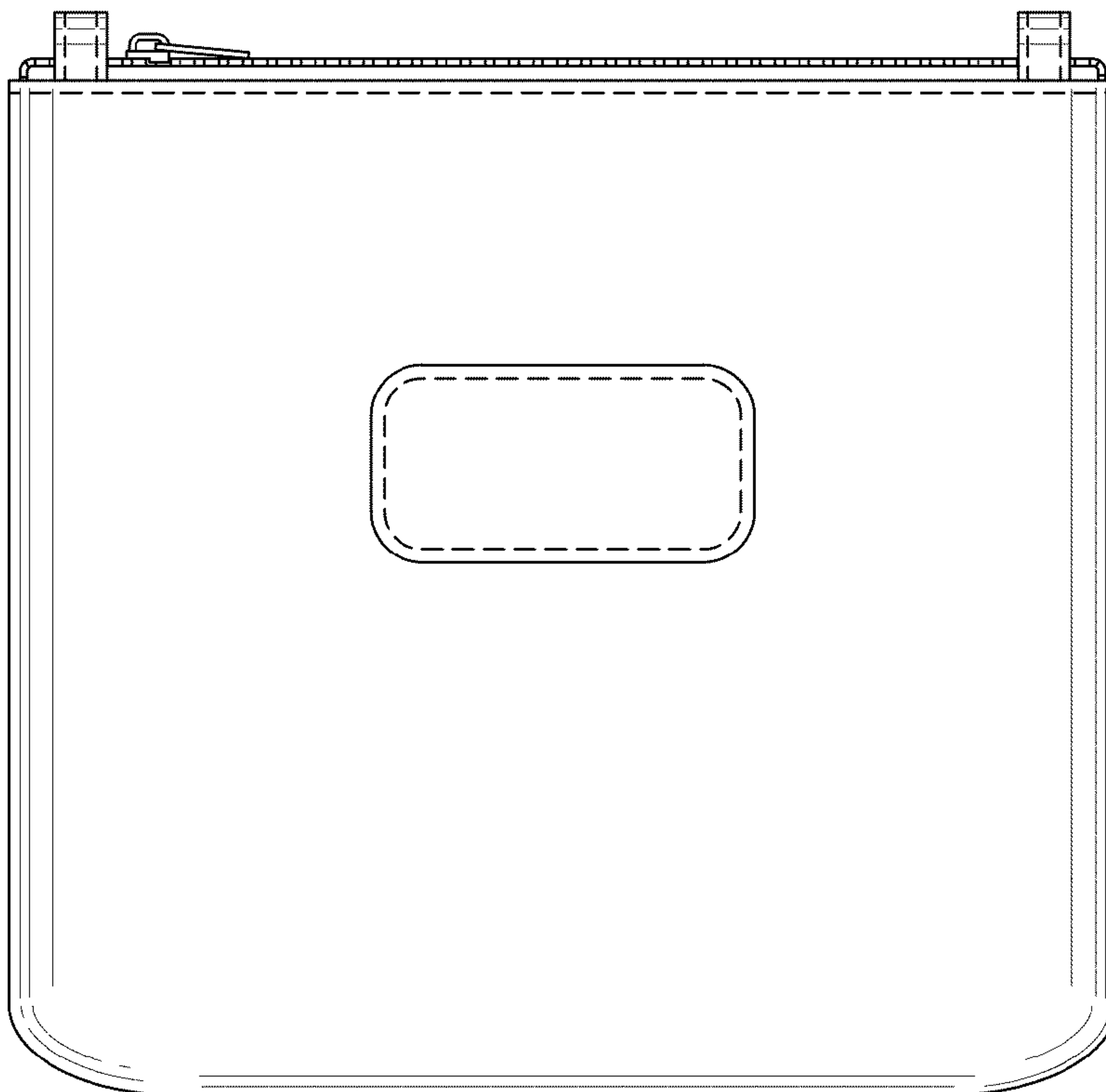

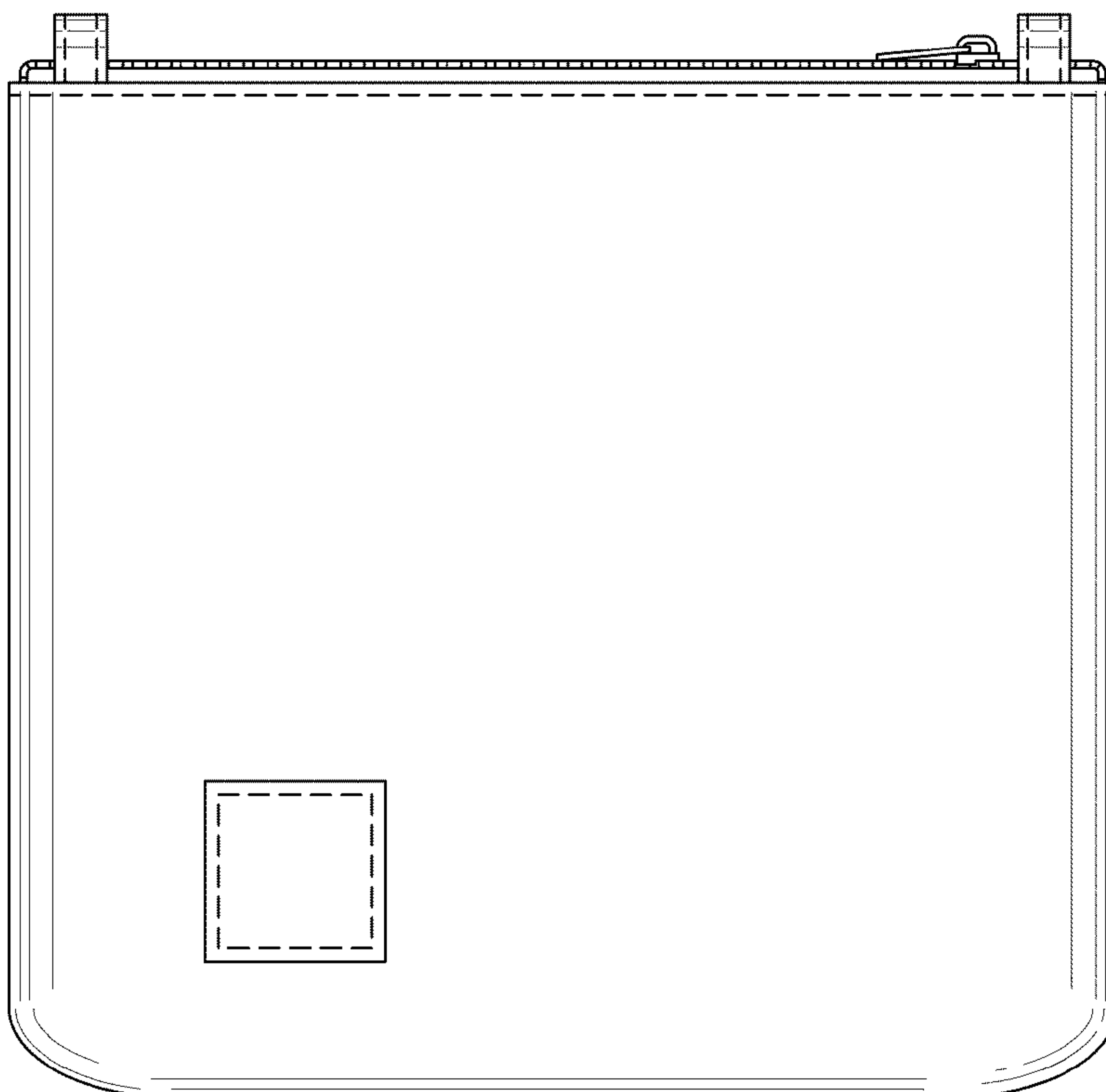

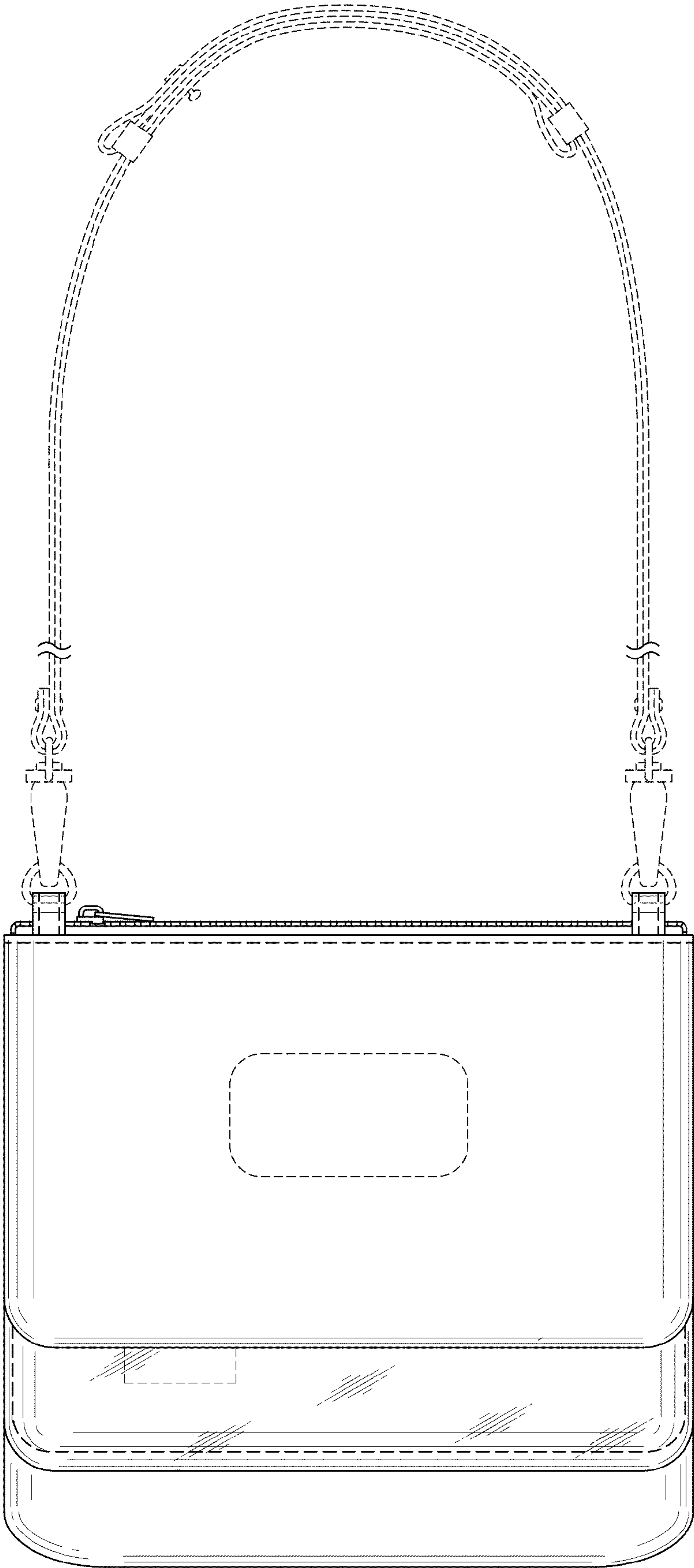

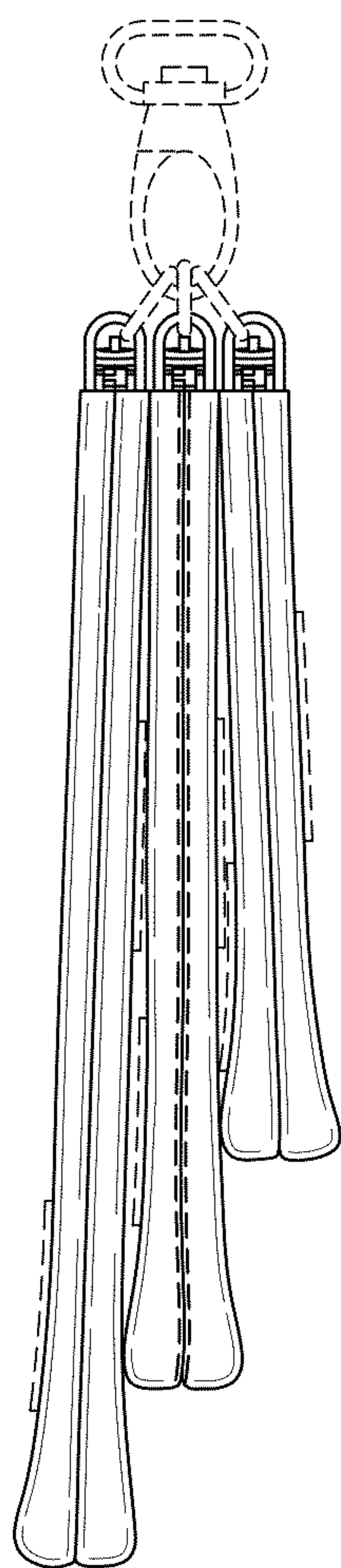

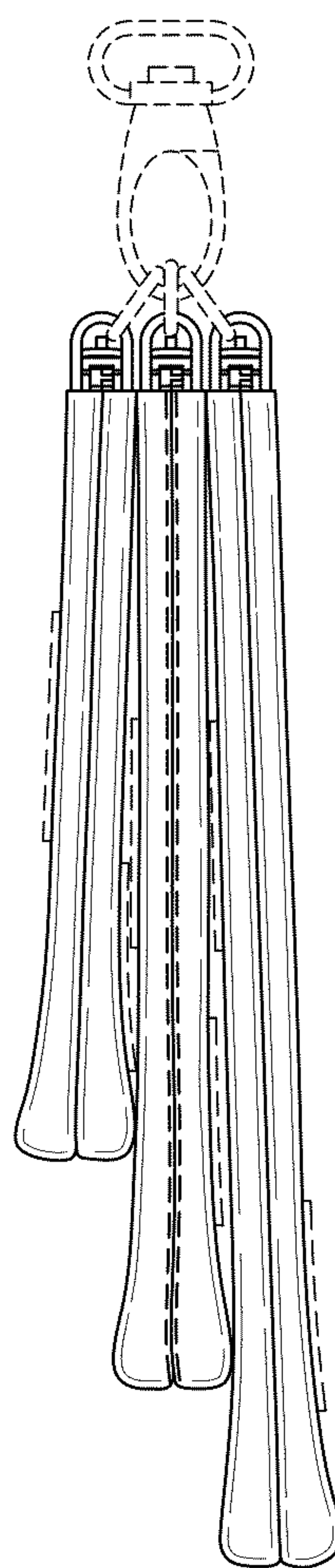

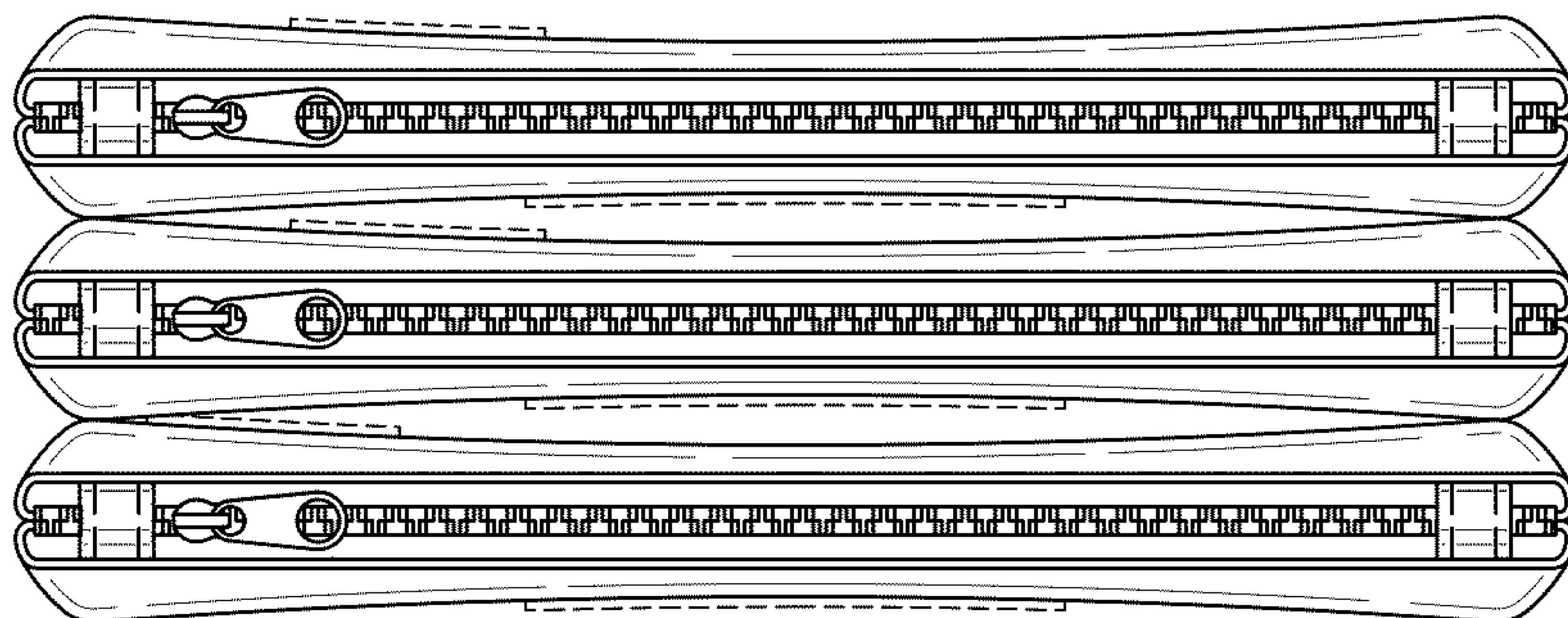

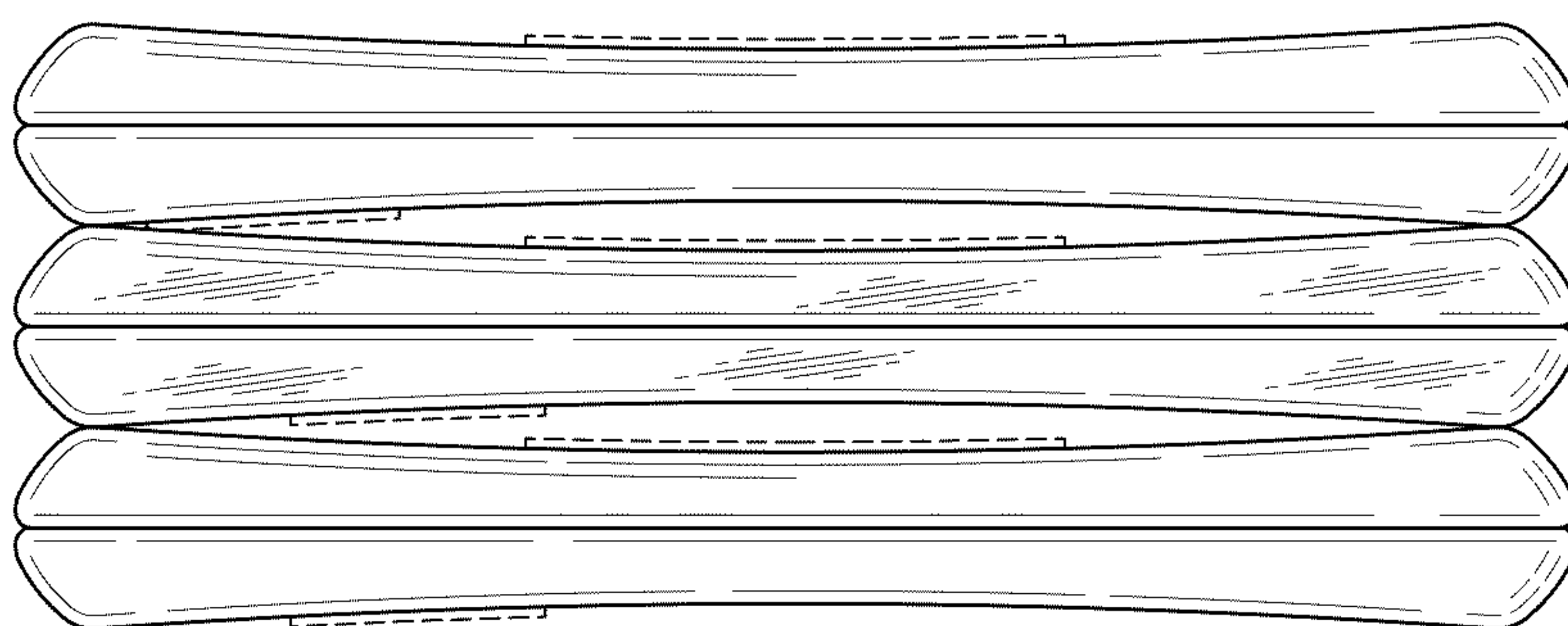

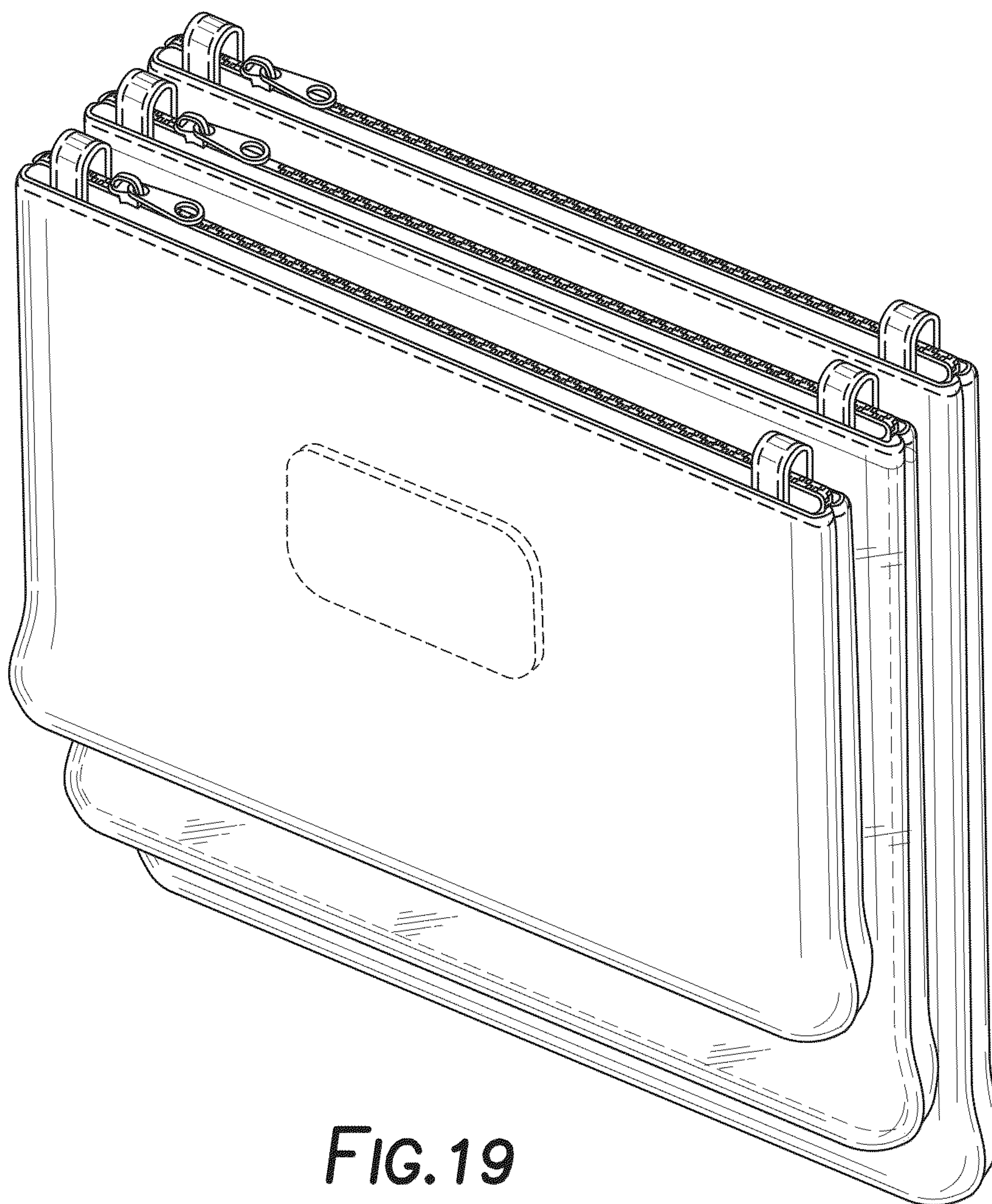

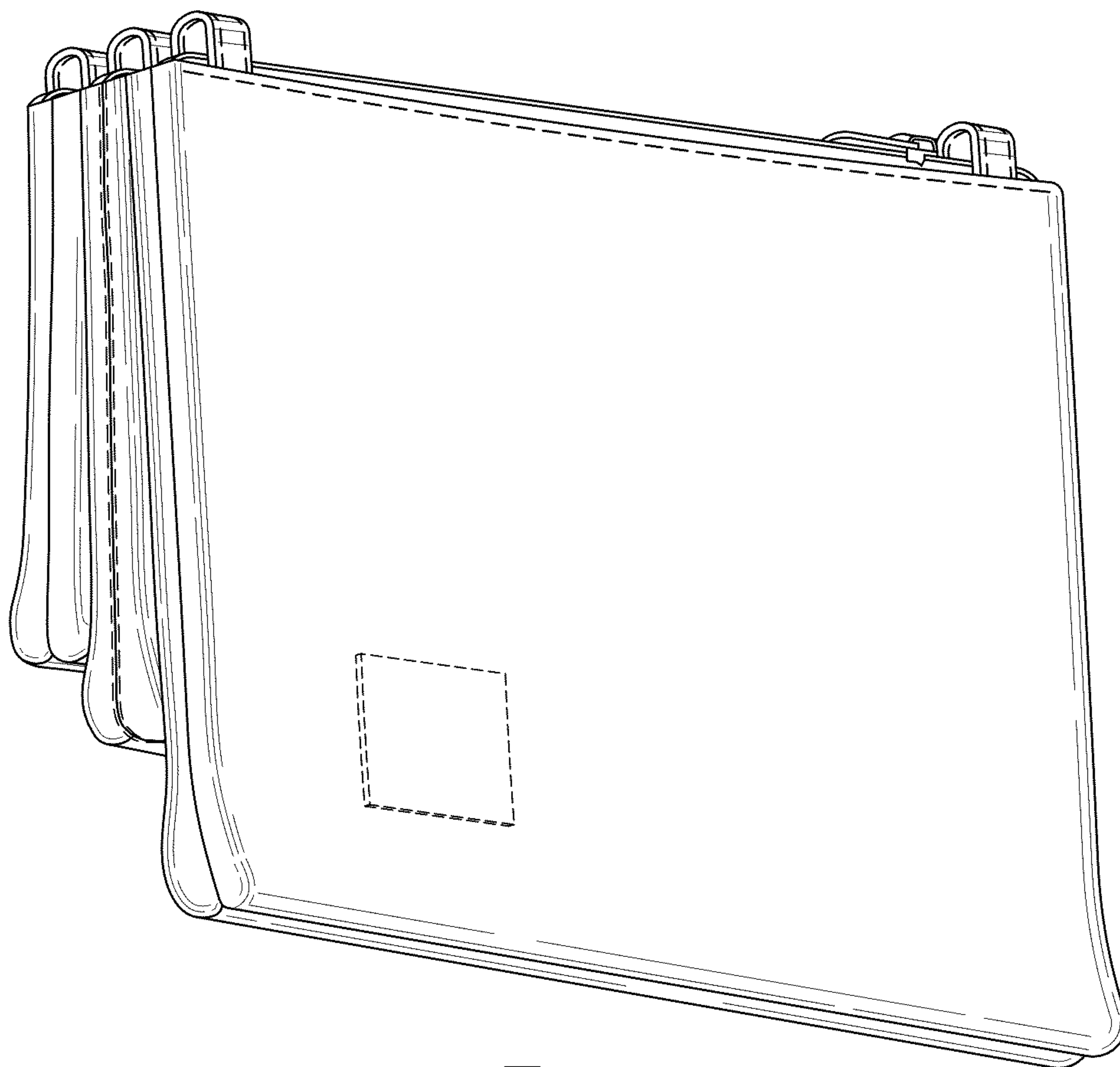

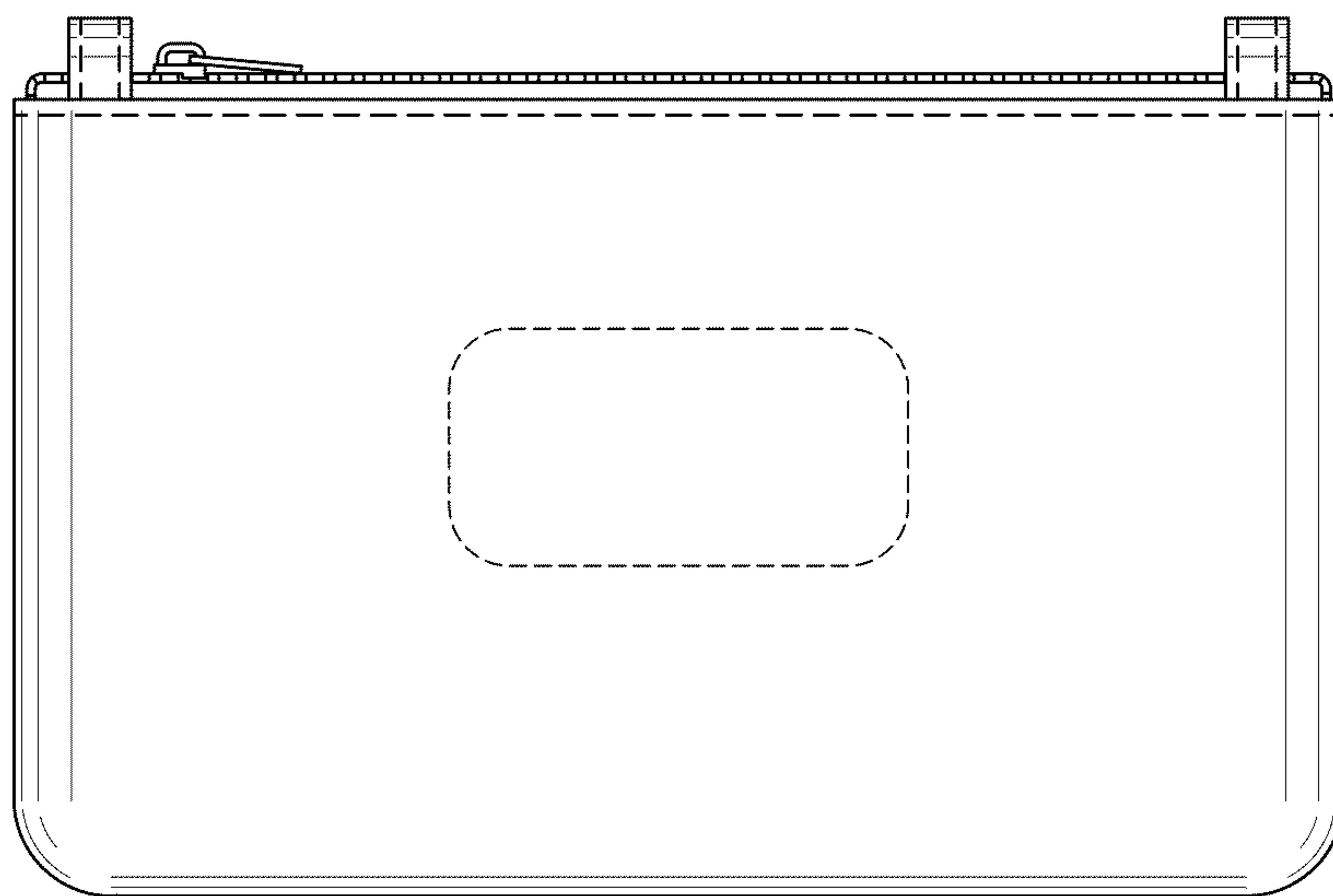

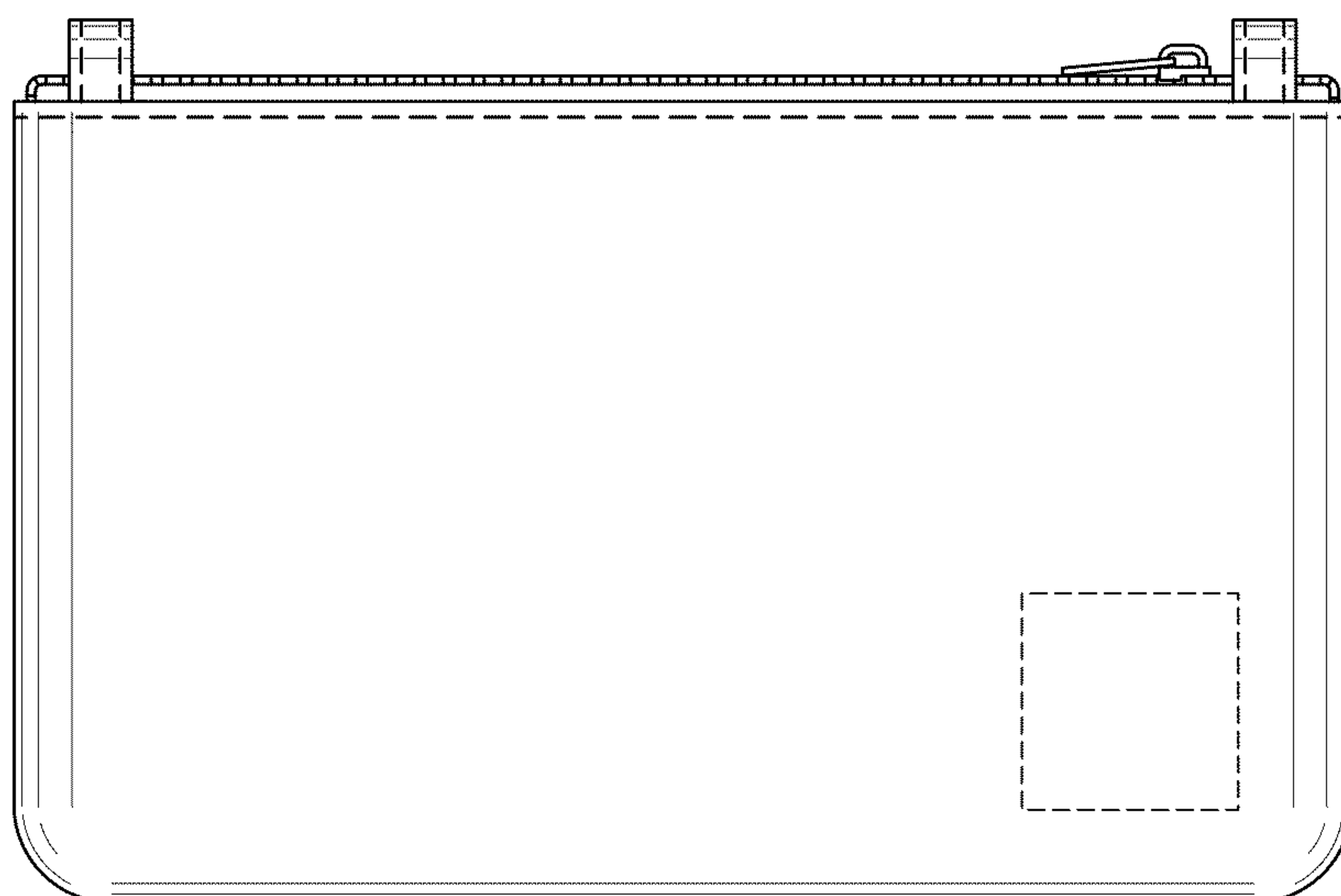

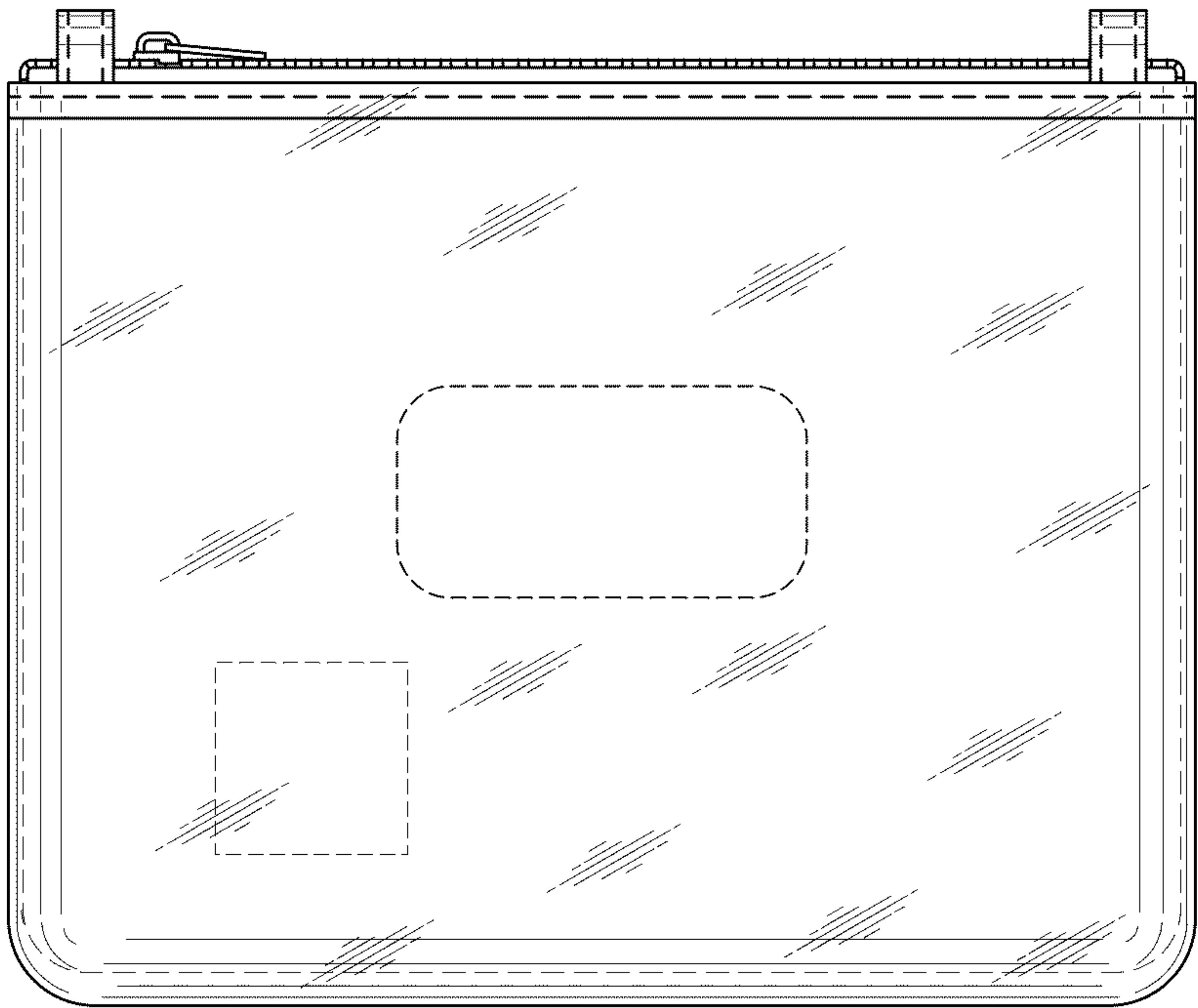

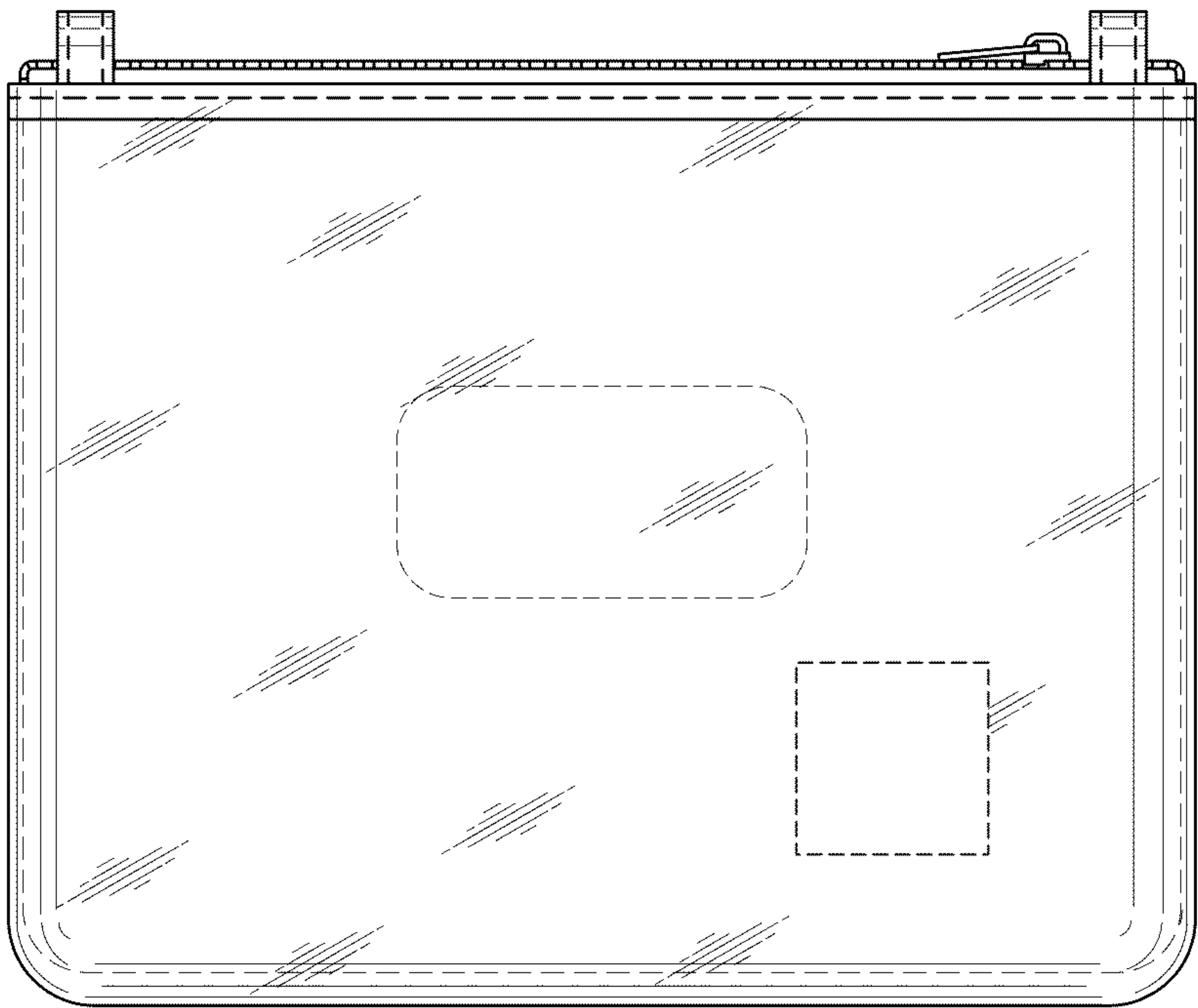

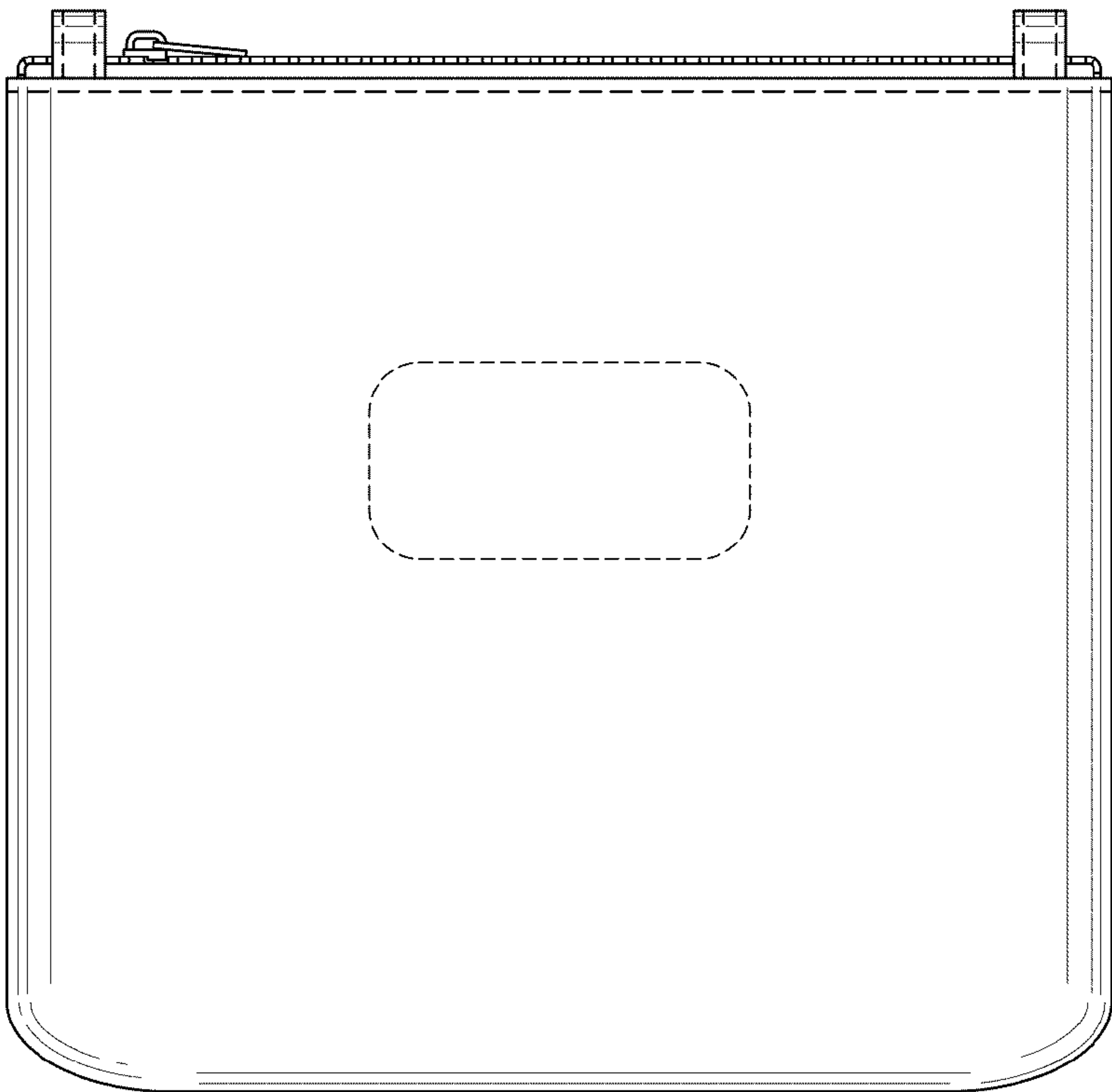

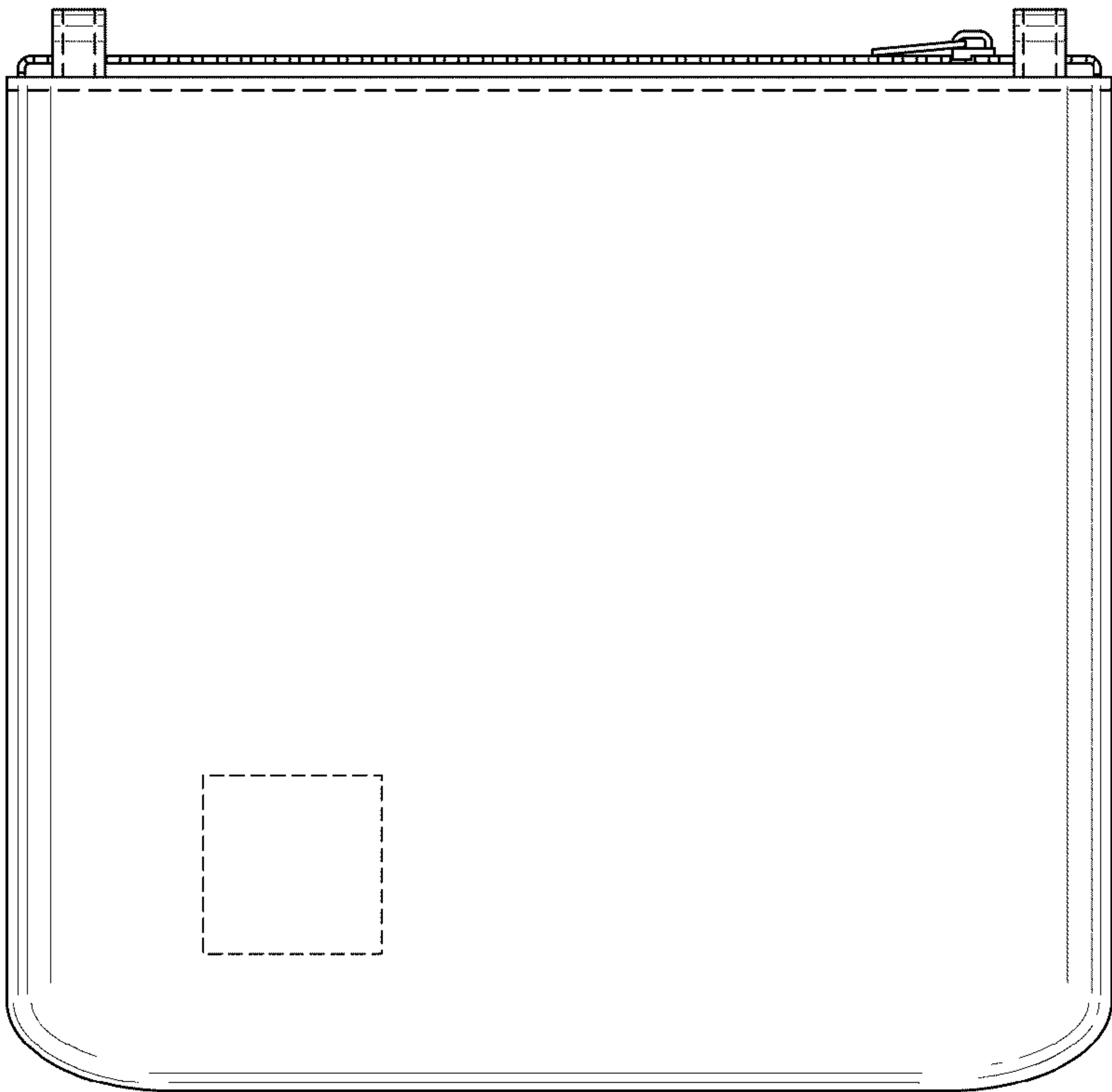
