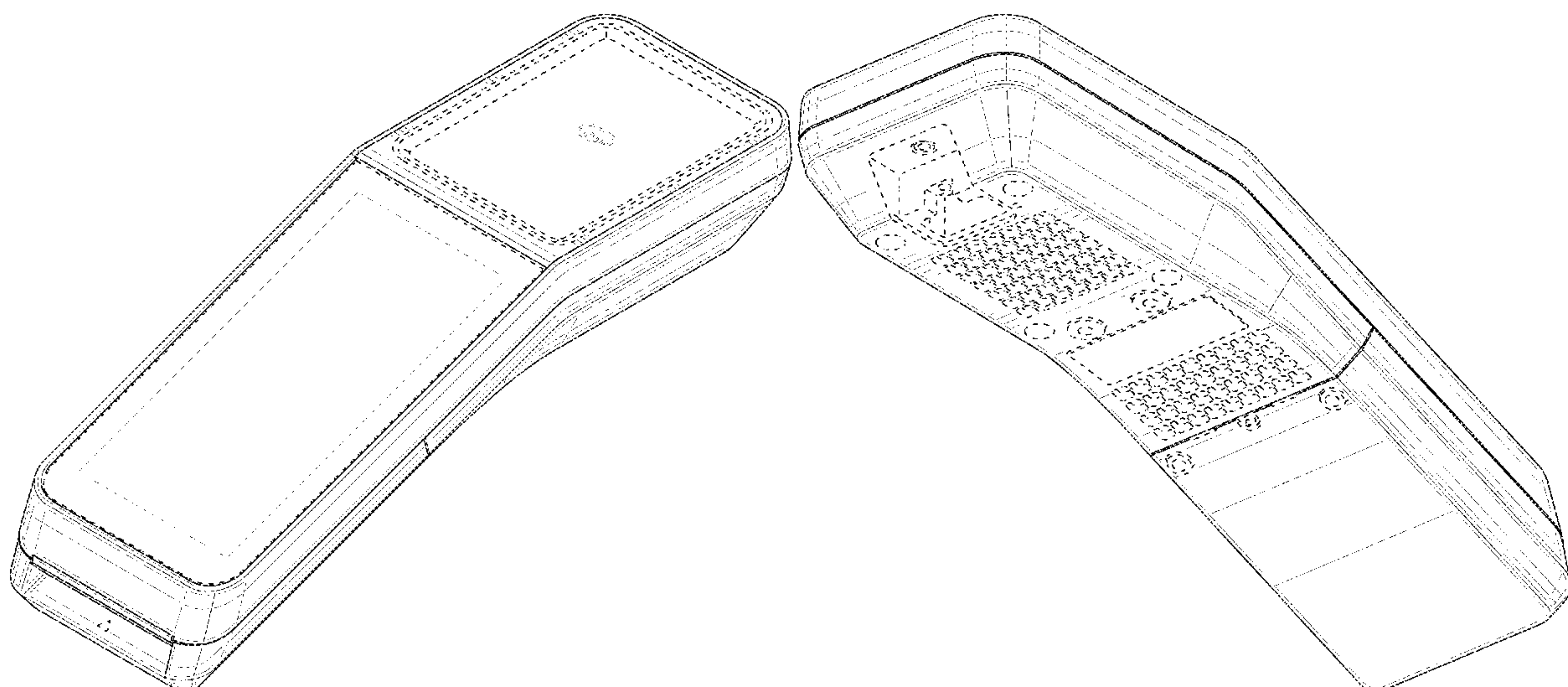
(57) **CLAIM**

The ornamental design for a user recognition device, as shown and described.

DESCRIPTION

FIG. 1 is a top, front, right-side perspective view of a user recognition device;
FIG. 2 is a bottom, back, left-side perspective view thereof;

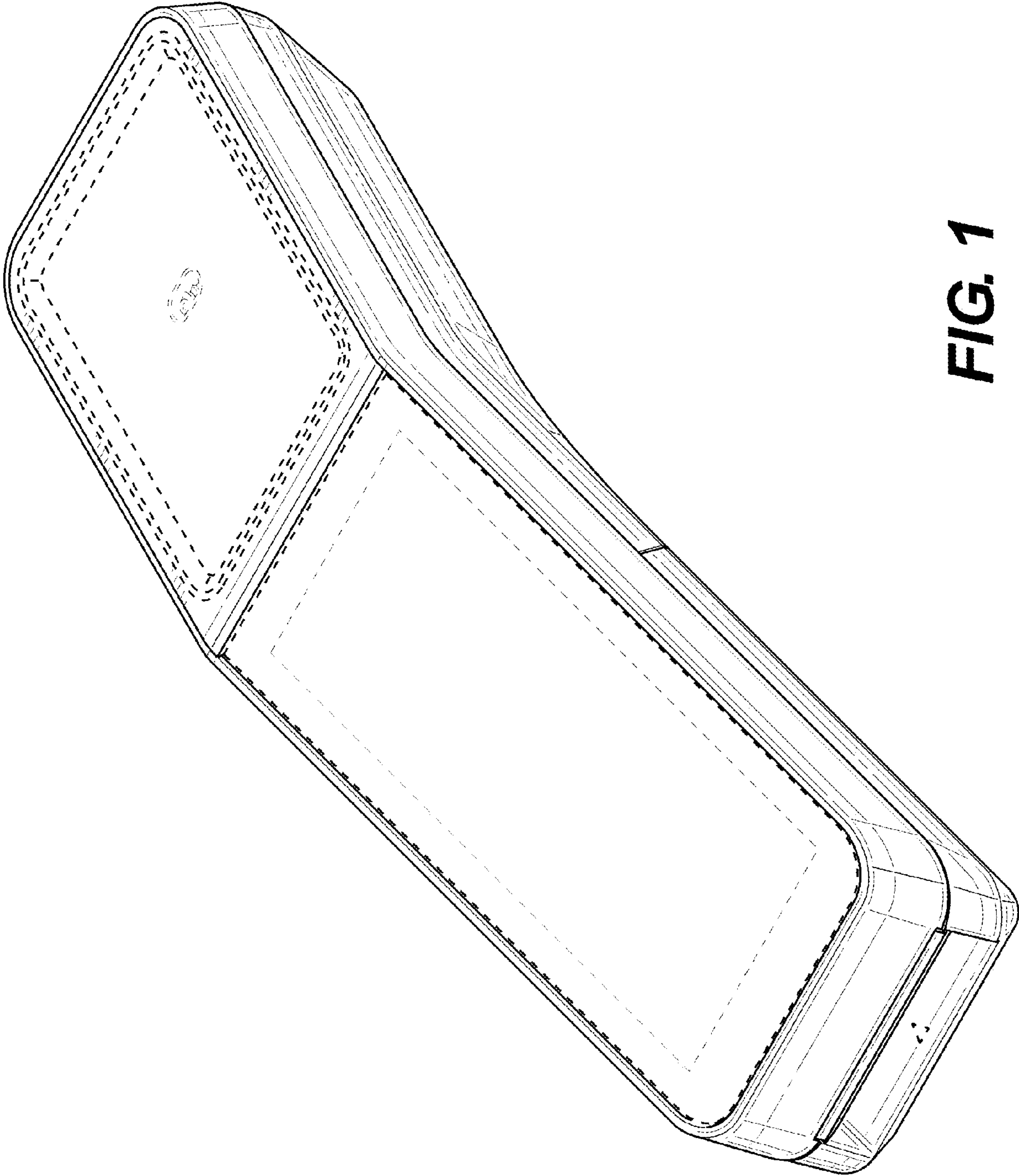

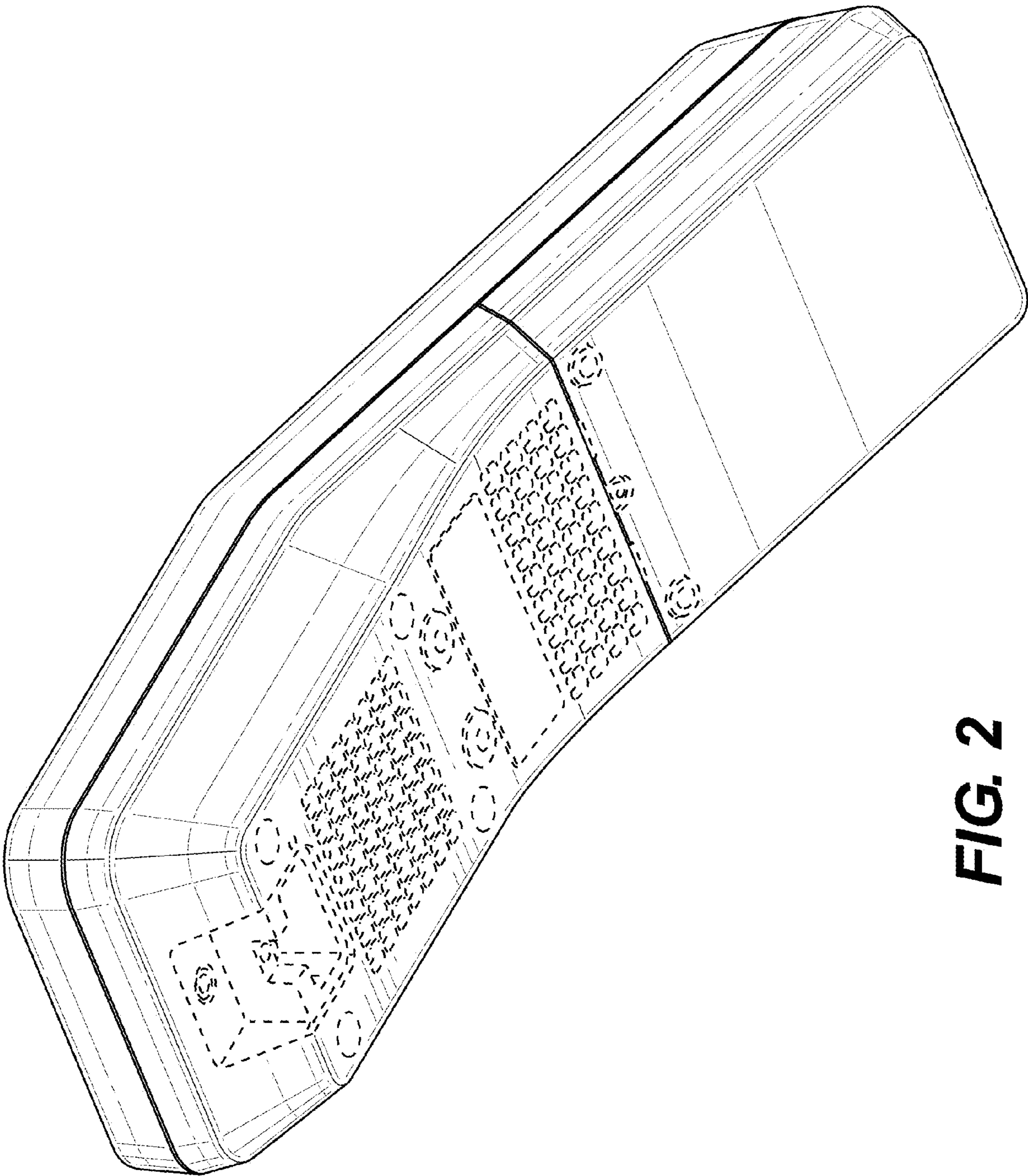

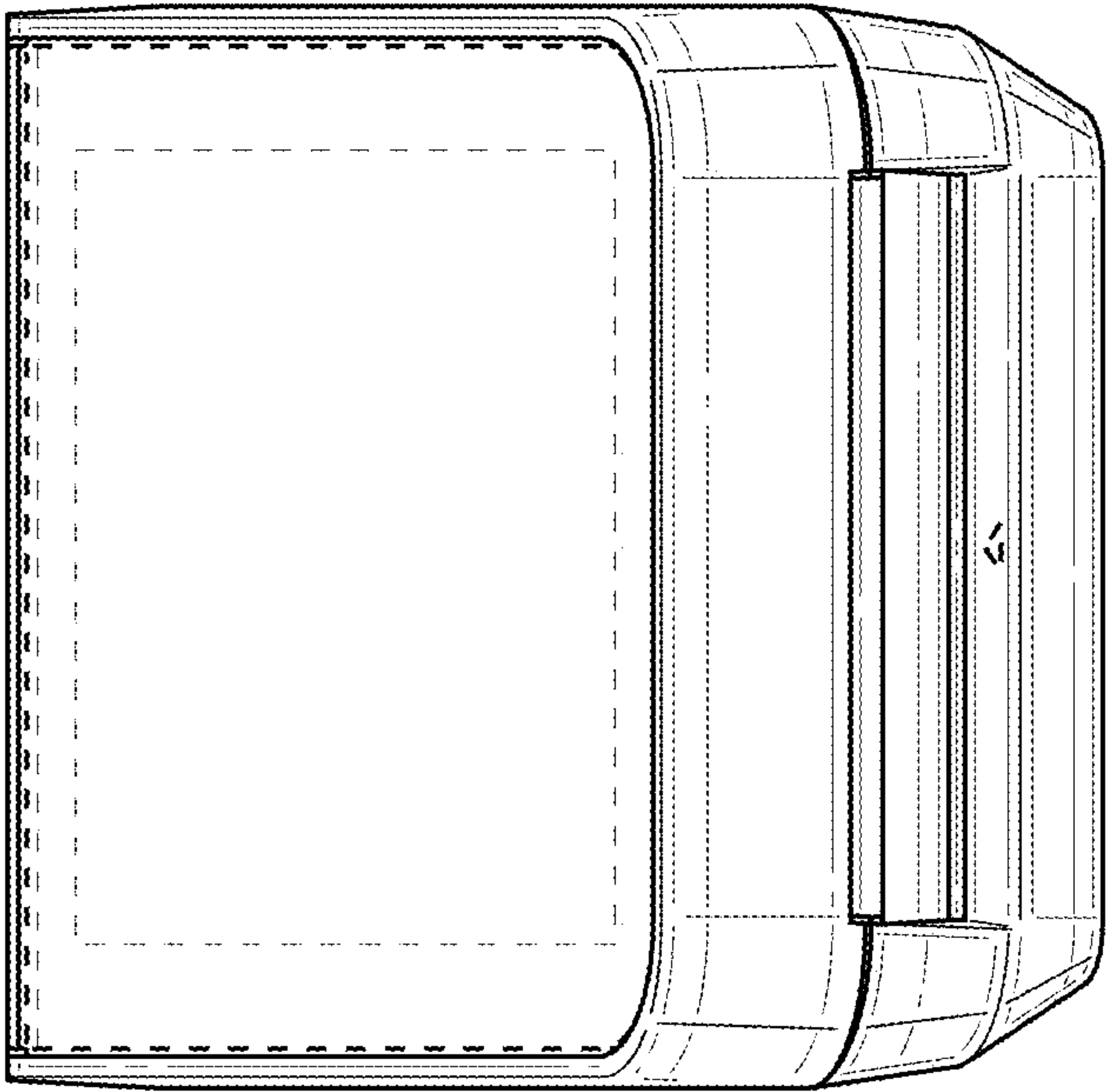

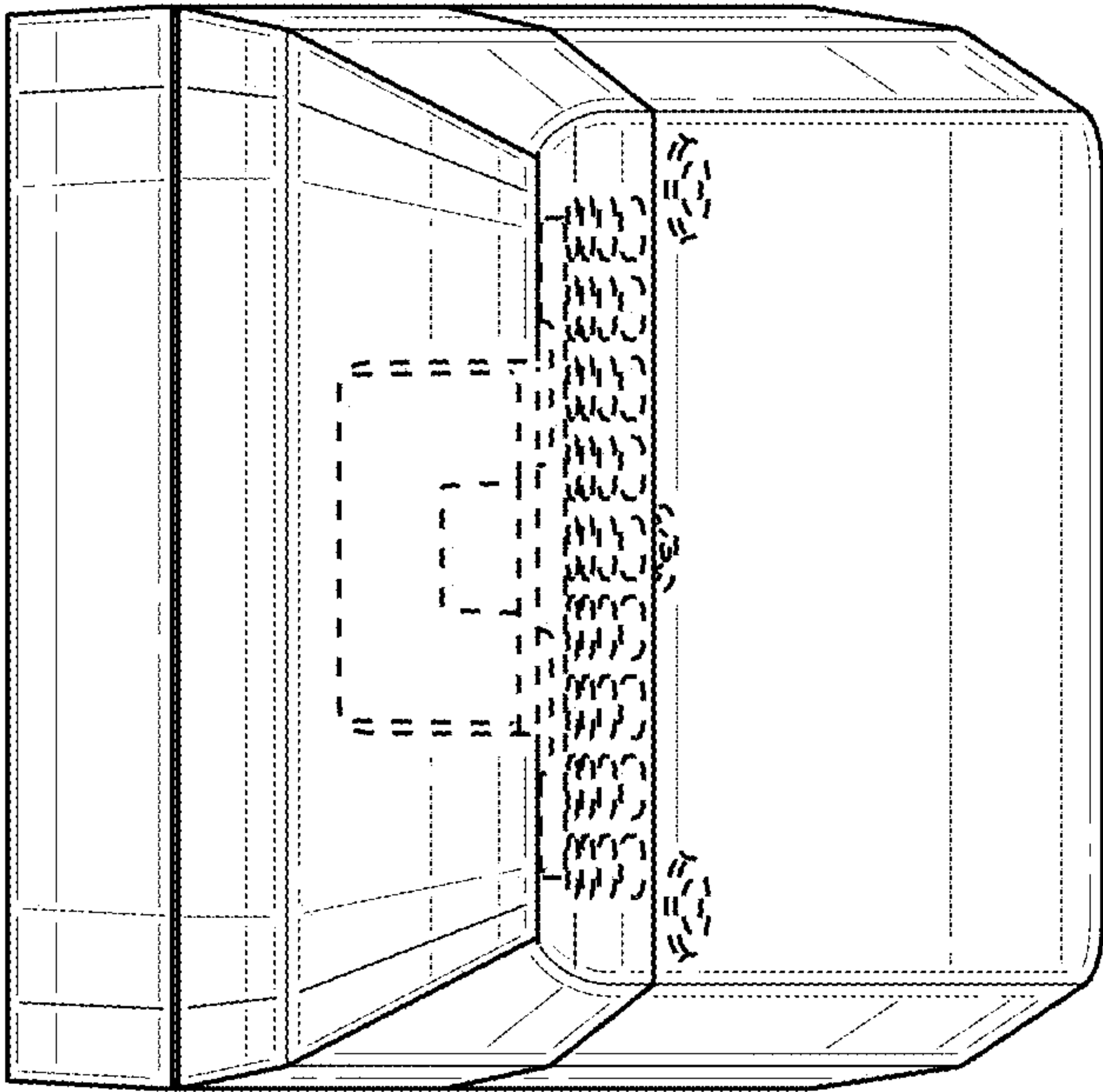

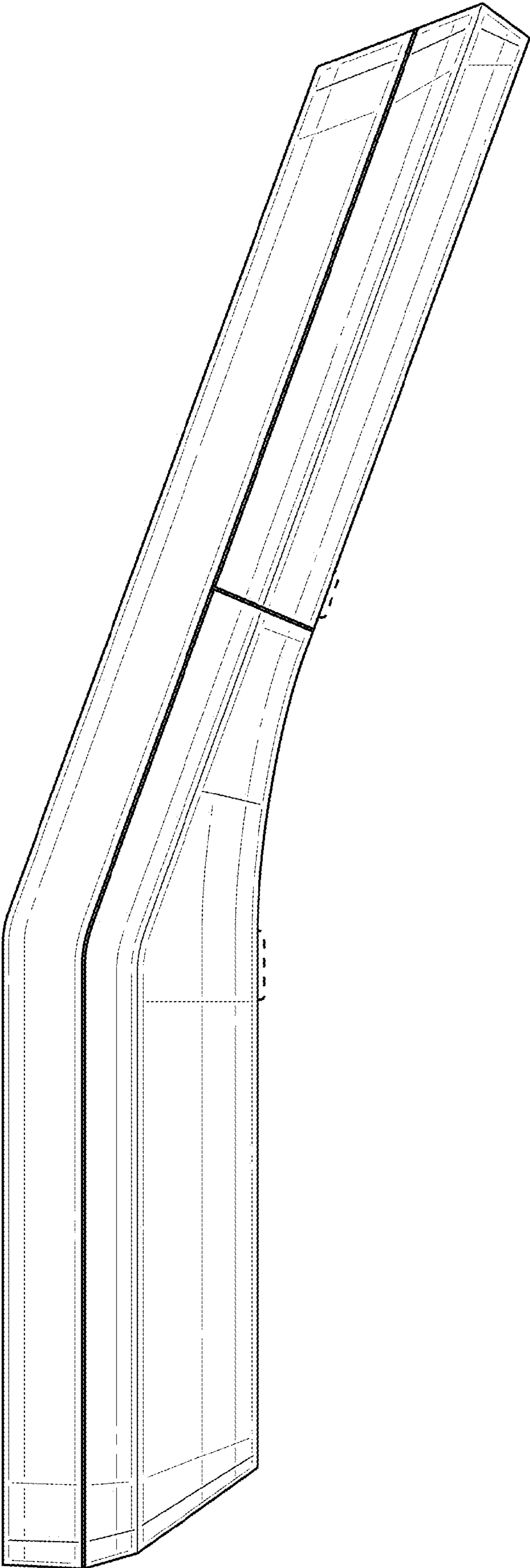

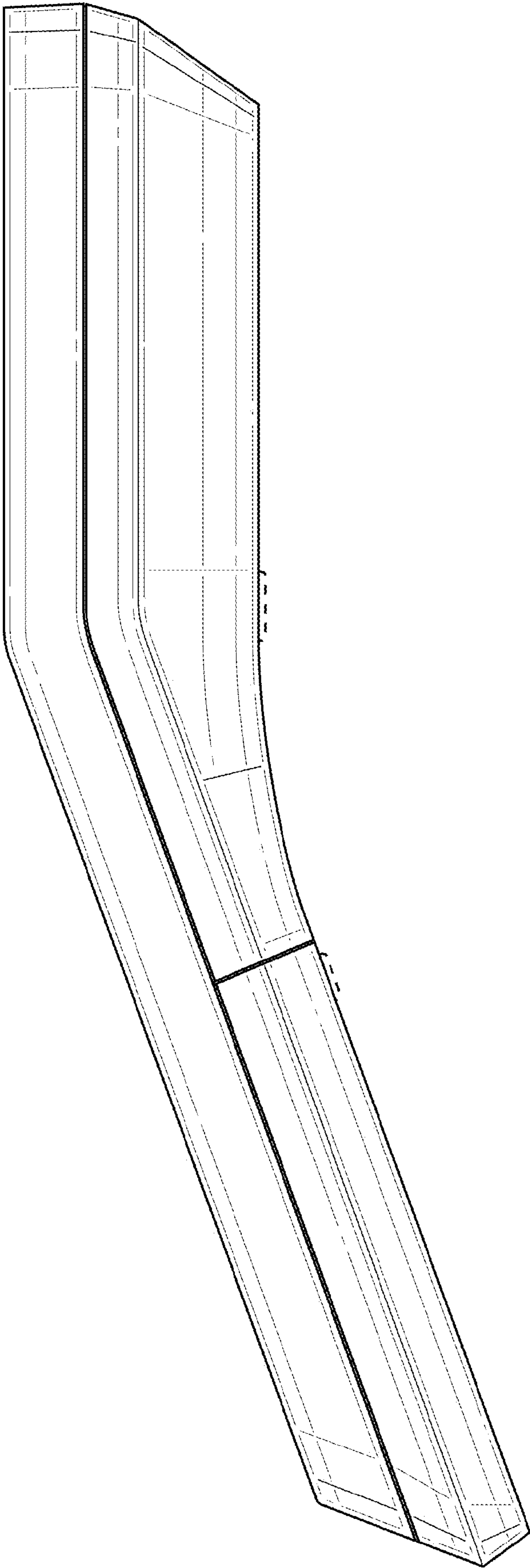

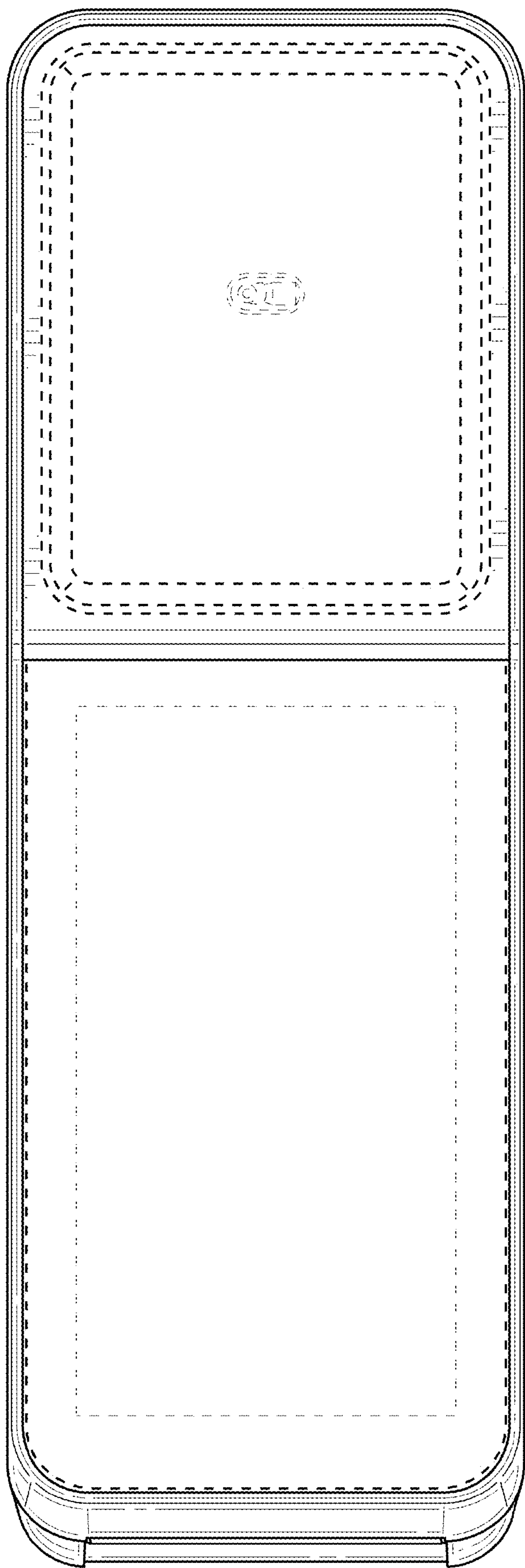

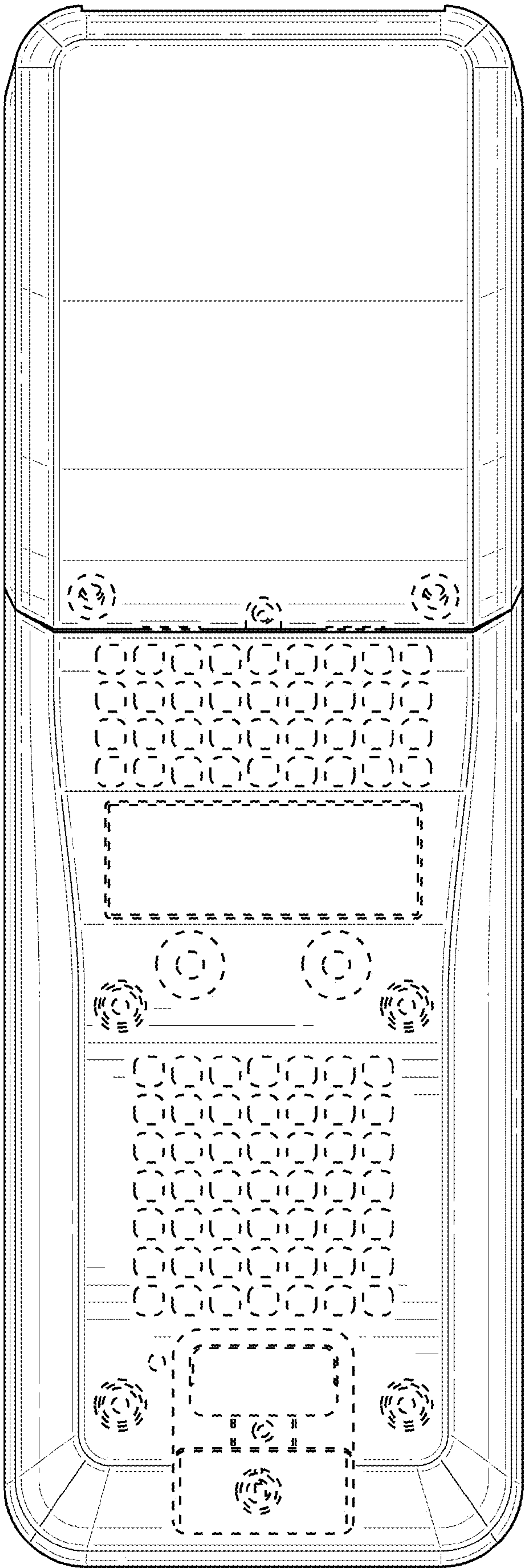
