DESCRIPTION

FIG. 1 is a perspective view of a vehicle headlight according to the novel design;

FIG. 5 is a back side view thereof;

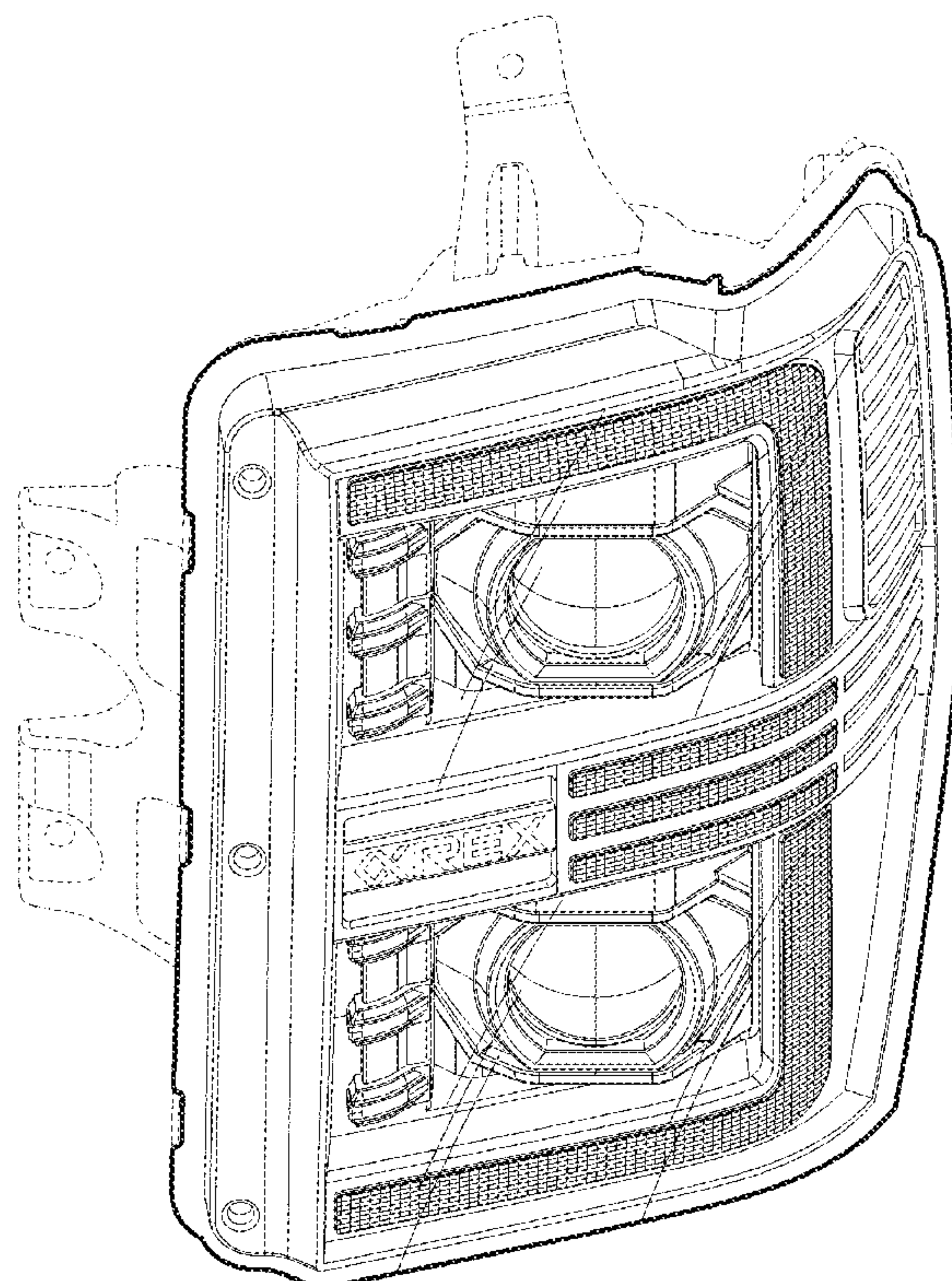
FIG. 6 an alternative perspective view thereof; and,

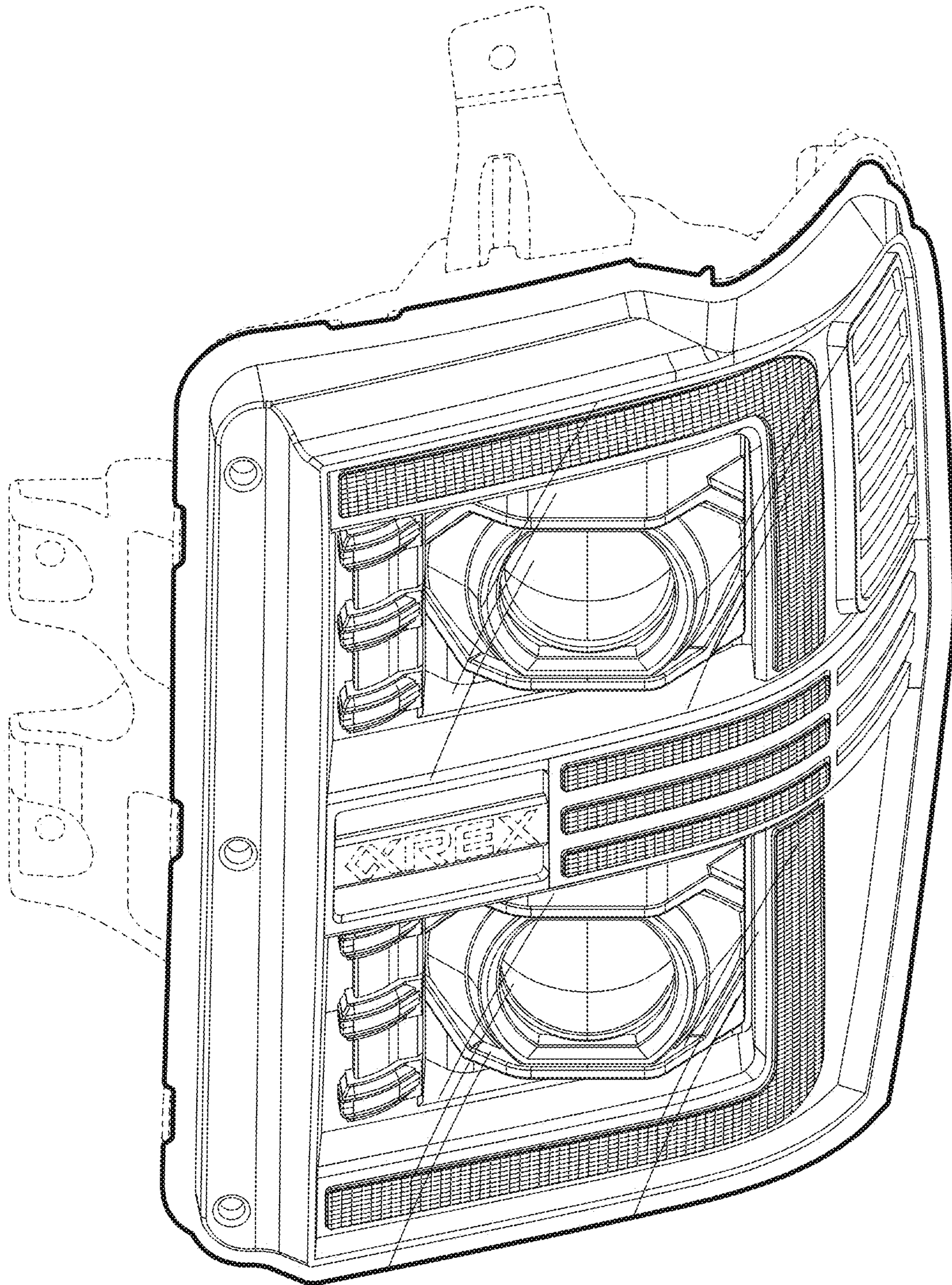

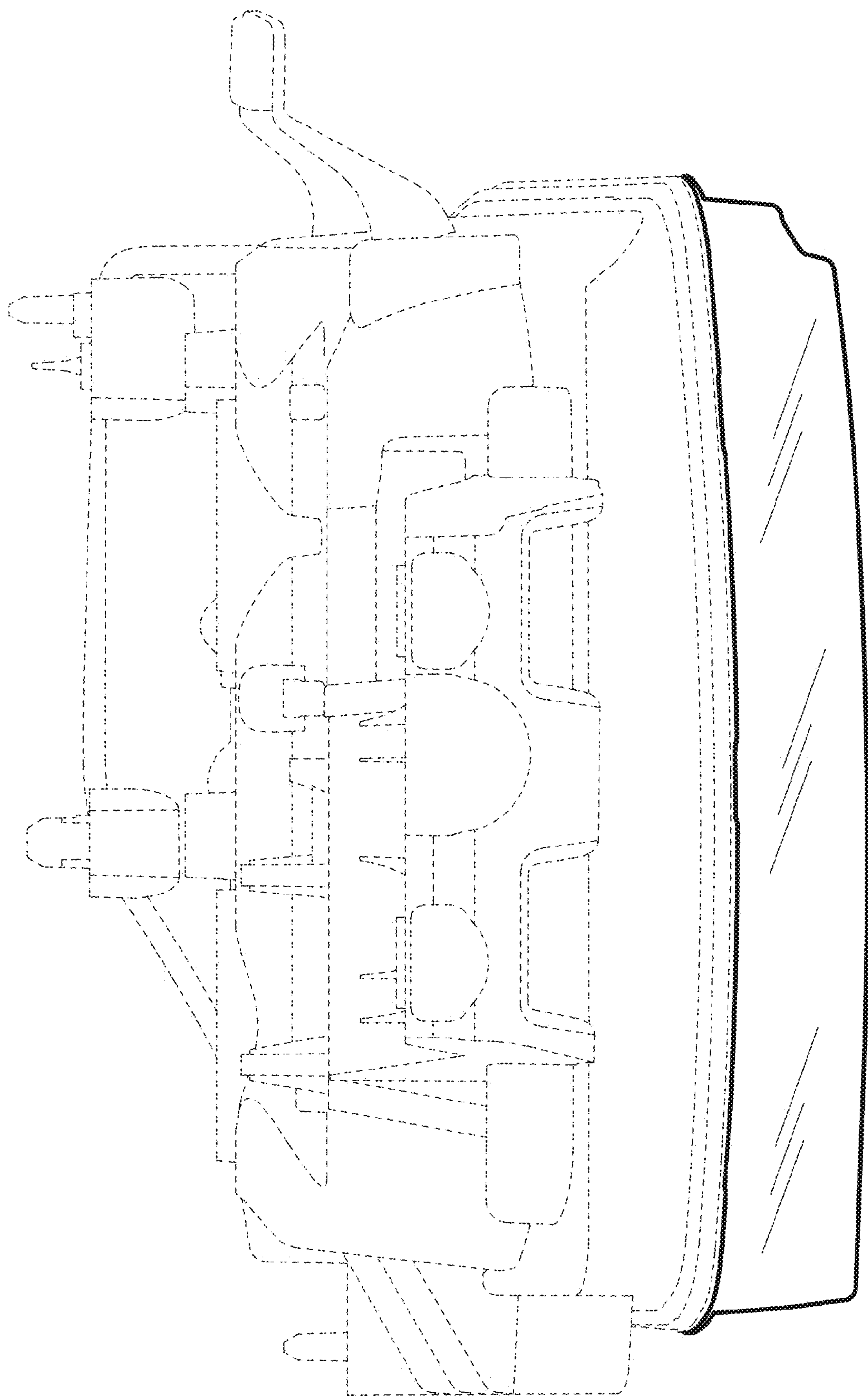

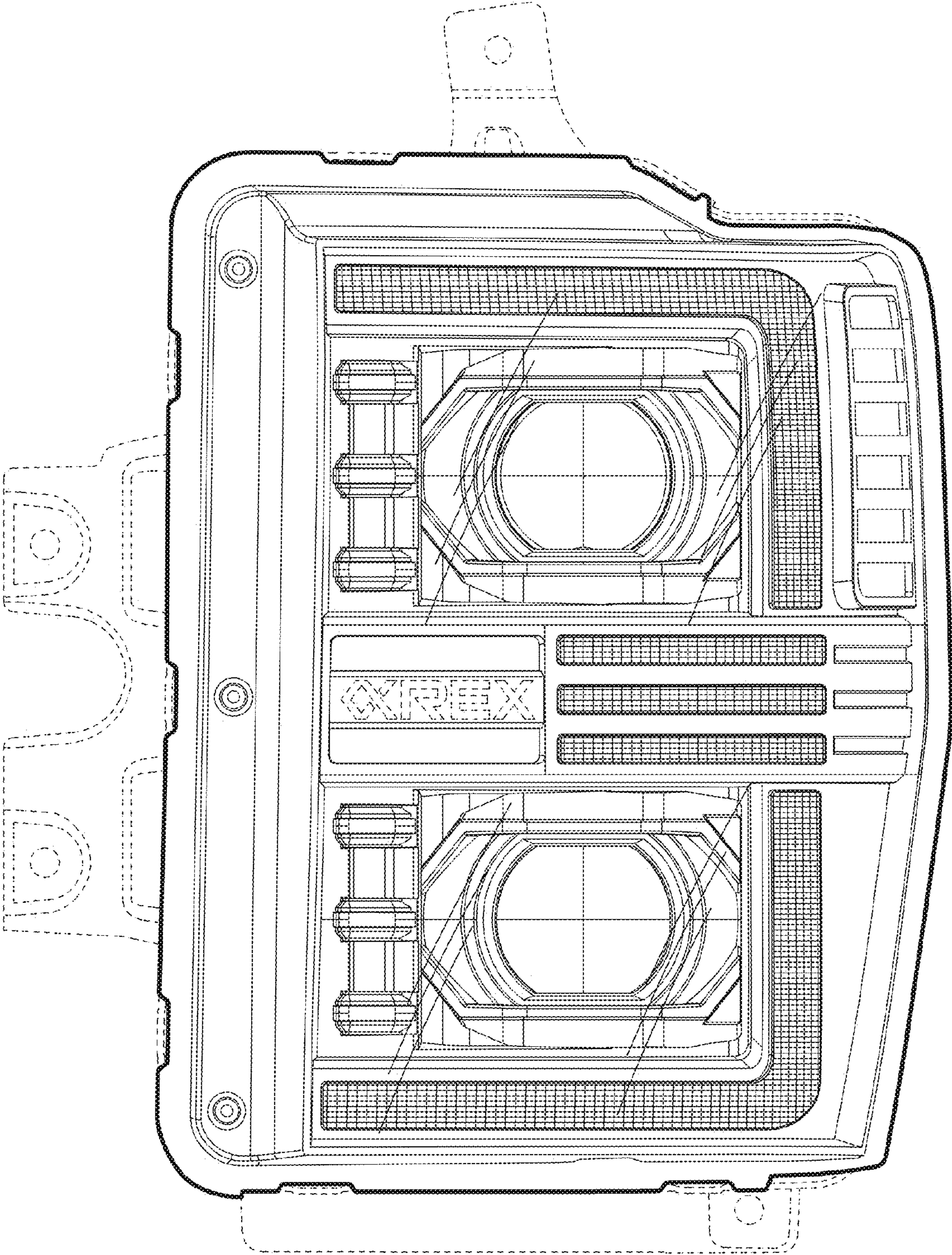

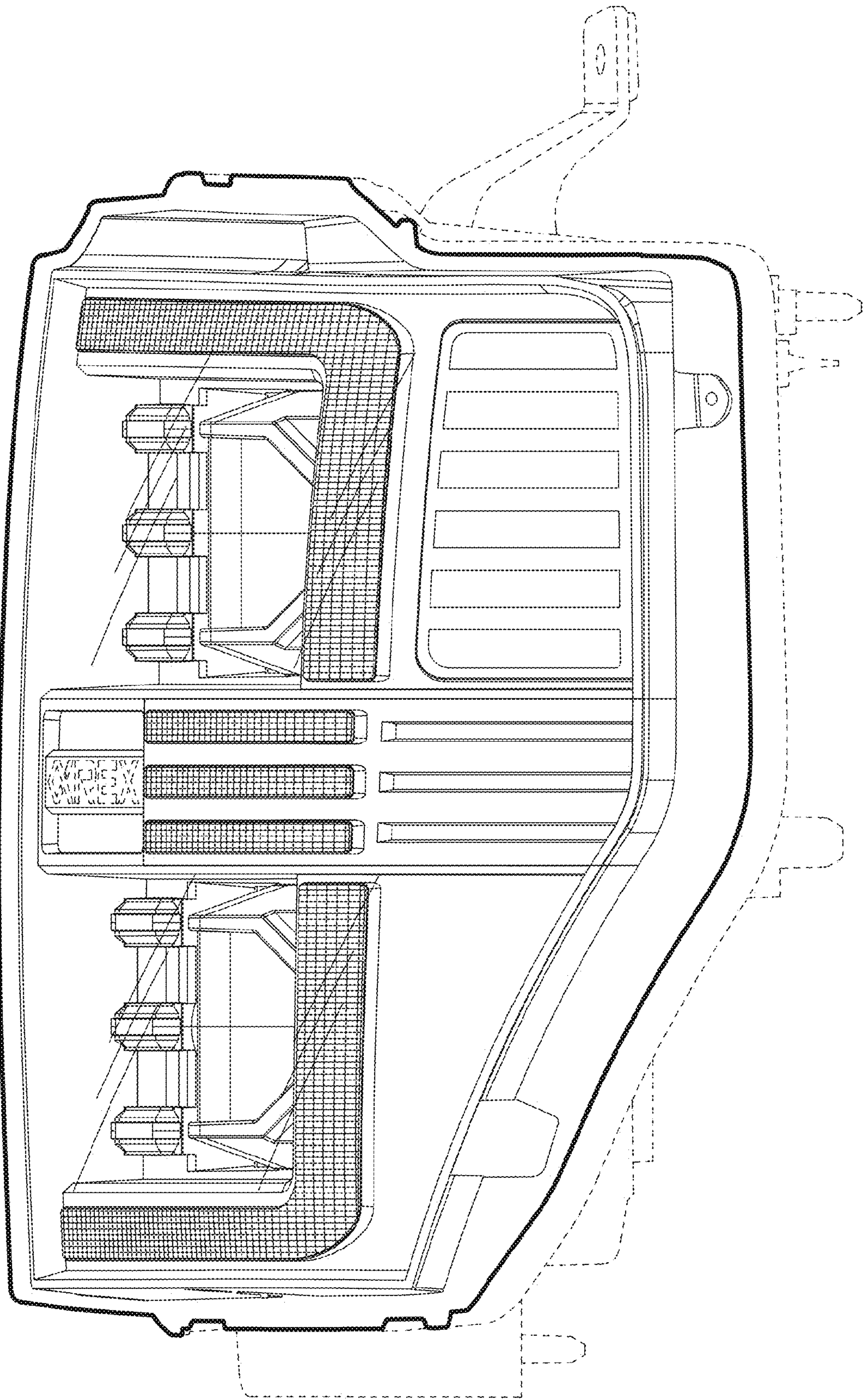

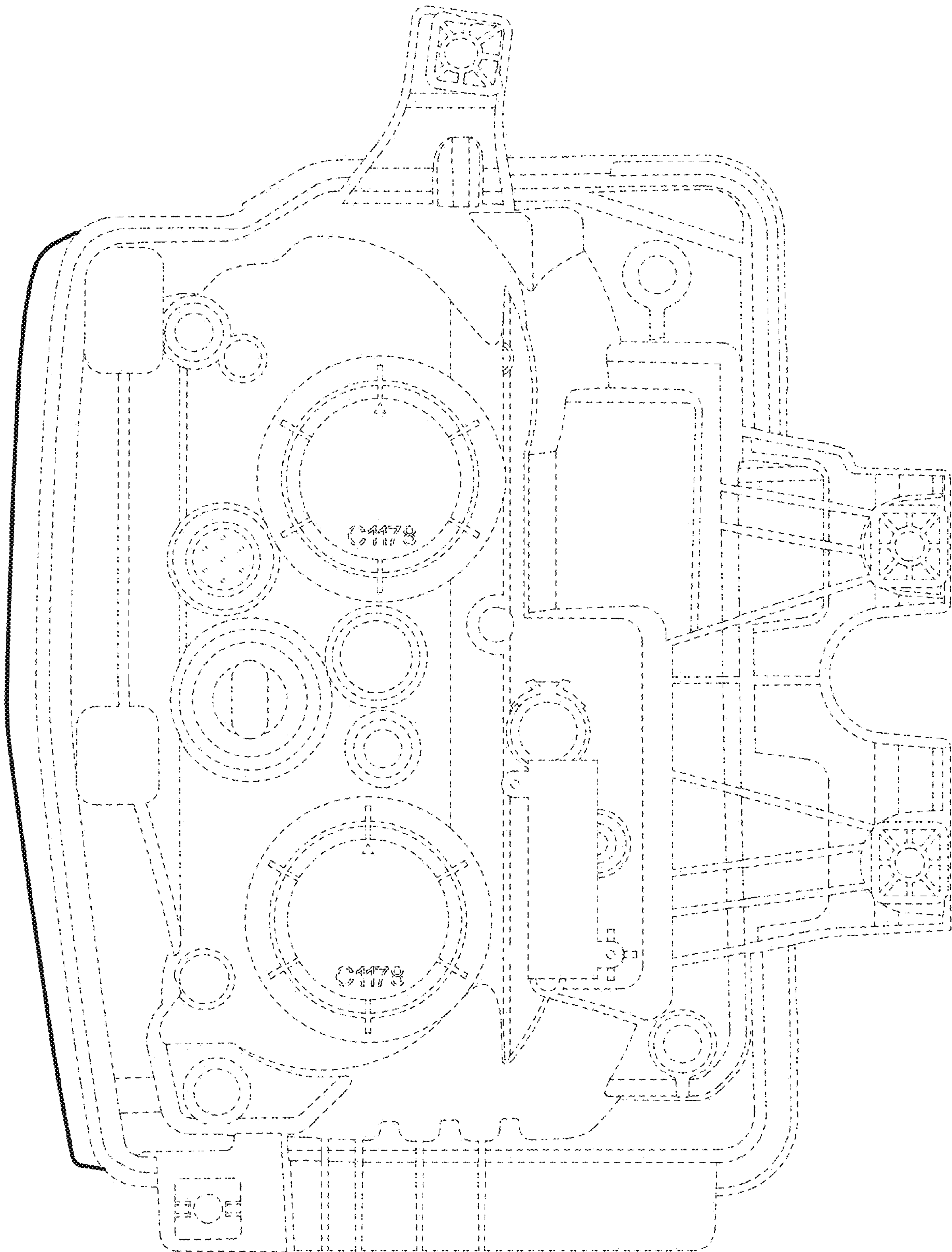

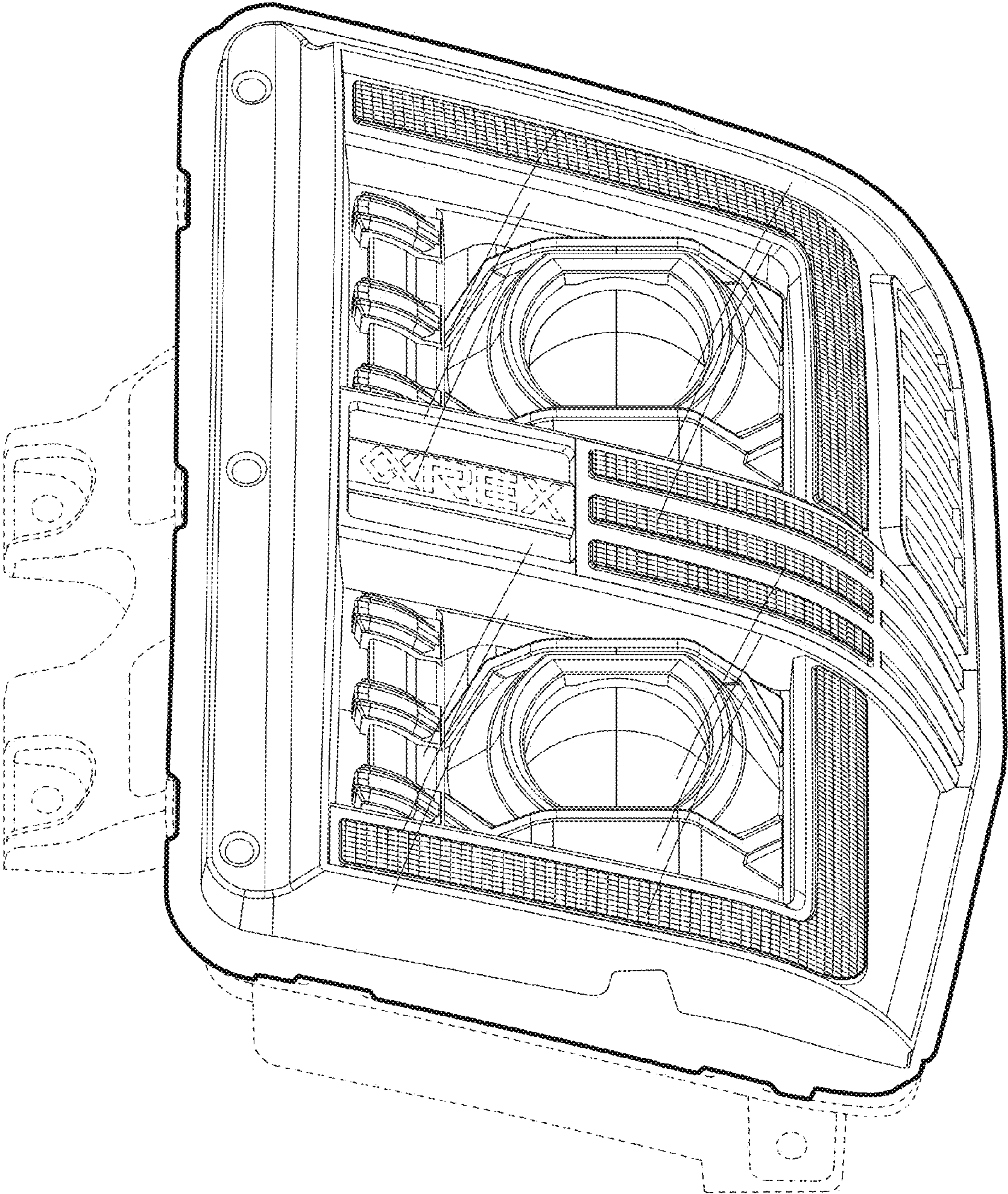

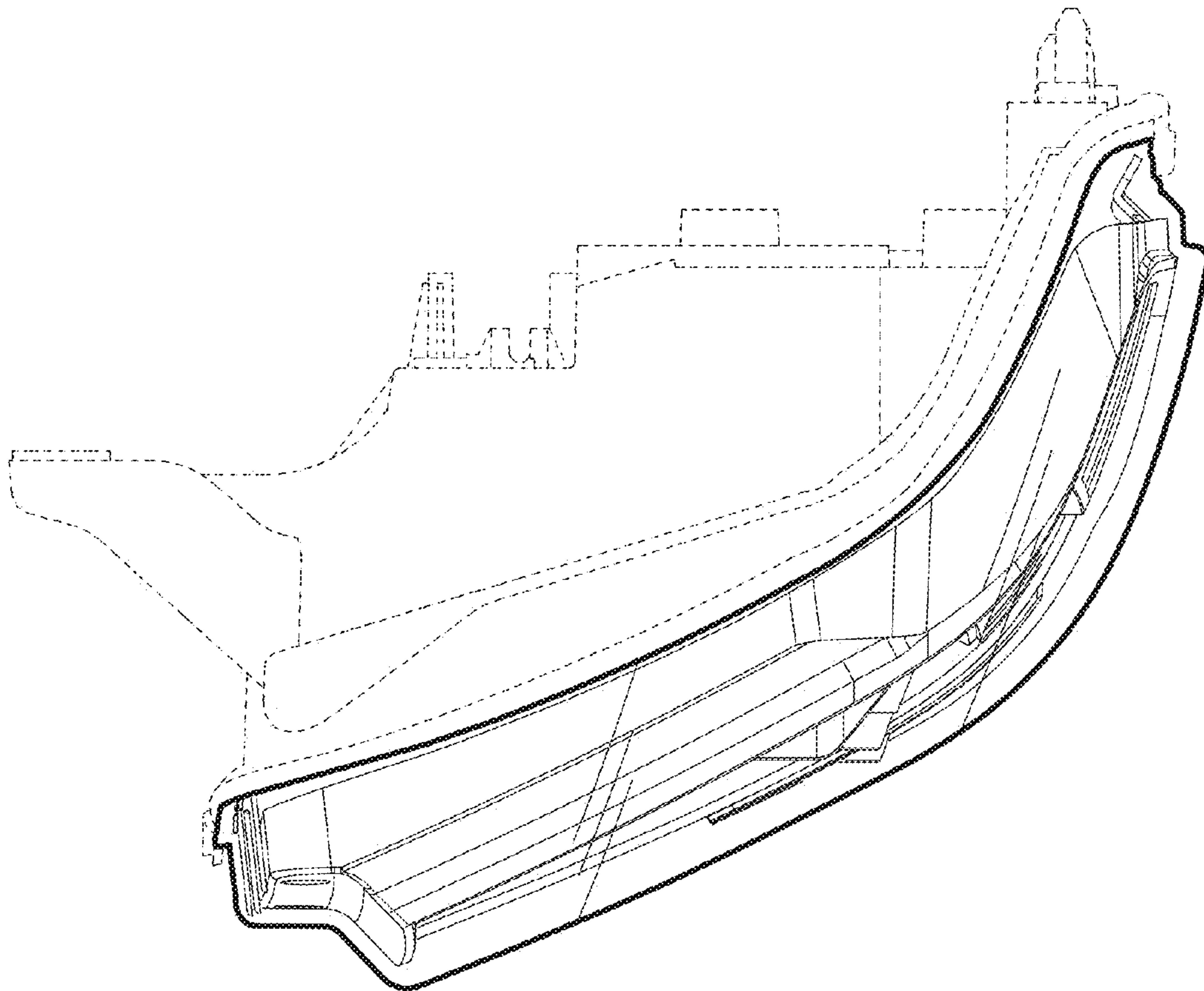
