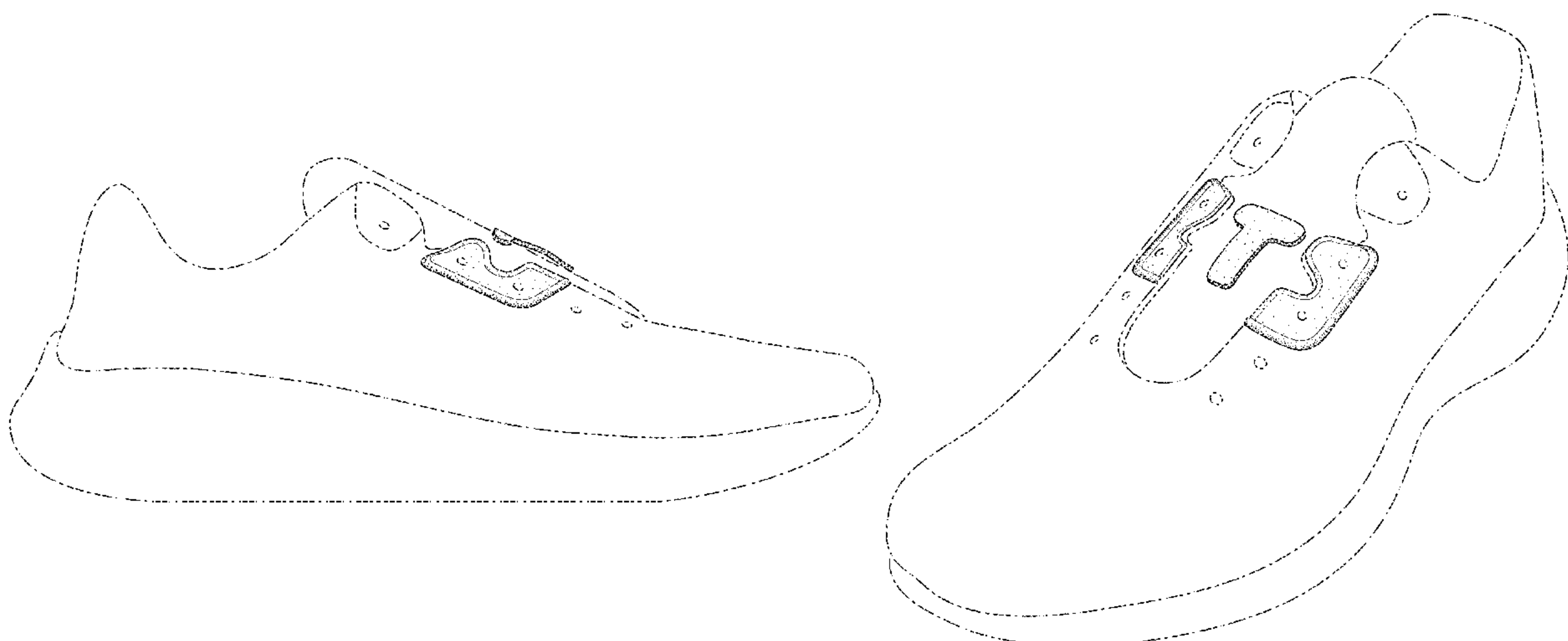
(57) **CLAIM**

The ornamental design for a shoe, as shown and described.

DESCRIPTION

FIG. 1 is a side view of a shoe showing my new design; FIG. 2 is a front perspective view thereof; FIG. 3 is a front view thereof; FIG. 4 is an opposite side front perspective view thereof; and, FIG. 5 is an opposite side view thereof. The broken lines within the shaded area represent eyelets that form no part of the claimed design. The broken lines depicting the remainder of the shoe form no part of the claimed design.

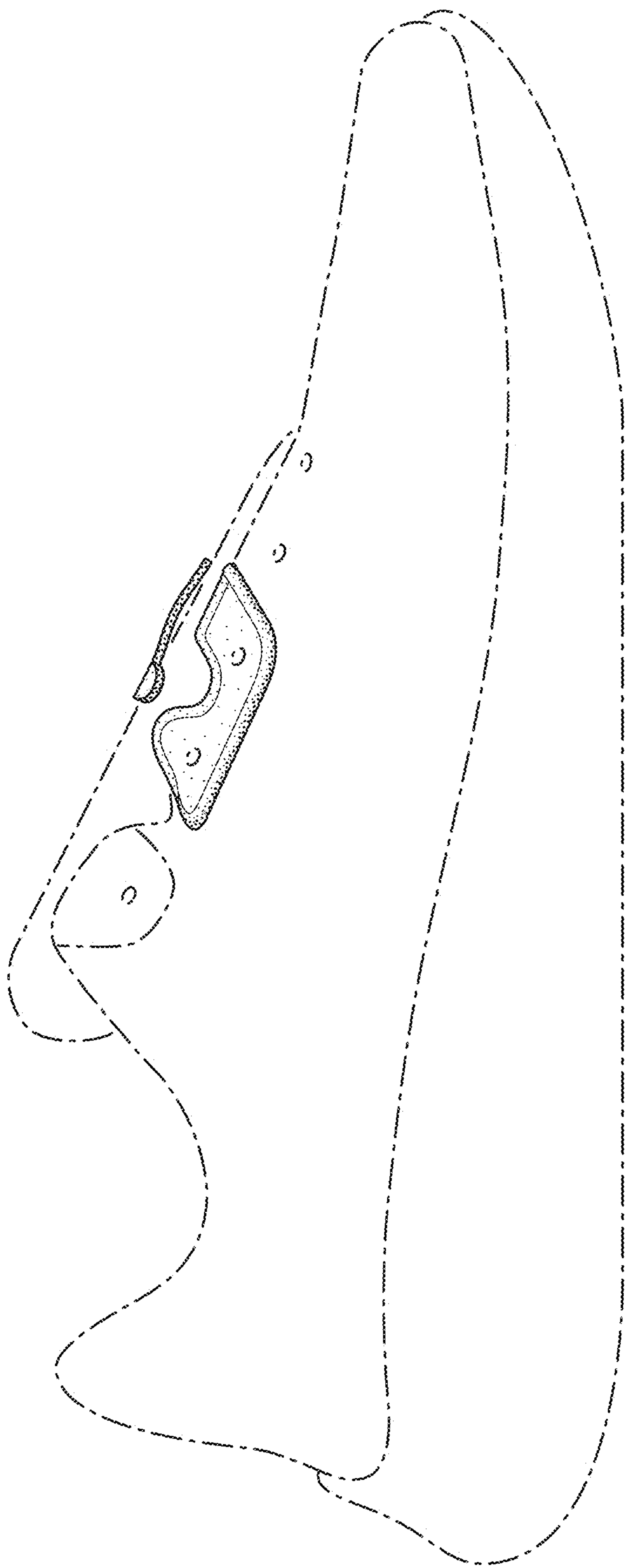

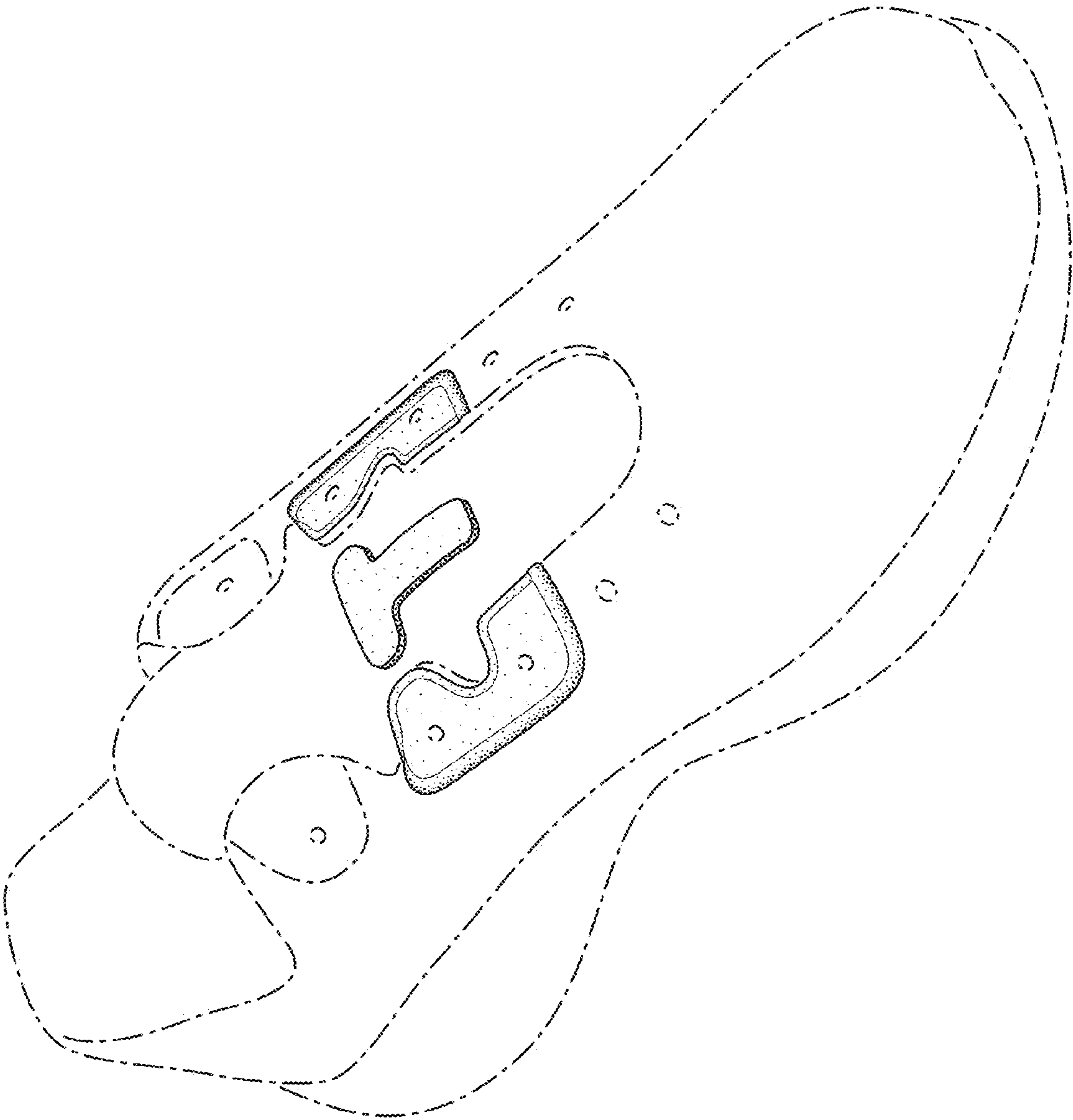

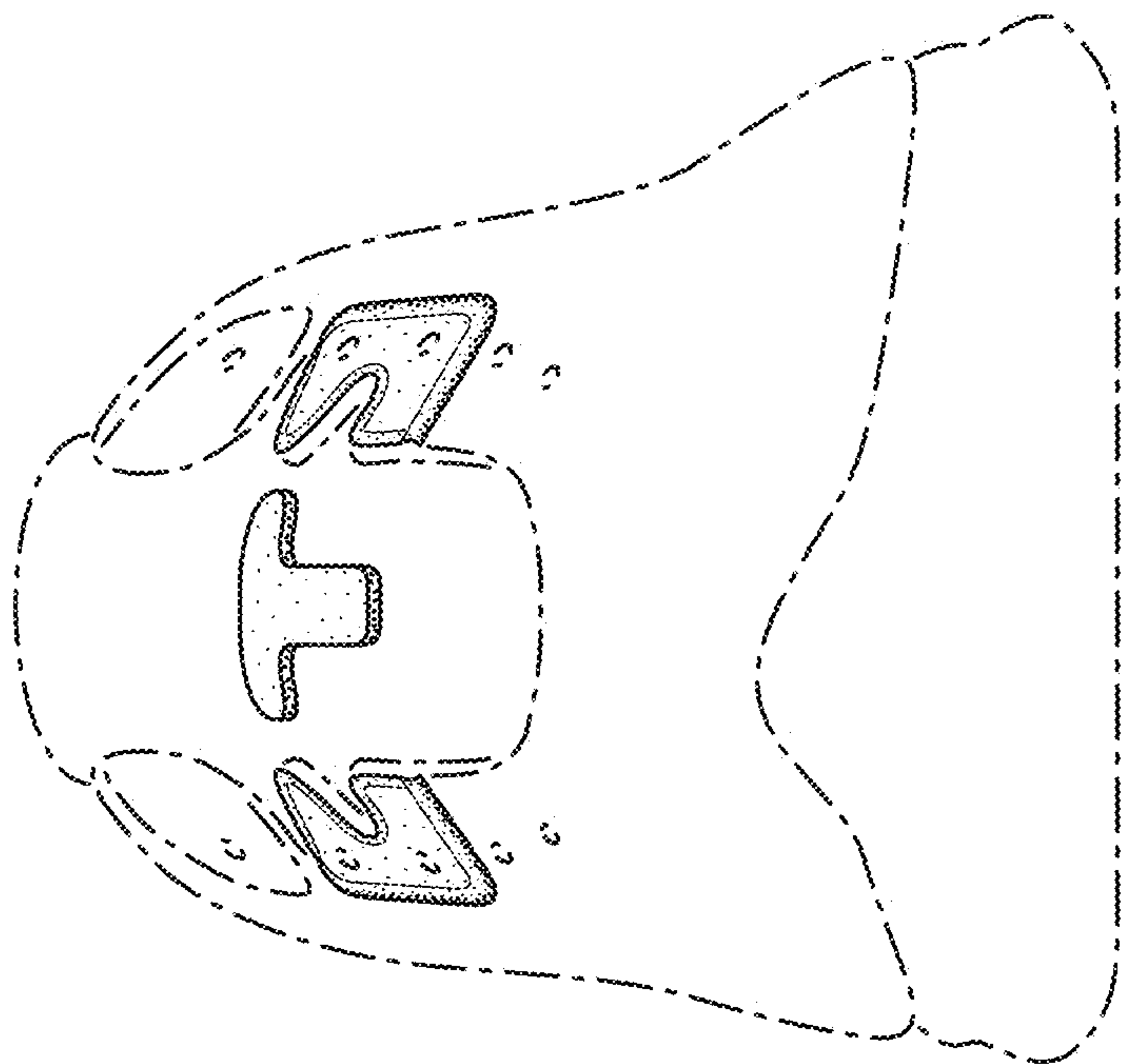

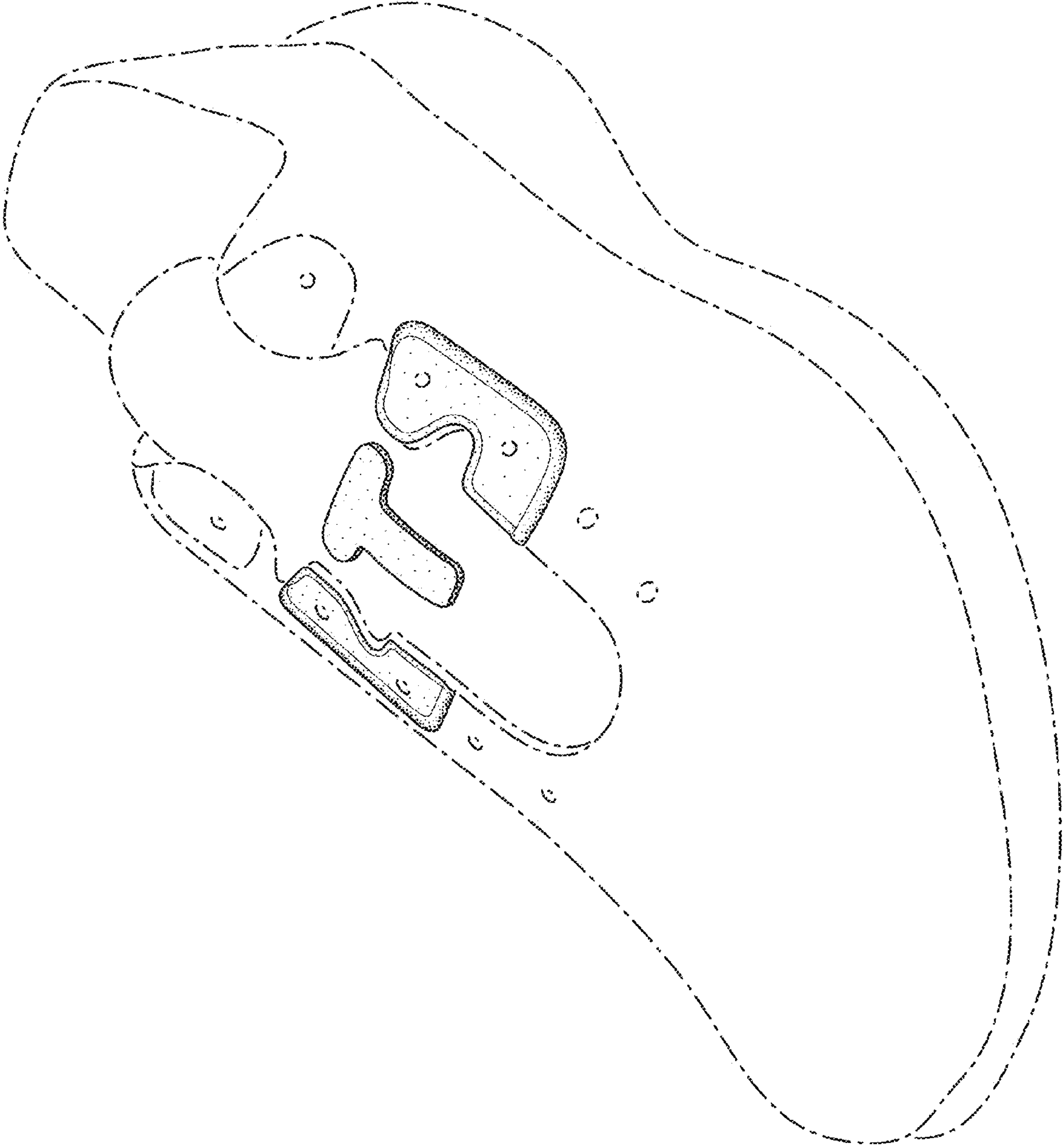

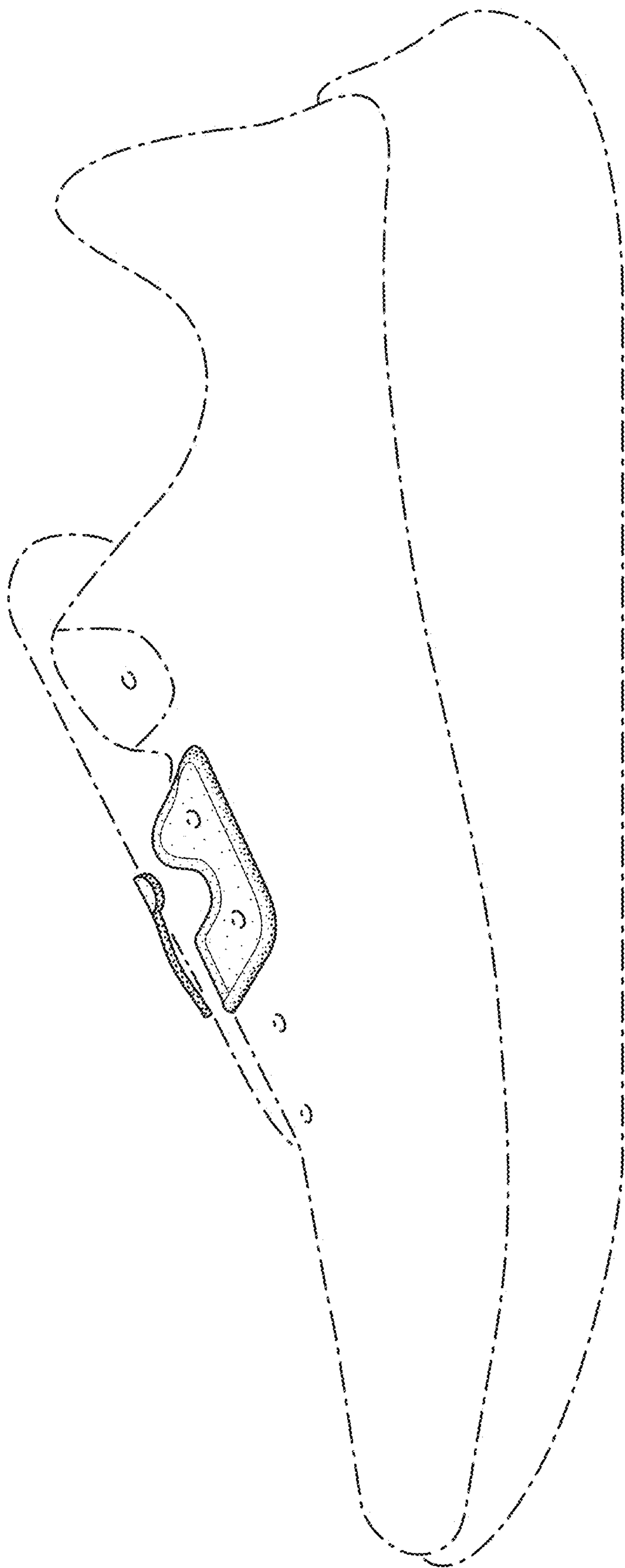
