The ornamental design for a vehicle rear wheel flare, as shown and described.

DESCRIPTION

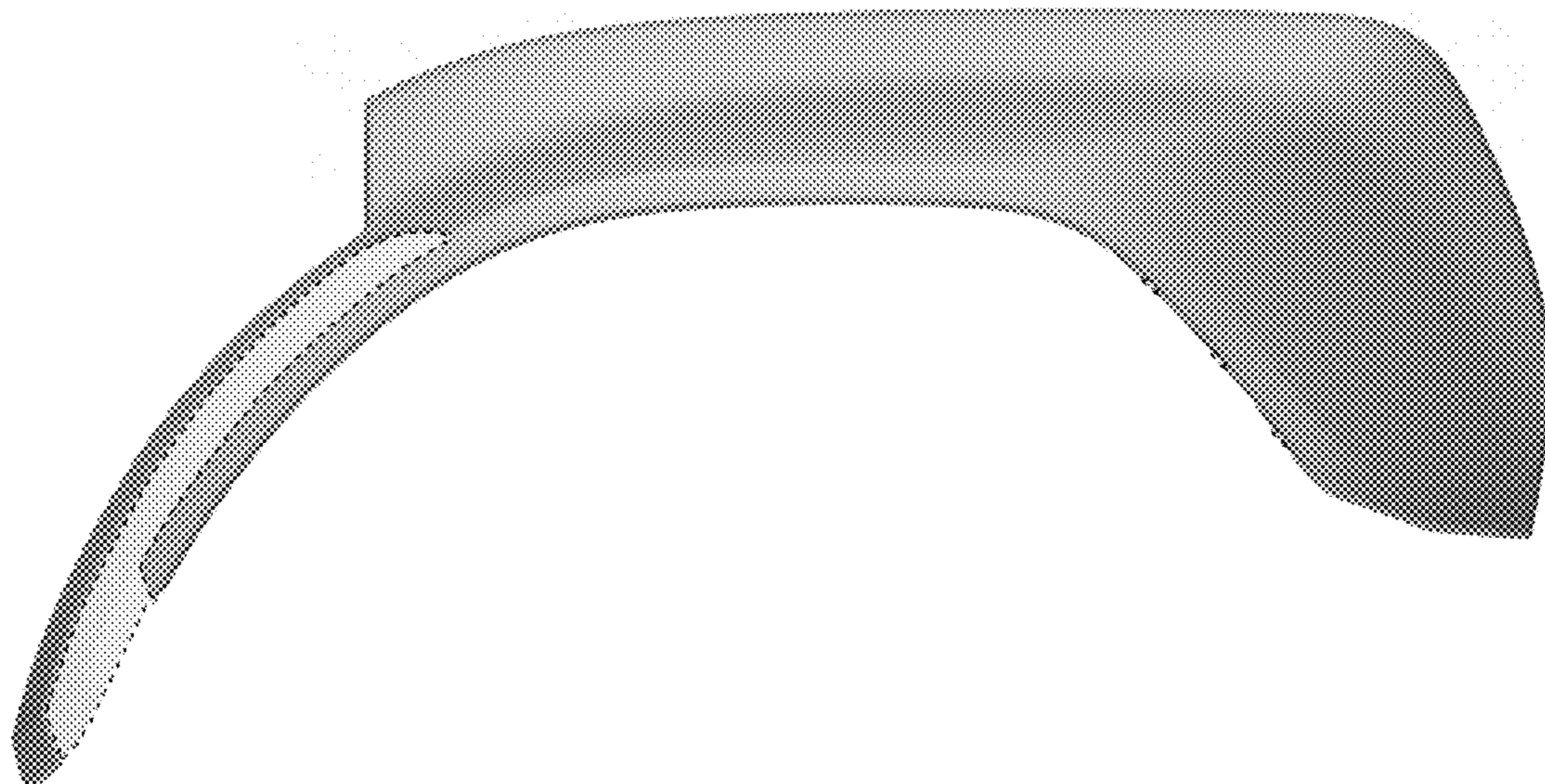
FIG. 1 is a front elevational view of a vehicle rear wheel flare showing our new design;
FIG. 2 is a left side elevational view thereof;
FIG. 3 is a right side elevational view thereof;
FIG. 4 is a top plan view thereof;

FIG. 6 is a top, front and left side perspective view thereof;
and,
FIG. 7 is a top, rear and right side perspective view thereof. Portions of the vehicle rear wheel flare surrounded by broken lines and shown in half-tone shading form no part of the claimed design.

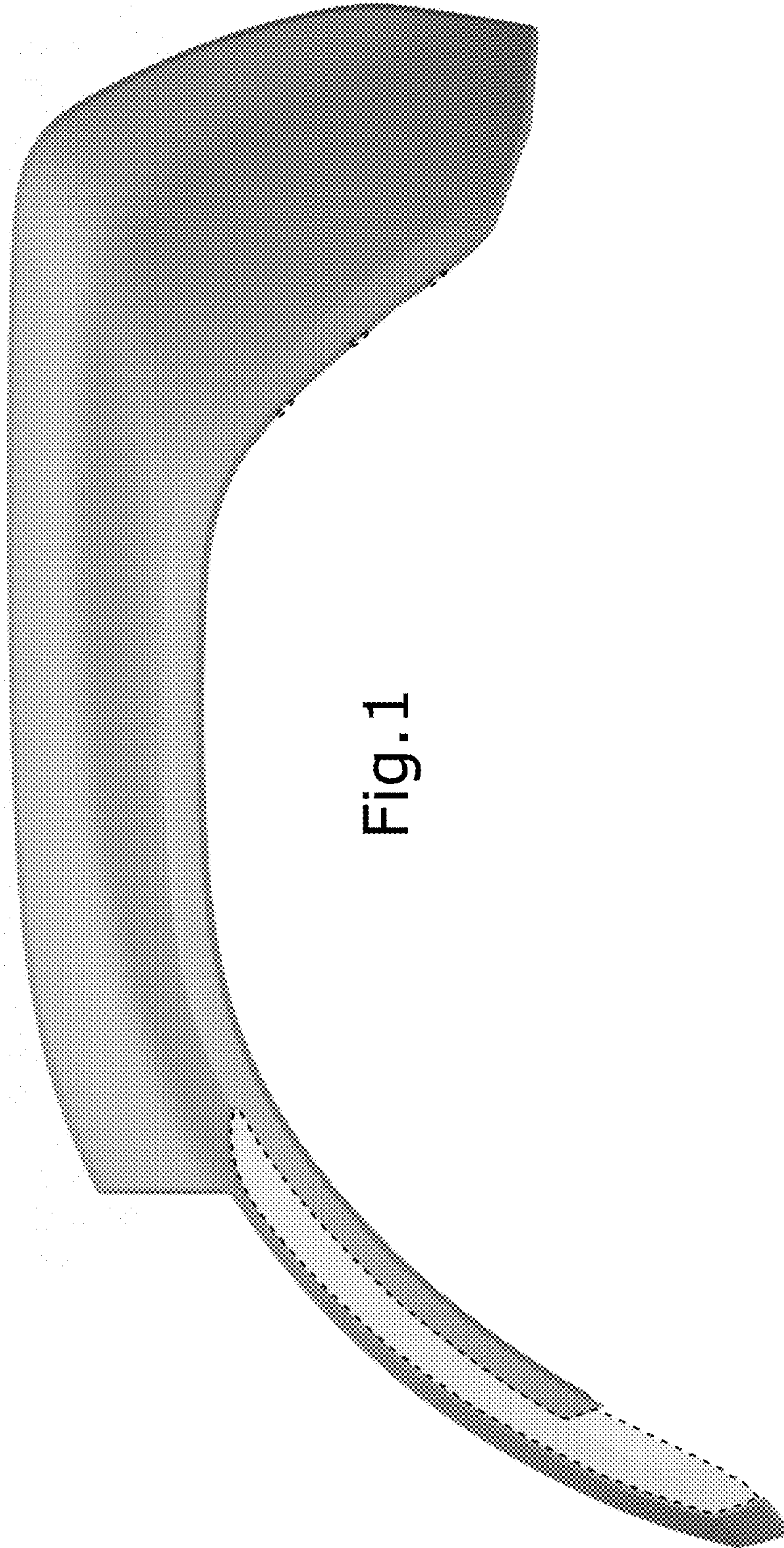

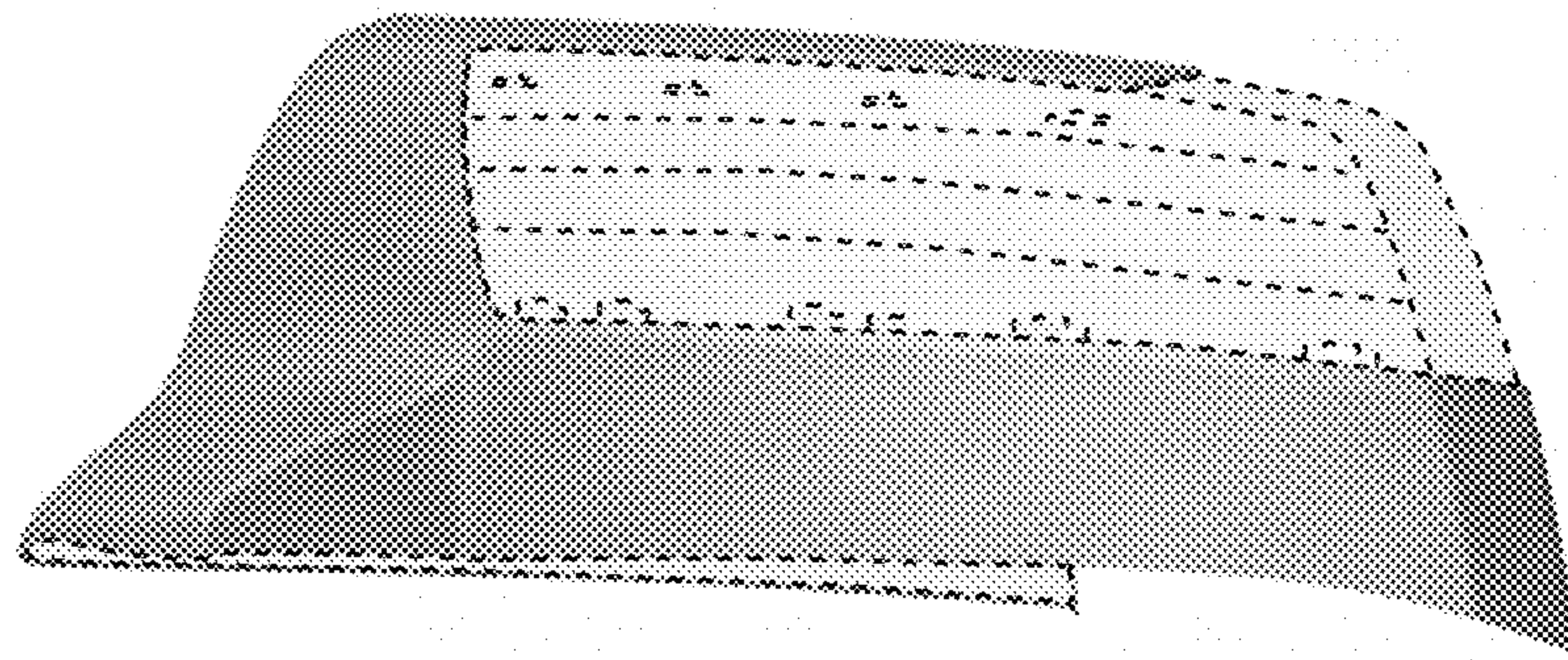

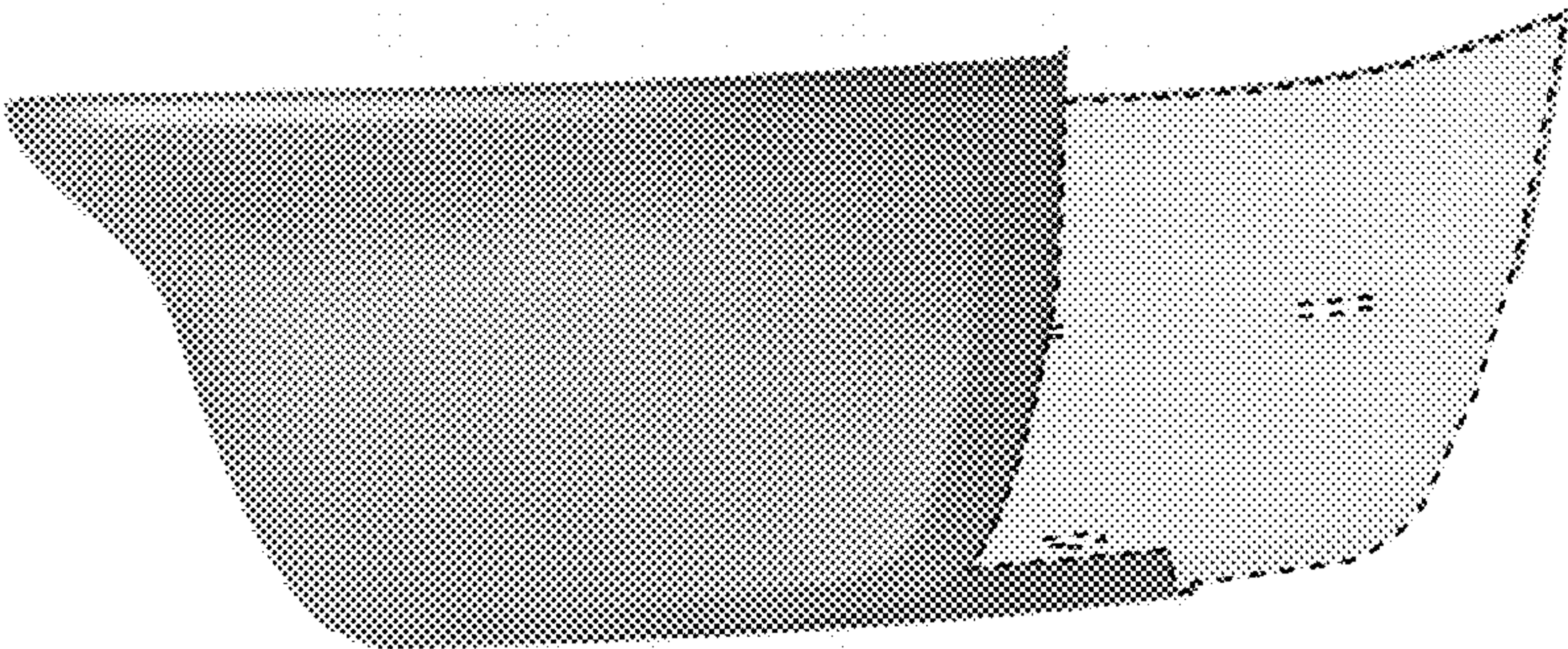

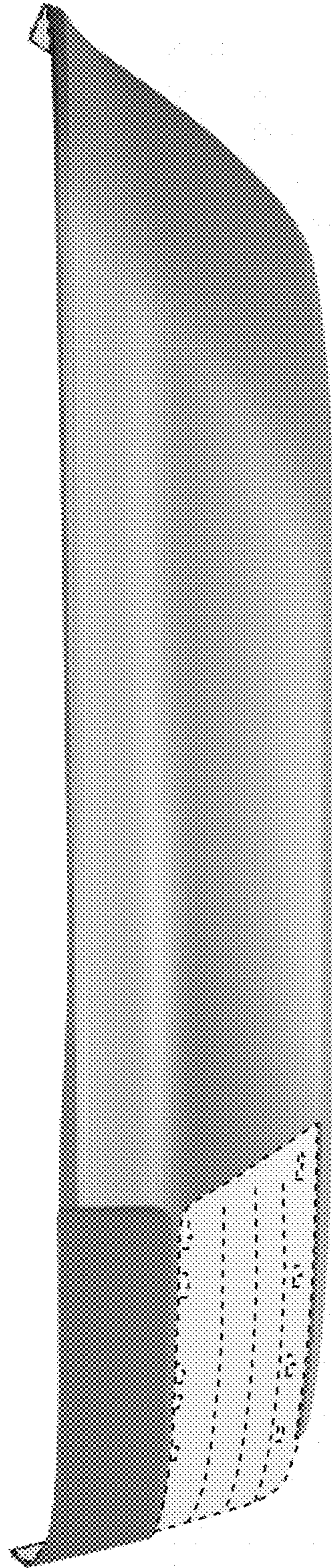

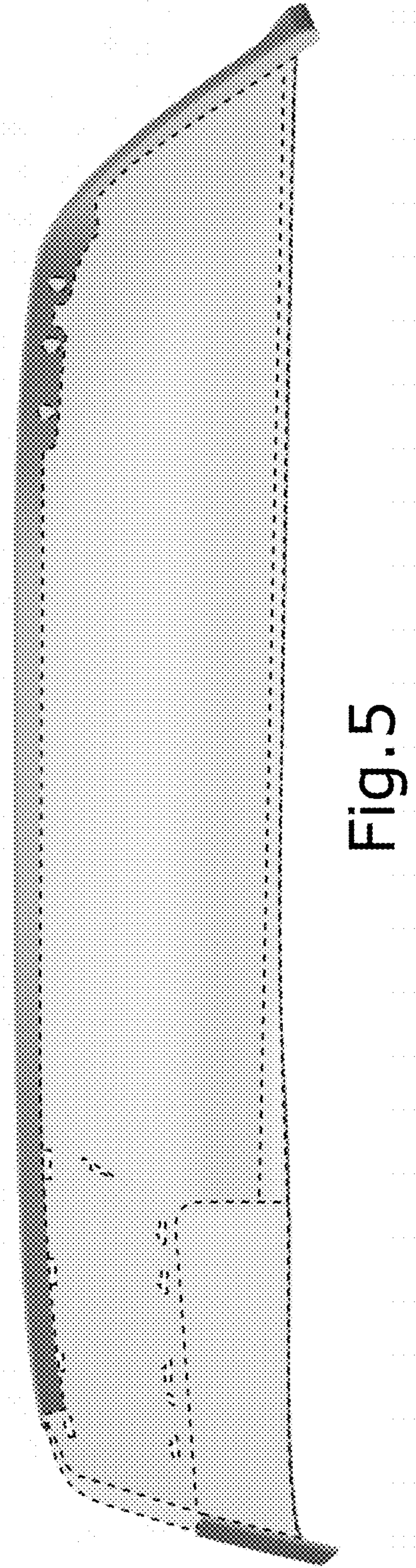

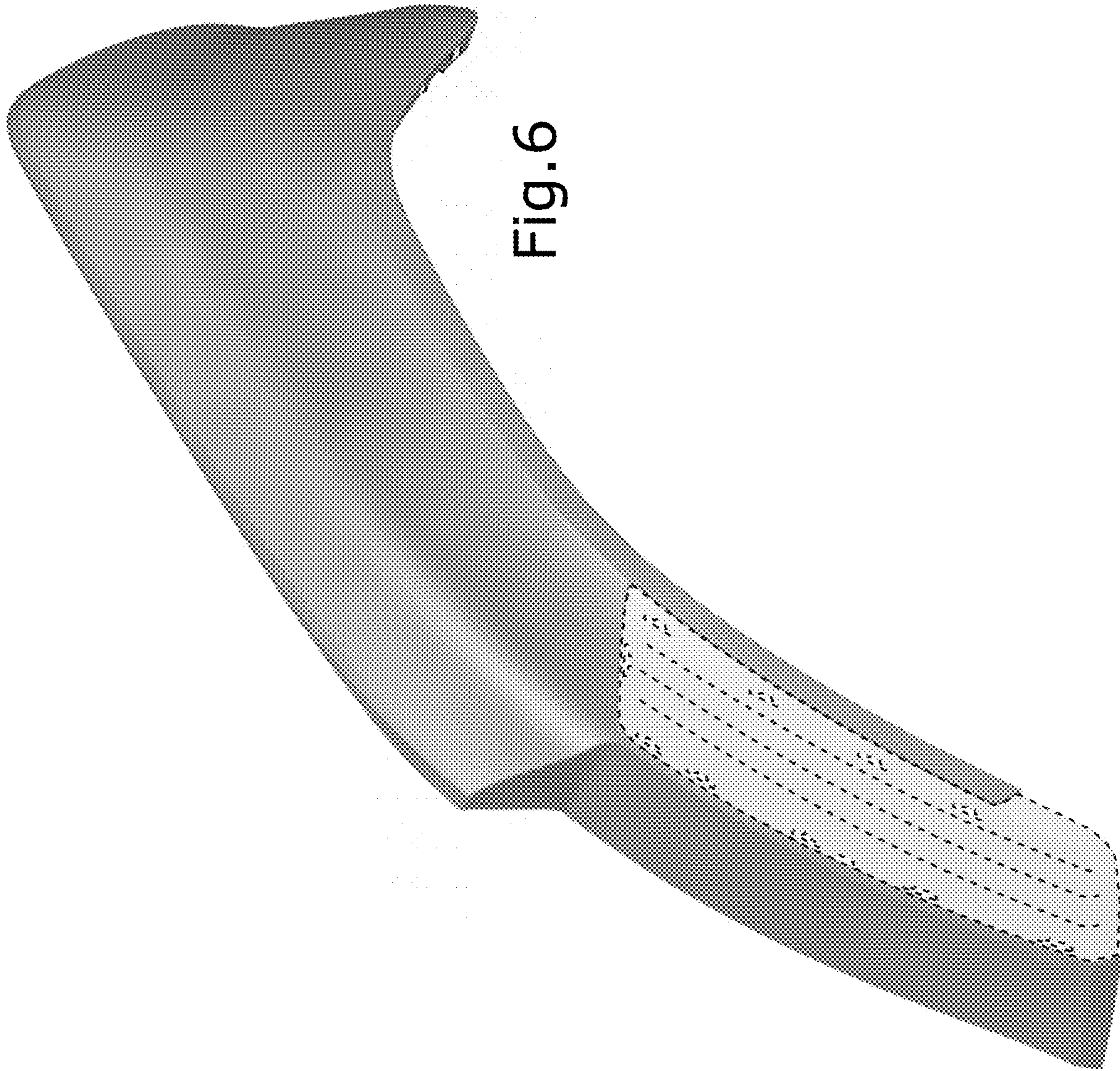

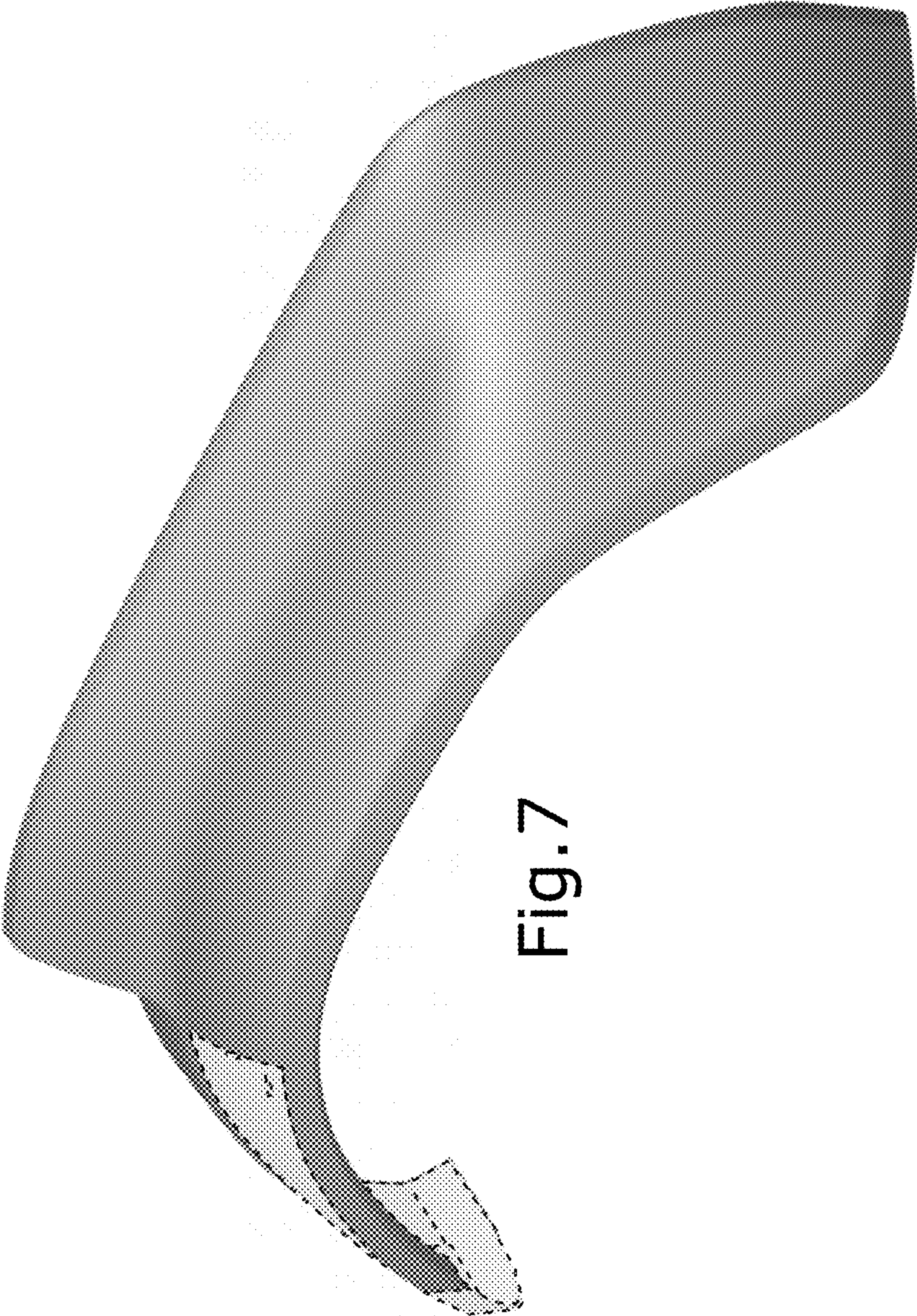
