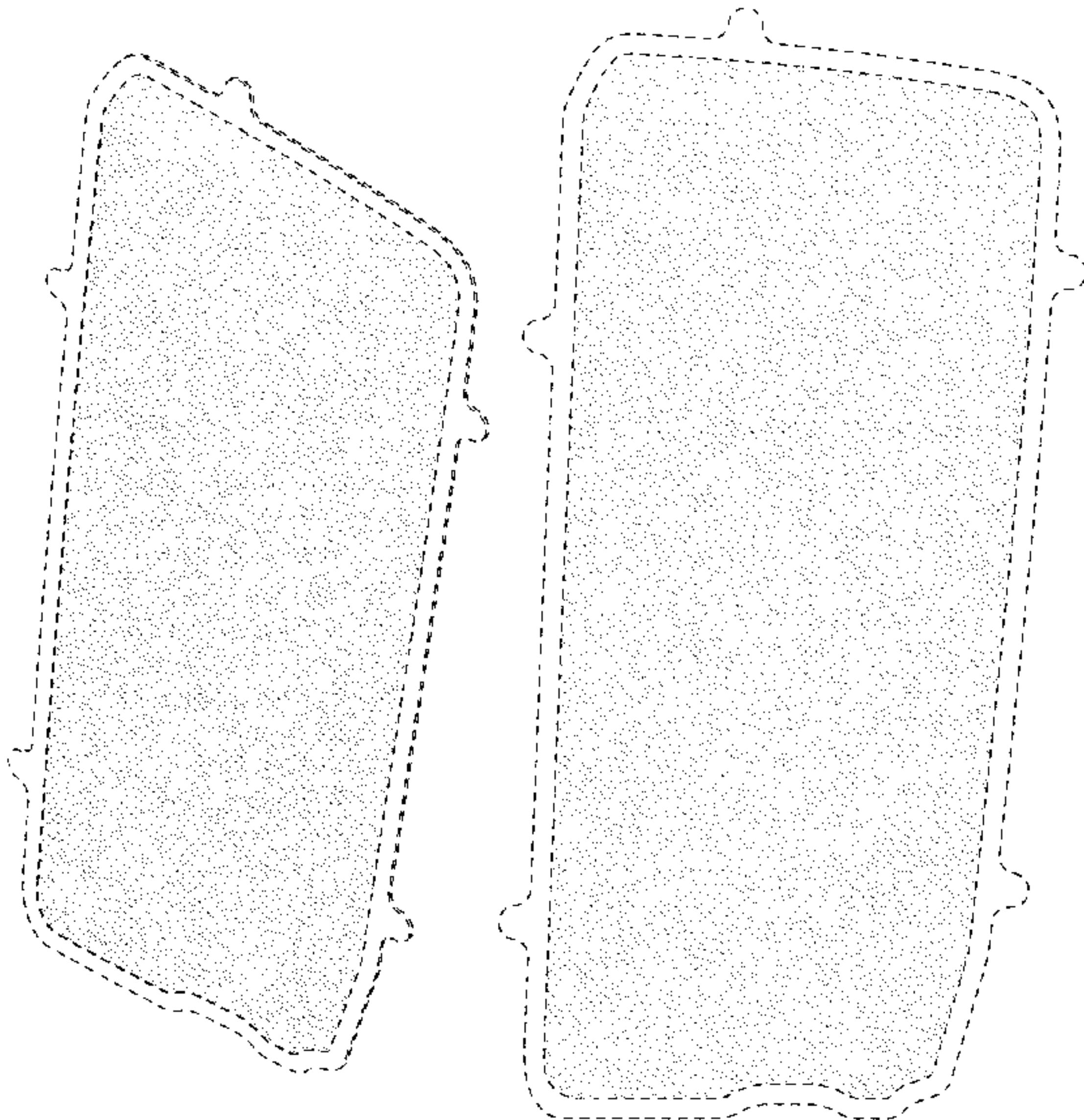
(57) CLAIM

The ornamental design for a vehicle grille screen, as shown and described.

DESCRIPTION

FIG. 1 is an isometric view of a vehicle grille screen, showing an embodiment of my new design.
FIG. 2 is a front elevational view thereof.
FIG. 3 is a rear elevational view thereof.
FIG. 4 is a right side elevational view thereof.
FIG. 5 is a top plan view thereof.
FIG. 6 is an isometric view of a vehicle grille screen, showing another embodiment of my new design, which is a mirror image of the vehicle grille screen of FIGS. 1-5.
FIG. 7 is a front elevational view thereof.
FIG. 8 is a rear elevational view thereof.
FIG. 9 is a left side elevational view thereof; and,
FIG. 10 is a top plan view thereof.
Stippling in the drawings represents the three-dimensional contours of the design, and is not intended to indicate surface decoration. The broken lines shown in the drawings depict portions of the vehicle grille screen that form no part of the claimed design.

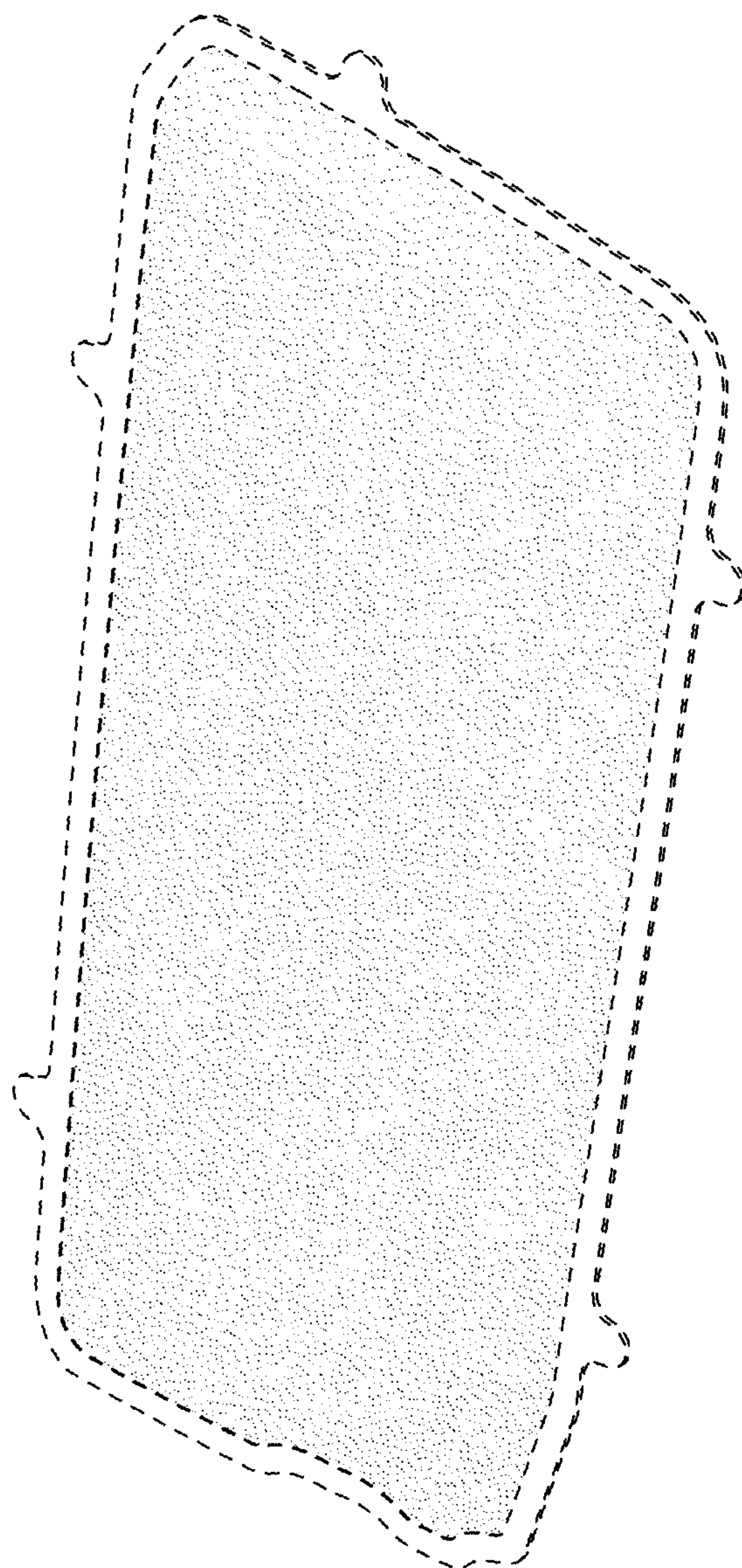

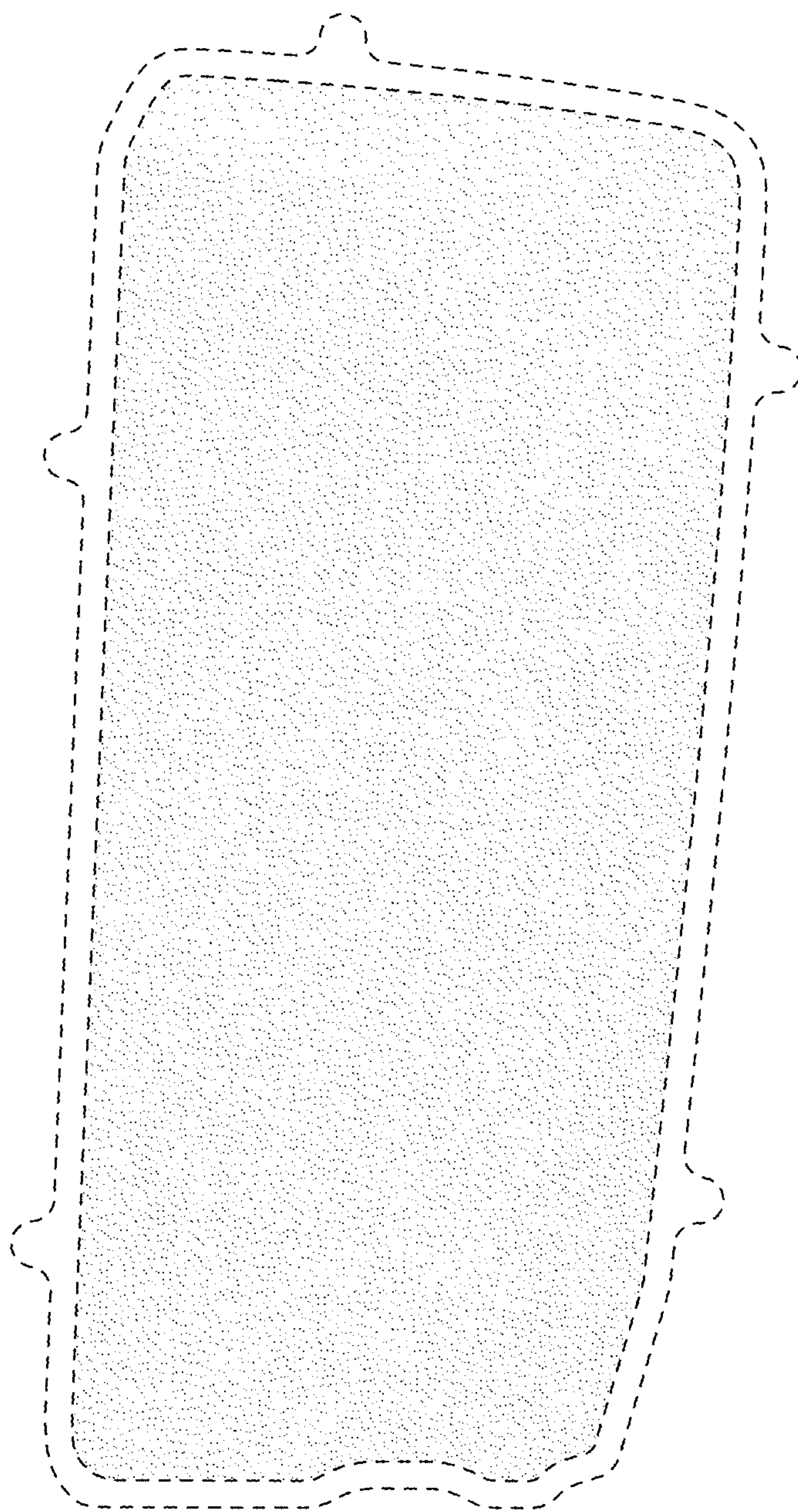

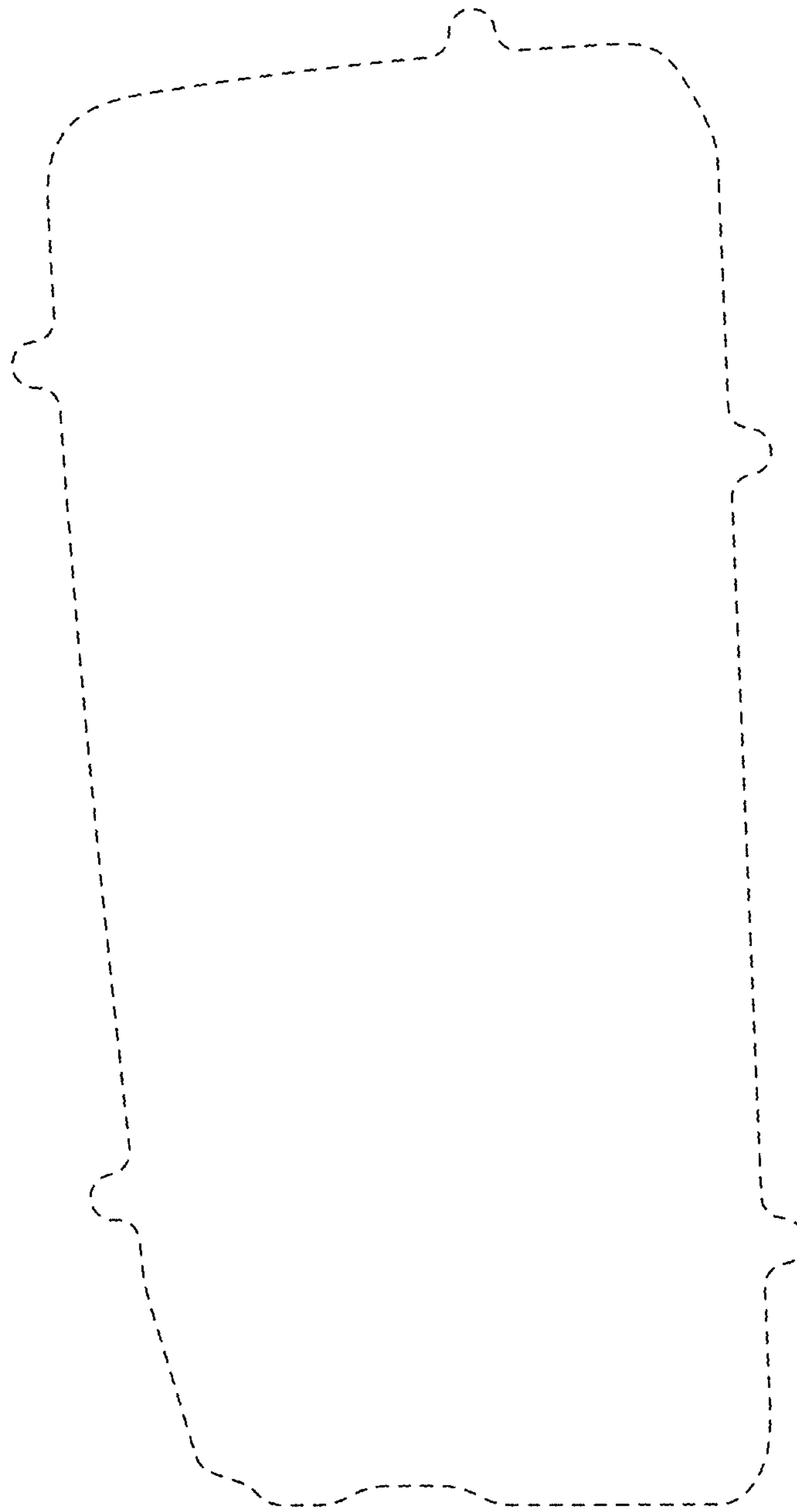

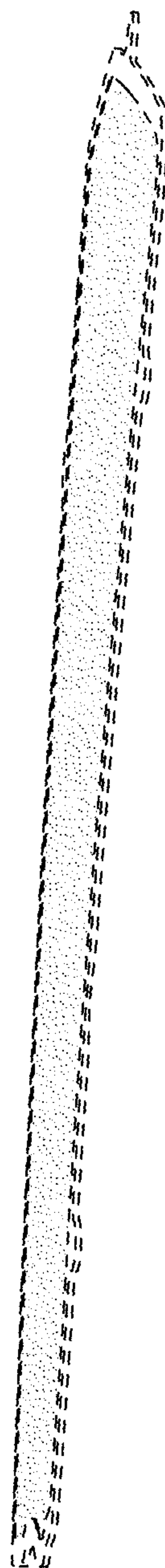

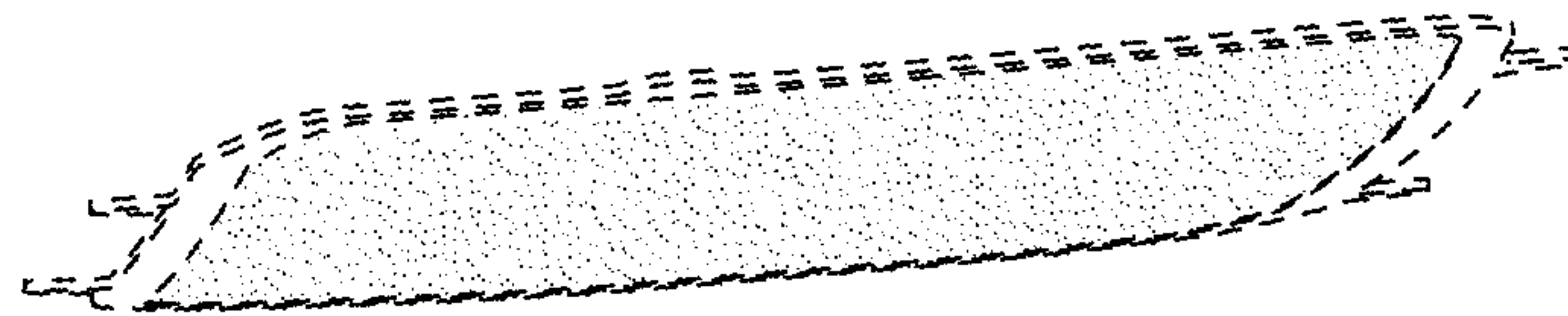

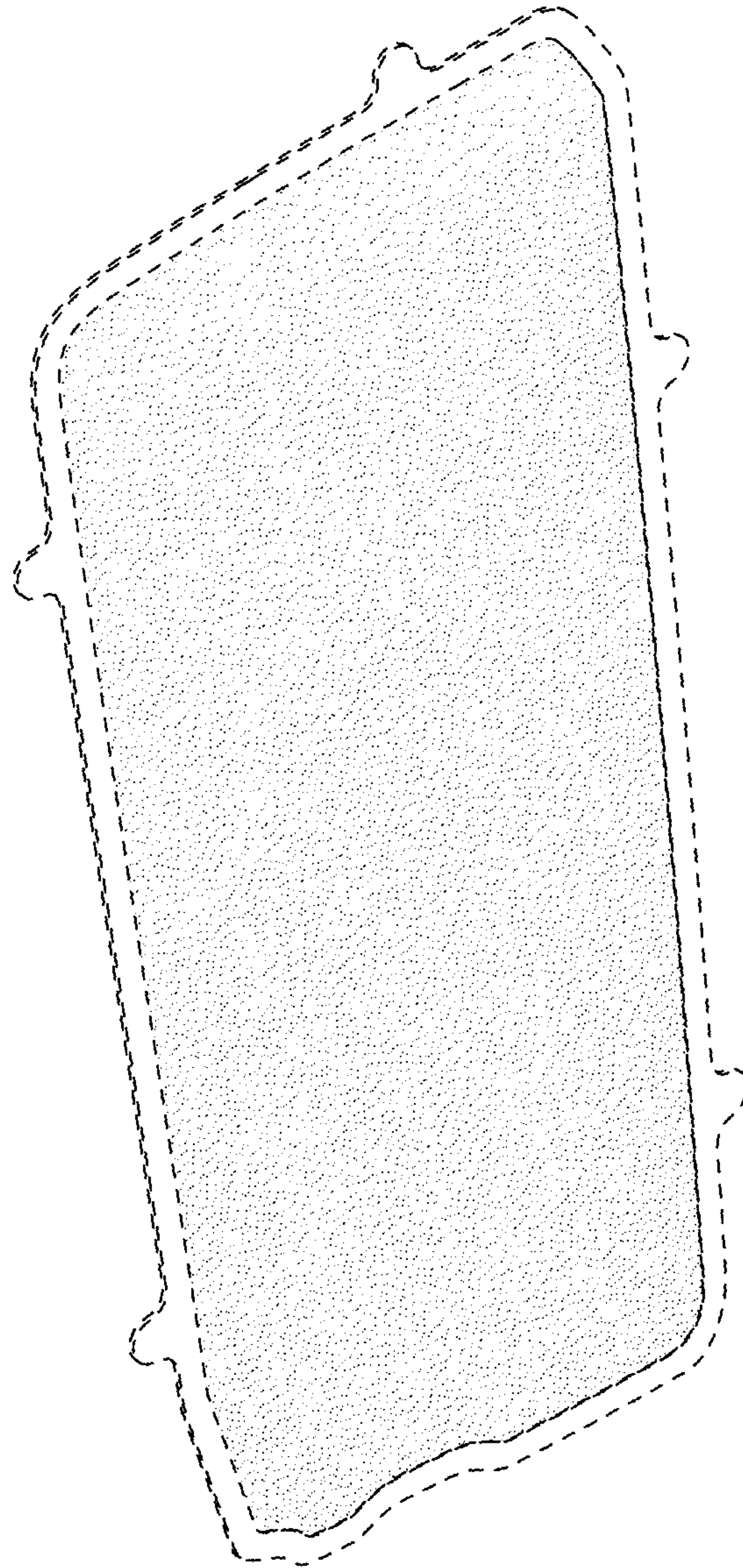

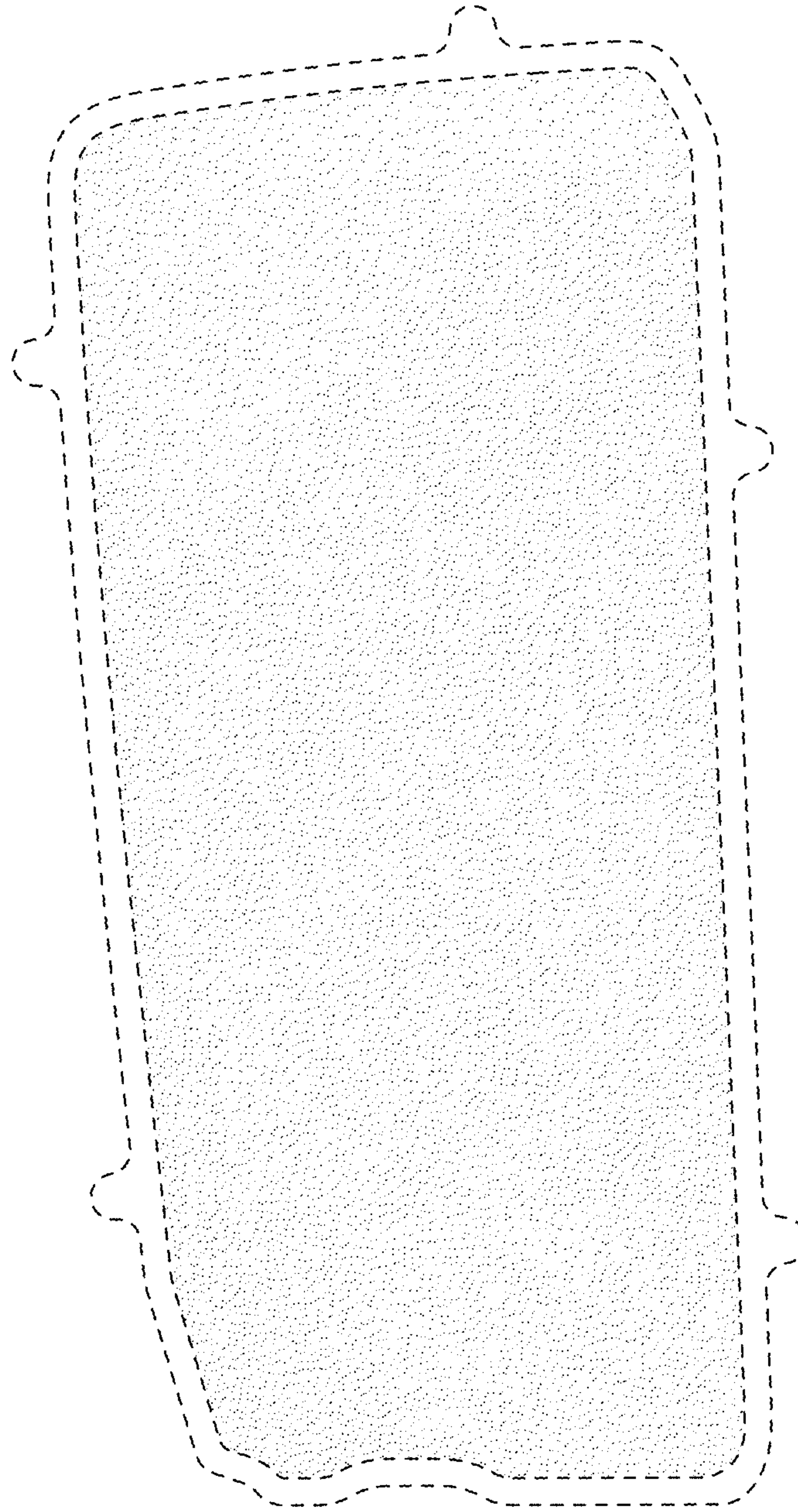

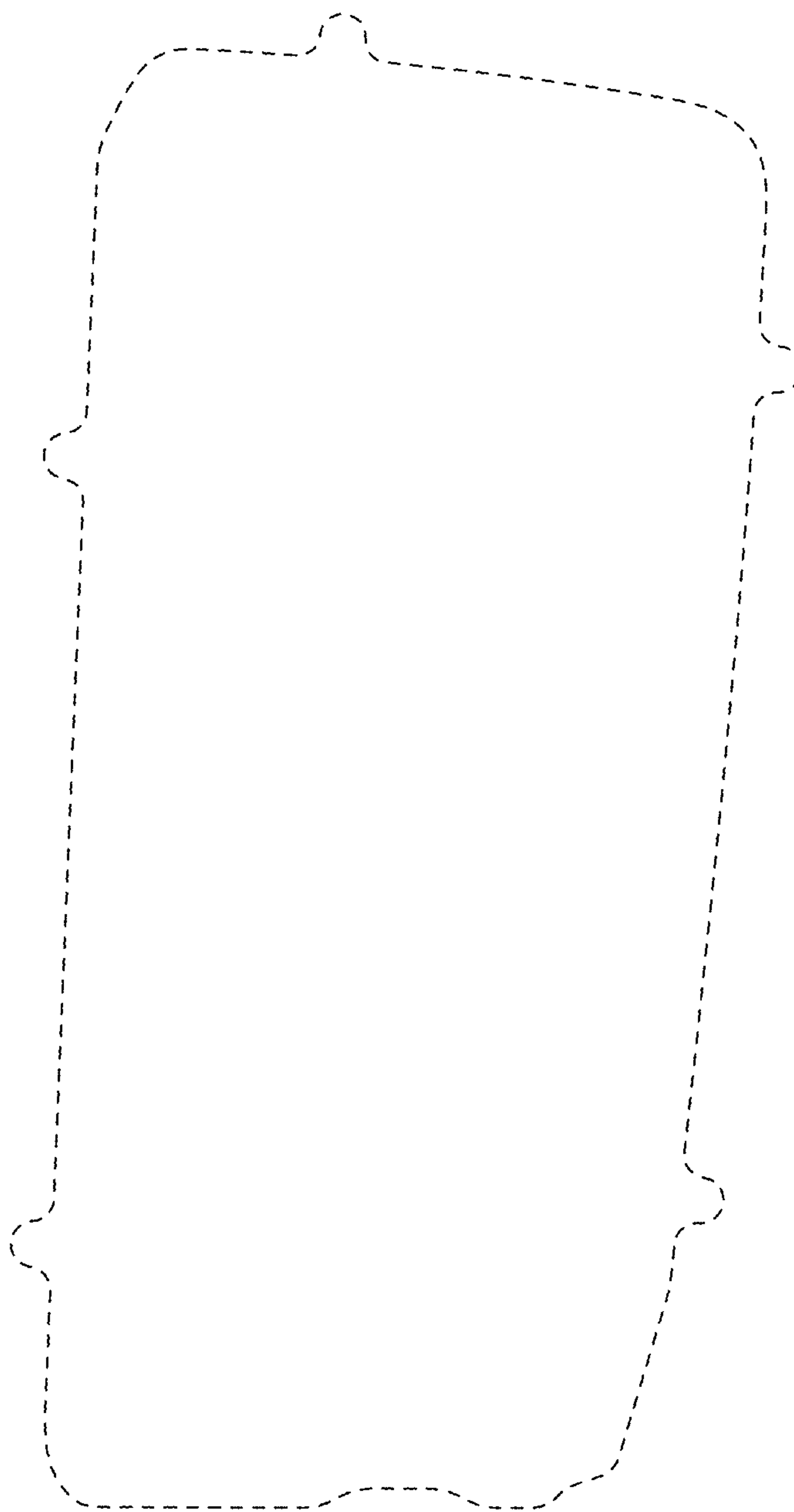

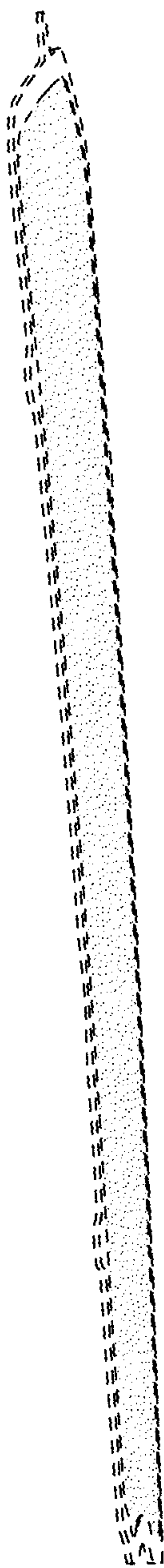

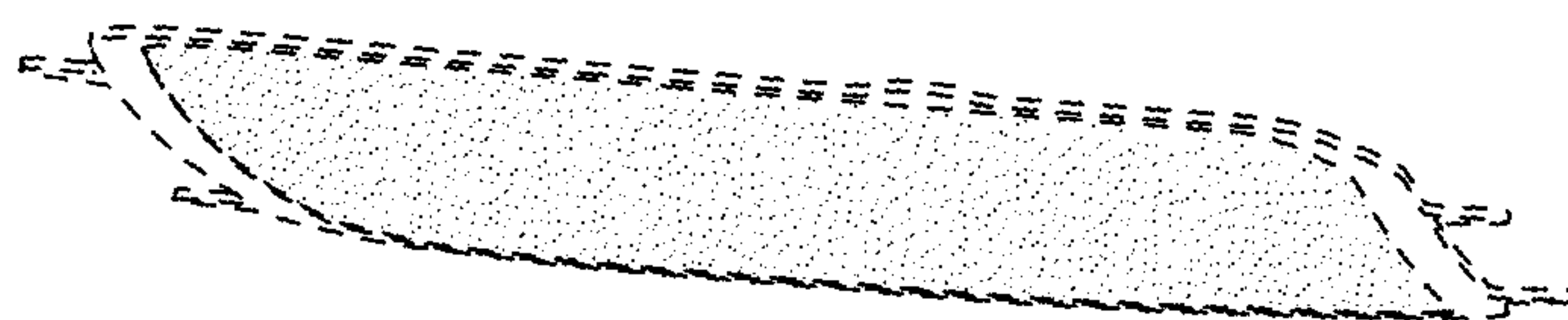
