FIG. 1 is a front, right, perspective view of a land clearing tool interface:

FIG. 2 is a rear, left perspective view thereof;

FIG. 3 is a top view thereof;

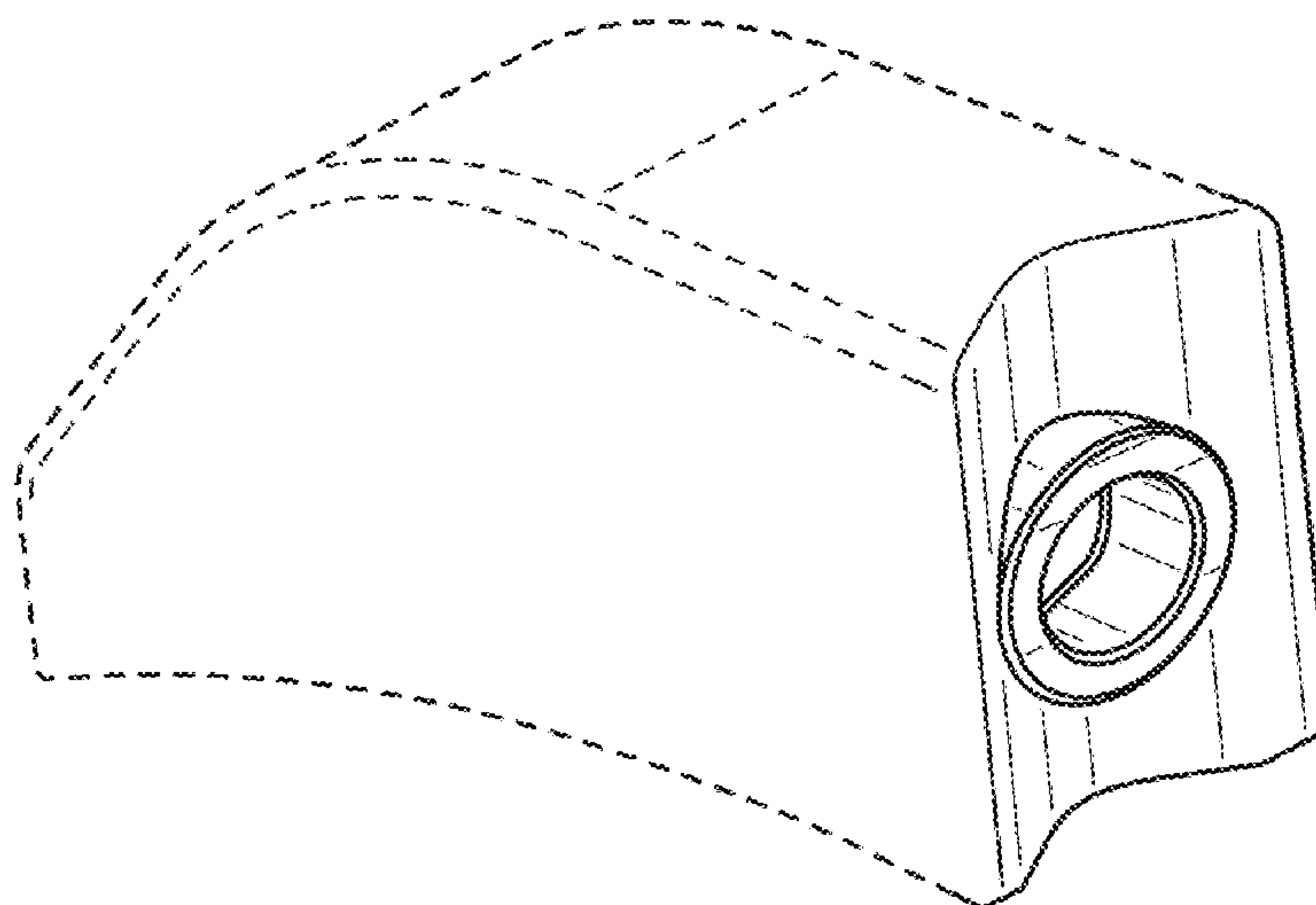
FIG. 4 is a right side view thereof, with a left side view being a mirror image of FIG. 4;

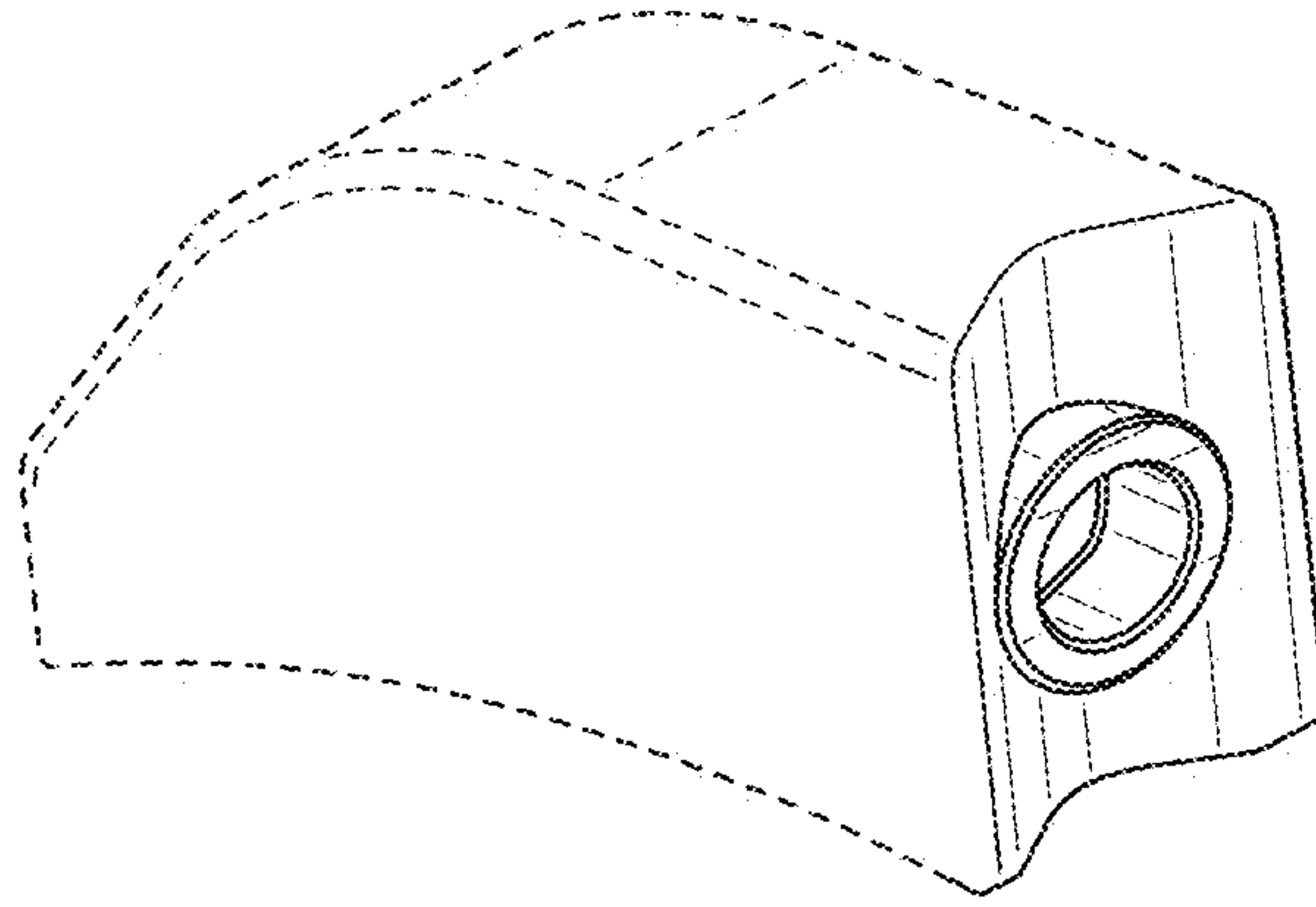

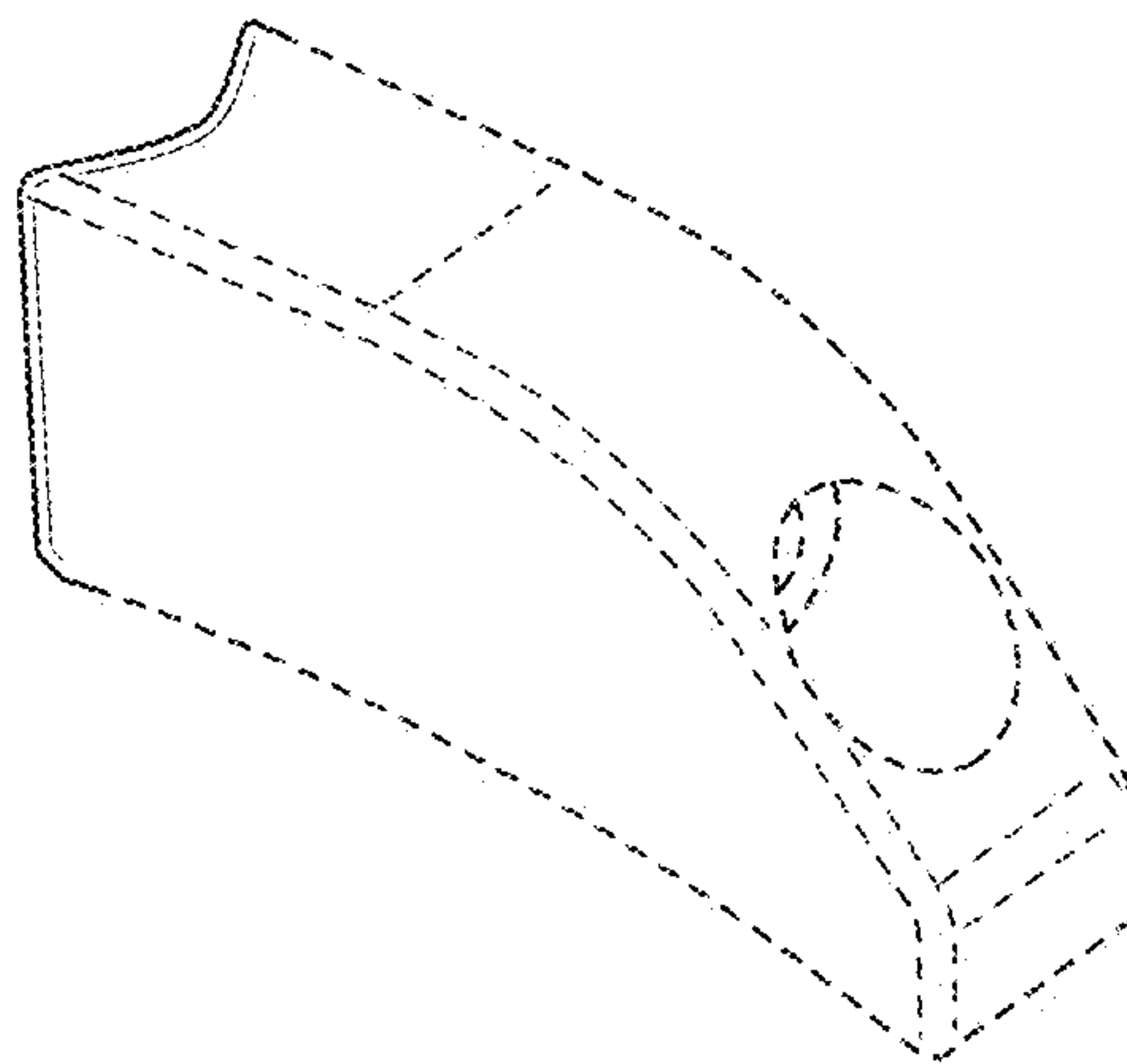

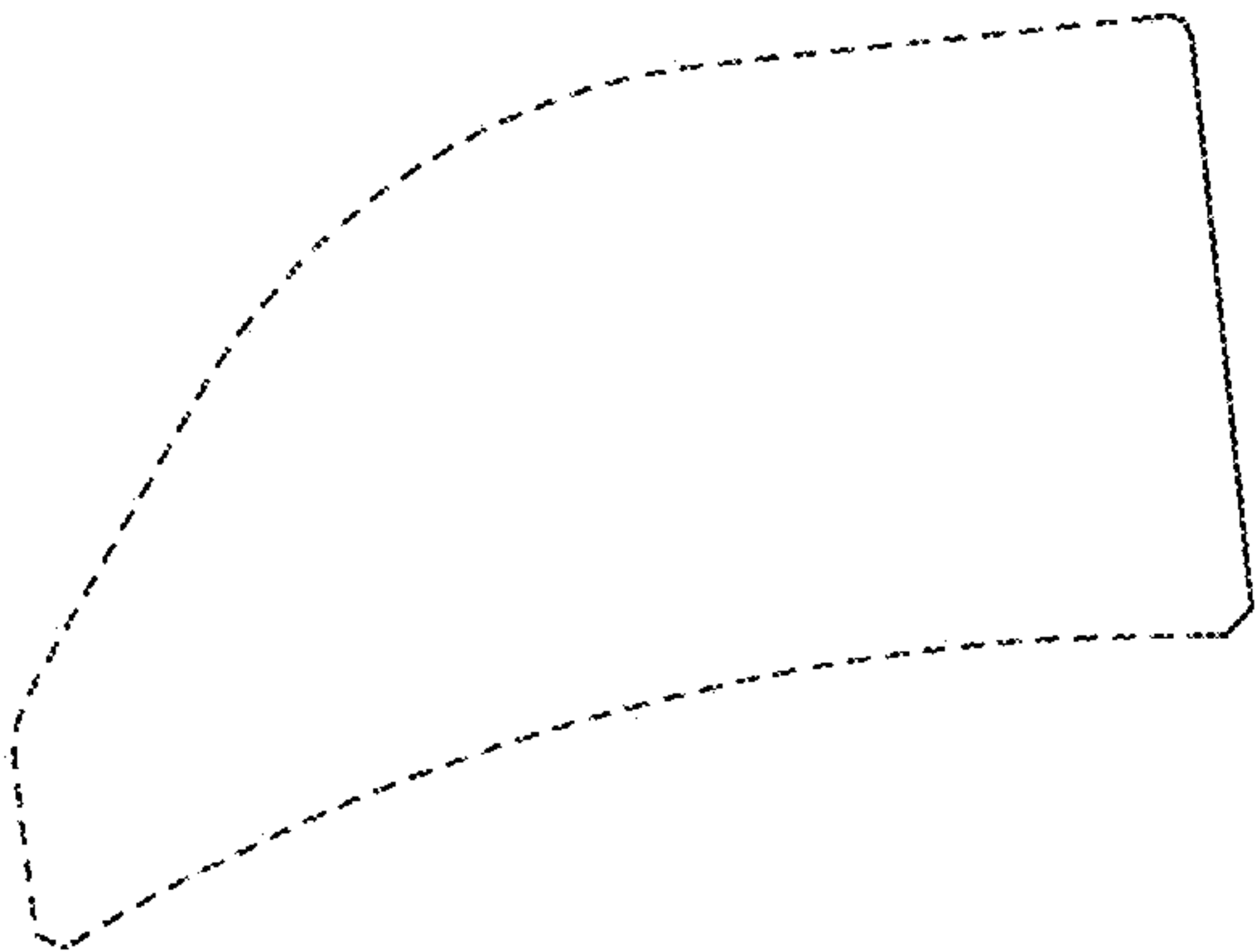

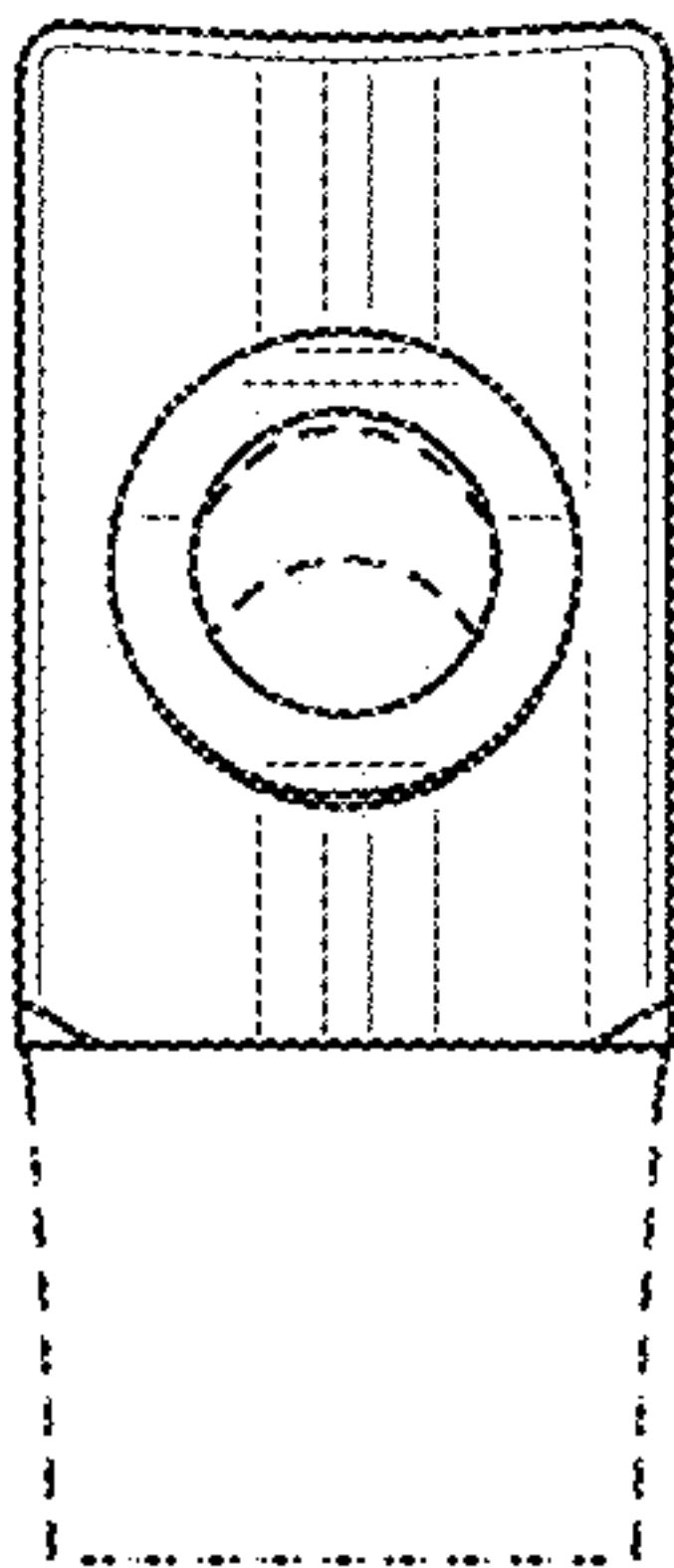
