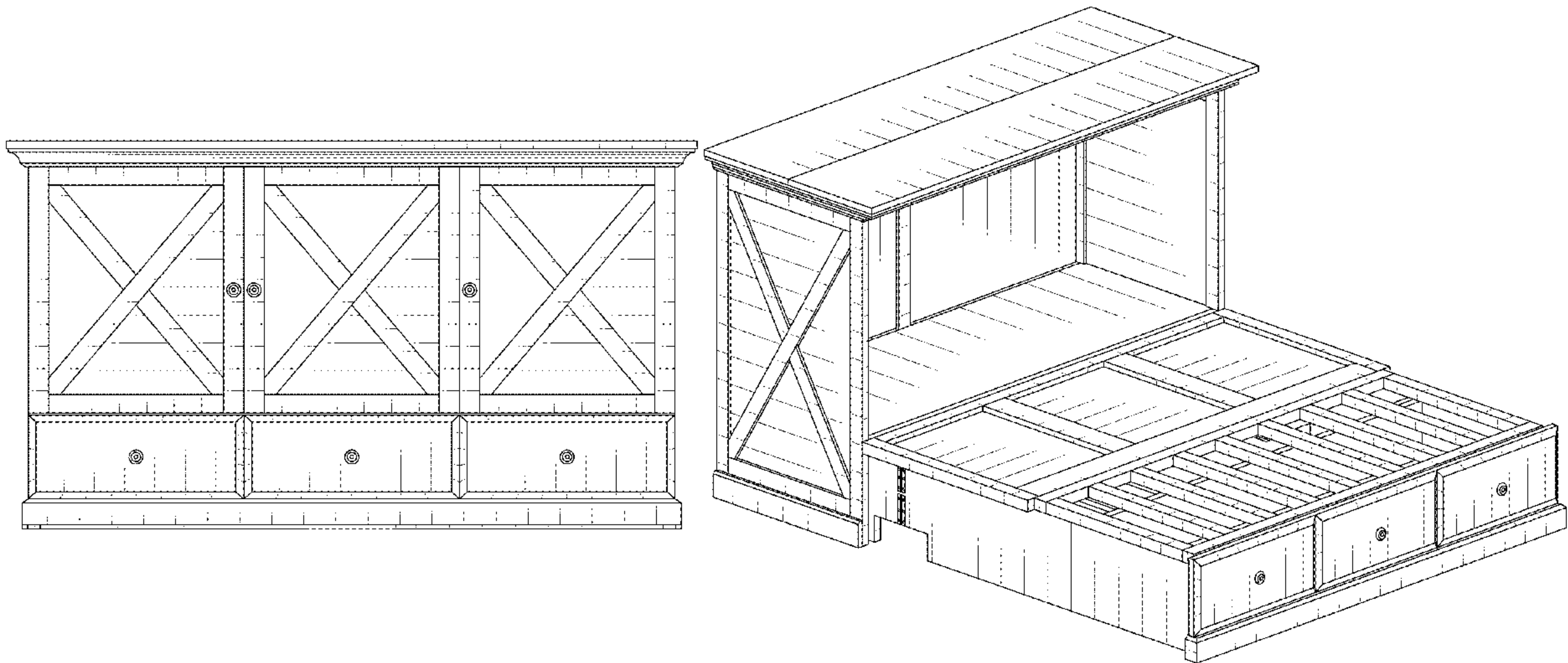
(57) CLAIM

The ornamental design for a fold-out cabinet bed, as shown and described.

DESCRIPTION

FIG. 1 is a front side elevation view of a fold-out cabinet bed, showing my design in a first position;
FIG. 2 is a back side elevation view thereof;
FIG. 3 is a left side elevation view thereof;
FIG. 4 is a right side elevation view thereof;
FIG. 5 is a top plan view thereof;
FIG. 6 is a bottom plan view thereof;
FIG. 7 is a front perspective view of the fold-out cabinet bed of FIG. 1, showing my new design in a second position;
FIG. 8 is a left side elevation view thereof;
FIG. 9 is a front side elevation view thereof;
FIG. 10 is a front perspective view of the fold-out cabinet bed of FIG. 1, showing my new design in a third position;
FIG. 11 is a front side elevation view thereof;
FIG. 12 is a back side elevation view thereof;
FIG. 13 is a top plan view thereof;
FIG. 14 is a left side elevation view thereof; and,
FIG. 15 is a bottom plan view thereof.

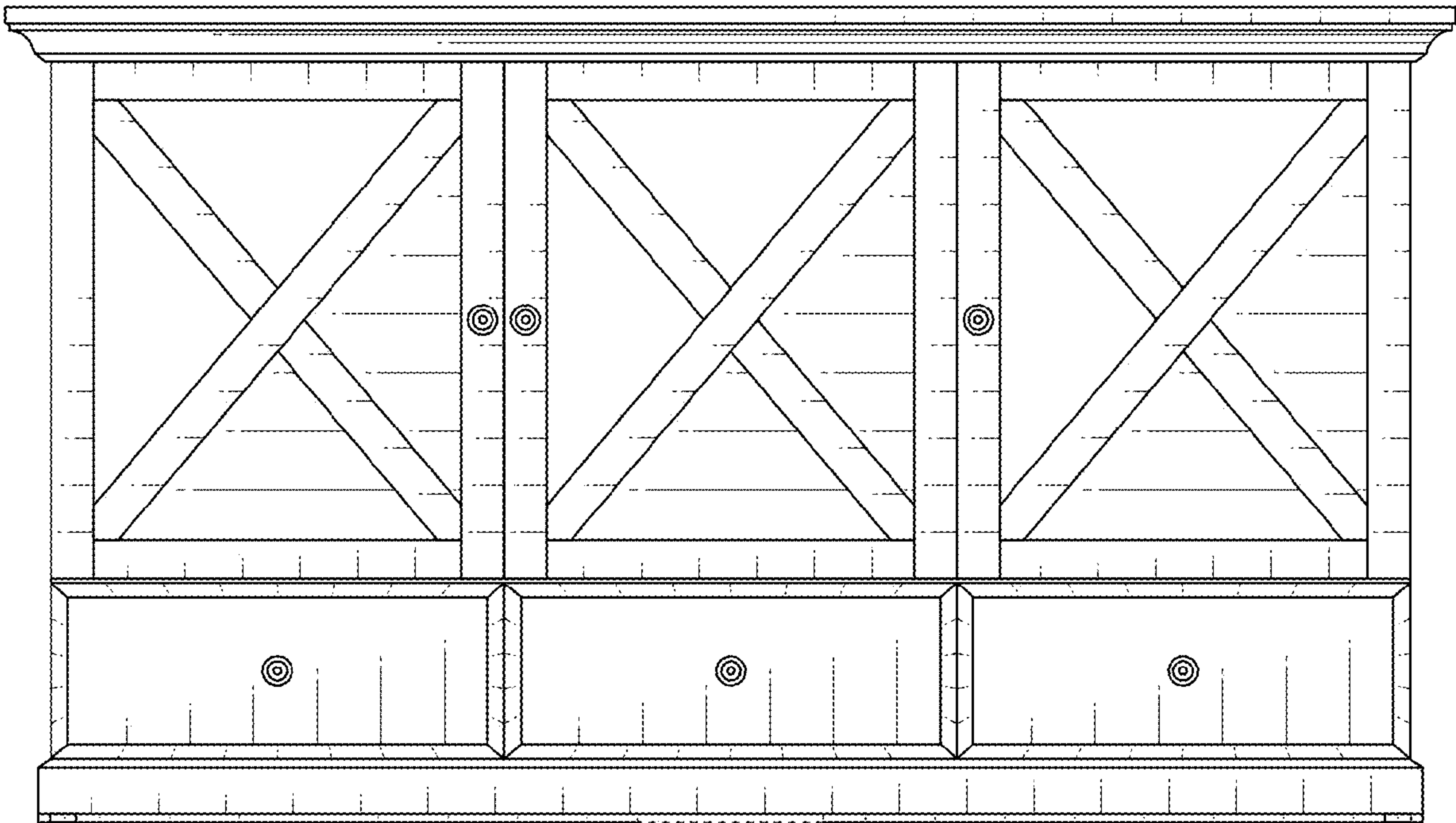

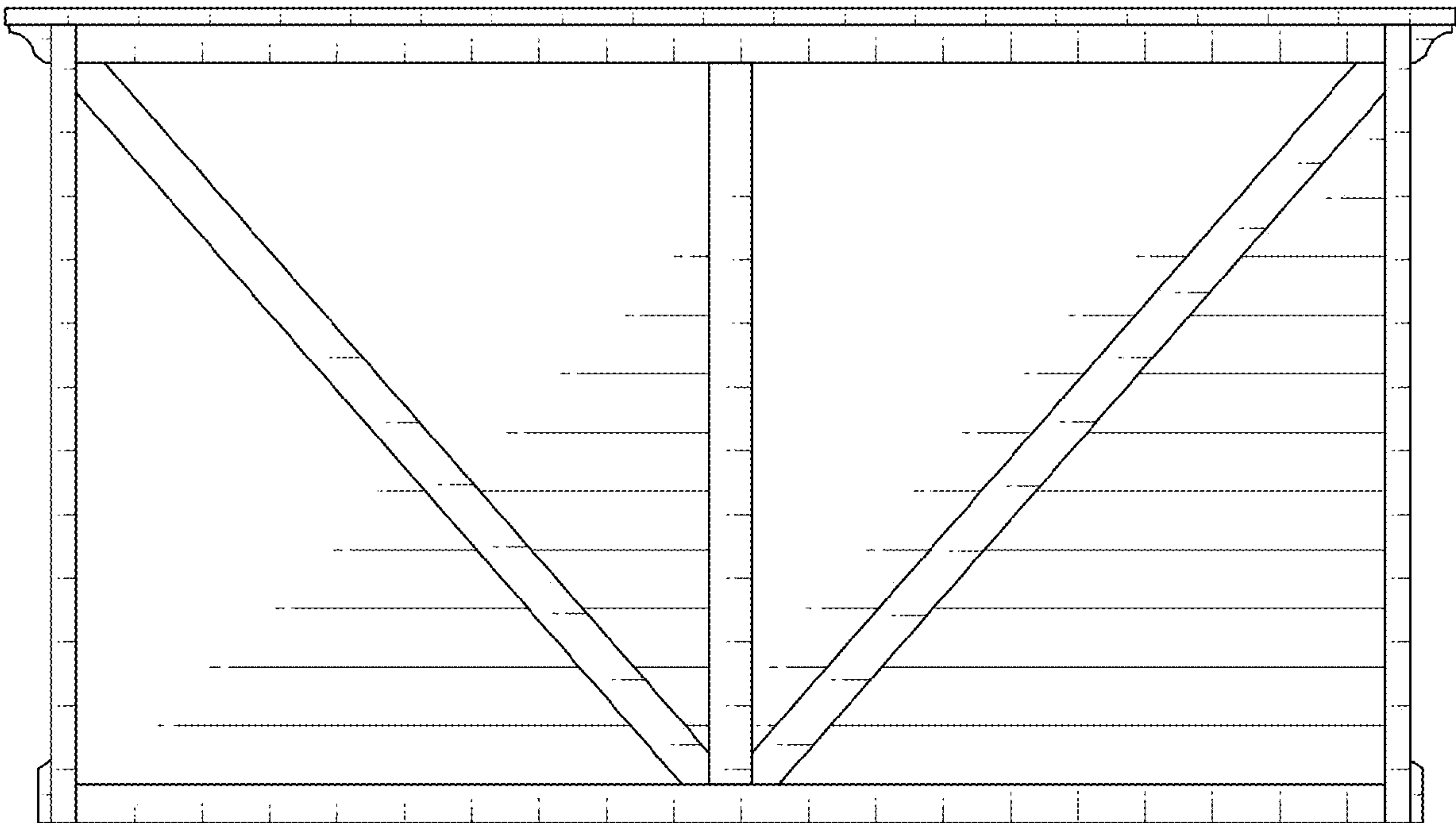

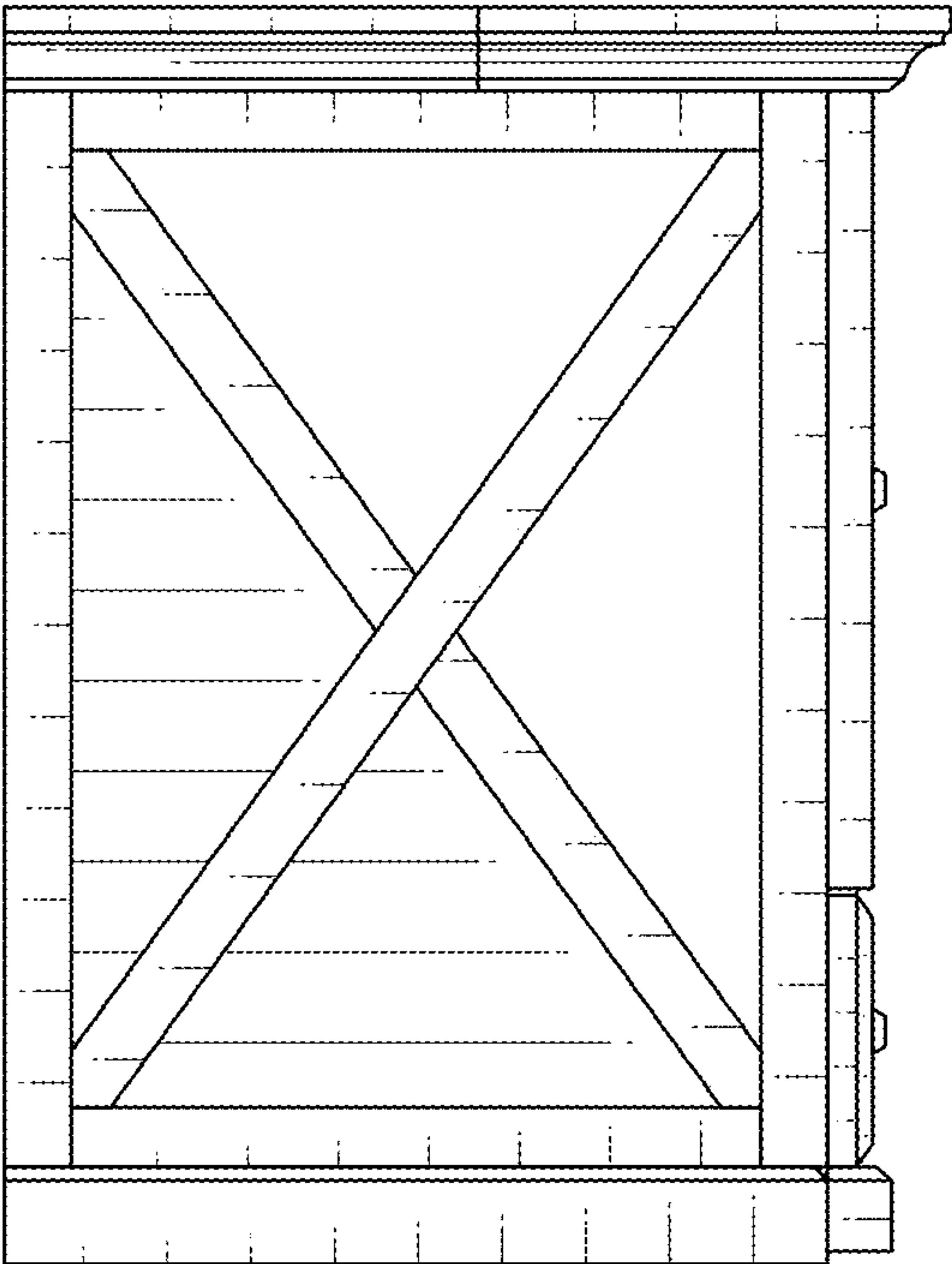

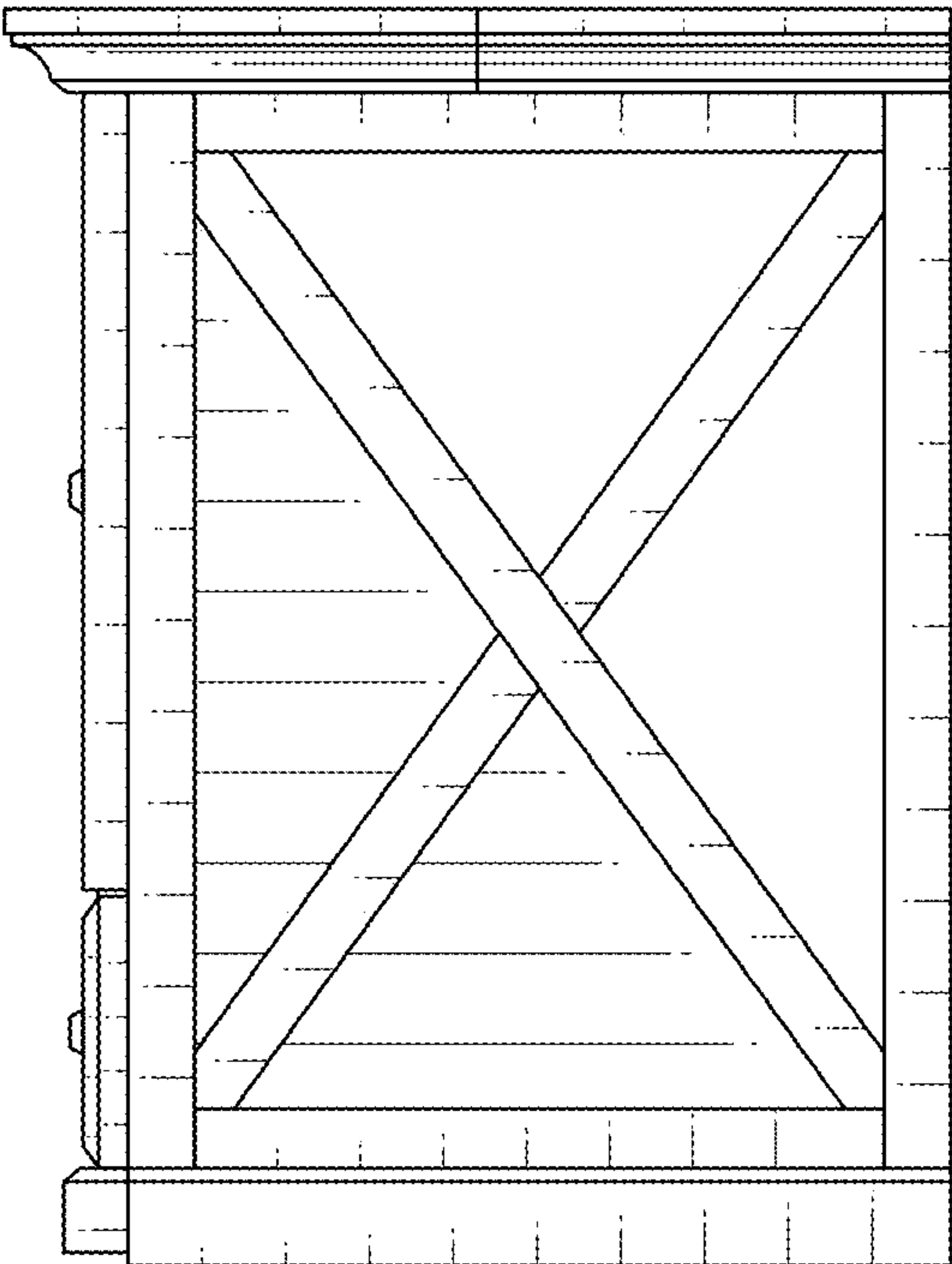

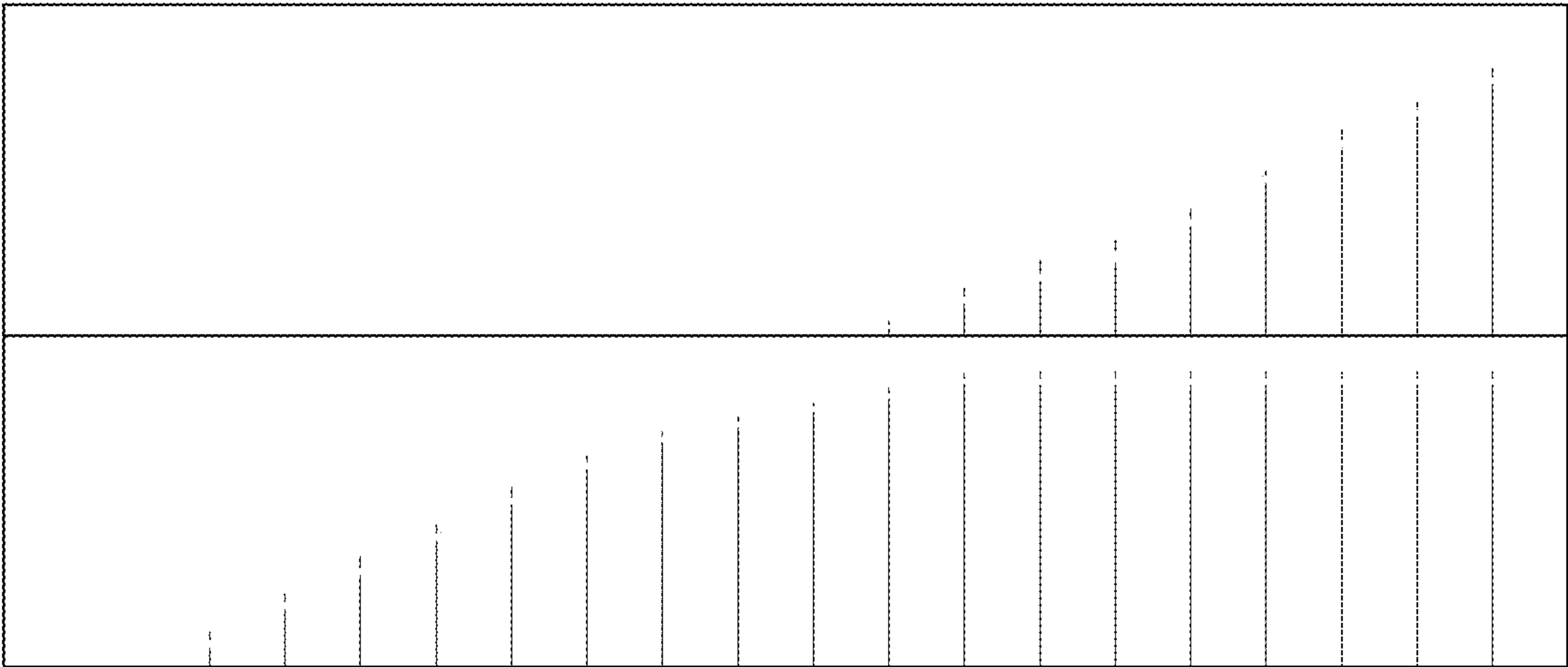

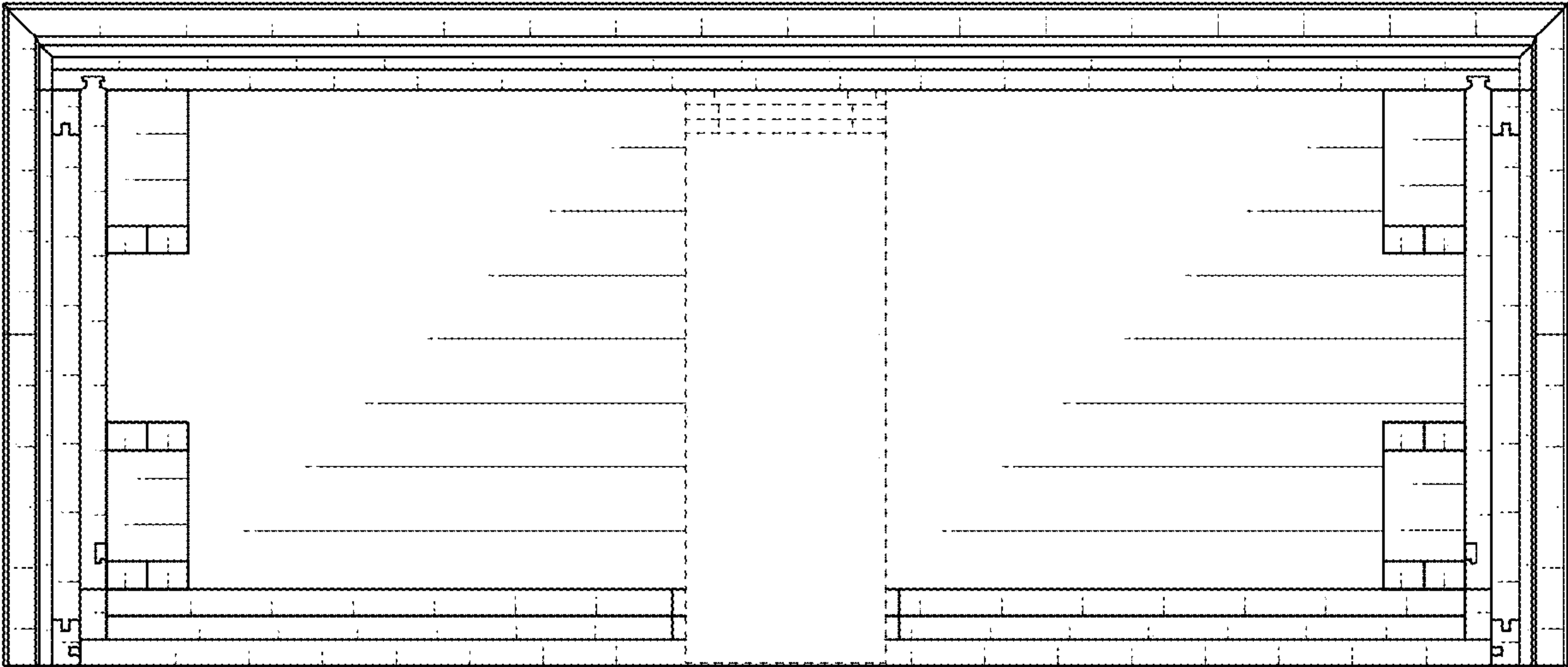

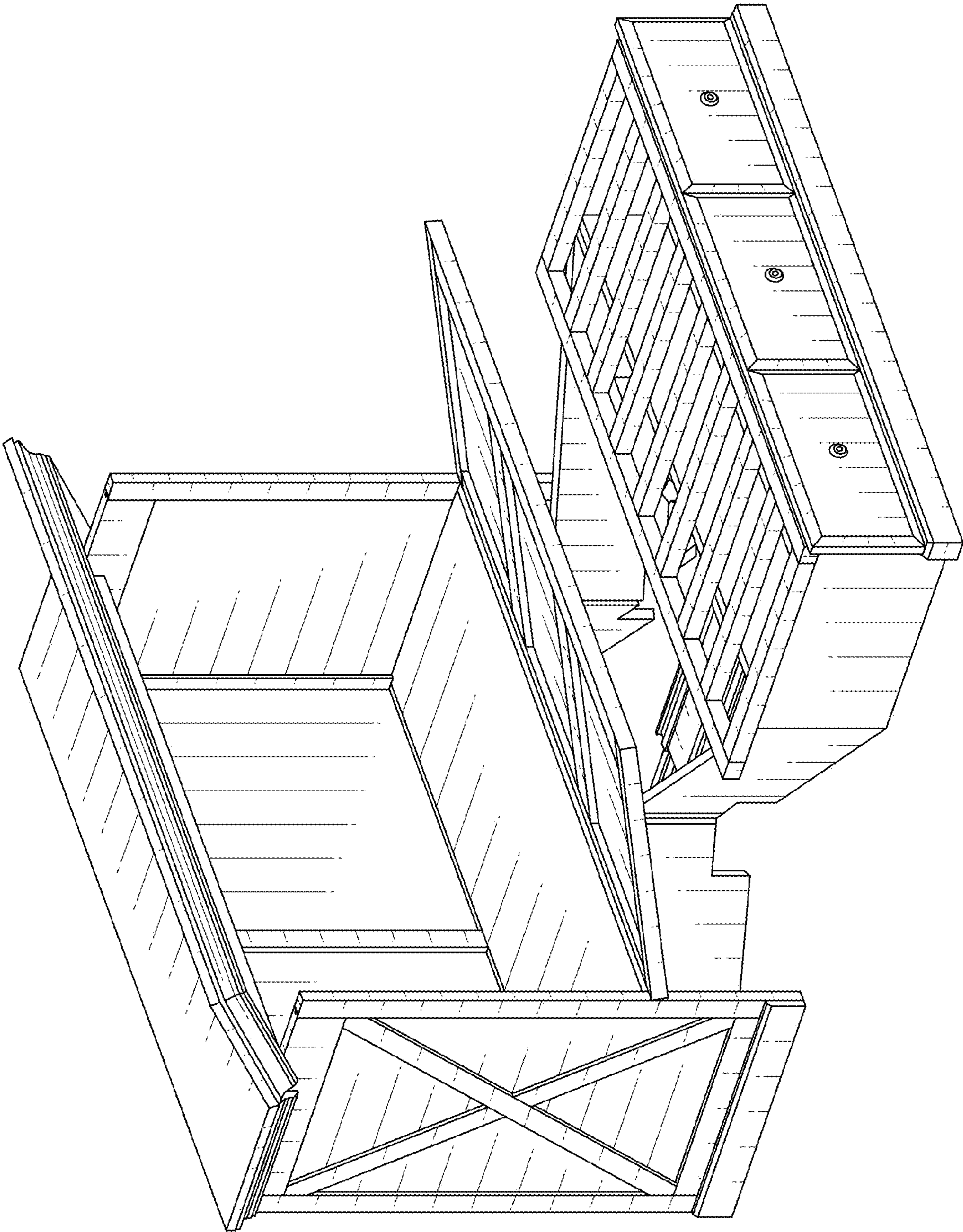

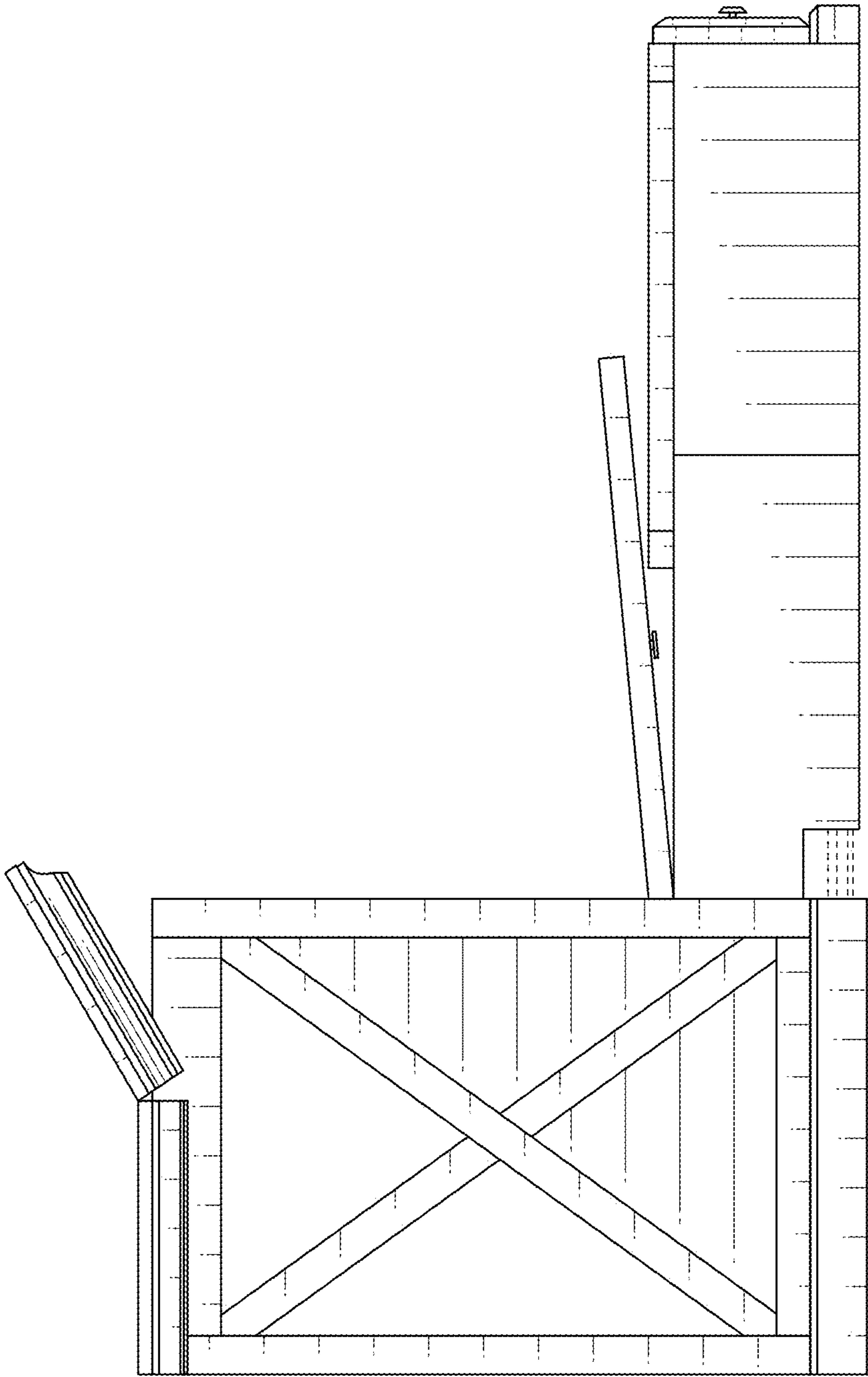

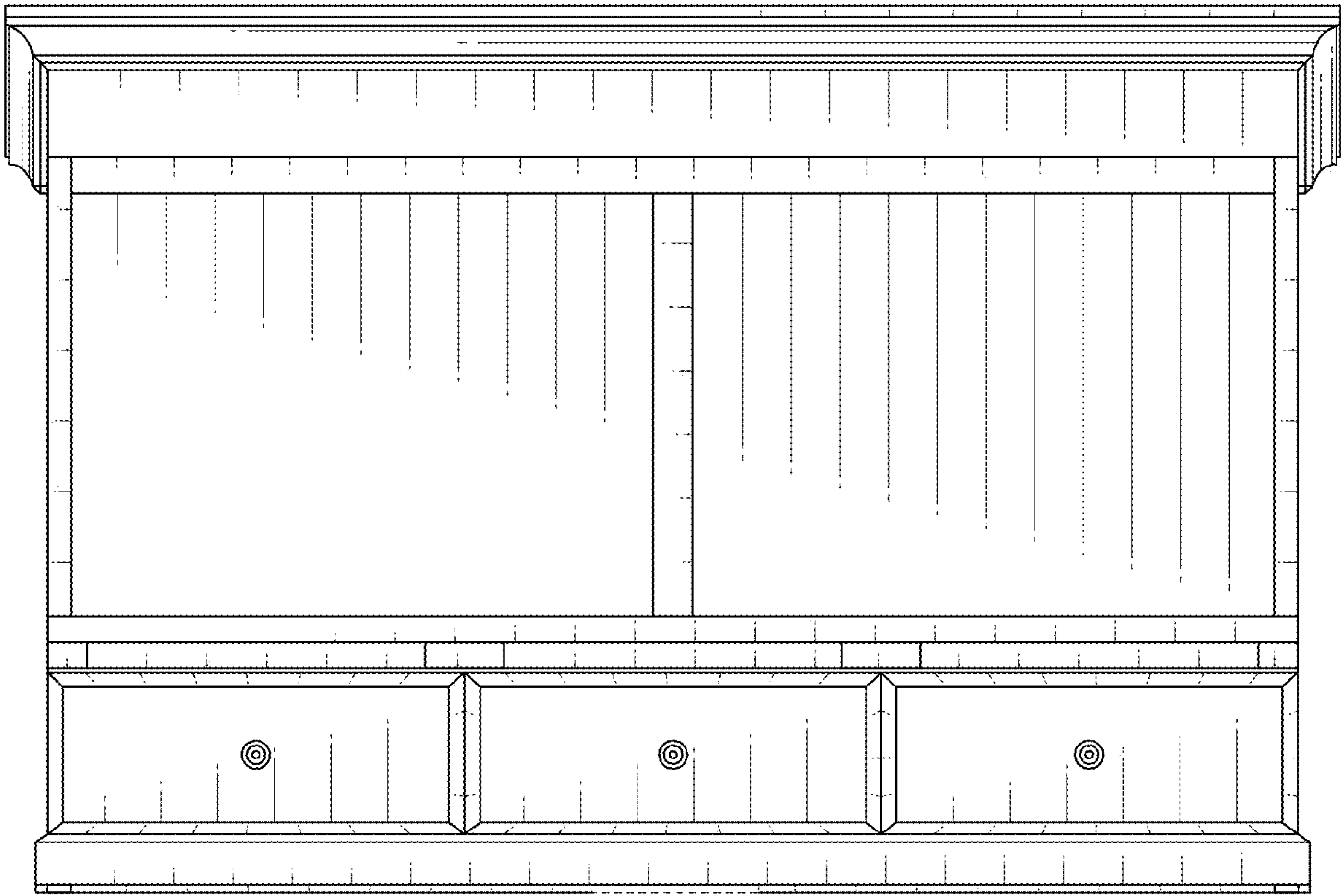

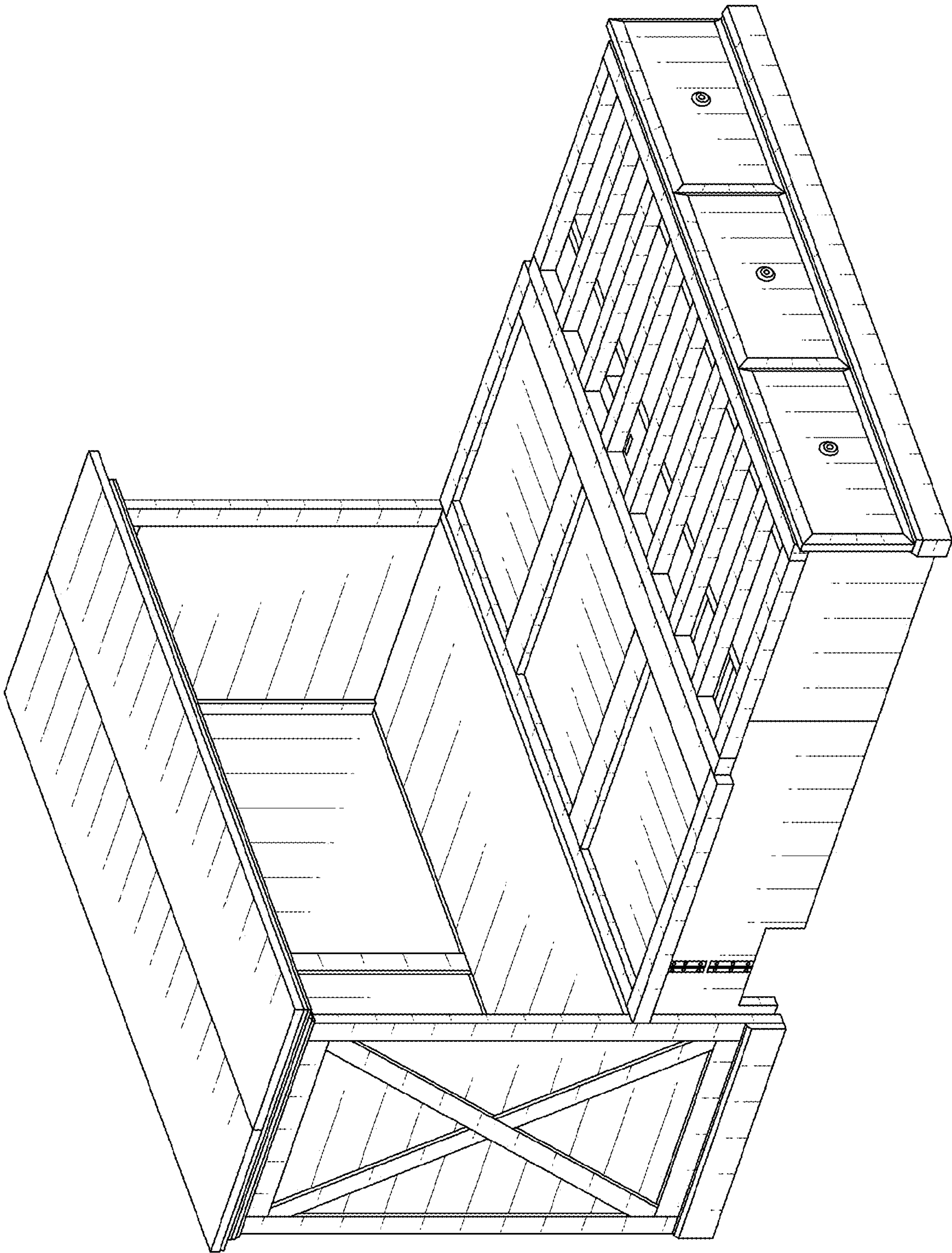

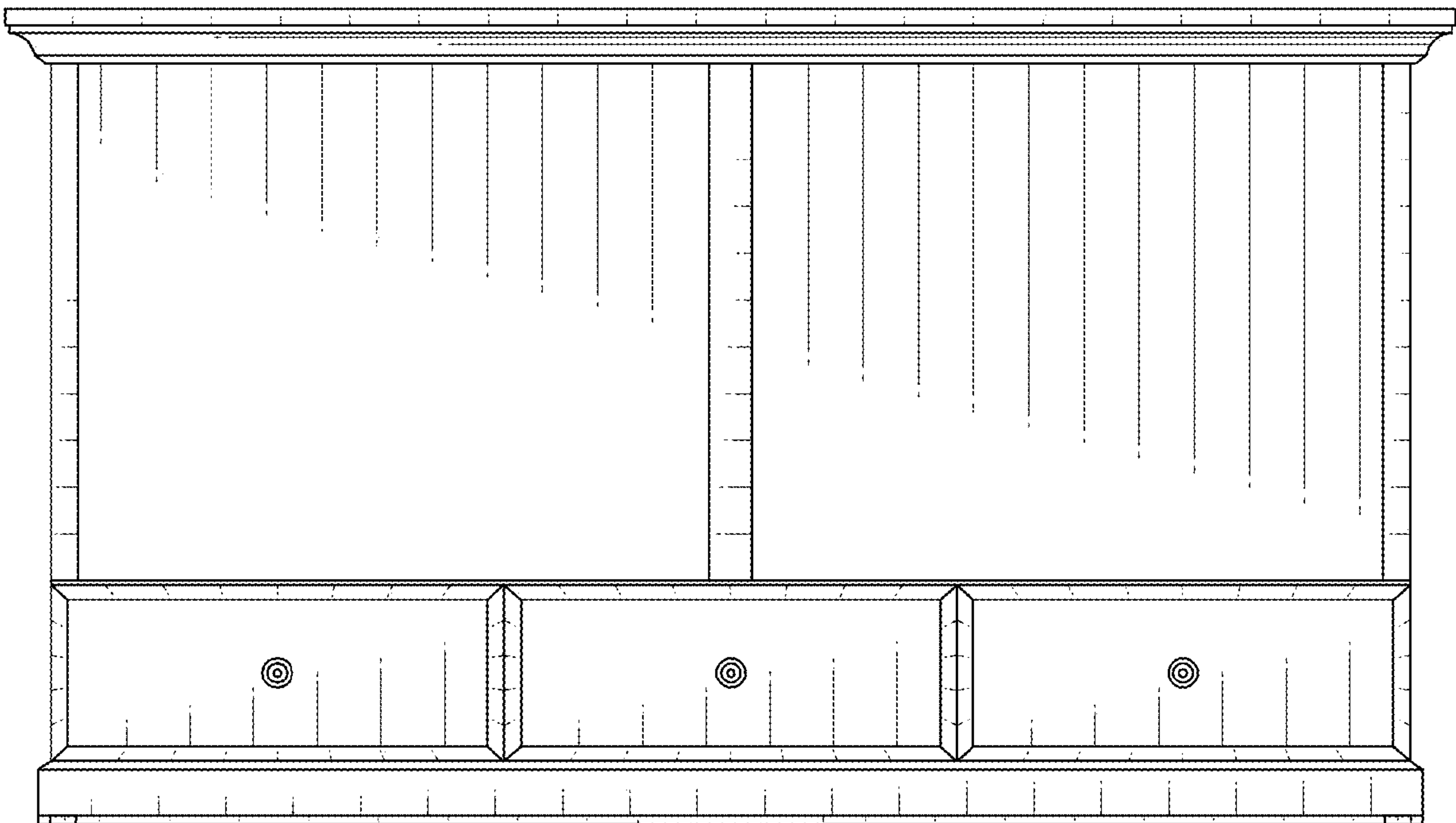

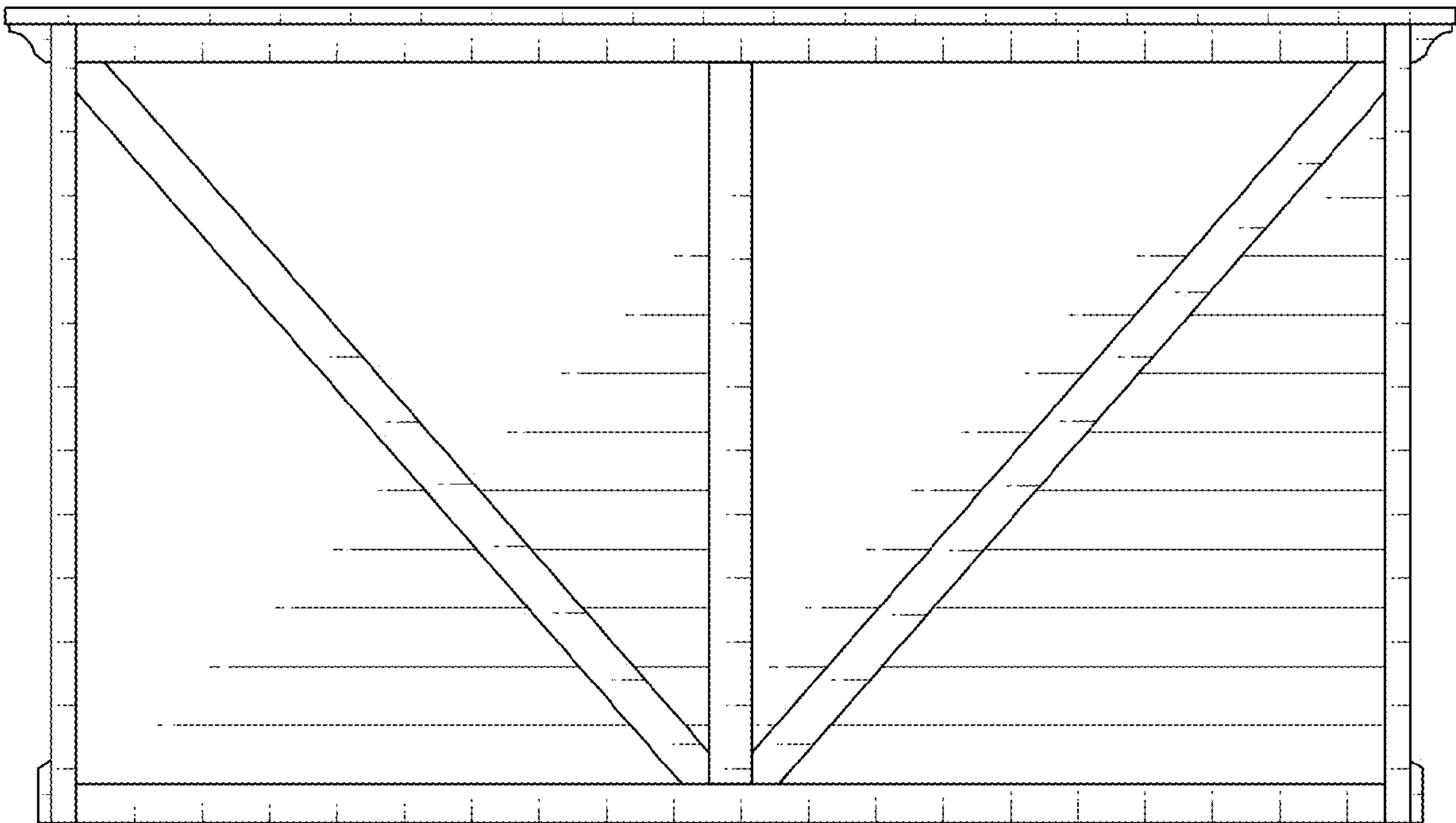

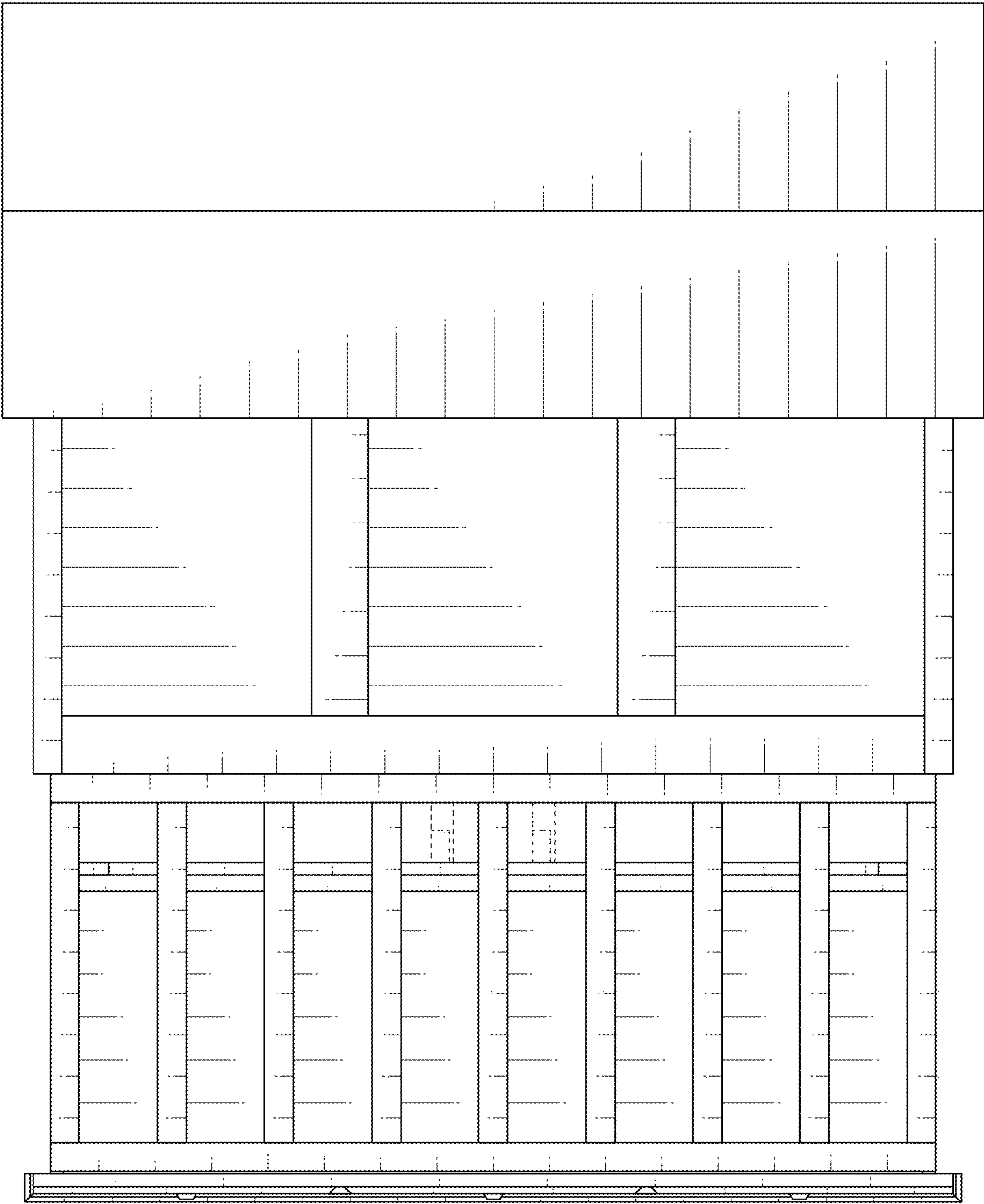

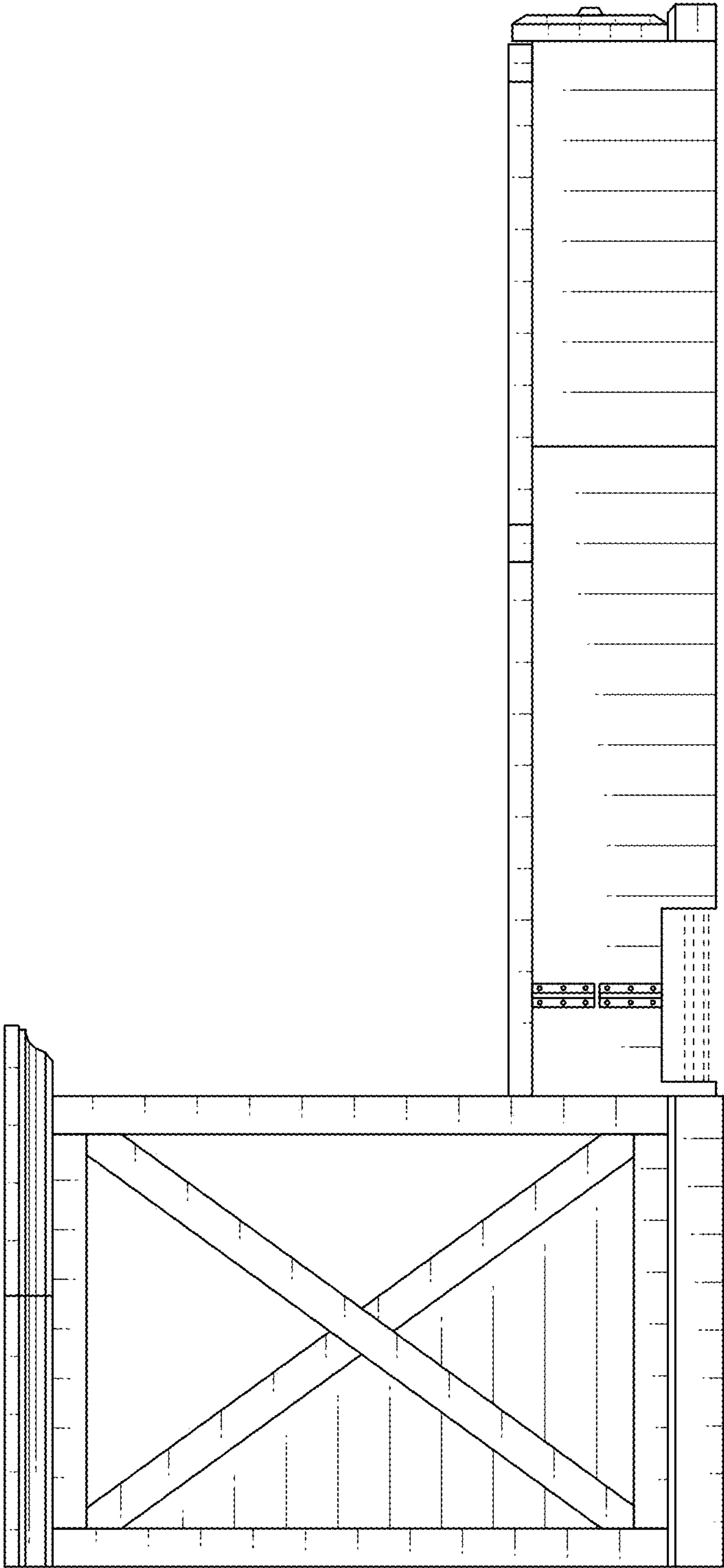

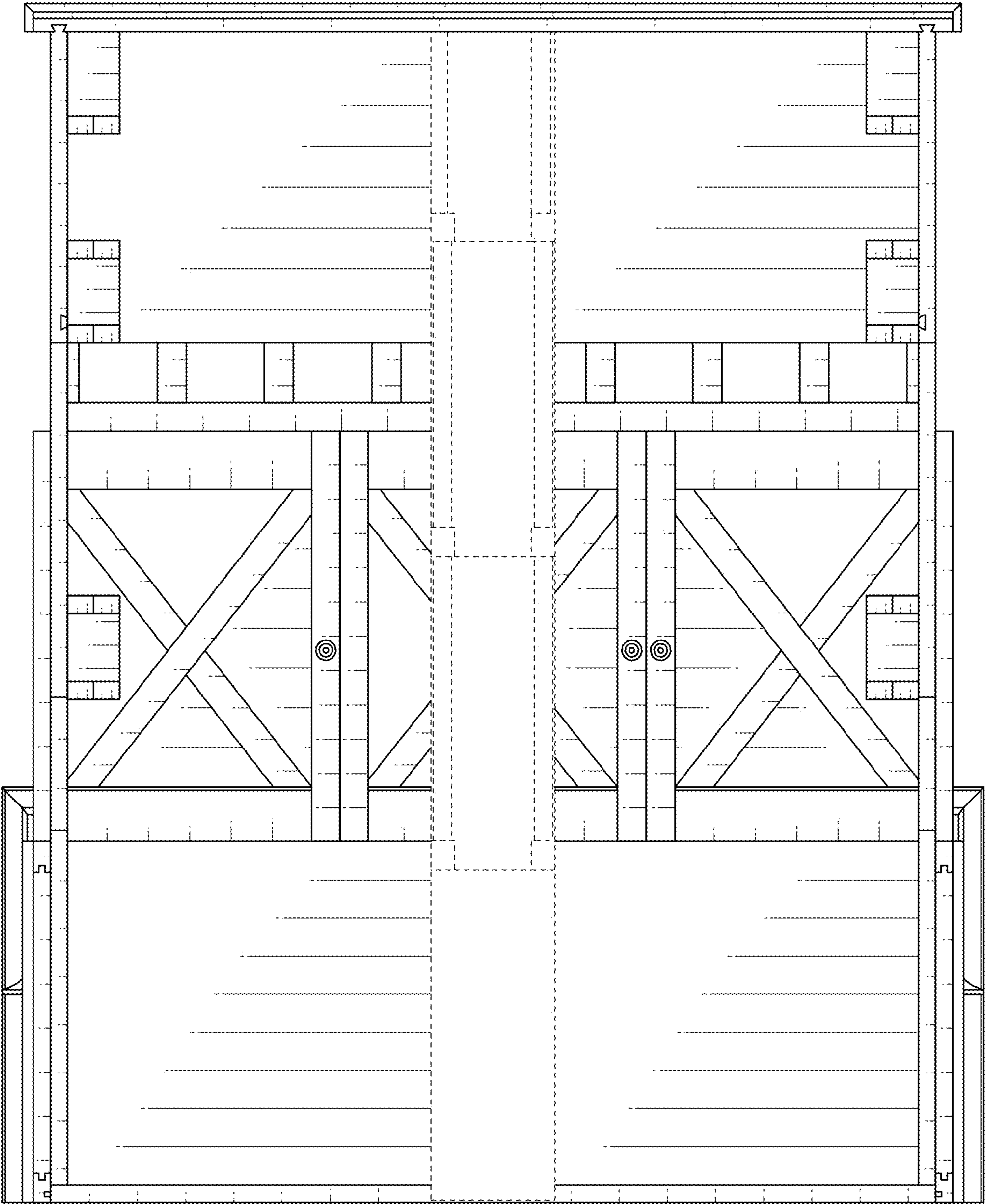
