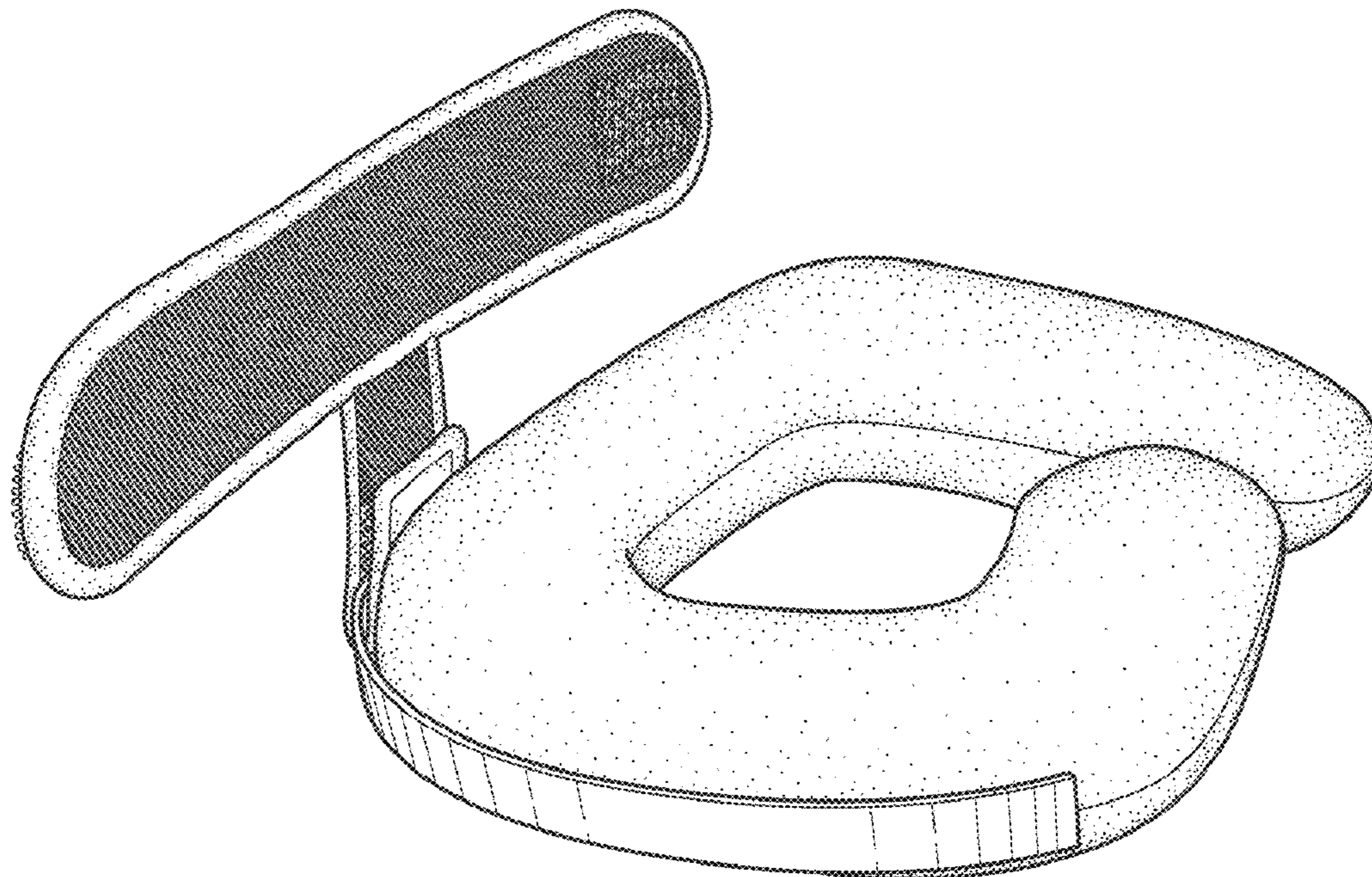
(57) **CLAIM**

The ornamental design for a pillow with detachable eye and ear shield, as shown and described.

DESCRIPTION

FIG. 1 is a left perspective view of the pillow with detachable eye and ear shield, showing my new design;

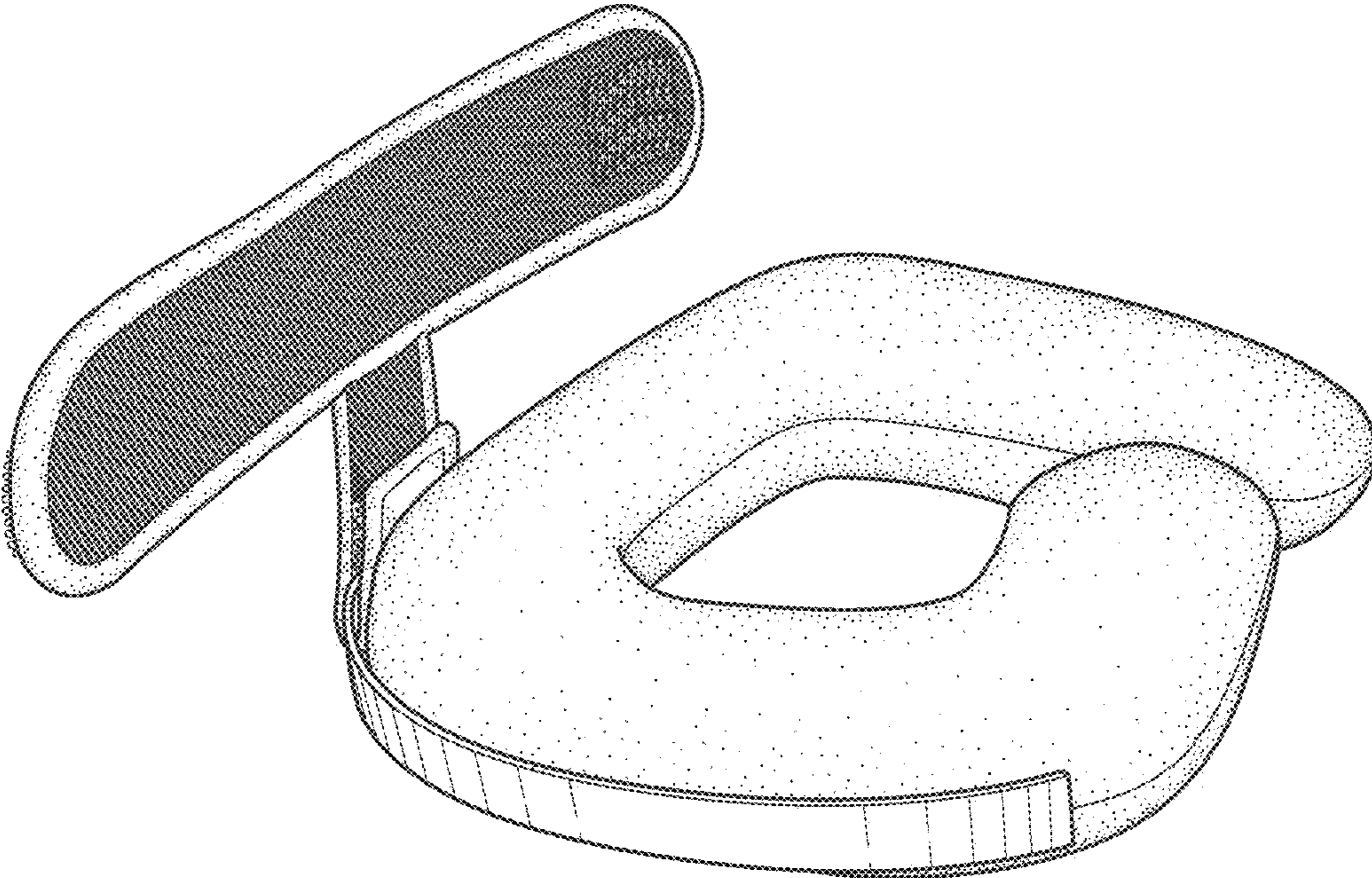

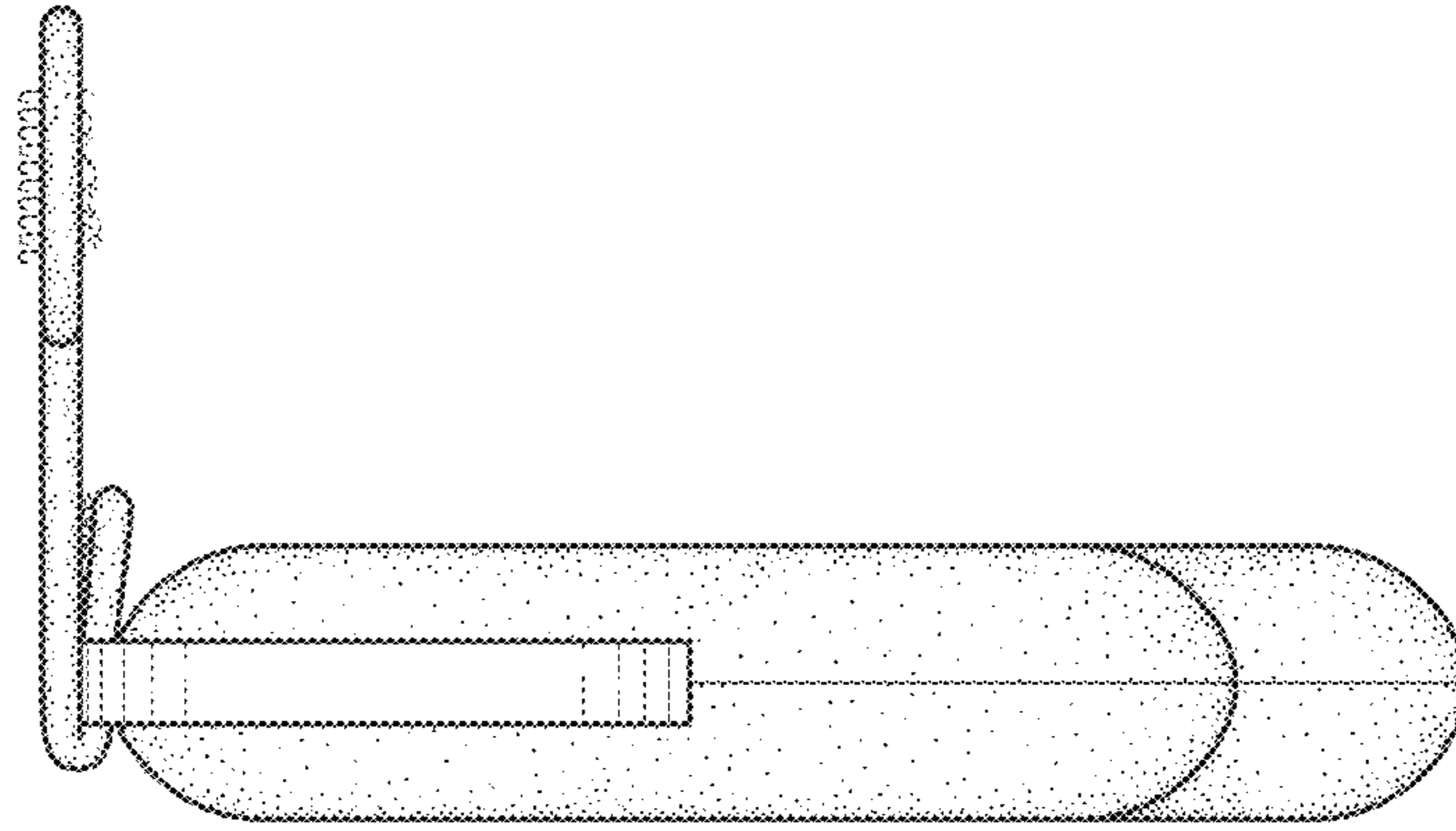

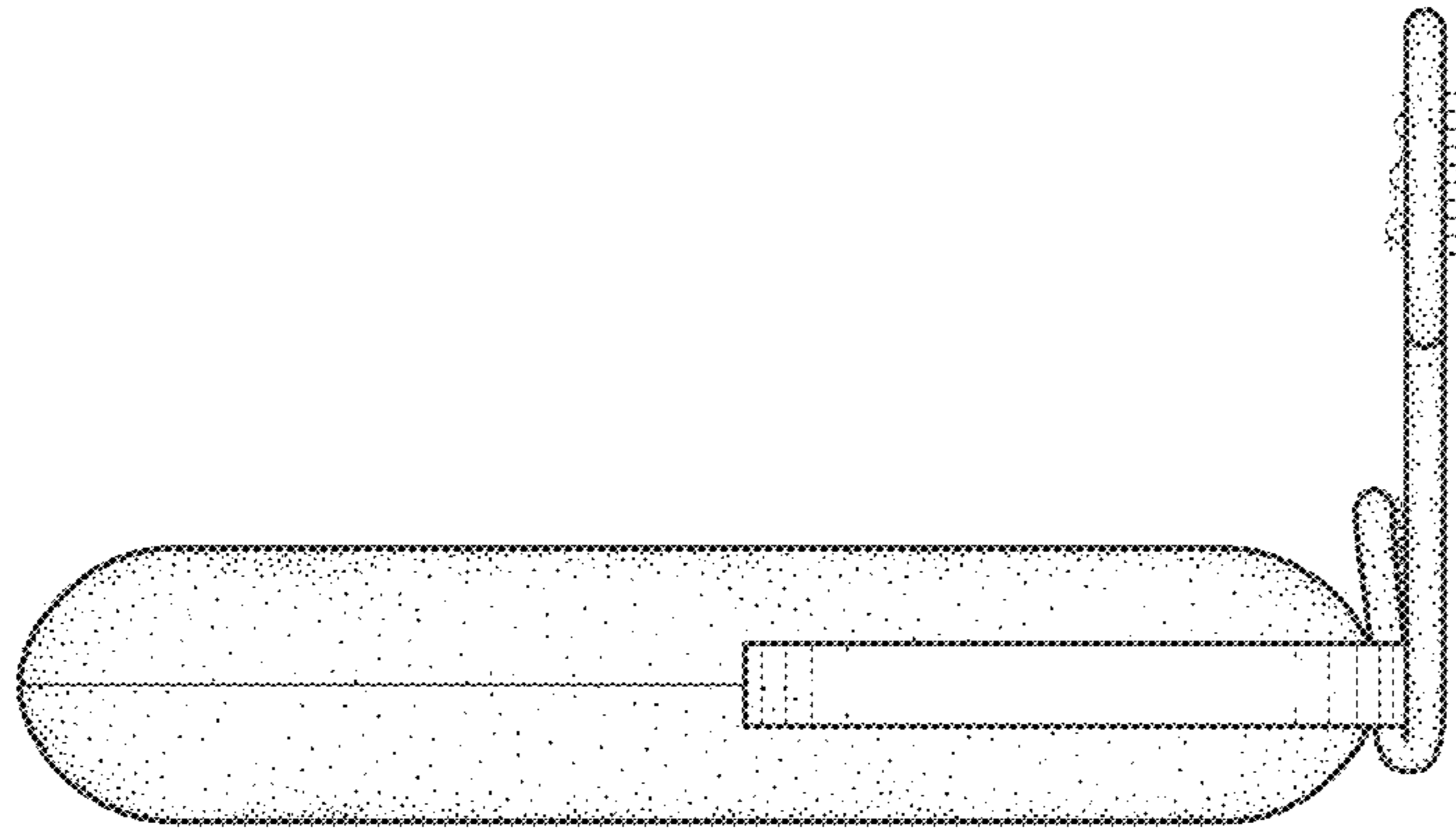

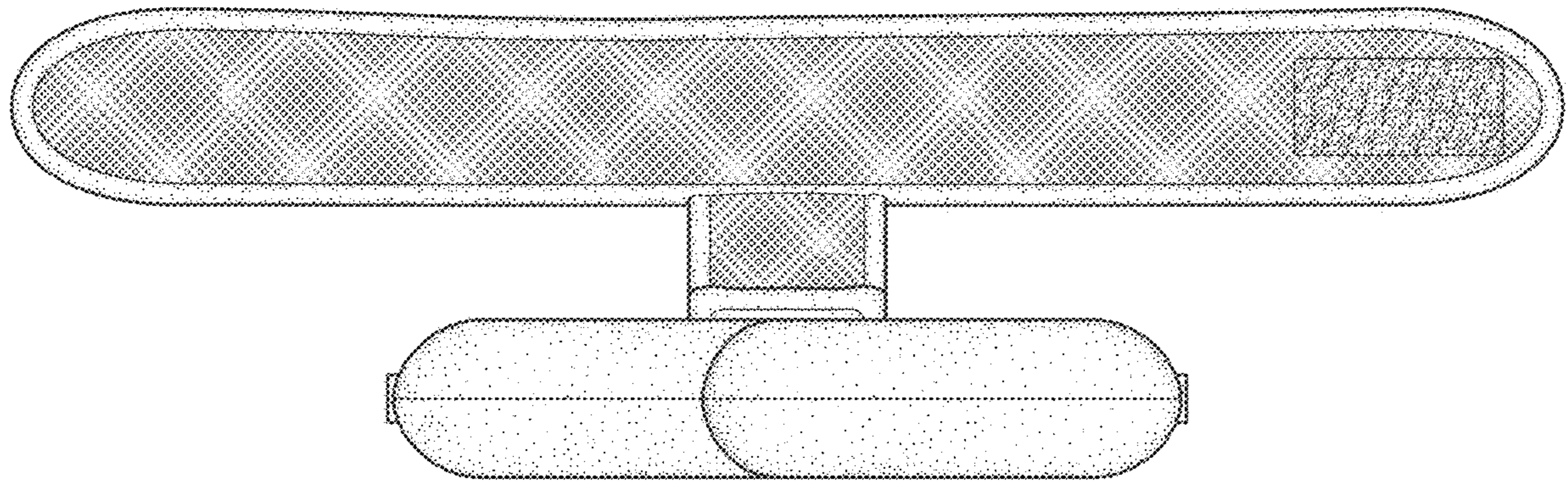

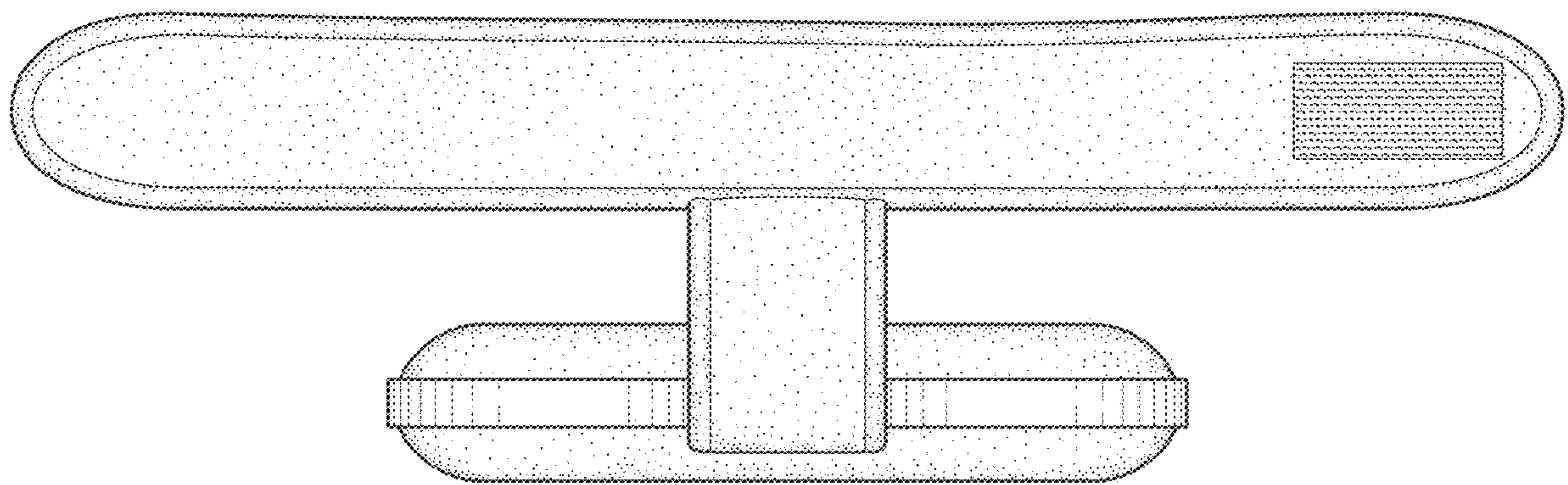

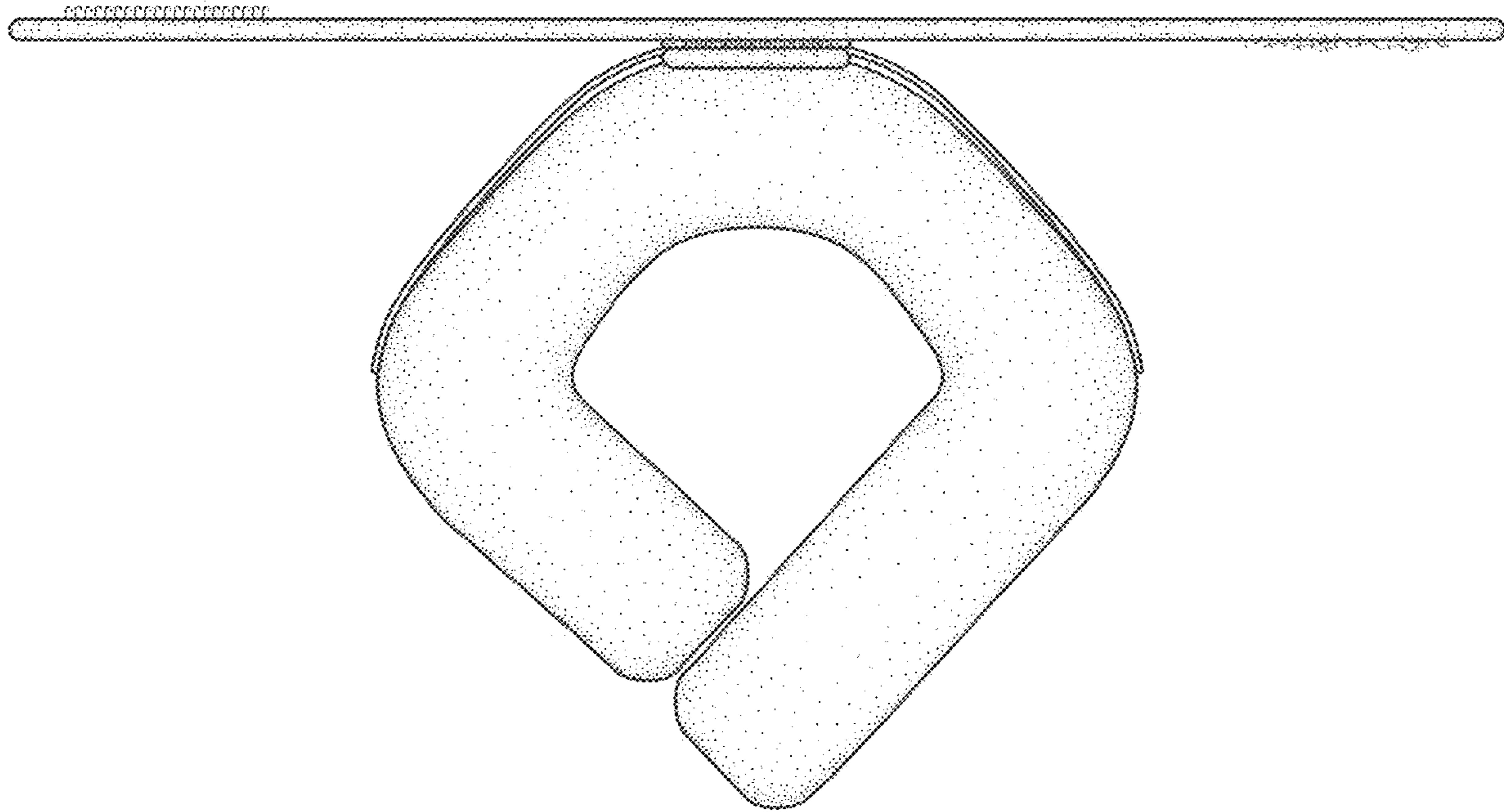

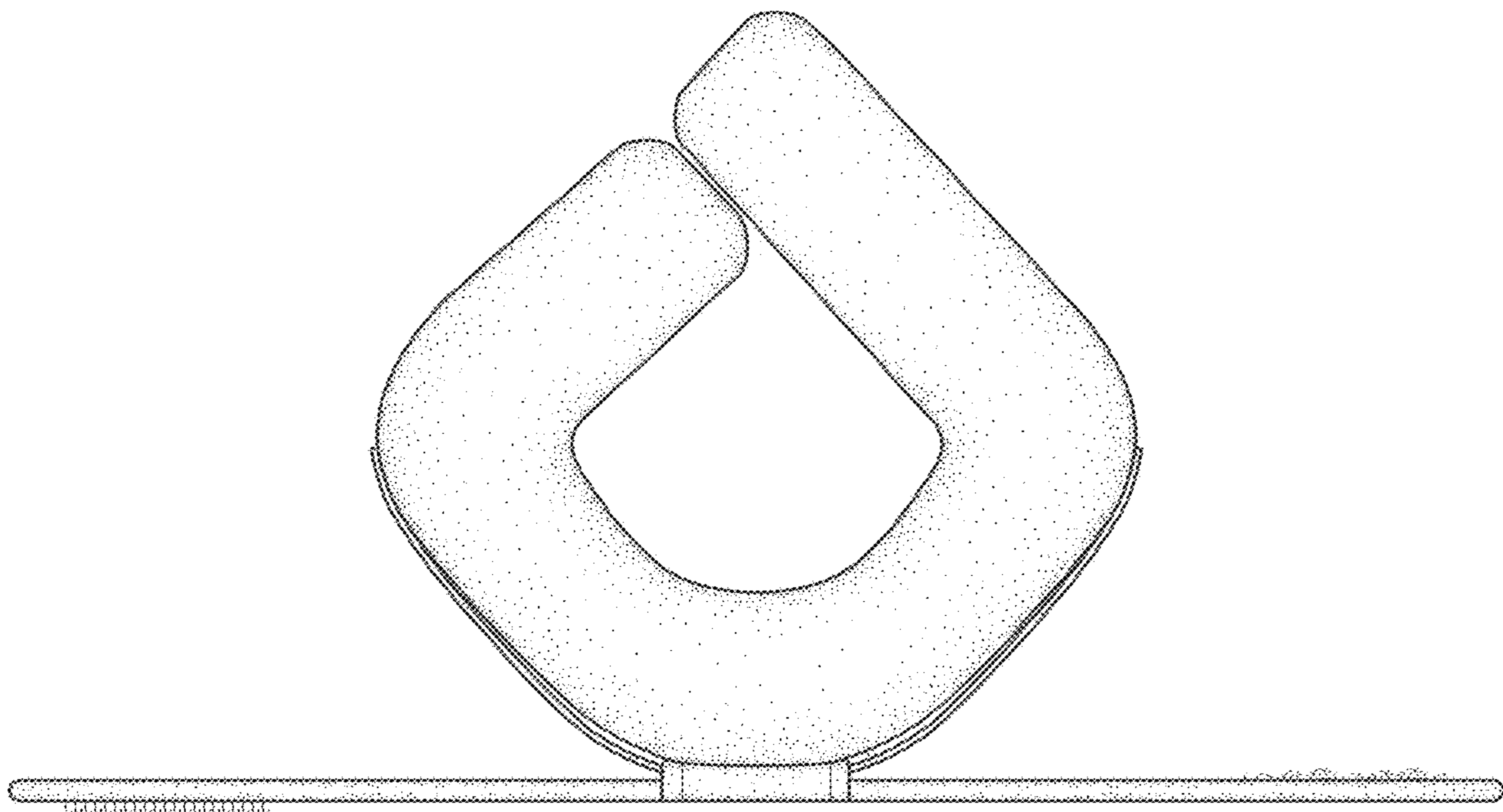

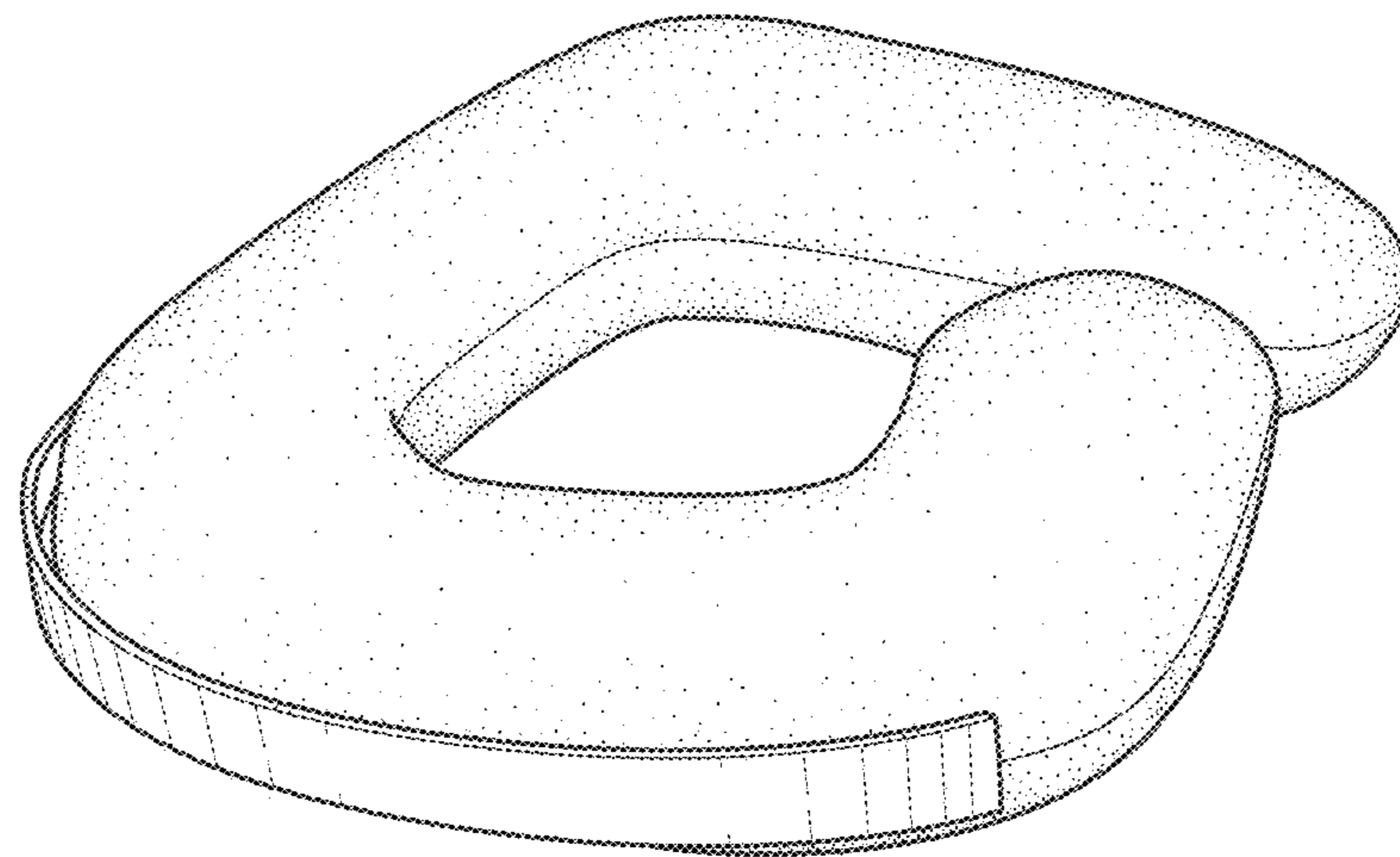
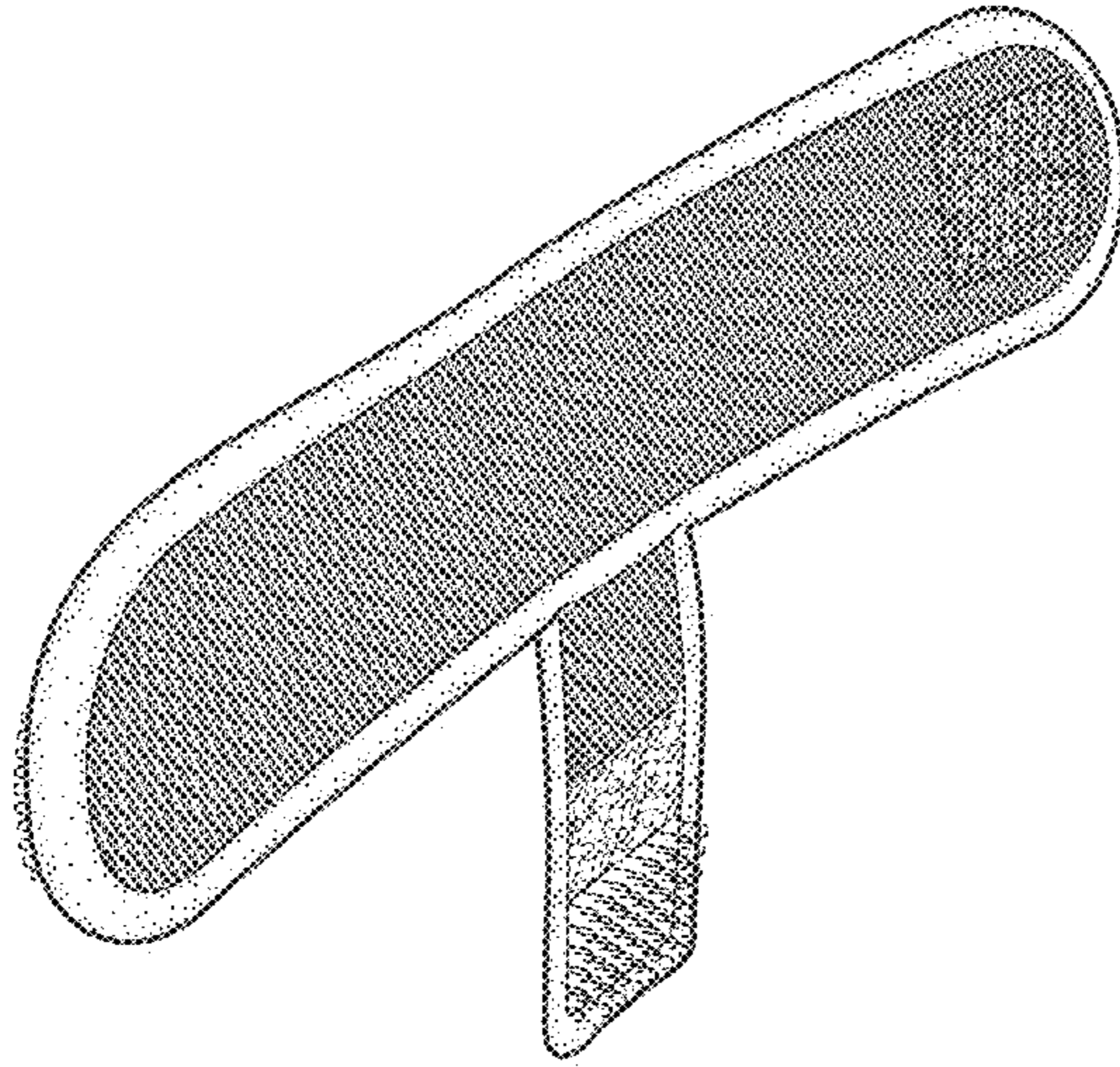
