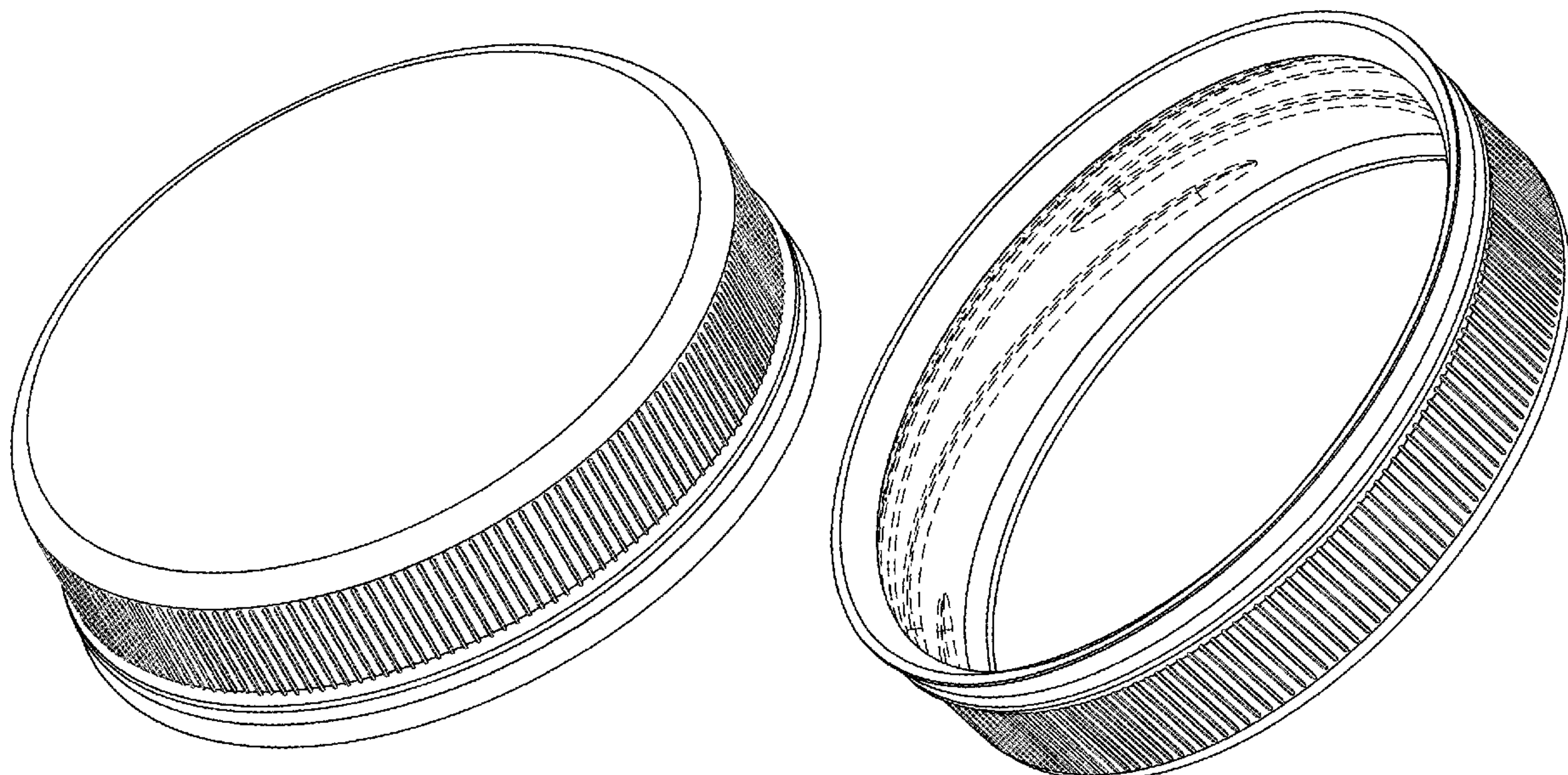
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a top perspective view of a closure, showing our new design.
FIG. 2 is a front view of the closure of FIG. 1, in which the opposing side views and the back views are identical.
FIG. 3 is a bottom perspective view of the closure of FIG. 1.
FIG. 4 is a top view of the closure of FIG. 1; and,
FIG. 5 is a bottom view of the closure of FIG. 1.

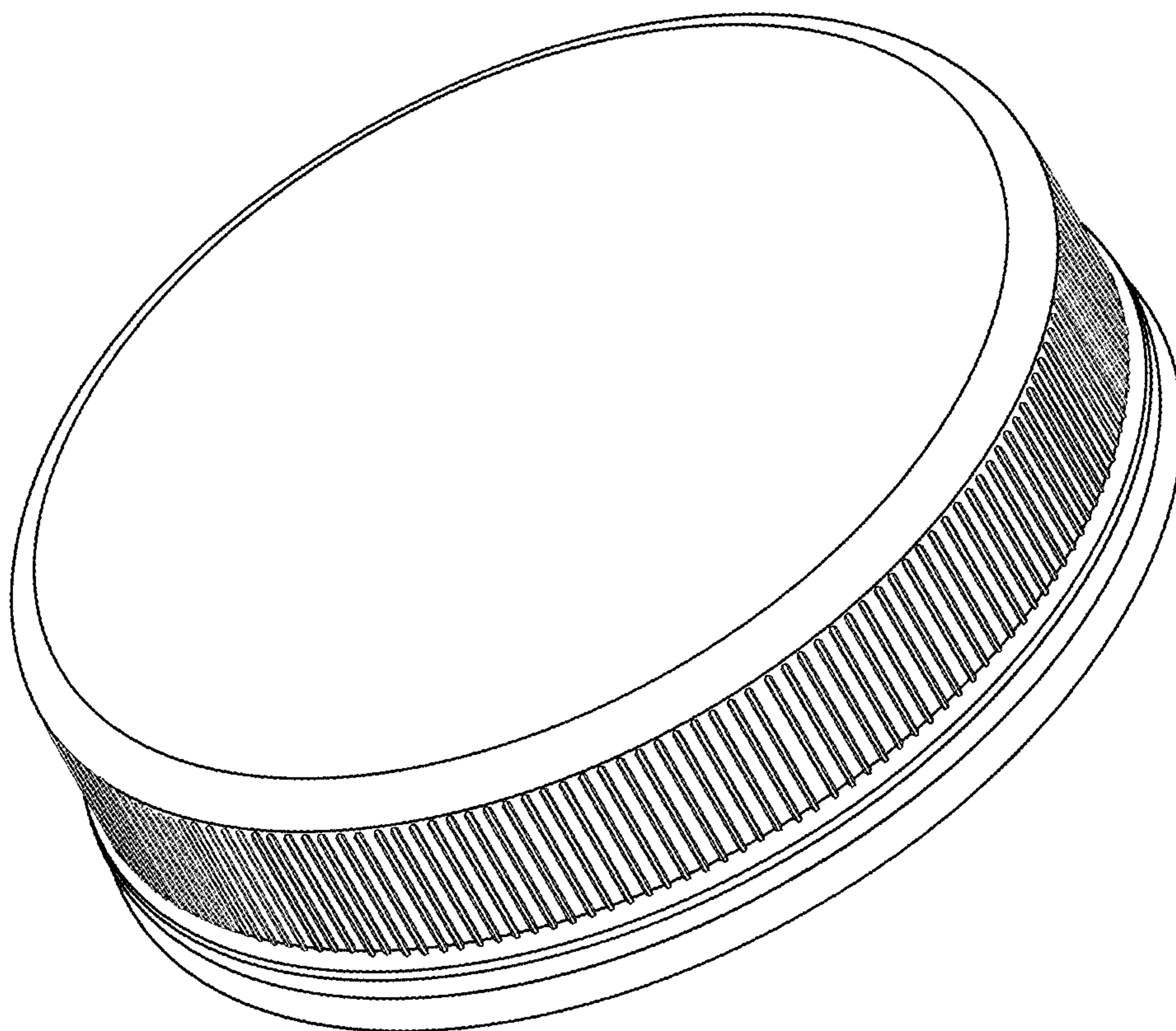

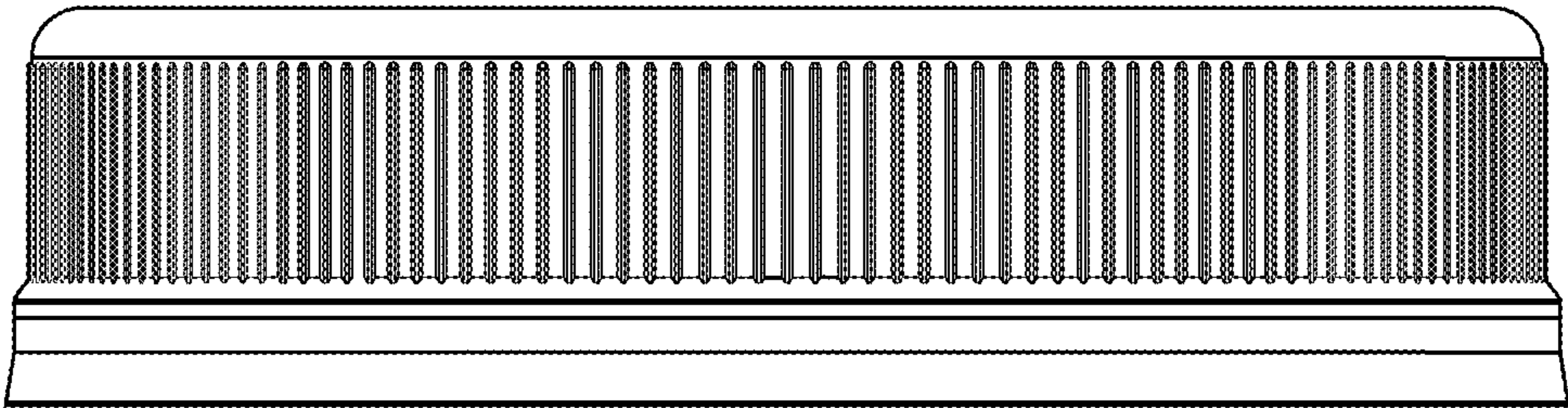

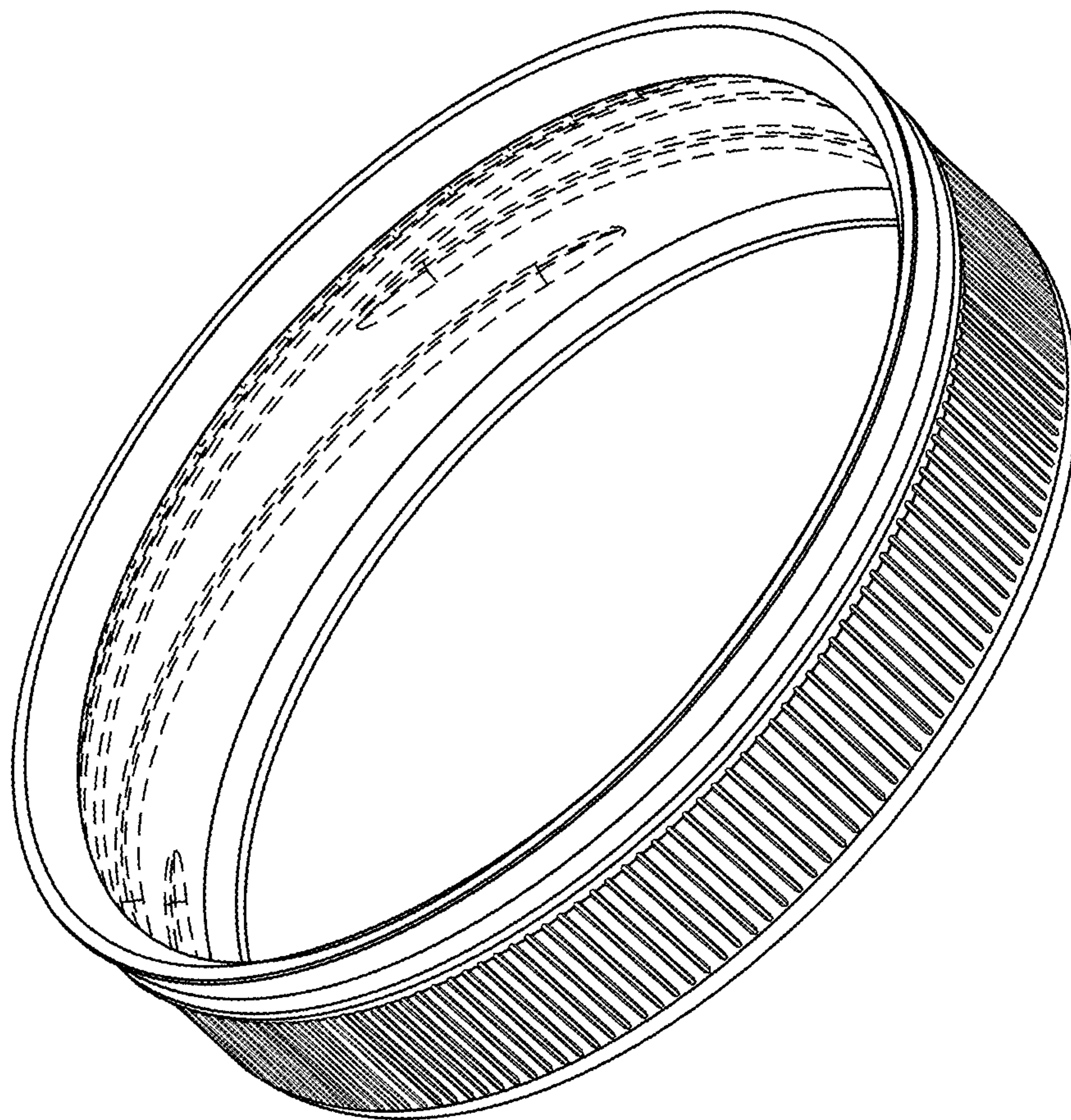

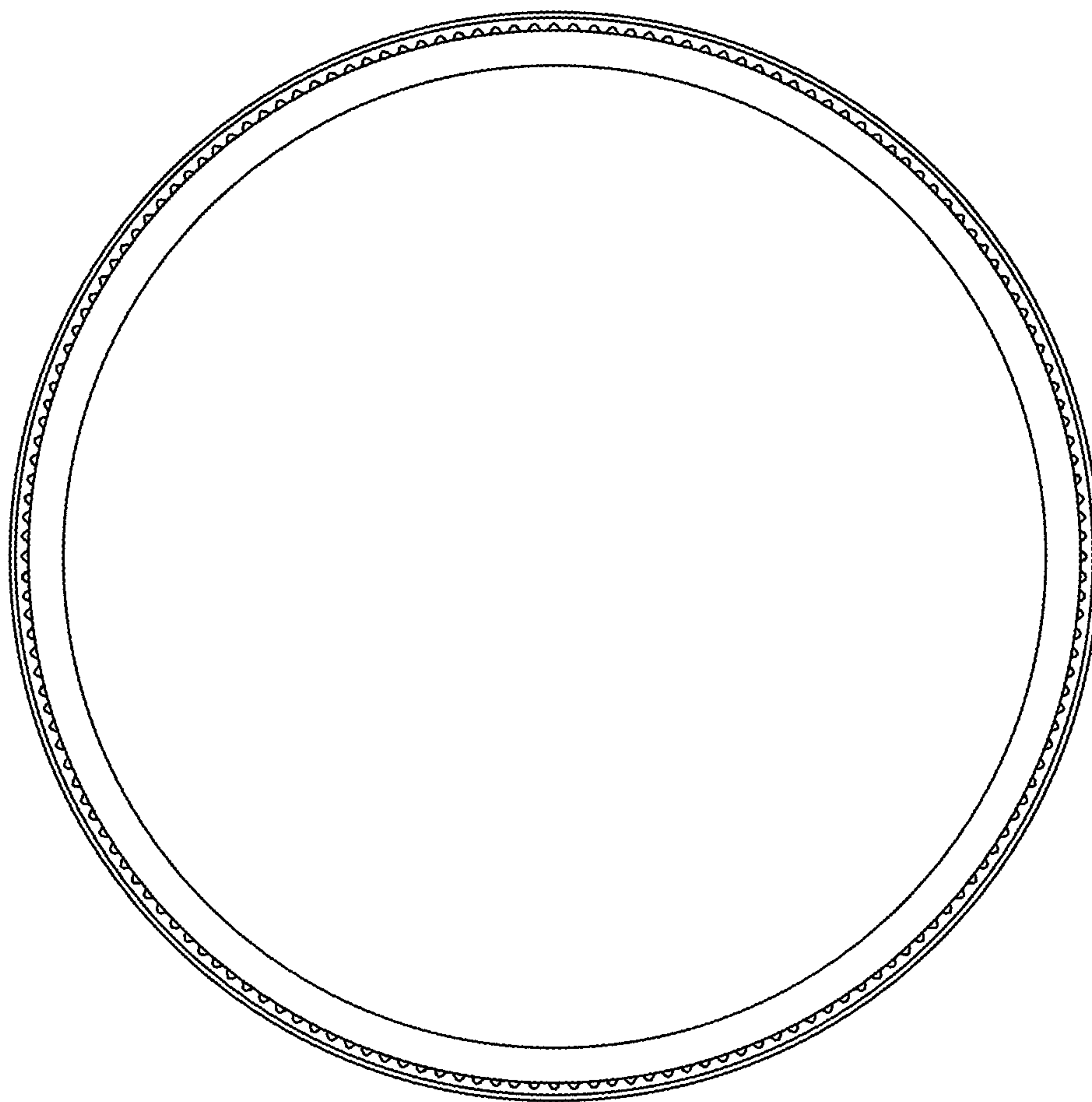

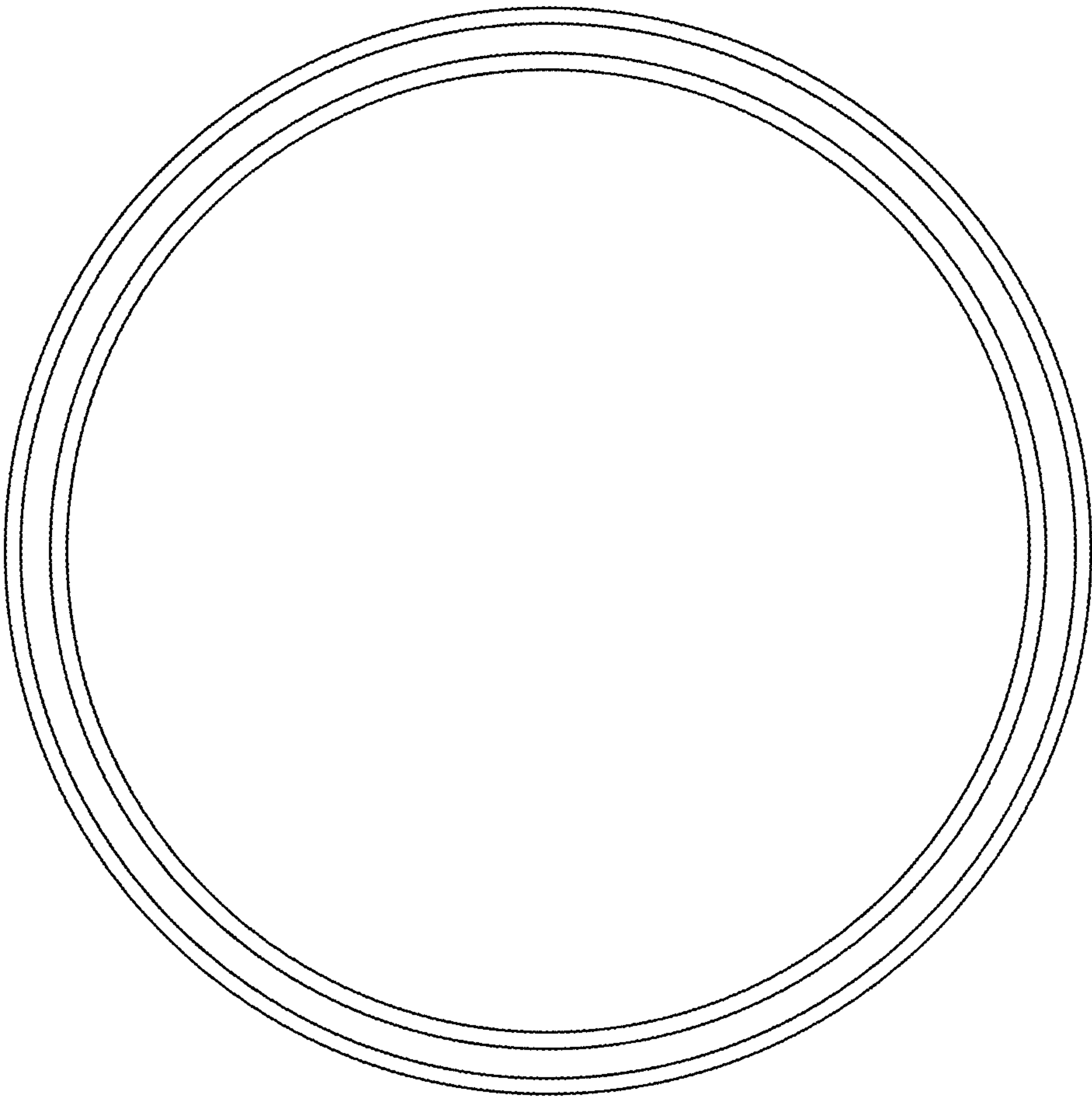
