The ornamental design for a turban, as shown and described.

**DESCRIPTION**

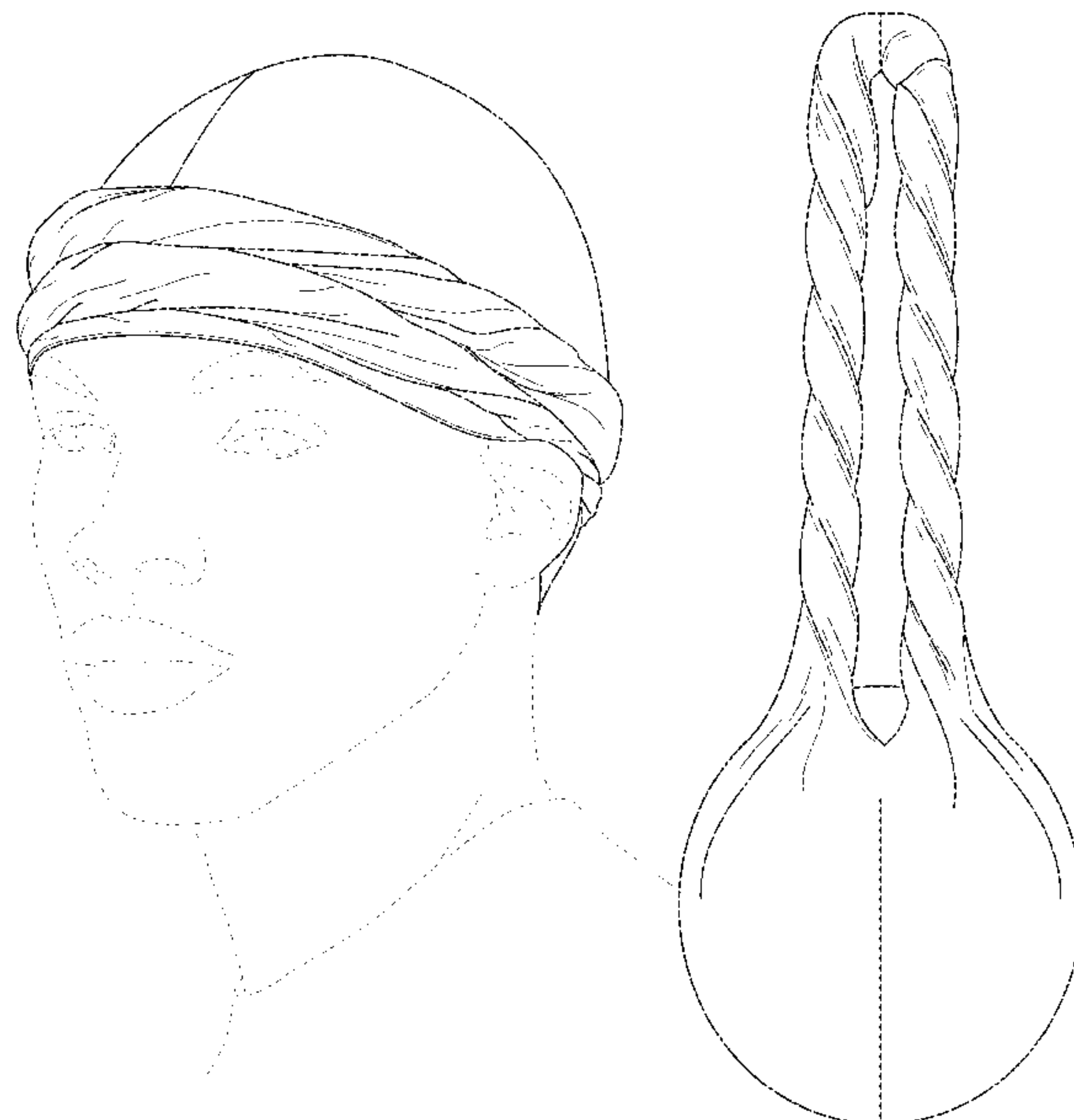
FIG. 1 is a front perspective view of a turban showing the claimed design in a wrapped in-use configuration; FIG. 2 is a rear perspective view thereof; FIG. 3 is a front elevation view showing the claimed design in an unwrapped configuration; FIG. 4 is a rear elevation view thereof; FIG. 5 is a right side elevation view thereof; FIG. 6 is a left side elevation view thereof; FIG. 7 is a top plan view thereof; and, FIG. 8 is a bottom plan view thereof. The broken-line outline of the partial human figure assists in illustrating the turban in a wrapped in-use configuration and shows environment that forms no part of the claimed design.

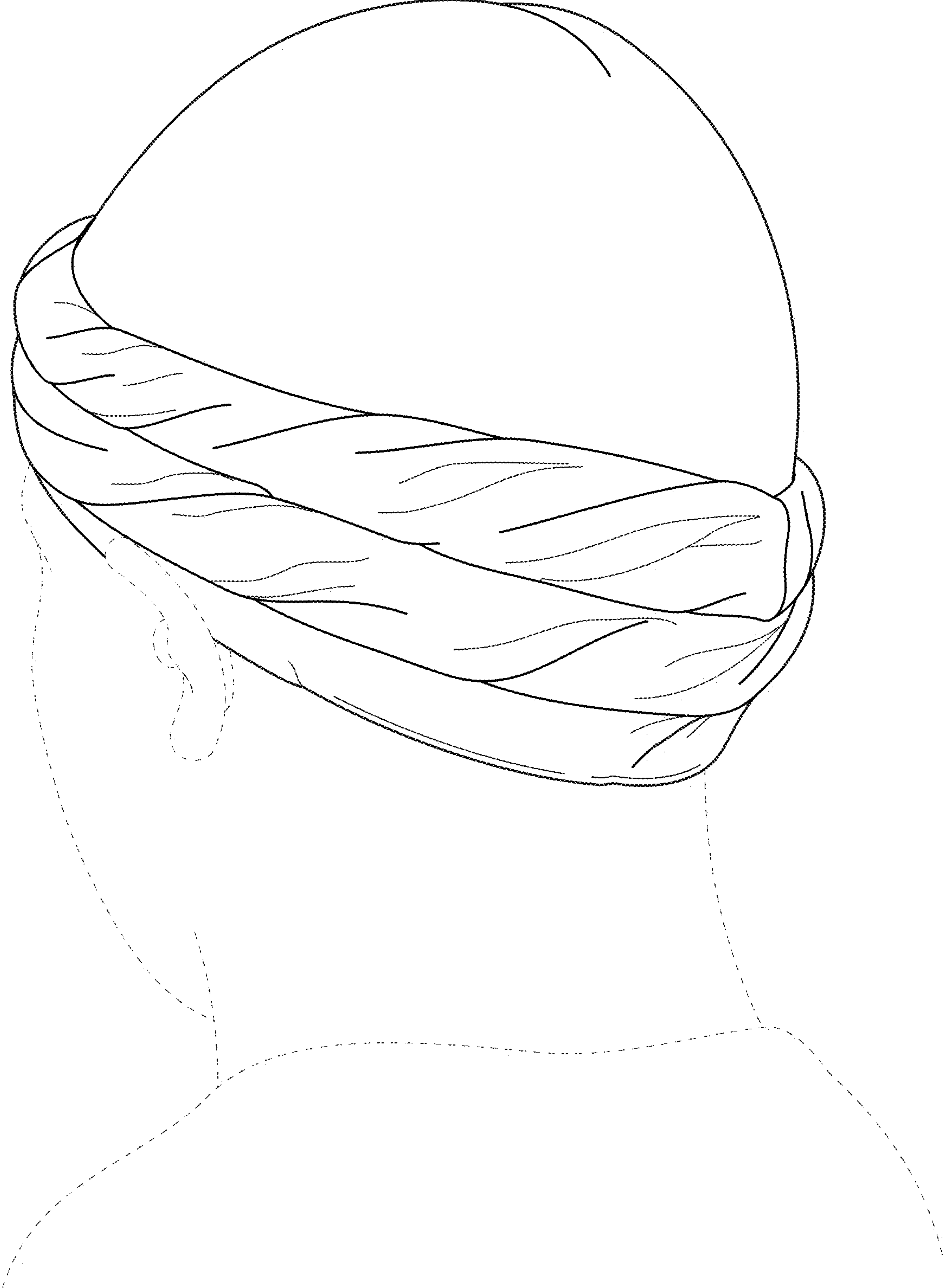

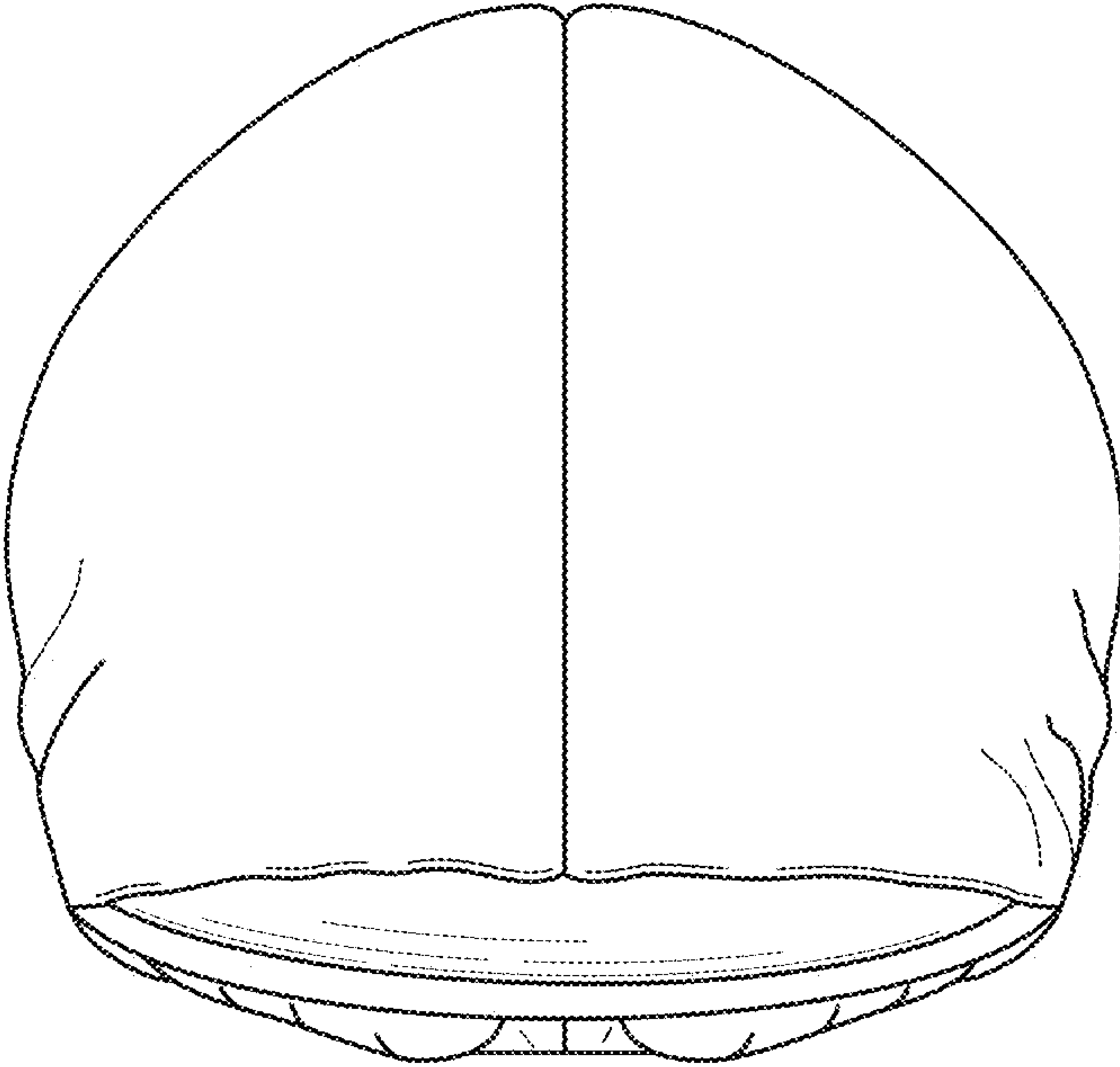

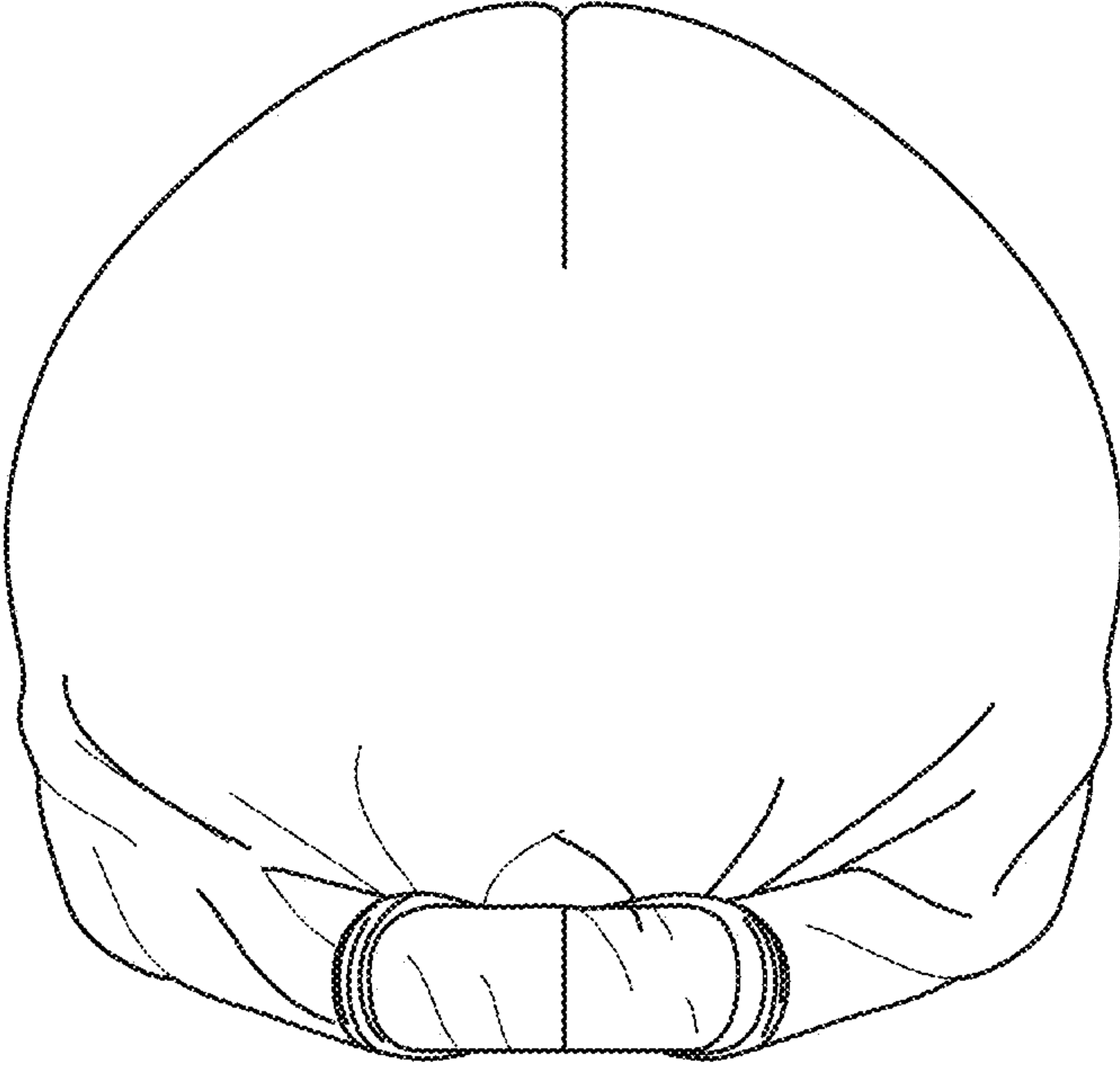

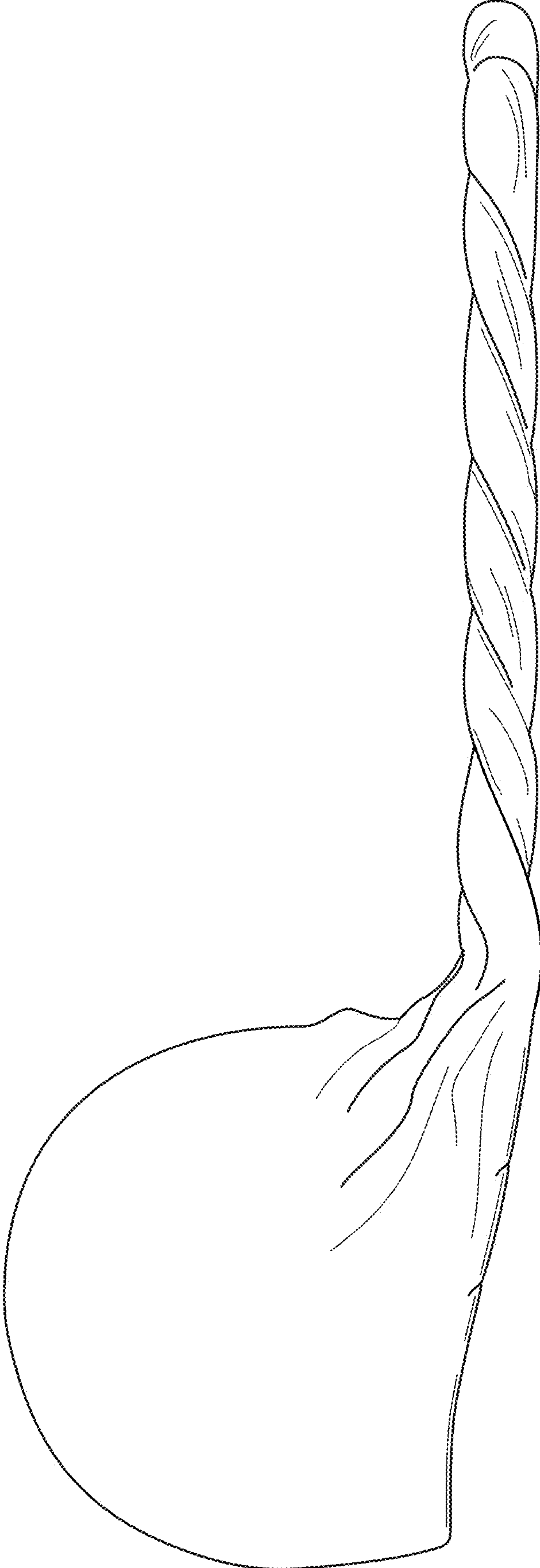

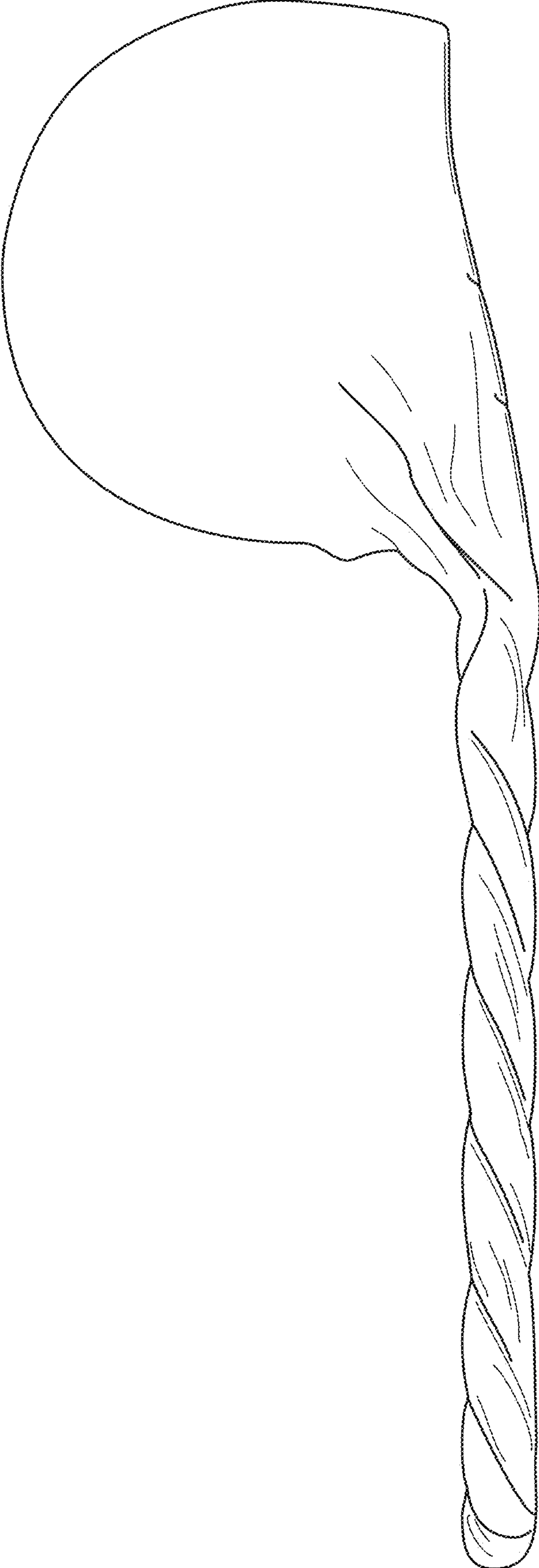
