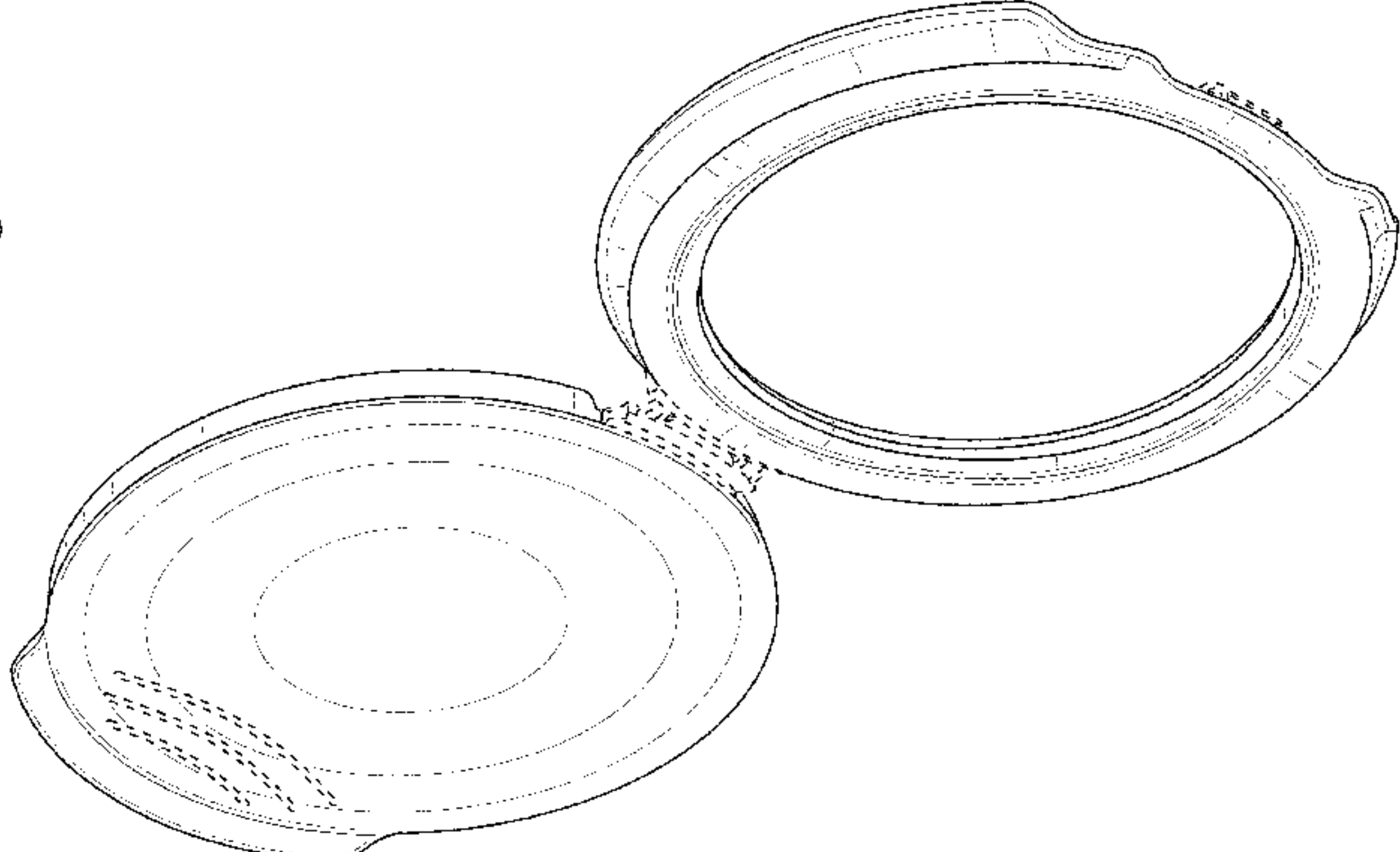
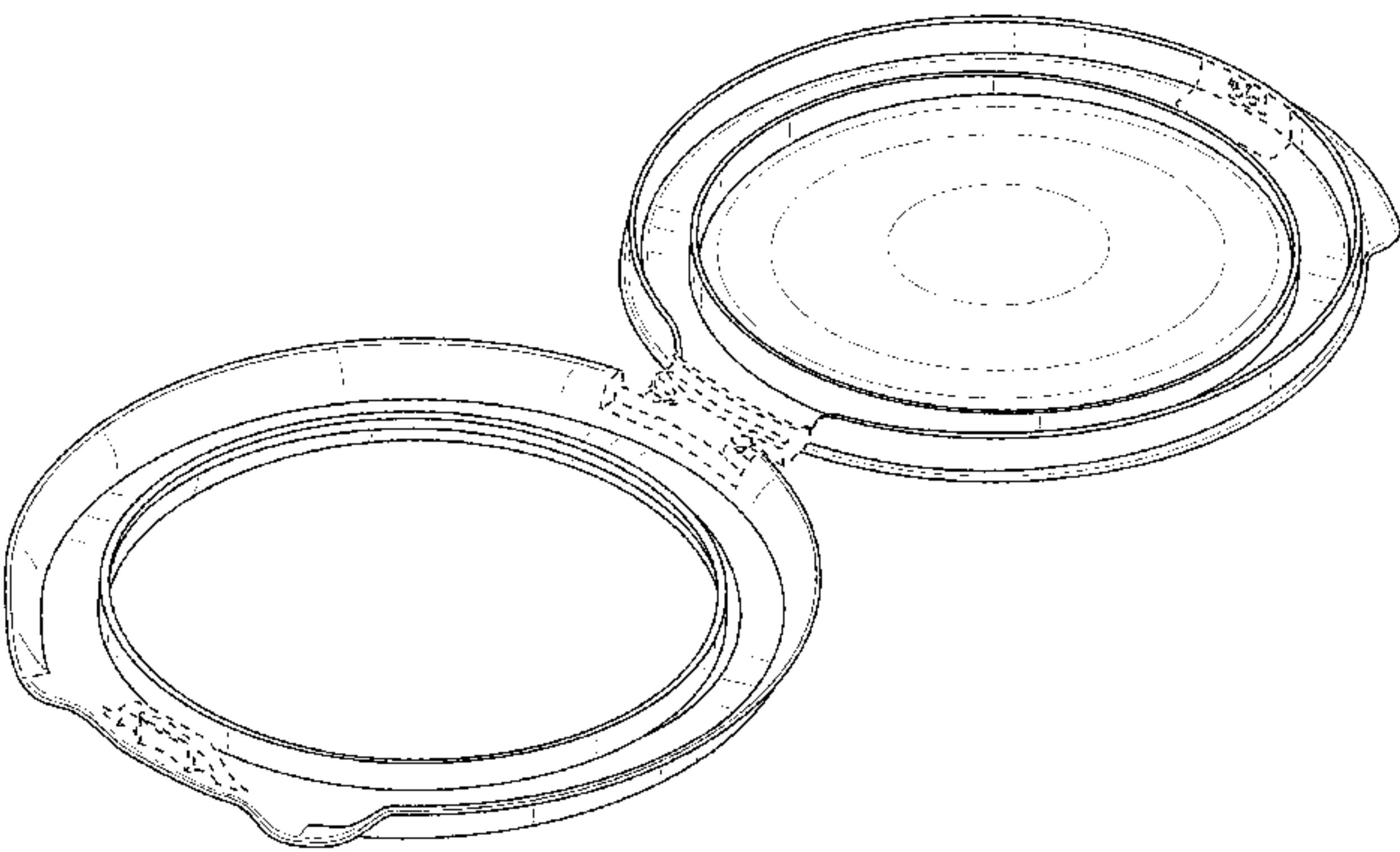
CLAIM

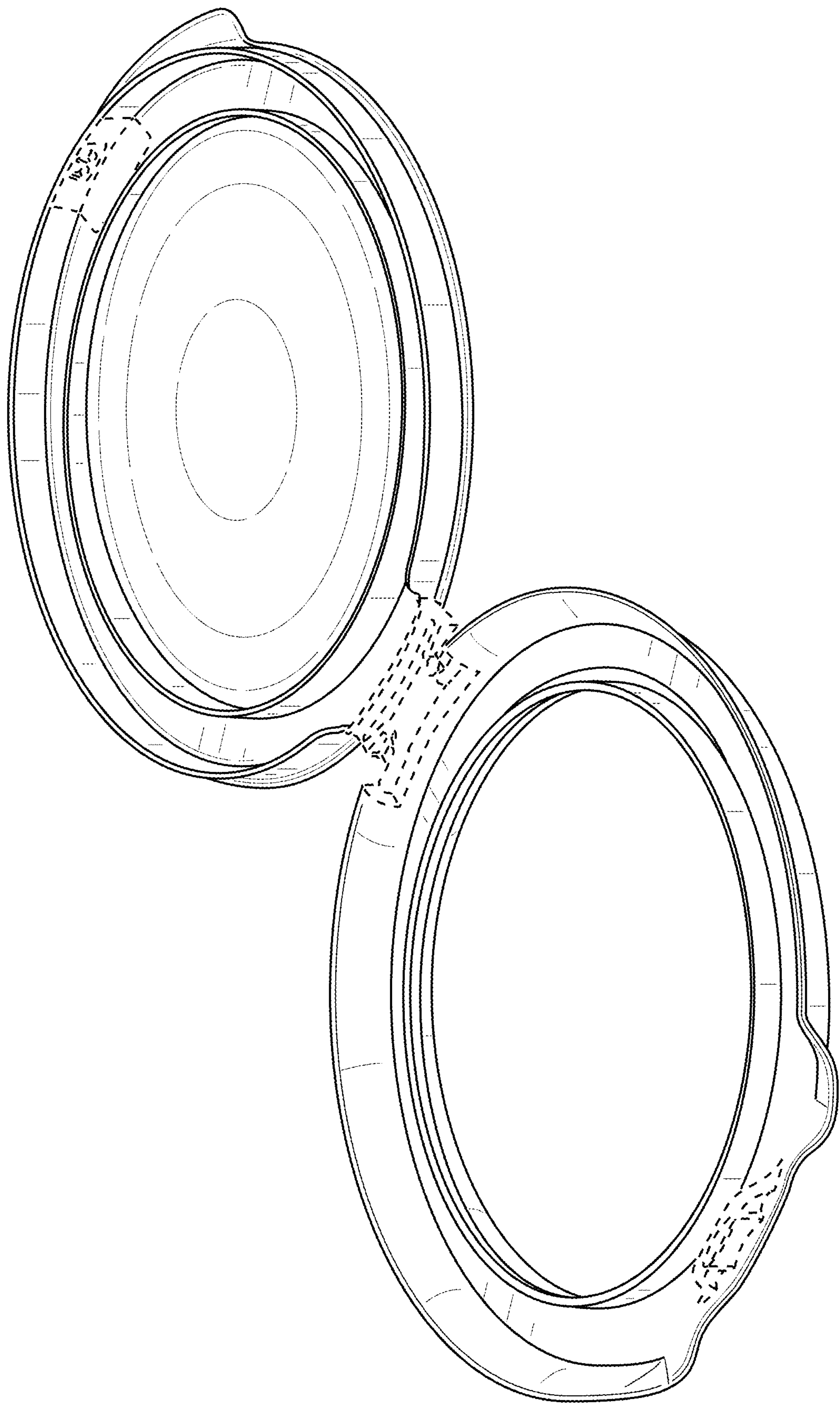

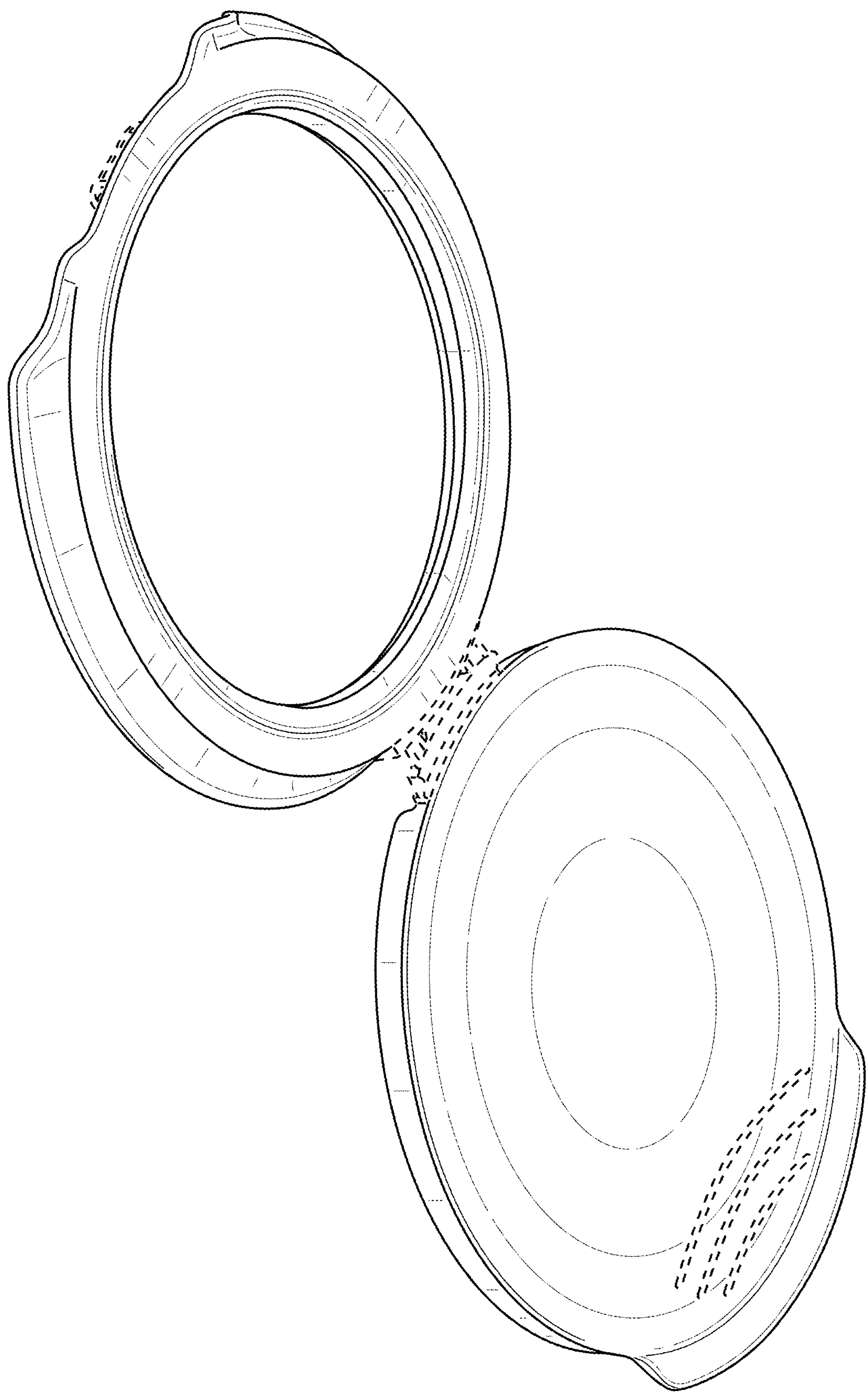

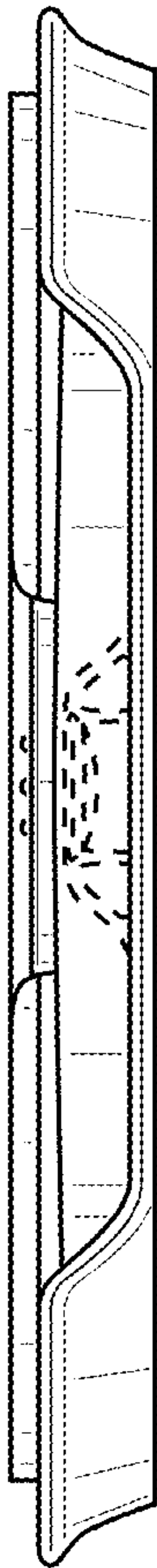

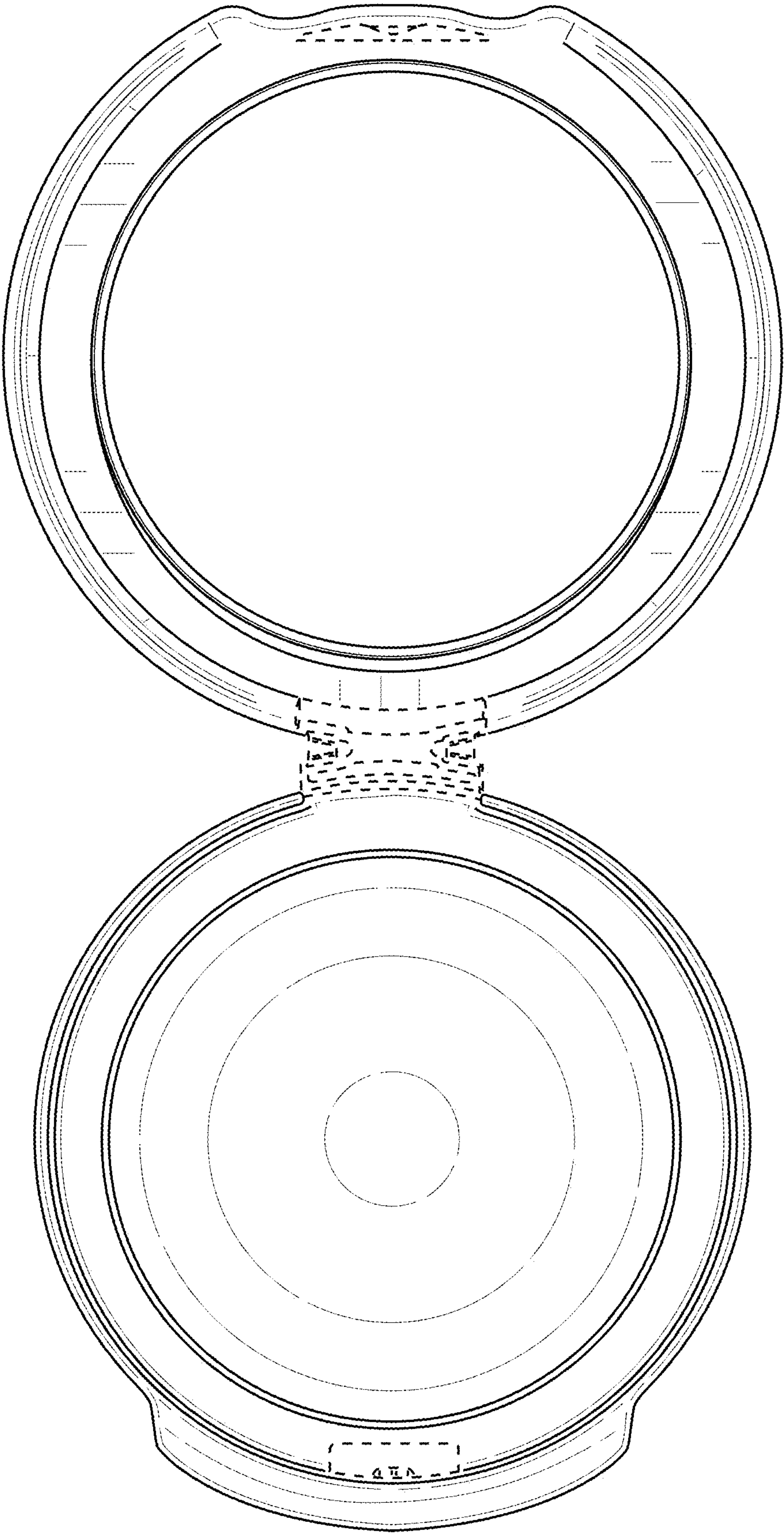

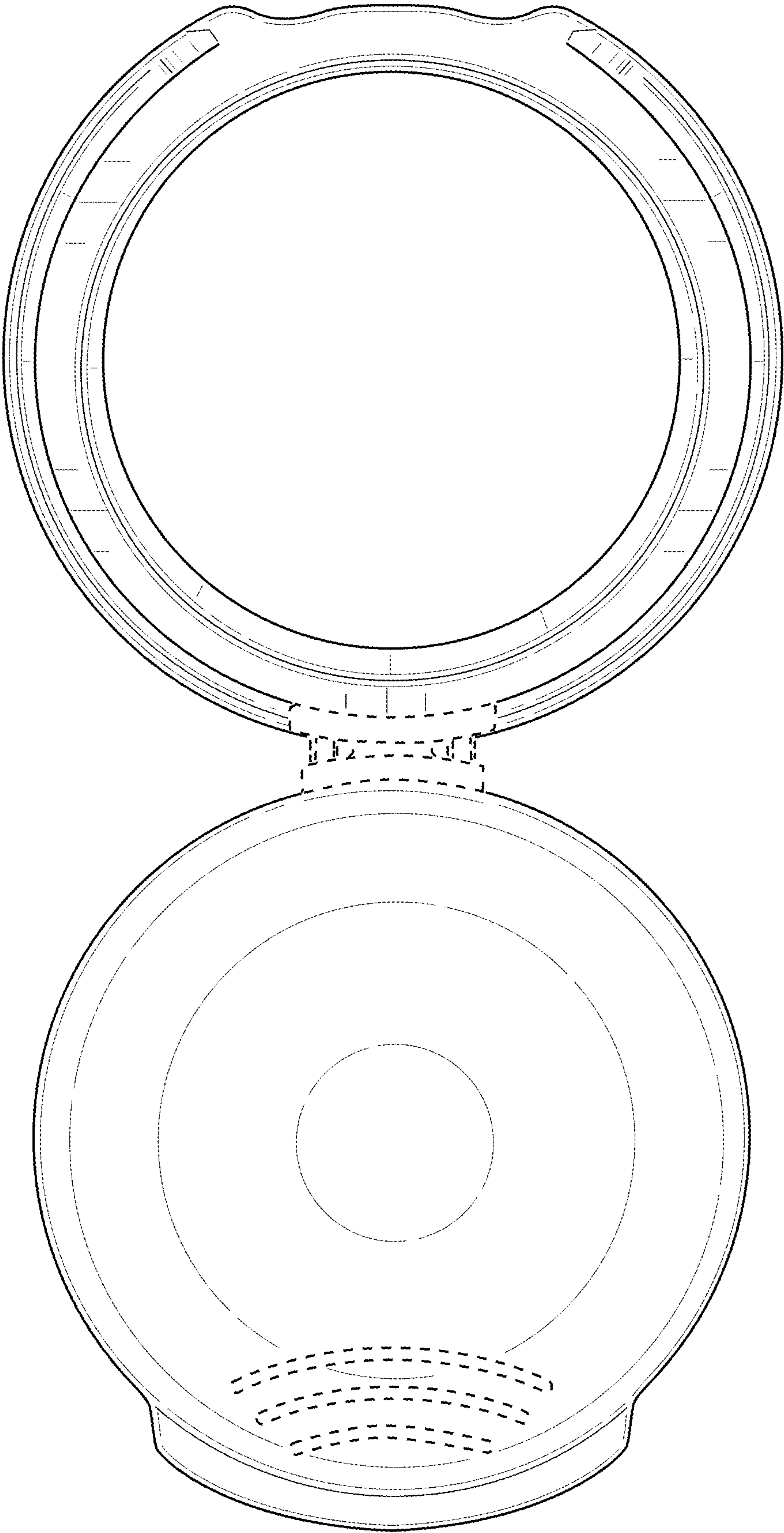

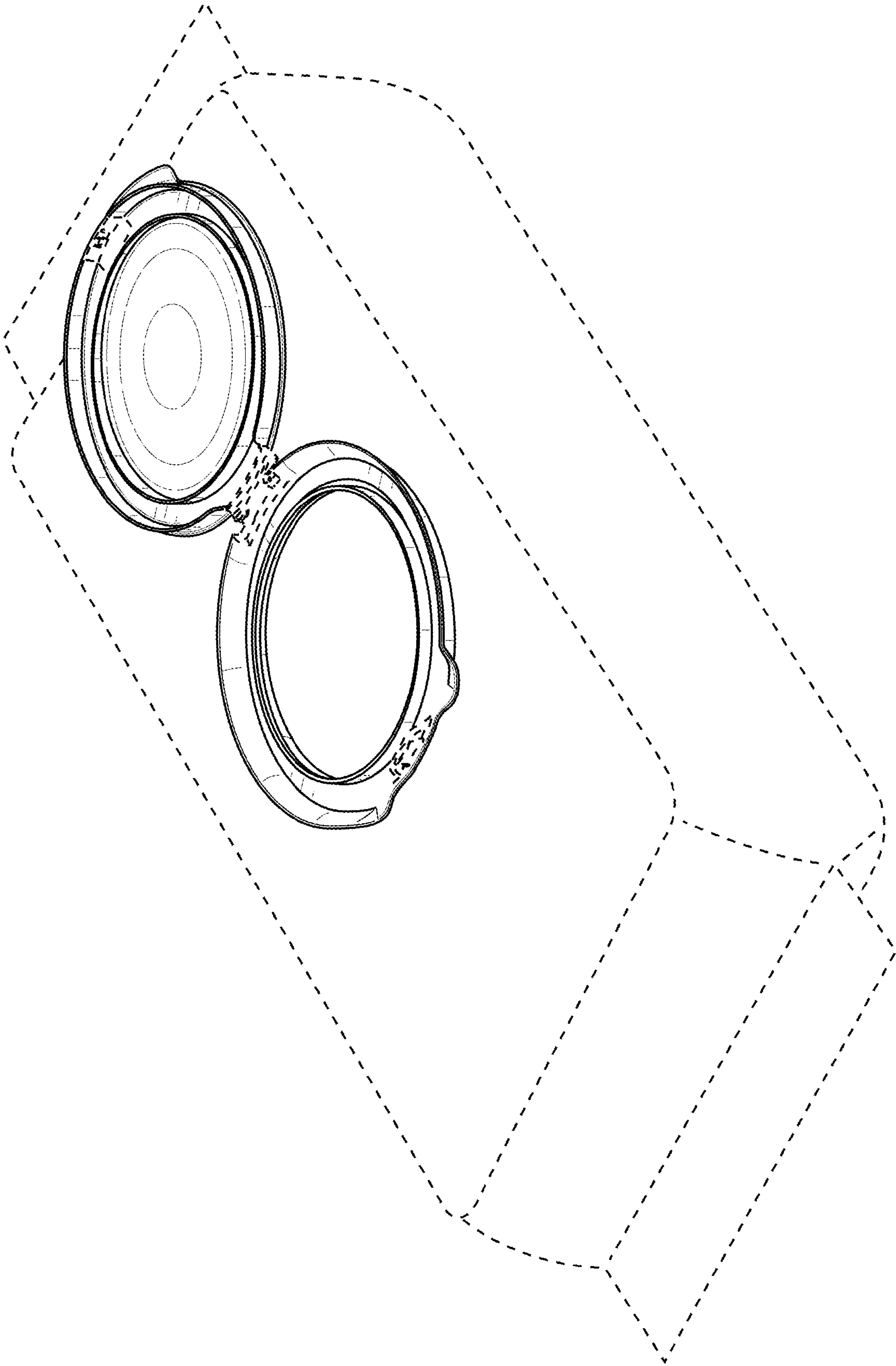
