DESCRIPTION

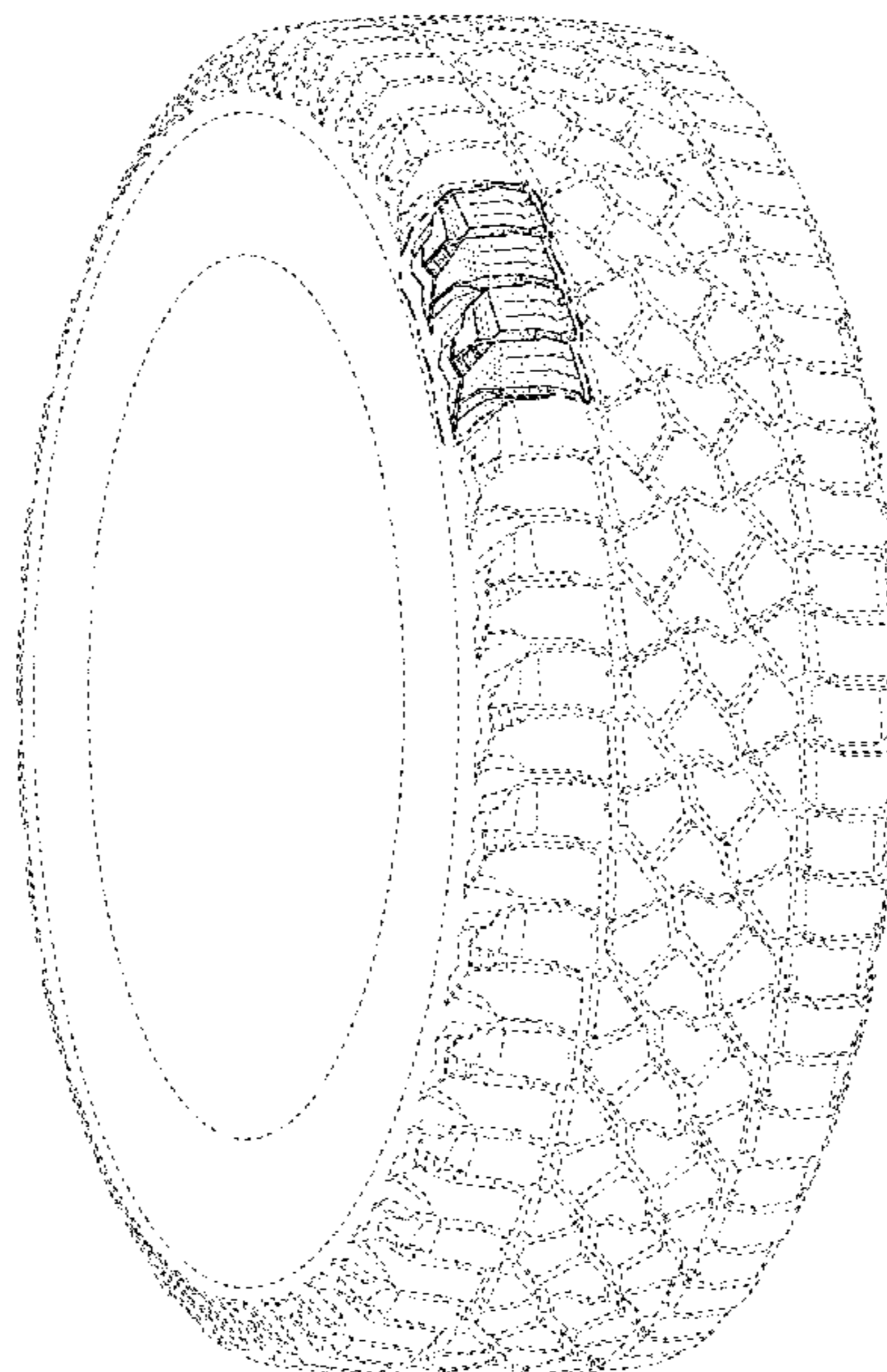
FIG. 1 is a perspective view of a tire, showing my new design;

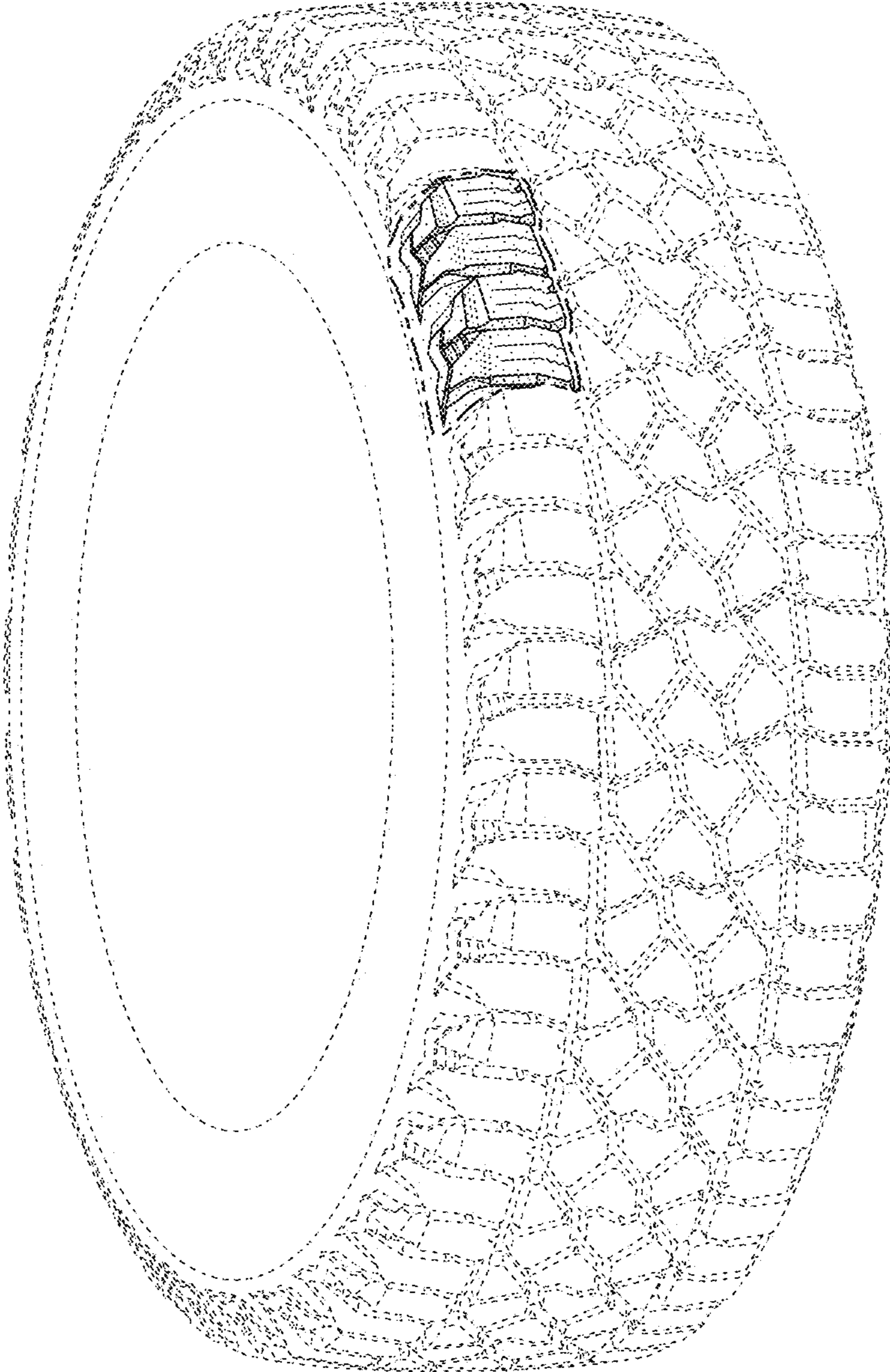

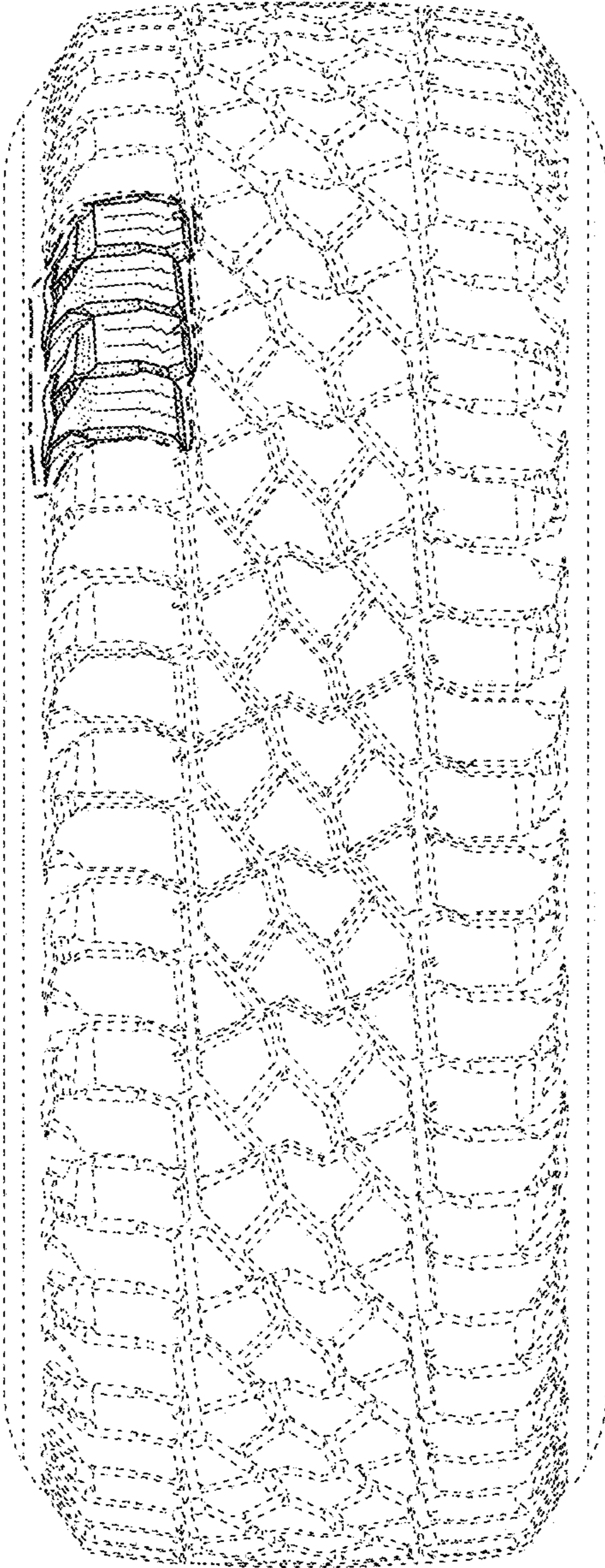

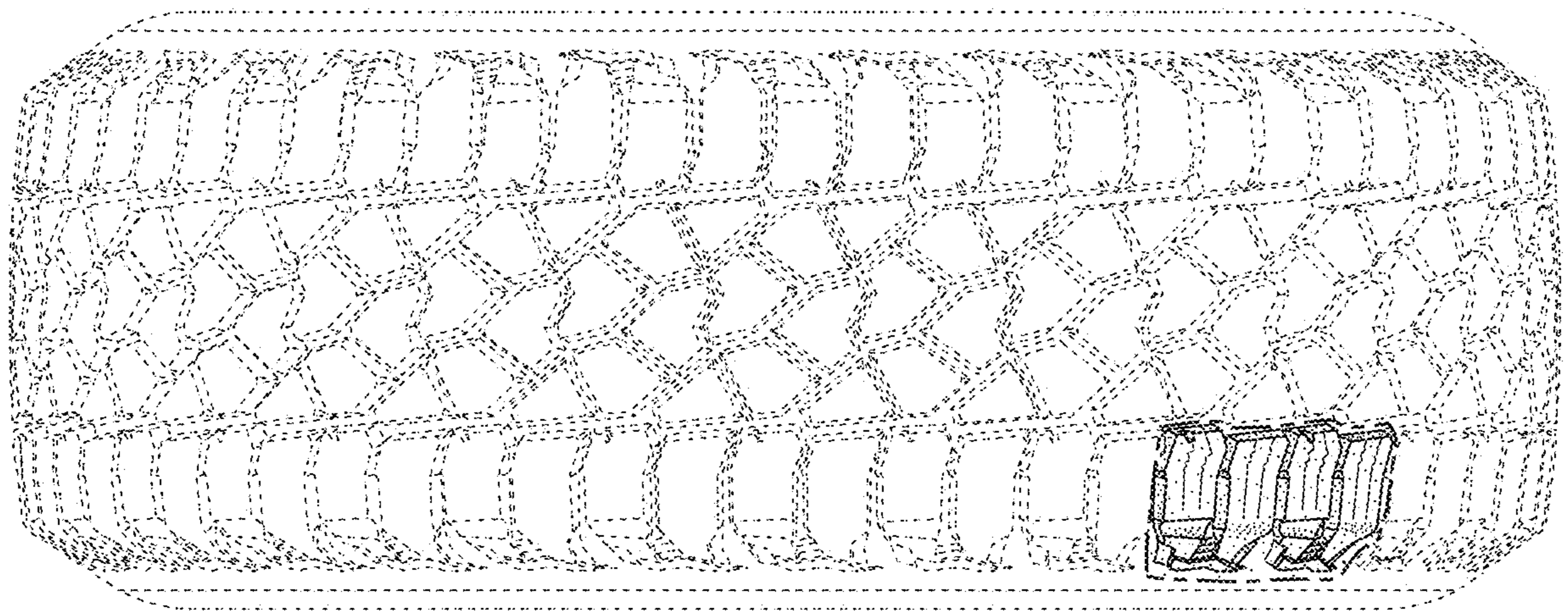

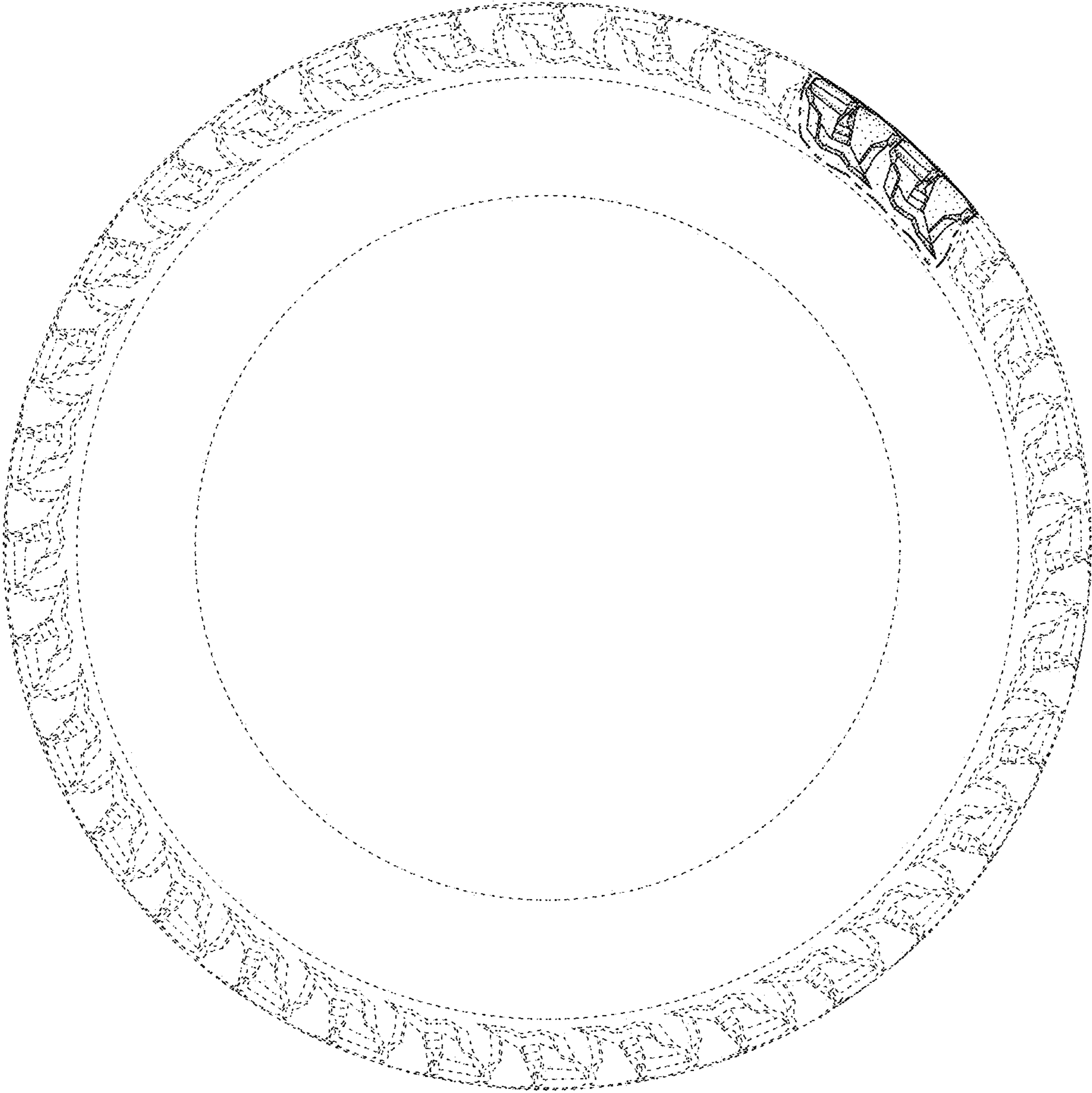
