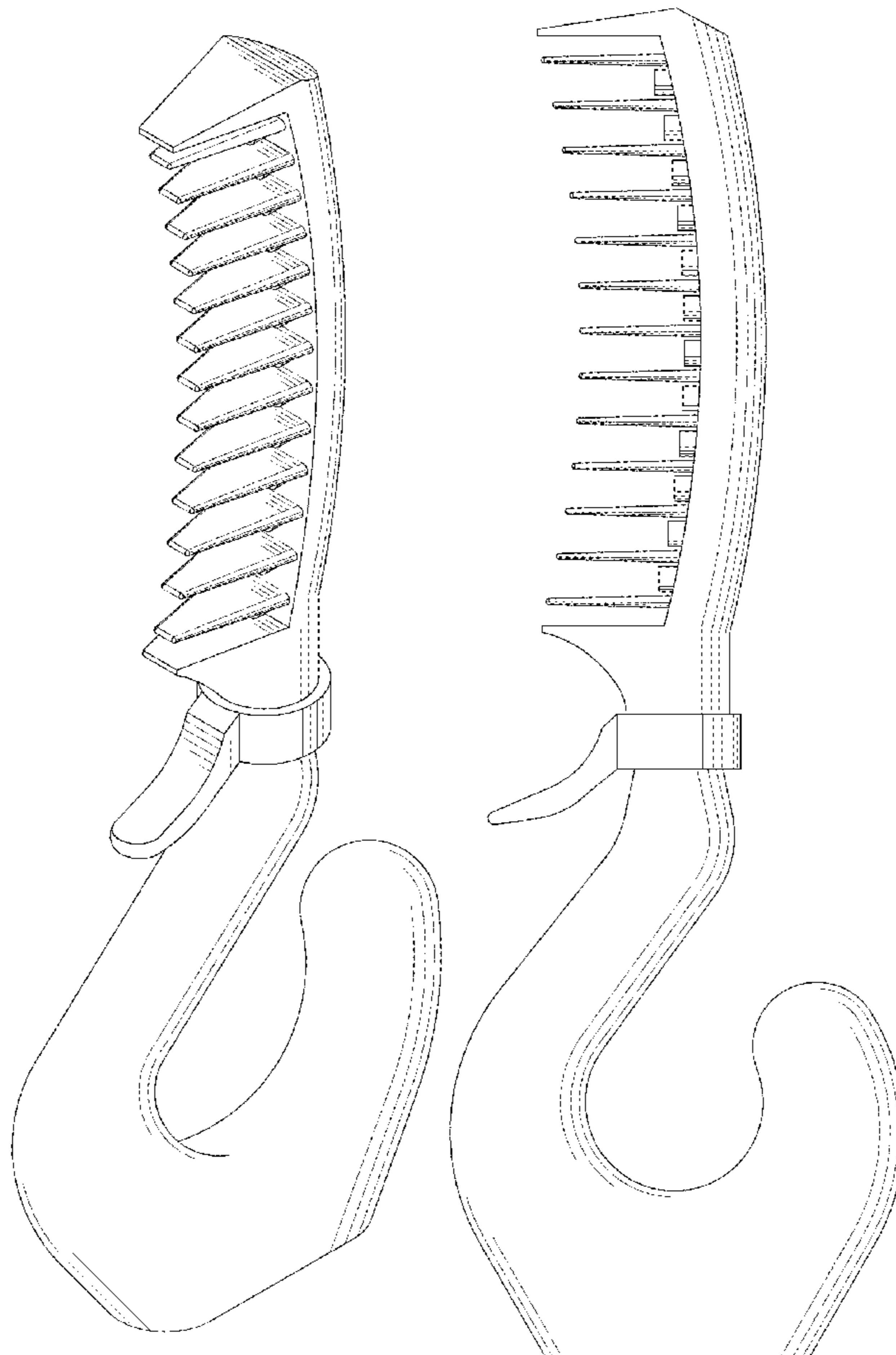
The ornamental design for a comb, as shown and described.

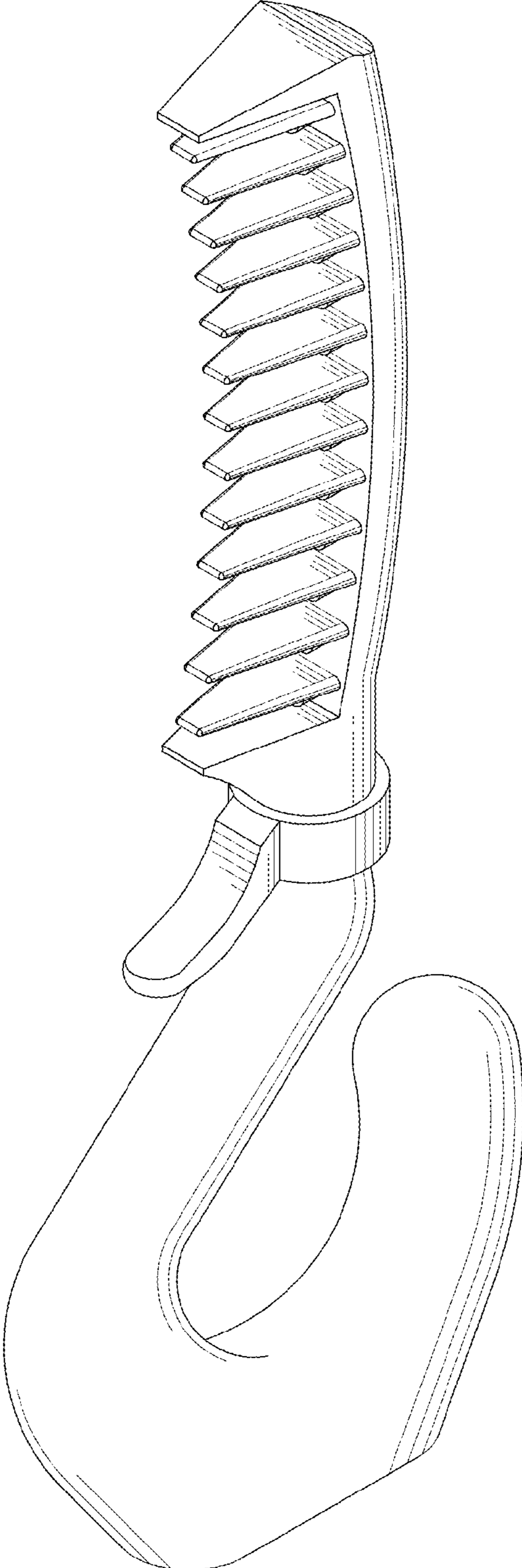
**DESCRIPTION**

 FIG. 7 is a bottom view of the comb.

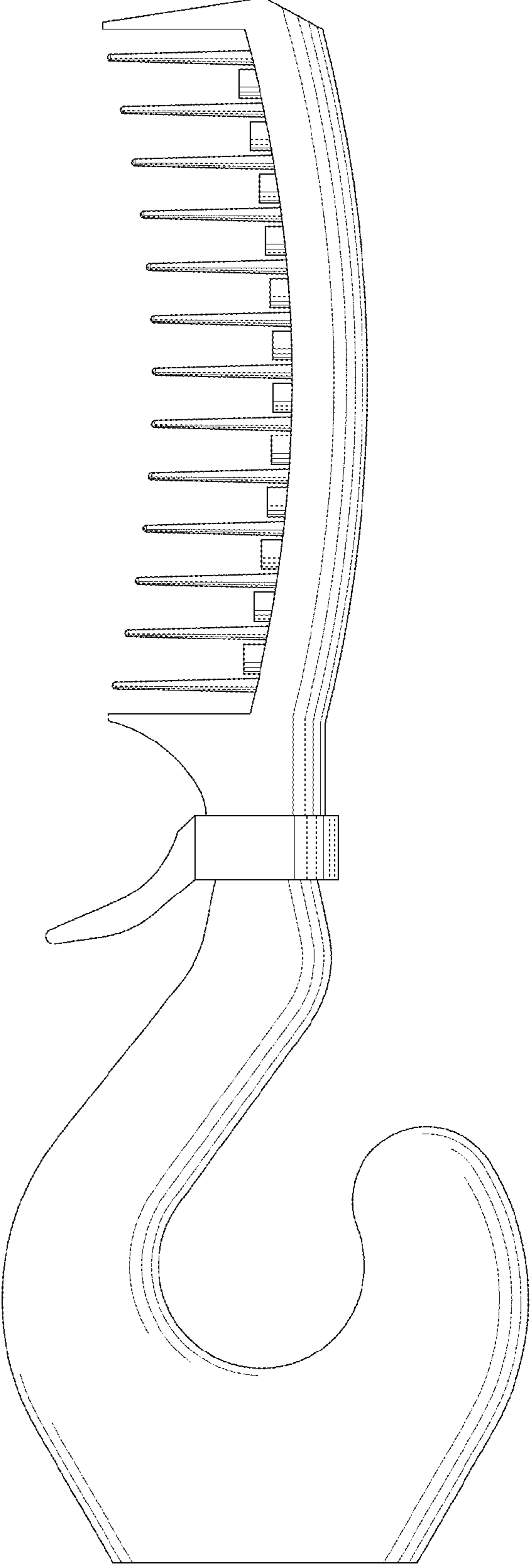

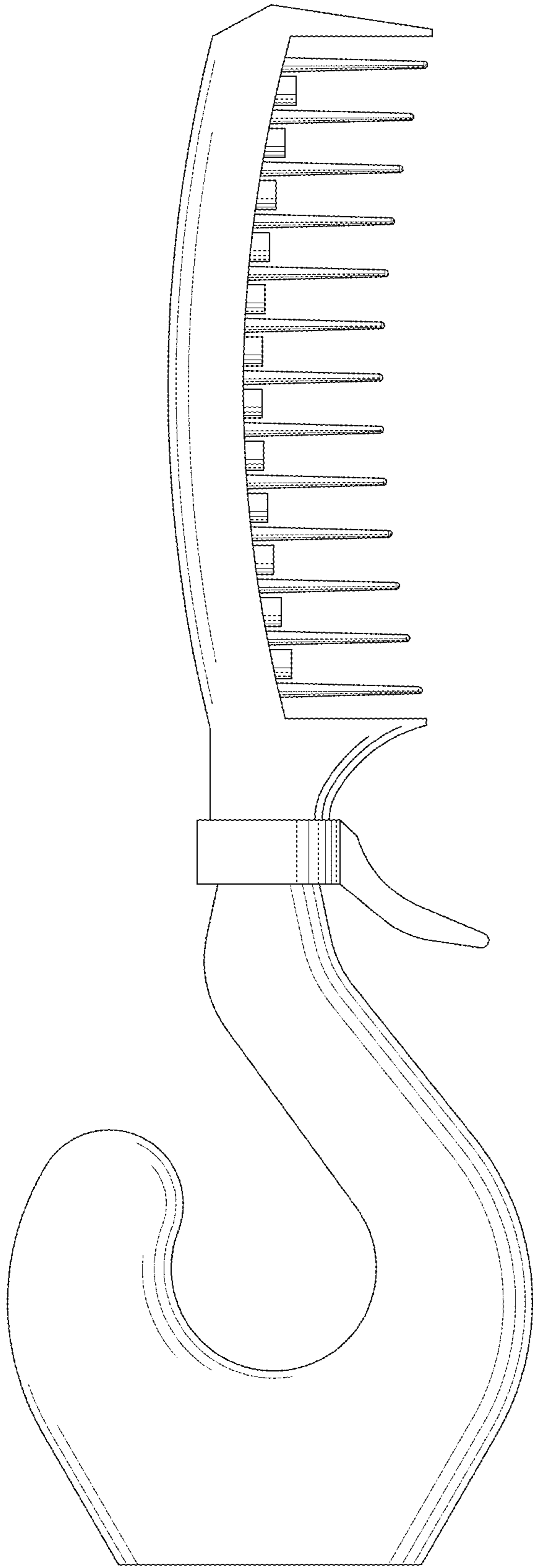




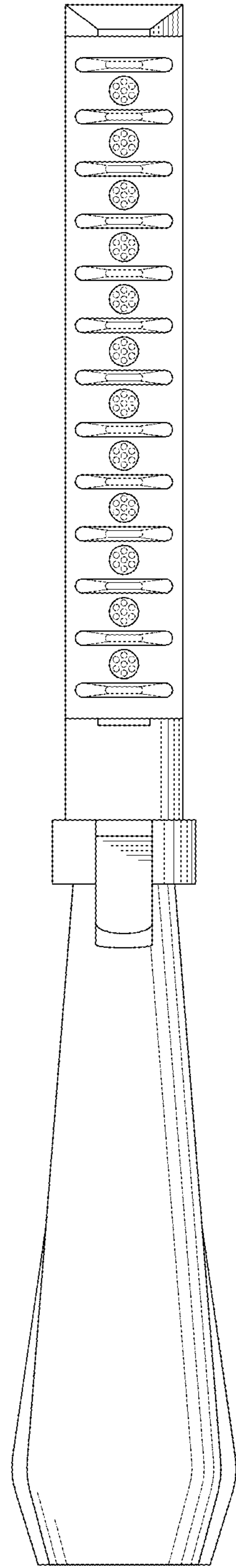

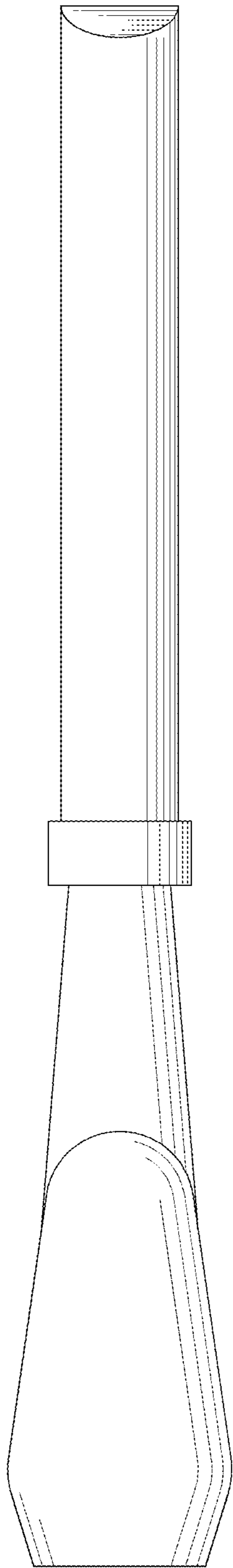

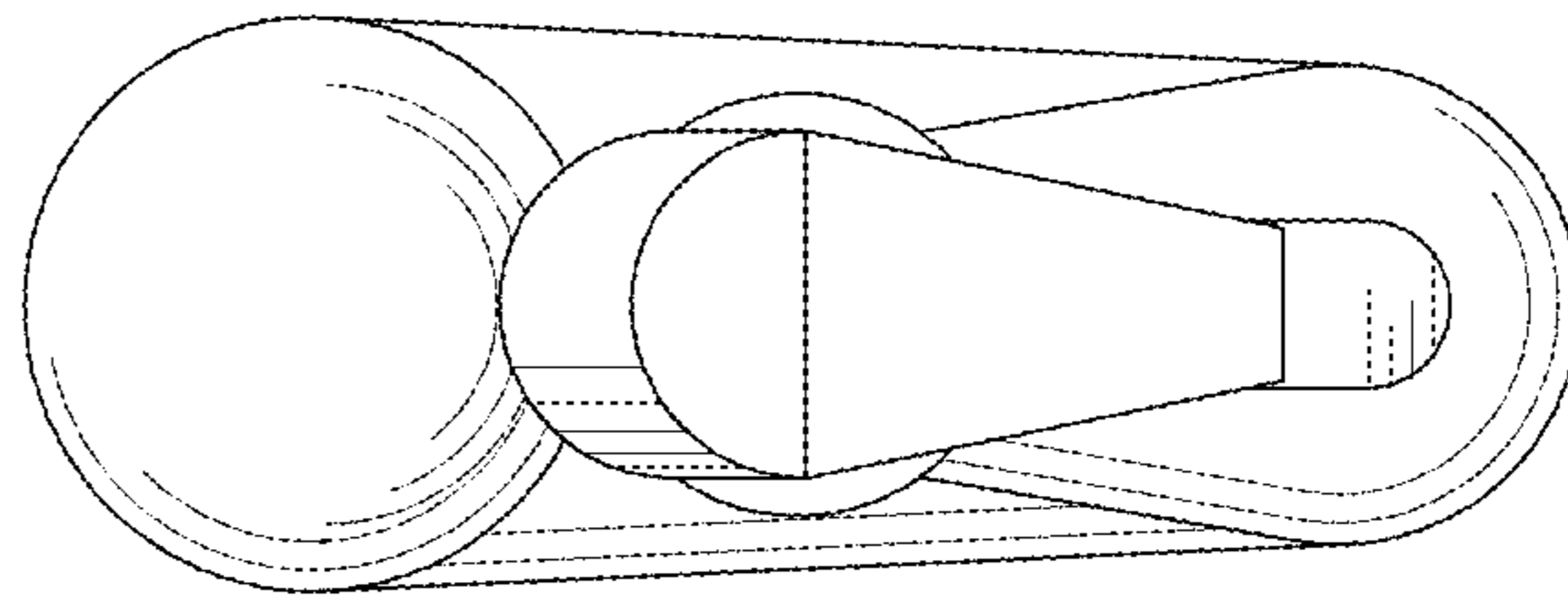

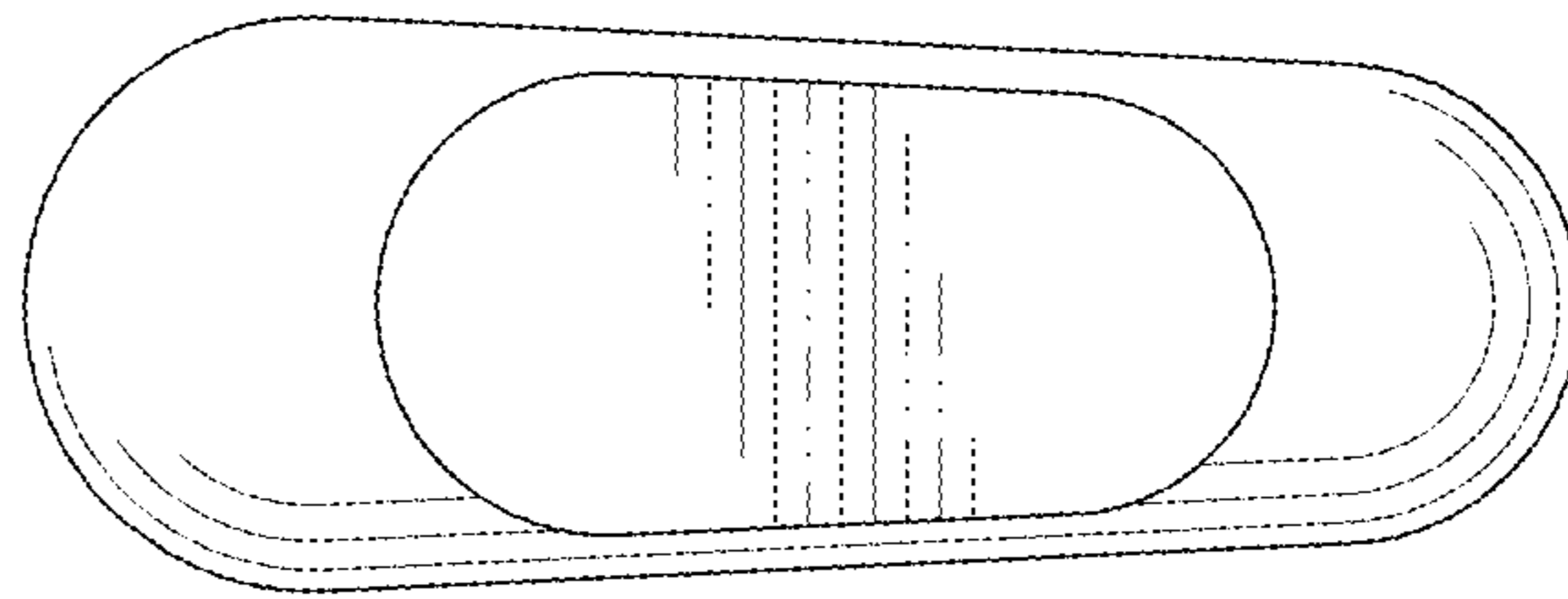
