The ornamental design for an angled razor with side ports, as shown and described.

FIG. 4 is a first side view of the angled razor with side ports.

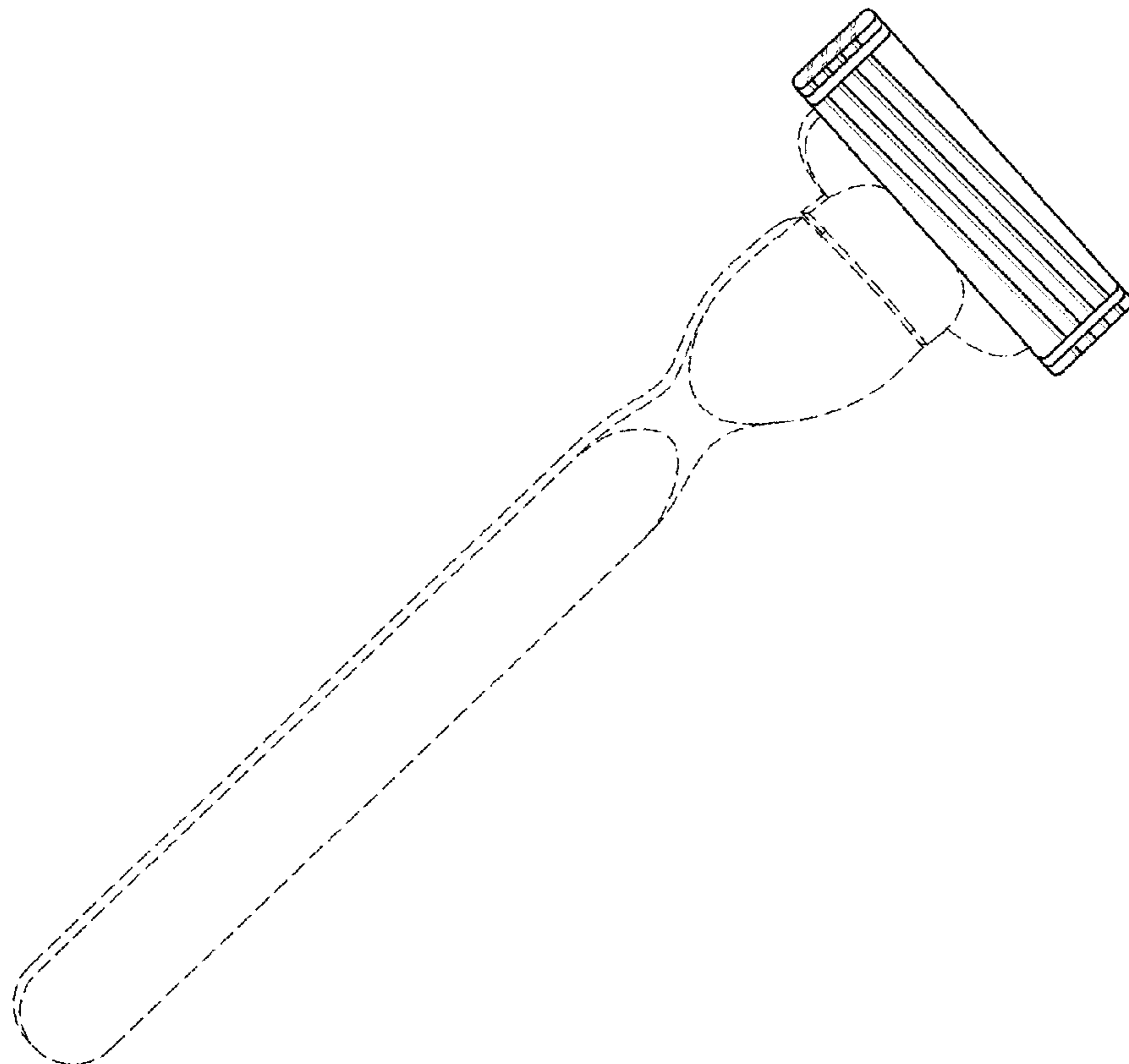
FIG. 5 is a second side view of the angled razor with side ports.

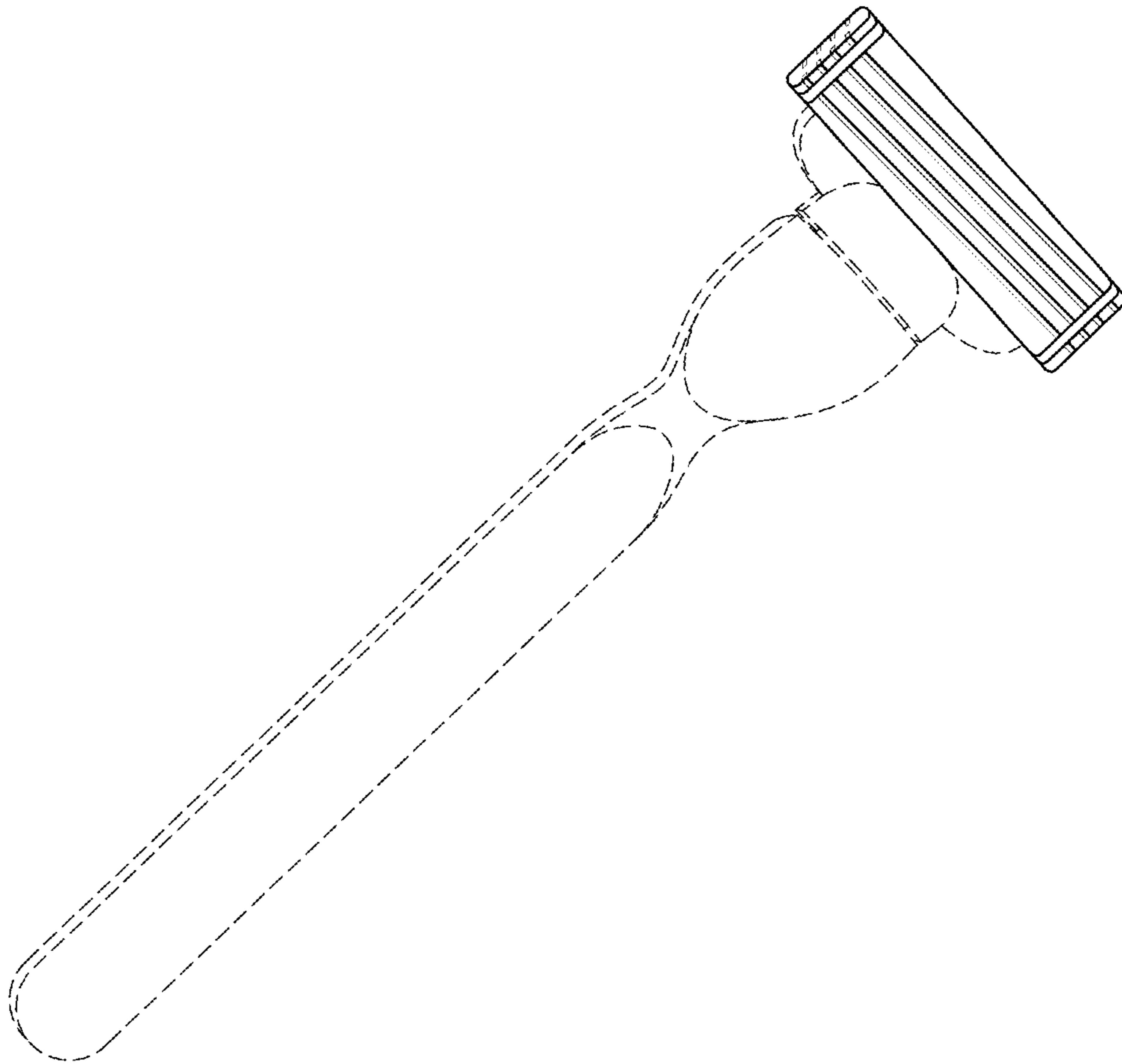

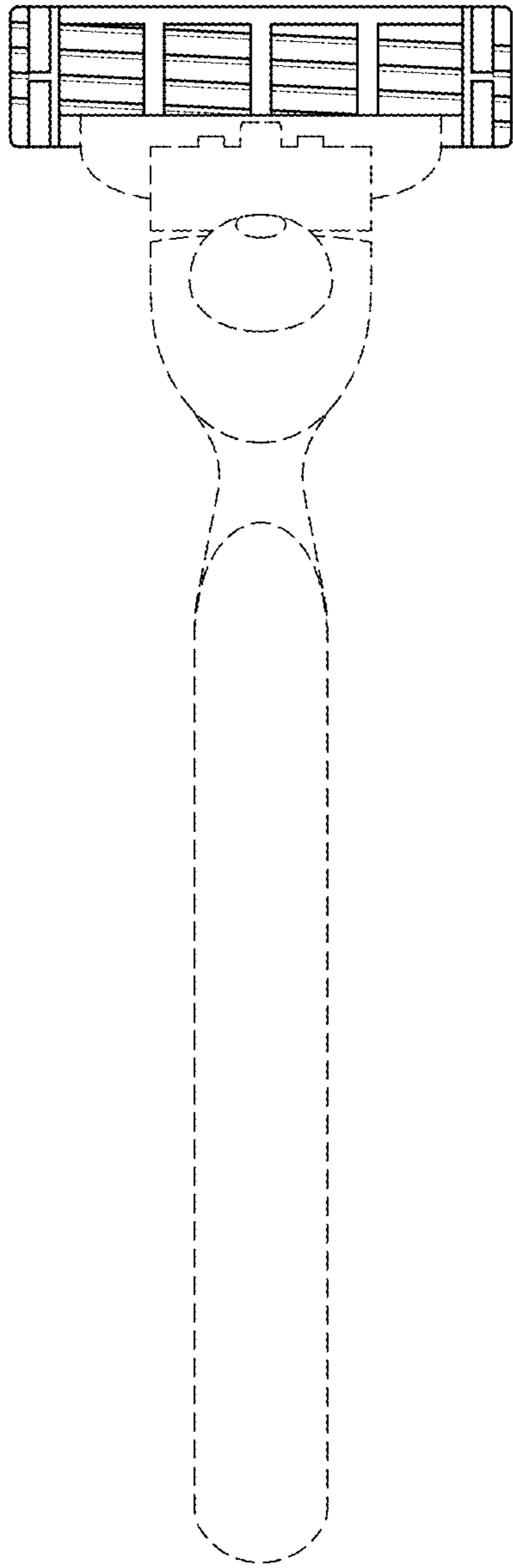

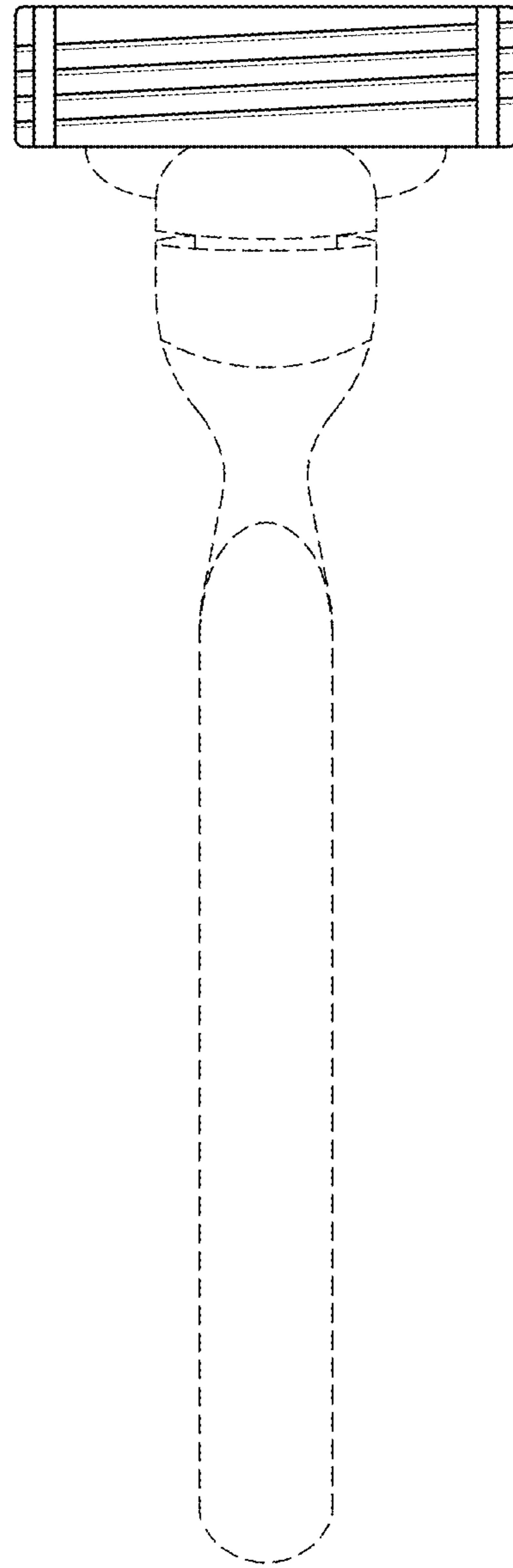

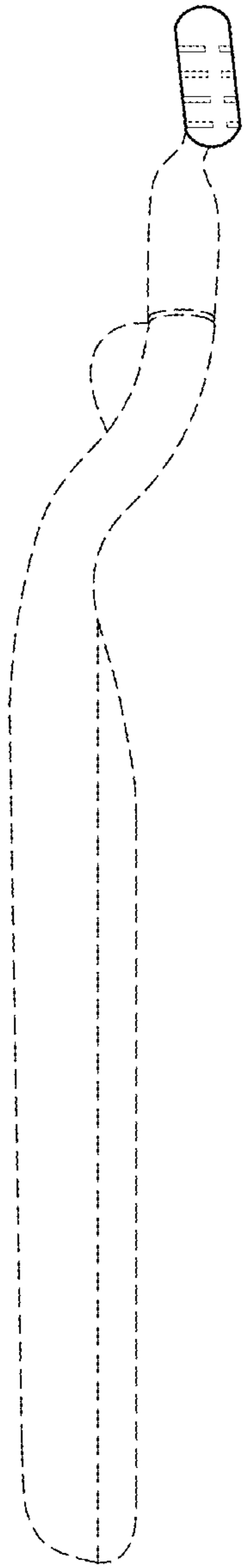

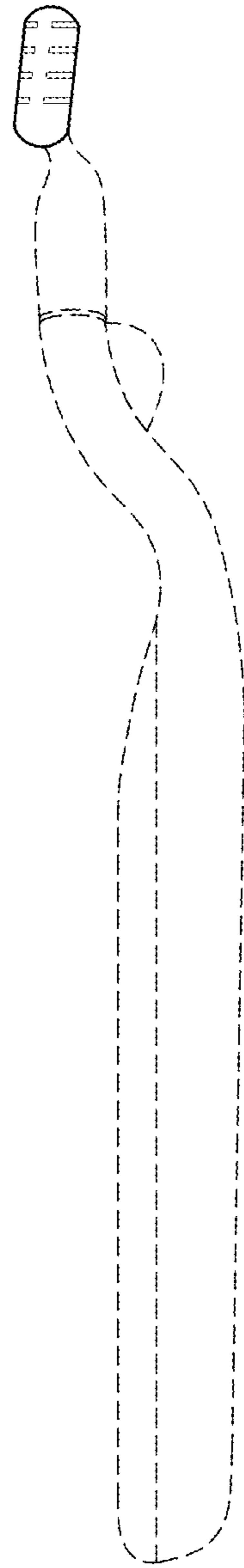

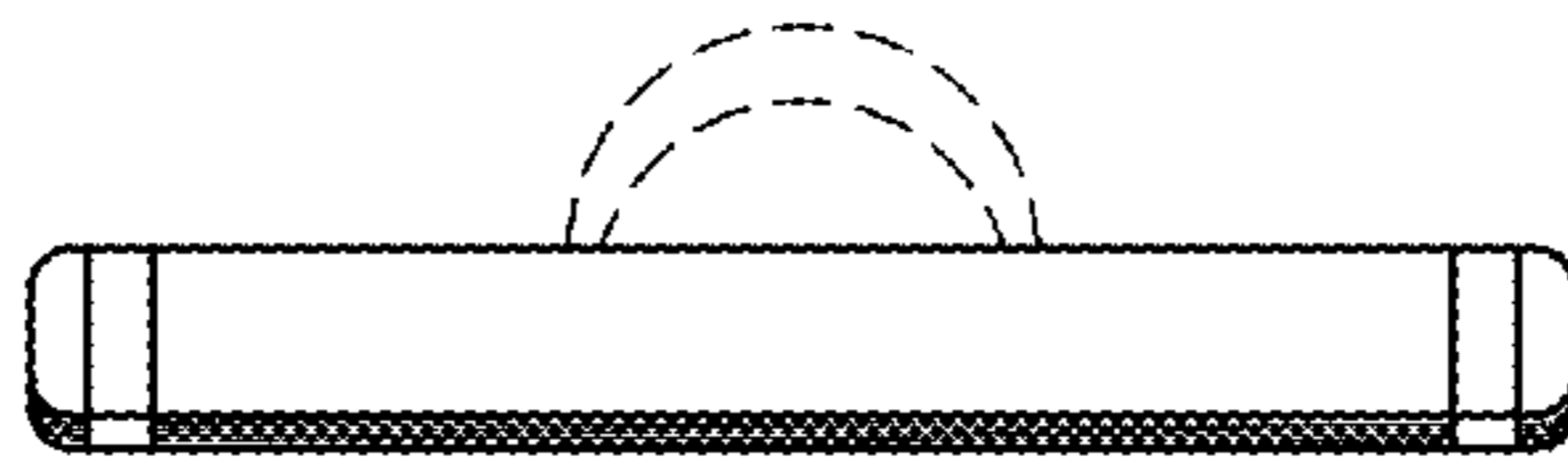

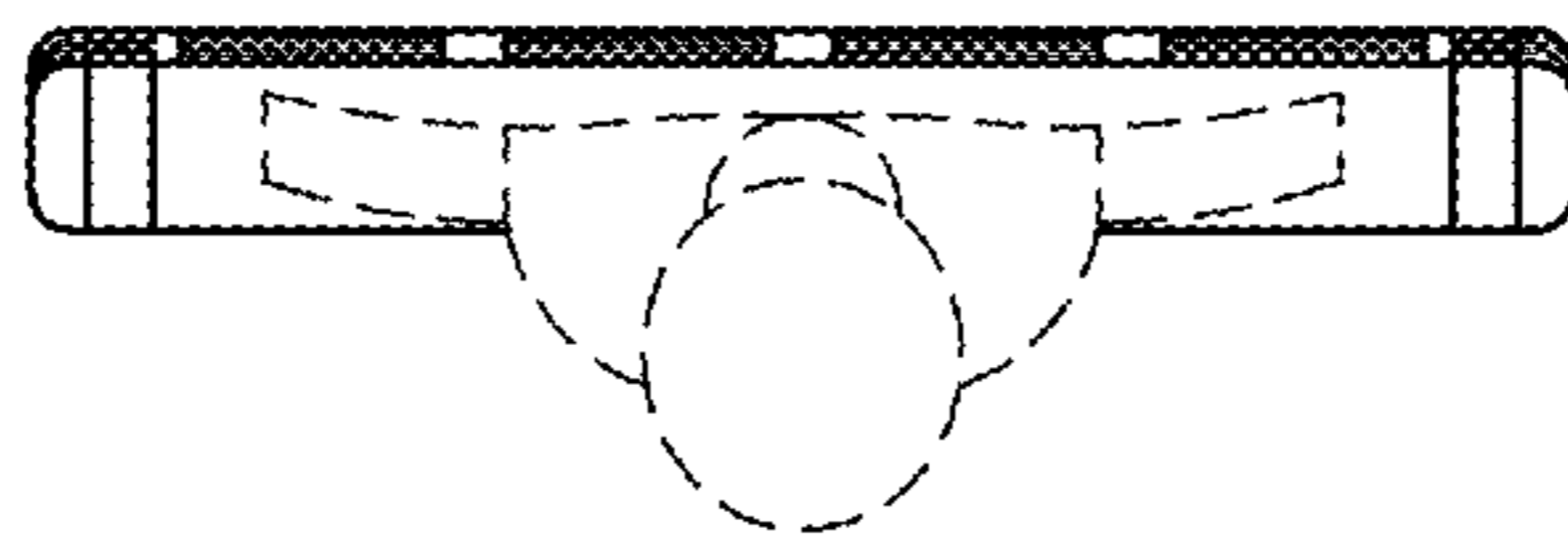
