FIG. 5 is a second side view of the trash bag with straps.

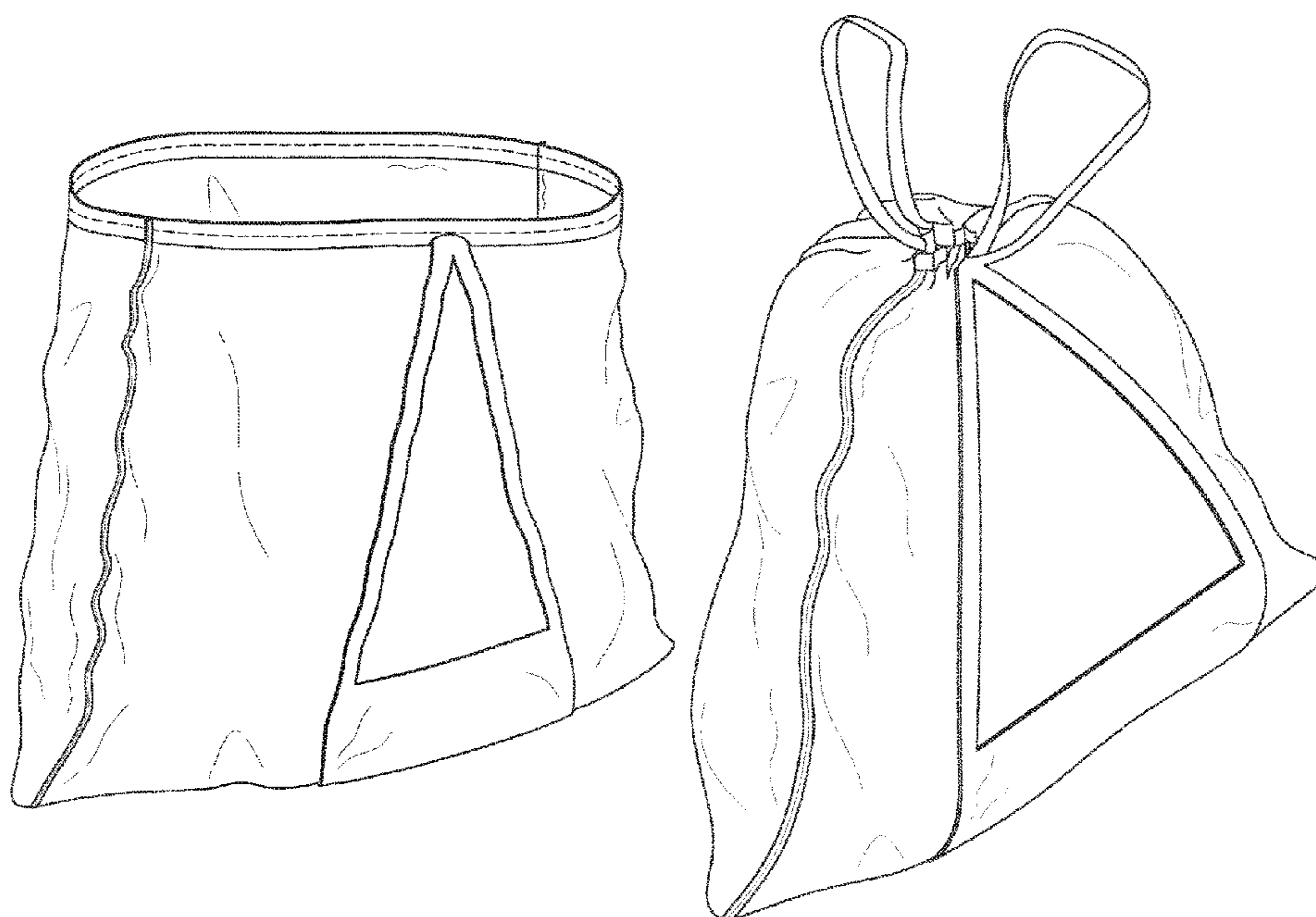
FIG. 6 is a top view of the trash bag with straps.

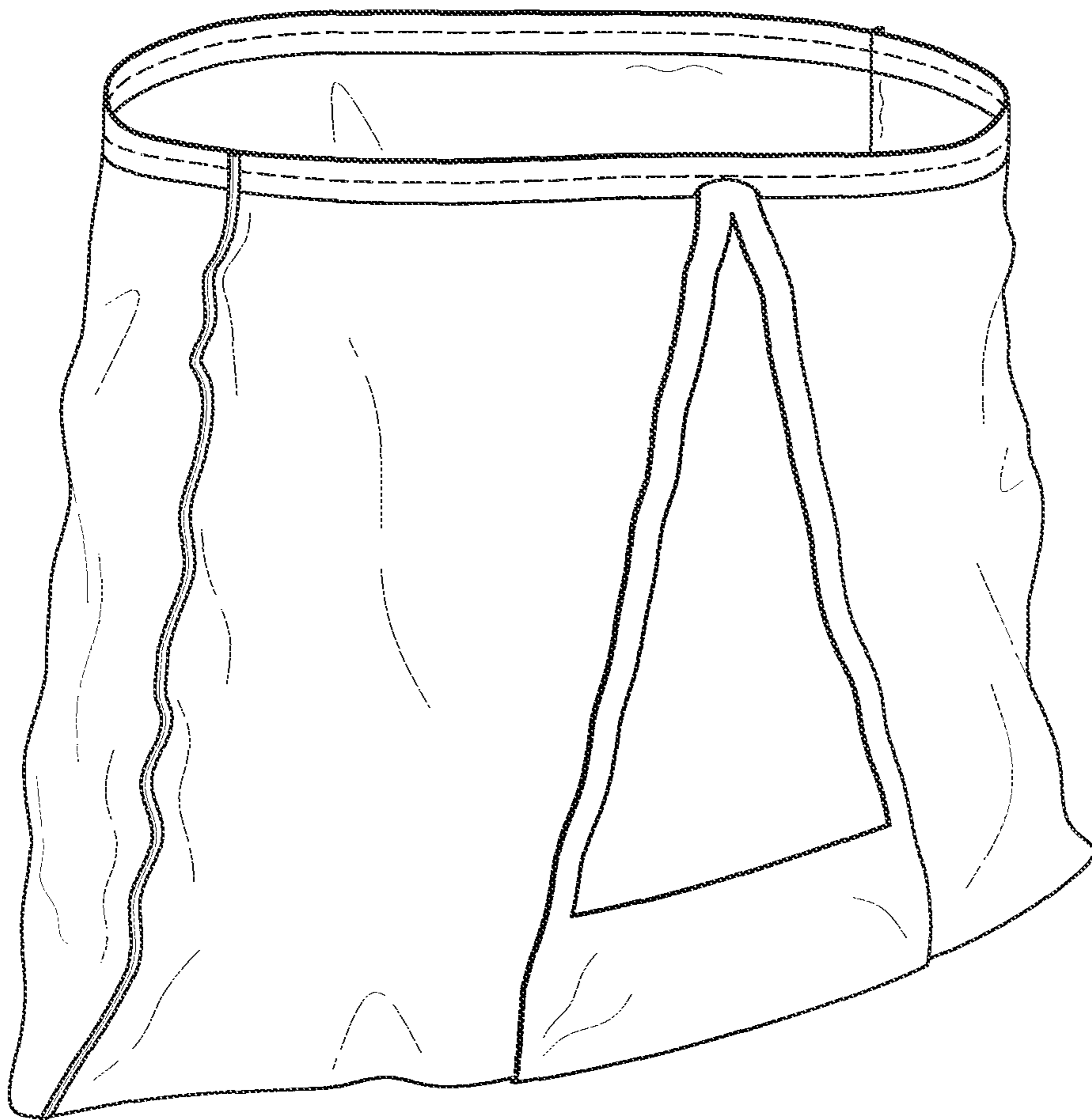

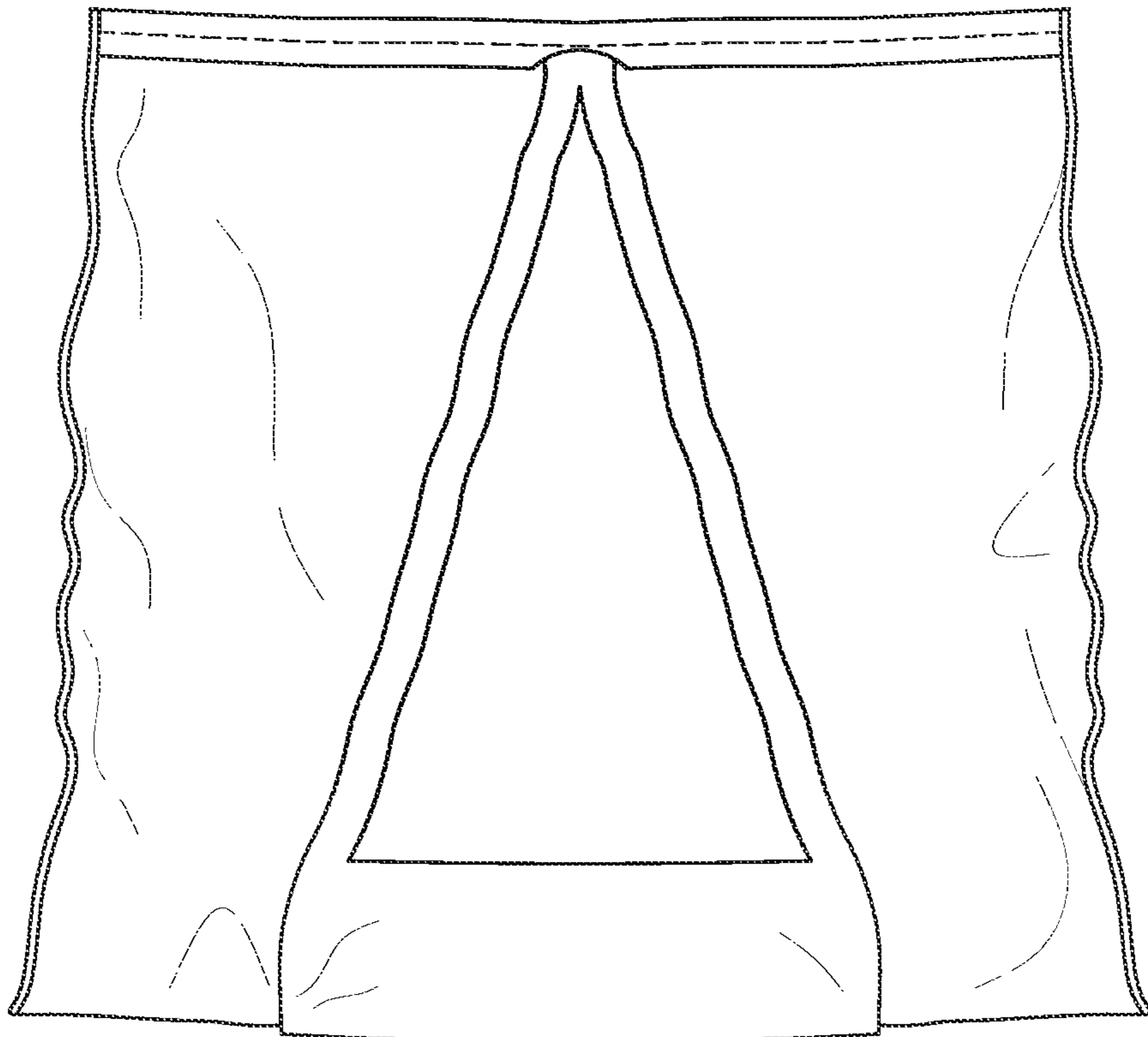

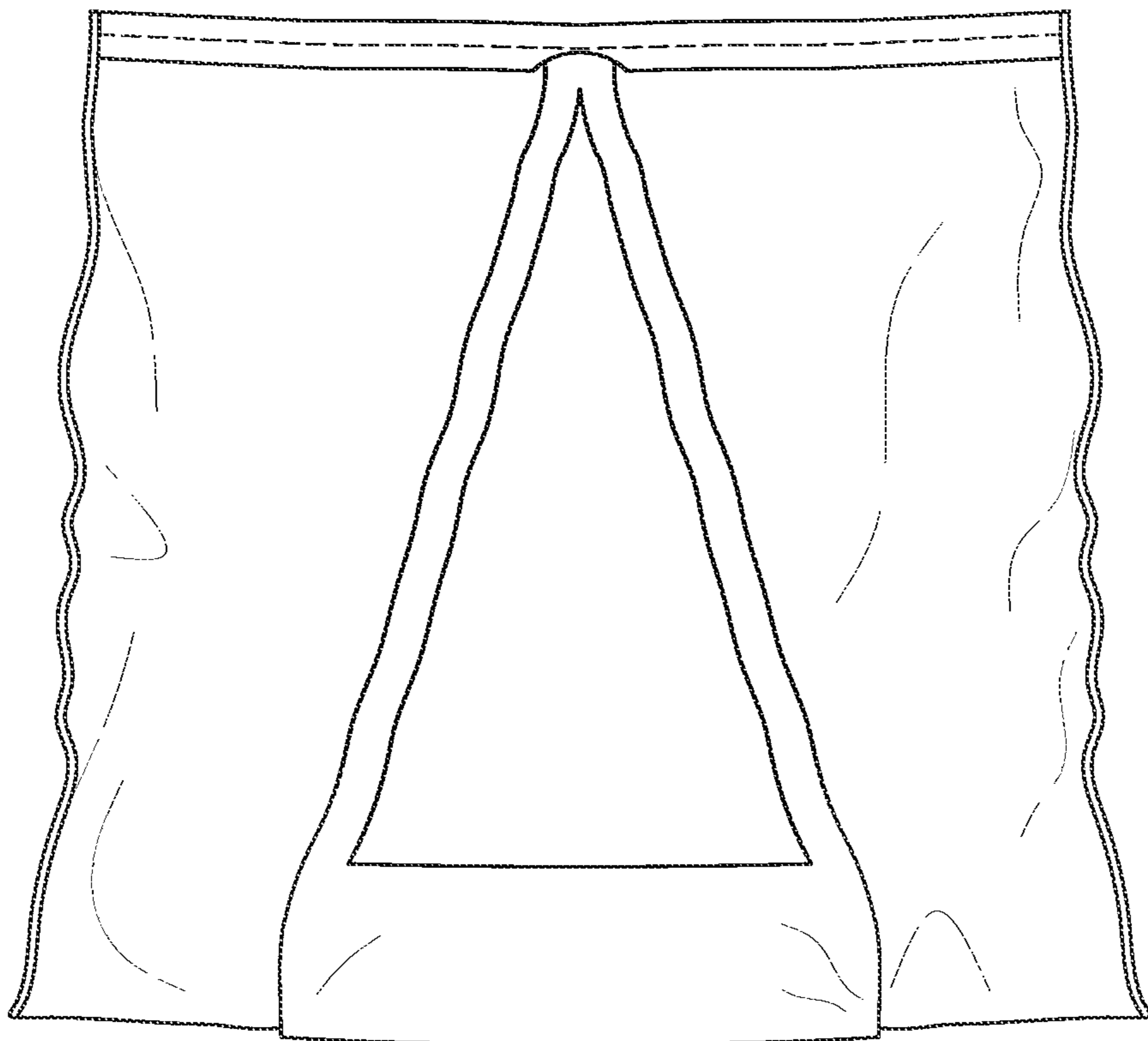

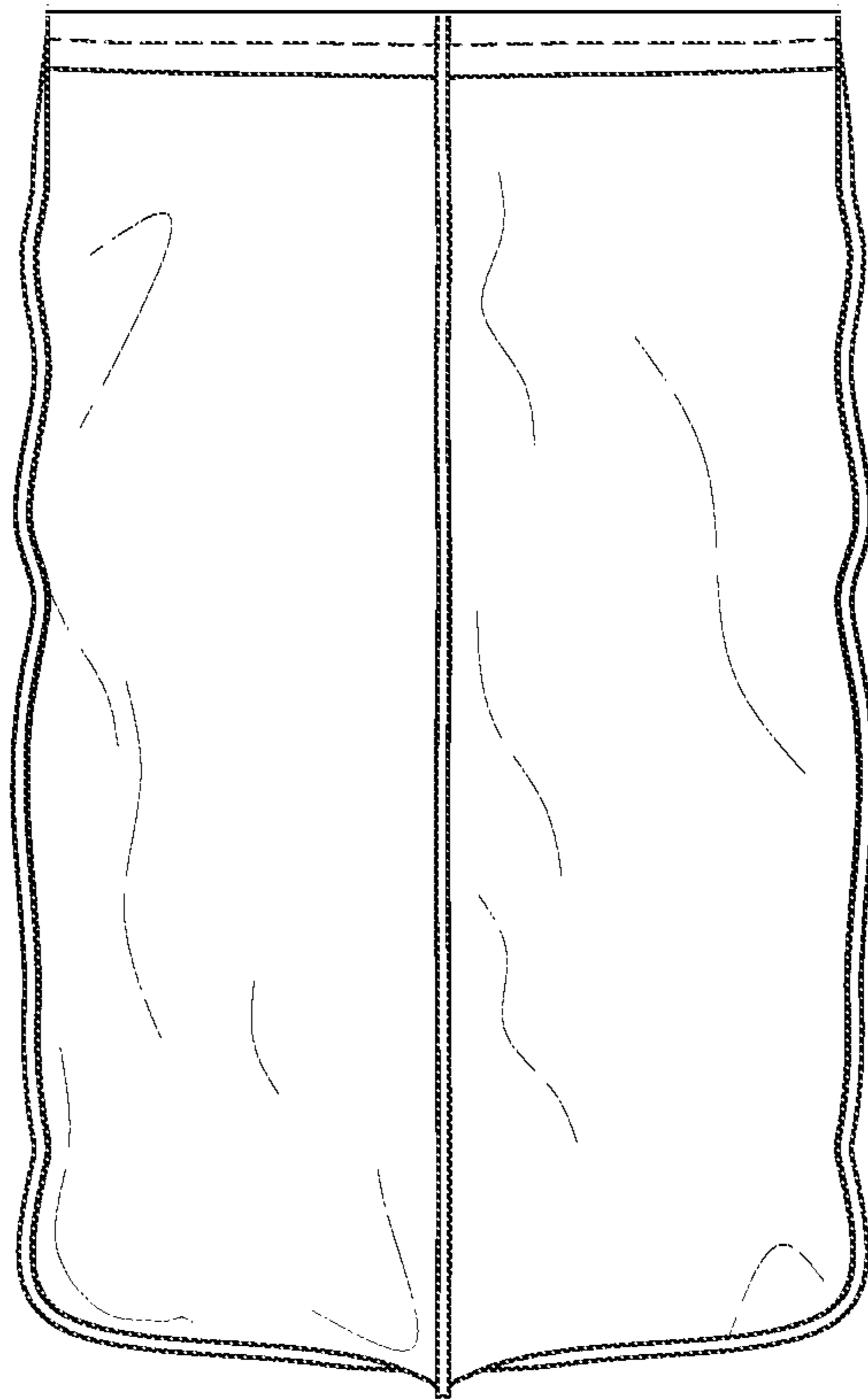

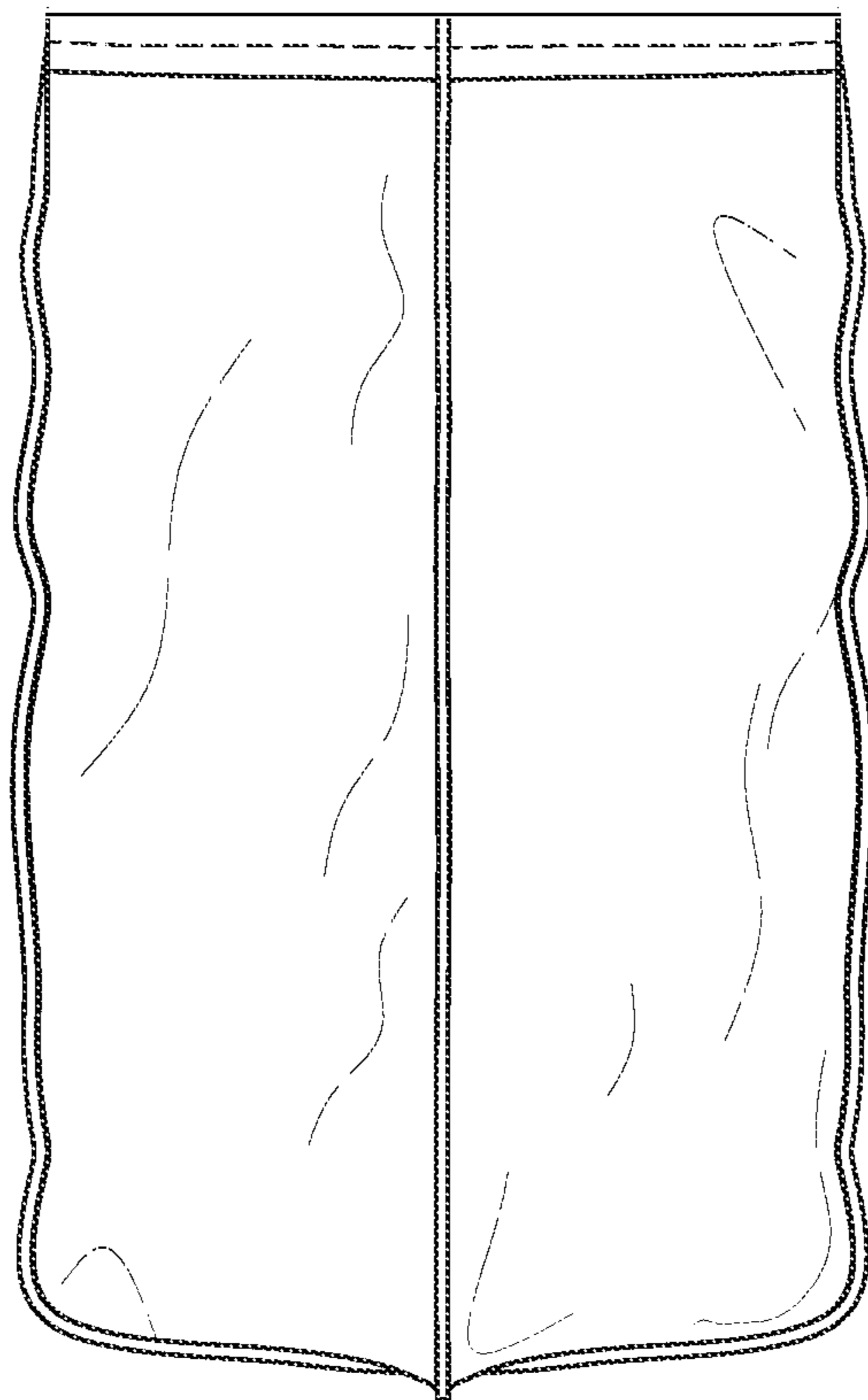

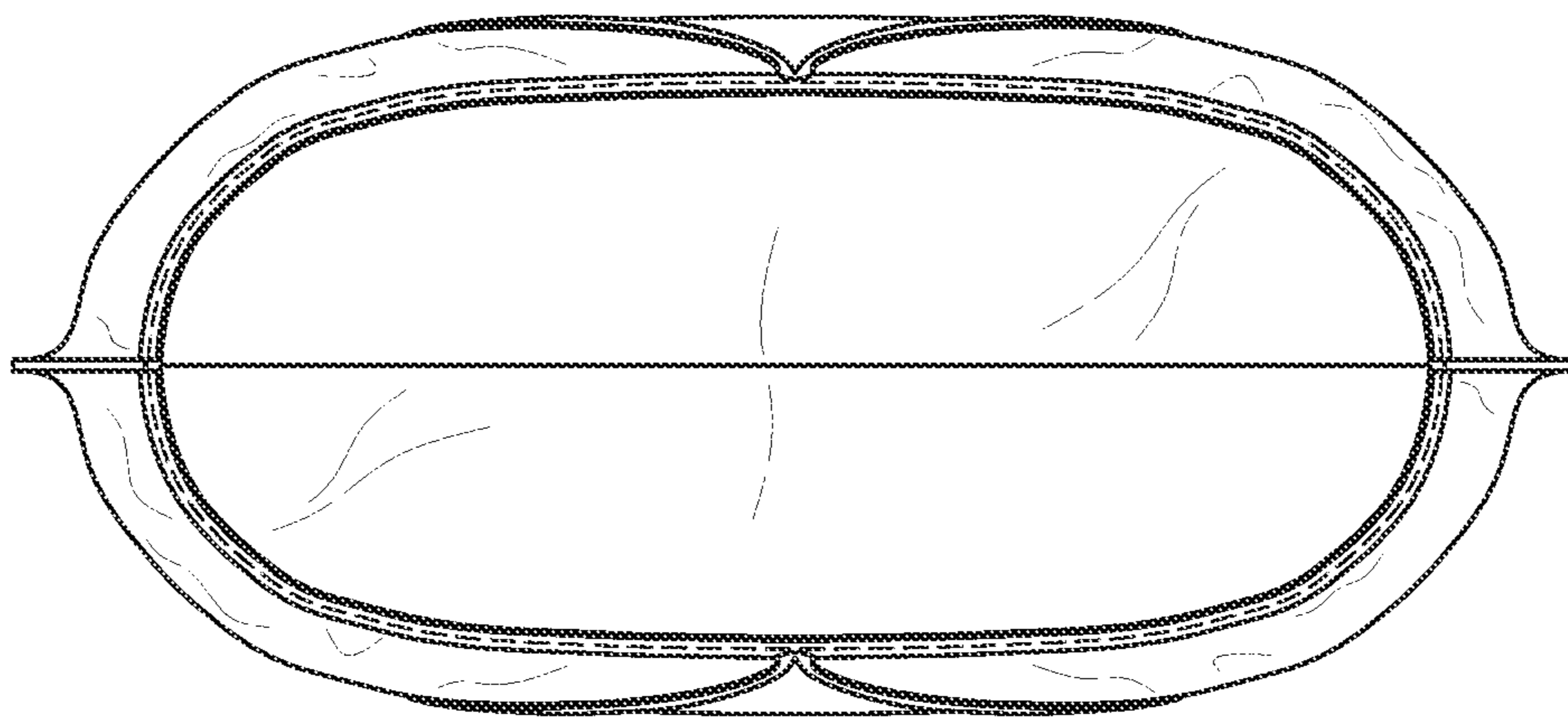

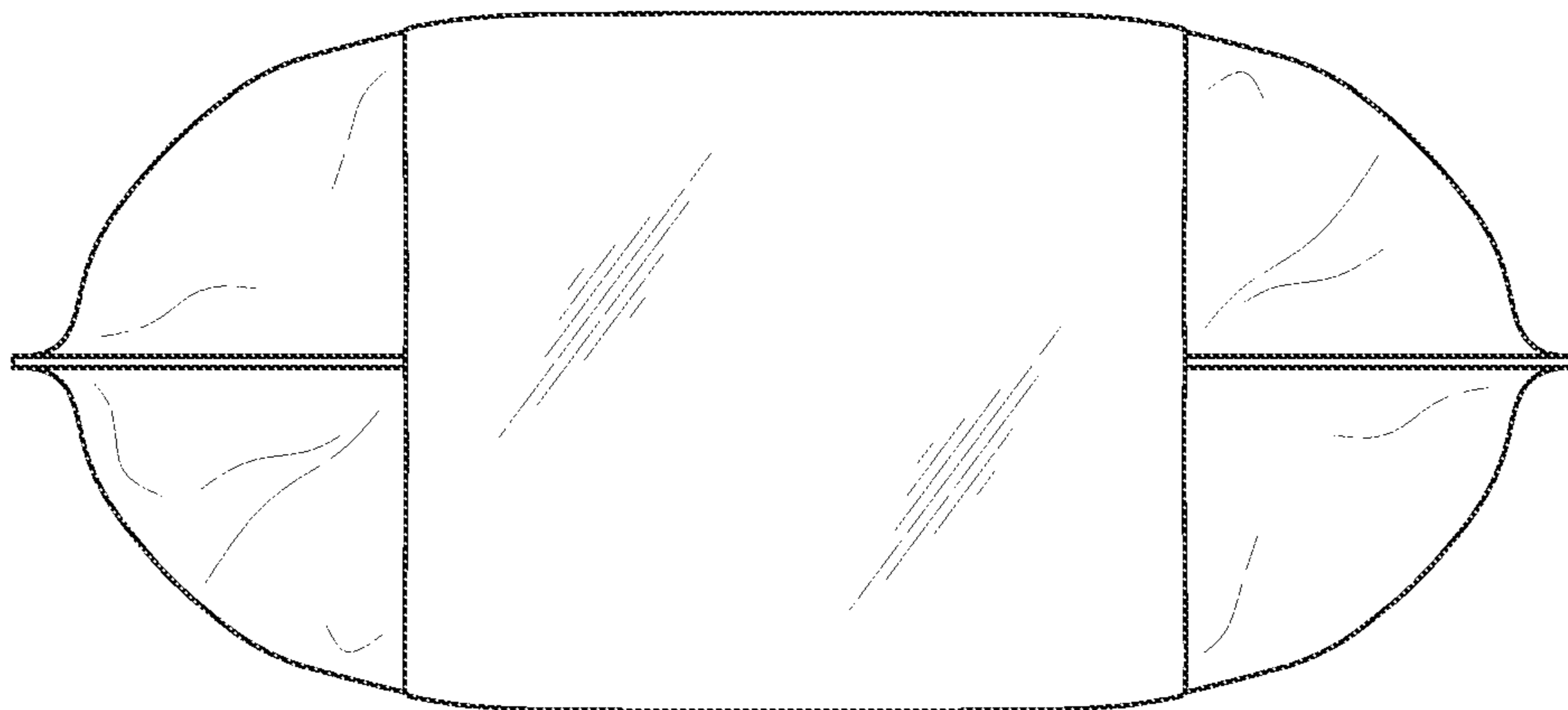

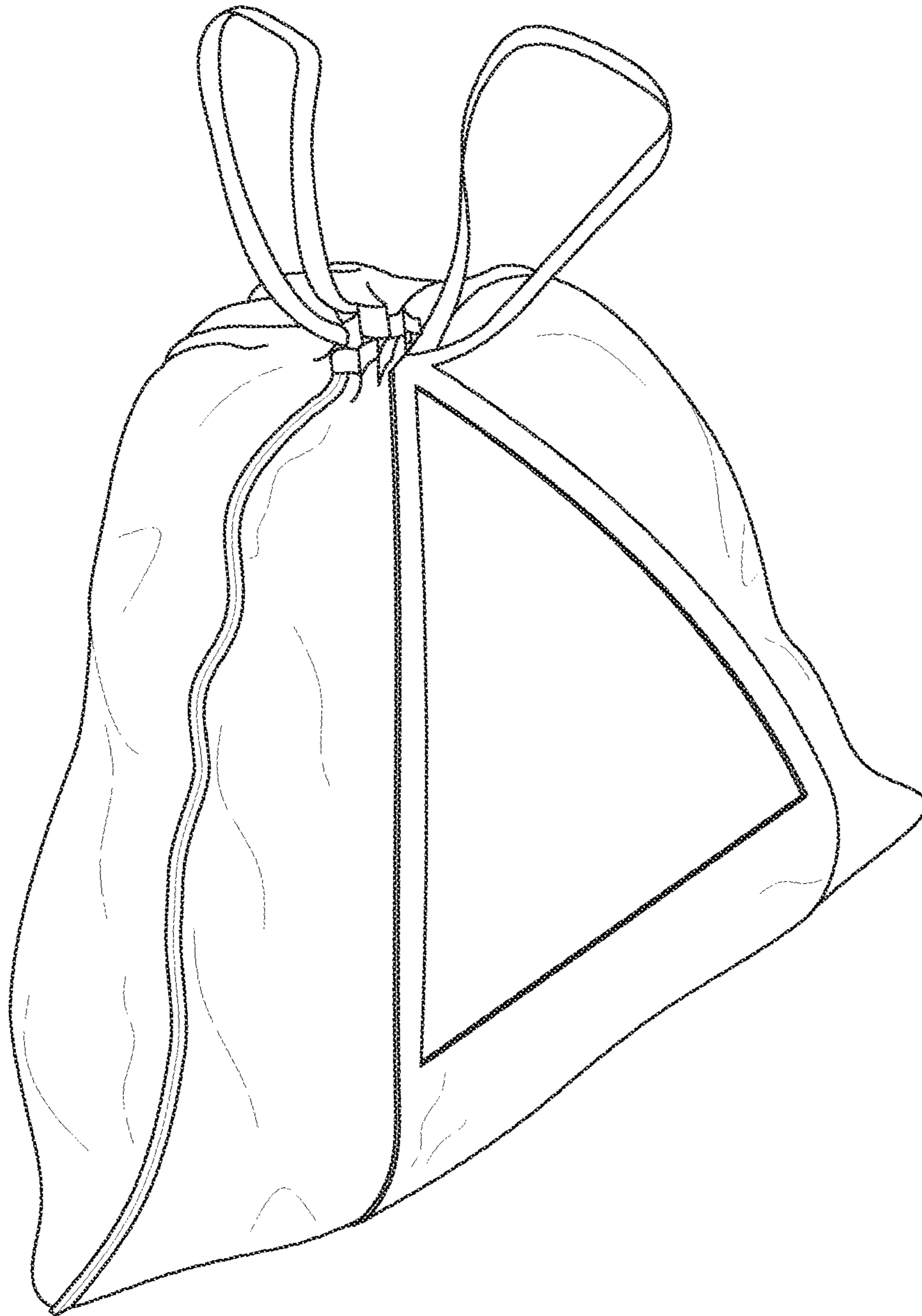
