#### **CLAIM** (57)

The ornamental design for a display screen portion with icon, as shown and described.

#### **DESCRIPTION**

FIG. 1 is a front view of a first image of a display screen portion with icon;

FIG. 2 is a front view of a second image thereof;

FIG. 3 is a front view of a third image thereof;

FIG. 4 is a front view of a fourth image thereof;

FIG. 5 is a front view of a fifth image thereof; and,


FIG. 6 is a front view of a sixth image thereof.

The dash-dot broken line showing of a display screen portion forms no part of the claimed design. The dash-dot broken line showing also shows the boundaries of the claimed design.

In the first embodiment, the appearance of the image sequentially transitions between FIGS. 1, 2, 3, and 5. In the second embodiment, the appearance of the image sequentially transitions between FIGS. 1-5. In the third embodiment, the appearance of the image sequentially transitions between FIGS. **1-6**.

The process or period in which one image transitions to another image forms no part of the claimed design.




