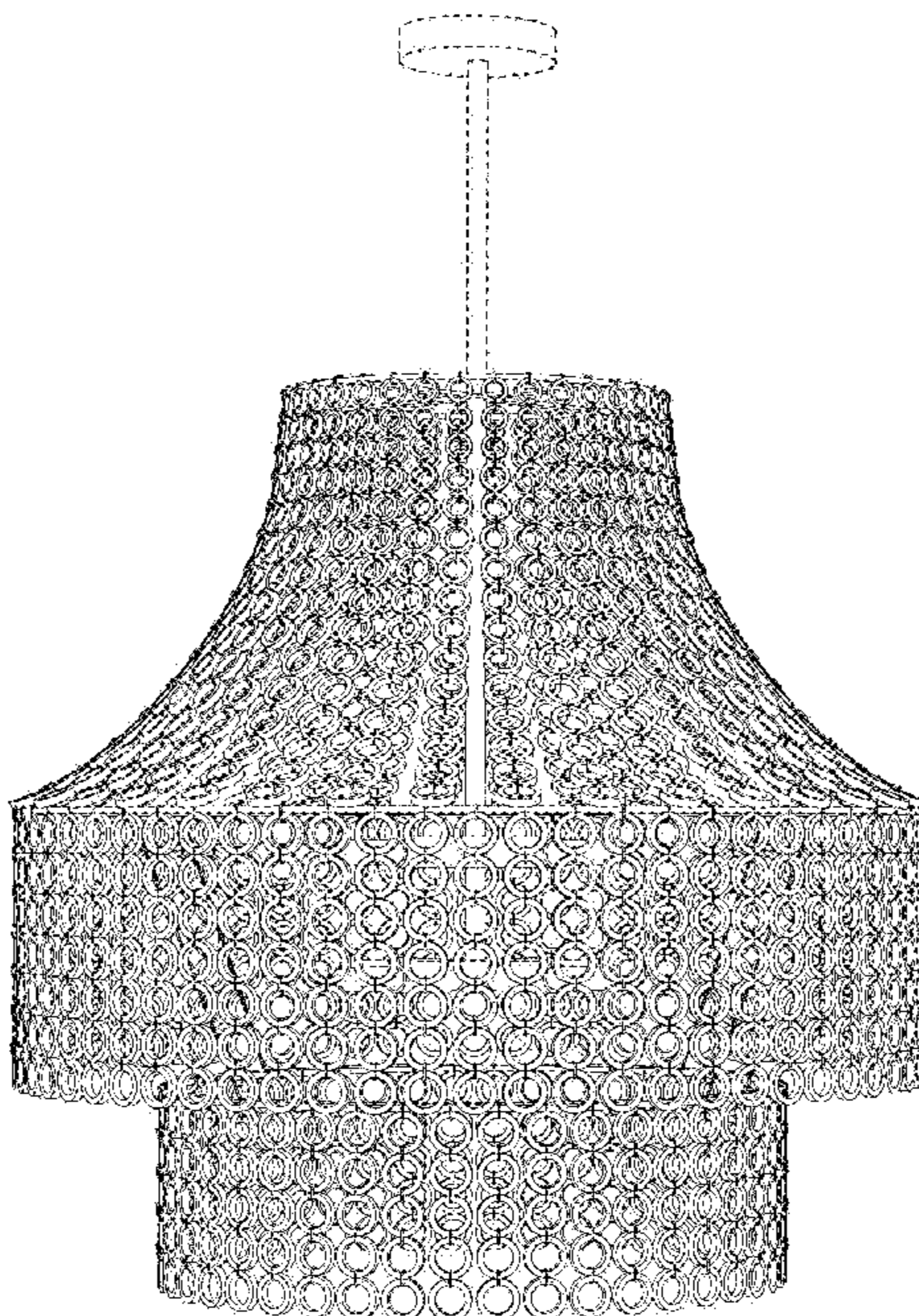
(57) **CLAIM**

I claim the ornamental design for a chandelier, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a chandelier according to this invention, wherein the chandelier comprises a symmetric shape;
FIG. 2 is a front view of the chandelier shown in FIG. 1;
FIG. 3 is a top view of the chandelier shown in FIG. 1; and
FIG. 4 is a bottom view of the chandelier shown in FIG. 1.

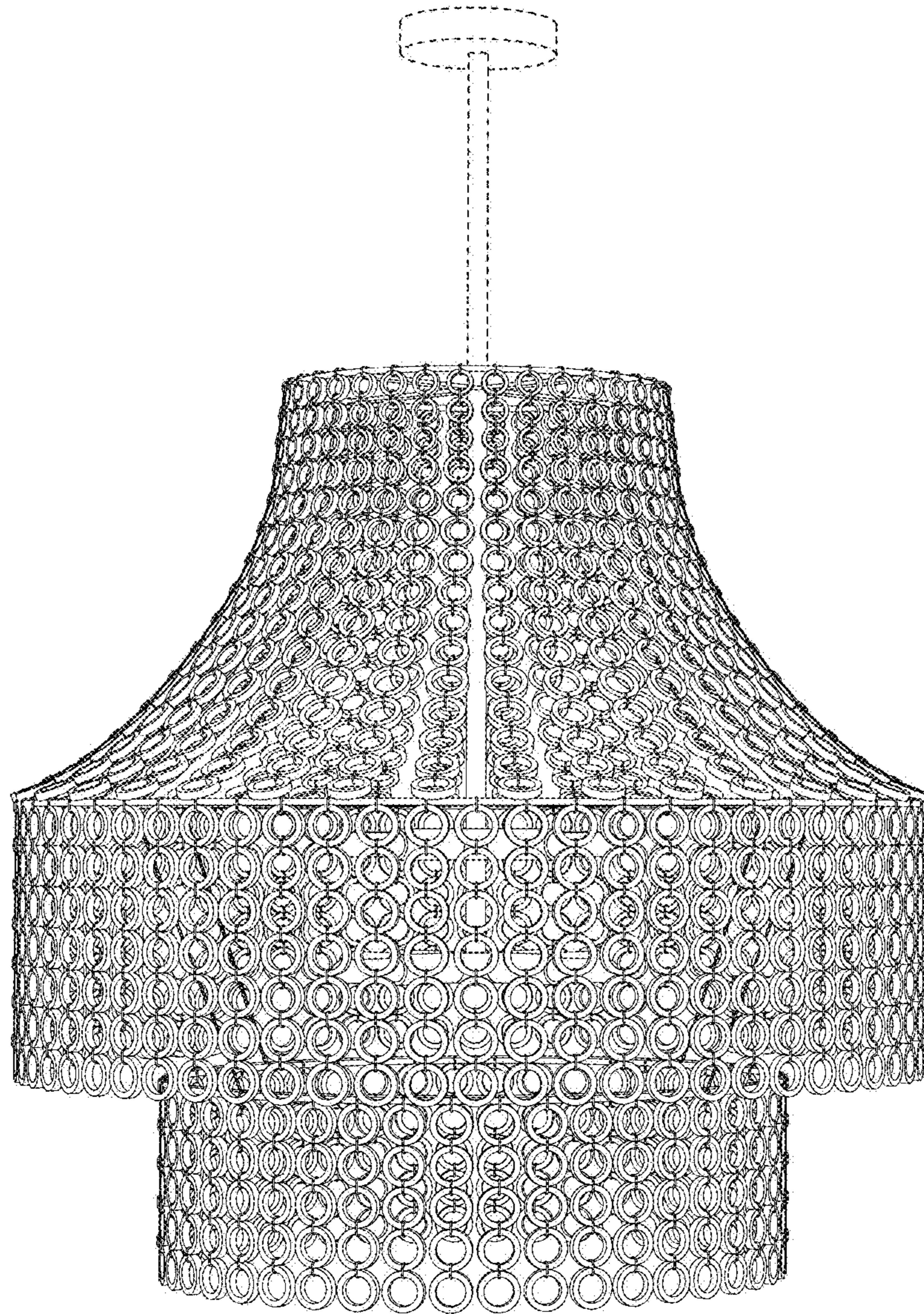

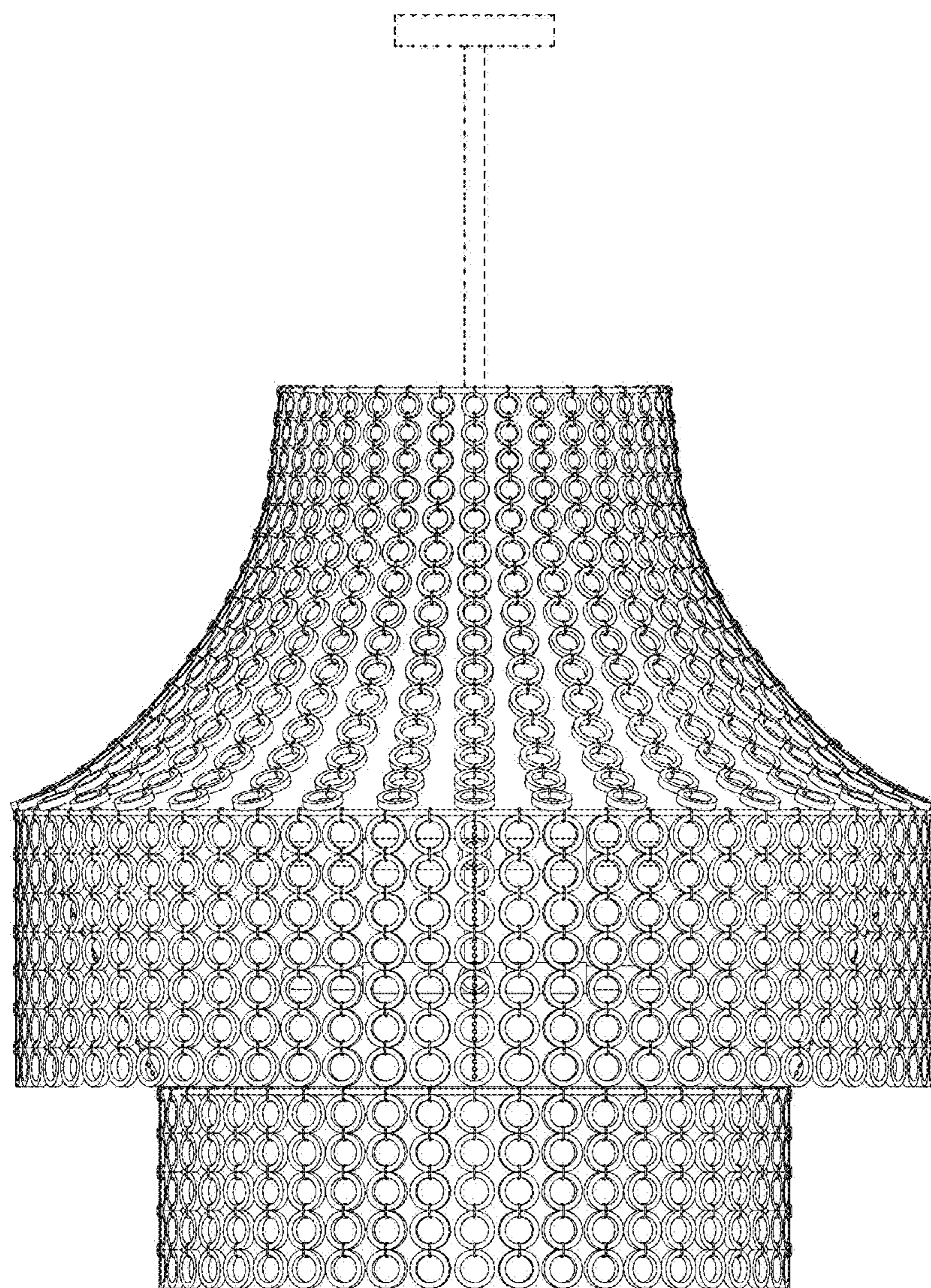

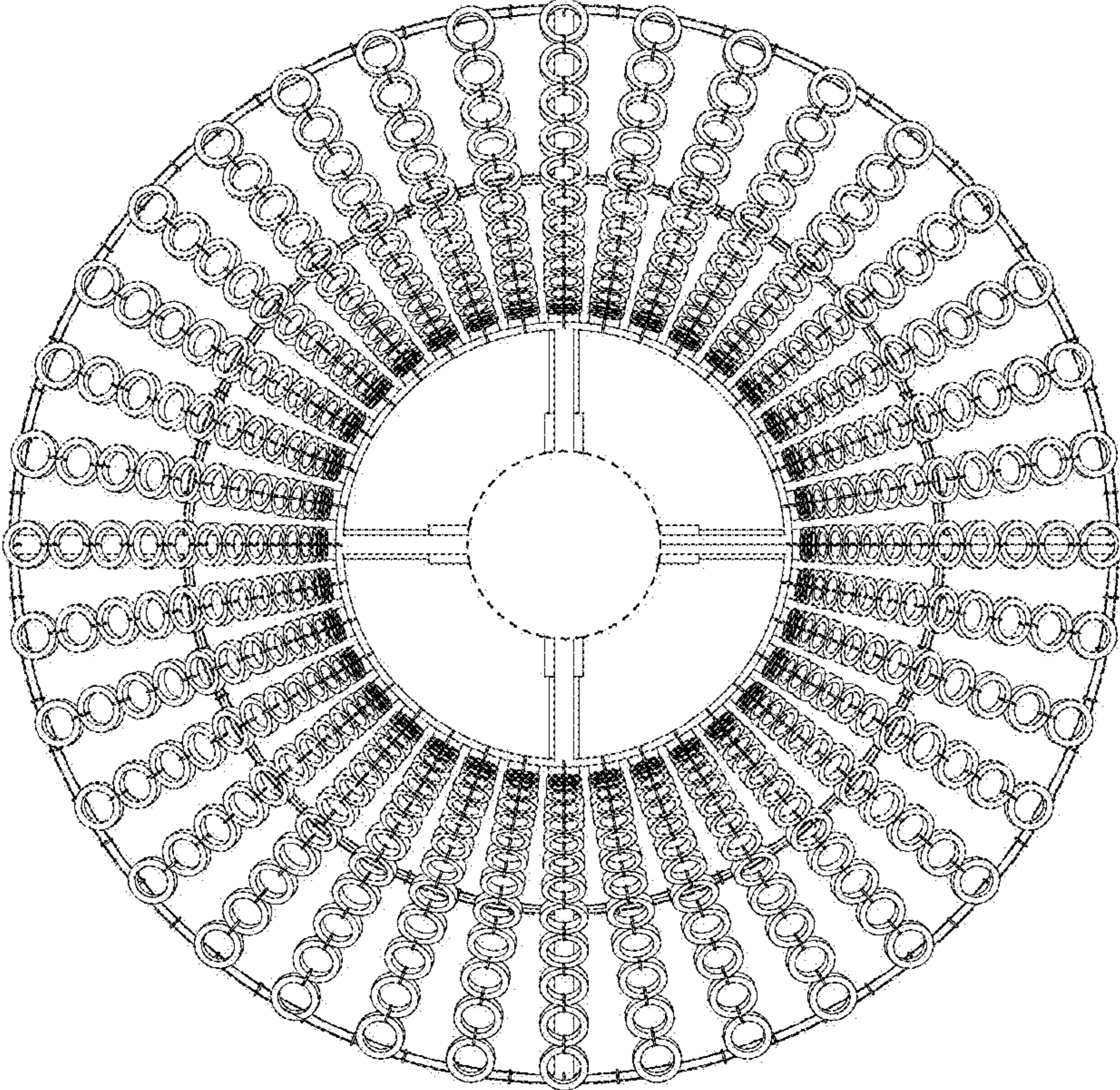

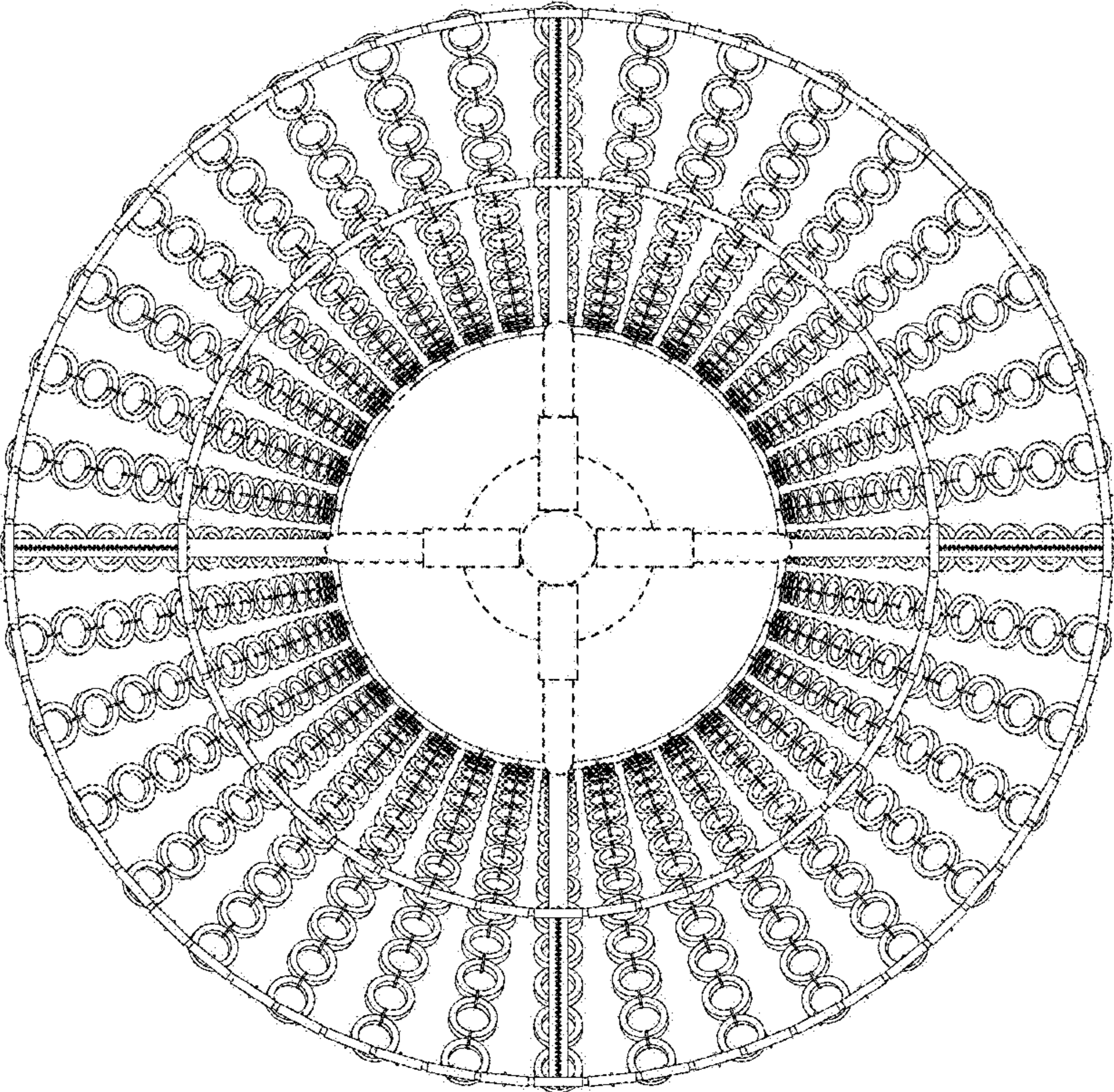
