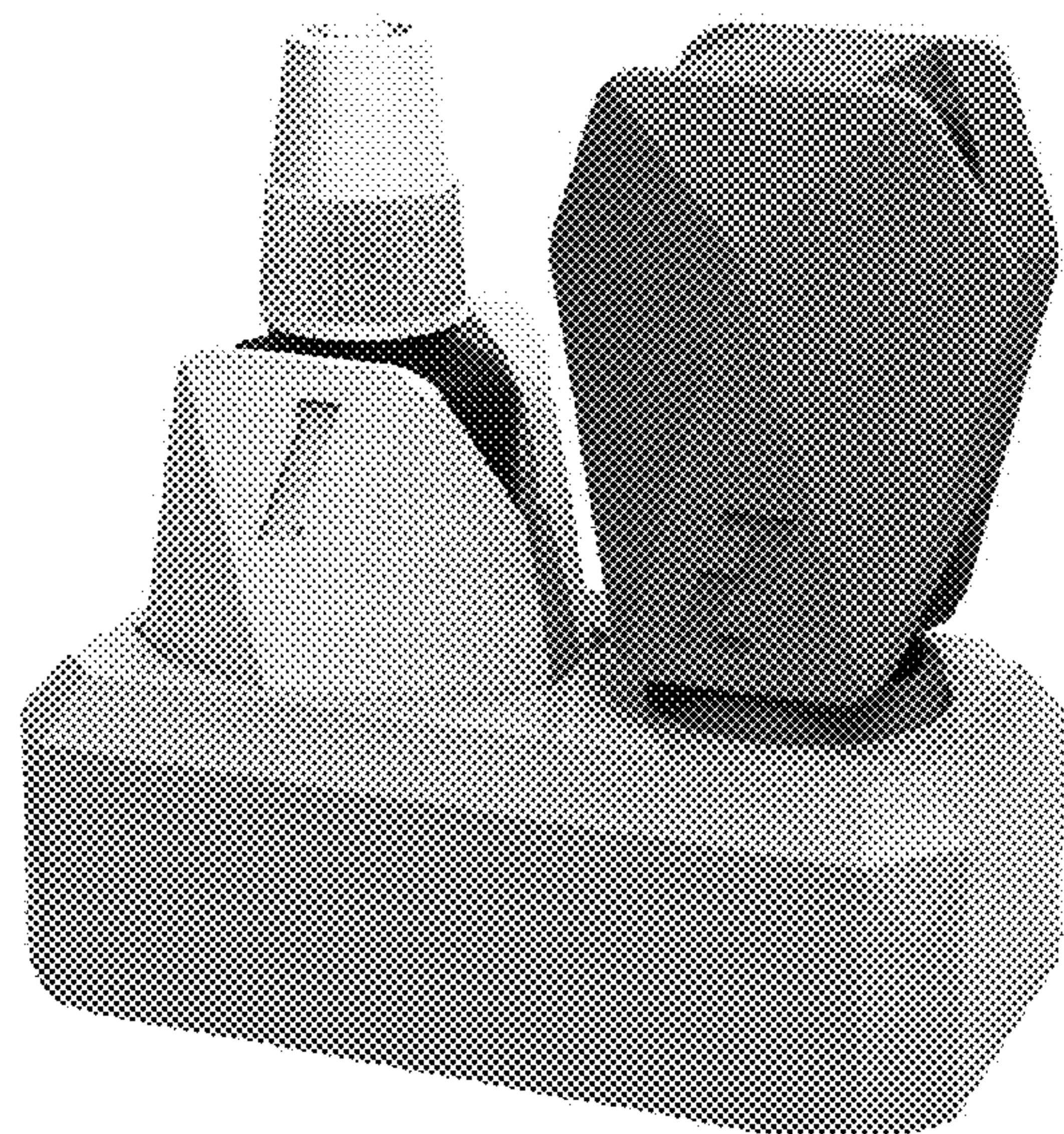
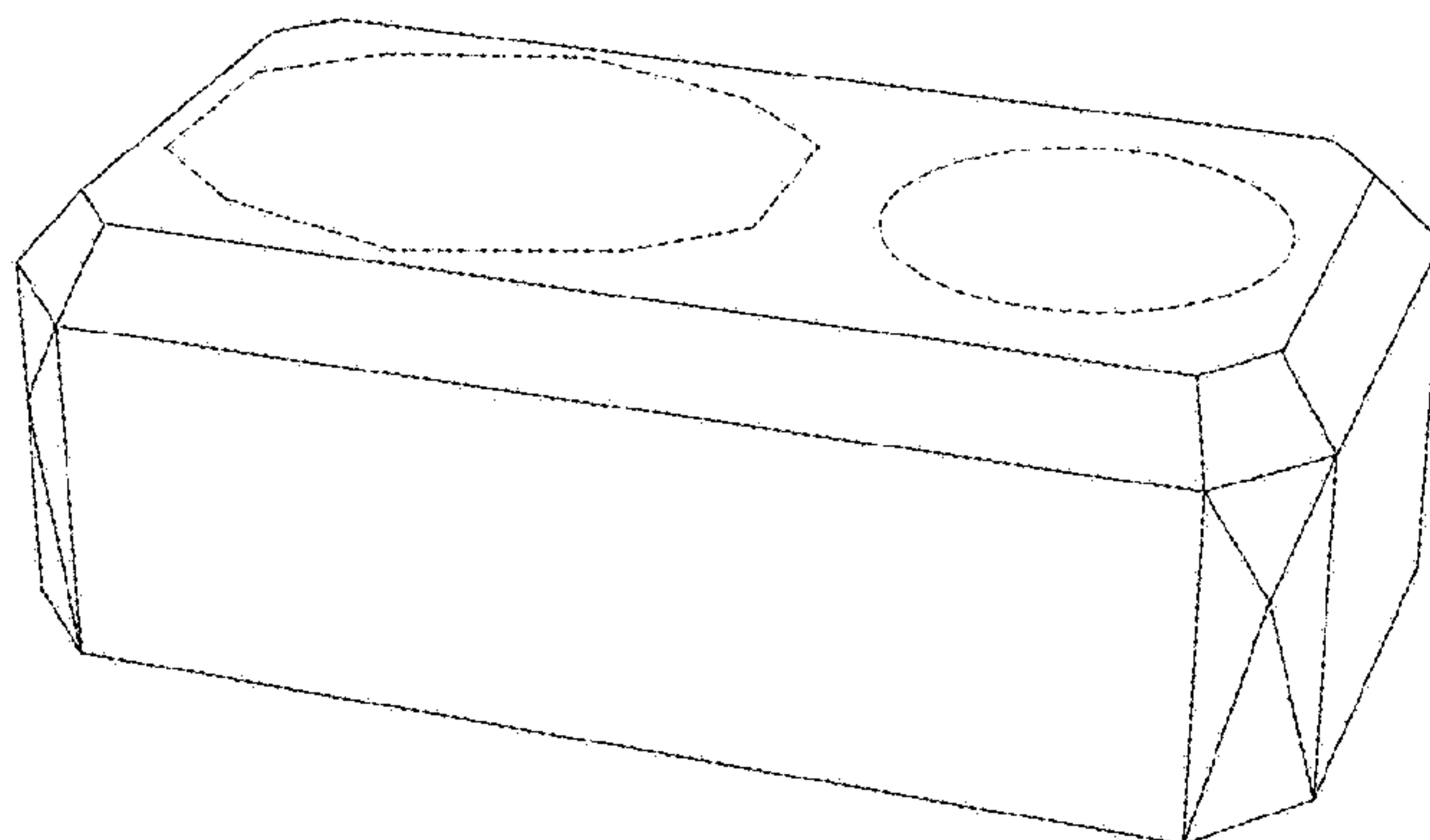
1.4 : Bottom

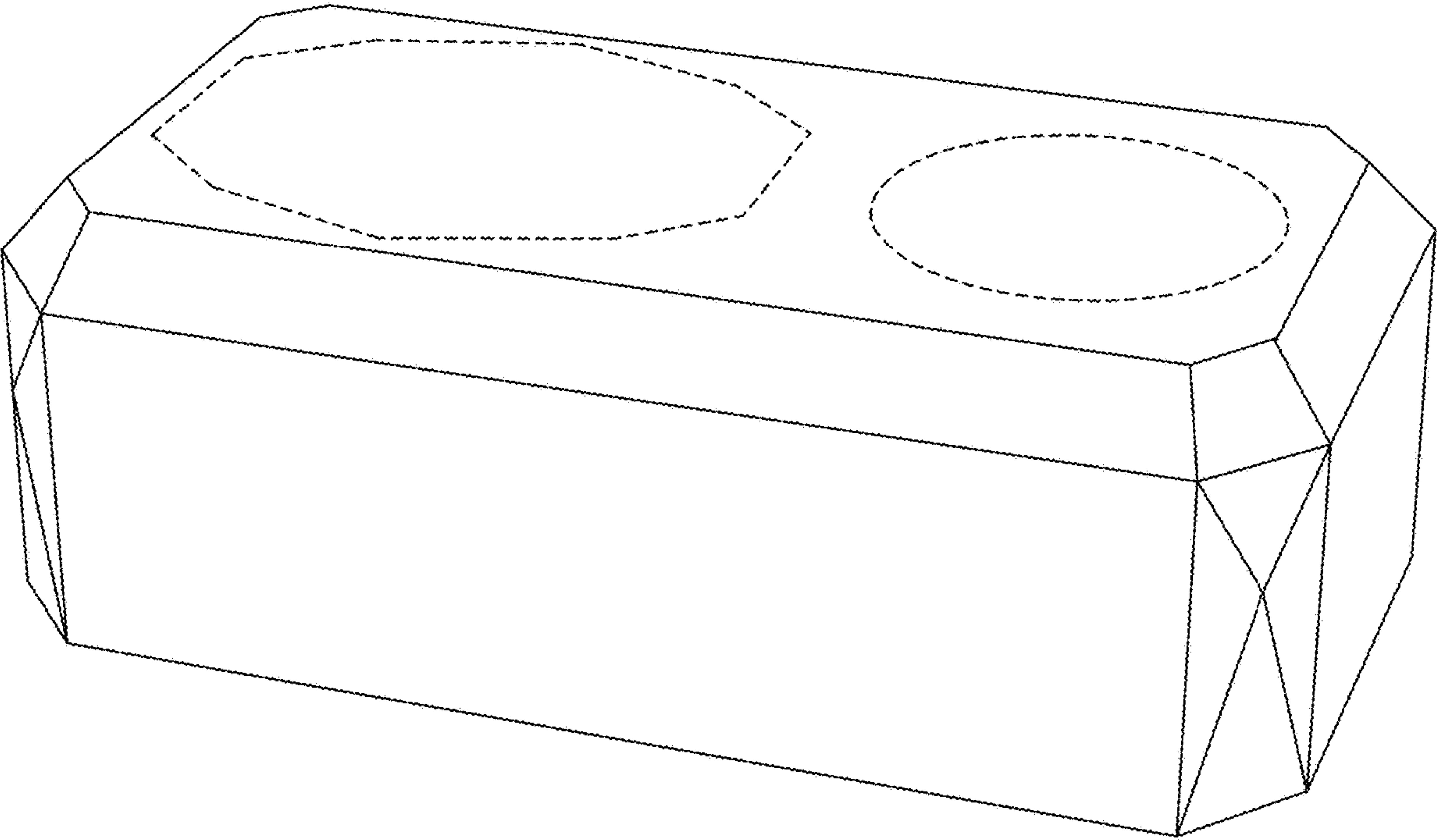
1.6 : Reference view showing the state in use

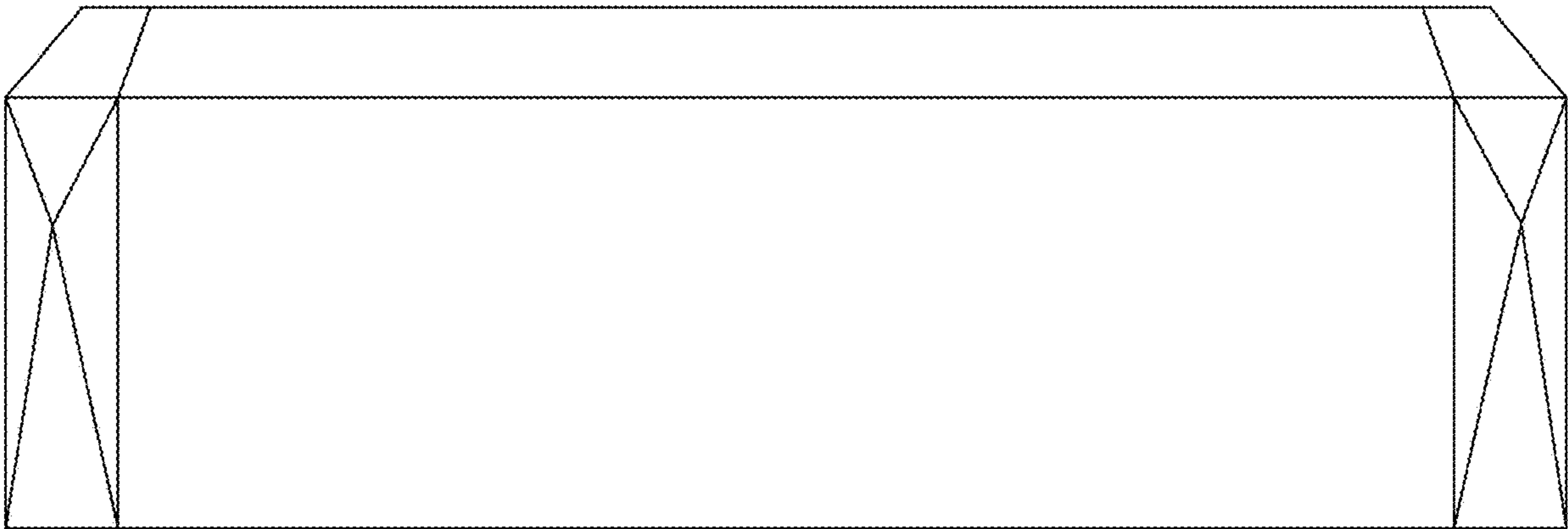

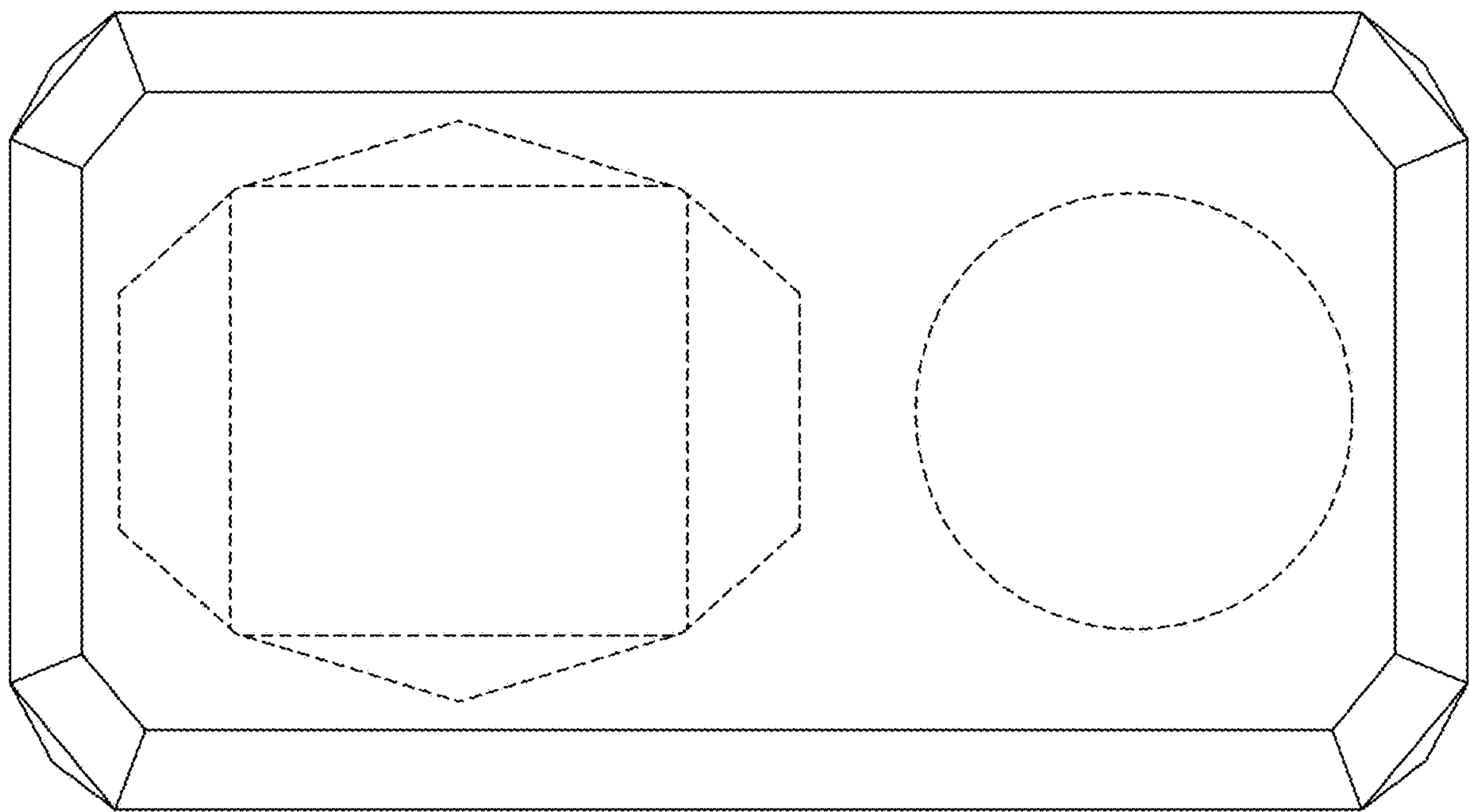

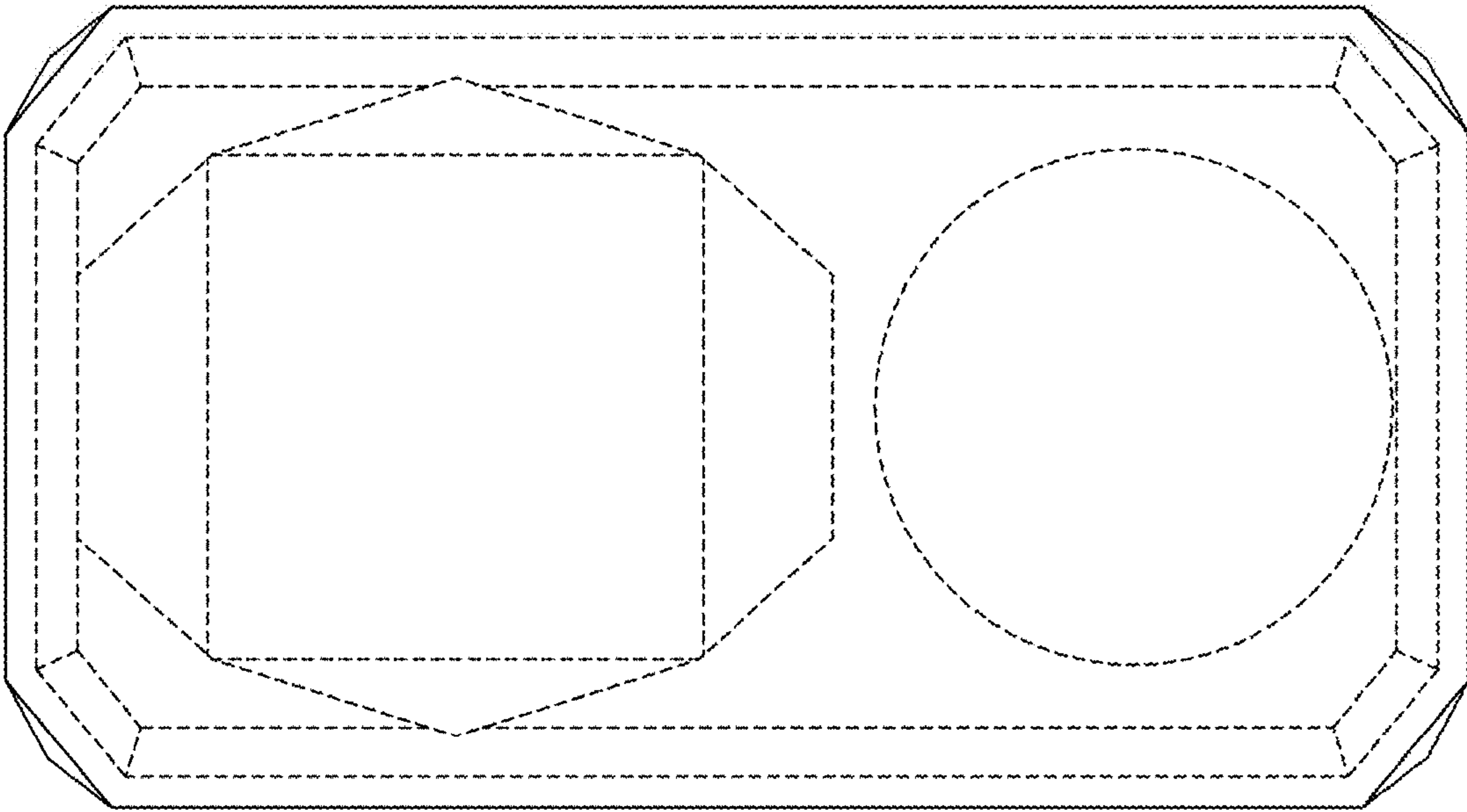

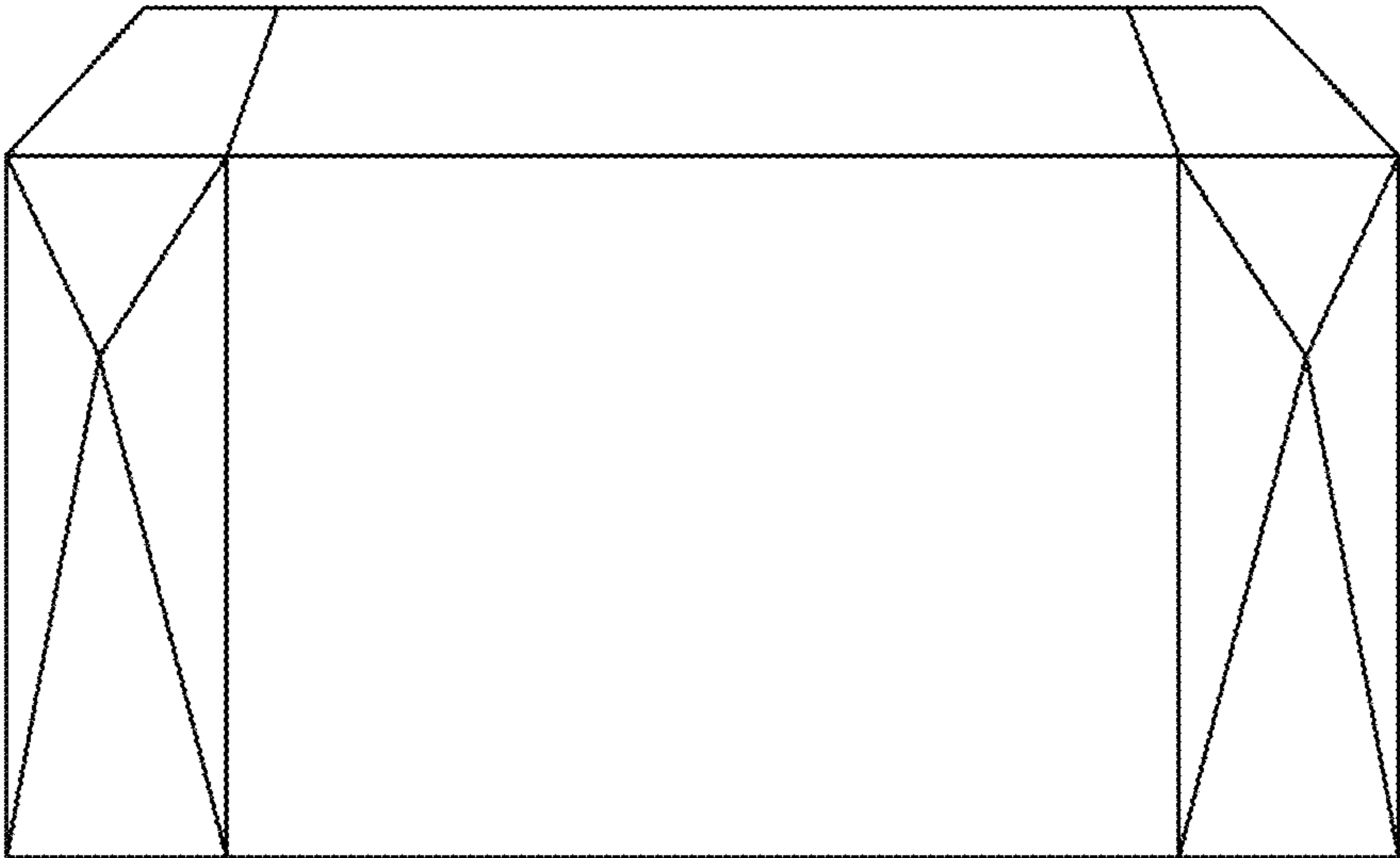
