(57) **CLAIM**

I claim the ornamental design for a pendant light, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a pendant light according to this invention, wherein the pendant light comprises a symmetric shape;

FIG. 2 is a front view of the pendant light shown in FIG. 1;

FIG. 3 is a top view of the pendant light shown in FIG. 1;

and,

FIG. 4 is a bottom view of the pendant light shown in FIG. 1.

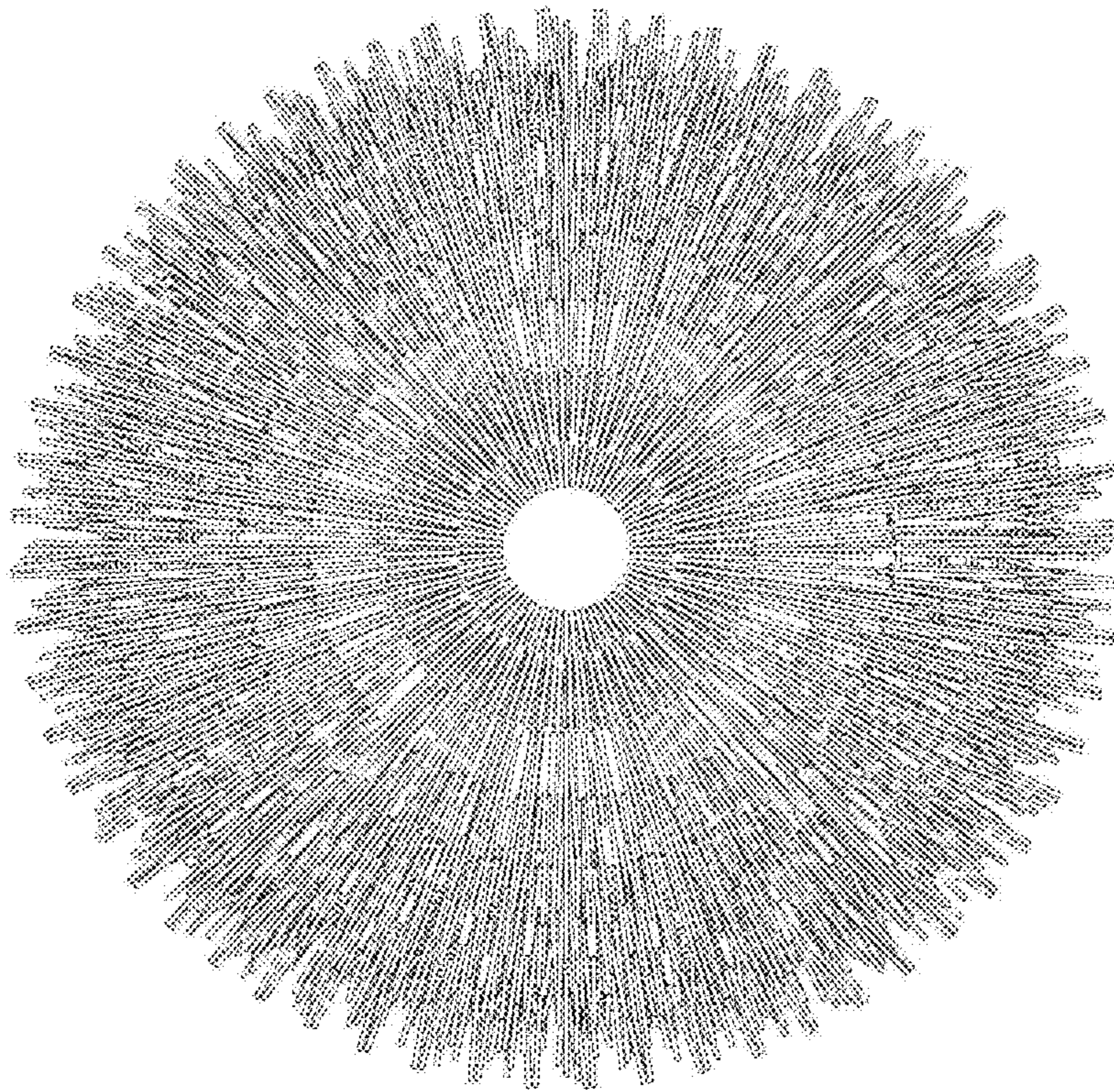

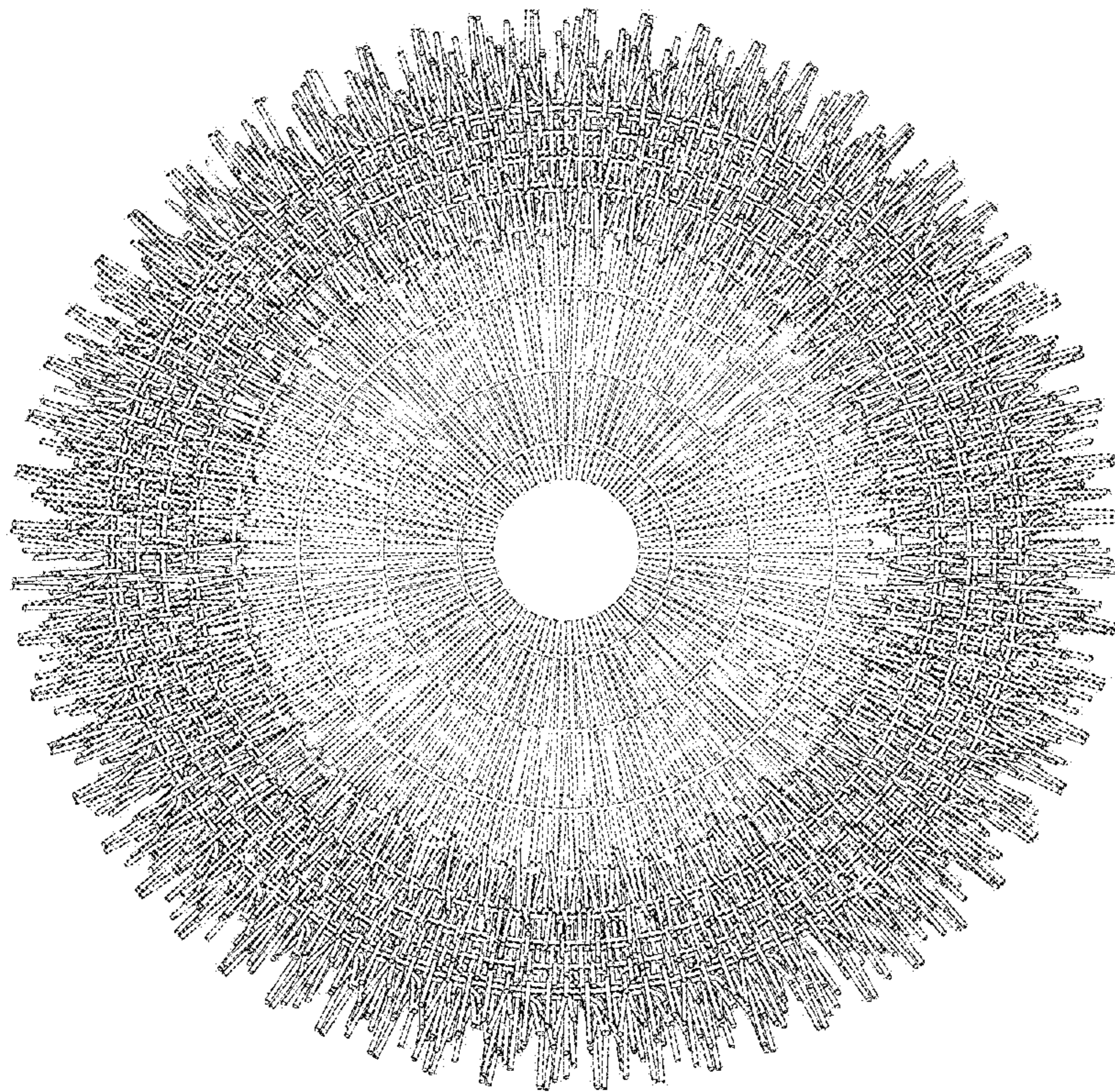
