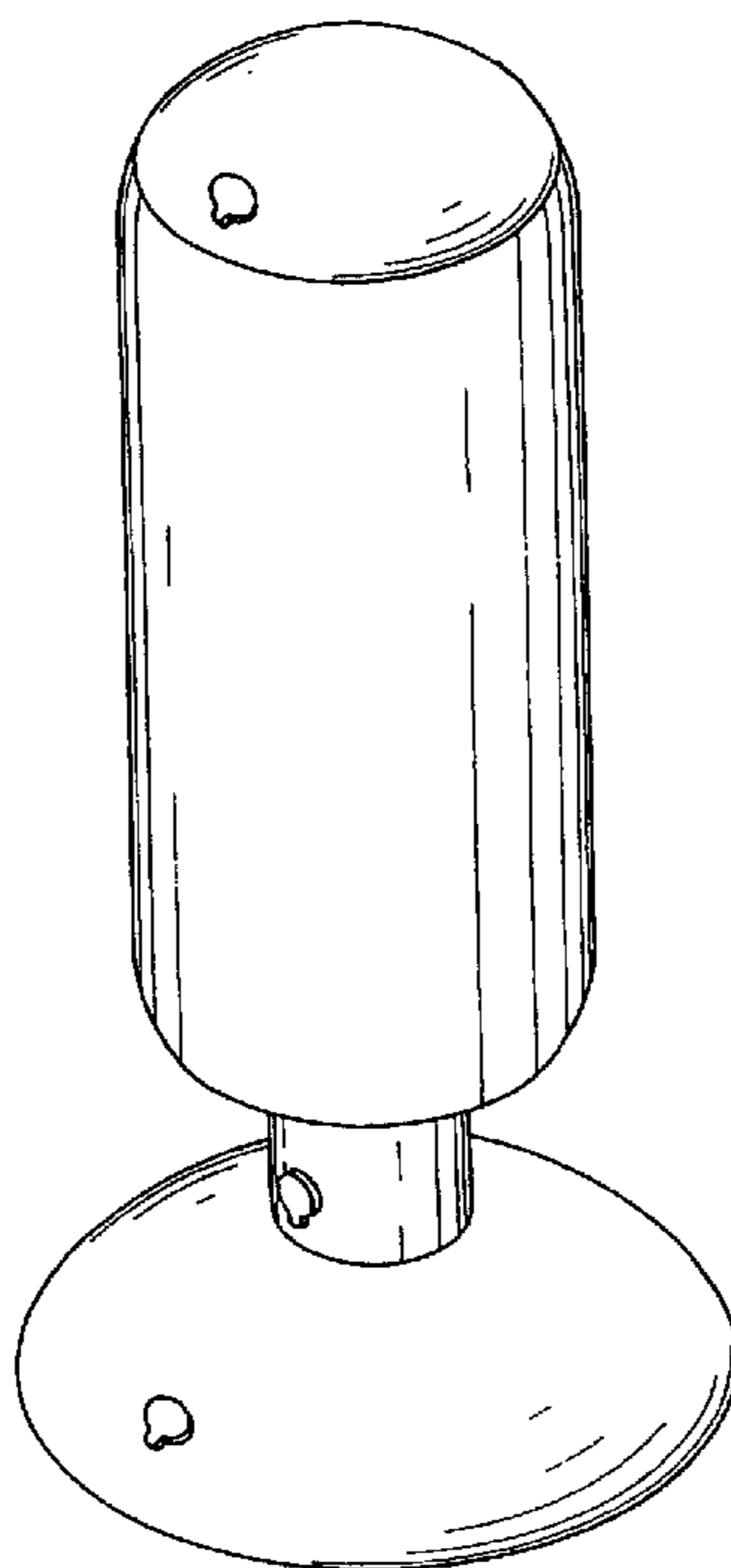
The ornamental design for a punching bag, as shown and described.

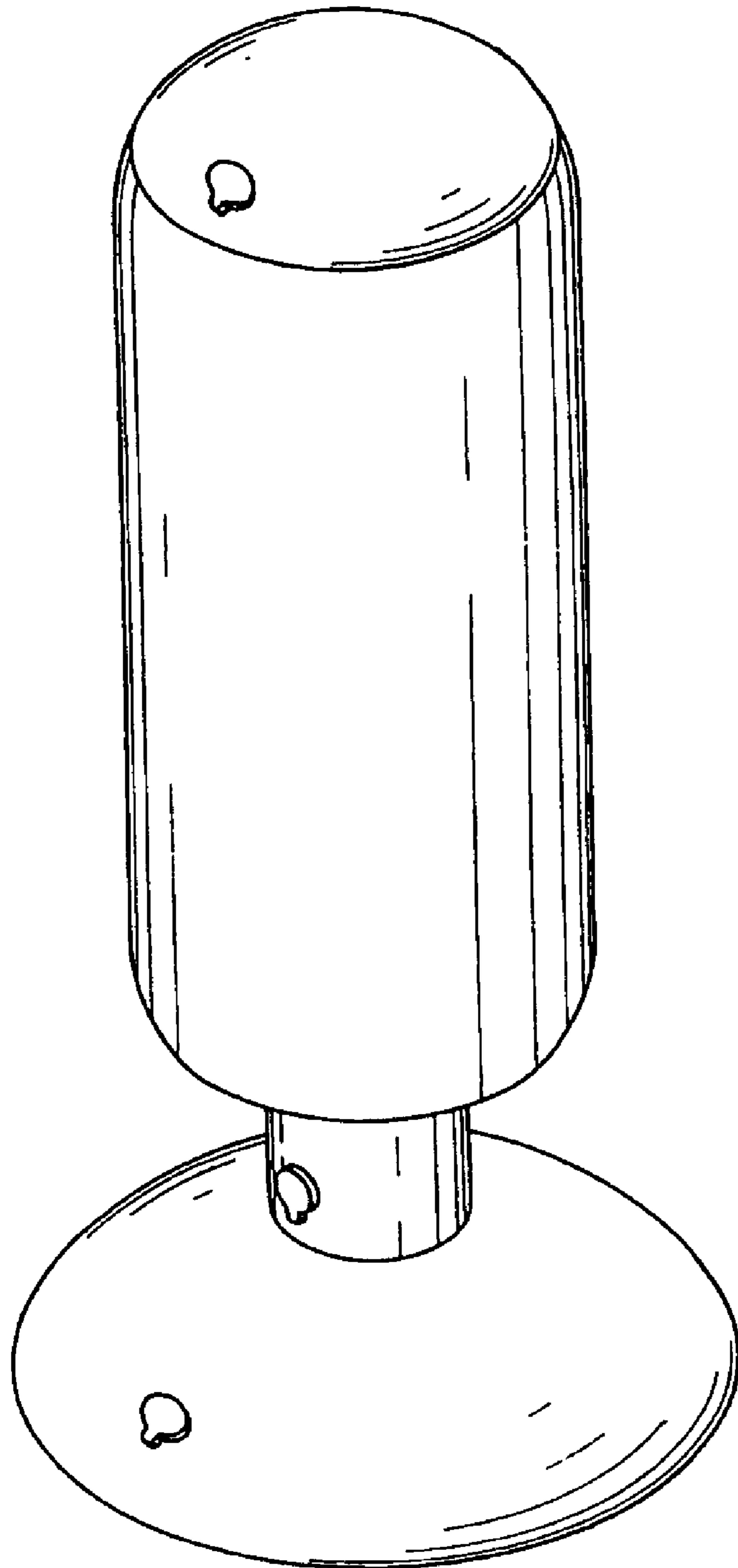

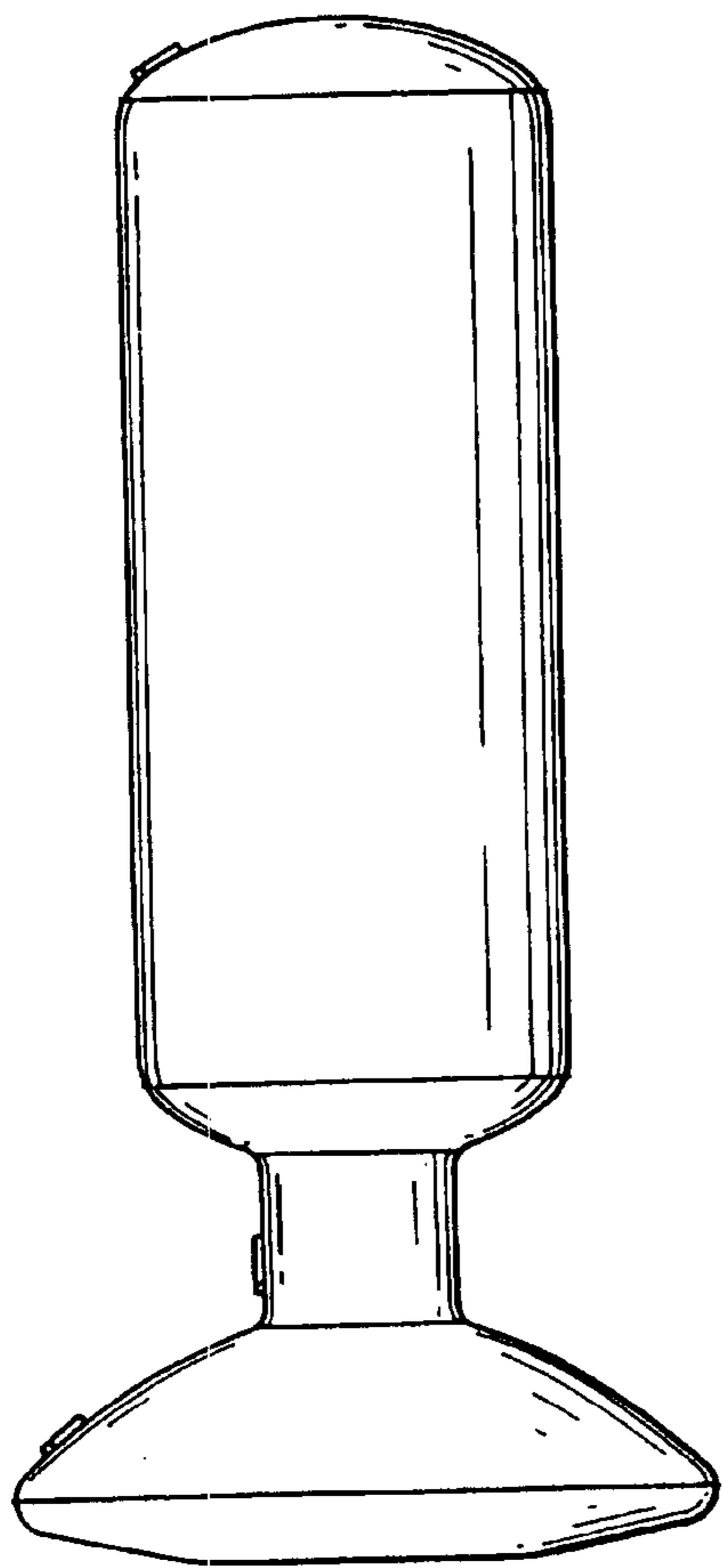

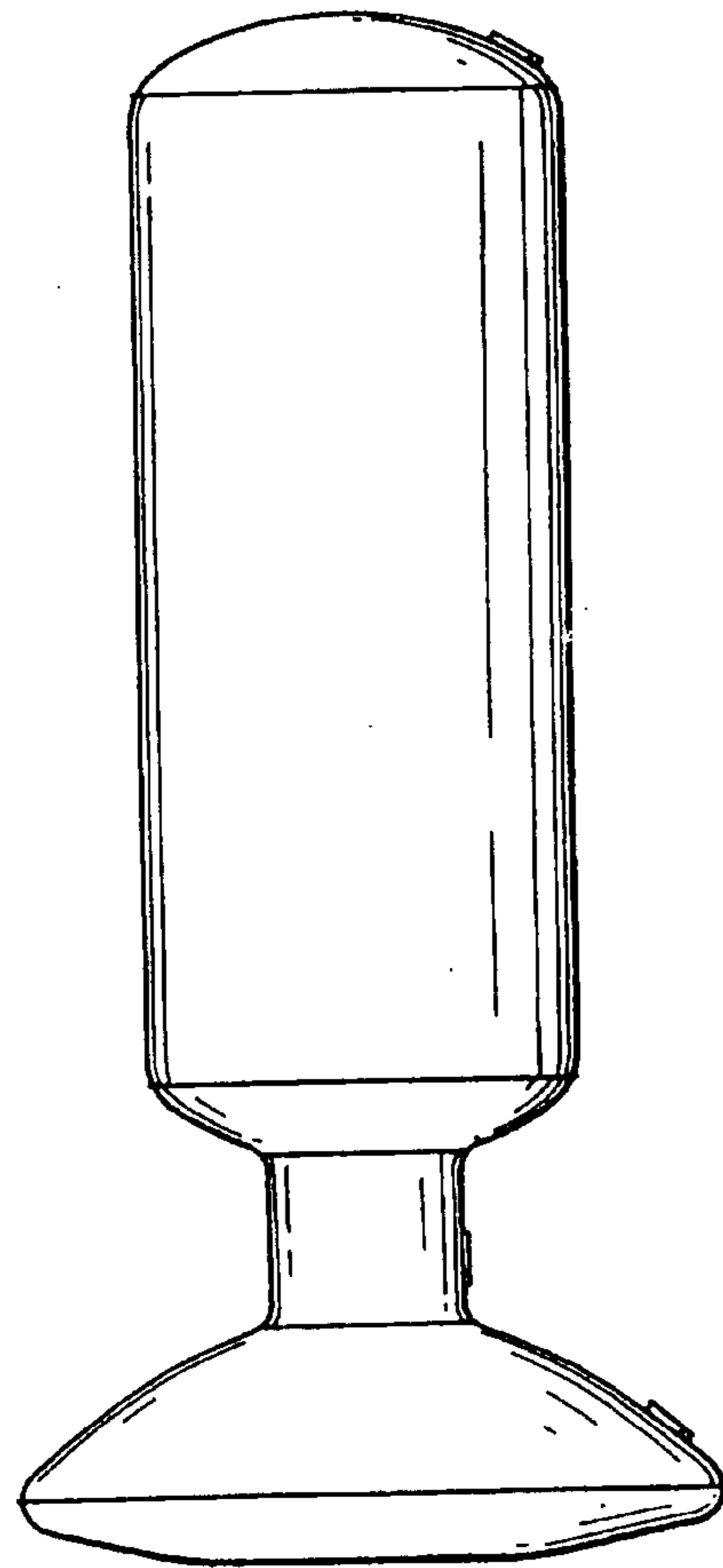

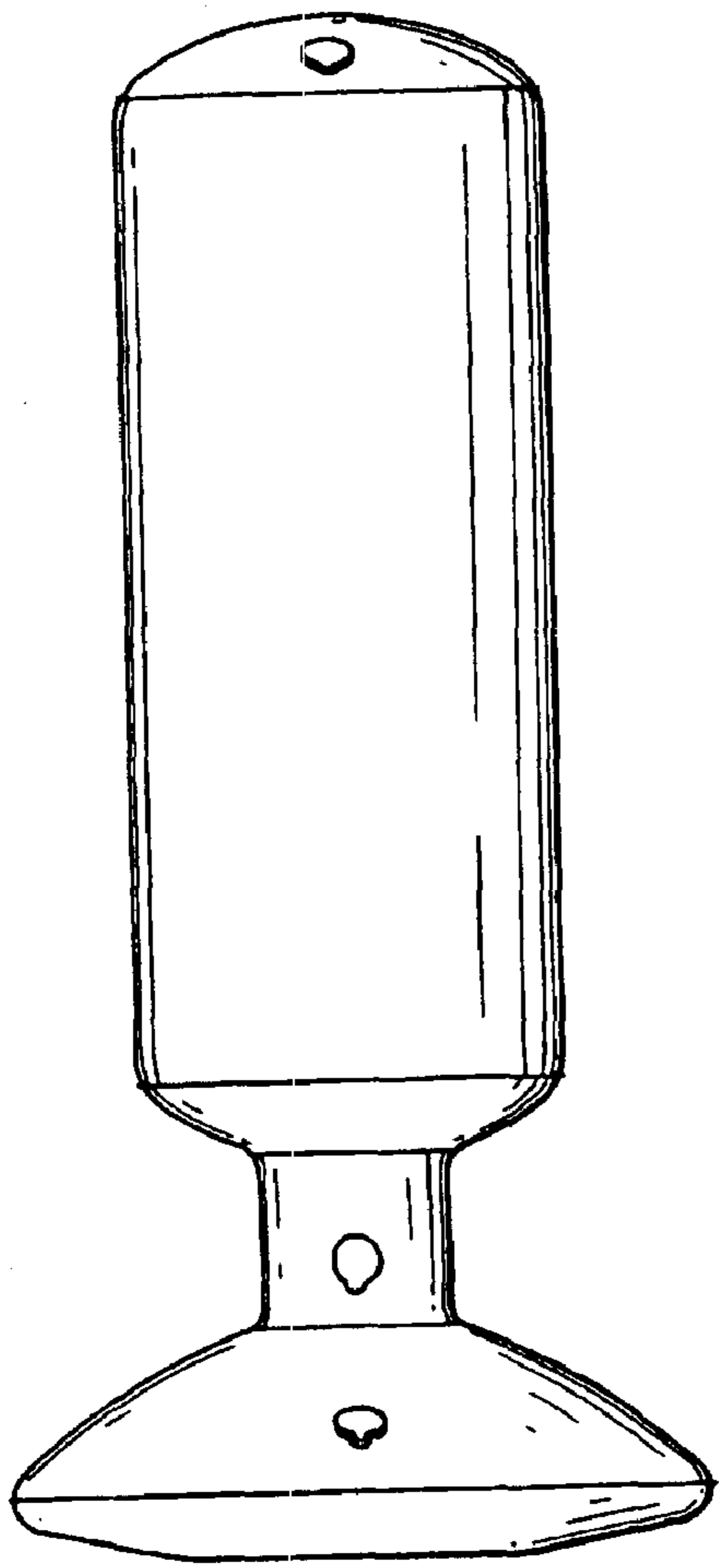

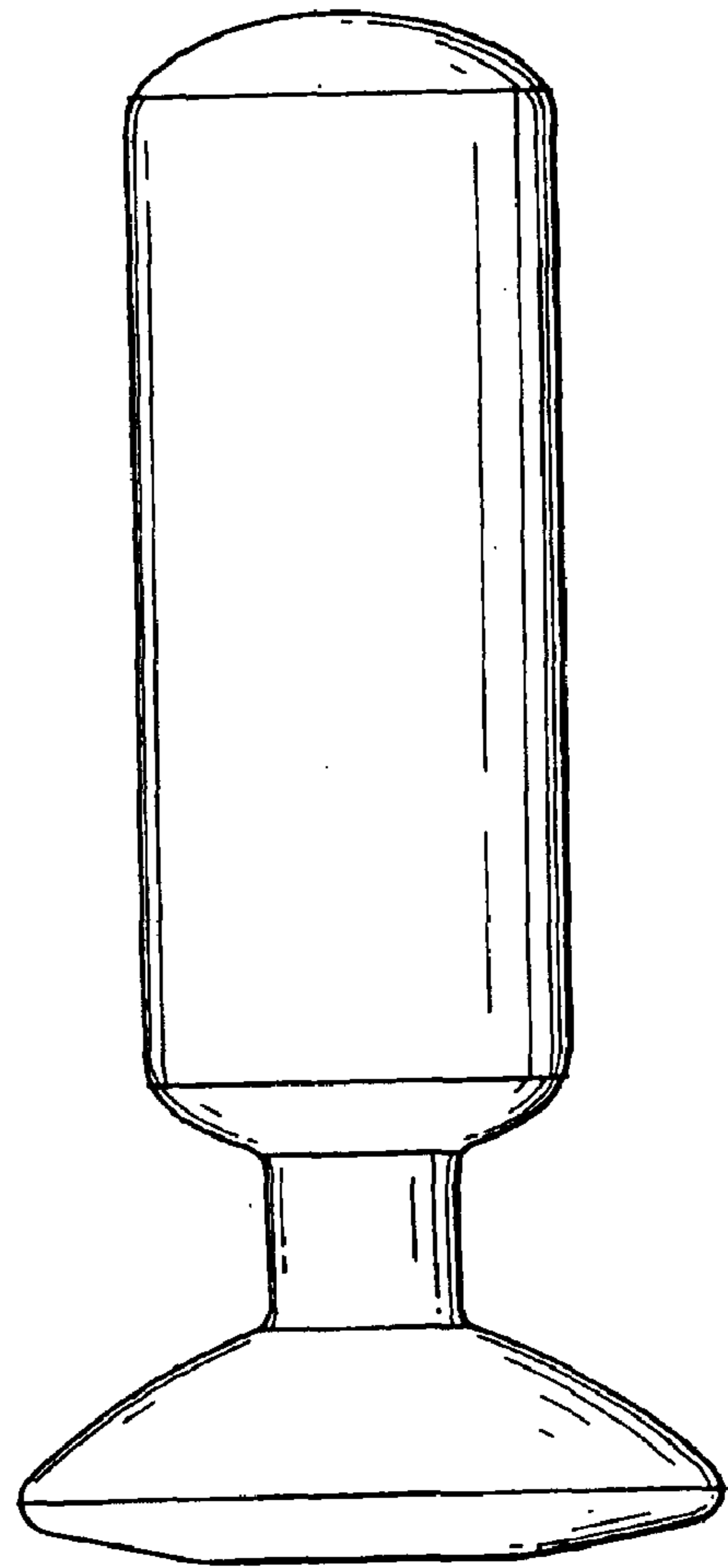

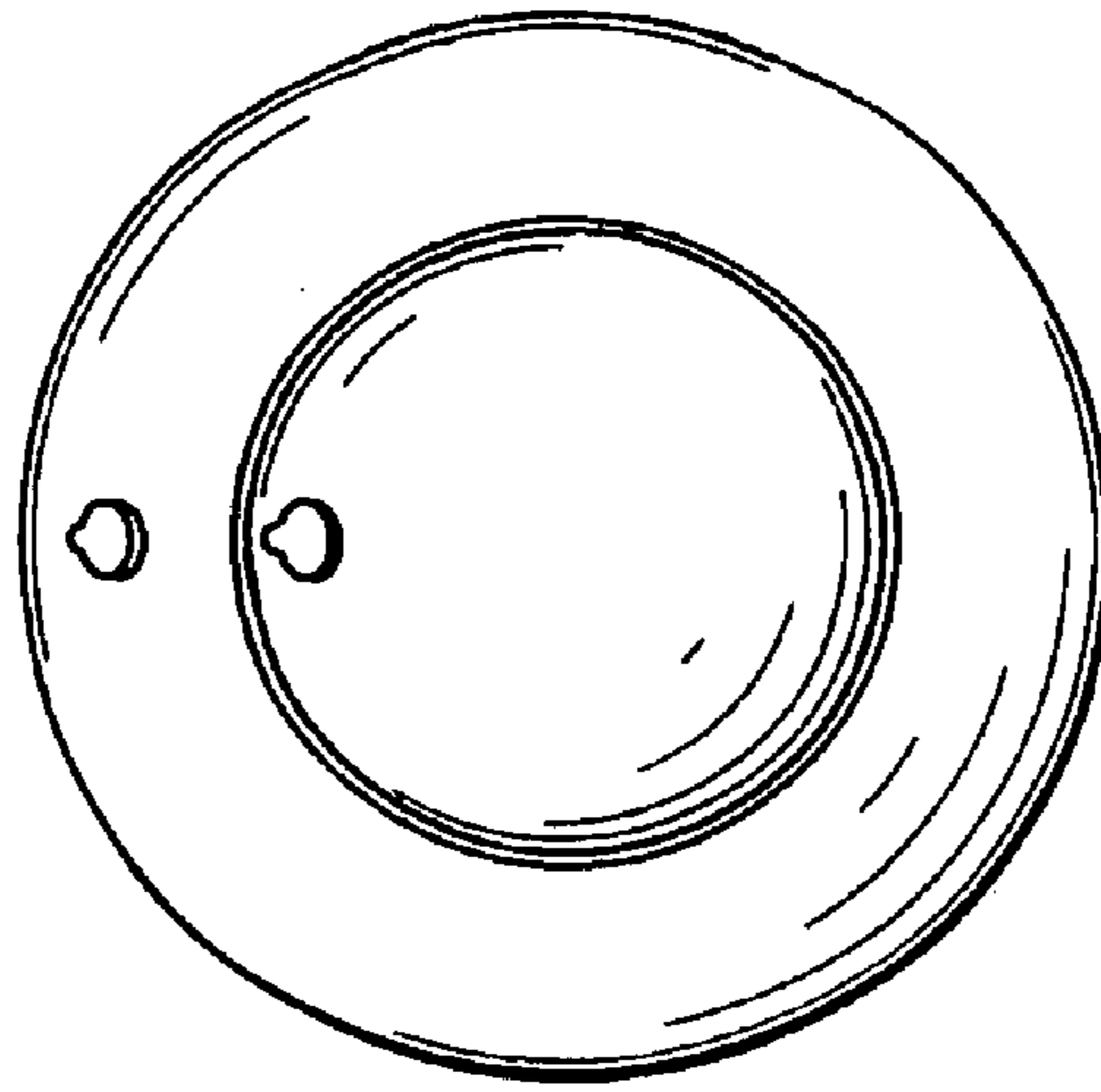

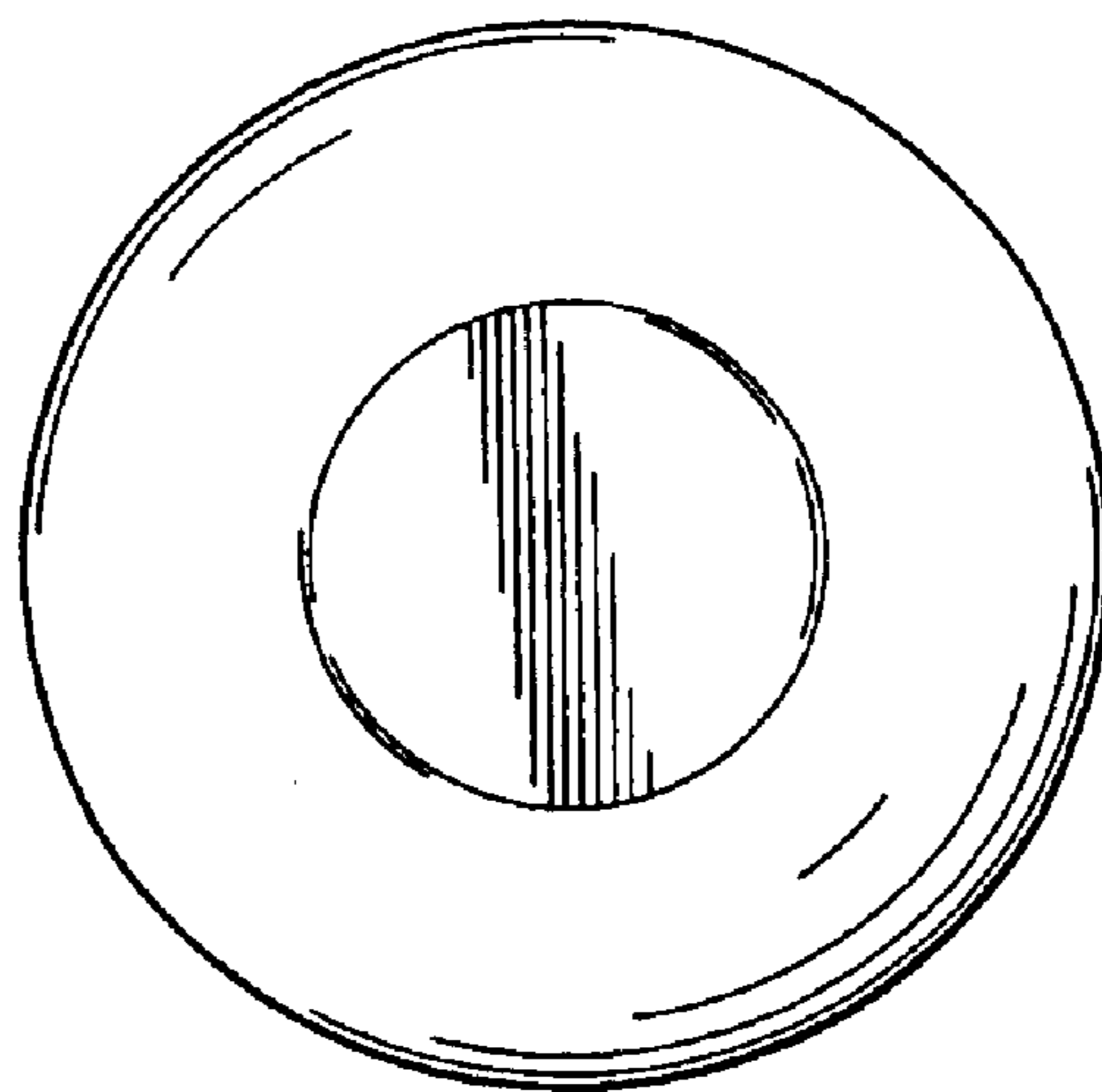
