In addition, for clarity, the stitching on the unclaimed subject matter is shown in lines of dot-dash-dot-dash. The stitching on the claimed subject matter is shown by dotted lines.

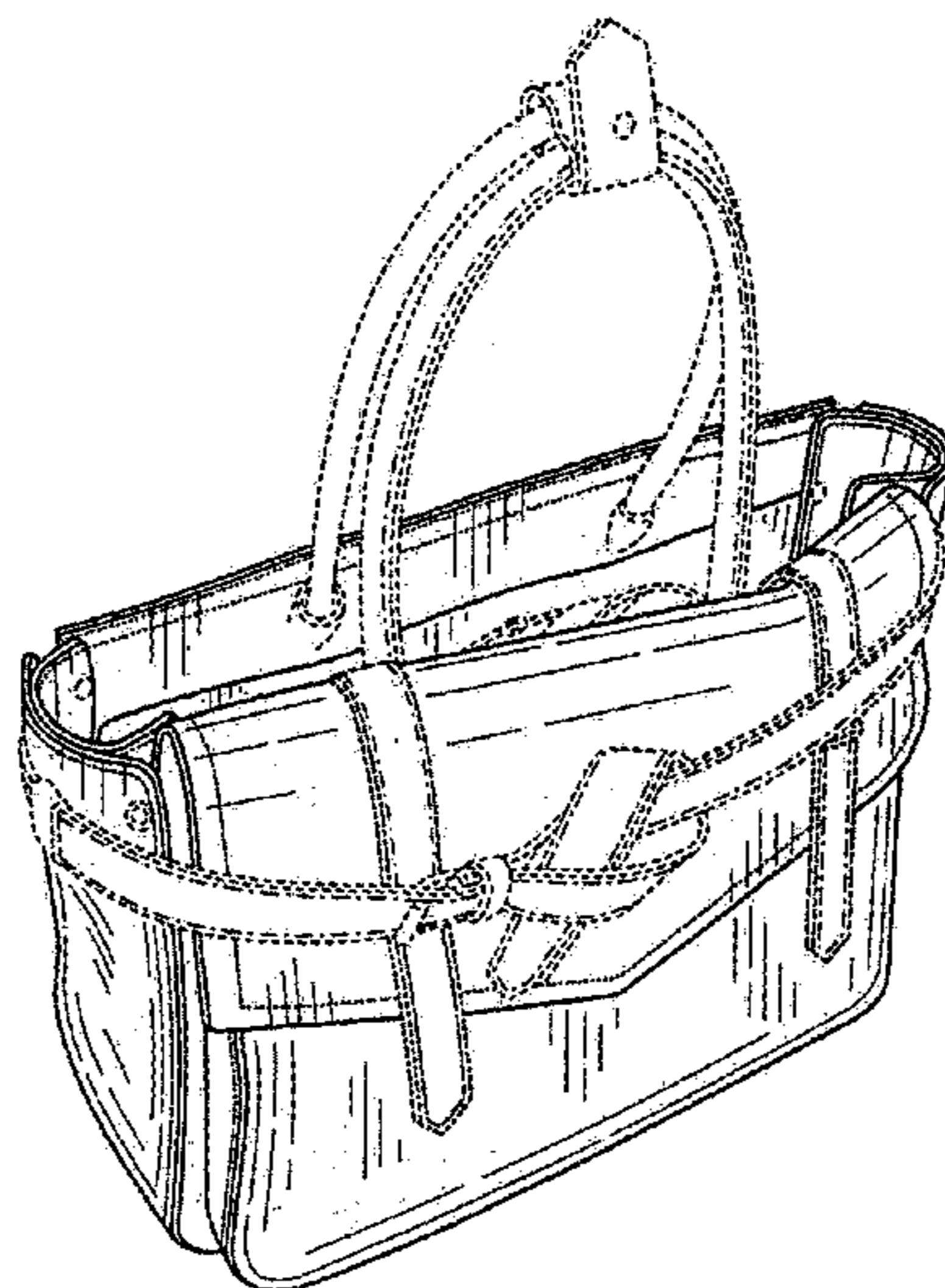

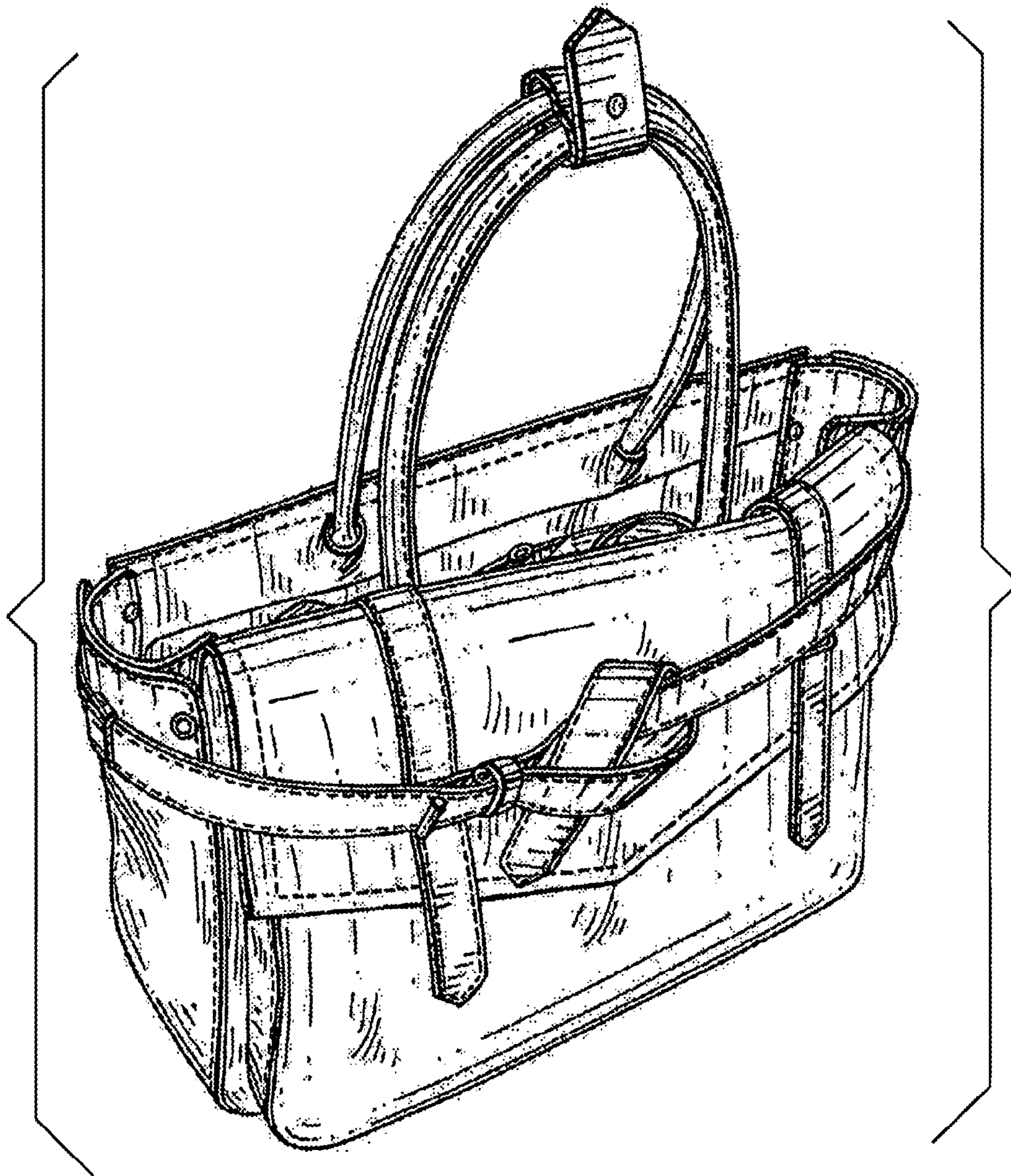

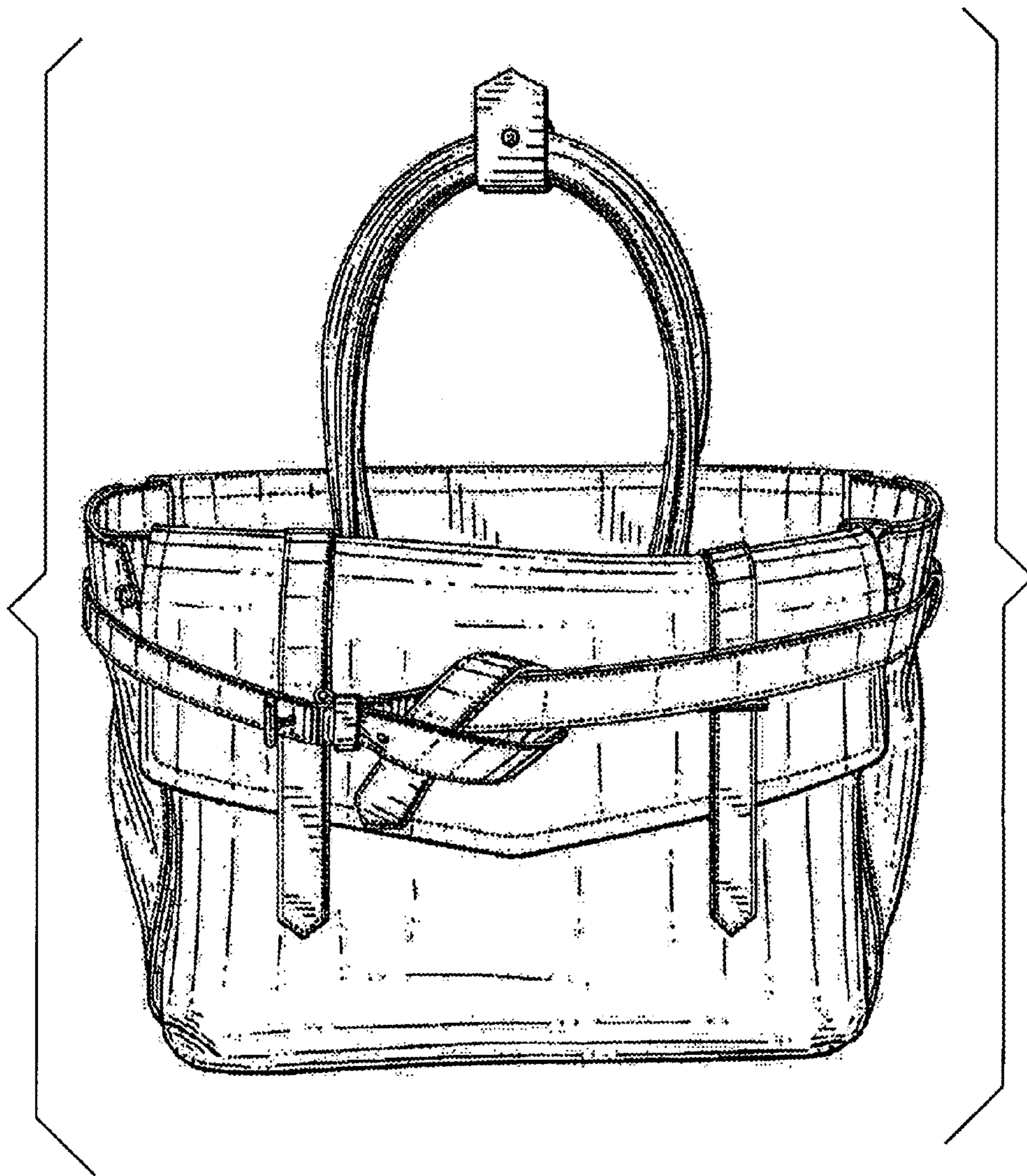

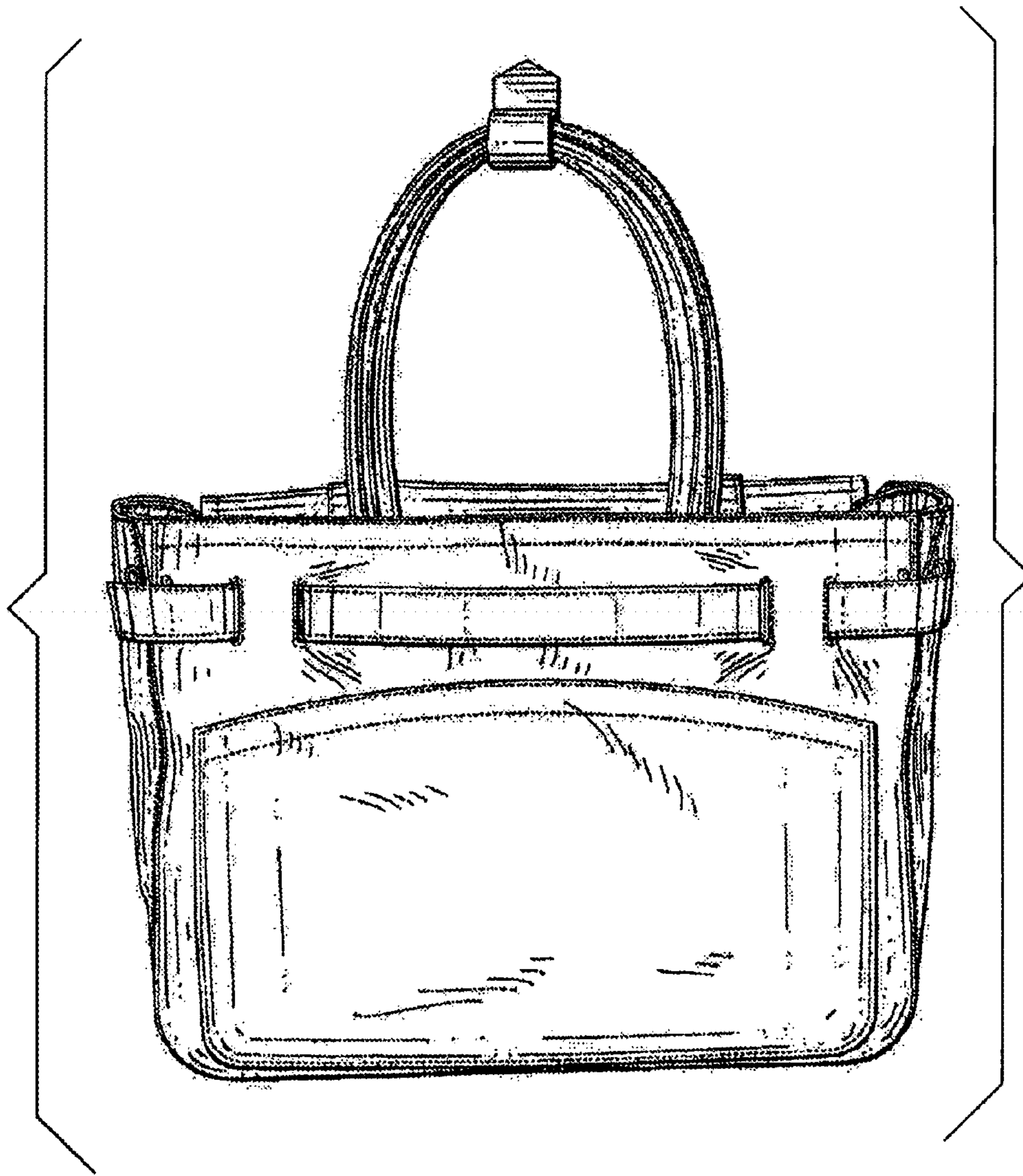

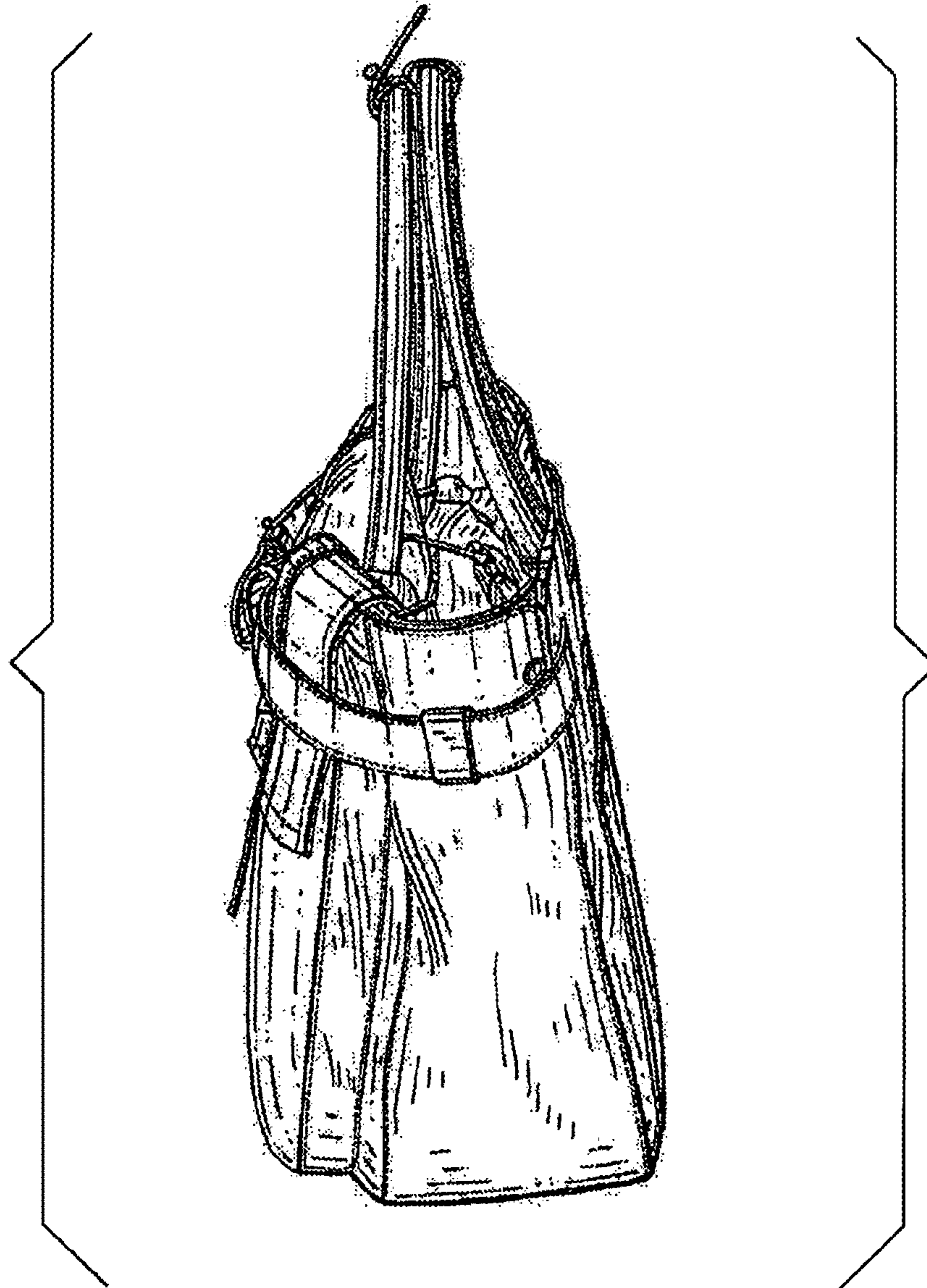

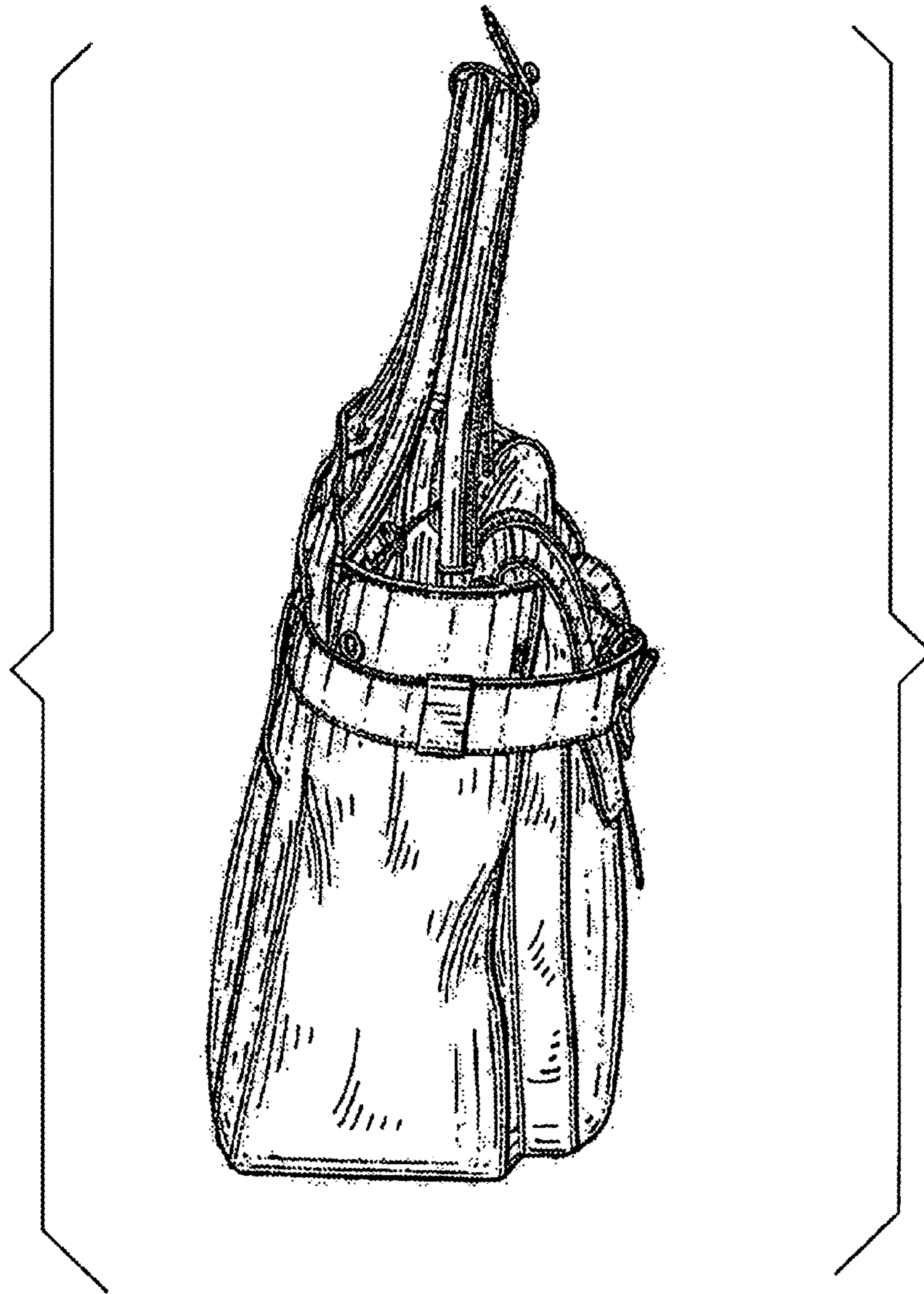

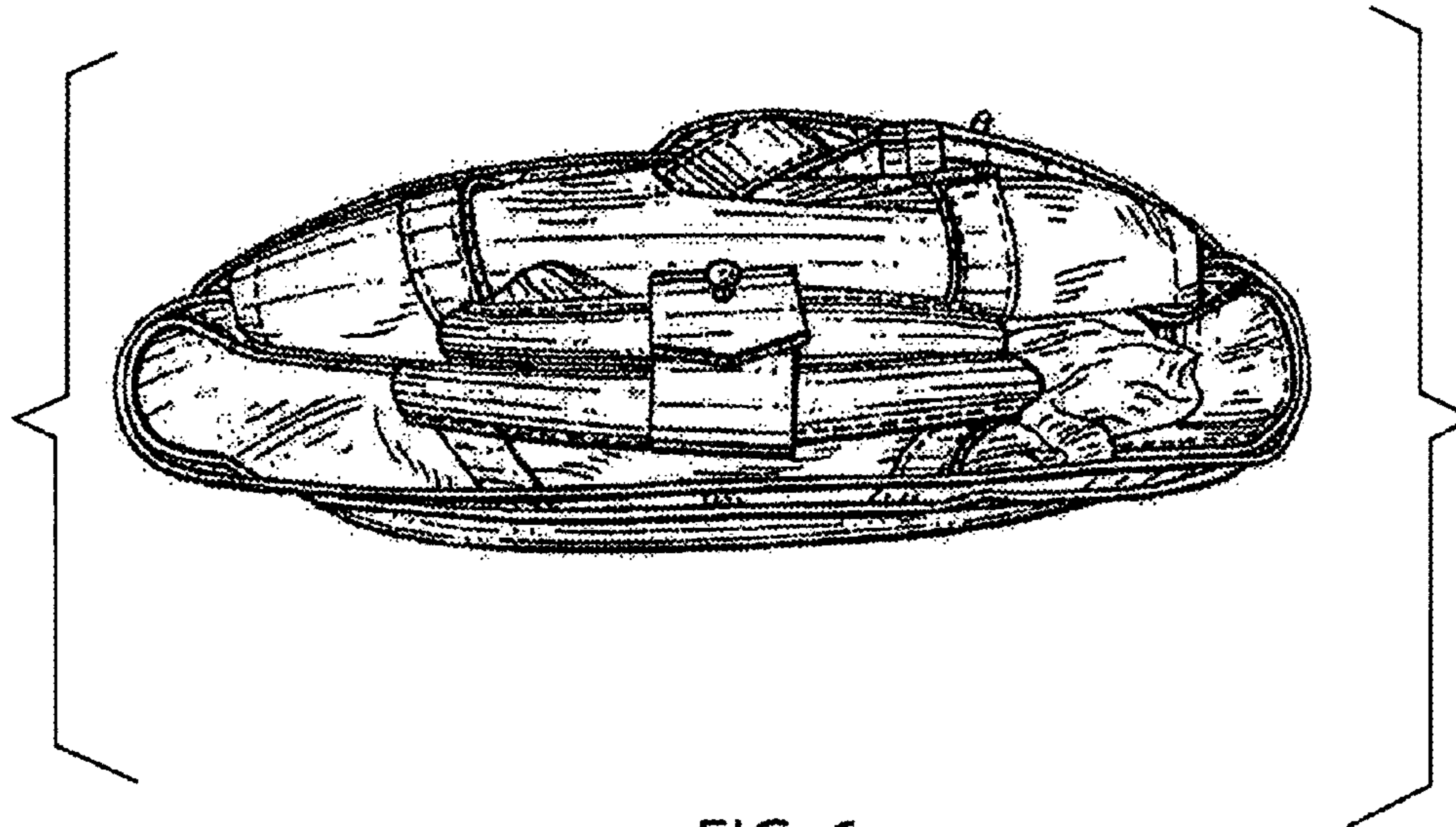

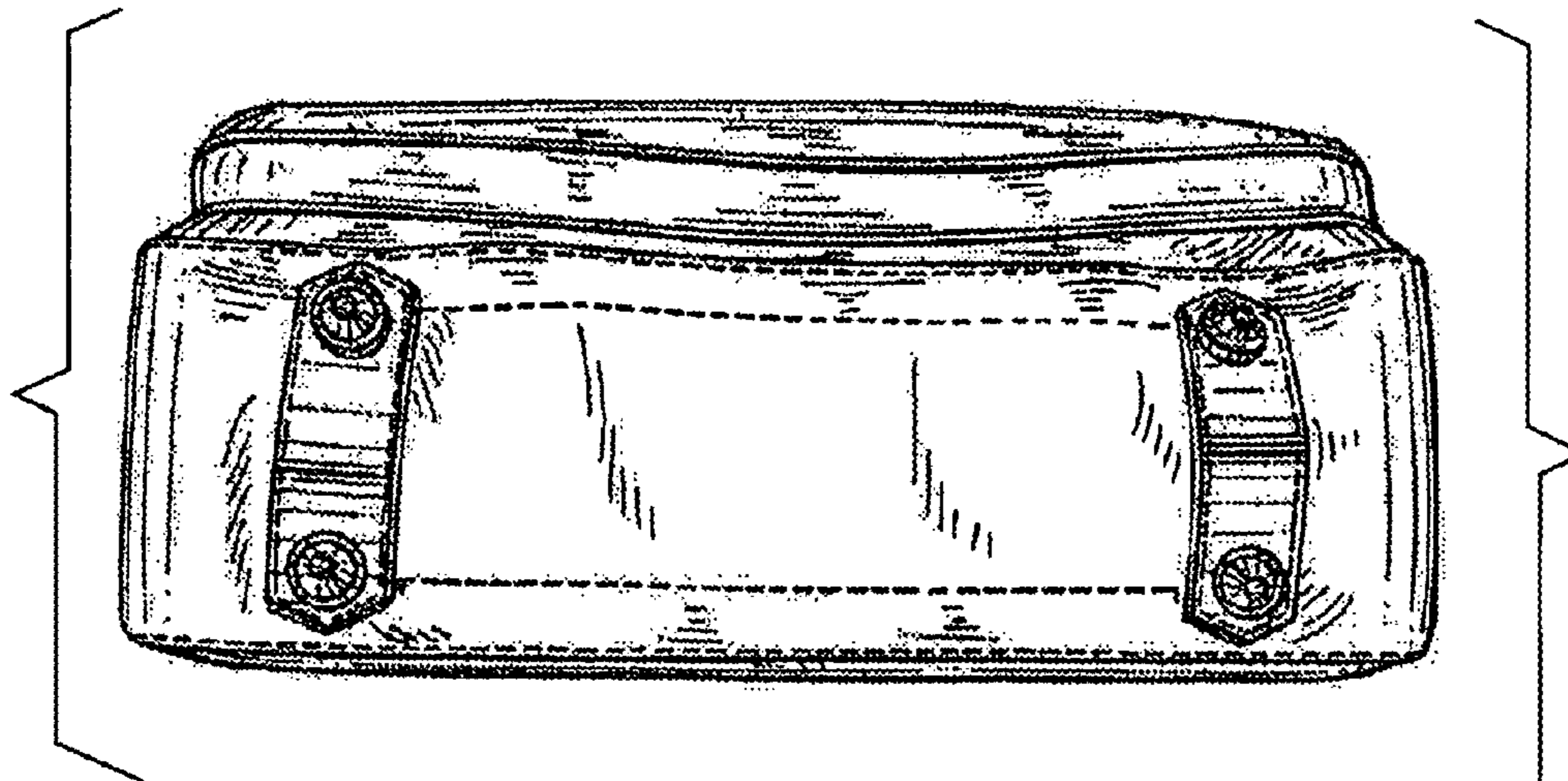

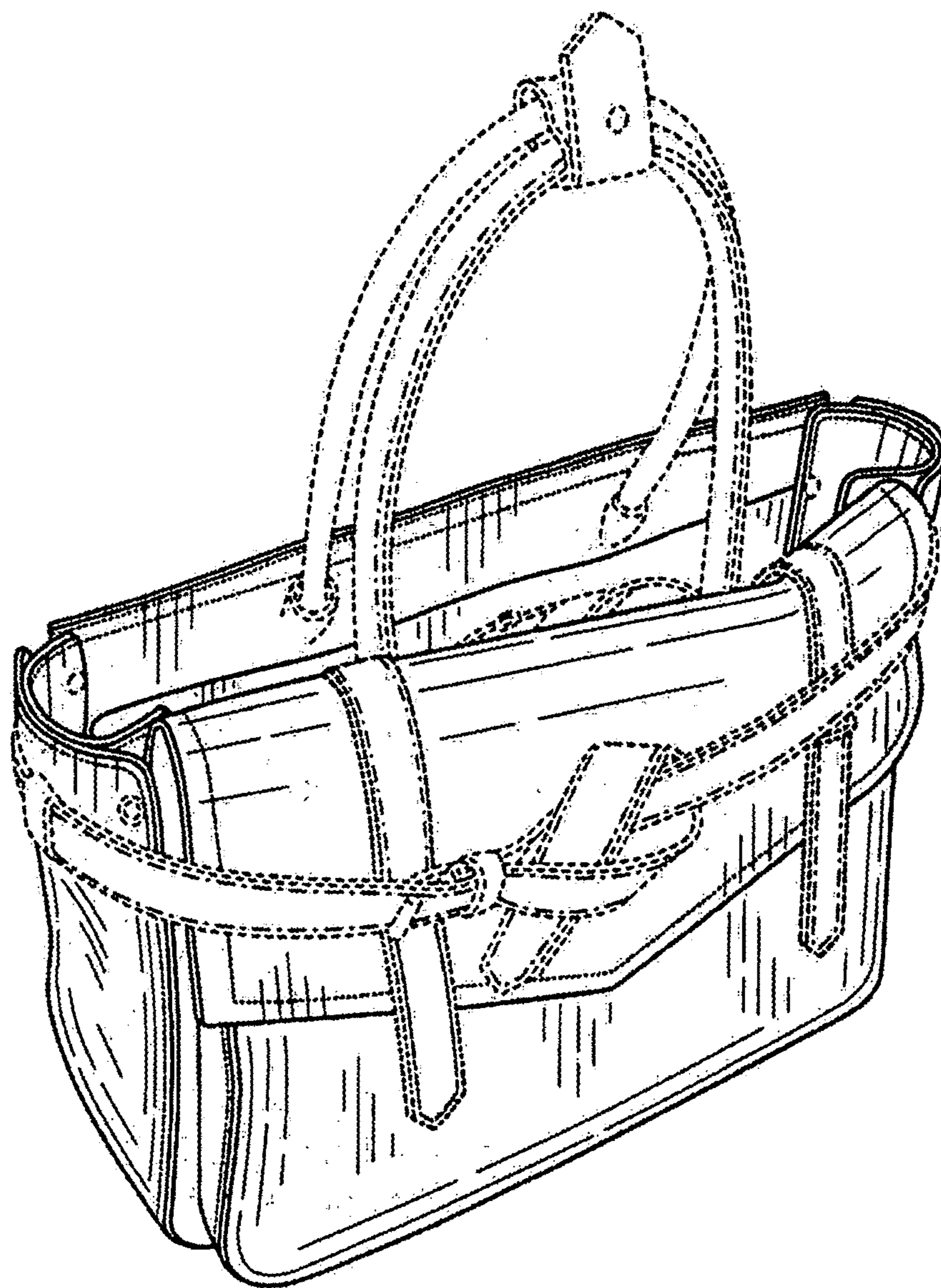

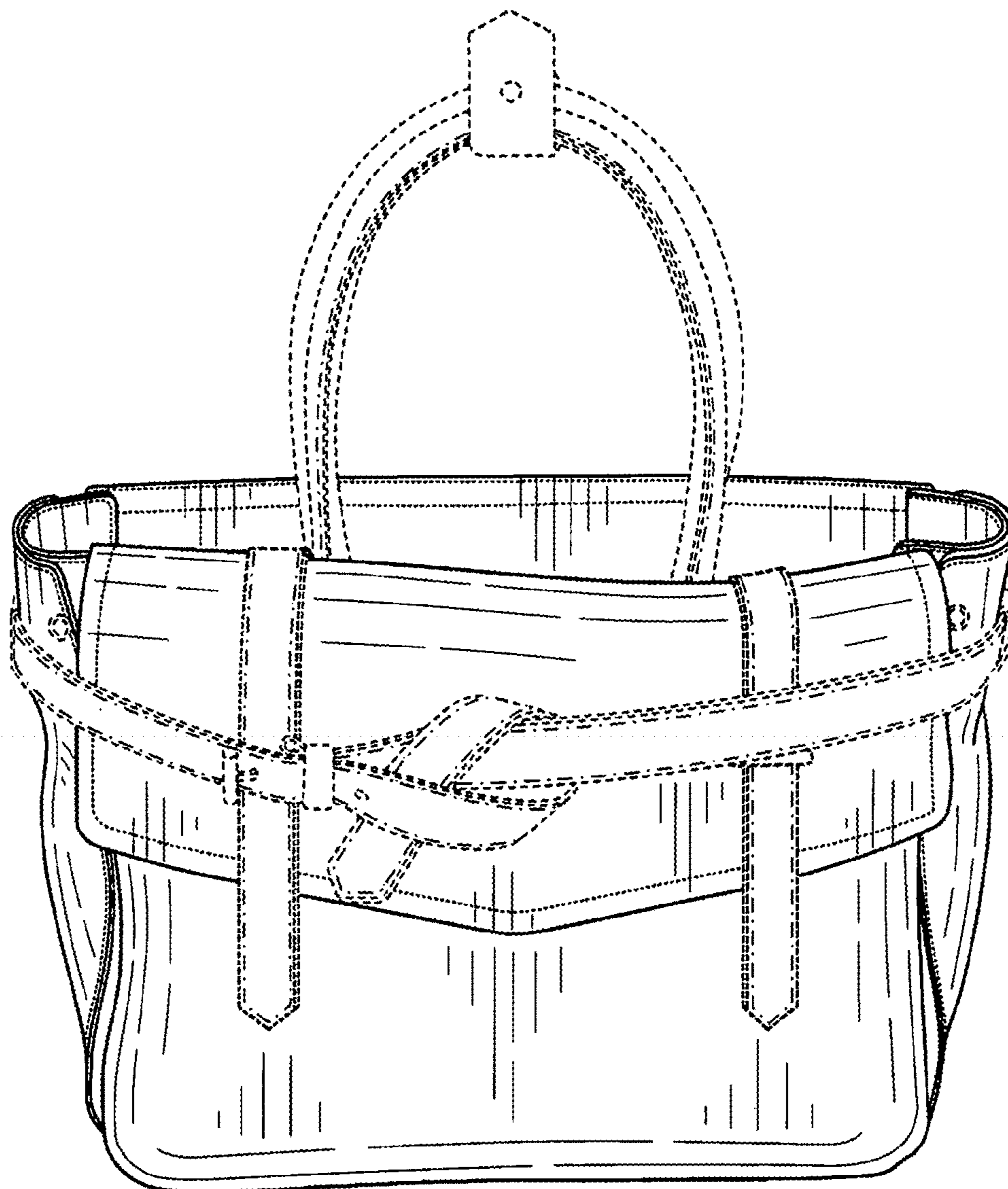

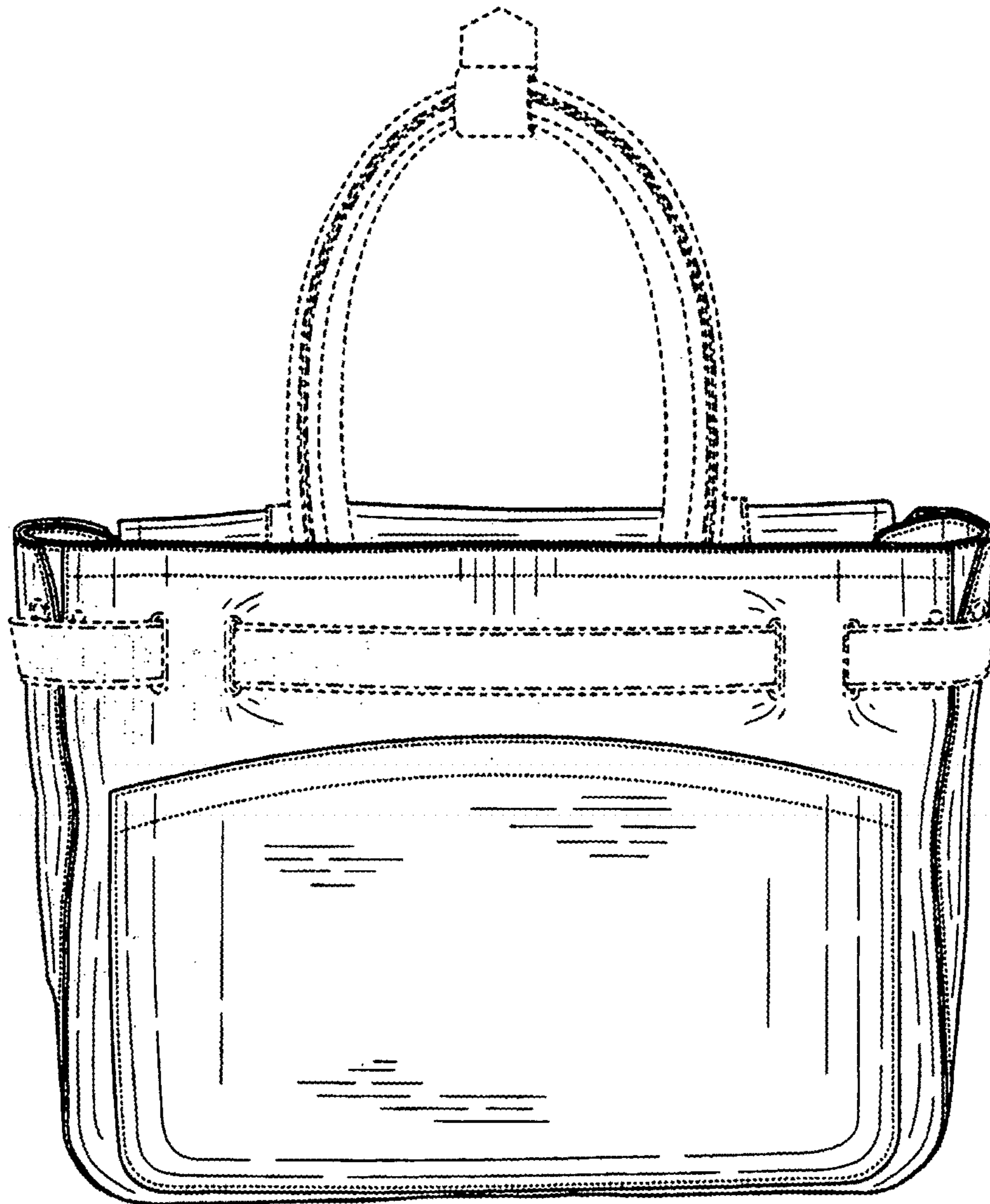

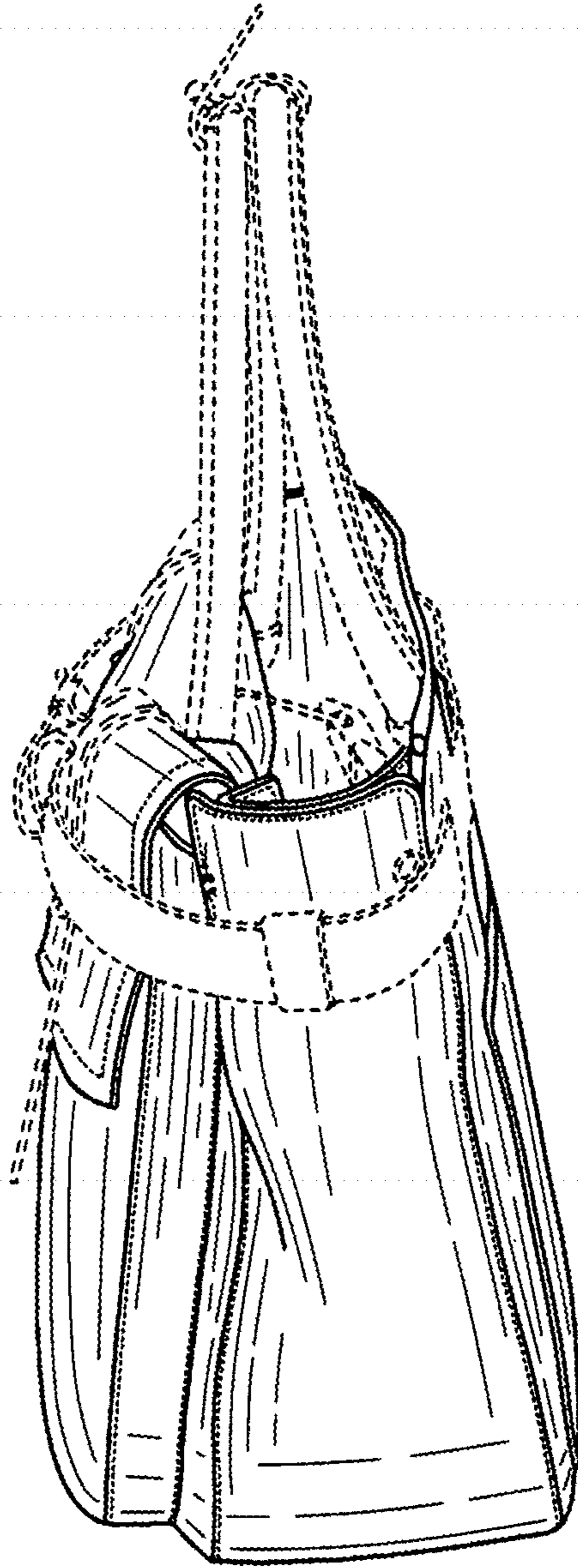

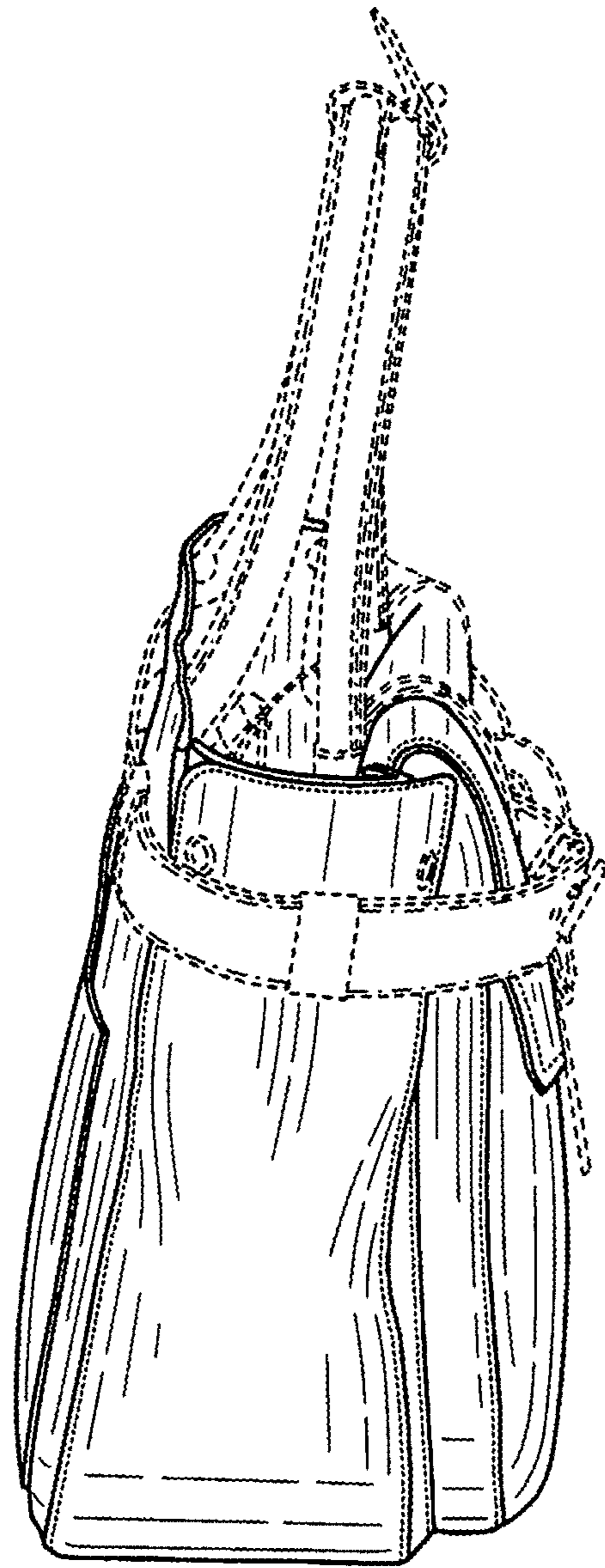

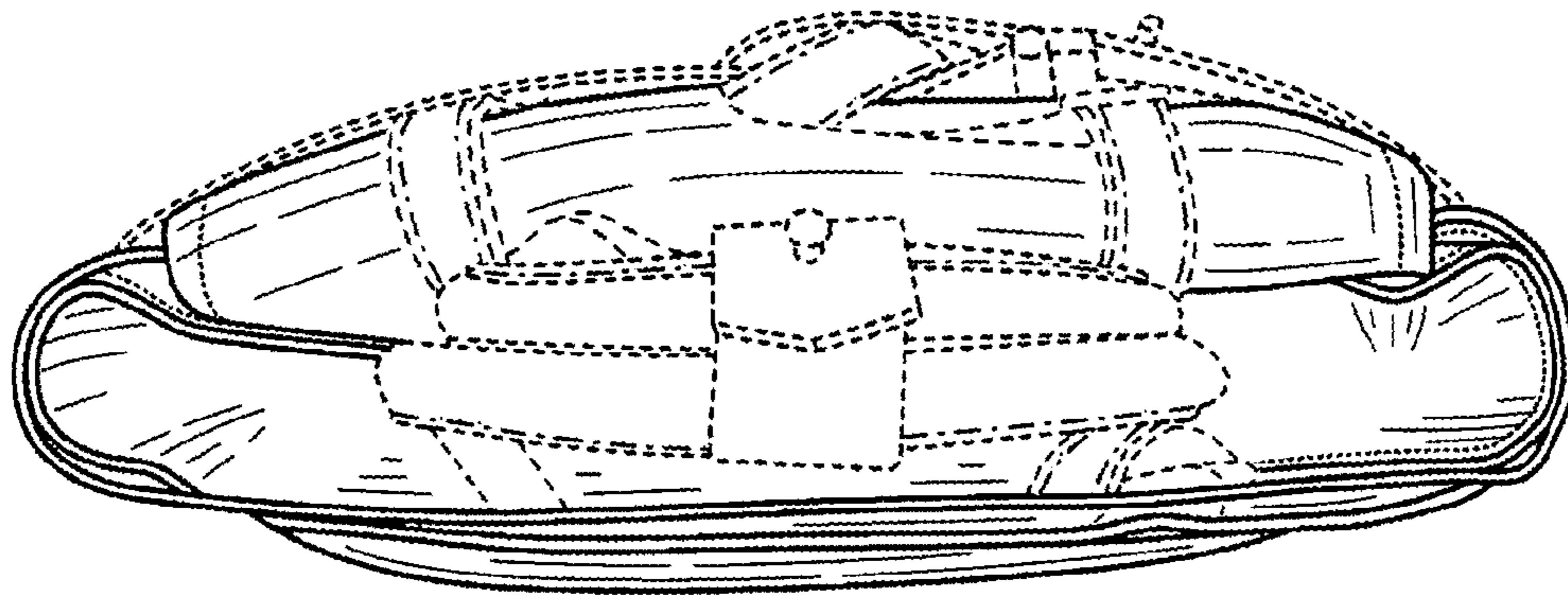

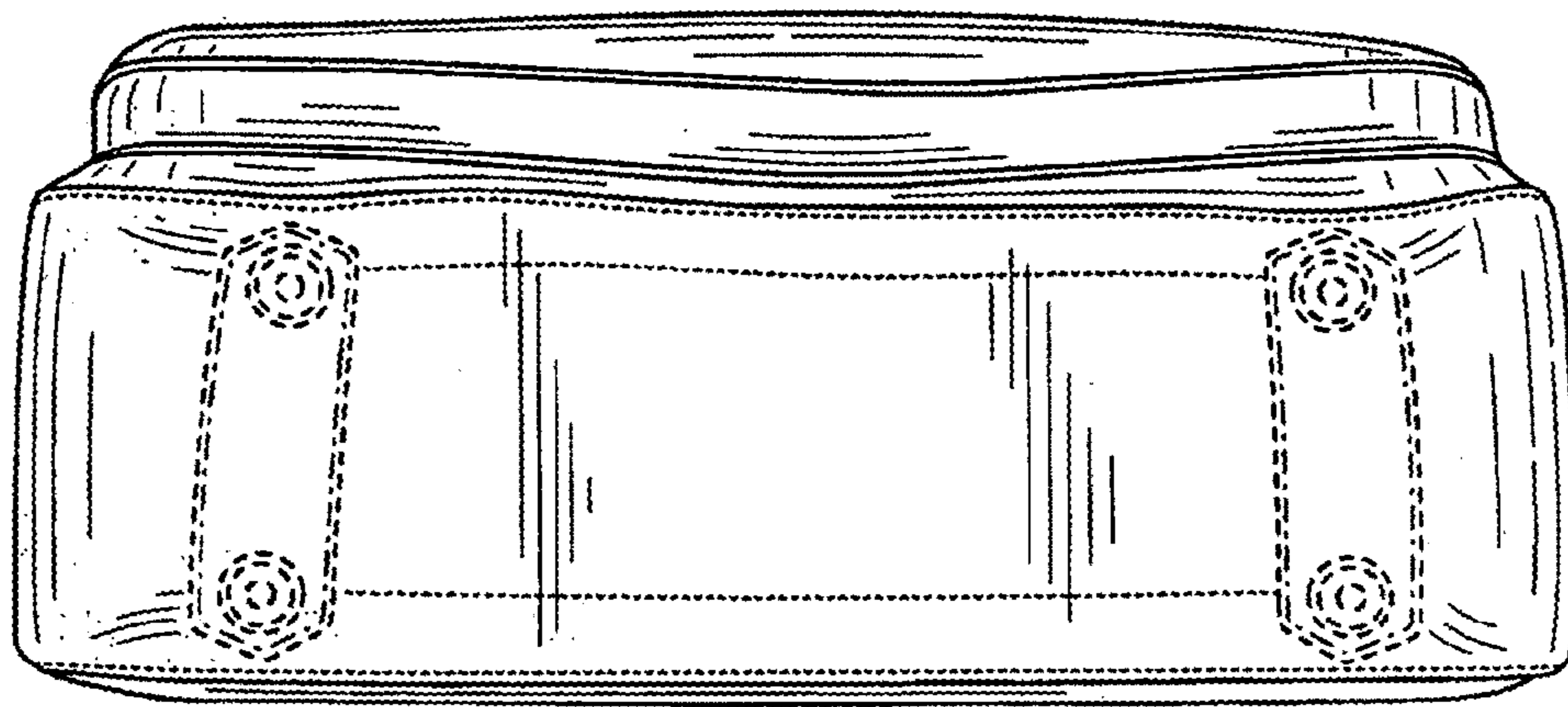
