(57) **CLAIM**

The ornamental design for a [set of] cart basket[s], as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of the first embodiment for a [set of] cart [baskets] *basket* showing my new design.

FIG. 2 is a side elevation view of the right and left sides, which are mirror images, of FIG. 1.

FIG. 3 is a front side elevation view of FIG. 1.

FIG. 4 is back side elevation view of FIG. 1.

FIG. 5 is a top plan view of FIG. 1.

FIG. 6 is a bottom plan view of FIG. 1.

FIG. 7 is a front perspective view of the second embodiment for a [set of] cart [baskets] *basket* showing my new design.

FIG. 9 is a front side elevation view of FIG. 7.

FIG. 10 is back side elevation view of FIG. 7.

FIG. 16 is back side elevation view of FIG. 13.

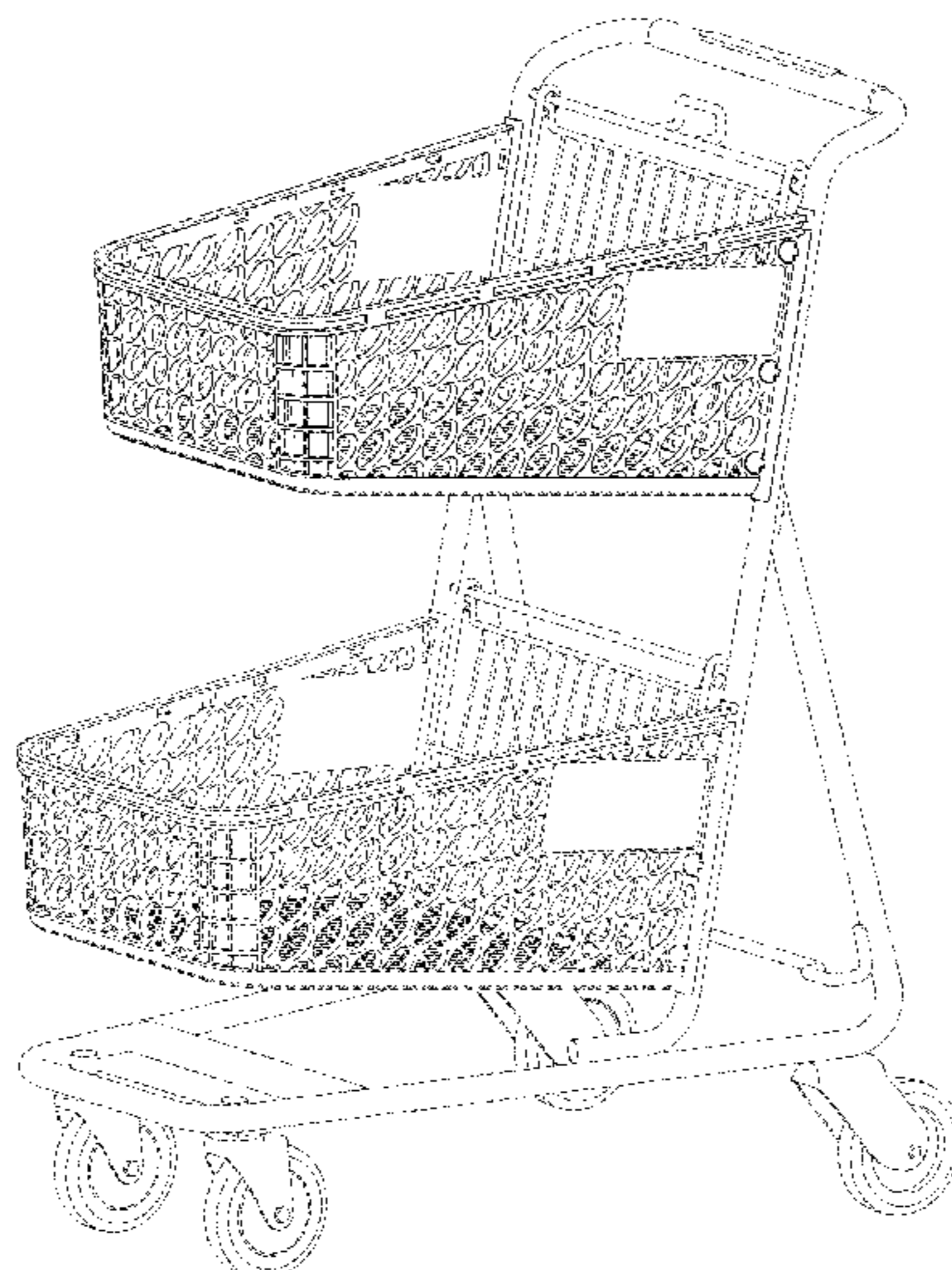
FIG. 17 is a top plan view of FIG. 13; and,

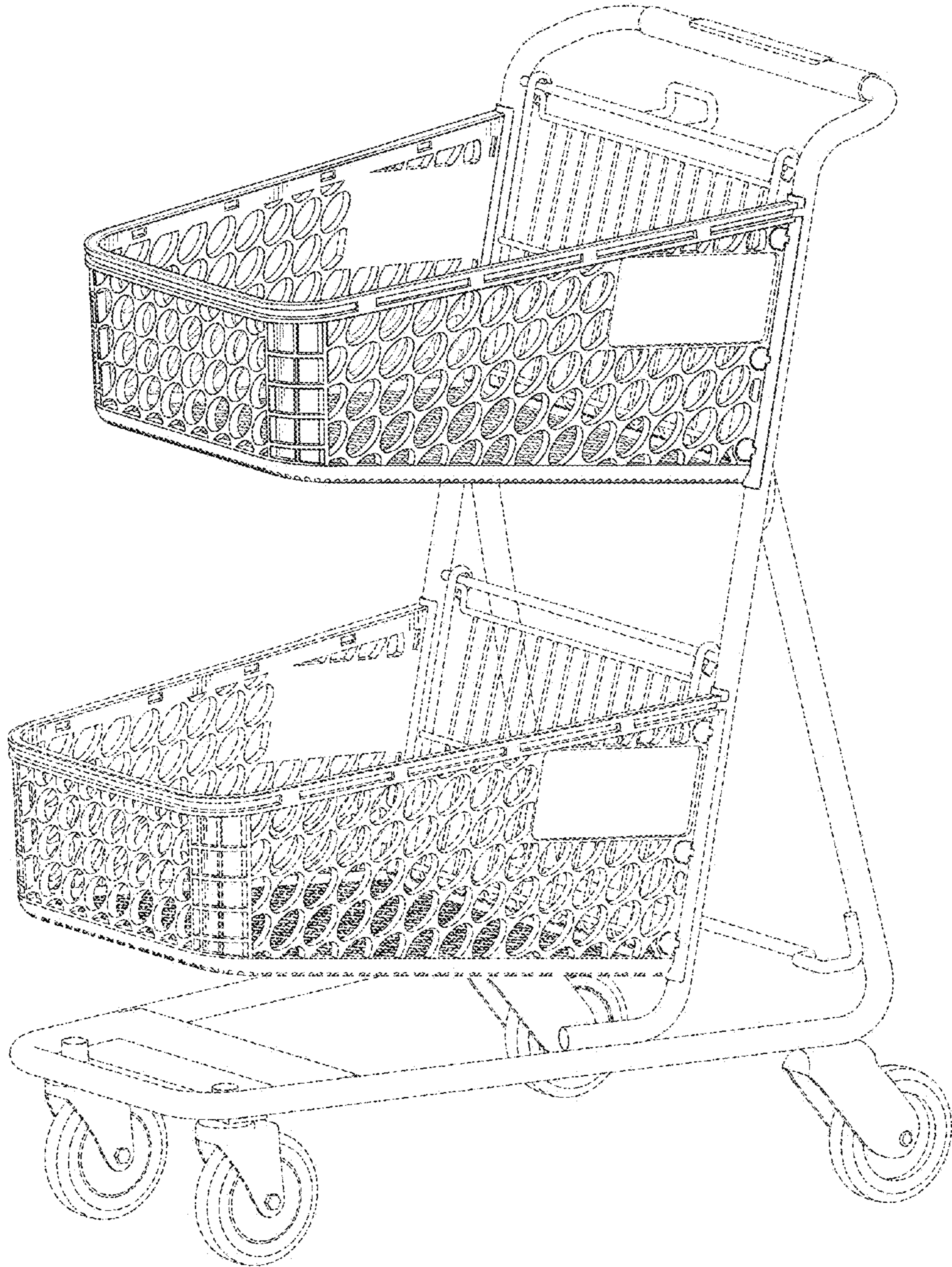

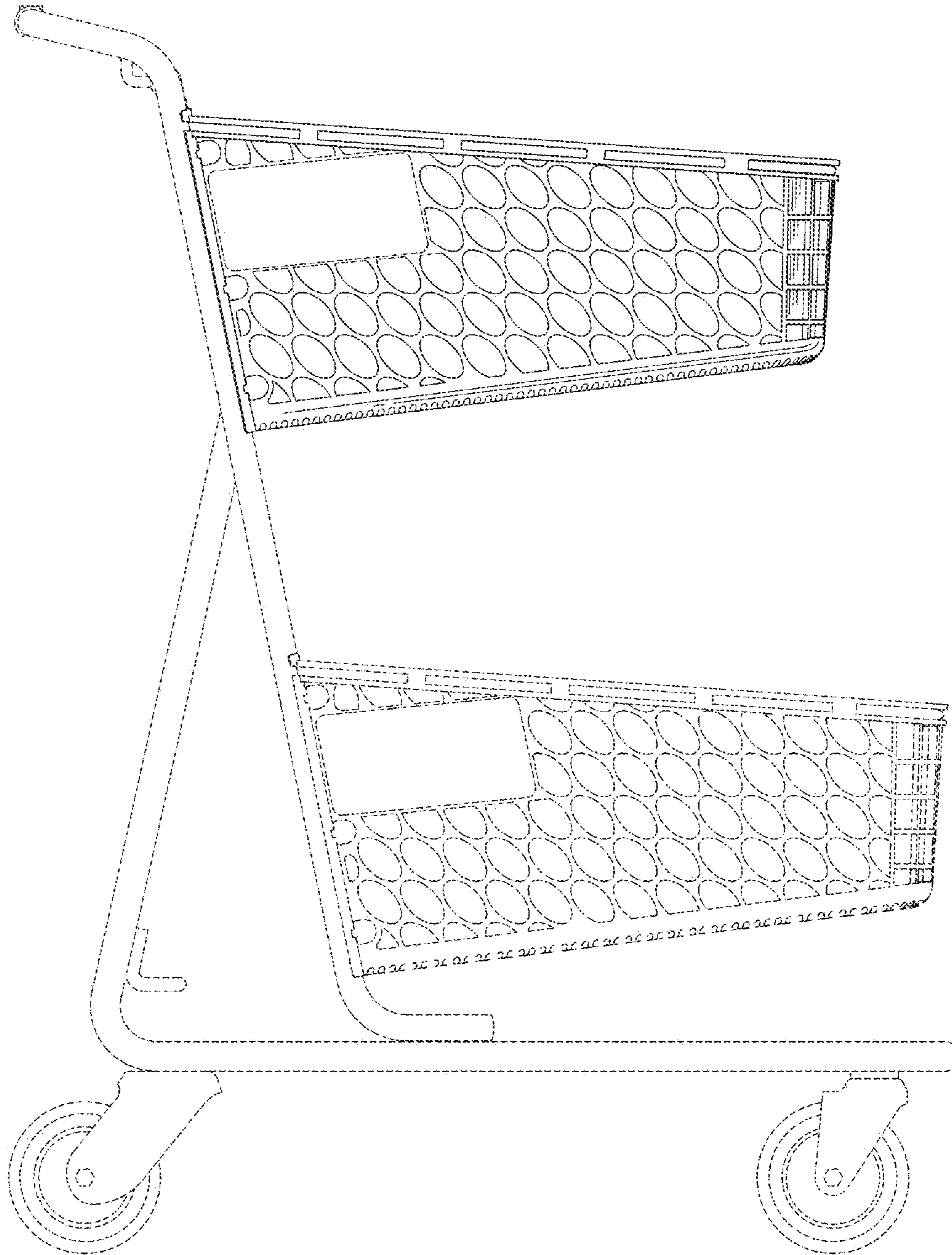

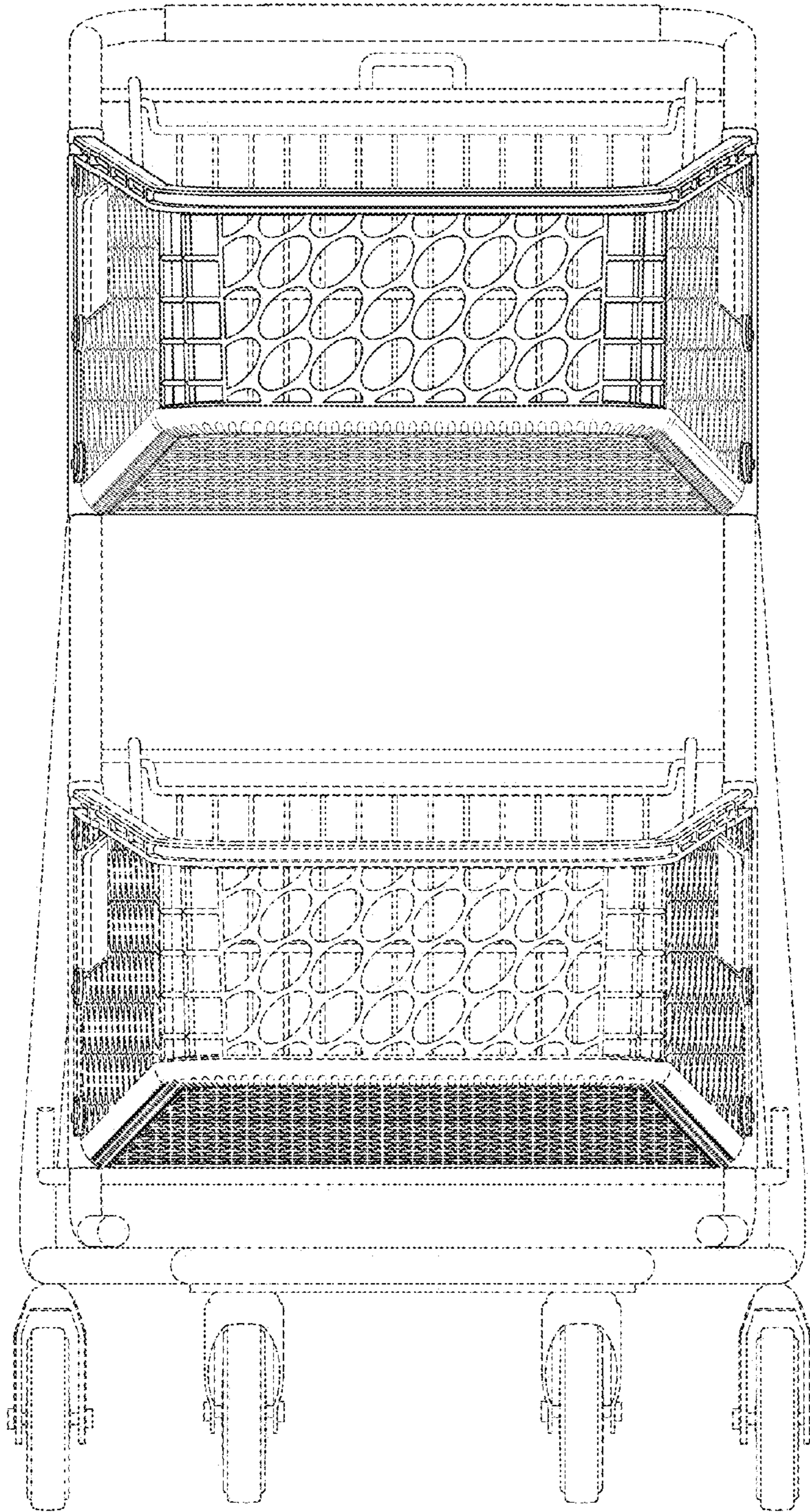

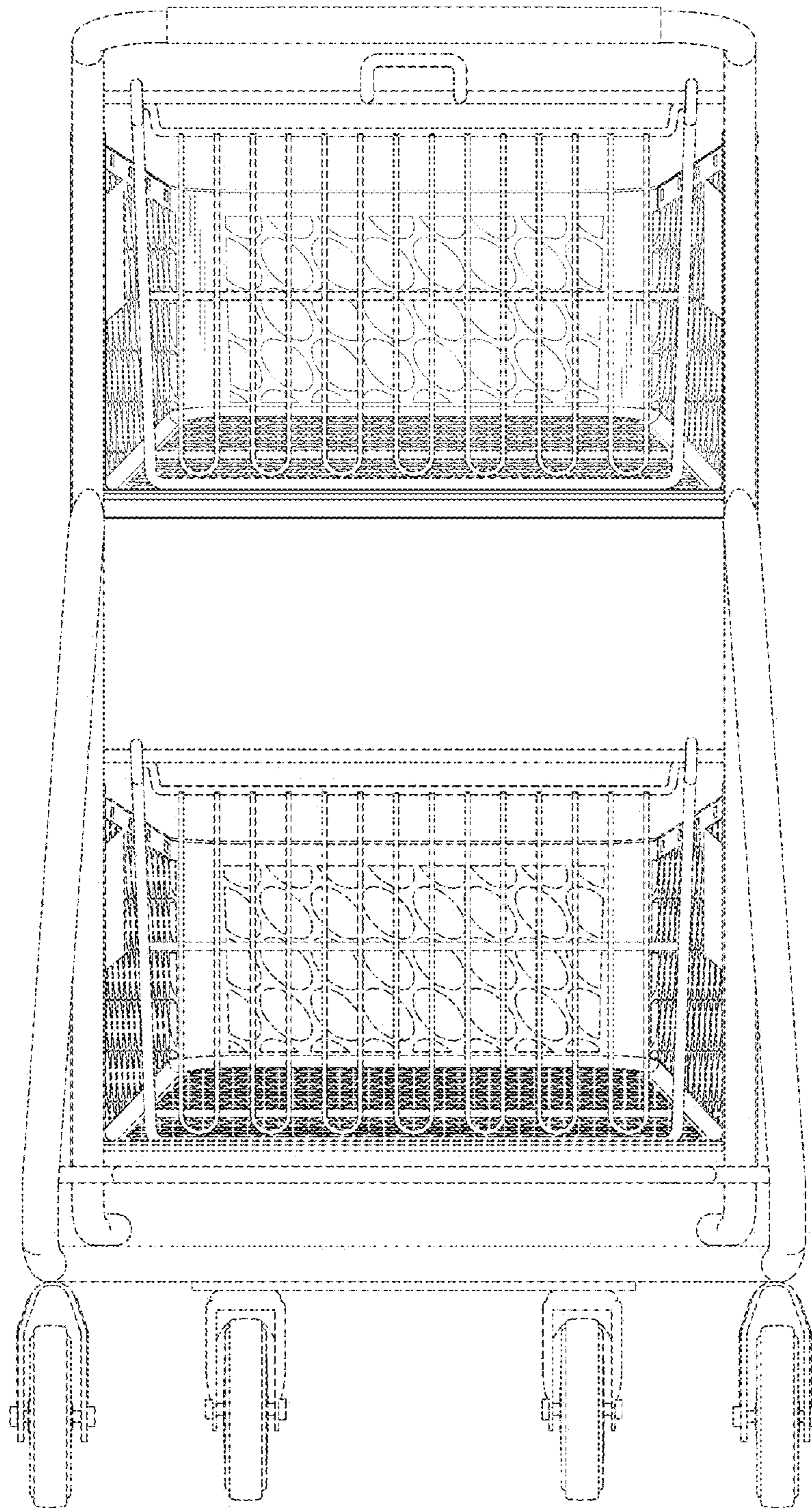

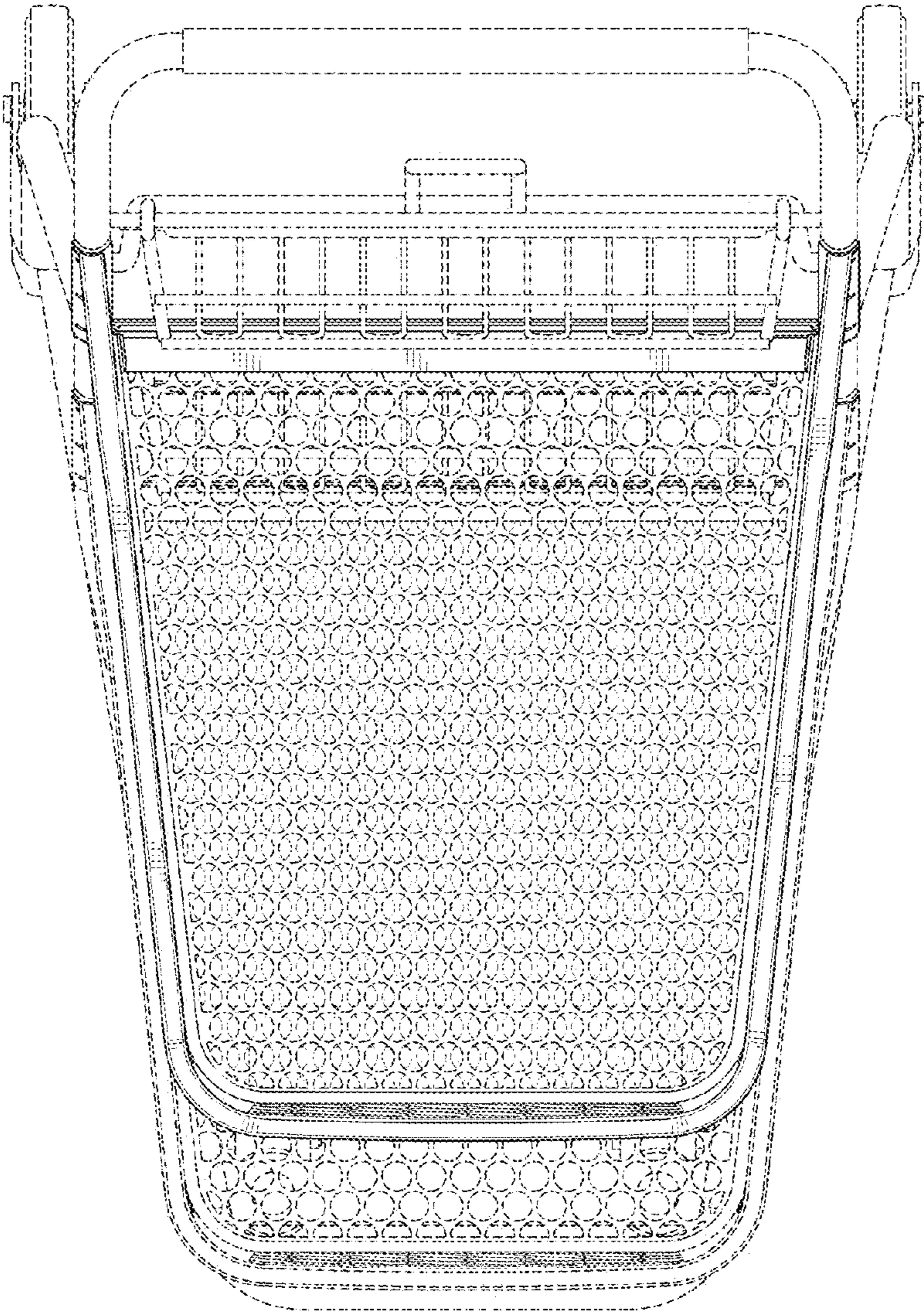

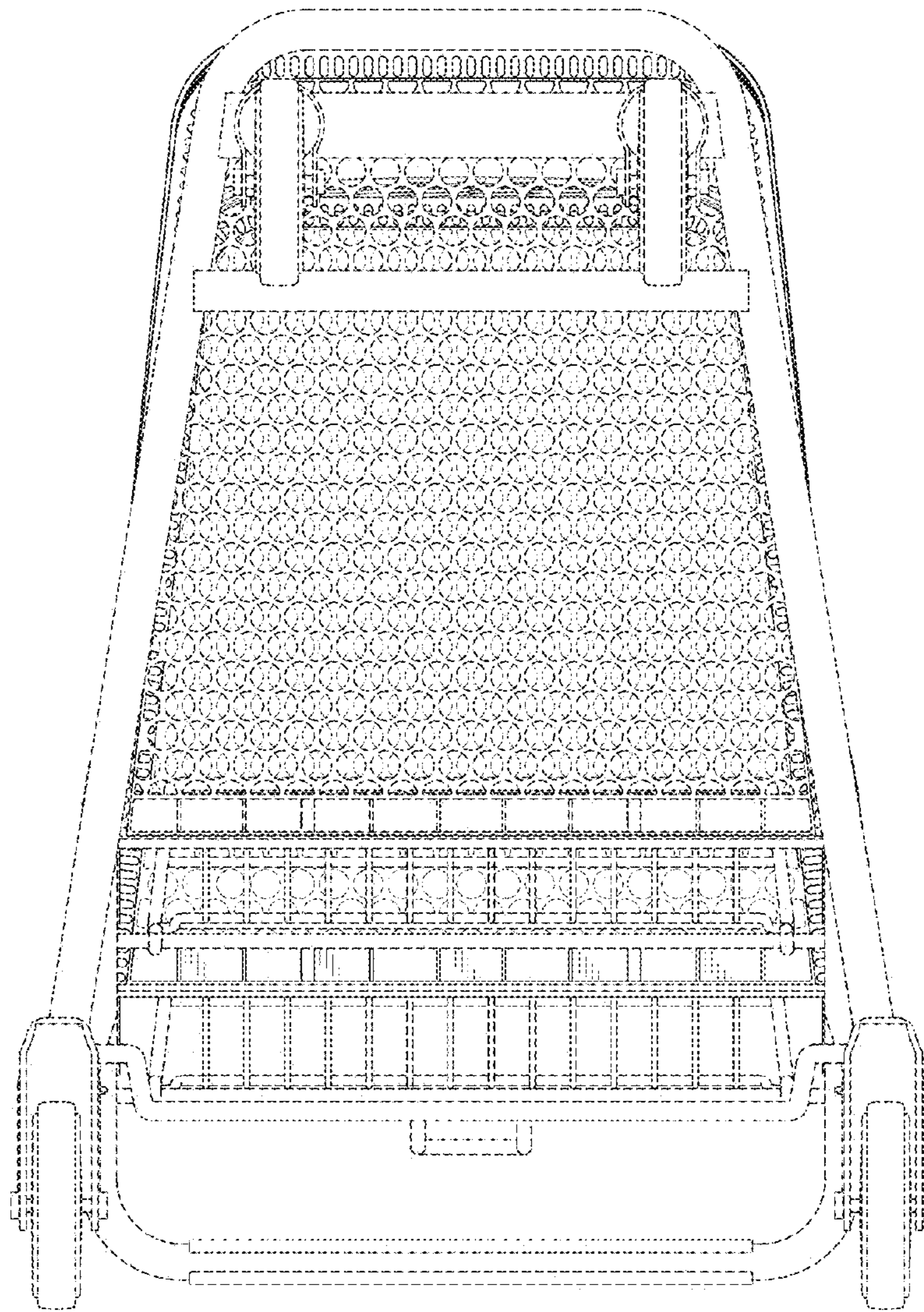

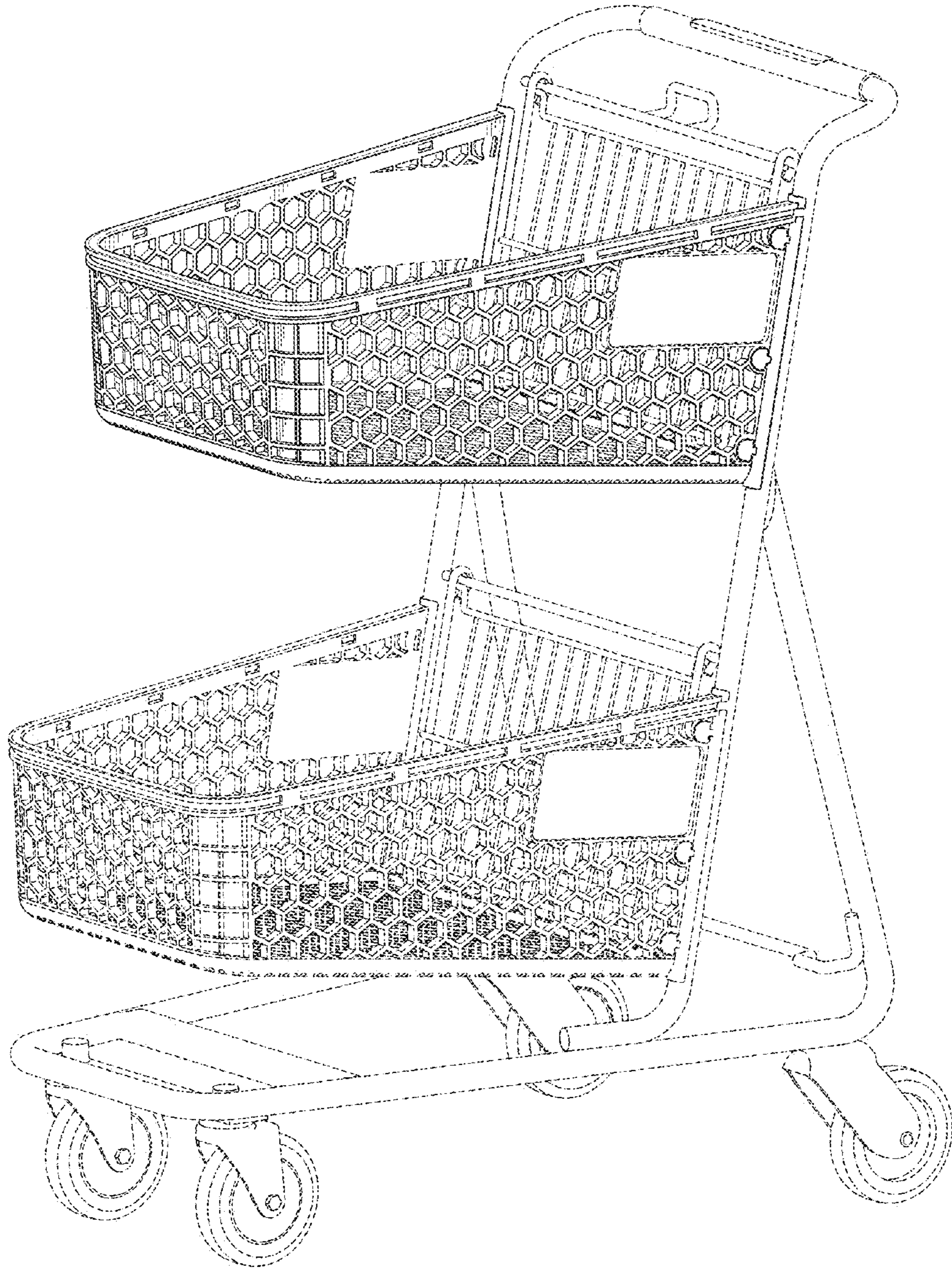

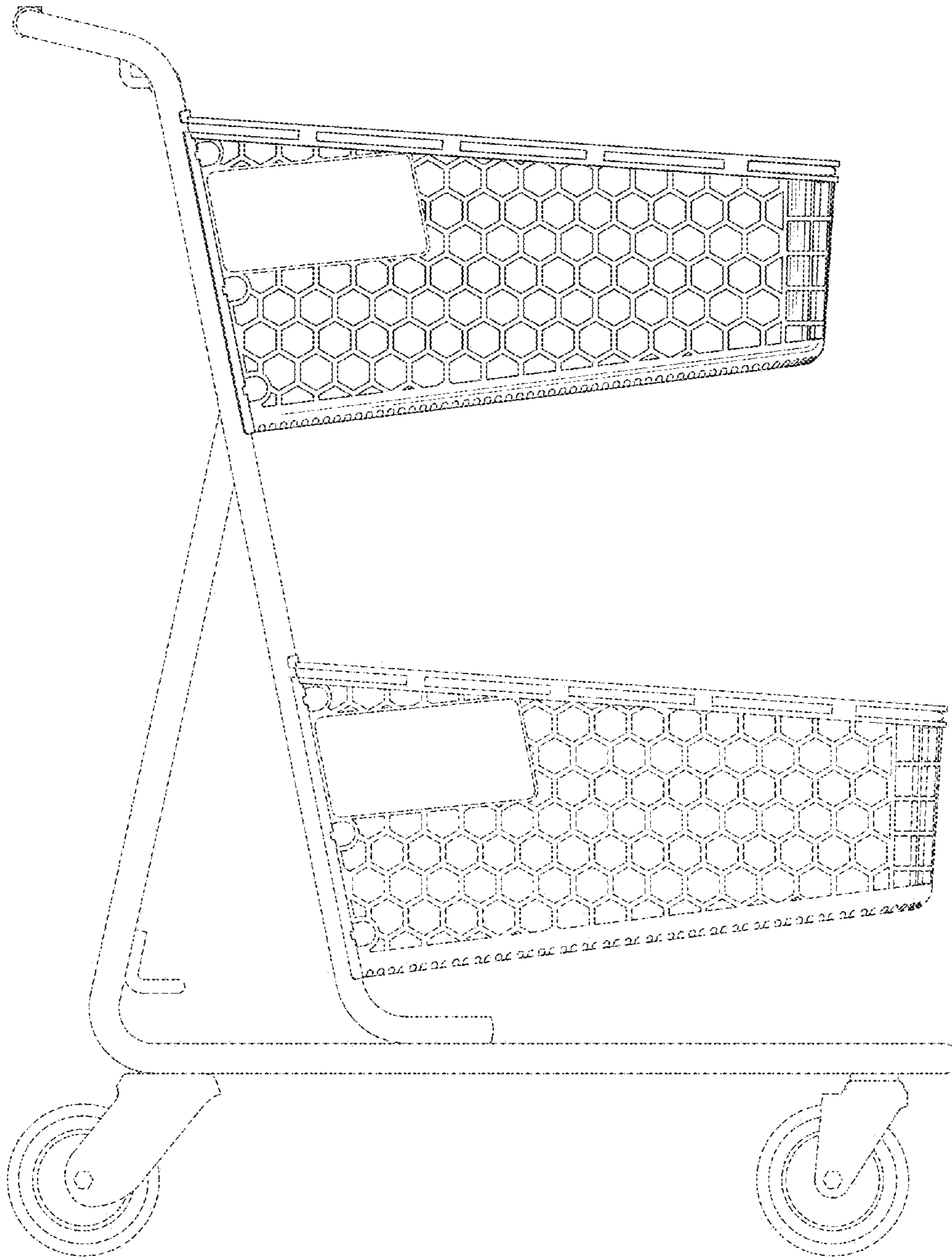

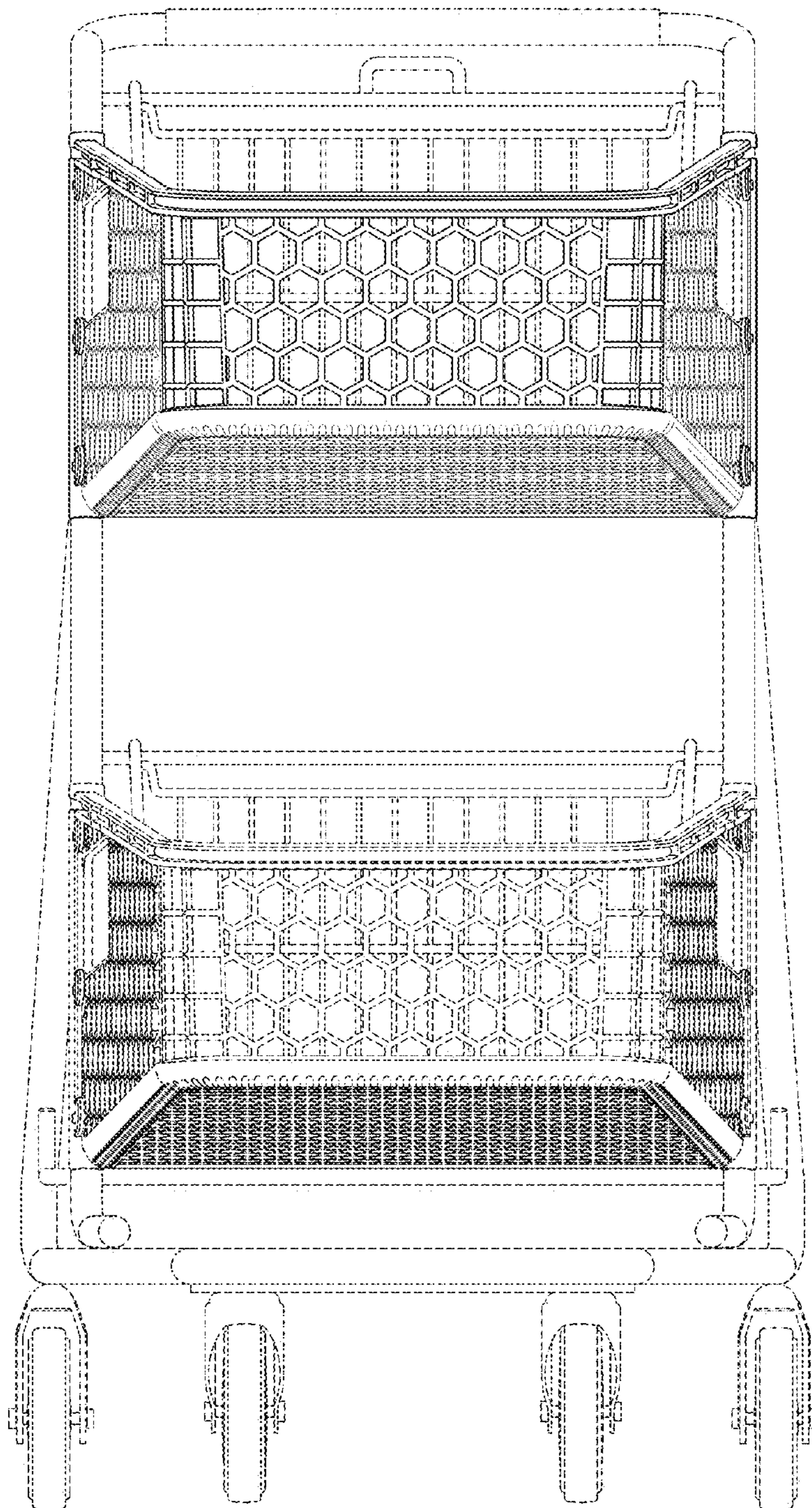

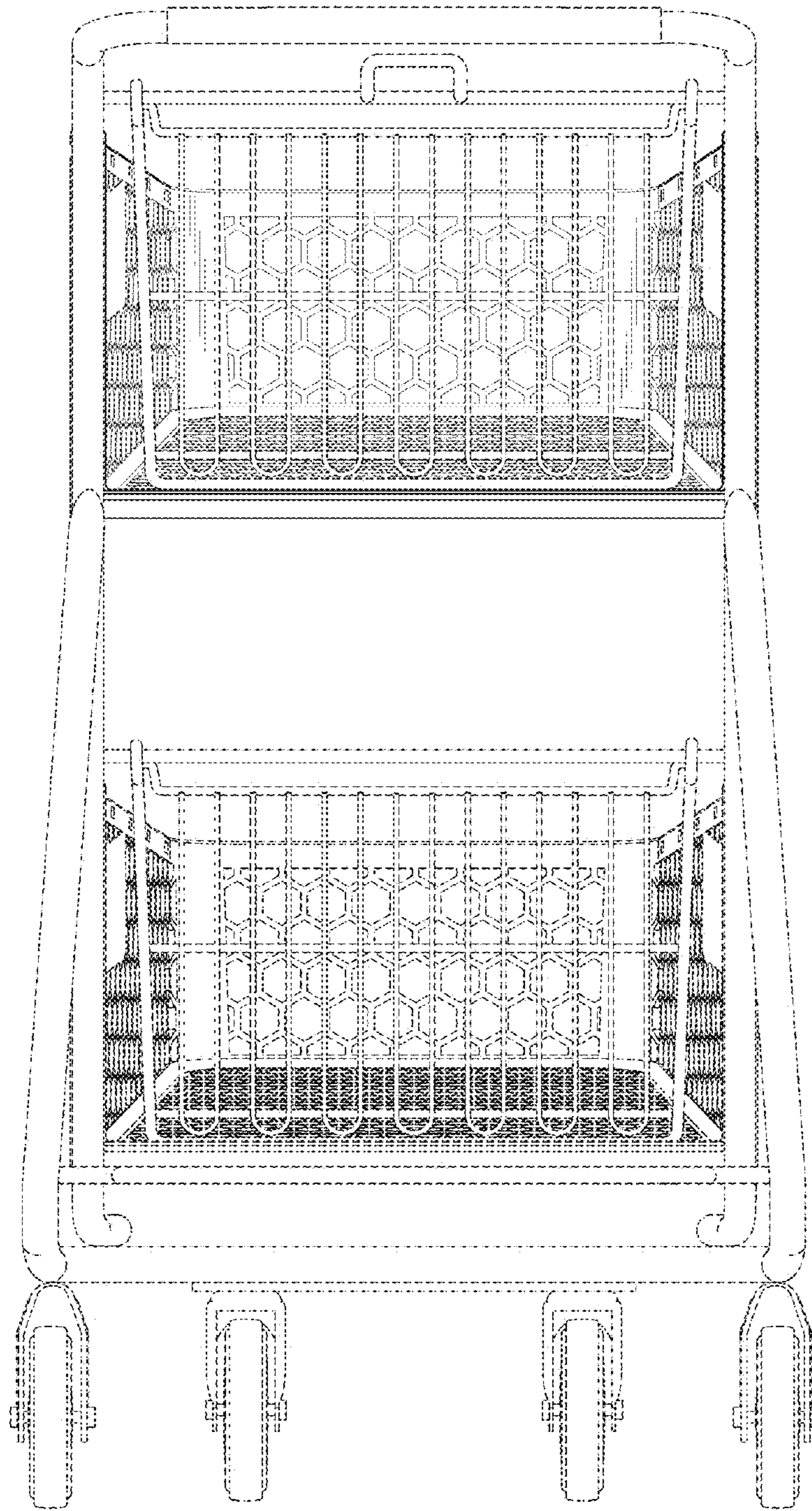

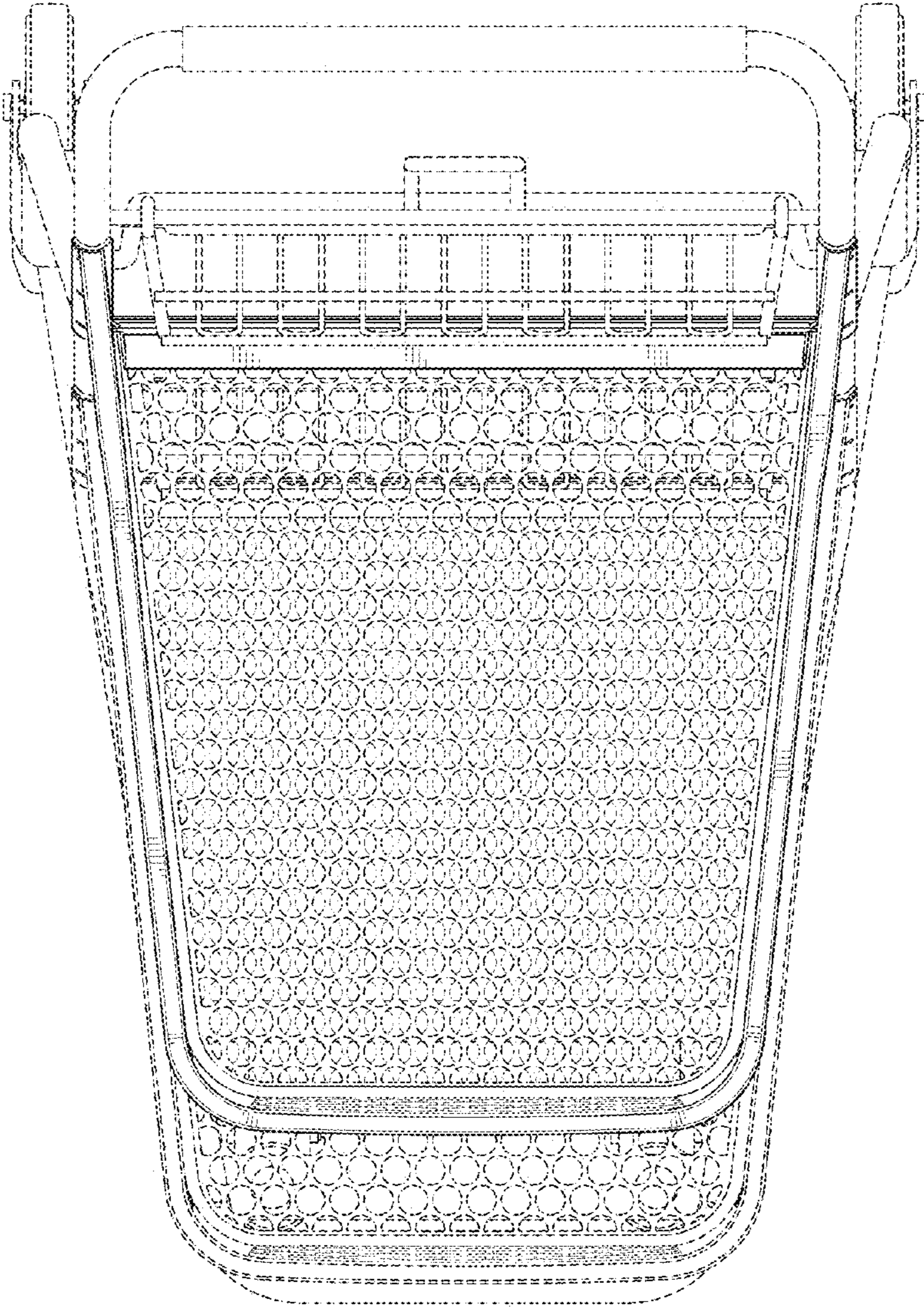

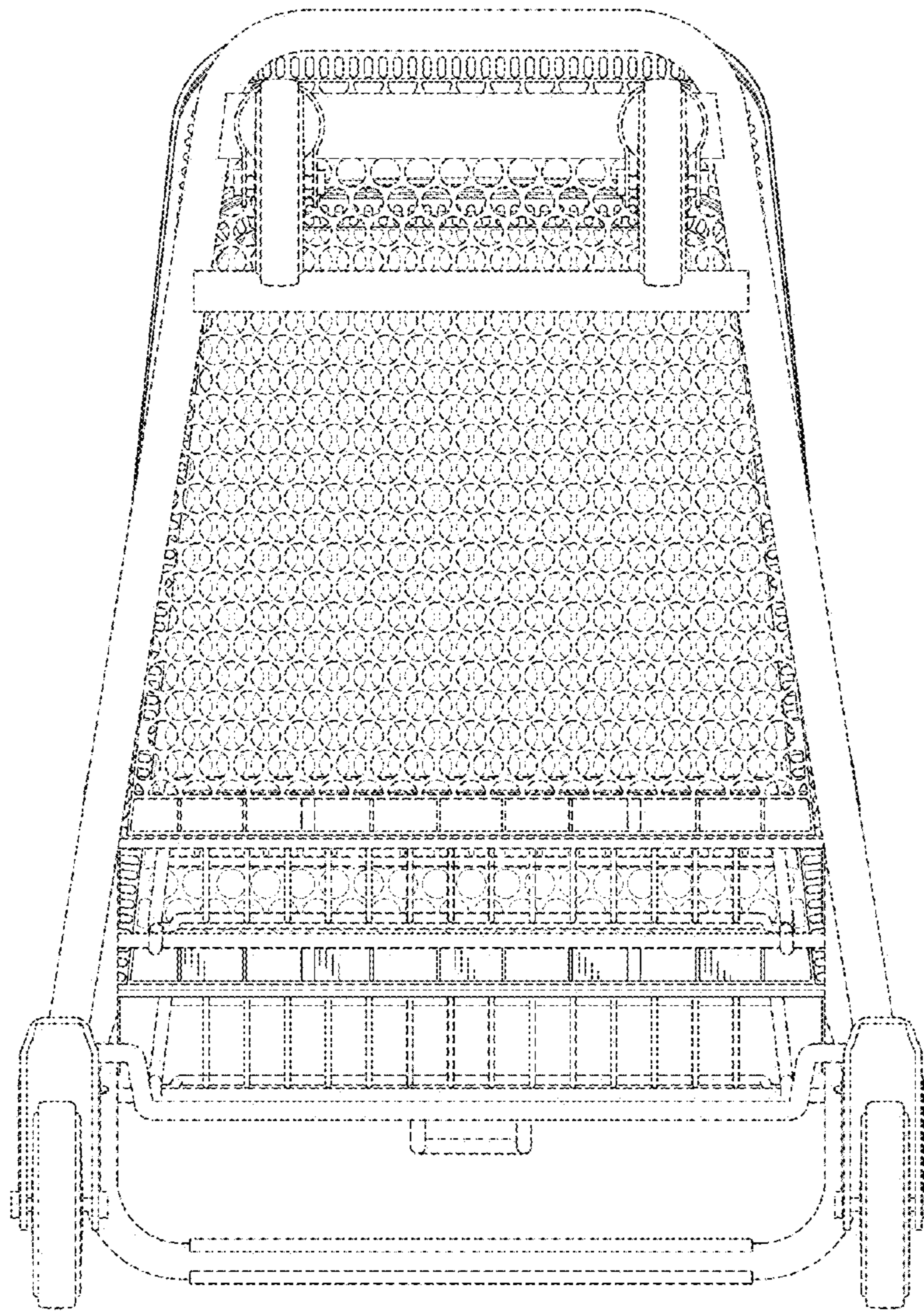

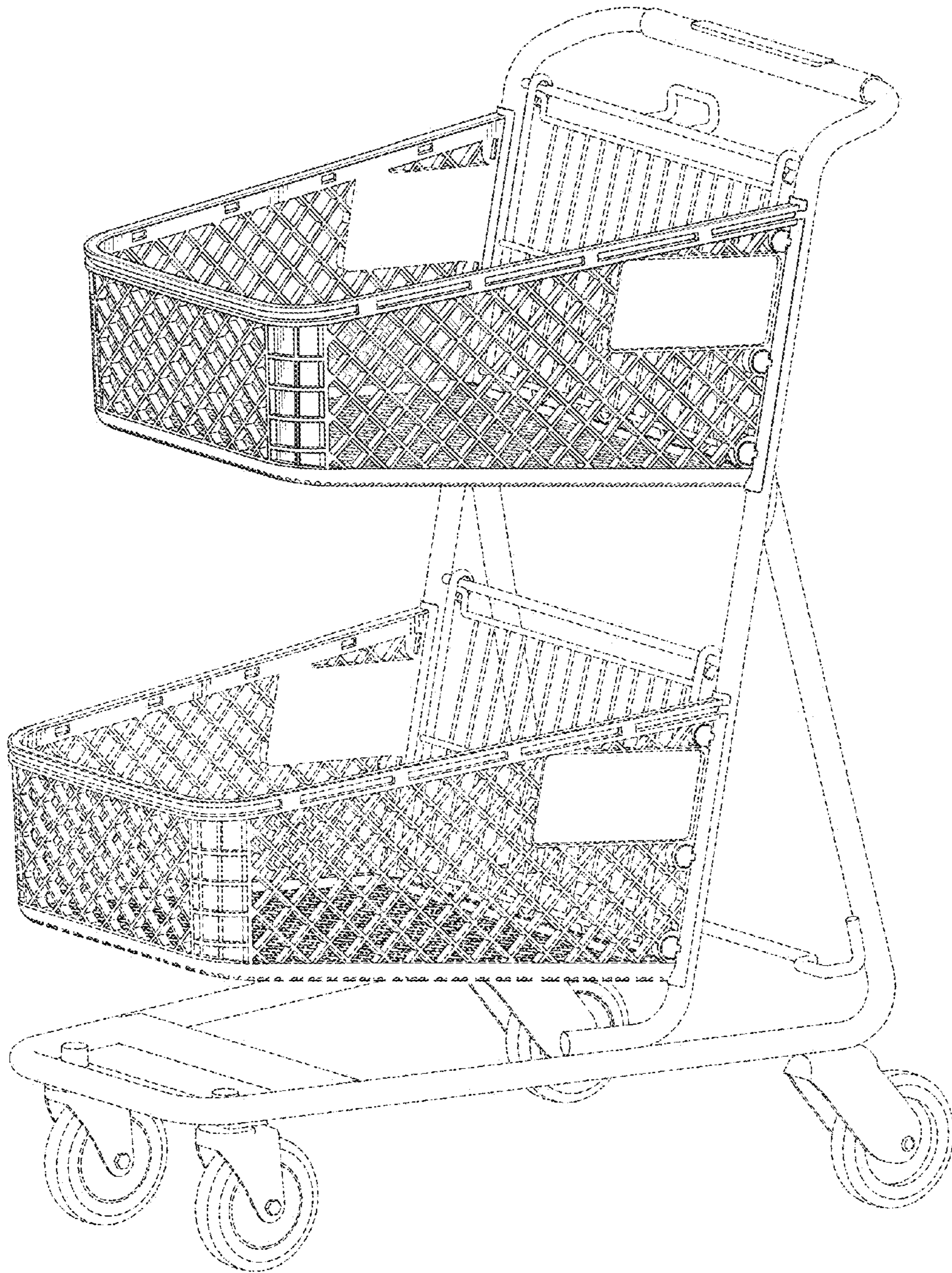

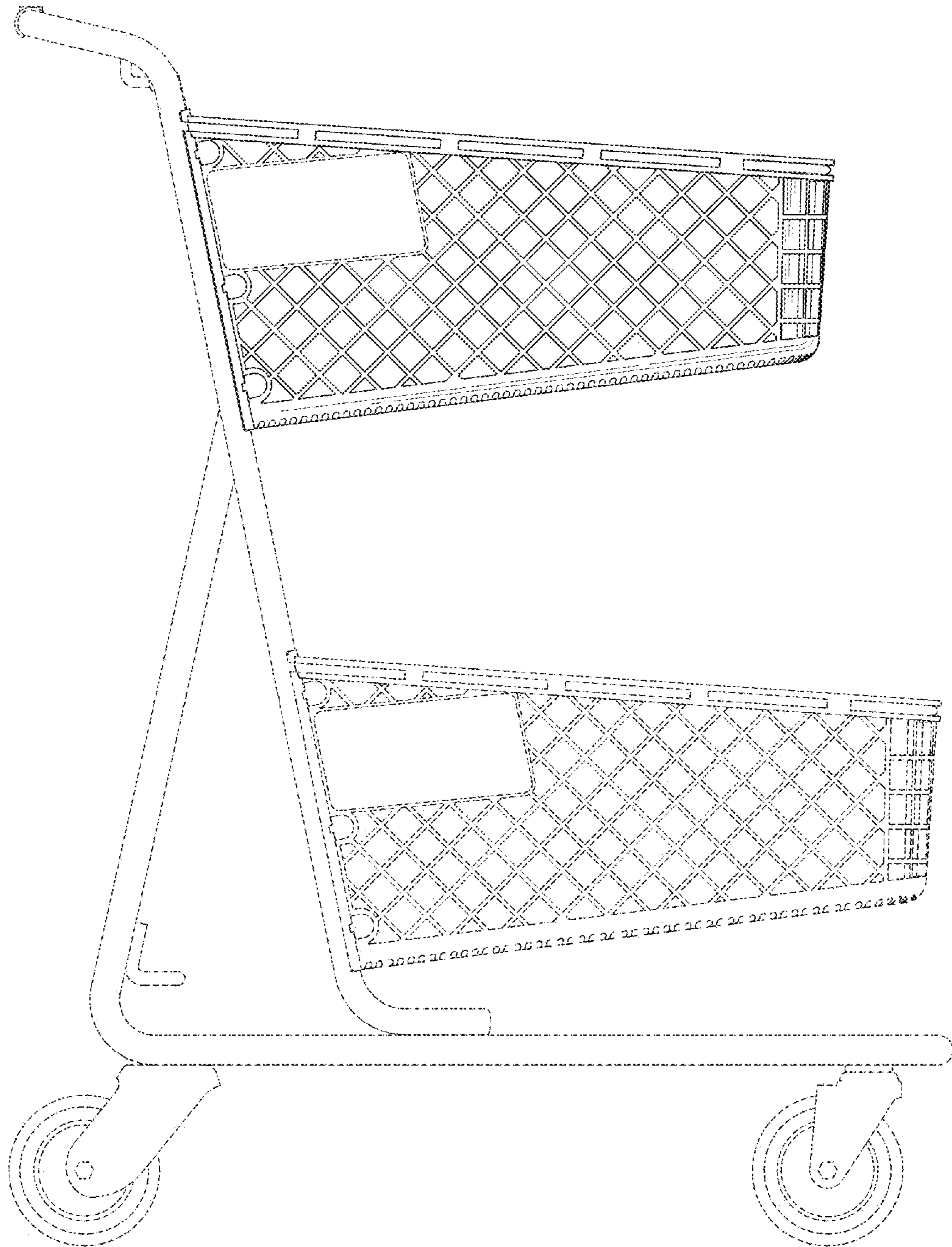

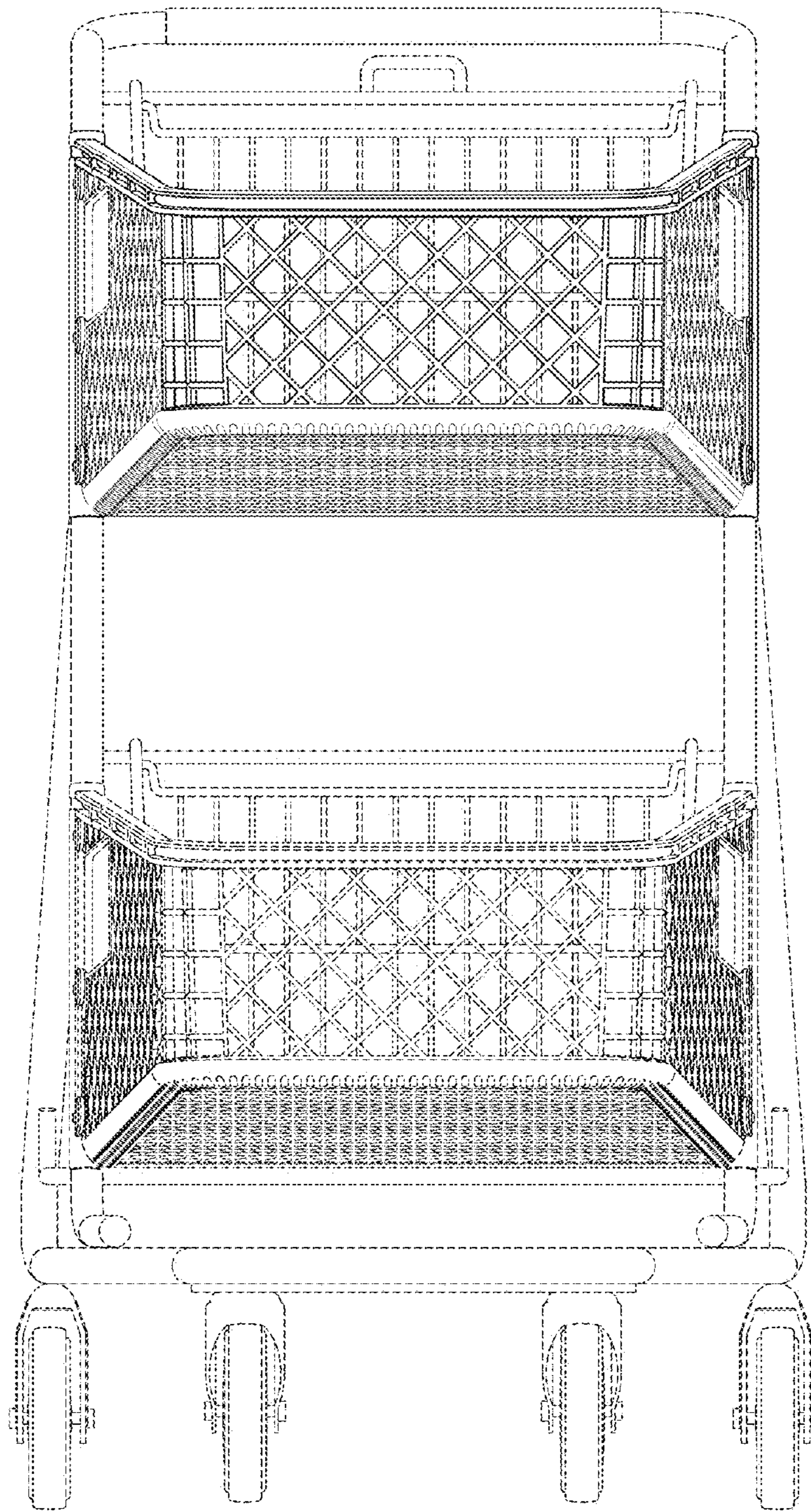

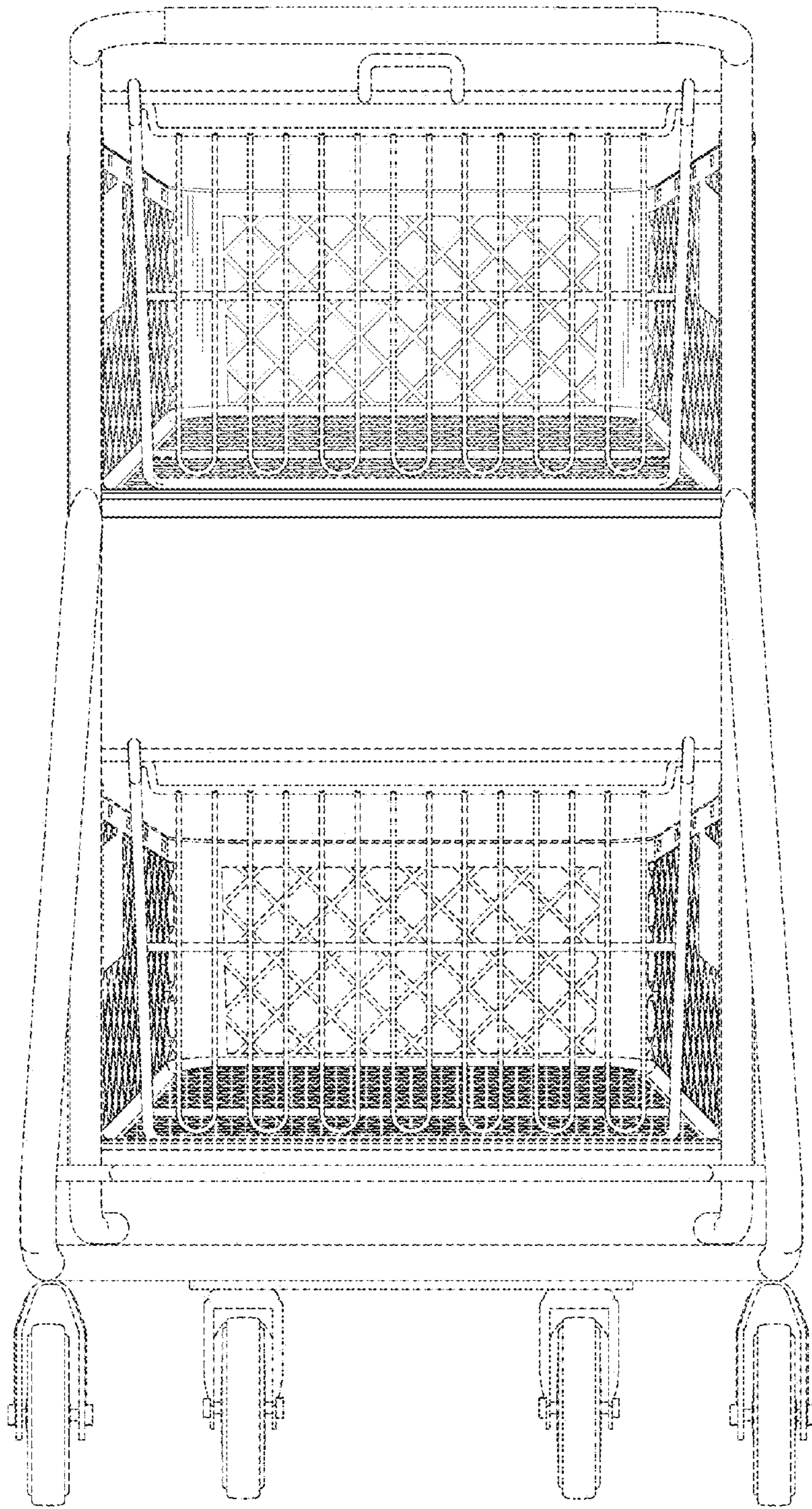

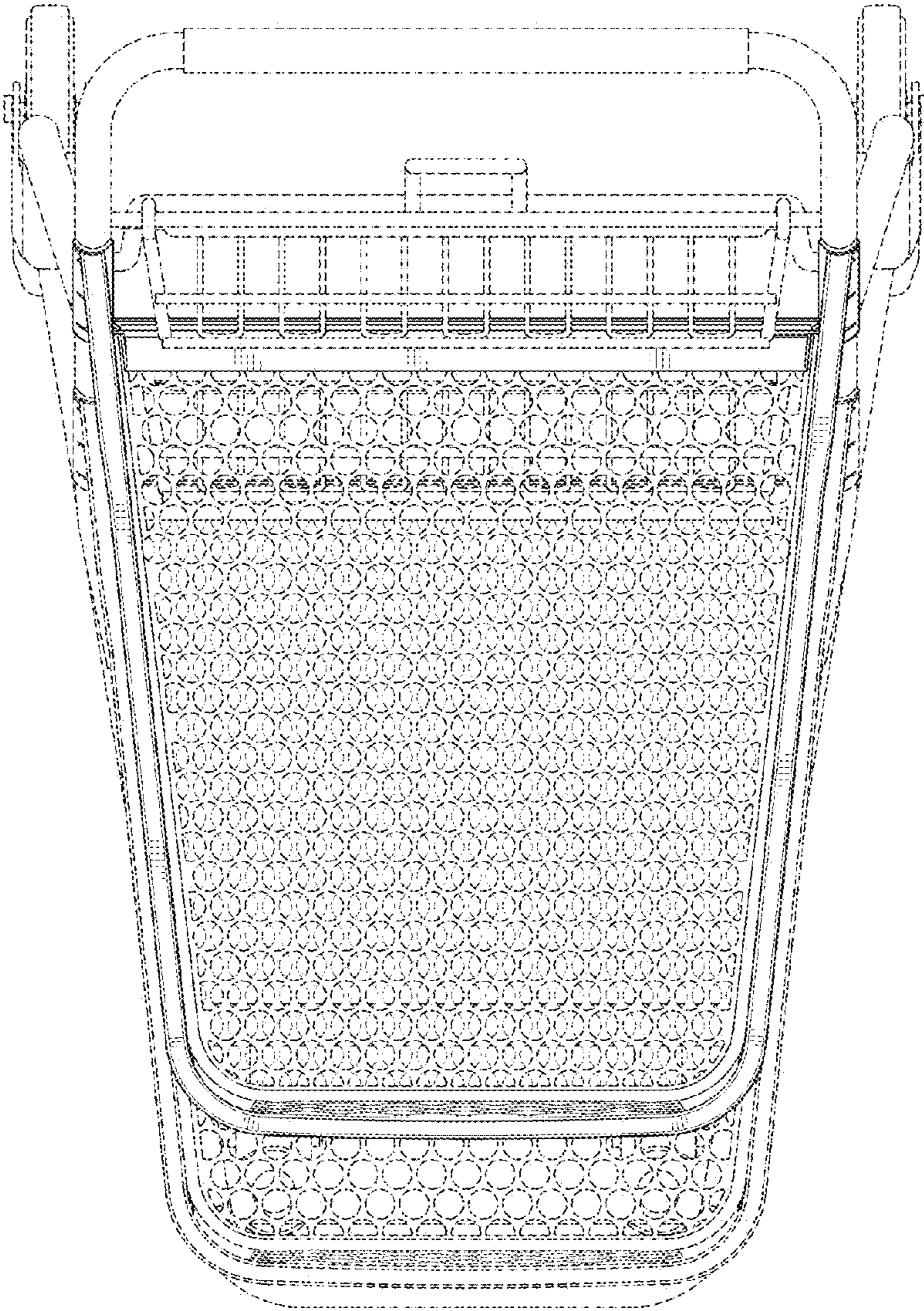

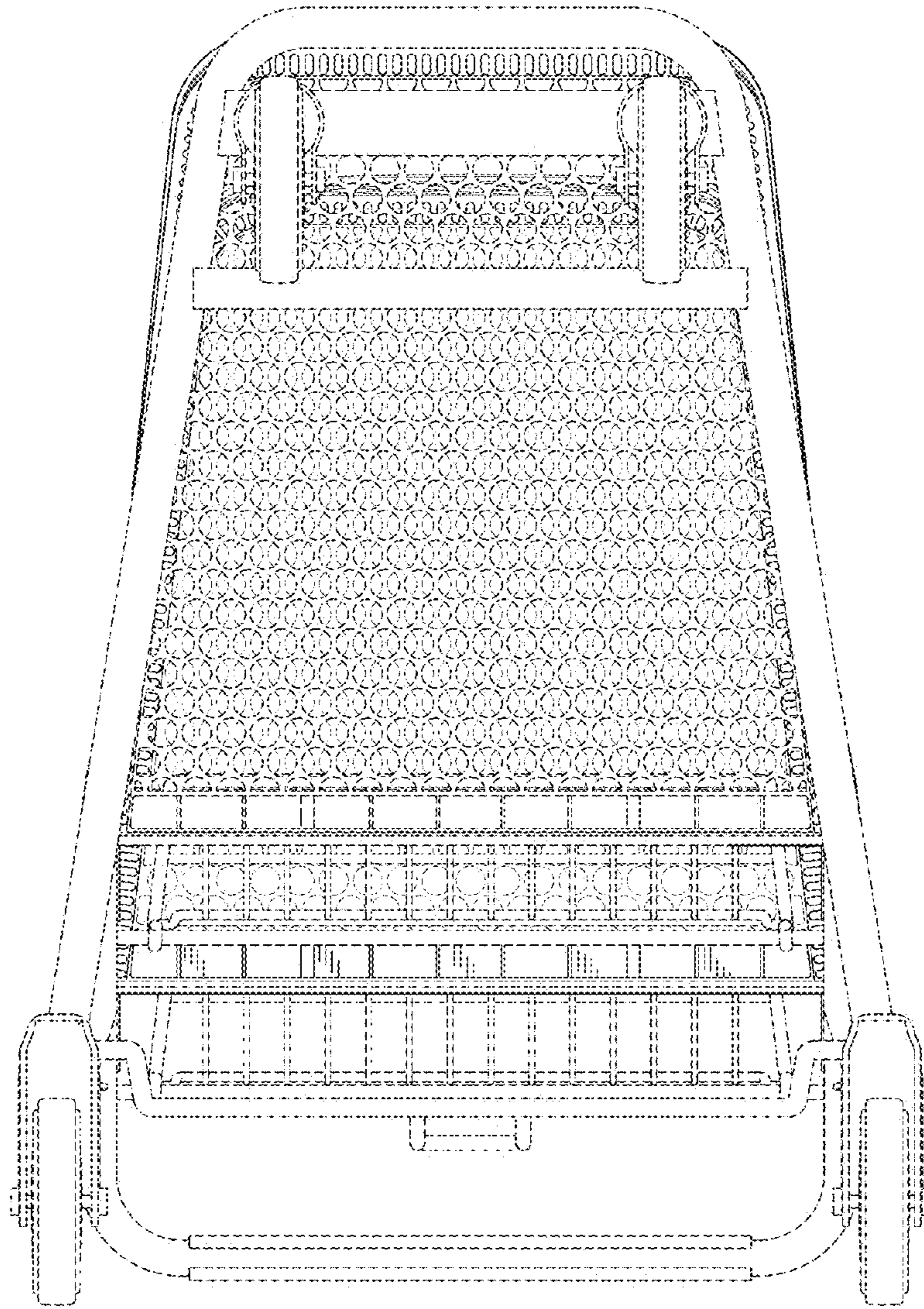
