The ornamental design for a cross-shaped display stand, as shown and described.

**DESCRIPTION**

*This application is a reissue divisional application of 29/463,818, filed on Mar. 12, 2014, now U.S. Pat. No. RE45,428, which is an application for reissue of U.S. Design Pat. No. D659,431.*

FIG. 1 is a front perspective view of a cross-shaped display stand in accordance with the present invention;

*FIG. 14 is a side elevation view thereof, the opposing side elevation view being a mirror image;*

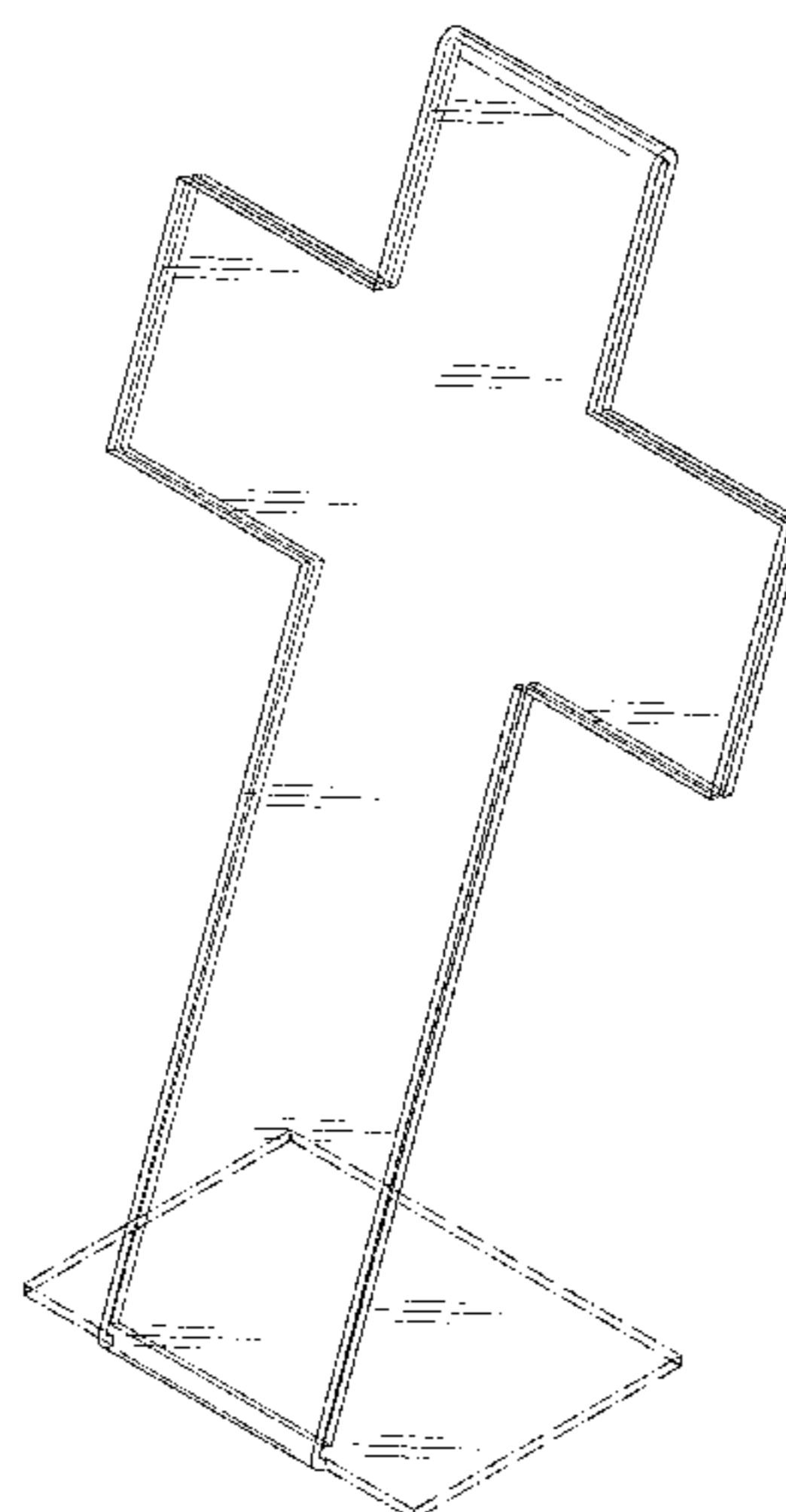
*FIG. 15 is a top view thereof; and,*

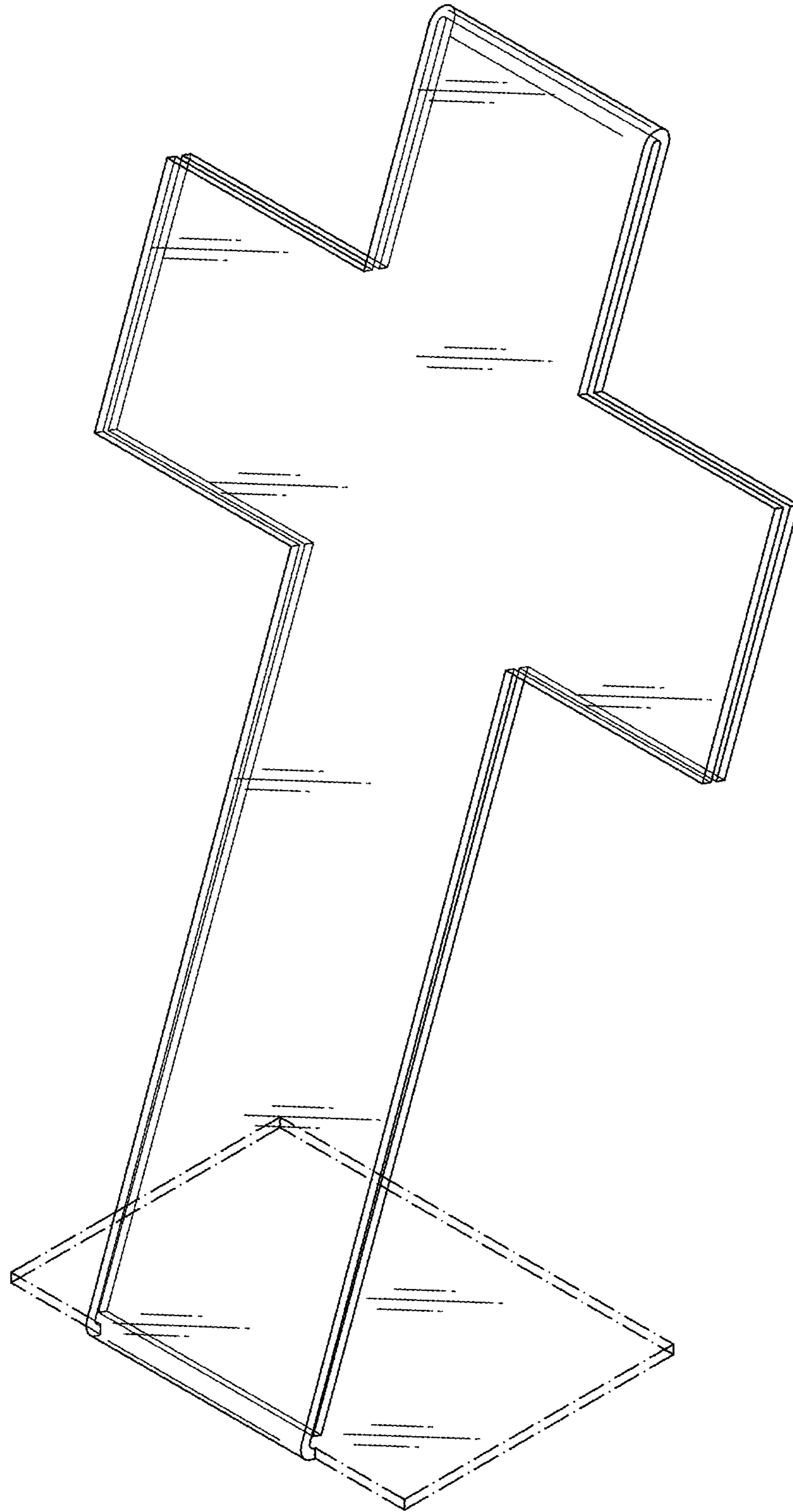

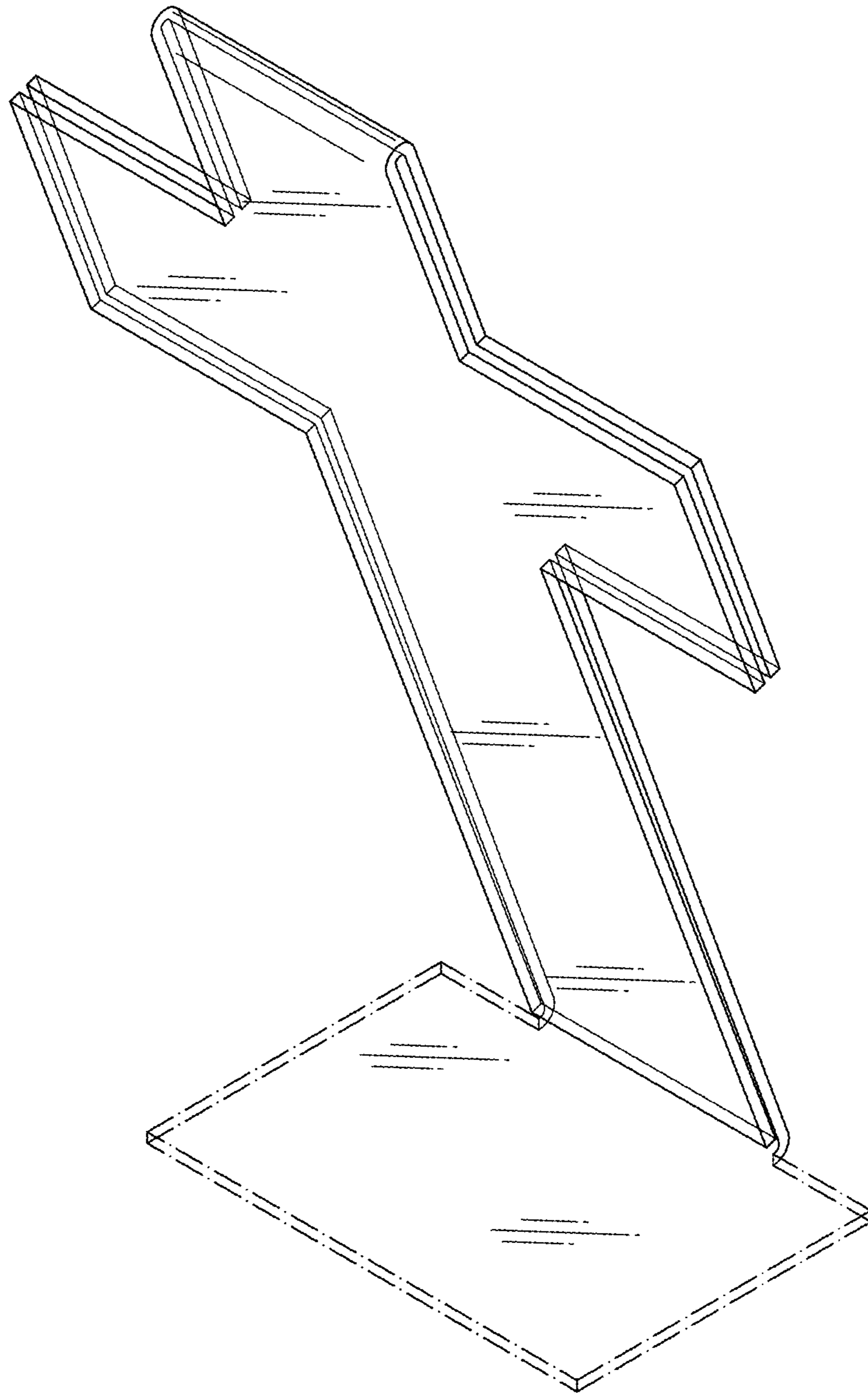

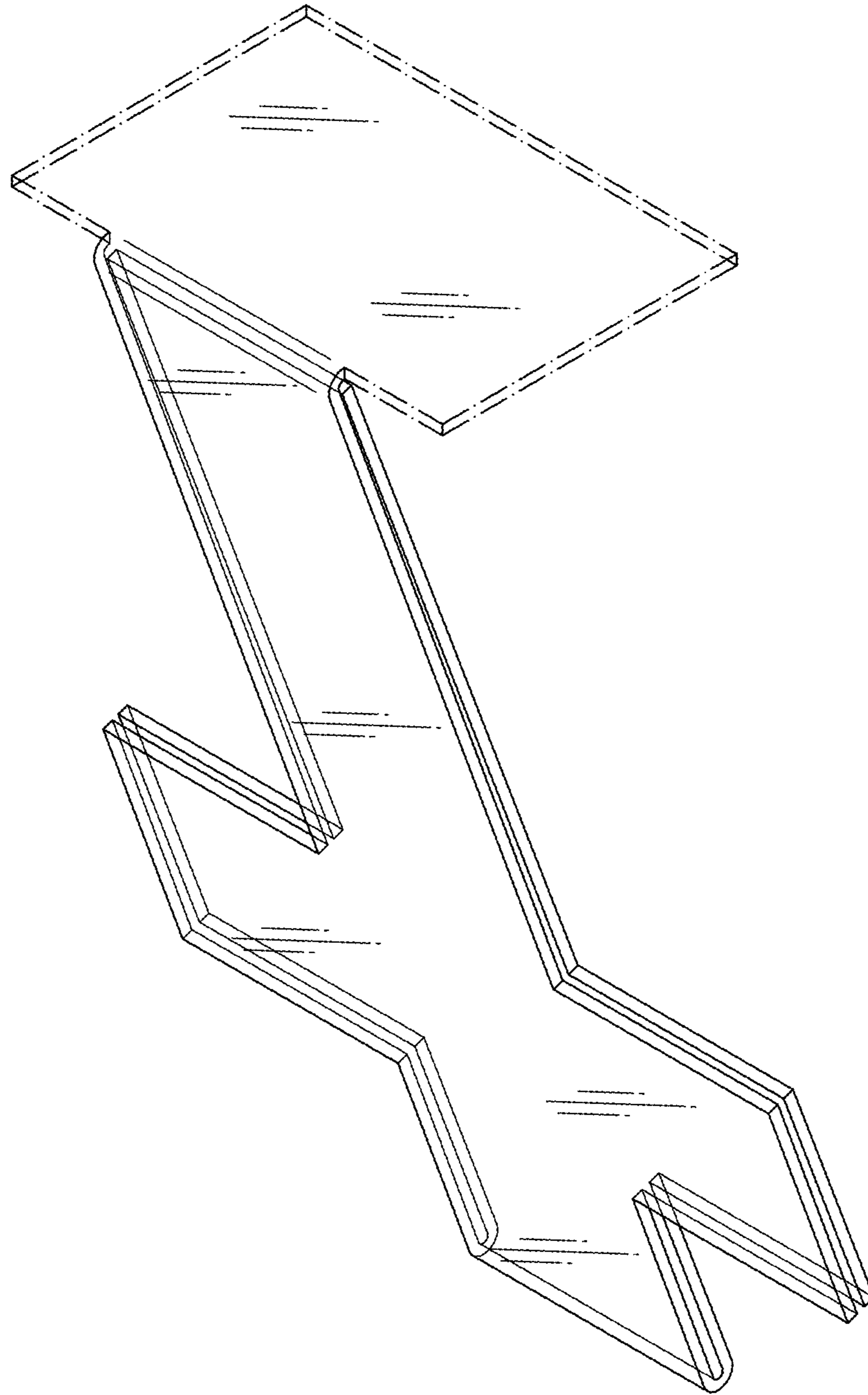

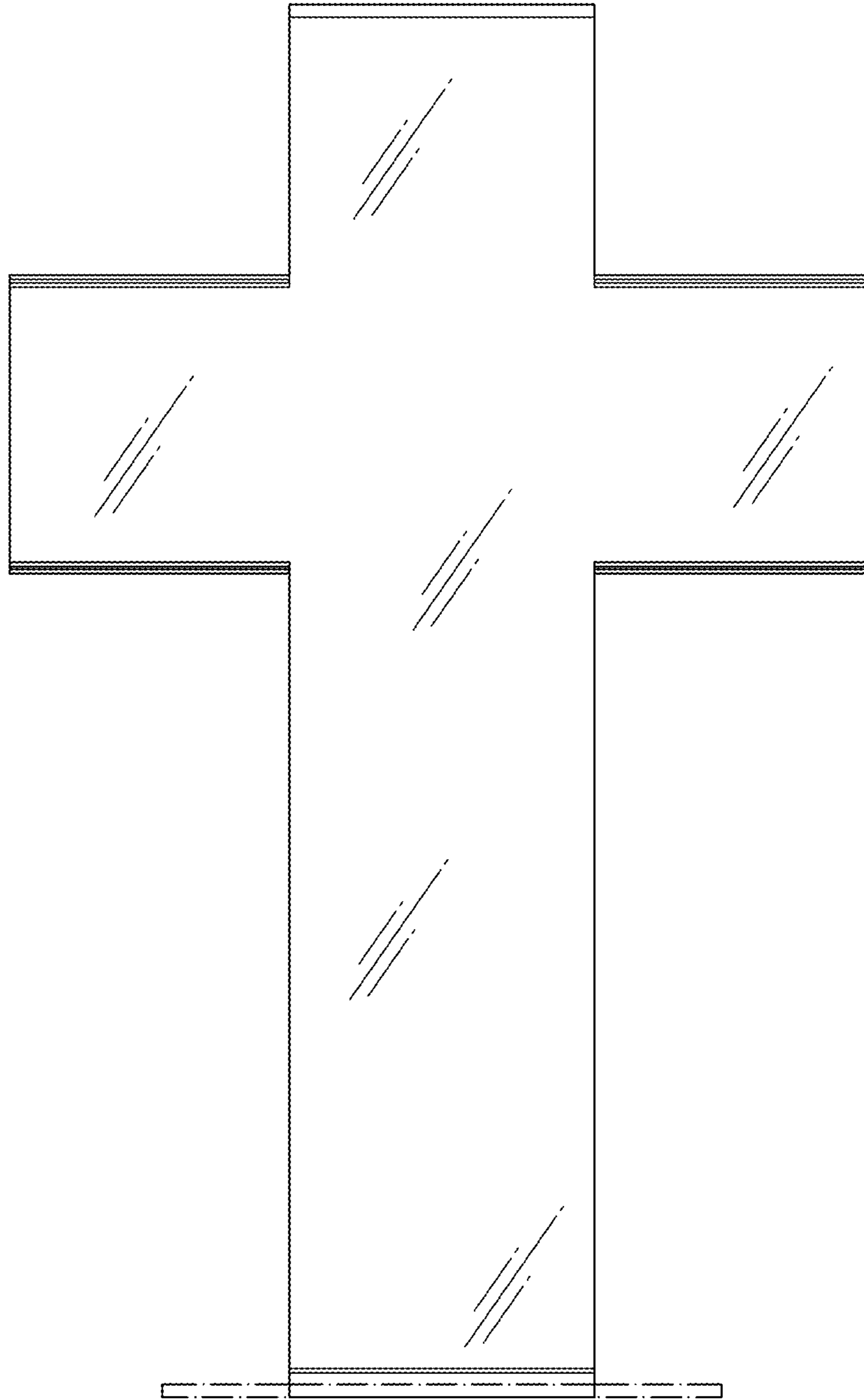

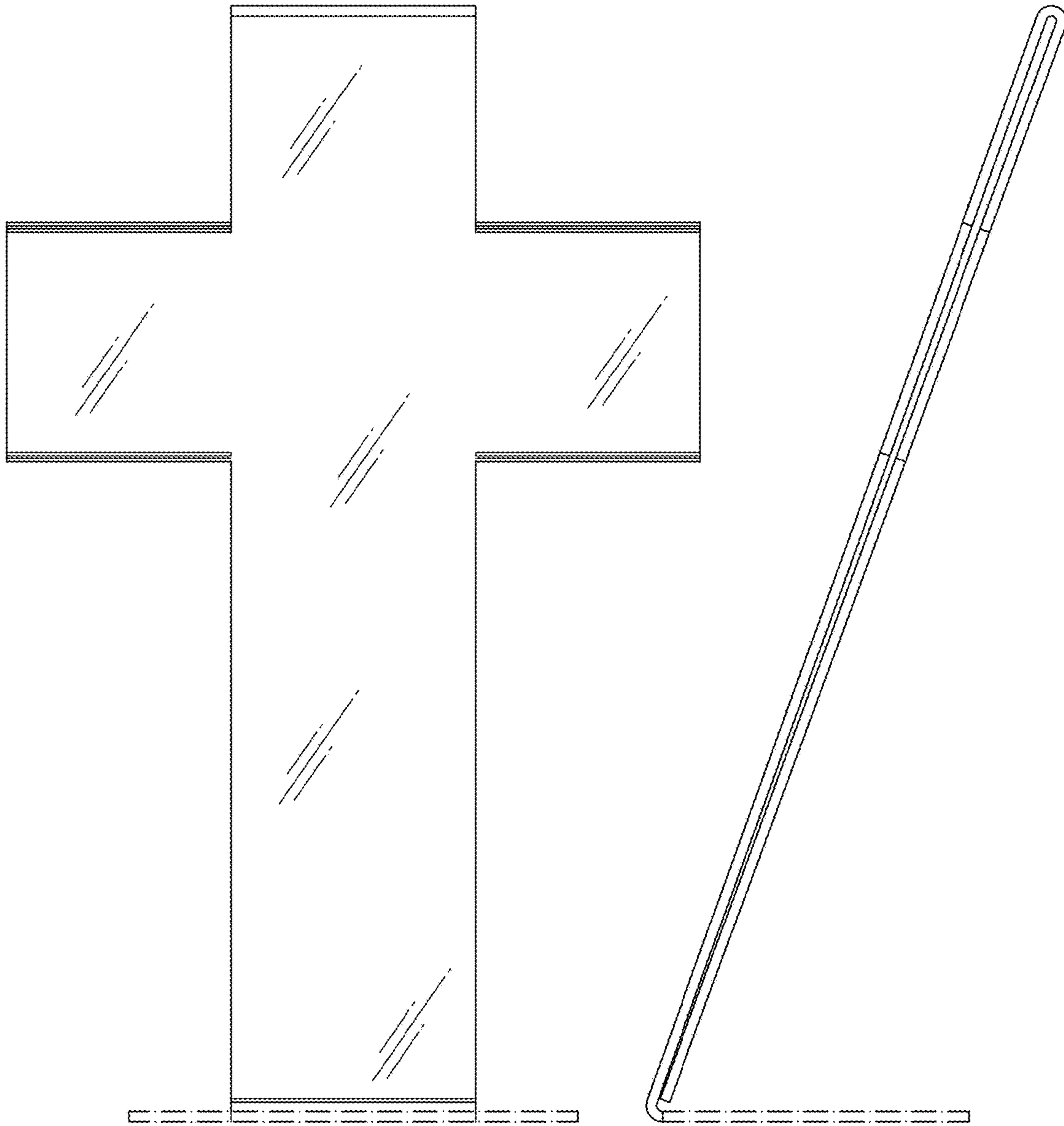

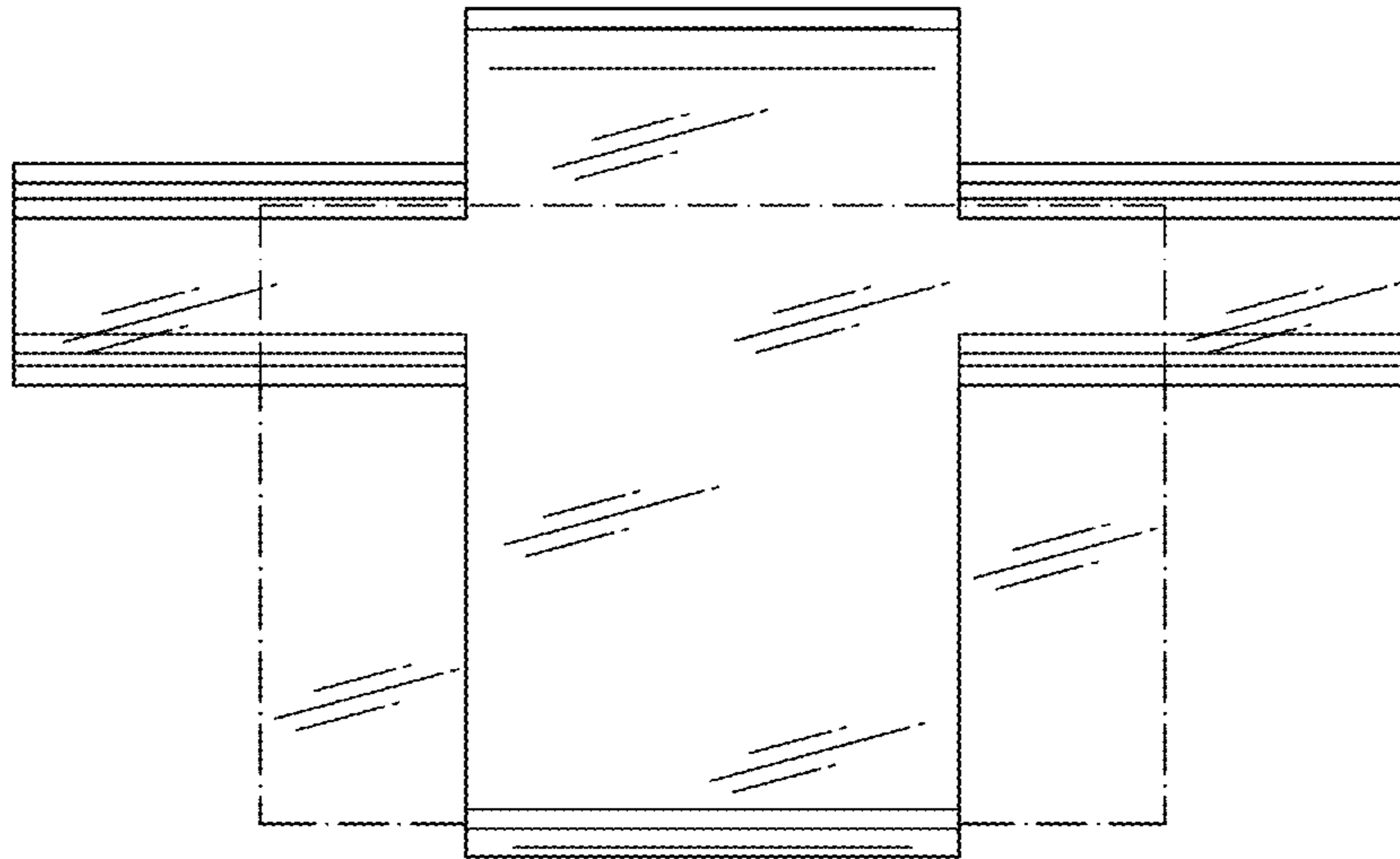

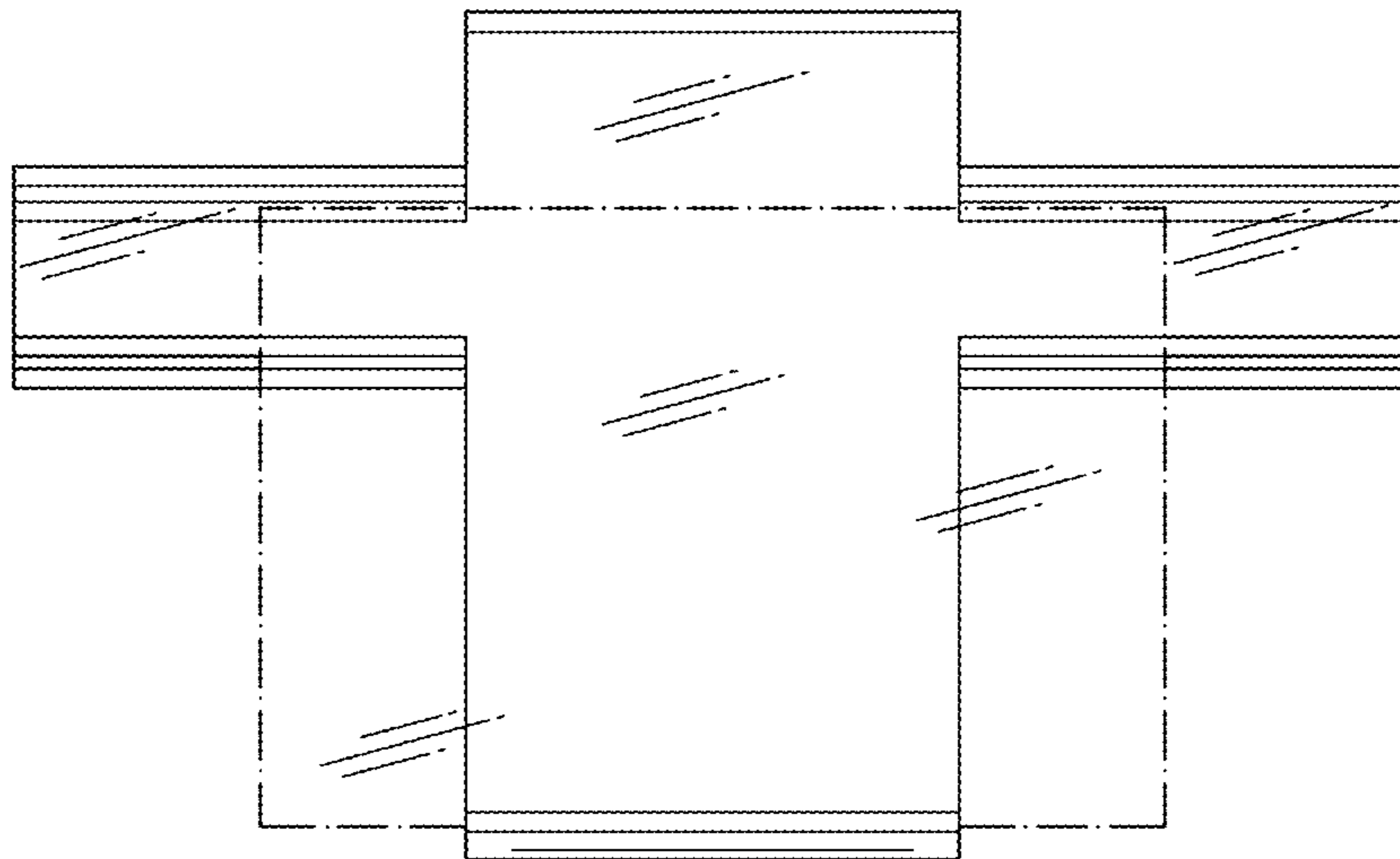

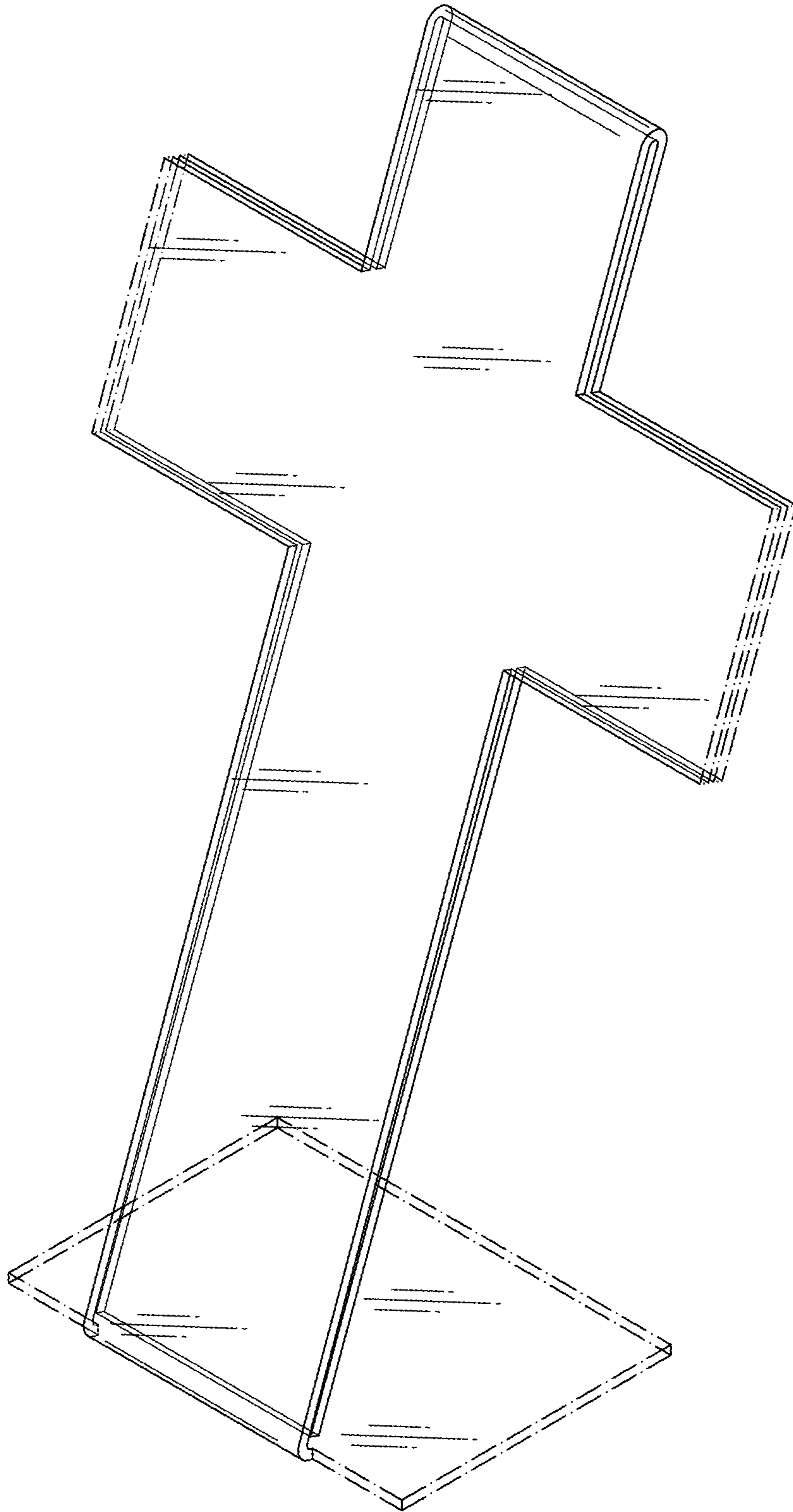

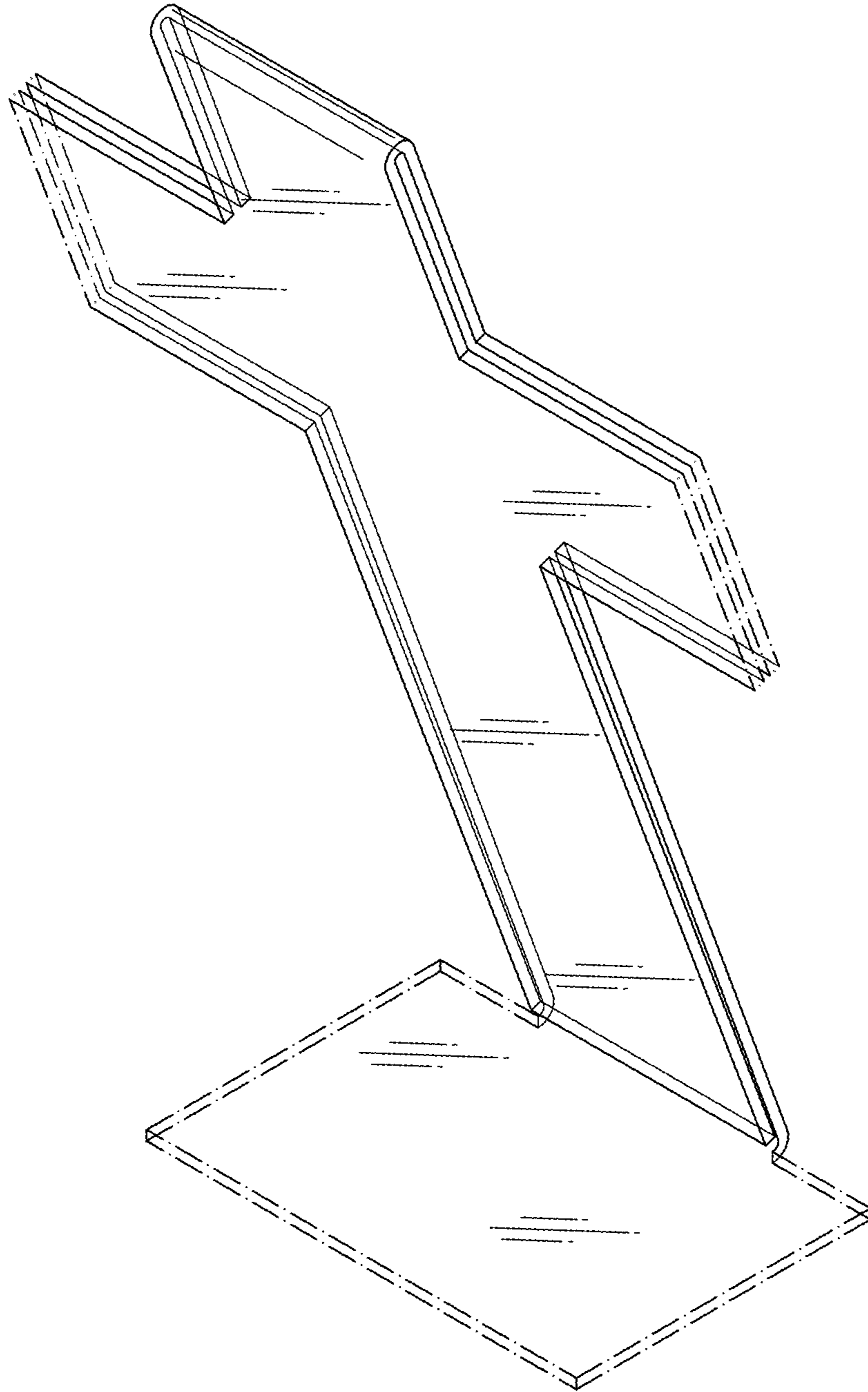

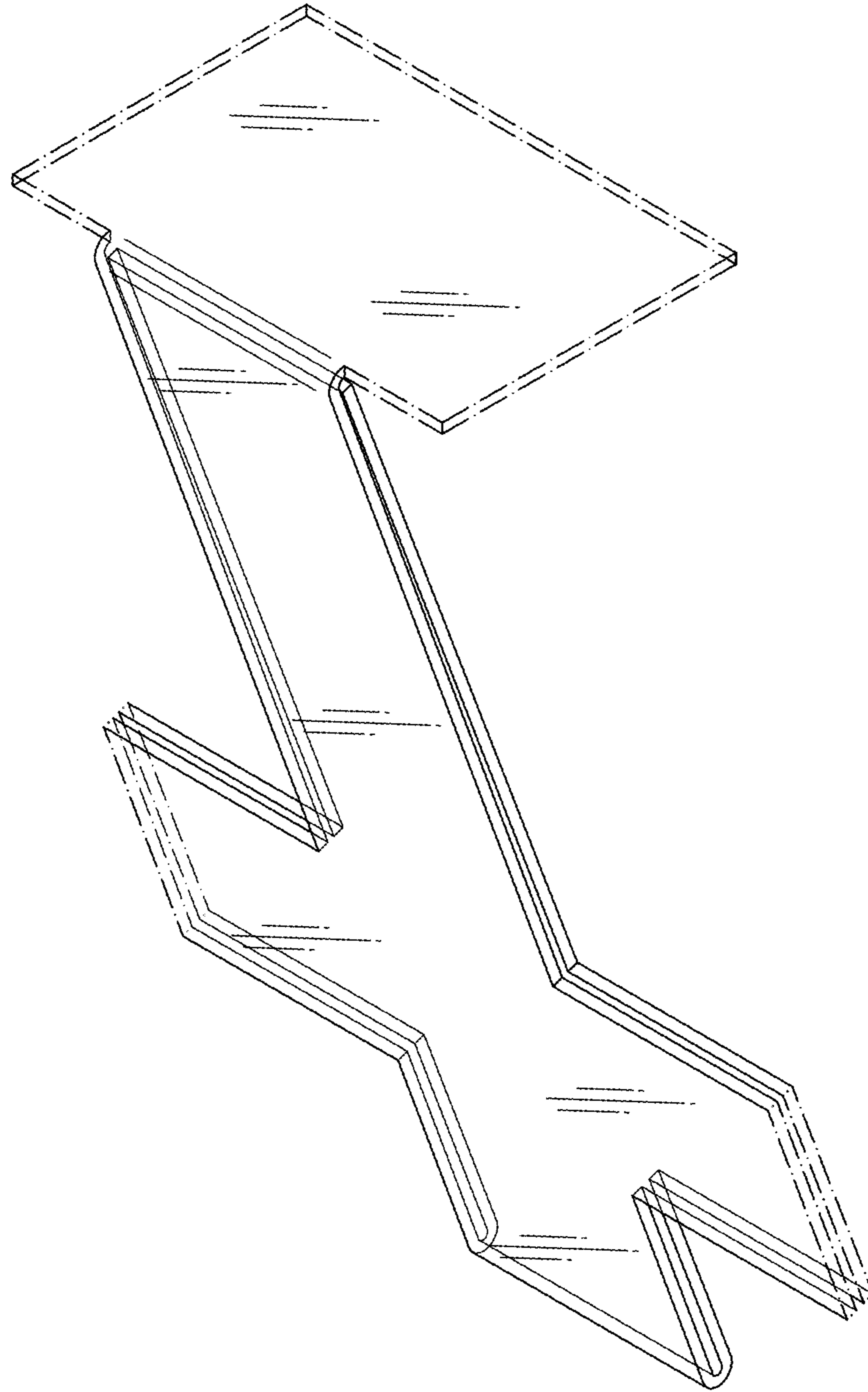

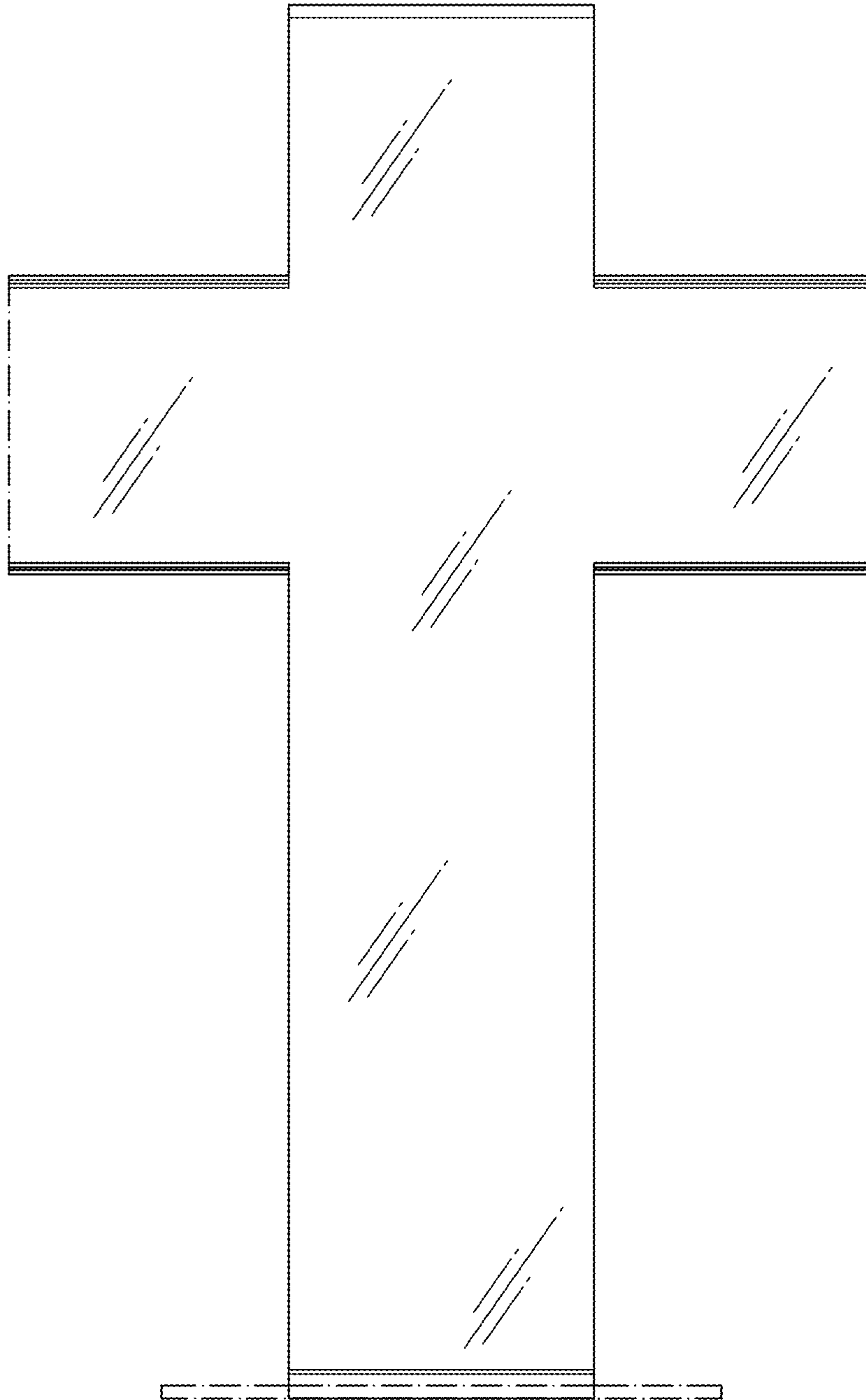

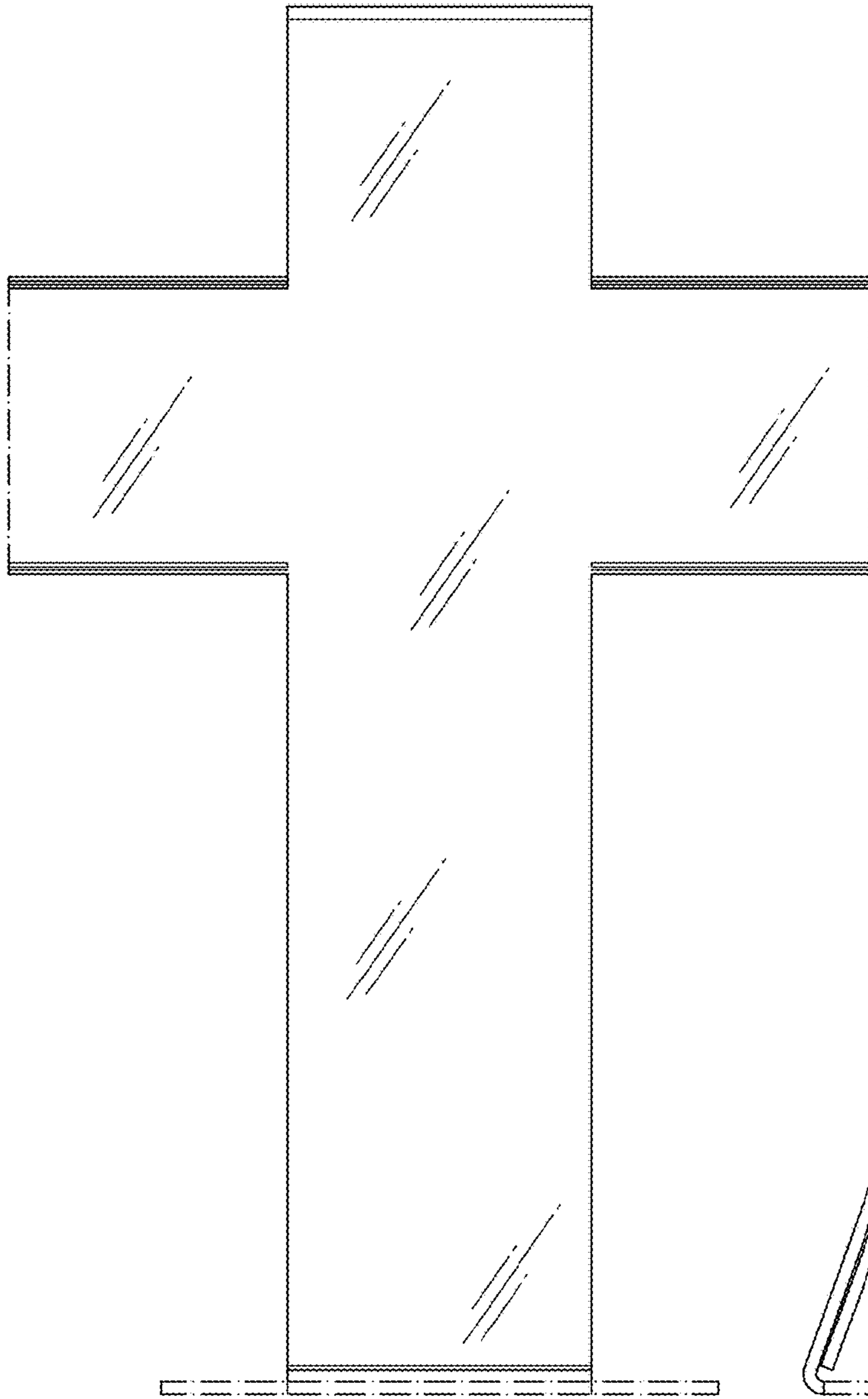

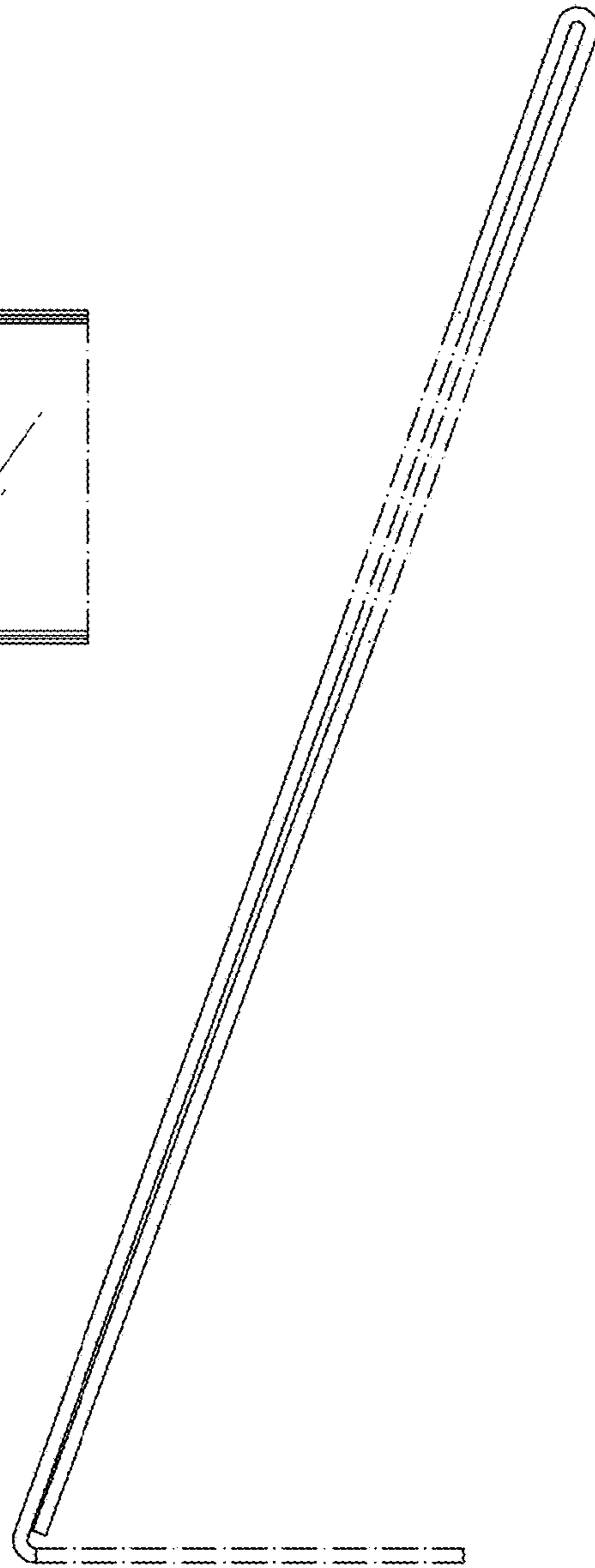

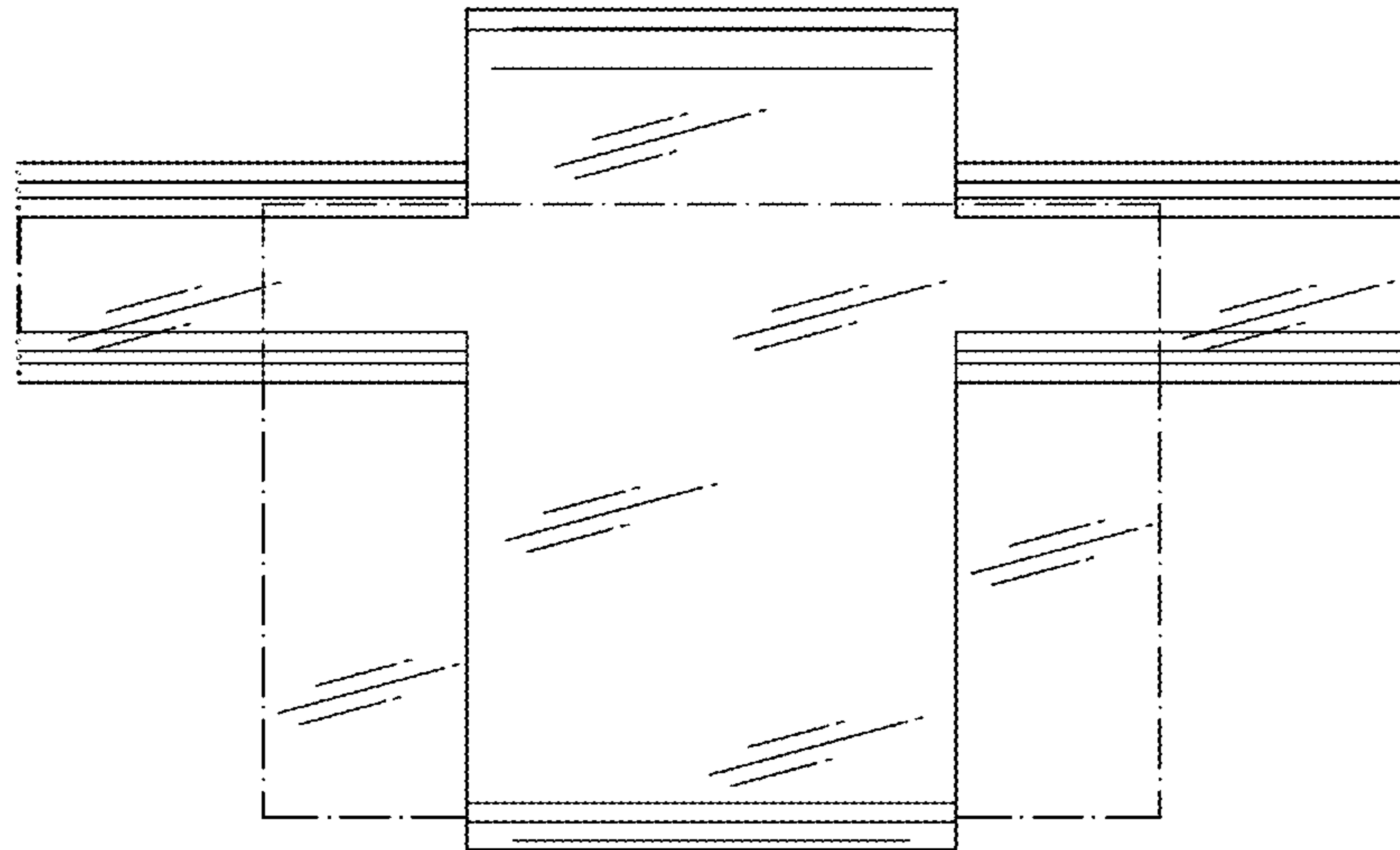

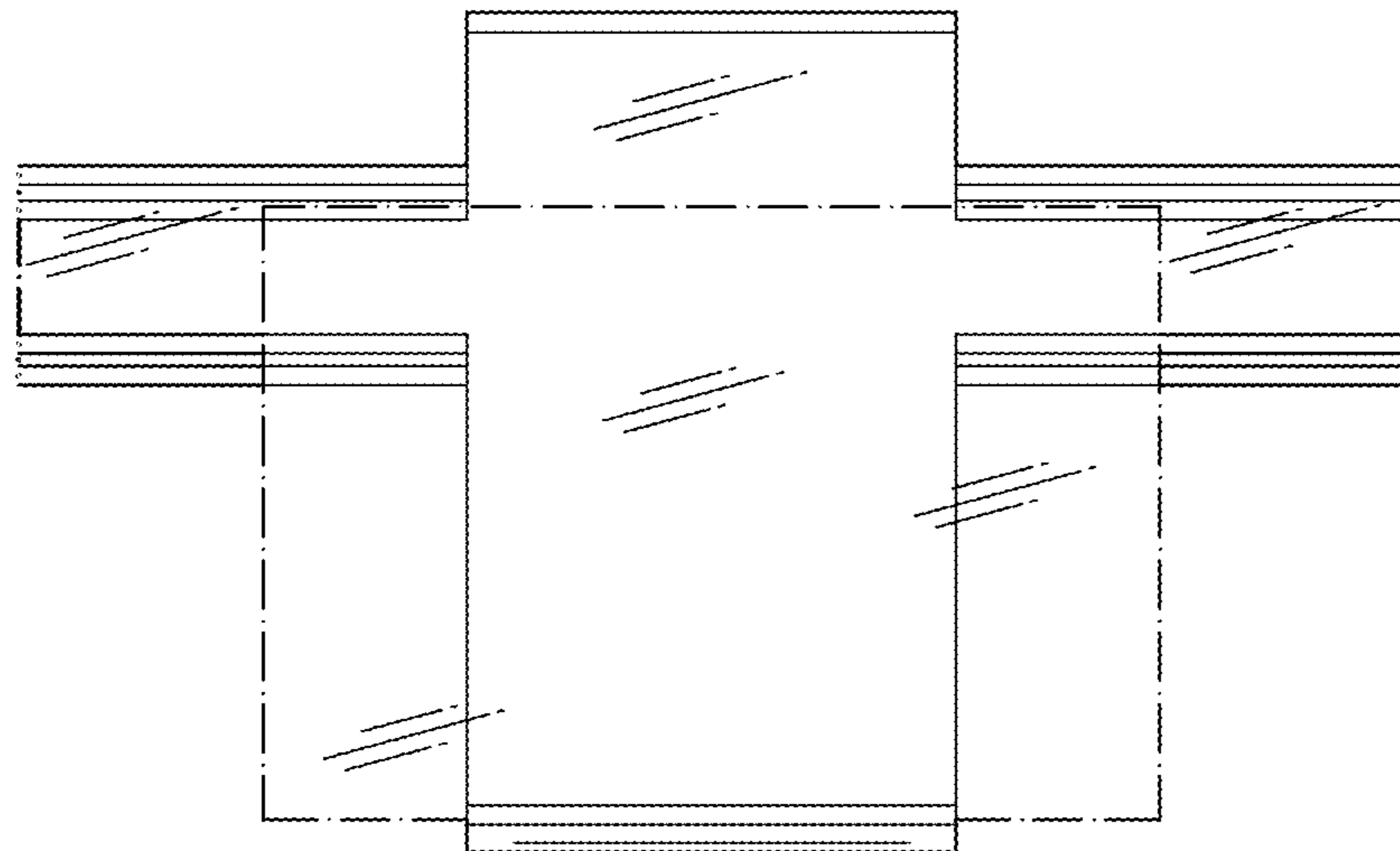
