DESCRIPTION

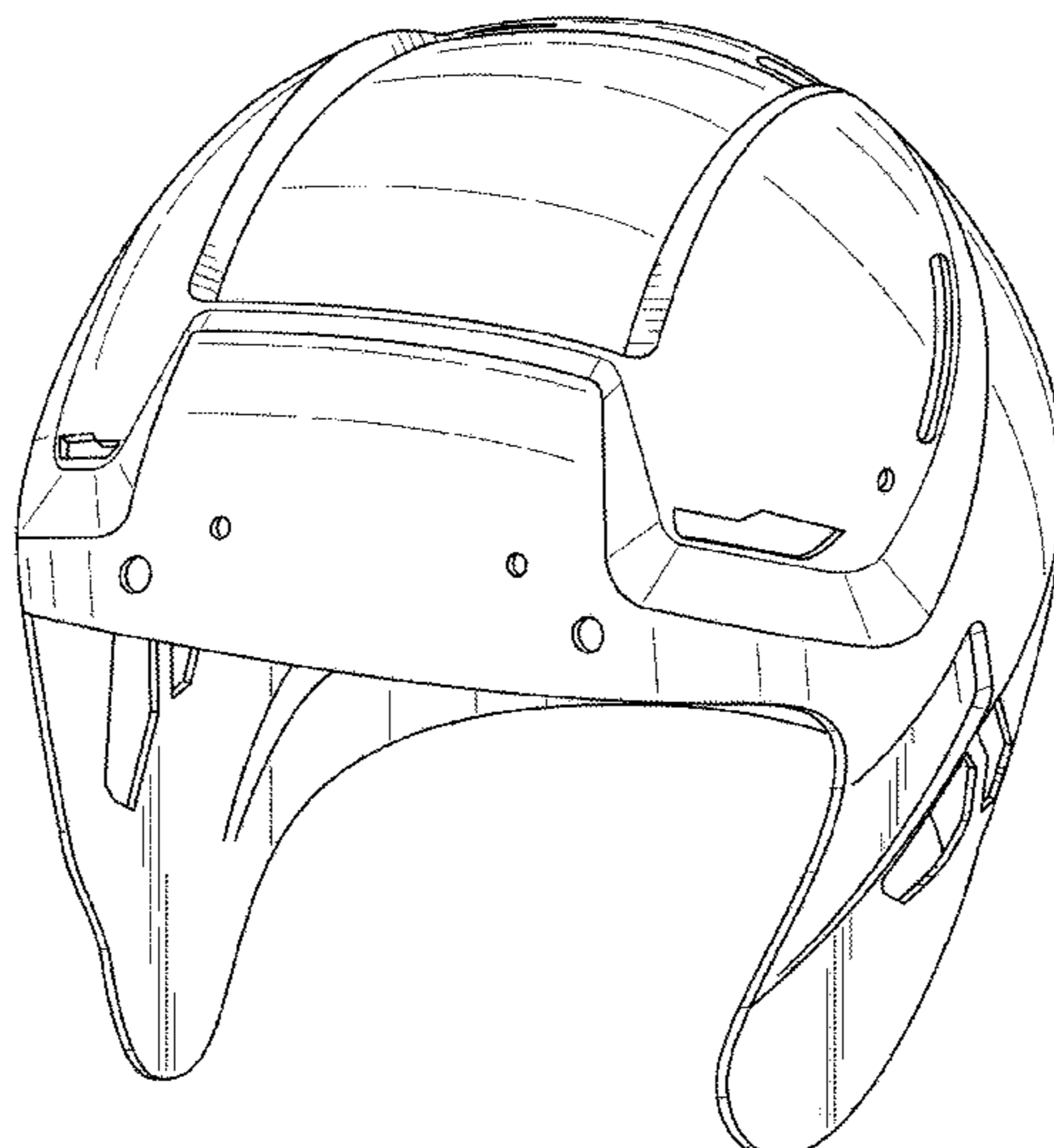
FIG. 1 is a left, top, perspective view of a football helmet shell showing our design therefor;

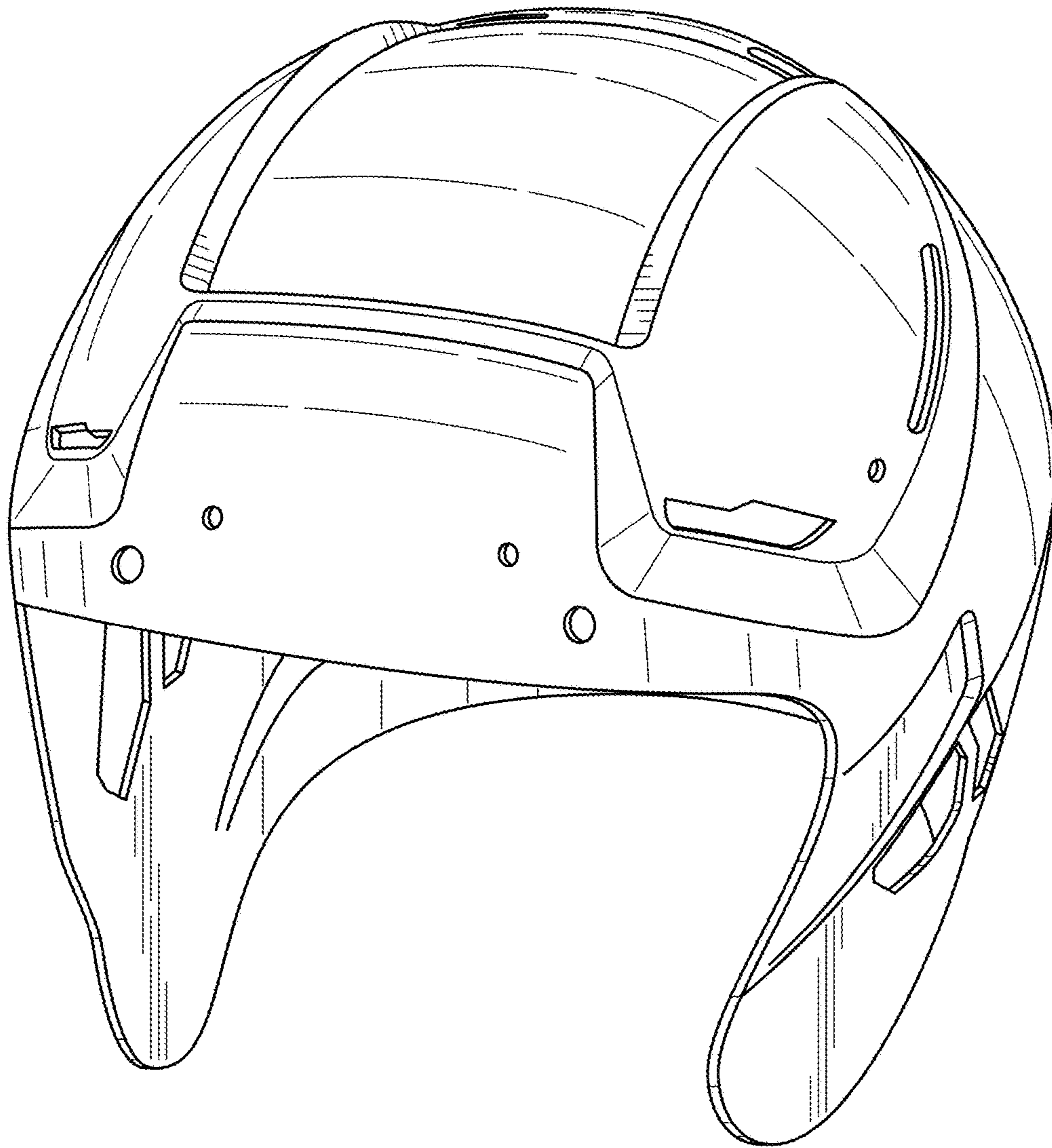

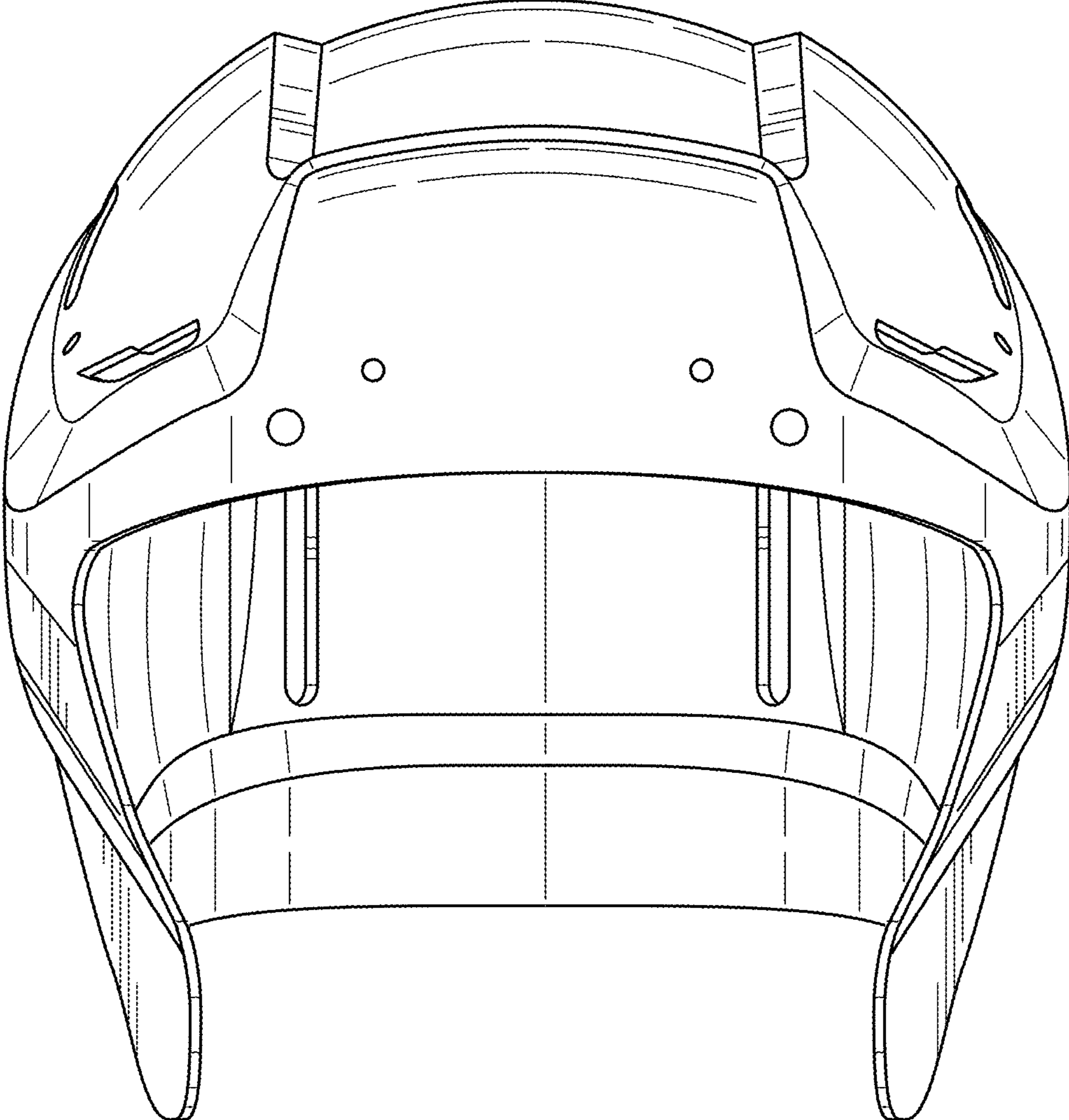

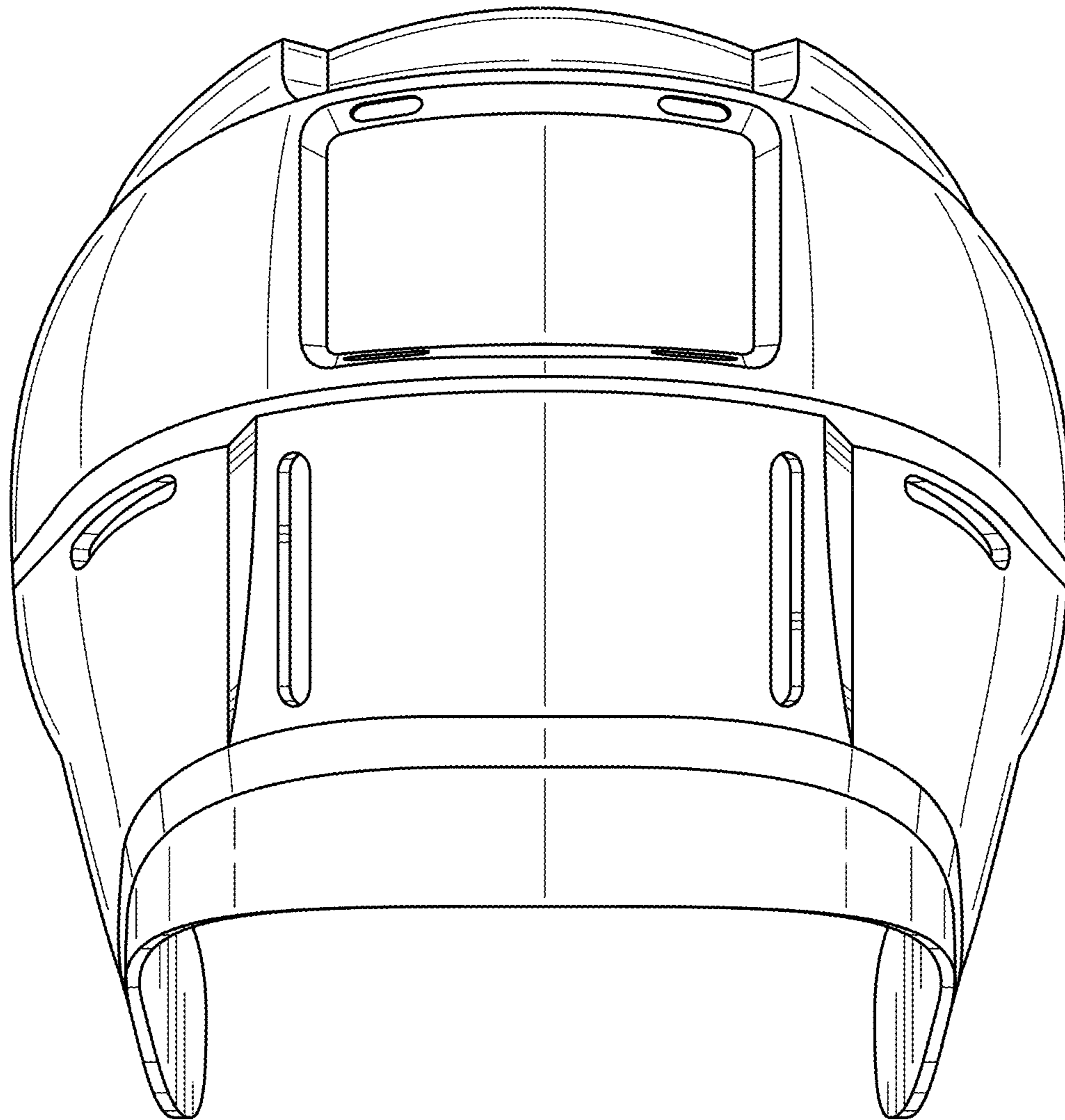

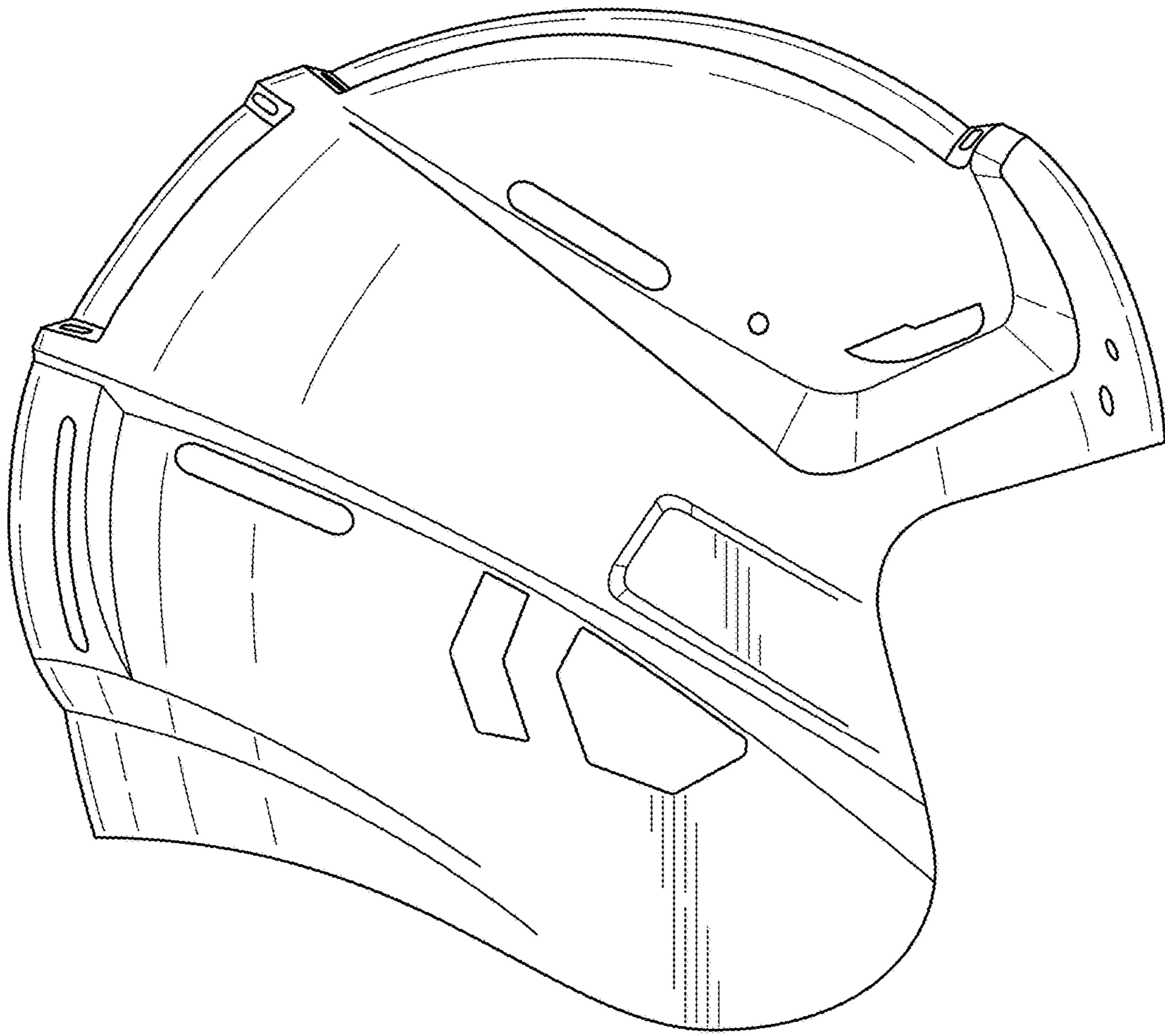

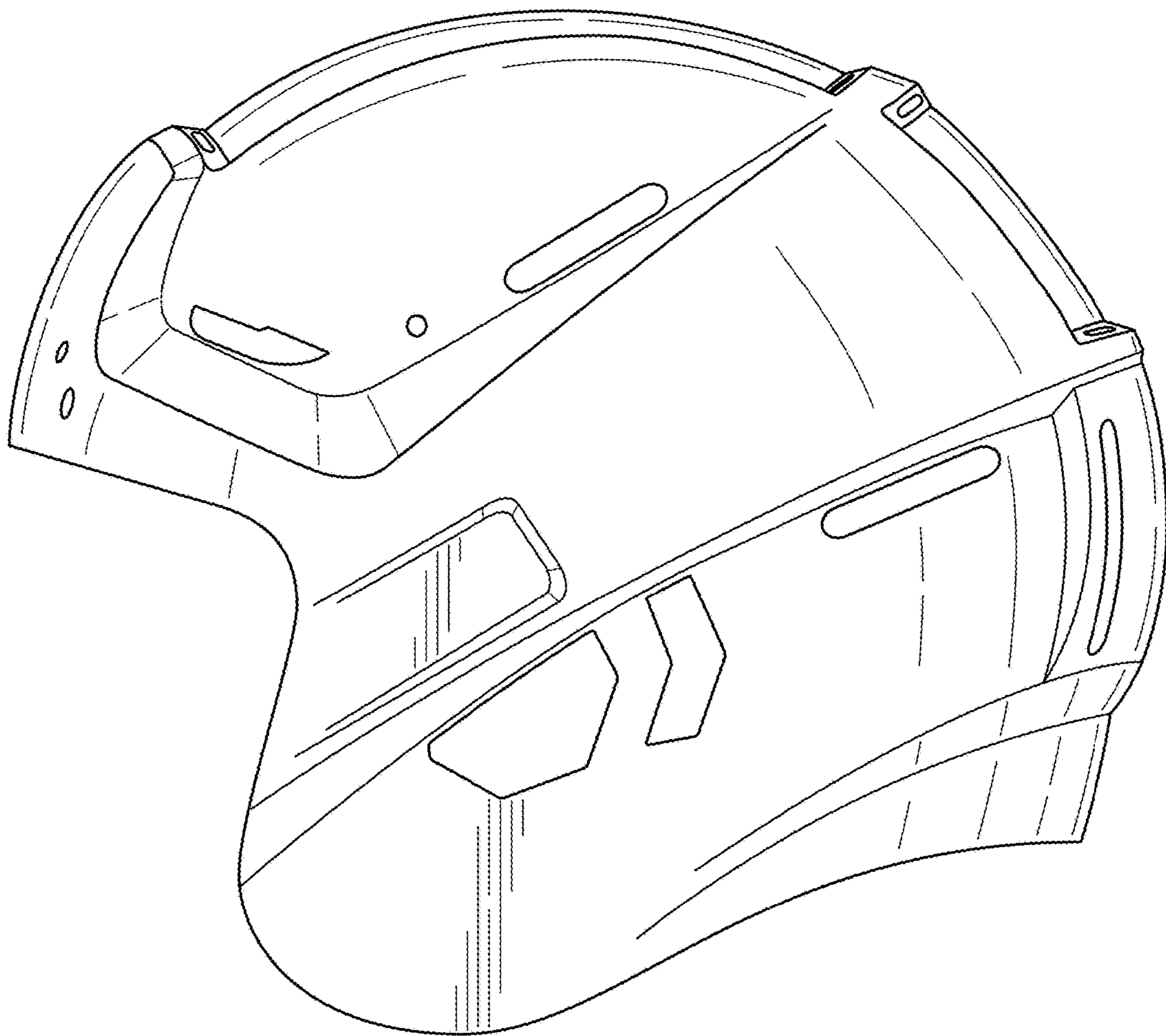

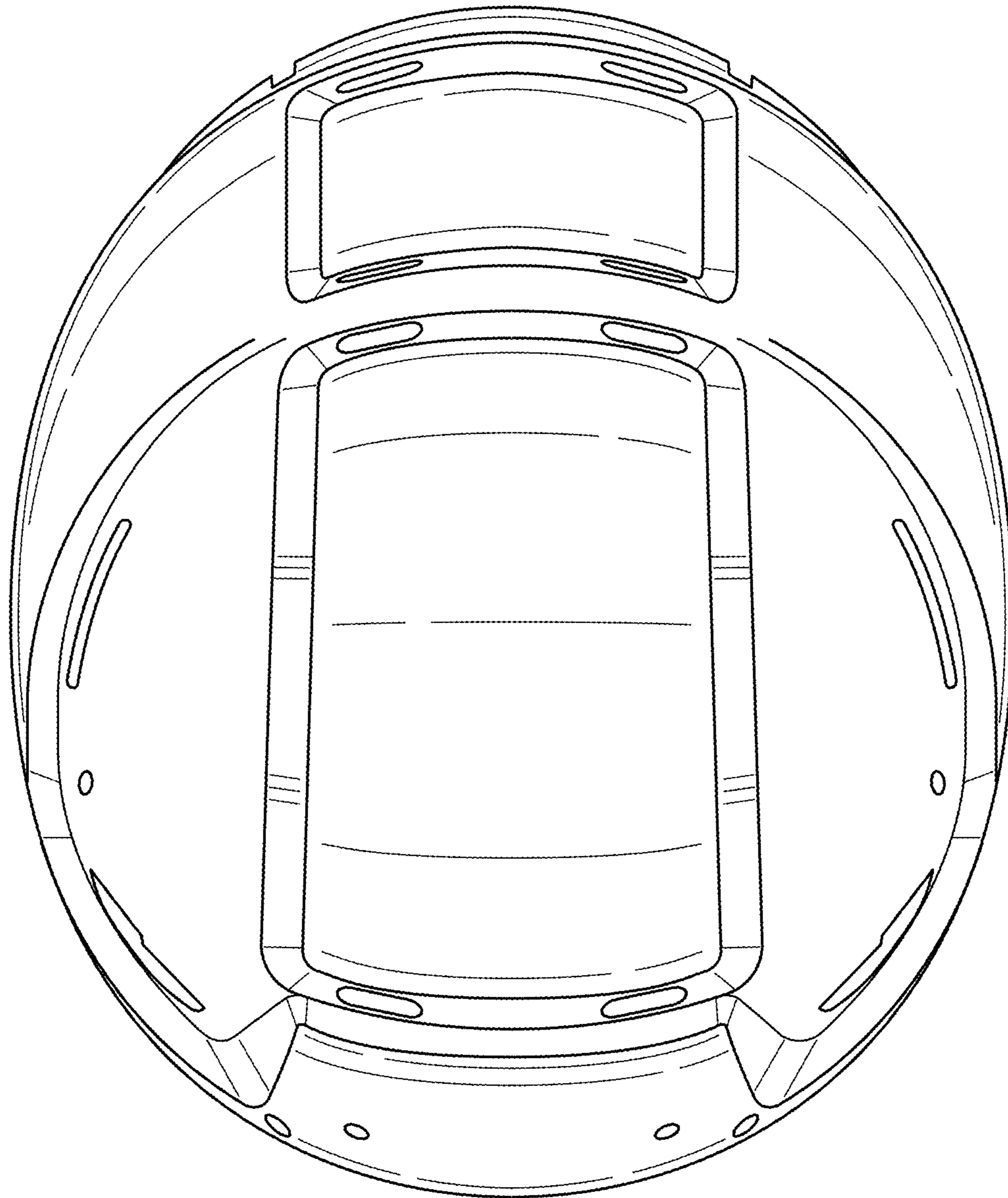

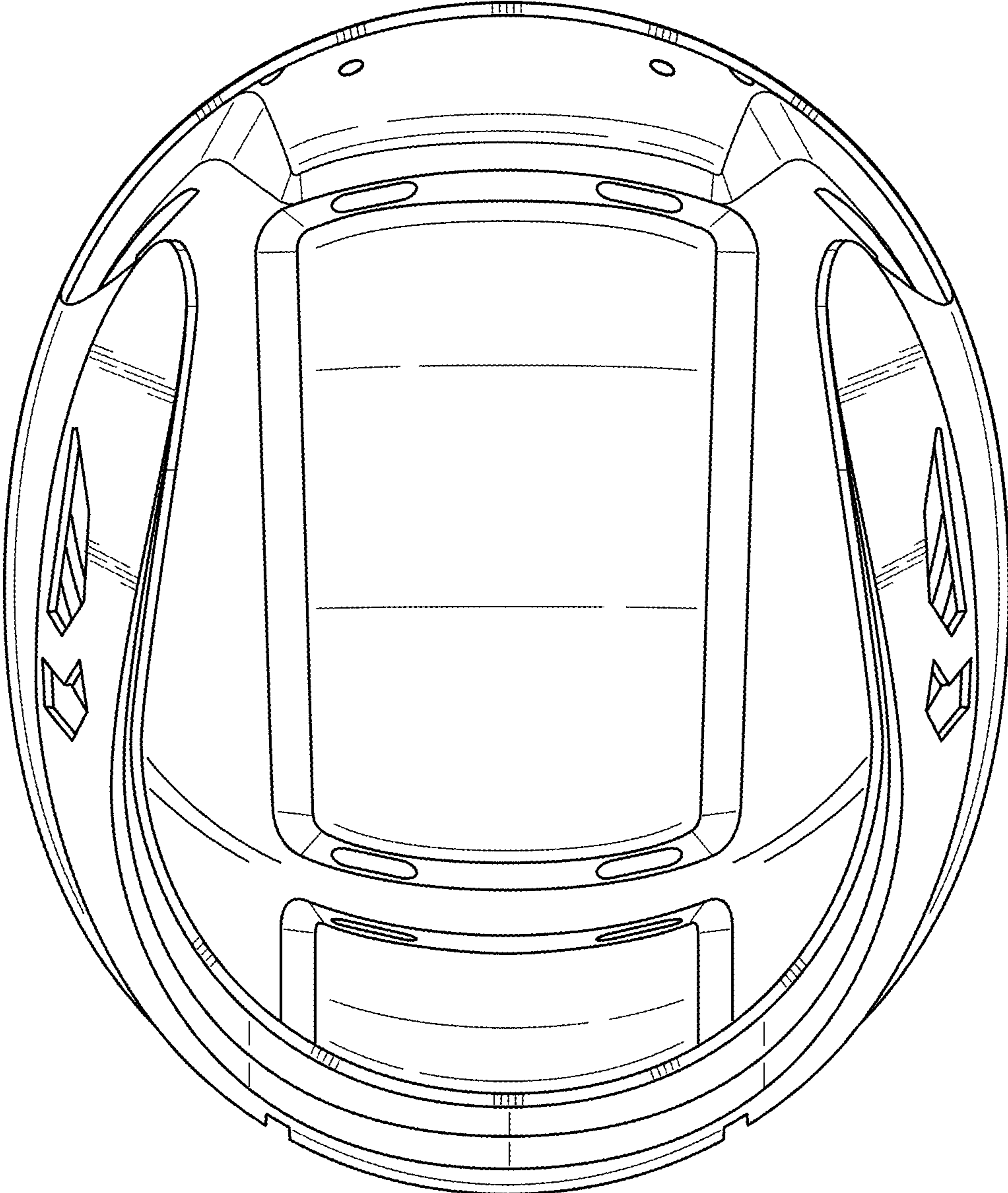
