(57) **CLAIM**

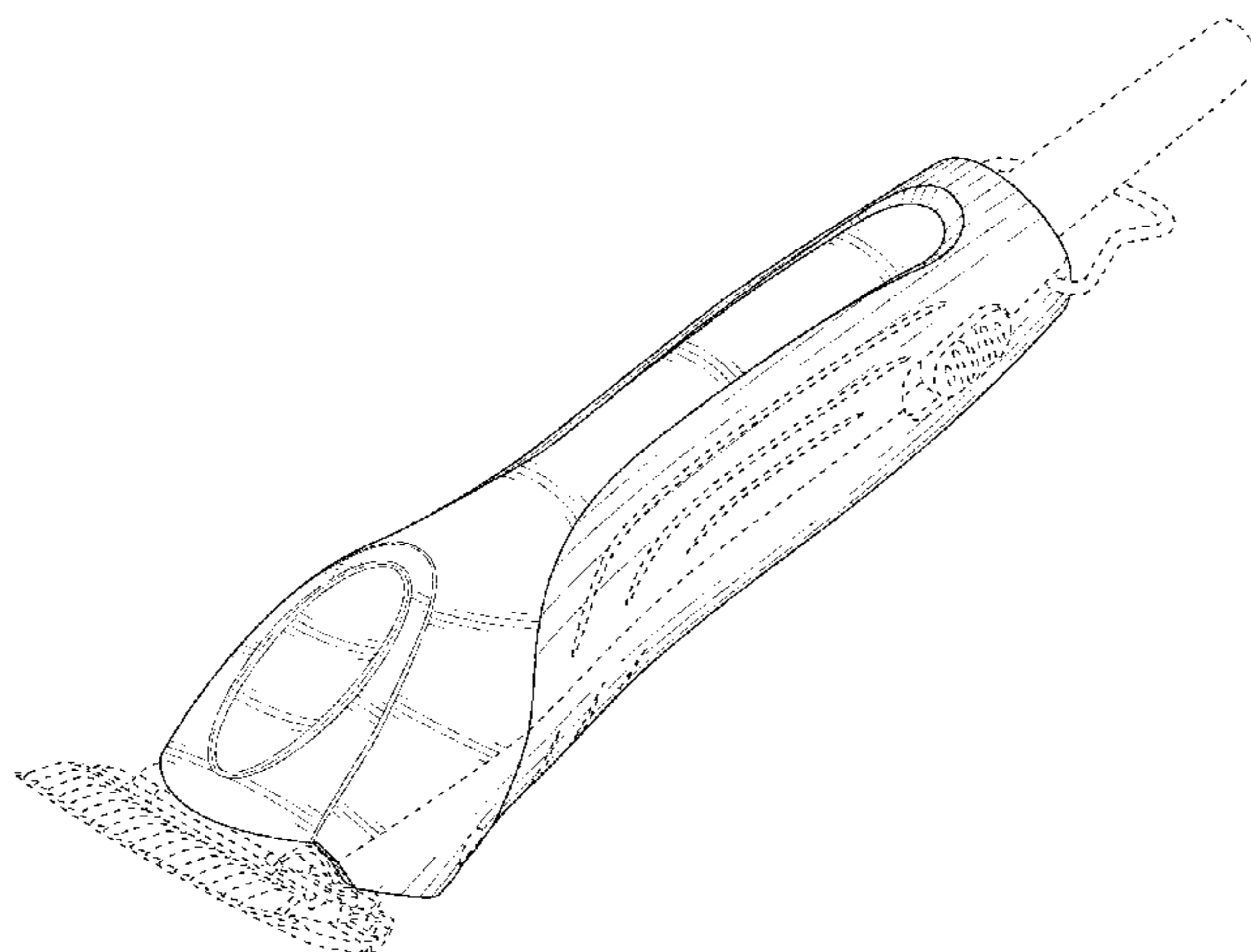
The ornamental design for the hair cutting device housing, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of the present hair cutting device housing;
FIG. 2 is a left side view of same;
FIG. 3 is a right side view of the hair cutting device housing of FIG. 1;
FIG. 4 is a front view of same;
FIG. 5 is a rear view of the hair cutting device housing of FIG. 1;
FIG. 6 is a top view of same; and,
FIG. 7 is a bottom view of same.

The unshaded, broken line features shown on the housing illustrate portions of the hair clipper device housing that form no part of the claimed design. The remaining broken lines illustrate the environment and form no part of the claimed design.

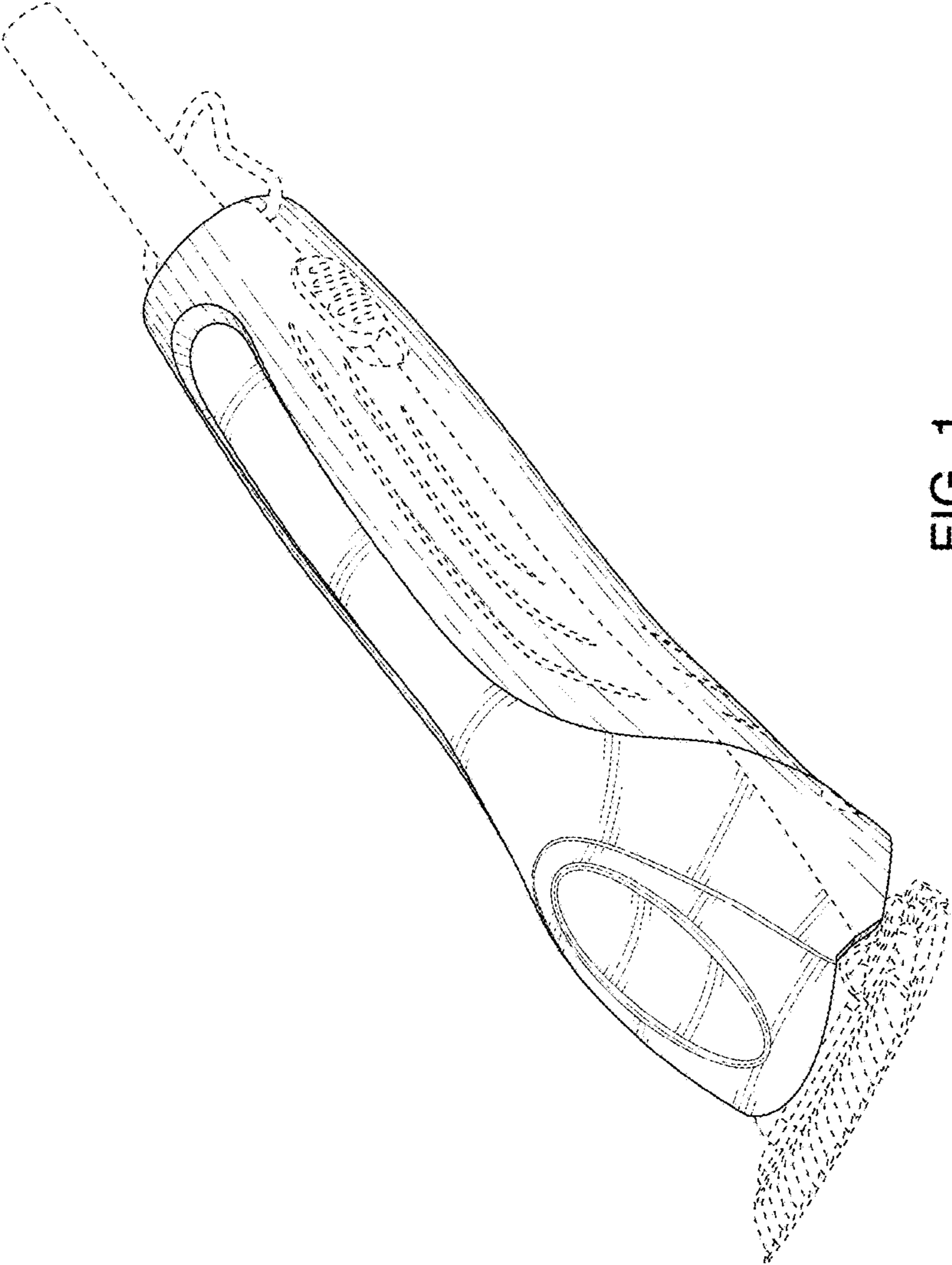

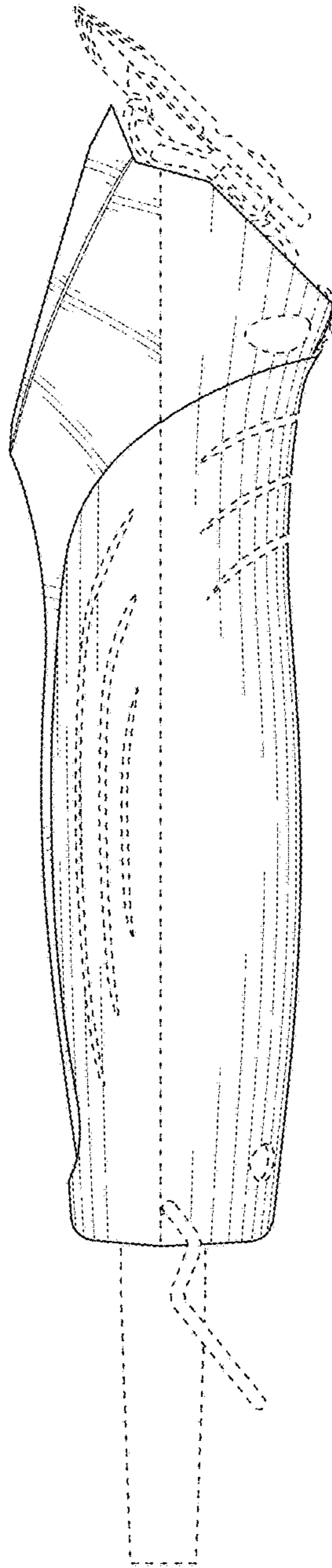

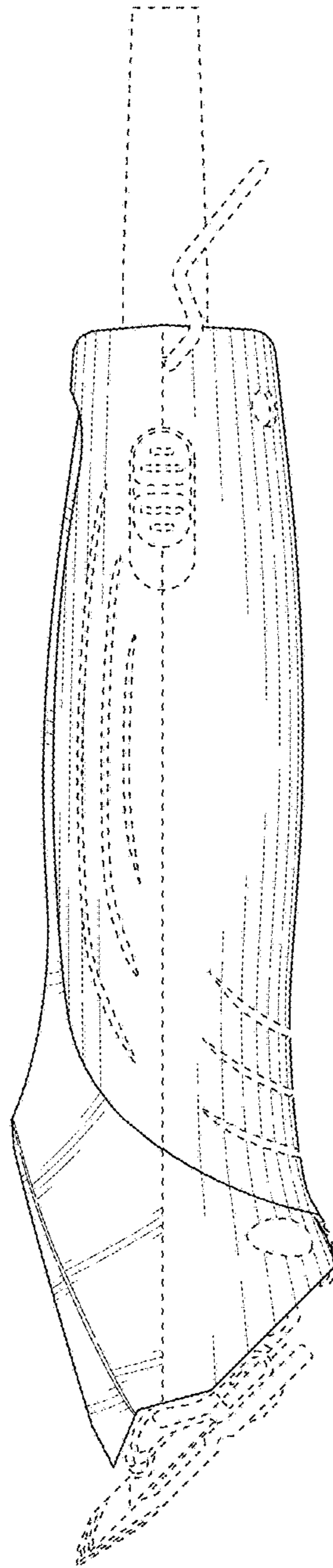

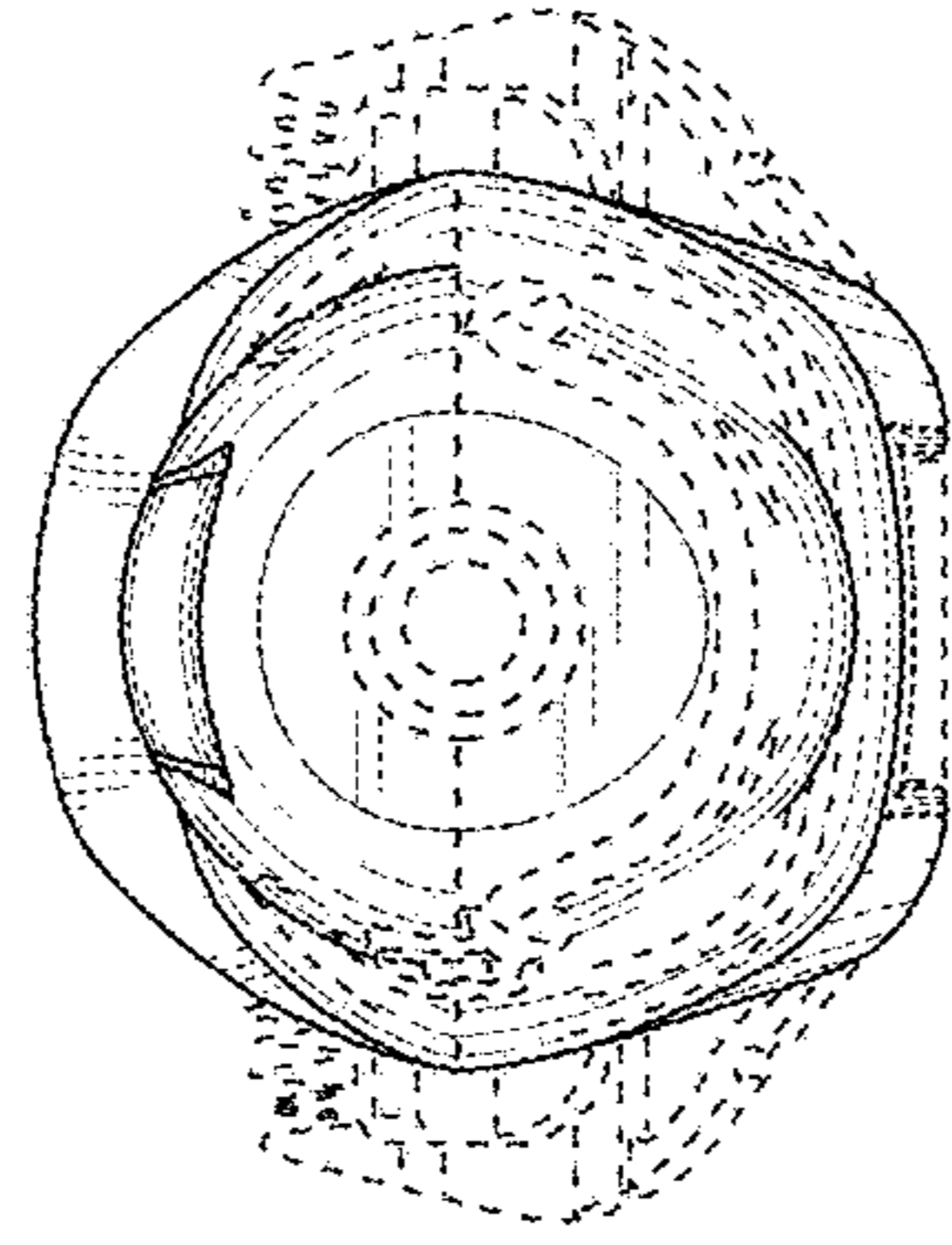

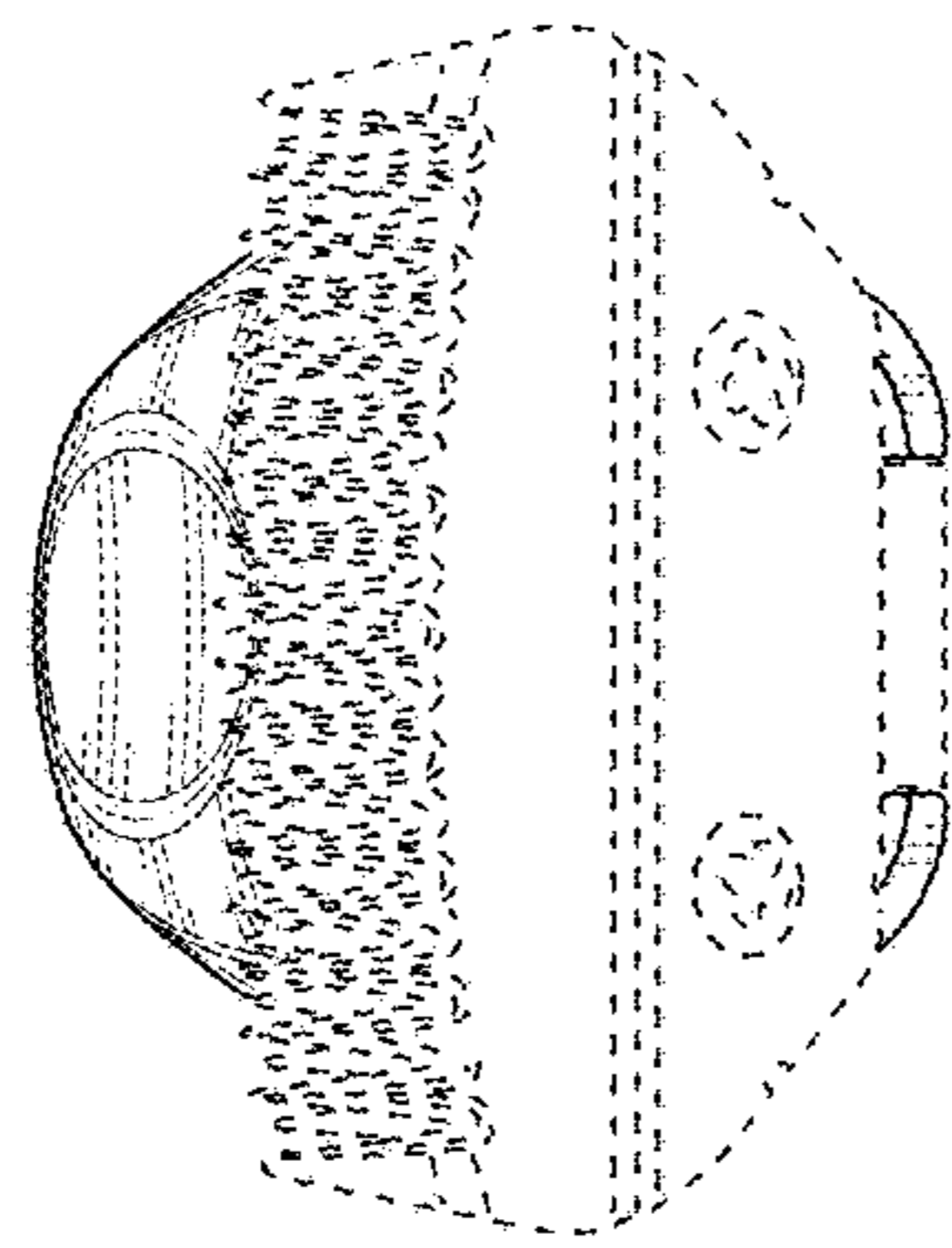

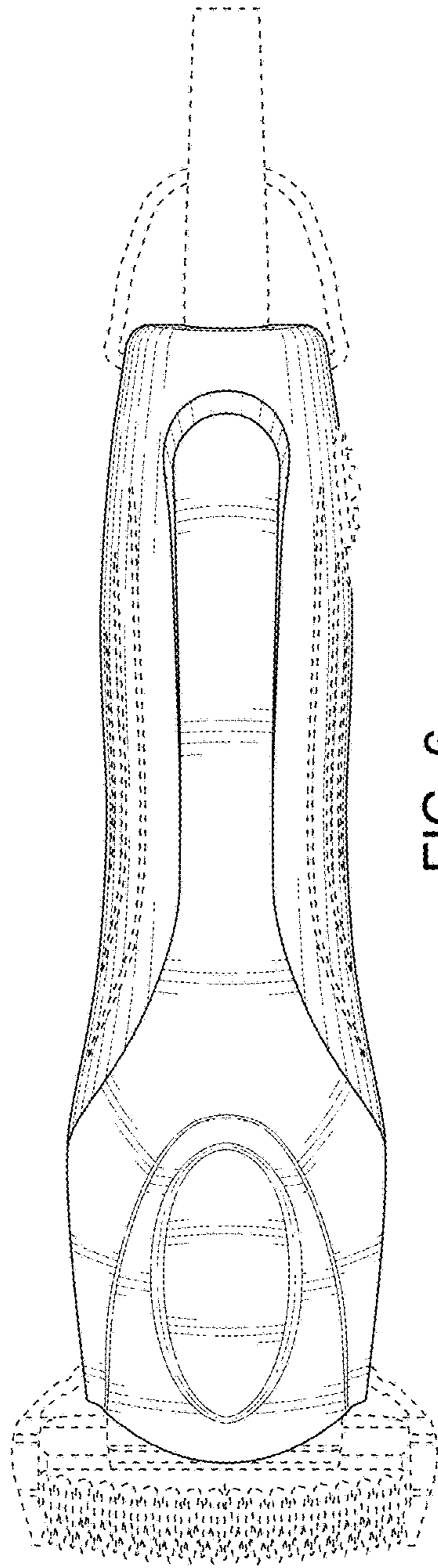

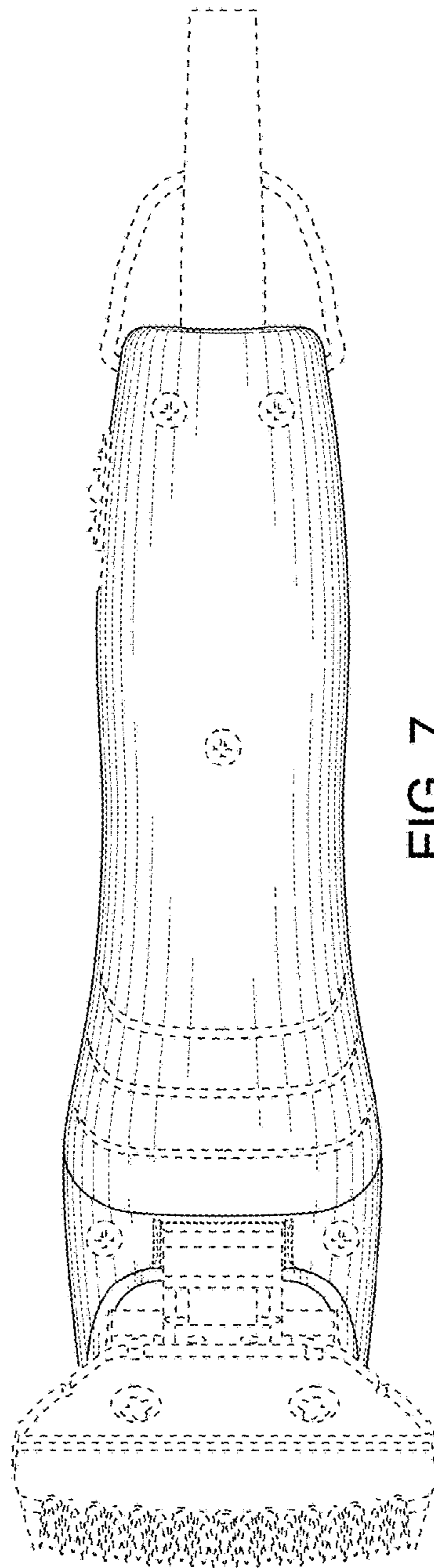
