The ornamental design of a handheld safety knife, as shown and described.

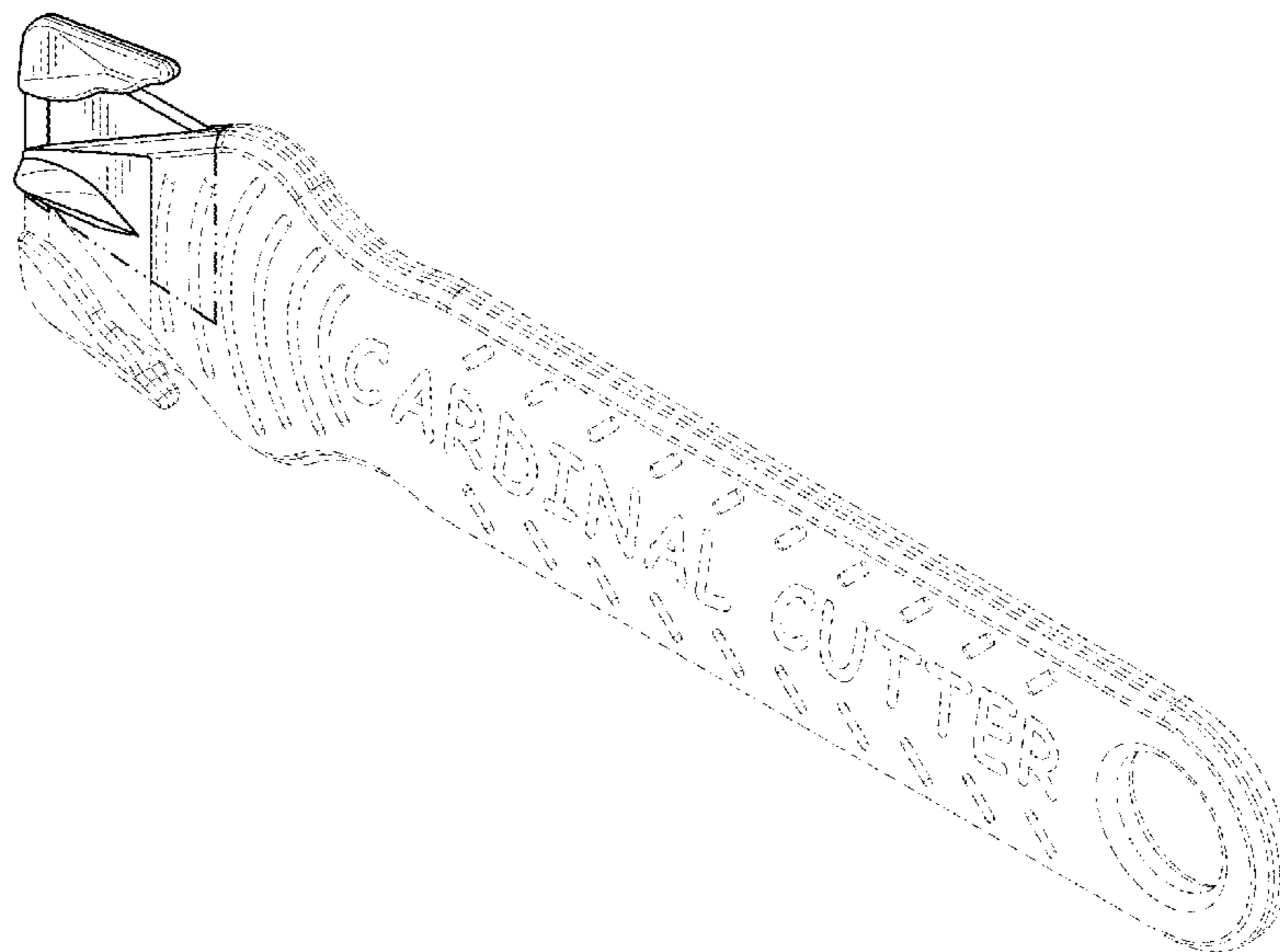
**DESCRIPTION**

FIG. 1 is a first perspective view of the handheld safety knife;  
 FIG. 2 is a second perspective view of the handheld safety knife;  
 FIG. 3 is a top view of the handheld safety knife;  
 FIG. 4 is a bottom view of the handheld safety knife;  
 FIG. 5 is a right-side view of the handheld safety knife;  
 FIG. 6 is a left-side view of the handheld safety knife;  
 FIG. 7 is an elevation view of the handheld safety knife; and,  
 FIG. 8 is an elevation view of the handheld safety knife from a side opposite that shown in FIG. 7.

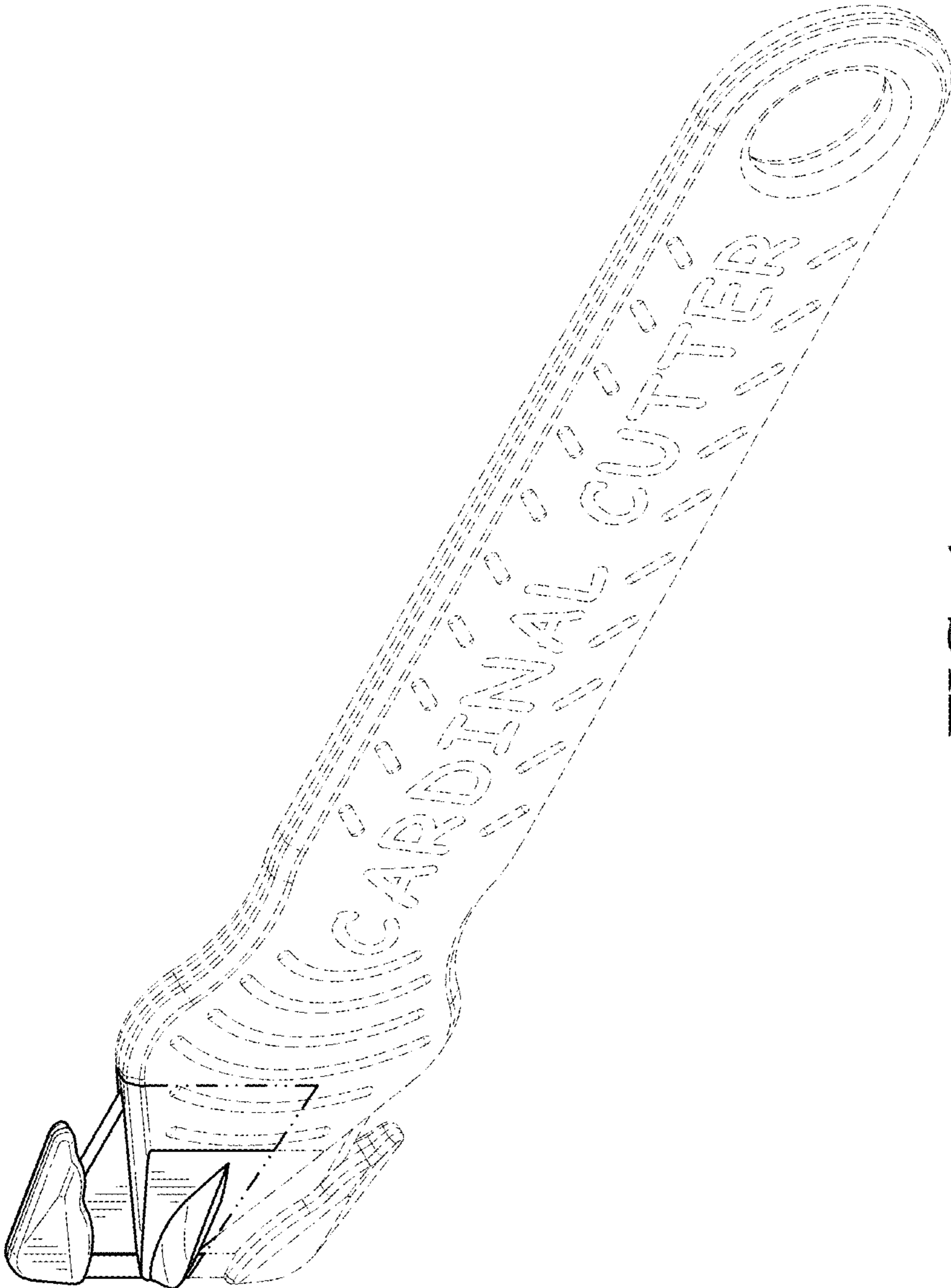

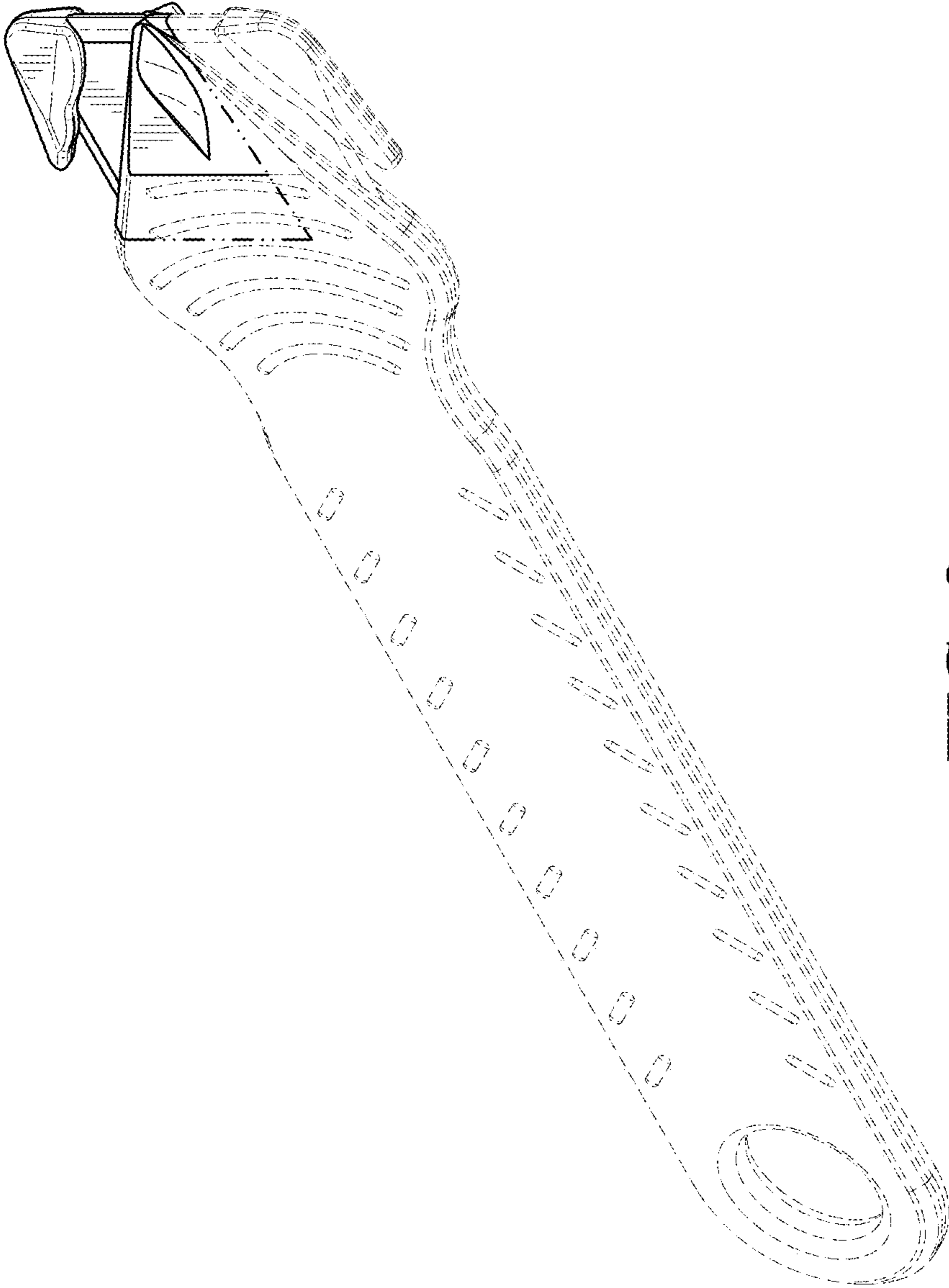

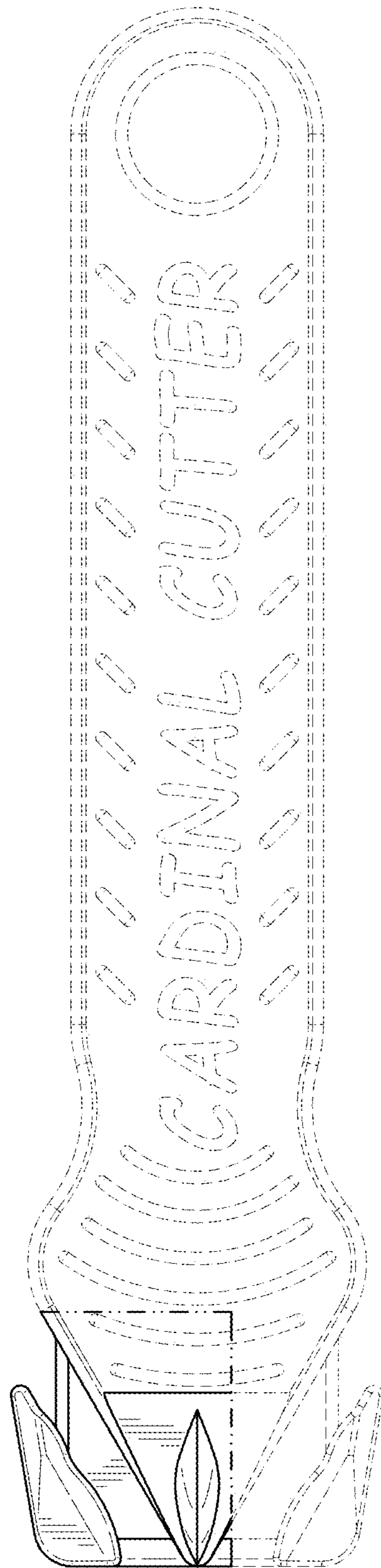

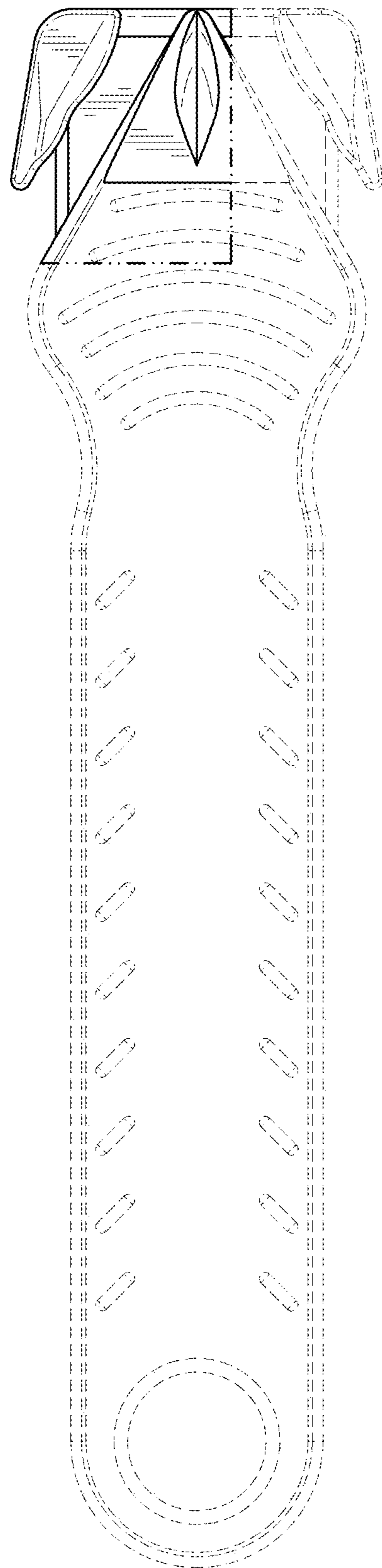

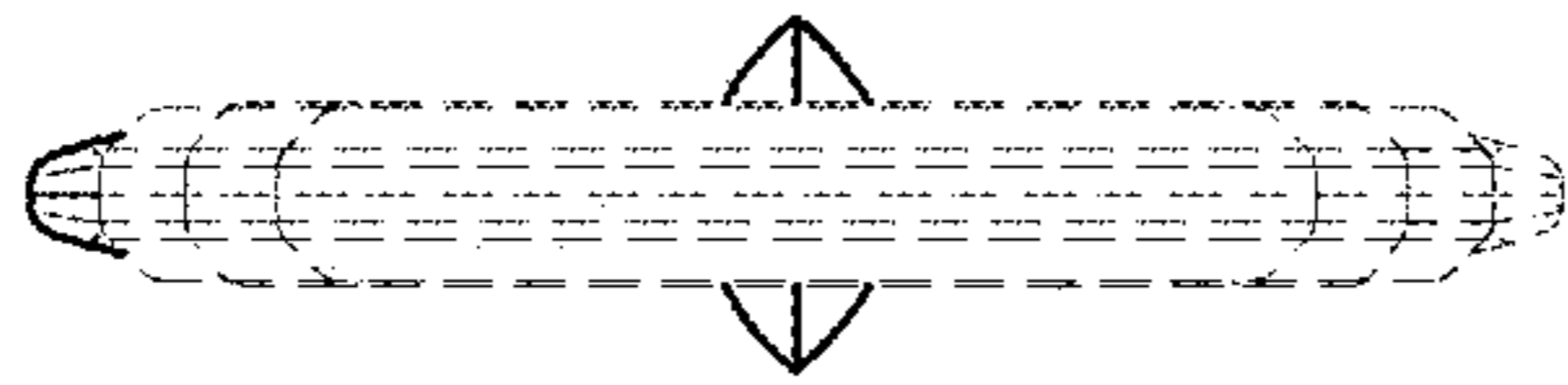

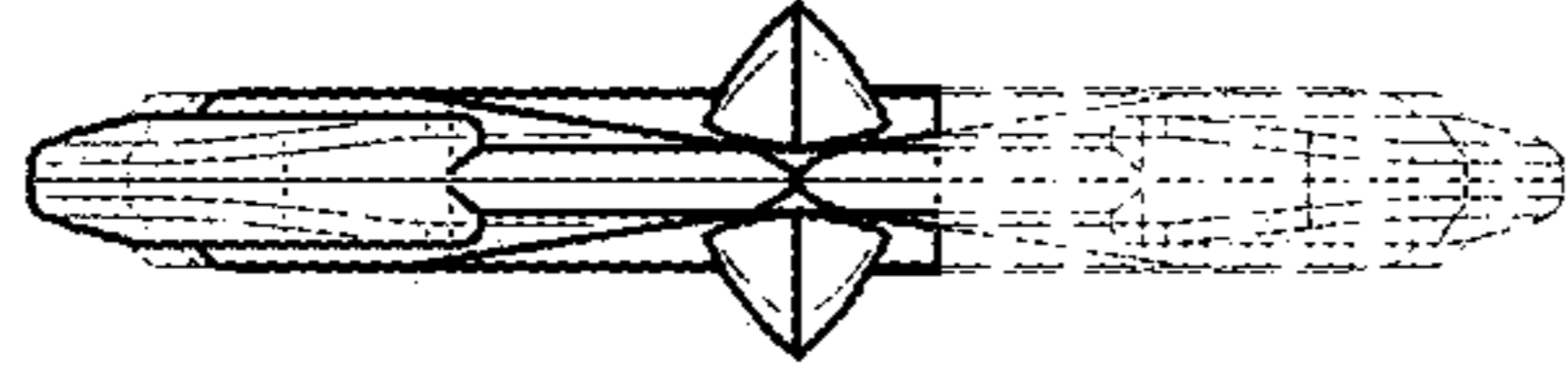

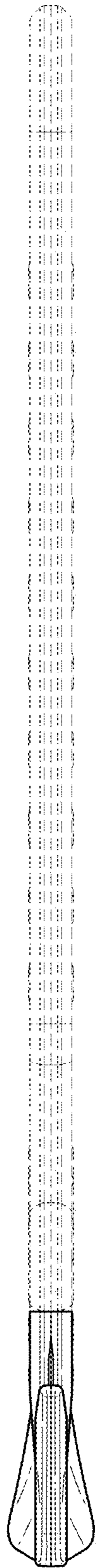

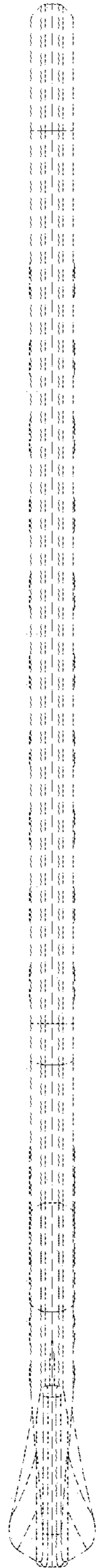
