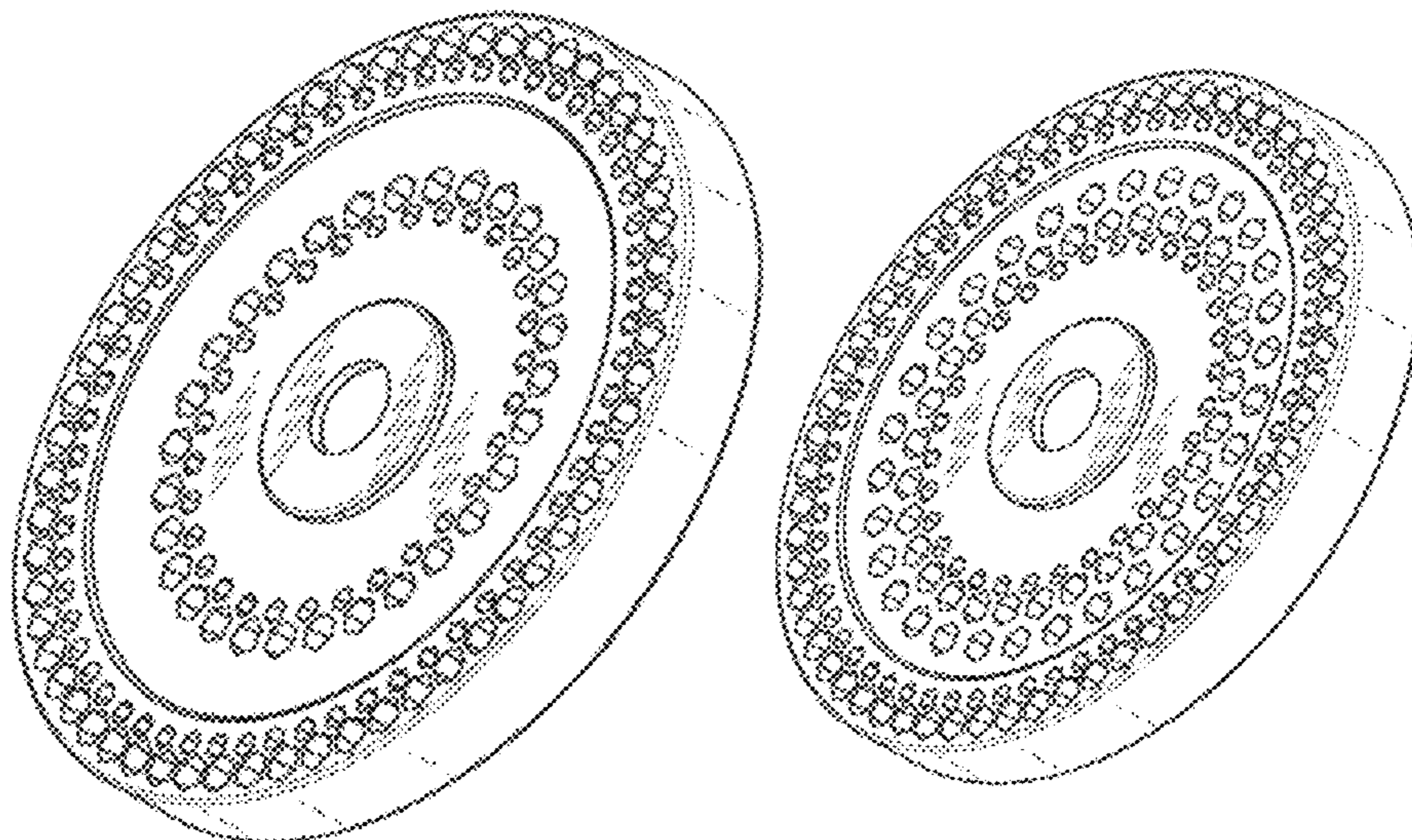
(57) **CLAIM**

The ornamental design for a weight plate, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a first embodiment of a weight plate showing my new design, the bottom perspective view being a mirror image;
FIG. 2 is a top plan view thereof;
FIG. 3 is a bottom plan view thereof which is a mirror image of the top plan view;
FIG. 4 is a left side elevational view thereof;
FIG. 5 is a right side elevational view thereof which is a mirror image of the left side elevational view;
FIG. 6 is a front elevational view thereof;
FIG. 7 is a rear elevational view thereof which is a mirror image of the front elevational view;
FIG. 8 is a top perspective view of a second embodiment of the weight plate, the bottom perspective view being a mirror image;
FIG. 9 is a top plan view thereof;
FIG. 10 is a bottom plan view thereof which is a mirror image of the top plan view;
FIG. 11 is a left side elevational view thereof;
FIG. 12 is a right side elevational view thereof which is a mirror image of the left side elevational view;
FIG. 13 is a front elevational view thereof;
FIG. 14 is a rear elevational view thereof which is a mirror image of the front elevational view;
FIG. 15 is a cross sectional view of the weight plate of FIG. 9 along the line referenced as 15; and,
FIG. 16 is a cross sectional view of the weight plate of FIG. 9 along the line referenced as 16.

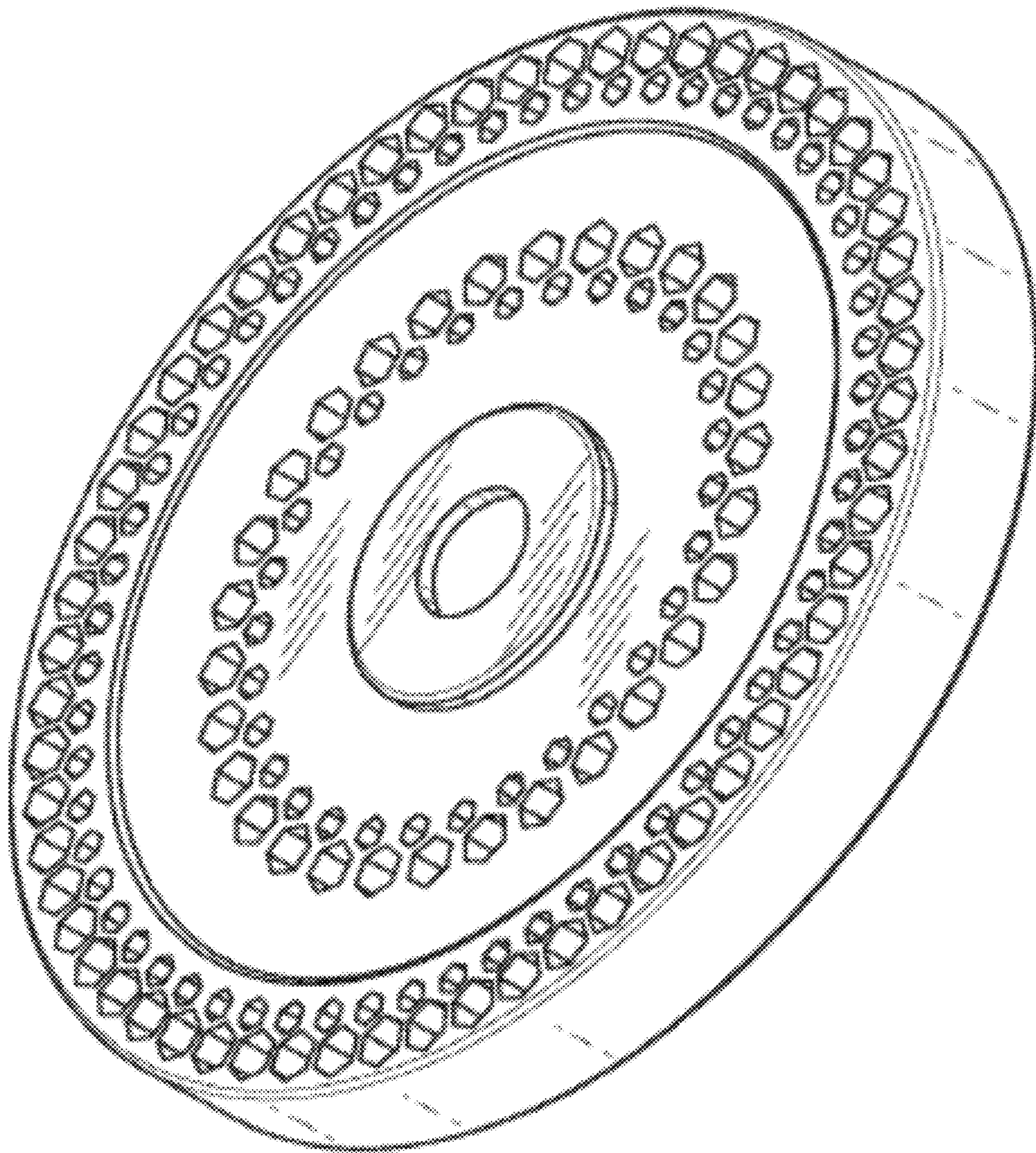

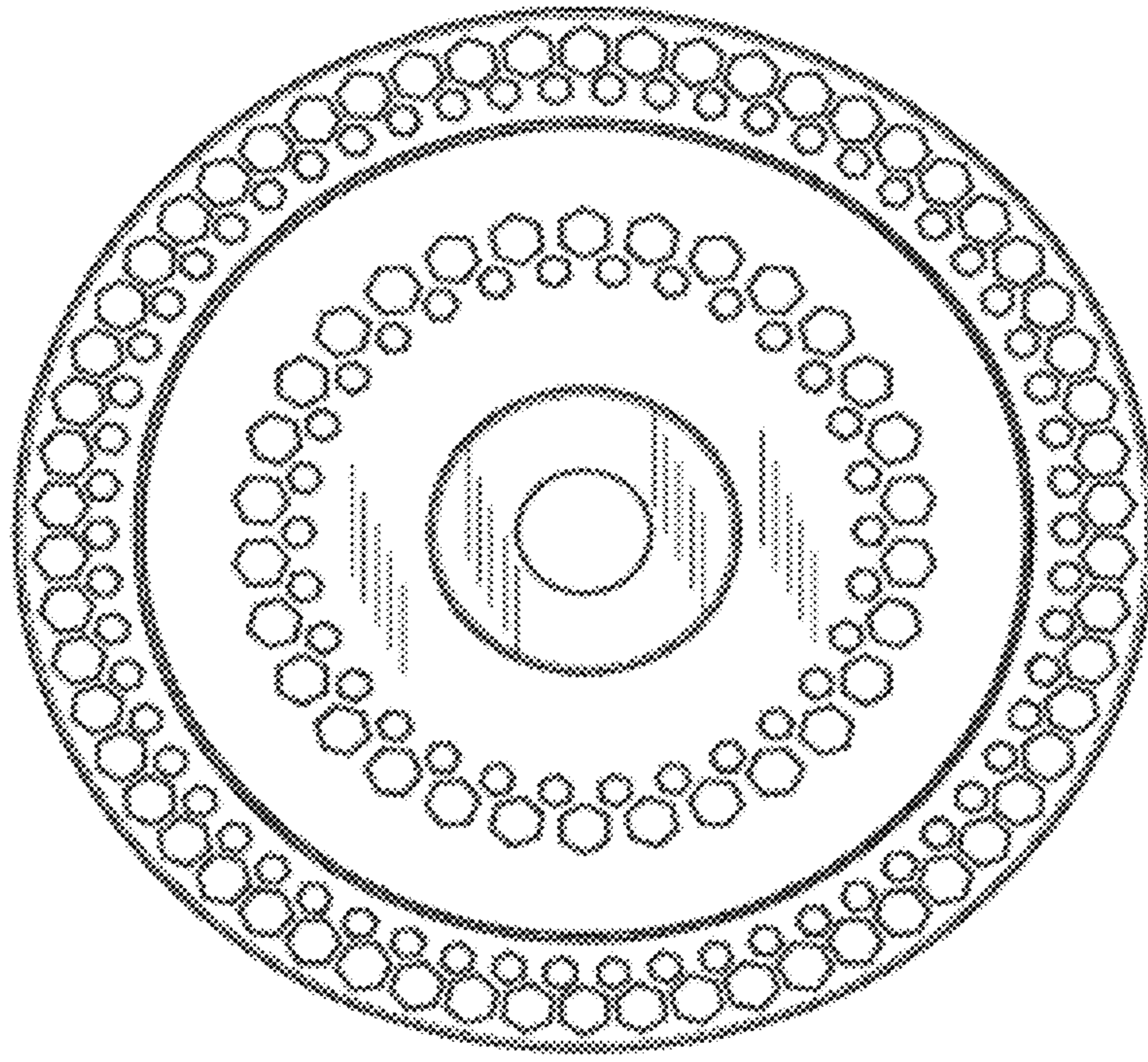

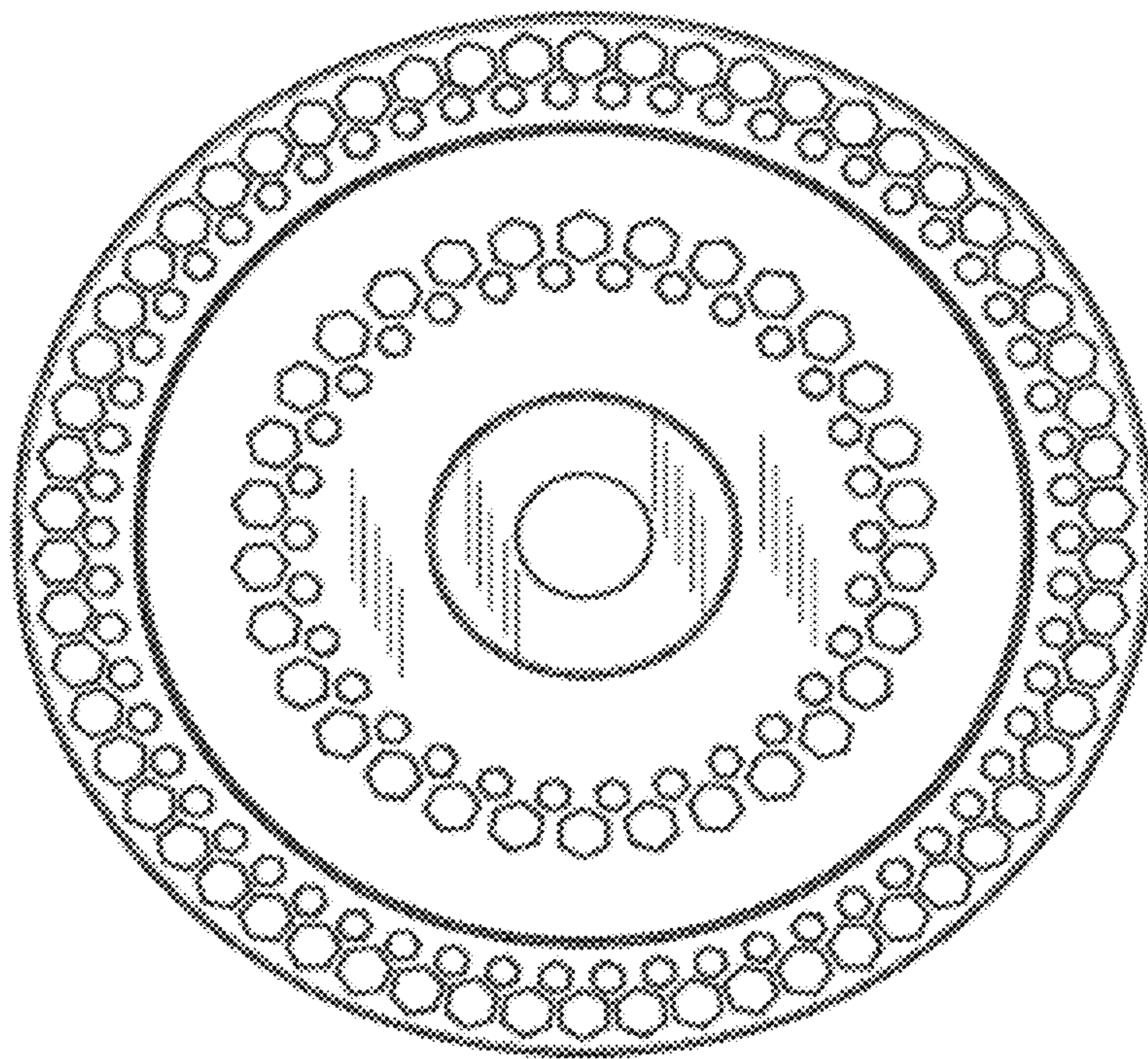

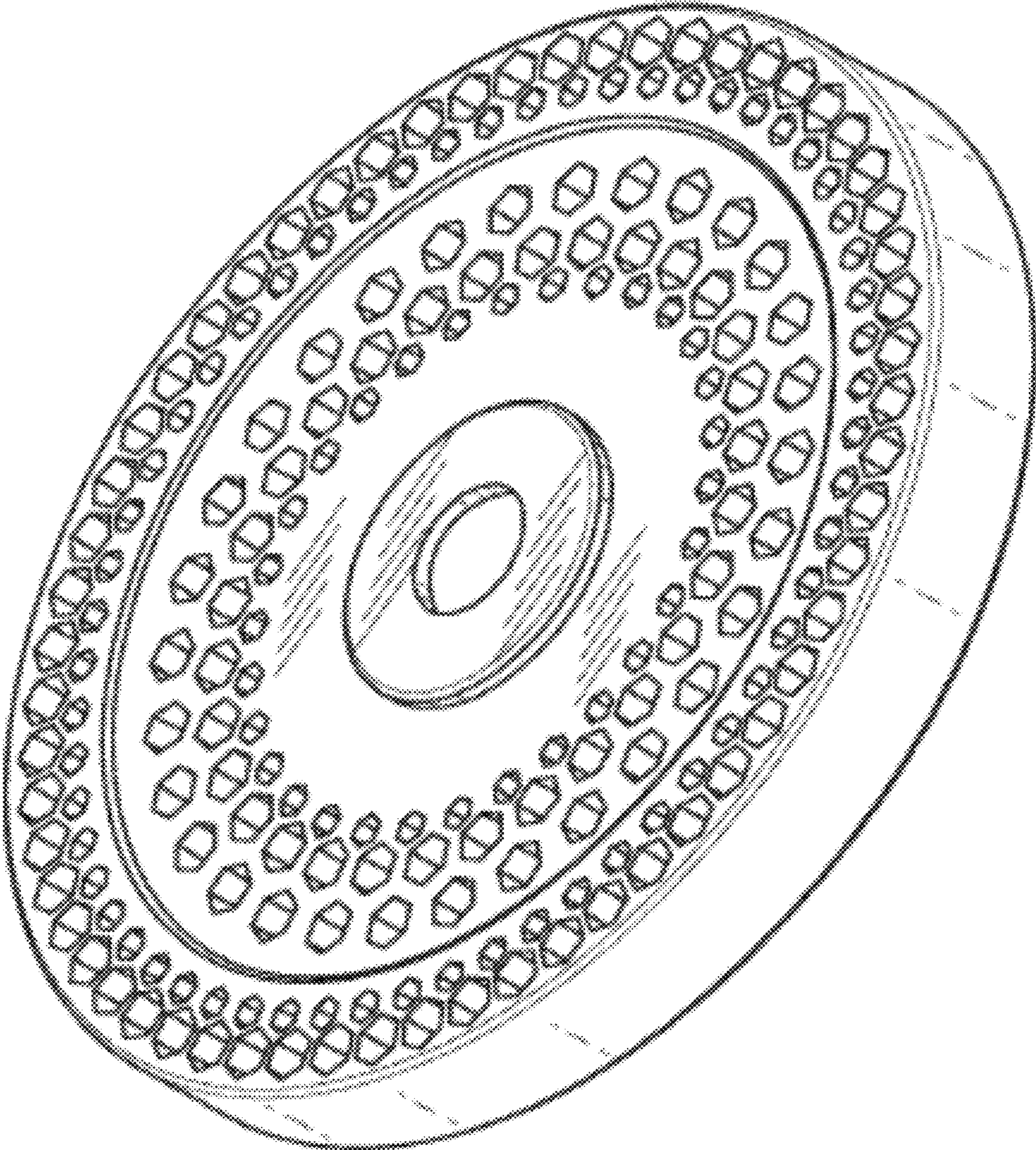

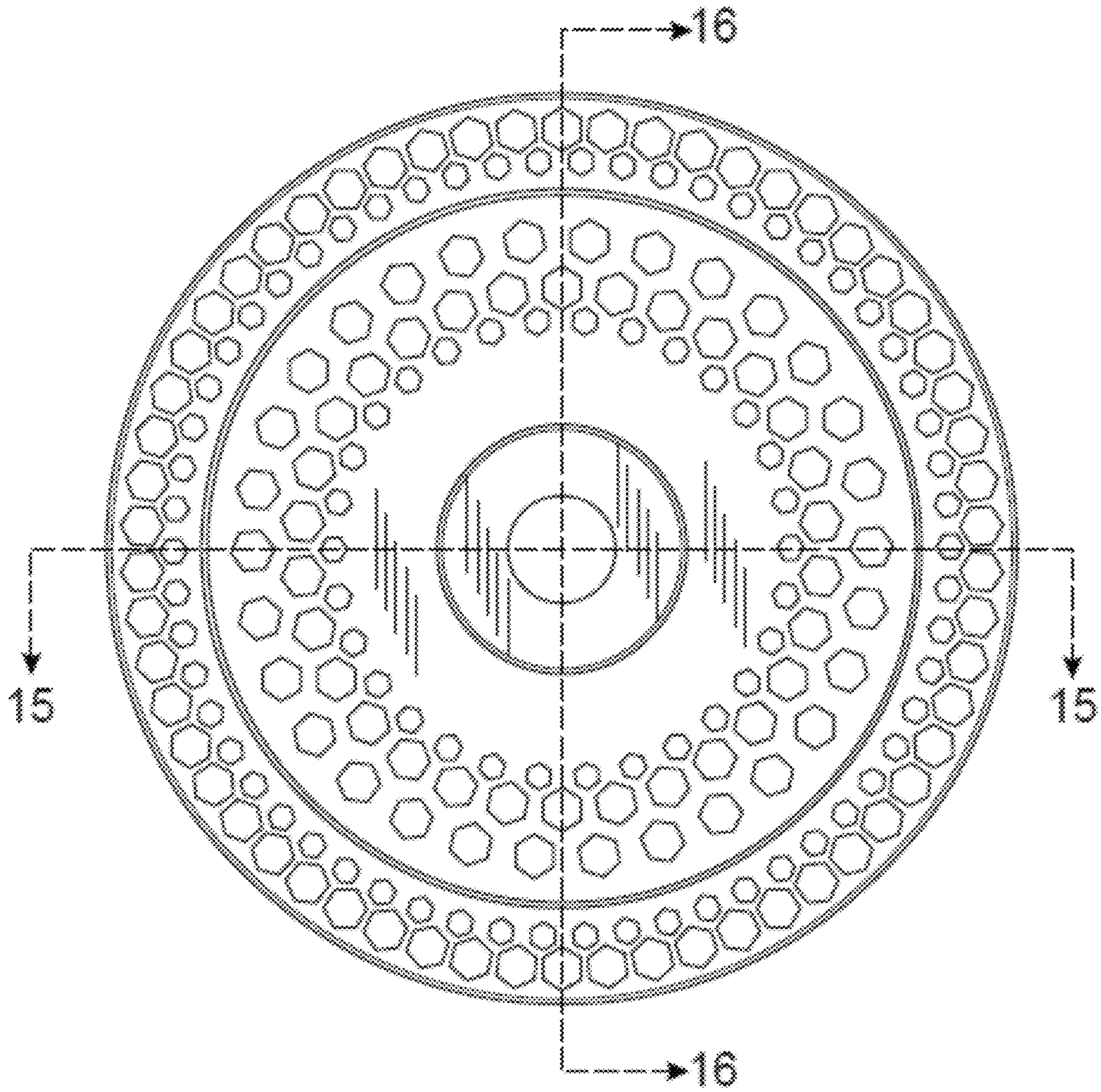

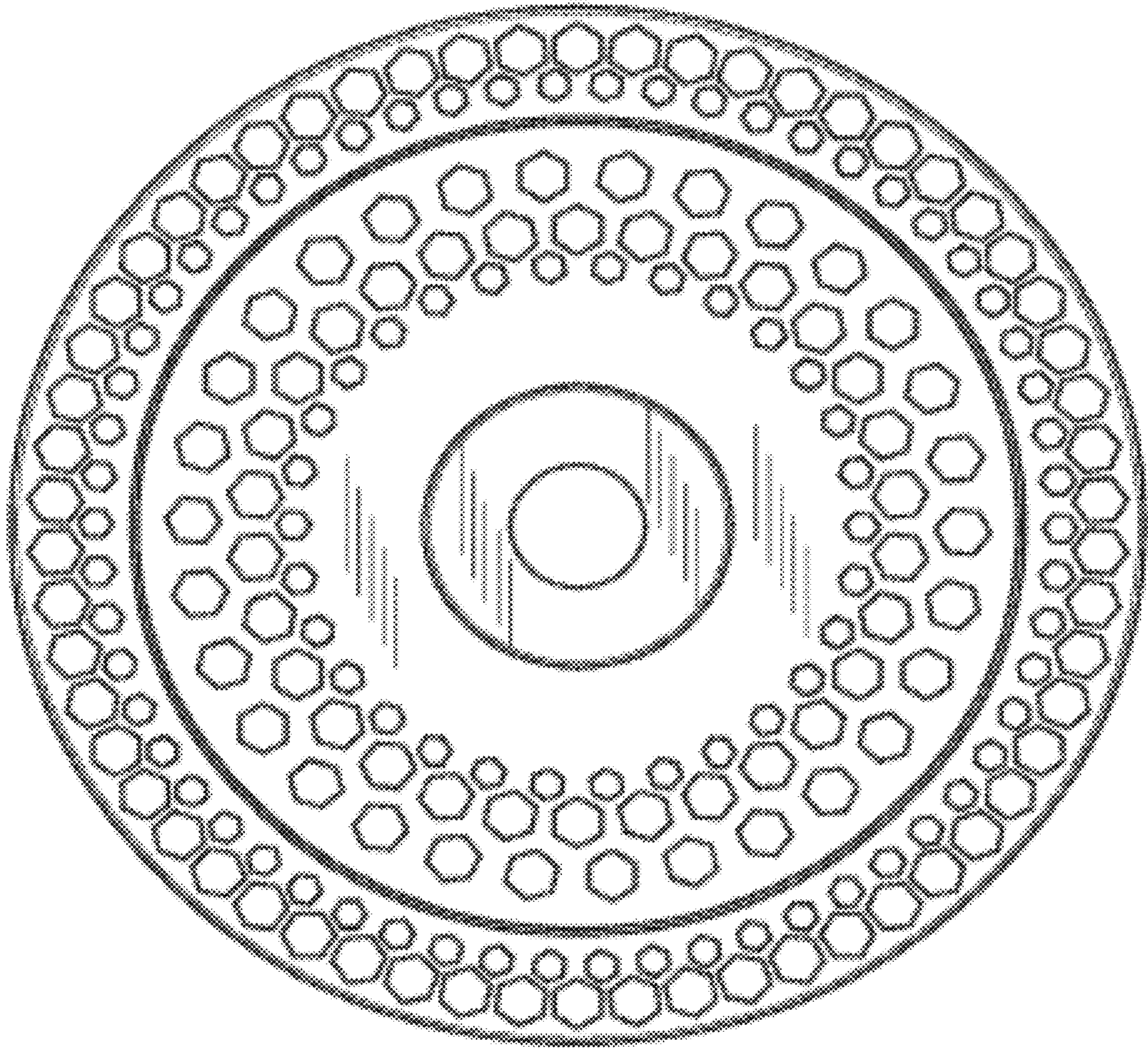

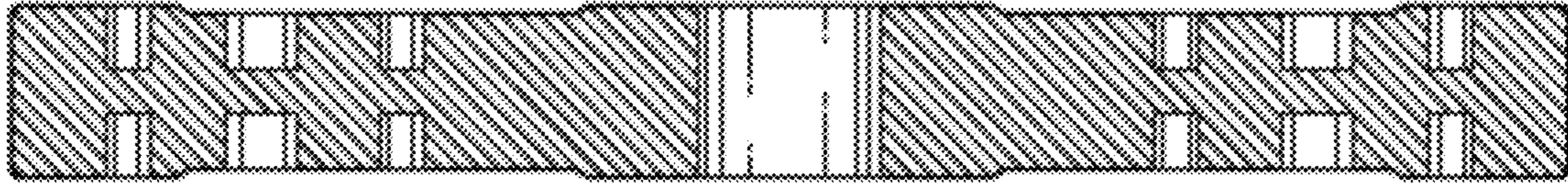

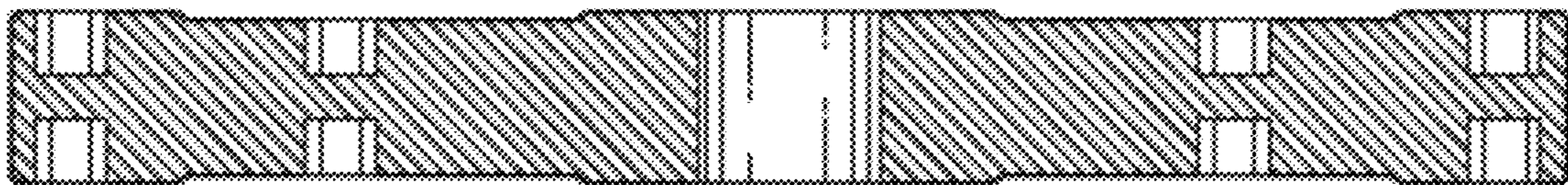
