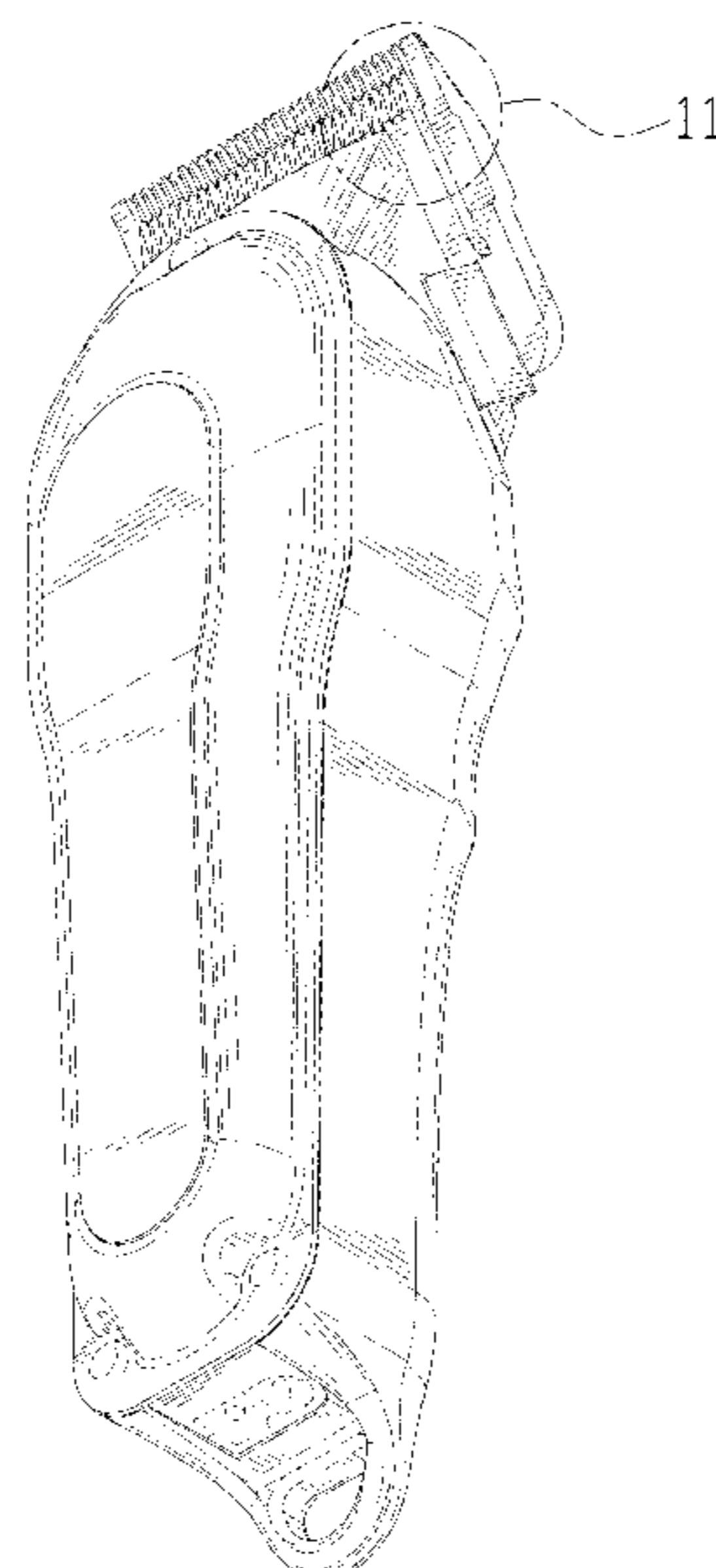
FIG. 1 is a front, right, and top perspective view of a hair clippers, showing our design.

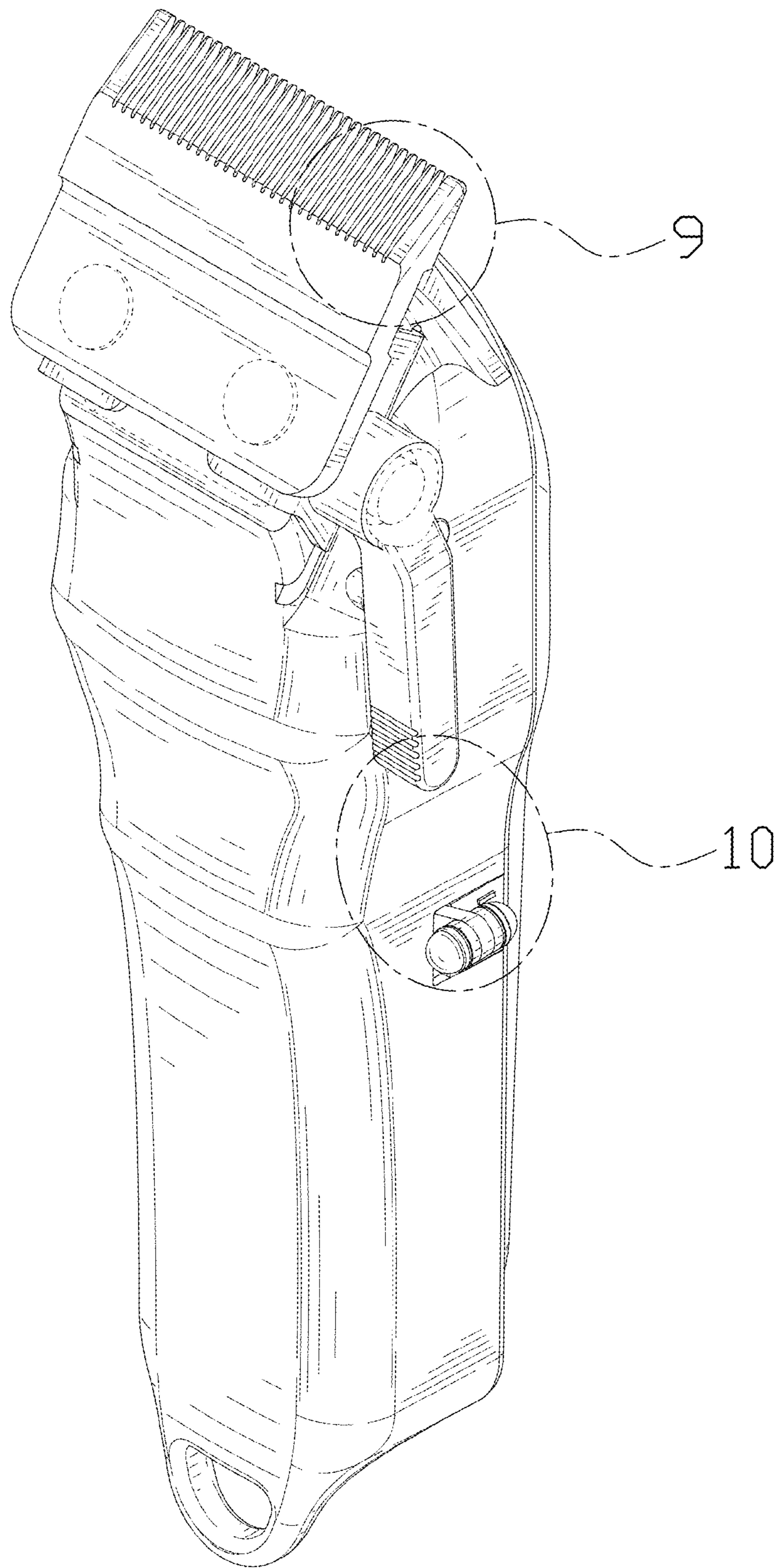

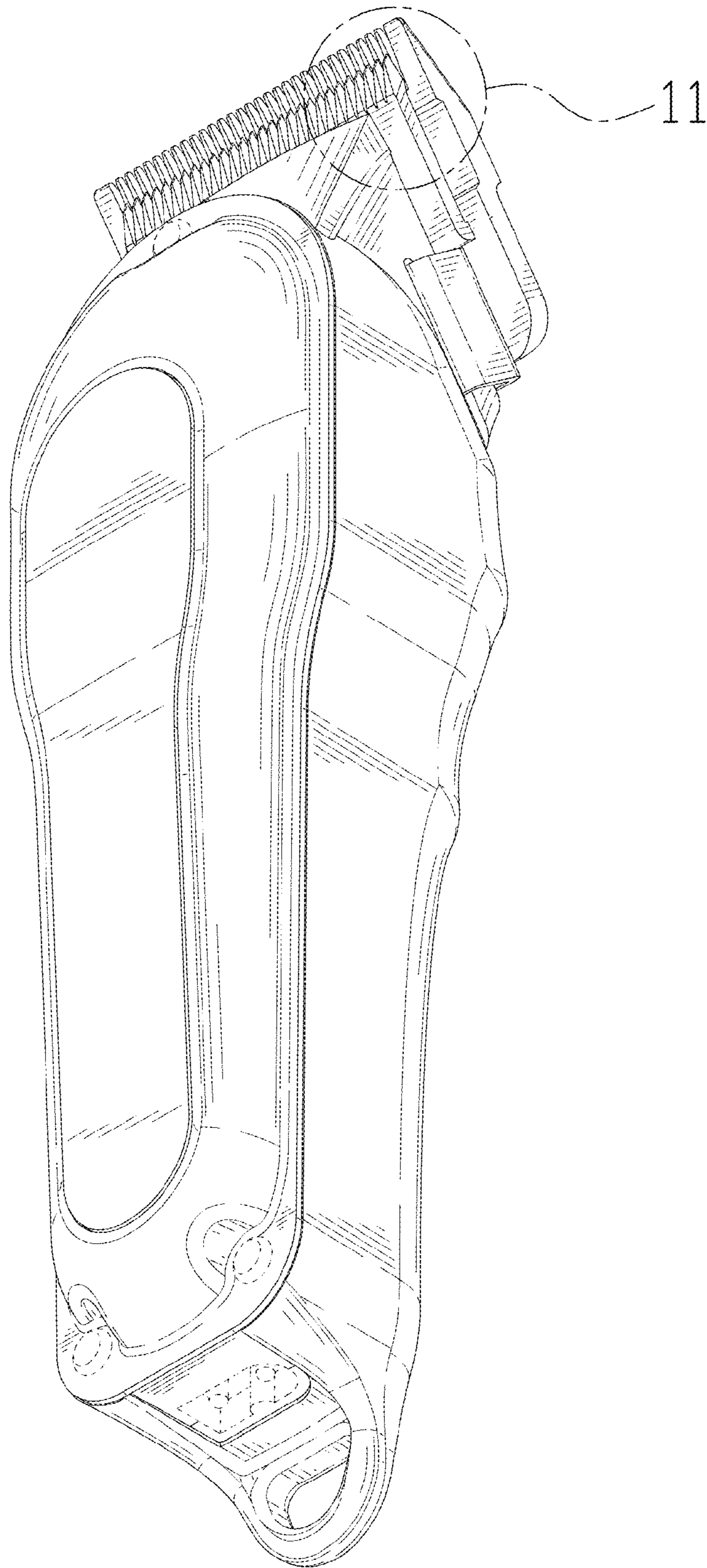

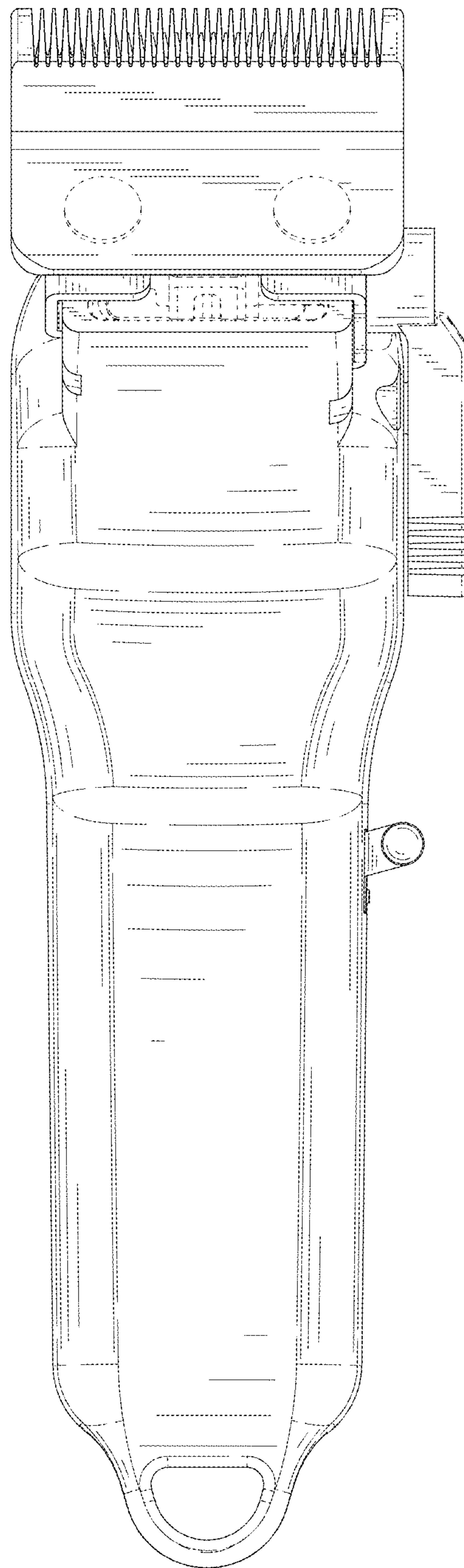

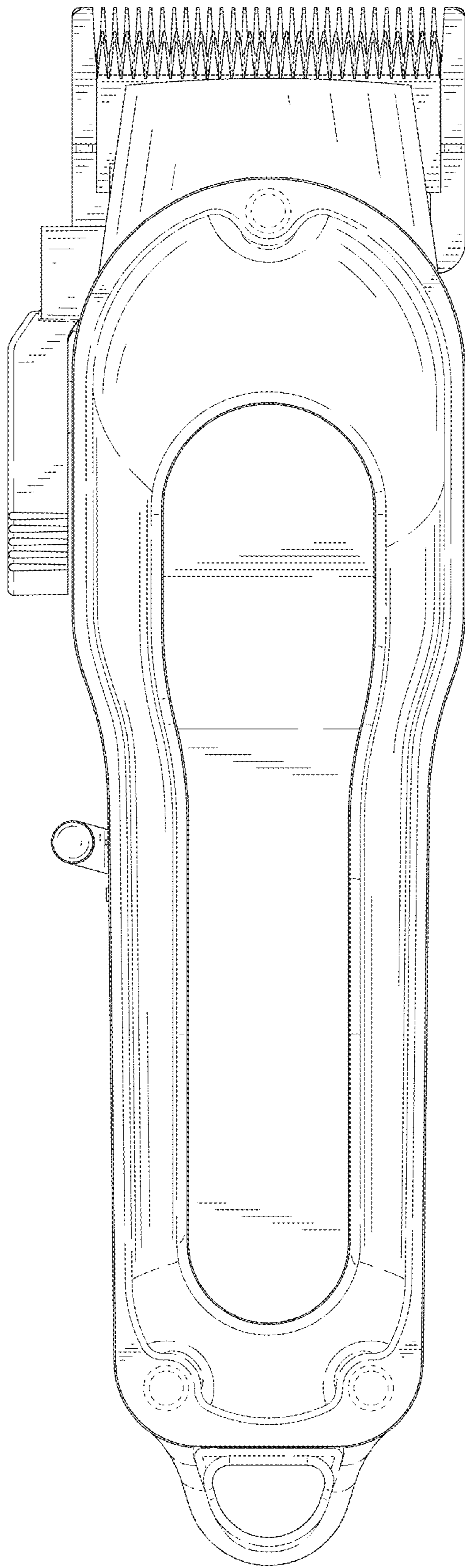

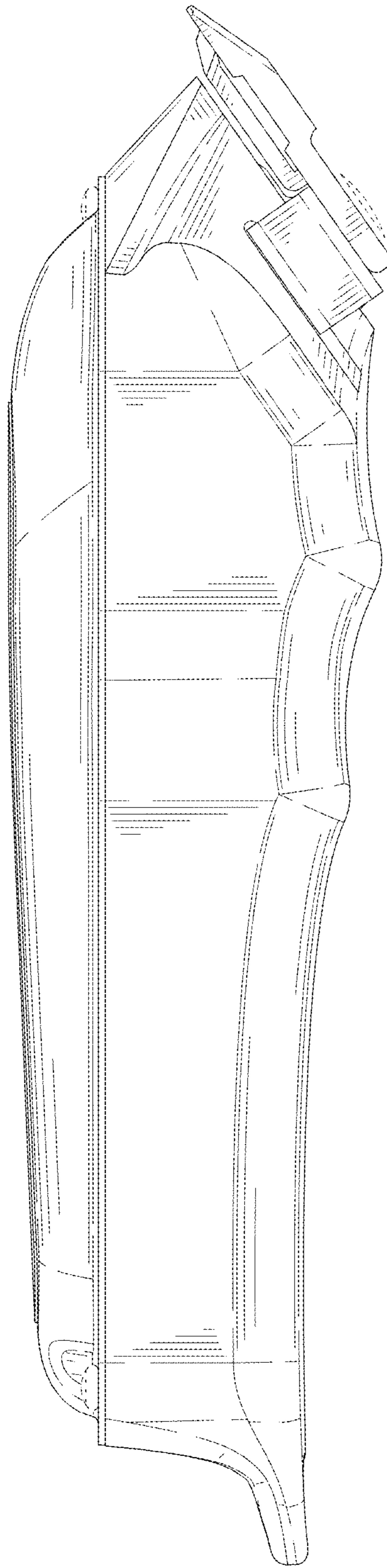

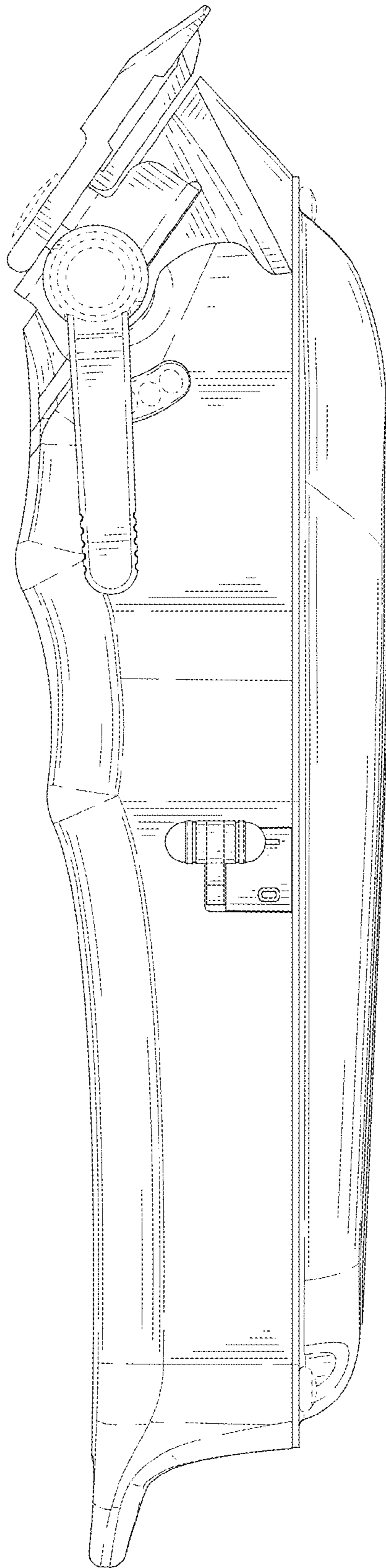

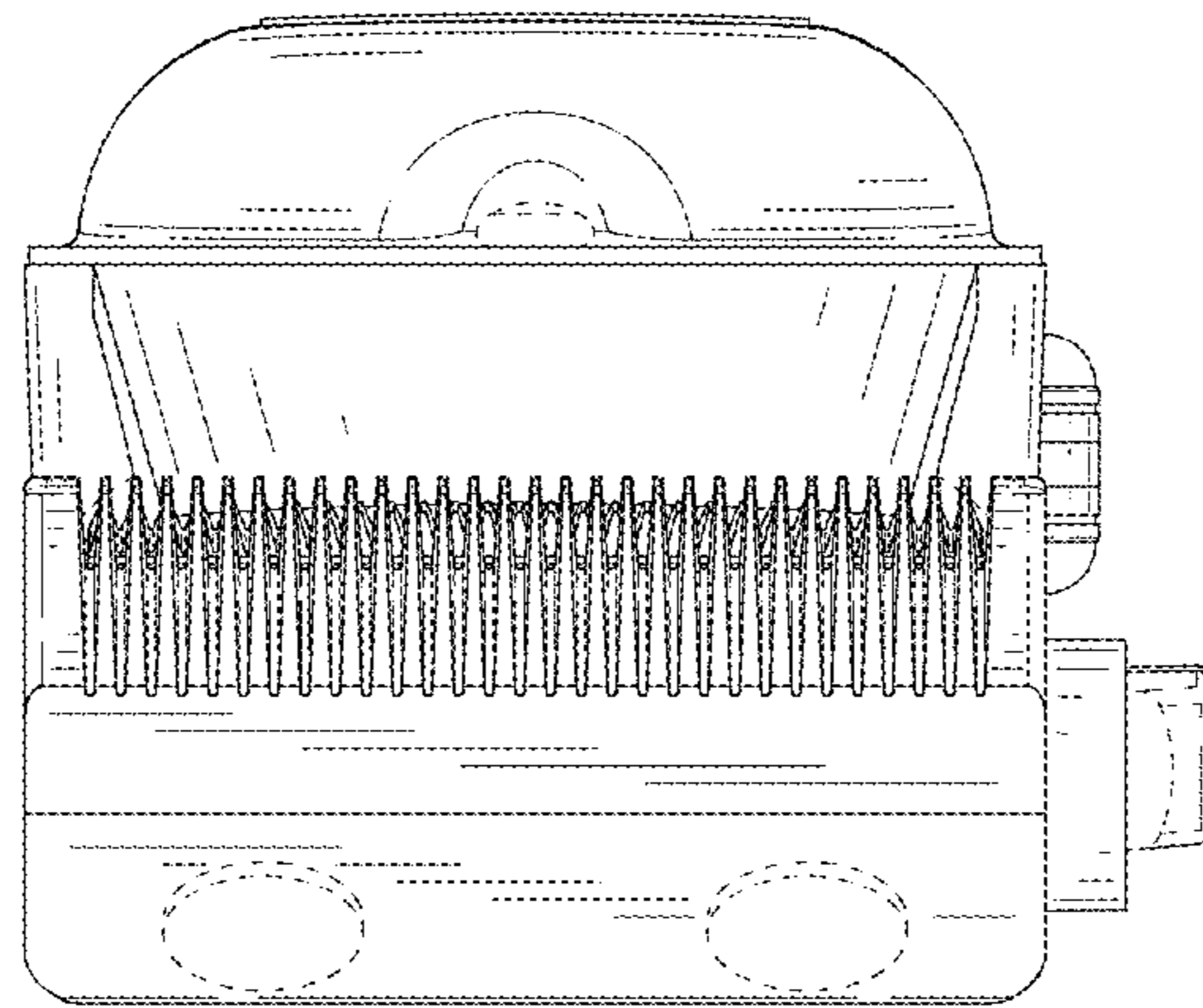

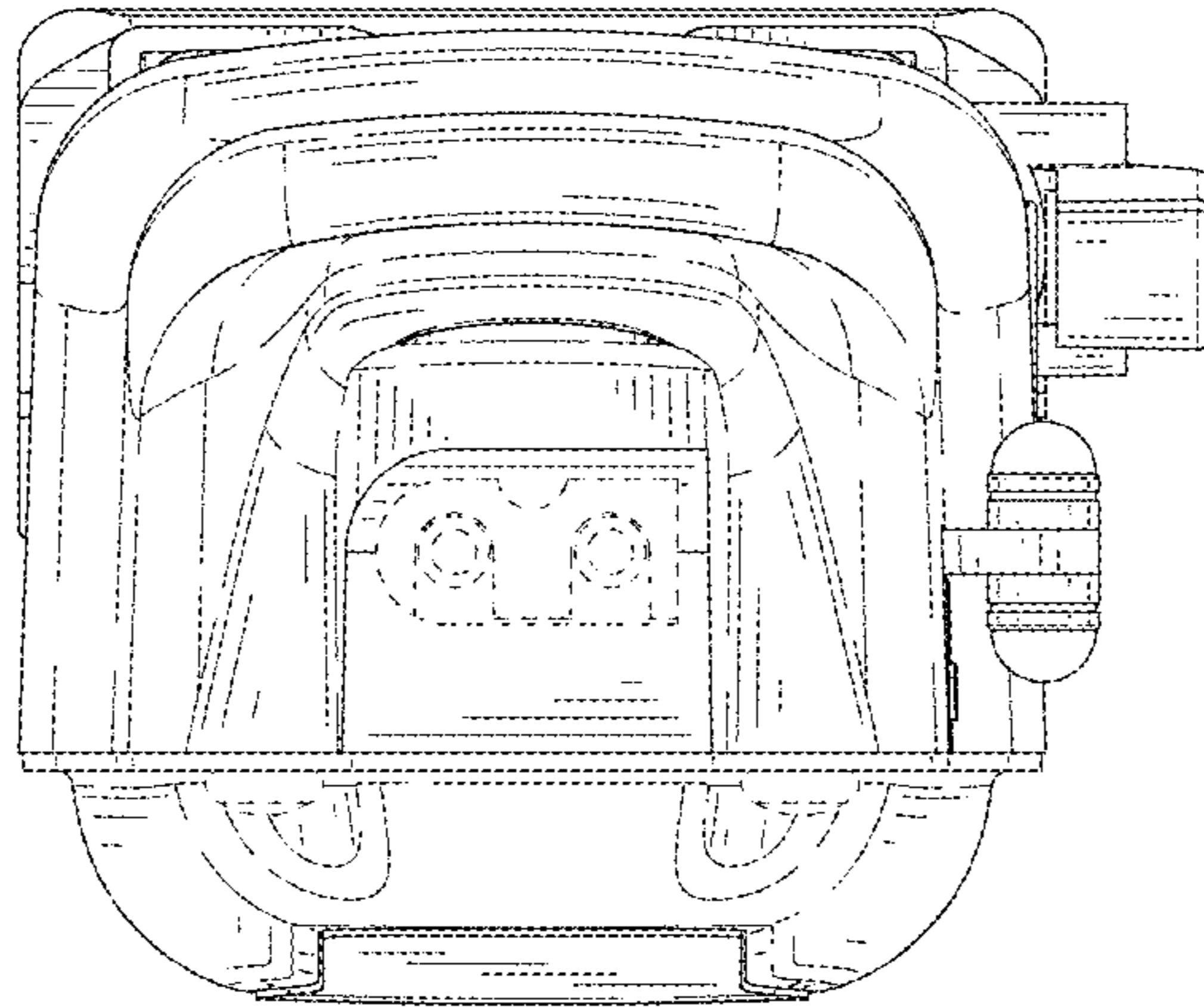

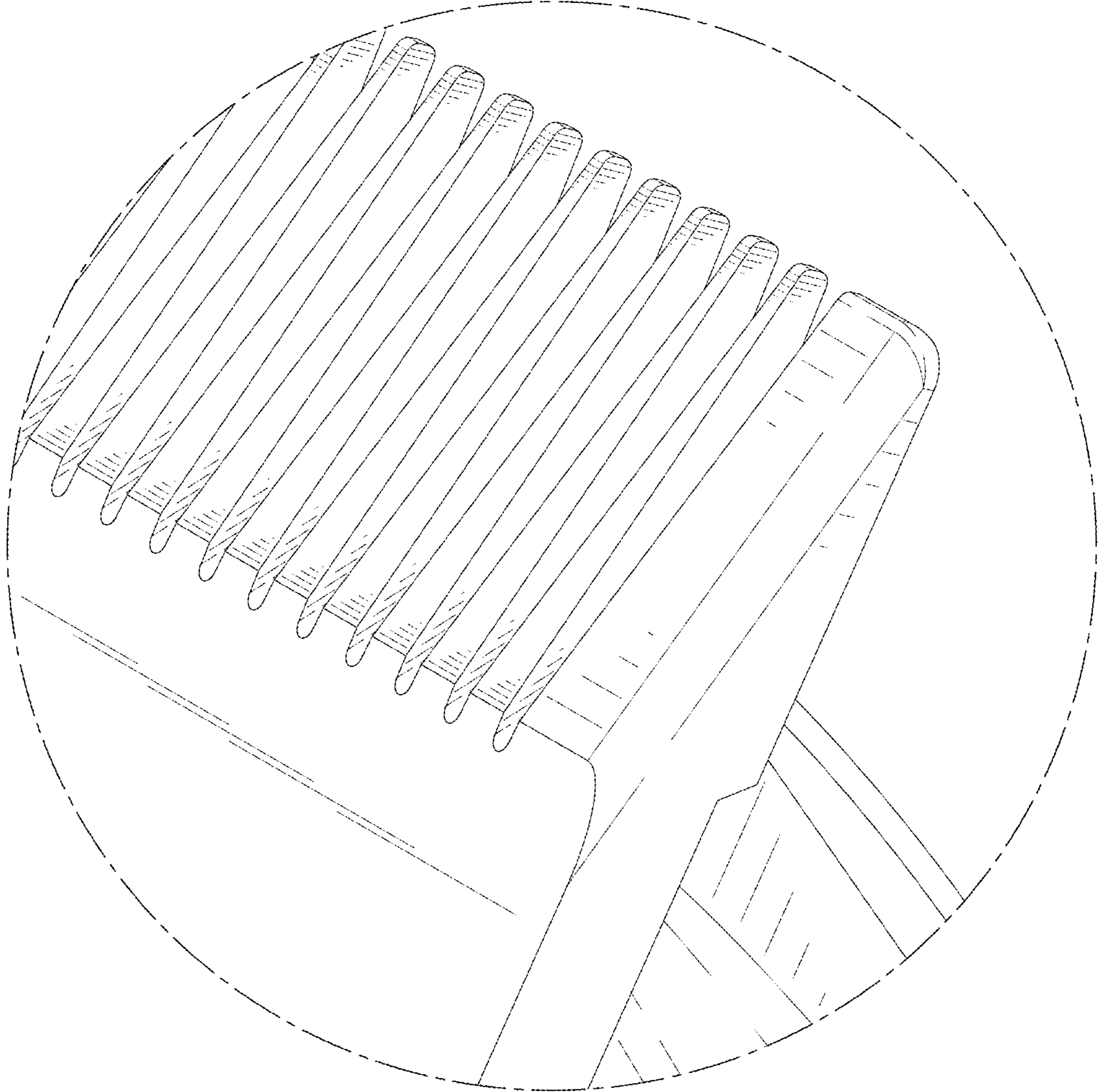

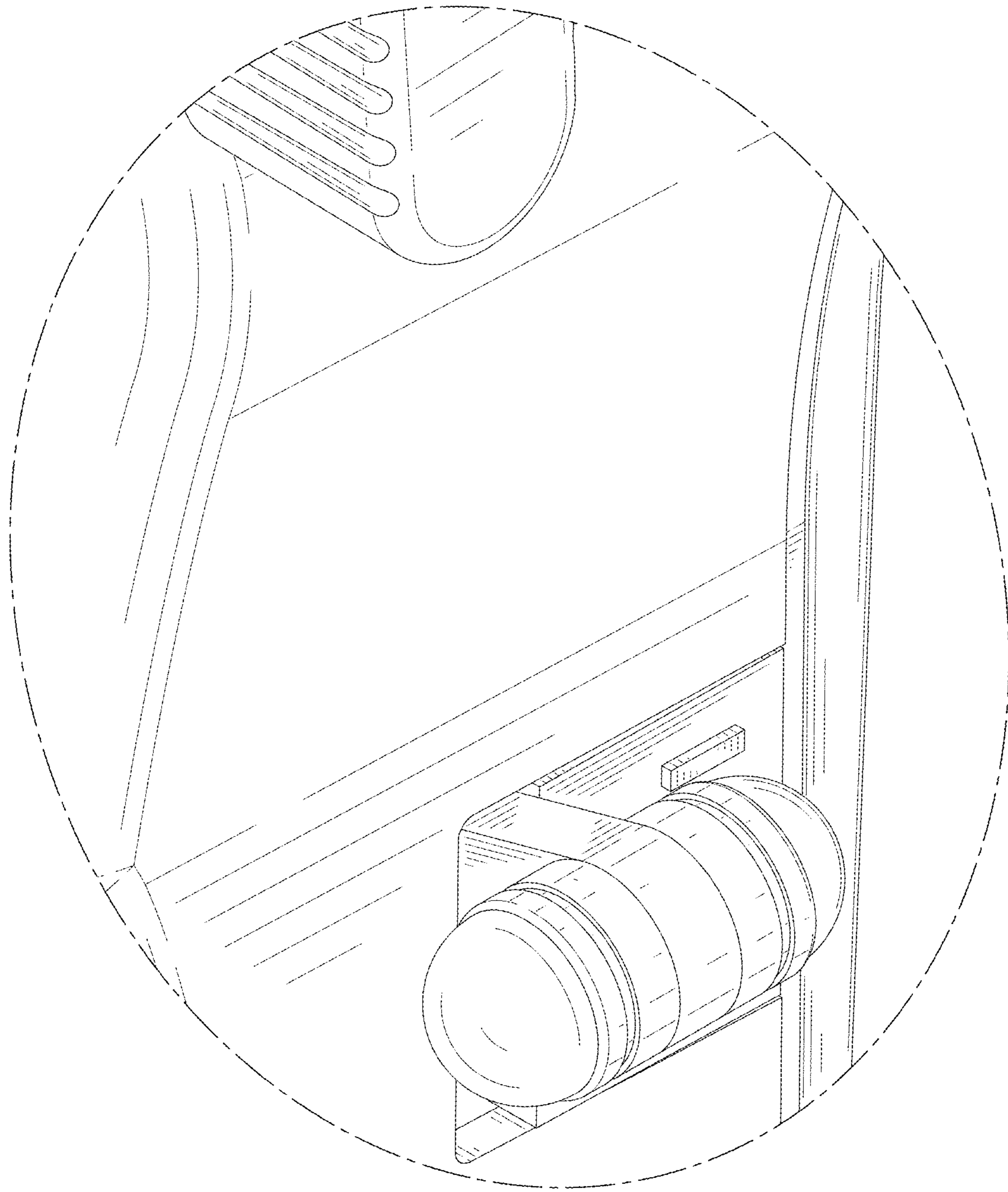

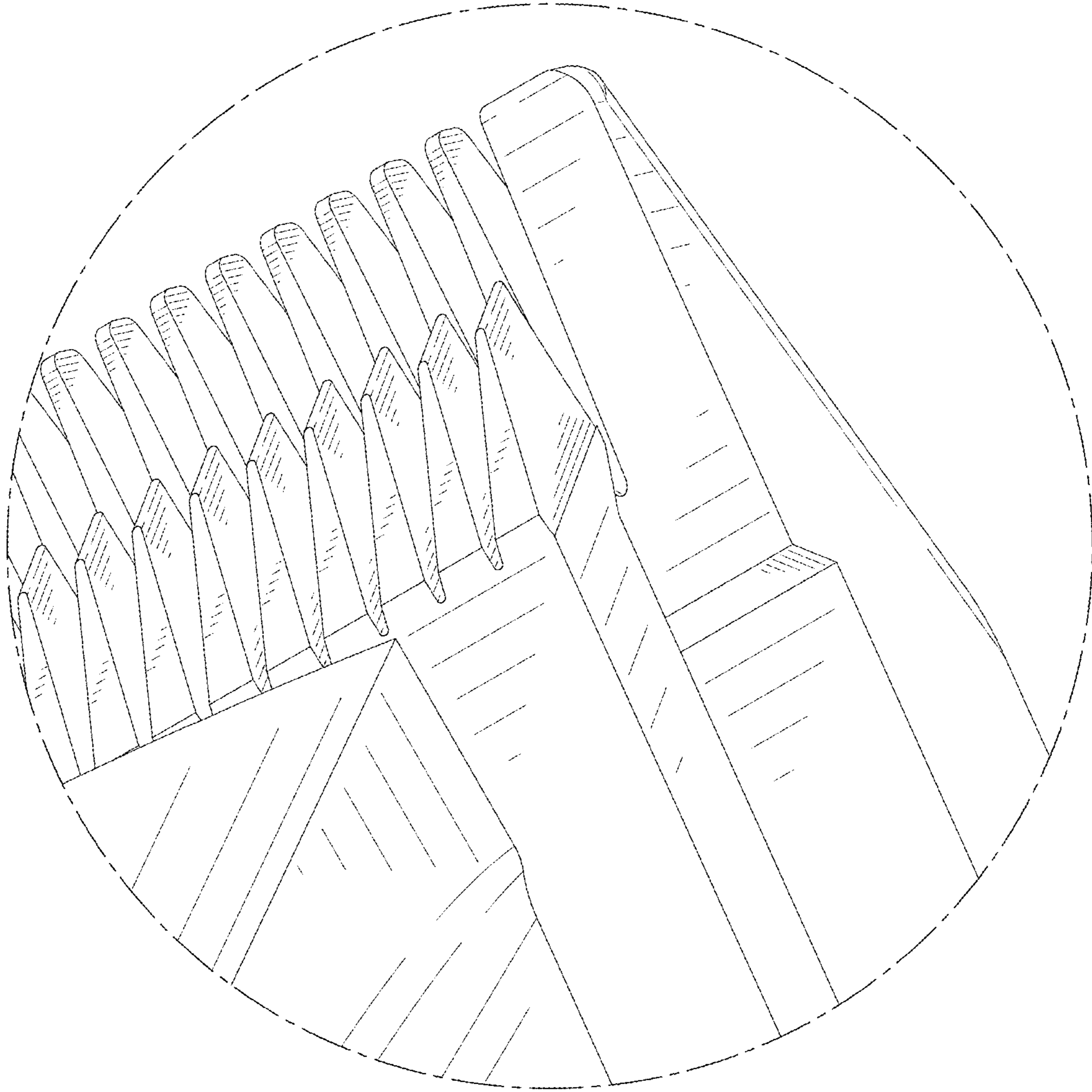
